NEW DELHI: The ministry of external affairs said that India and China held a discussion over the situation along the Line of Actual Control (LAC) on Thursday and decided to jointly uphold peace and tranquillity on the ground.

MEA said that a 'frank, constructive and forward-looking exchange of views' took place at the 31st meeting of the Working Mechanism for Consultation & Coordination on India-China Border Affairs (WMCC) in Beijing.

Dissecting the evolution Rahul's ot approach, Irani suggested that his newfound focus on caste politics and symbolic gestures marks a significant departure from his earlier tactics.In a recent podcast, Smriti Irani said, "There has been a change in Rahul Gandhi's politics." Highlighting that the Congress leader appears to believe he has finally tasted success after years of struggling to find his footing, she said, "When he (Rahul Gandhi) speaks about caste, he for the first time in his political career, speaks as an instrument. When he wears white T-shirt in Parliament, he knows what message he is trying to send to the youth." She also noted that every gesture and statement from Gandhi is part of a broader, more calculated strategy. "They're planning a different game in politics now, and these guys are far from naive," she added.

Irani highlighted that Rahul's recent emphasis on caste politics is a deliberate move, a first in his career where he is using such a sensitive issue to resonate with the masses. Rahul's shift towards castebased rhetoric is a response to his earlier failures in garnering mass appeal through other means.

US-made F-16 fighter jet crashes in Ukraine due to 'pilot error': Reports

NEW DELHI: A USmade F-16 fighter jet given to Ukraine crashed on August 26, resulting in the death of its pilot, Oleksiy Mes, who was known by the call sign "Moonfish", said sev-eral US media reports on Thursday.

The incident occurred during a significant Russian aerial assault on Ukraine, which involved over 200 missiles and drones targeting various civilian and energy facilities.

A CNN report citing a source in the Ukrainian

The kids were admitted to Ara Sadar Hospital for treatment.

The incident brings back the memories of 2022 when nearly 72 kids of two government schools fell ill after consuming de-worming tablets in Bhagalpur and Munger.

Wayanad paid the price because Kerala ignored Gadgil's report. Landslide is wake up call

The recent landslides in Wayanad, Kerala, which have left at least 282 people dead, more than 200 injured, and 240 still missing, serve as a stark reminder of the fragile balance between human development and environmental sustainability. As rescue operations enter their third day, with over 1,000 people saved, the immediate focus is on providing relief and finding the missing persons. However, the broader implications of this disaster call for a critical evaluation of our approach to development and environmental management. Kerala, with its unique geographical and climatic conditions, is no stranger to landslides. Districts like Idukki, Kottayam, Malappuram, and Wayanad have long been recognised as landslide-prone areas. According to a study conducted by the Geological Survey of India, around 14.5 per cent of Kerala's total area is prone to landslides. The heavy rains during the southwest monsoon are a yearly phenomenon, yet the scale and frequency of deadly landslides in recent years are alarming. This tragic event underscores the urgency of addressing the root causes of such disasters, which include both natural and anthropogenic factors. The Madhav Gadgil report, submitted by the Western Ghats Ecology Expert Panel in 2011, provides a comprehensive framework for understanding and mitigating these risks. The report emphasises the importance of preserving the ecological integrity of the Western Ghats, advocating for the restoration of denuded flora and the rehabilitation of people in vulnerable areas. The Western Ghats, a UNESCO World Heritage Site, are a biodiversity hotspot and play a critical role in regulating the climate and hydrology of the region. However, the report highlights that climate change is exacerbating weather patterns, leading to unprecedented and unpredictable natural disasters. The panel warned that unchecked development and deforestation in the Western Ghats would lead to increased landslides and other ecological disasters. One of the key recommendations of the Gadgil report is to halt engineering projects in ecologically sensitive areas. This includes limiting quarrying, construction activities, and monocropping, all of which compromise the ecosystem's ability to cope with natural changes. Unfortunately, these recommendations have often been overlooked in favour of short-term economic gains. The Chaliyar River's devastating impact this year, intensified by increased rainfall and upstream deforestation, is a direct consequence of such oversight. The river, originating from an altitude of around 2 km, has brought fast-moving waters laden with debris, devastating villages in its path. The recurring nature of these disasters reveals a significant gap in warning systems and emergency preparedness. Despite landslide risk maps clearly identifying vulnerable areas, the state has been repeatedly caught off-guard. According to the Kerala State Disaster Management Authority, there were over 400 landslides in the state between 2018 and 2020 alone. The lack of proactive measures to mitigate risks and enhance resilience has resulted in avoidable loss of life and property. This calls for the establishment of well-equipped, staffed, and empowered expert committees to assess the feasibility of development projects in sensitive areas, ensuring that environmental concerns are not sidelined.

In addition to structural measures, there is a need for a paradigm shift in public policy. Sustainable development should not be viewed as an obstacle to economic growth but as a foundational element of longterm prosperity.

Israel's Assassination Spree Forces Iran to **Choose: Total War or Total Humiliation?**

Iran's 'Axis of Resistance' is in a crisis. If Iran is the mothership, the Houthis, Hamas and Hezbollah are its proxies, extending far and wide into the West Asian region. These extensions of Iran have allowed it to project power across the Middle East, tackling its enemy Israel and keeping Arab powers in check. But Israel attacked all three of these heavily armed militant offshoots within days, and it has not even spared Iranian territory in the process. News of the assassination of Hamas political chief Ismail Haniyeh in the Iranian capital of Tehran has sent shockwaves across the world and has embarrassed Iran. After all, he was a guest of Iran to attend the inauguration of its new Masoud President Pezeshkian, when he was killed in a blast. Before this, Israel struck a building in another capital city, Beirut in Lebanon, eliminating Fuad Shukr, Hezbollah's most senior military commander and a right-hand man to the Shia militant group's leader Hassan Nasrallah. This was apparently in response to a rocket attack by Hezbollah which killed 12 children in the Golan Heights, a Syrian territory controlled by Israel since the 1967 war. Israel also declared that Mohammad Deif, the military leader of Hamas in Gaza, was also killed in an air raid last month. And this is not it. The Houthis also got a taste of Israeli retaliation when a crucial Yemeni lifeline, the Hodeida port, came under attack. The massive air strike on this Red Sea Port was an answer to a drone attack by the Houthis. Israel is prepared



for any further escalation, it says, and is on high alert anticipating a response from Iran. Meanwhile, Iran is trapped in its own web. Israel has killed one of Iran's dearest guests in its capital city. Haniyeh was a guest of the Iranians. He attended the inauguration of the new Iranian President, Supreme Leader Khamenei with a warm hug and posed with the victory sign with other Iranian leaders. That was the last the world saw of him as he was killed before dawn in his special residence in Tehran. Iran's Islamic Revolutionary Guard Corps (IRGC) reported it as a "Zionist raid" that took his life. It was initially theorised that it was an Israeli missile attack, and it raised serious questions about Iran's air defence capabilities. But it is now being reported that it was actually a bomb placed inside the guesthouse where Haniyeh was staying. And it was placed almost two months before the attack. For two months, the security apparatus in Iran failed to track this bomb. When Haniyeh was finally inside, the bomb was detonated remotely. This raises

serious questions about Iran's security and intelligence capabilities. This was a lapse at many levels, if it was a lapse at all. After all, how could it be so easy to take Haniyeh out? This Hamas leader had been evading the Israelis for decades, enjoying safe haven in Qatar. Israel had been trying to take him out for years. Haniyeh was no small target— he was the political chief of Hamas since 2017, representing the group in diplomatic conversations with Arab and Western leaders. He shuttled from Turkey to Qatar and Iran to secure funding for Hamas. This is why some media reports will tell you that he was seen as a so-called "moderate" face of Hamas. This is not because he did not subscribe to the radical extremist ideology of Hamas but because leaders engaged with him behind closed doors to keep tabs on the Palestinian movement in Gaza. The truth is that Haniyeh was responsible for the intense militarisation of Hamas during his time in Gaza and was even accused of diverting humanitarian aid to the Hamas armed wing. He

is also believed to have

amassed a wealth of \$4 billion while being a leading face of Hamas. Israel believes that he was involved in the gruesome October 7 Hamas attack which killed over a thousand Israeli civilians. But the hunt is not over yet, as Israel has hinted that its next target could be Yahya Sinwar, the leader of Hamas within the Gaza Strip. With Haniyeh gone, Hamas is searching for a new leader. Some say that it could be Khaled Meshaal, who had previously lost Iran's favour when he supported a rebel movement against Syria's Bashar Al Assad. Meshaal has already survived an assassination attempt by Israel. In 1997, he was injected with poison by Israeli agents in the Jordanian capital of Amman. But the mission was botched, the agents were captured and the then-king Hussein was so furious that he threatened to hang the agents, and scrap Jordan's peace deal with Israel unless it shared the antidote. Under Netanyahu, who was in his first term at the time, Israel agreed to hand over the antidote and Meshaal was saved. If he returns to the paramount position in Hamas, he will surely need to watch his back or perish like his predecessor. Coming back to Haniyeh's death which has caused serious embarrassment for Iran. Everyone wants to know whether Iran will respond. After all, all its proxies and its own sovereign territory are under attack. Israel's message is pretty clear. No one is safe. So, will Iran sit back down, take the loss and lose face as a result— or will it strike back? If you go by the reactions of Iran's leaders,

then revenge is right around corner. Pezeshkian said, "I raised his victorious hand and today I have to bury him on my shoulders. Iran will make the terrorist invaders regret their cowardly action." Meanwhile, Ayatollah Khamenei said, "The criminal, terrorist Zionist regime martyred our dear guest in our territory and has caused grief, but it has also prepared the ground for a severe punishment... It is our duty to take revenge." Khamenei has even ordered a direct attack on Israel, according to reports. But it's not as simple as it looks. Iran's words are failing to match its actions. In April this year, Israel attacked the Iranian embassy in Syria and killed several IRGC officers. Iran retaliate but it seemed like it did not want a war. It rained down missiles over Israel, almost all of which were intercepted by the Iron Dome air defence systems. The damage was little and by no means a major escalation. Moreover, reports said that Iran had notified countries in the region, indirectly tipping Israel off about the attack and letting it prepare its defences in advance. Could it be that Iran does not want to be dragged into an all-out war with Israel, even though Israel is baiting it for confrontation every now and then? 39,000 Palestinians have been reported dead in Gaza, while over 100 Israeli hostages remain in captivity with no end in sight to the Israel-Hamas war. Israel has made a solid show of force in the last ten months, training its guns at Iran and Iran's proxies, all at the same

But that has never made any difference in my feeling towards people in the services. I do not defend the black sheep; they may be there. But are there not many honest people among them? But what is the language that you are using? I wish to place it on record in this House that if, during the last two or three years, most of the members of the services had not behaved patriotically and with loyalty, the Union would have collapsed. Ask Dr John Matthai. He is working for the last fortnight with them on the economic question. You may ask his opinion. You will find what he says about the Services. You ask the Premiers of all provinces. Is there any Premier in any province who is prepared to work without the Services? He will immediately resign. He cannot manage. We had a small nucleus of a broken Service. With that bit of Service, we have carried on a very difficult task. And if a responsible man speaks in this tone about these Services, he has to decide whether he has a substitute to propose, and let him take the responsibility. This is not a Congress platform. It is said that we promised Rs. 500 for the Ministers in the Karachi resolution. There is a long distance between Karachi and Delhi today. It is a different thing. You want Rs. 45 a day free of incometax. What is the use of talking about Rs. 500 today? It is very wrong. But I am prepared to admit that if the Indian Government is to be run today on the basis of Gandhian philosophy without an army, I am prepared to change the whole thing. You are today spending 160 to 170 crores of rupees per year on the army. Are you going to change that set-up? Tomorrow the whole of

we were in jail? I myself was arrest- strong army. The Police, which was broken, has been brought to its proper level and is functioning fairly efficiently. The Heads of the Departments of the Police in every province are covered under this guarantee. Are you going to change that? Are you going to put your Congress volunteers as captains? What is it that you propose to do? I am grieved to find that in a Parliament of this kind, Members, senior Members, speak in this strain. Delhi: According to sources, the Centre is considering moving NEET-UG, the national eligibility-cum-

Education ministry will revise NCERT's bagless school guidelines

Modi government working on new policy to increase lifespan of NH

Delhi: The Modi government is set to finalize a policy that will enable the strengthening of aging national highways through a technique called 'whitetopping', which aims to extend their lifespan. The primary focus will be on rehabilitating flexible, or asphalt, pavement, which makes up the largest and most crucial component of the aging national highway network.

According to an report the ministry of road transport and highways is currently seeking feedback on a draft policy that outlines the technique, its advantages, and the criteria for selecting national highways to be rehabilitated.

India's national highway network currently spans approximately 146,000 kilometers. "As India is building more and more two-, four- and six-lane national highways and expressways, the quantum of aged assets is increasing which warrants rehabilitation to extend its life further," a senior government official explained to the financial daily. Although there are various techniques and treatments available for strengthening flexible pavement, India has chosen to implement the thin white-topping technique, according to the official.

Thin white-topping involves constructing a concrete overlay with a thickness of 100-200 mm on top of an existing in-service bituminous pavement.

CM's relentless monitoring leads to the capture of another wolf

Lucknow/Bahraich

With Chief Minister Yogi Adityanath's vigilant monitoring and the swift action of the Forest department officials, another wolf was finally captured from Bahraich village on Thursday morning. The wolf had terrorized residents in over 35 villages and with its capture the local population is breathing a sigh of relief. So far, the Forest department has caught four wolves from the Bahraich area, with the latest one set to be relocated to Gorakhpur Zoo. CM Yogi praised the Forest department officials for their commendable efforts in ensuring the safety of the local community. Notably, the one captured on Thursday morning was the most ferocious of the four wolves caught so far. As the news of the 'man-eater' wolf capture spread, a wave of relief swept through the nearby villages, and the local community praised the Forest department's tireless work in securing their safety. Principal Chief Conservator of Forests (Wildlife), Sanjay Srivastava, informed that the wolf was first detected by a thermal drone at 11 p.m. on Wednesday night. "It was monitored again through a drone around 5 a.m. the following morning. The wolf's footprints were spotted, and the local Forest department officials quickly sprang into action. After a challenging effort, they successfully captured the wolf from the floodplain of Sisayya village at around 10:45 a.m. The search for two other wolves is still ongoing," he added.He elaborated: "Drone mapping was carried out, and efforts were made throughout the day on Wednesday. By continuously tracking its movements, the wolf's location was identified from its footprints on Thursday morning. The team then resorted to physico-chemical immobilization and successfully captured the wolf using a net."Principal Chief Forest Conservator (Wildlife) Sanjay Srivastava stated that the captured wolf would be sent to the Gorakhpur Zoo. Earlier, following instructions from Chief Minister Yogi Adityanath, Forest and Environment Minister Dr. Arun Saxena, Principal Chief Conservator of Forests and Head of Department Sudhir Kumar Sharma, and Principal Chief Conservator of Forests (Wildlife) Sanjay Srivastava arrived in Bahraich Wednesday. After visiting the affected villages and reassuring the residents, the Forest Minister confirmed that the department's team was fully equipped to capture the wolf, with Chief Minister Yogi Adityanath personally overseeing the situation. Within 24 hours of the Forest Minister's arrival, the man-eater wolf was successfully captured. After considerable effort, the hard work of the Forest Department finally bore fruit. FSSAI crackdown on 'A1 or A2' milk product ads

Delhi: India's top food safety regulator has prohibited the marketing and sale of milk and milk products labelled as A1 or A2, deeming such practices "misleading". The Food Safety and Standards Authority of India (FSSAI) issued an order aimed at curbing what it sees as deceptive promotions, particularly on social media platforms, that tout A2 butter, curd or ghee as superior products, a person aware of the matter said, asking not to be named. It has come to the notice of FSSAI that several food business operators are selling/marketing milk and milk products such as ghee, butter, curd etc in the name of A1 & A2 under FSSAI licence number and/or registration certificate", the order stated. The regulator explained that the A1 and A2 distinction in milk is related to differences in protein structure, specifically beta-casein. Consequently, the FSSAI deemed A2 claims on milk fat products as misleading and not in compliance with the Food Safety and Standards Act of 2006 and associated regulations.

DGCA fines Air India, 2 officials Rs 99 lakh

Delhi: DGCA has slapped a fine of Rs 99 lakh on Air India and two of its senior officials for a rostering lapse that paired a trainee pilot with a nontraining captain for operating an international flight this July. The regulator has also suspended post holder approval of Air India director (training) for six months.

years ago. On Sunday, Pakistan lost their first-ever Test match against Bangladesh. This defeat came on their home soil in Rawalpindi. Despite declaring their first innings at 448/6, Pakistan lost the game after Bangladesh took a 117-run lead in their first innings. Pakistan collapsed to 146 in their second innings, and Bangladesh chased down the 30-run target with ease. This win marks Bangladesh's first victory against Pakistan in 14 matches. This loss marks the 17th time in Test cricket history that a team has lost after declaring their first Ironically, Pakistan was also the first team to suffer such a defeat. In a 1961 Test Lahore against England, they declared at 387/9 but lost by five wickets. The recent defeat in Rawalpindi is Pakistan's third such loss. Before this, they lost to Australia in the 2016 Melbourne Test despite declaring at 443/9 in the first innings.India also experienced a similar fate in a 1976 Test against the West Indies in Kingston. 69 Indians await release from **Russian army: Jaishankar**

NEW DELHI: External affairs minister S Jaishankar Friday said the govt is awaiting release of 69 Indians recruited into Russian army and that in many cases there are indications that the Indian nationals were misled into joining that country's armed forces. So far, Jaishankar said there are 91 Indian nationals recruited into Russian army. Out of them, eight have passed away, 14 were discharged or in some manner have come back with govt's assistance and "there are 69 citizens awaiting release from Russian army," he said, in response to a question in LS.

Out of the eight who died, the mortal remains of four have been sent back to India and in two cases — one from Haryana and Punjab — DNA samples have been sent to the Russian side.

In one case from Gujarat, the family wants the body to be cremated in Russia and in another case



from UP, the mortal remains are being brought back, Jaishankar said while responding to Parliament question in Sabha.According to the EAM, the issue is that Russian authorities maintain these Indian entered contracts for services with Russian army. "We are not necessarily subscribing to that... In many cases there are reasons to indicate that our nationals were misled, that they were told that they were going for some other job and then they were deployed with the Russian

army," he added. The issue of Indians recruited into Russian army was taken up by PM Modi during his meeting with Russian president Putin last month. "We take this issue very very seriously. I have myself raised it numerous times with the Russian foreign minister...When the Prime Minister was in Moscow last month, he raised it personally with President Putin and got the assurance that any Indian national in the service of the Russian army will be discharged and released," Jaishankar
