NEW DELHI: The parents of IAS officer Puja Khedkar are on the run following the filing of an FIR against them for allegedly threatening a farmer. The development comes amid heightened media scrutiny of Khedkar, who recently sparked controversy with her demands for a separate cabin and staff during her posting in Pune.

Puja is also accused of using a private luxury car with a VIP number plate and red-blue beacon, during her tenure at the Pune collector's office. Separate teams of Pune police visited the Baner bungalow of Puja's mother, Manorama Khedkar, on Sunday, but received no response despite repeated attempts to make contact. Pune Rural SP Pankaj Deshmukh stated, "The accused are on the run. We are trying to contact them, but their phones are switched off. We have also visited their residence, but they were not available. Several teams, including local crime branch officials and local police stations, are searching for them in Pune and nearby areas where they have other residences and farmhouses."The case was filed on Friday night after a video surfaced showing Manorama Khedkar, accompanied by private bouncers, brandishing a pistol on June 5, last year, during an argument with farmers over a land ownership dispute. On Saturday, police recorded statements from witnesses in Dhadawali and conducted a spot panchnama. At 7 am on Sunday, officials from the Paud police and the Rural police's local crime branch arrived.

Tihar jail sources stated that Kejriwal had only lost 2 kg and was under regular monitoring by an AIIMS medical board. According to Kejriwal's health report provided by Tihar sources, he weighed 65 kg upon his initial arrival at the

prison on April 1 and maintained a weight of 66 kg between April 8 and 29. When he returned to prison on June 2 following a 21-day bail, weight was his recorded at 63.5 kg. As of July 14, his weight had decreased to 61.5 kg, indicating an effective weight loss of 2 kg. The prison administration has written to the Delhi government's Home Department, rejecting the AAP's allegations regarding Kejriwal's health.

How Modi Outwitted His Opponents?

For a third term, Prime Minister Narendra Modi is returning. Since 1962, no prime leader has been able to pull this off. What is the size of this? For the BJP, what does that mean? What does it signify for the ruling Nehru-Gandhi dynasty and the Congress? Let's consider the major changes in Indian politics that have occurred since 2014 in order to comprehend this. vAn extraordinary incident happened in August 2017, yet at the time it was mostly overlooked. Sampatiya Uikey, a BJP member from Madhya Pradesh, took the oath of office as a Rajya Sabha member that same month. With that, the 65-year reign of the Congress as the biggest party in the Rajya Sabha came to an end, thanks to the BJP. The strength of a political party in state legislatures across the nation is reflected in the Rajya Sabha, demonstrating the Congress's political dominance in Indian politics. They could occasionally lose out in the Center, However, power was never distant from them. Even in the Lok Sabha election of 1999, which Vajpayee won, the Congress had a healthy 5% higher vote share than the BJP. As one might assume, there was some anti-incumbency sentiment in 2004. Vajpayee lost power with a mere 1% swing against the BJP. It used to be difficult for a non-Congress party to be reelected. This was an advantage that the Congress used to be well aware of. In 2010, P Chidambaram said, "The Congress party is something the BJP is jealous of." He had said, "The Congress party alone has the ability to rule the nation for five years, return to the people, seek a mandate, and win reelection." What has altered since 2014. then? The least we can say, Mr. Chidambaram, is that the BJP has nothing more to be "envious" of the Congress over. This makes three straight elections that the Congress has lost. Its percentage of the vote stayed between 19 and 21 percent in 2014, 2019 and 2024. By contrast, this is a far cry from the 28% that the Congress received in 1999! What changed that way? Currently, the BJP has a significant advantage over the Congress-more than 10%. In 2014, the BJP secured 31% of the vote; in 2019, that number rose to 36%; and in 2024, to 36%. In comparison, such figures have not been seen by the Congress since 1991. A few unsettling parallels exist between 2004 and 2024. Both times, exit polls were incorrect, and the BJP fared much worse than anticipated. The BJP lost roughly 1% of the vote in both elections. However, the BJP's national footprint in 2024 is far greater than the Congress's. They gained new supporters in Odisha, Telangana, and Andhra Pradesh to offset the votes they lost in areas like Uttar Pradesh. The BJP's baseline was significantly higher everywhere. They still have twelve seats from the state, despite their defeat in Bengal. Similar to this, the BJP managed to win 33 seats in Uttar Pradesh in spite of setbacks. In total, the BJP had 303 seats heading into the 2024 election, compared to Vajpayee's meager 182 seats in 2004. It's possible that the BJP fell well short of "400 paar." But one thing was certain well before the polls ever started: the Congress would not come close to being the single largest party, which would be the BJP. It's likely that this was the first general election of its kind. Let's examine the Congress's performance in the three states where the party is now in power in order to determine whether or not they can govern for five years and be reelected. The party was defeated in all four Himachal Pradesh seats. They could only win nine of the twenty-eight seats in Karnataka. In Telangana, the Congress and BJP shared eight seats apiece, resulting in a draw. The state administrations controlled by Congress in the final two positions have only been in office for a short while and are already experiencing extreme antiincumbency. This is a startling bit of information. In a large state, no one has been reelected to the Congress since 2011! Since then, the BJP has won two consecutive terms at the federal level and returned to power. in a number of states, including Uttar Pradesh.

poned, tensions still exist. Leader of the Opposition Rahul Gandhi and Prime Minister Narendra Modi have both indicated that they want to carry on

with business as usual. The opposition, however, does not appear to be as cohesive as the ruling coalition. As soon as the 18th Lok Sabha convened, the chinks were apparent. Giving Rahul Gandhi recognition as the Leader of the Opposition (LoP) as of June 9, the day the Congress Working Committee announced his selection, was among Om Birla's first actions as Lok Sabha Speaker on June 26. On June 26, a different Rahul

also evident. In an attempt to get the Lok Sabha to denounce the era, he mentioned the Congress and its leader, Indira Gandhi. The Congress was left out in the cold despite its protests. Congressmen hurried to the Well of the House, but the Samajwadi Party, or SP (37 seats), the TMC (29), the DMK (22) and the Left parties (eight seats), did not accompany them. They didn't move from their seats, suggesting that they approved of the solution. The following day, these allies made a weak attempt to defend Congress, claiming that since it had expressed regret for the Emergency, no resolution was required. Together, these INDIA bloc parties hold 96 seats in the Congress, compared to 99 MPs.

Byju's said that with Raveendran and board members deciding to skip the EGM, it will not have the required quorum and cannot proceed to discuss or vote on the agenda. 

Uttarakhand will notify parents of children aged 18 to 21 and enlist live-ins online

Delhi: By the end of the year, Uttarakhand is anticipated to have adopted the Uniform Civil Code (UCC), and plans are underway to develop an online registration system for married individuals and cohabiting couples. Notably, this is the first time the government has revealed that live-in registration will be available online. Government should start new rules to combat fraudulent e-commerce reviews

Delhi: Consumer affairs secretary Nidhi Khare said the Union government will use an Indian Standards code to combat fake customer reviews and inflated ratings on e-commerce platforms, a global issue, as online shoppers complain more on the national consumer helpline. Online shoppers are heavily influenced by customer reviews and ratings. E-commerce sellers manipulate ratings and add paid reviews to encourage sales. "The presence of fake reviews online jeopardizes the trust-

worthiness and credibility of shopping platforms and can cause consumers to make wrong purchase decisions," said Khare, who led a stakeholders' meeting with Amazon and Flipkart executives. Mordor Intelligence estimates that India's e-commerce market would expand from \$112.93 billion in 2024 to \$299.01 billion in 2029, a 21.5% CAGR. The new standard (IS 19000:2022) assigns reviewers and administrators particular duties. New regulations compel organiza-

tions

review authors in certain ways. E-commerce grievances on the national consumer helpline increased from 95,270 in 2018 (22% of all grievances) to 4,44,034 in 2023 (43% of total grievances). E-commerce platforms in India must create a documented code of practice and share it with management and workers. Khare said they must show how they will follow this constitution and the principles. guiding Amazon and other platforms have acknowledged the identify issue globally.

Sebi proposes tighter SME listing requirements over misuse worries

Delhi: Sebi and stock exchanges aim to tighten standards for SMEs seeking public listings, according to Reuters. Concerns over exploitation of a 2012 platform to help small firms access financing markets prompted this change. According to sources in the report, the planned modifications might boost the minimum amount of public offerings to Rs 30 crore to Rs 50 crore (\$3.59 million to \$5.99 million).

In response to stakeholder engagements, these new regulations are due later this year. There's no minimum issue size, but corporations listing on this

market must have Rs 25 crore in post-issue capital. Joe Biden dramatically raises US tariffs on Chinese EVs and chips

Delhi: US President Joe Biden lambasted Beijing for "cheating" as he raised tariffs on Chinese products such electric vehicles and semiconductors. Beijing strongly

opposed the sanctions as Biden sought to appear tough on trade ahead of a rematch with Republican Donald Trump in November's US



presidential election. "We're not going to let China flood our market, making it impossible for American automakers to compete fairly," Biden declared in the White House Rose Garden. He said, "We're never going to allow China to unfairly control the market for these cars," before ordering duties. Trump's tariffs have been frequently criticized by Biden. He's been using similar tactics to win over blue-collar voters in swing Rust Belt states. The White House stated EV tariffs will treble to 100% this year and semiconductor duties will rise from 25% to 50% by next year. The sanctions targeted \$18 billion in Chinese imports, including batteries, vital minerals, and medical supplies. Biden said China has substantially supported critical sectors, forcing corporations to produce more than the world can consume and flooding the market with unfairly priced commodities. The president's announcement followed a review of tariffs imposed by then-president Trump on \$300 billion in Chinese imports. The Biden administration maintained tariffs.



Ghaziabad Residents Drink Nearly Rs 400 Crore in Beer **During Heatwave**

Delhi: The excise agency reports that Ghaziabad residents have consumed approximately Rs 400 crore in beer due to the past three months' scorching. Officials credit high heat and consistent prices for this record sales result. People in Ghaziabad and the National Capital Region sought ways to cool themselves due to extreme heat. In addition to lemonade, lassi, and buttermilk, many Ghaziabad inhabitants chose alcoholic beverages, especially beer, which generated large excise money. Ghaziabad beer drinkers spent Ks 397.16 crore during April to June 2024, up 106% from the previous year. Even more, beer can sales rose 116%. Over 13.3 million cans were sold this year, up from 11.5 million last year. Beer helps many cope with soaring temperatures. Due to this tendency, the excise department saw significant income growth throughout these three months. District excise inspector Rakesh Kumar said the severe heat and stable beer pricing drove record sales. said, "The data clearly shows that the intense heat and no price hike were the primary reasons for the exceptional revenue of Rs 397 crore."
