PM Modi, Shah in BJP's 1st list for 195 LS seats, 20% sitting MPs not repeated

The list is a reflection of the party's confidence and effort to balance boldness in de-boarding some incumbents with caution in sticking with "safe"

NEW **DELHI:** Narendra Modi, who is seeking a third term, will contest the Lok Sabha elections from Varanasi seat, while home minister Amit Shah and defence minister Rajnath Singh will seek re-election from their constituencies of Gandhinagar Lucknow respectively. They along with former CM of Madhya Pradesh Shivraj Singh Chauhan, Union ministers Jyotiraditya Scindia, Bhupendra Yadav, Mansukh Mandaviya, Smriti Irani, Gajendra Singh Shekhawat, Arjun Munda, Kiren Rijiju and Sarbananda Sonowal are among the 195 names BJP announced on Saturday for stealing a march over its rivals.



In all, 34 Union ministers figure in the list. Lok Sabha Speaker Om Birla will contest from Kota in Rajasthan. Names were announced for UP (51), MP (24), Gujarat (15), West Bengal (20), Rajasthan (15), Kerala (12), Chattisgarh (11), Jharkhand (11), Assam (11), Telangana (9), Delhi (5), Uttarakhand (3), Jammu and Kashmir (2), Arunchal Pradesh (2), Goa (1), Tripura (1) and Andamans (1), Daman Diu (1). Big states like Maharashtra, Bihar and Andhra as well as Punjab where the party is in coalition or is exploring tie-ups don't figure in the list though the party has finished its homework on its choices for seats it has decided to

the party's focus on youth. The list includes 28 women, making up 14% of candidates announced so far. The party's focus on OBC

community has also been reflected as majority of sitting MPs from the caste bracket, mainly in Uttar Pradesh, Madhya Pradesh and Chhattisgarh, have been retained. The category accounts for 57 of the nominations. The party has fielded one Muslim candidate - Abdul Salam from Malappuram in Kerala. This is the first time BJP has fielded a Muslim candidate in Lok Sabha polls since 2014. Former Union minsters who are missing from list include Harshvardhan (Chandni Chowk) and Jayant Sinha who took to X in the morning to declare that he had opted out of the contest because of his commitment to fight climate change. Suspense is going to linger over the chances of others like Pokhriyal Nishank as the party has refrained from confirming him for his Haridwar seat.

Centre signs pact to address Tripura's indigenous issues

NEW DELHI: A tripartite agreement aimed at making Tripura dispute-free by resolving all issues concerning its indigenous people, was co-signed by the Centre, Tripura govt and The Indigenous Progressive Regional Alliance (Tipra) in the presence of home minister Amit Shah here on Saturday.

"Today is a historic day for Tripura. Through this agreement, we have honoured history, corrected past wrongs and accepted today's realities, to move towards the future... the indigenous people of Tripura no longer need to fight for their rights as govt of India will now be two steps ahead to create mechanisms to safeguard their rights," Amit Shah said after the tripartite constitute a joint workpact was signed.

The pact - eleventh in the series of agreements signed in the current term of Modi govt to make North-East region free of

insurgency, violence and disputes - seeks to resolve all issues faced by Tripura's indigenous people regarding history, land and political rights, economic development, identity, cul-

ture and language. The Centre, Tripura govt and Tipra (popularly known as Tipra Motha) have agreed to ing group to work out and implement the mutually-agreed points on all issues in a timebound manner. Starting Saturday and

"Today, in the presence of home minister Amit Shah-ji, there was a meeting with pres-RLD of Jayant Chaudhary-ji. I heartily welcome his decision to join NDA family," BJP national president JP Nadda wrote on X.

Chaudhary had told reporters, "I took this decision (of joining NDA) after speaking to all MLAs and workers of my party. There was no big planning behind this decision, or had we decided this a long time ago. We had to take this decision within a short time because of the situation. We want to do something good for the country, for our people.'

The RLD chief had said that consultations with MLAs and workers were held after his grandfather Chaudhary Charan Singh was bestowed Bharat Ratna. Bonhomie between BJP and RLD became reasonably apparent after Chaudhary reacted to his late grandfather being given the country's highest civilian honour. 

'Motherhood full-time job': HC hikes woman's maintenance cost

BENGALURU:

Highlighting demanding nature of motherhood. Karnataka HC in a recent judgment ruled in favour of a woman and her two children, and hiked her maintenance cost. Justice

Nagaprasanna granted the woman Rs 36,000 per month in maintenance from her husband, a manager in a nationalised bank, instead of Rs 18,000 per month awarded by Anekal family court.

The couple, who got married in 2012, has two sons, aged 11 and 6. As the relationship deteriorated, the wife in 2020 moved family court and filed an application under Section 24 of Hindu Marriage Act, seeking Rs 36,000 per month as interim maintenance. The family court had in 2023 initially awarded Rs 18,000 per month in interim maintenance. The wife challenged the order, pointing out that her husband is drawing a monthly salary of Rs 90,000.

The woman said she had requisite qualifications and was working earlier, but her husband insisted she quit her job as a lecturer to take care of the chil-

The husband argued that she is qualified and can resume her career and be financially independent instead of depending on maintenance he is expected to pay.

BJP eyes options in Badaun against SP veteran Shivpal

LUCKNOW: Who would be up against SP heavyweight and party chief Akhilesh Yadav's uncle Shivpal Singh Yadav in Badaun in the upcoming Lok Sabha elections? The question has started doing the rounds amid broad indications that the BJP may deny the ticket to sitting party MP and daughter of former SP leader Swami Prasad Maurya, Sanghmitra Maurya, this time. Highly placed sources in the BJP said that Union minister and sitting Rajya Sabha MP BL Verma and the party's Braj region president Durvijay Singh Shakya are emerging as the top contenders for the ticket from the constituency which has a sizable presence of the OBC, essentially Kushwahas, Shakyas, Lodhs and Yadavs.

Sixty-two years old Verma is often considered a 'close aide' of former CM Kalyan Singh. Currently, Union MoS for cooperative and north-east development Verma has also been the party's state vice-president. He was nominated to the Rajya Sabha in 2020 and a year later, in July 2021, was inducted in the Modi cabinet. Verma's Itenure in RS is till November 2026.Shakya, too, wields considerable influence within the organisational command given his closeness to the RSS. He started his political career



while working with the Akhil Bharatiya Vidyarthi Parishad. He later became the Braj region general secretary and vice-president.

The saffron brass is also considering the name of SP MLA from Bisauli in Badaun, Ashutosh Maurya, who voted from the BJP candidates in the recently conducted Rajya Sabha poll. Maurya, a three-term MLA from the district, happens to be a Dalit. In 2019 Lok Sabha elections, Sanghmitra was the foremost choice of the BJP against SP's Dharmendra Yadav, who has been representing the seat since 2004. The move paid off as Sanghmitra defeated Dharmendra by a margin of

over 18,000 votes. Sources said that Sanghmitra Sources said that BJP has been

has not been finding much favour from BJP regional brass after Swami Prasad unfurled the banner of revolt against BJP and defected to SP camp in the run-up to 2022 assembly elections. Though Maurya lost the assembly elections from Fazilnagar seat in Kushinagar, Akhilesh propped him as party national general secretary and MLC. The move, however, boomeranged as Maurya courted controversies by making provocative statements against Sanatan Dharma and Ram temple, in what potentially hurt the Hindu religious sentiments.

His statements not only drew sharp riposte from the saffron dispensation but also put the SP brass in a discomfiture.

Rat-hole miner Hassan declines another house offered in Delhi's **Dilshad Garden**

NEW DELHI: Rat-hole miner Wakeel Hassan, who had lost his house in a demolition drive, has declined another offer of a house in Dilshad Garden here by the authorities. "On Friday night, four government officers, including an SDM, came and offered me a house in Dilshad Garden but I refused to accept it as they wanted me to shift on a temporary basis," Hassan said. "It was also not in writing. That house belongs to an NGO," he said. After the demolition, DDA officials proposed Hassan to relocate to an EWS (economically weaker sections) flat in Narela, which is far from Khajoori Khas in northeast Delhi. Hassan rejected the offer, stating that it was "far and unsafe." On being asked why he declined the second offer, considering that Dilshad Garden is closer to Khajoori Khas compared to the distant Narela, Hassan said that the cost of his demolished house was more than Rs 1 crore and if the government wants to compensate, then the cost of the house should be matched.

NSE registered investor base crosses 9 crore unique investors

AMBALA: The unique registered investors on the National Stock Exchange of India crossed 9 crore (90 million) on February 29th, 2024. The total number of client codes registered with the Exchange stands at 16.9 crores (169 million) (Includes all client registrations done till date; clients can register with more than one trading member). Unique investor registrations at NSE have seen an accelerating trend over the last few While the years. increase from 6 to 7 crore (60 to 70 million) unique investors took about nine months, the next crore (10 million) investors came in eight months, and the jump from 8 to 9 crores (80 to 90 million) took only five months. During this period, daily new unique registrations



have averaged between nearly 47,000 in October 2023 to 78,000 in January this year. Store cashier flees with Rs 1 crore, held while trying to escape to Gujarat

NEW DELHI: A cashier sent police on a wild goose chase after stealing Rs 1 crore from a clothing store in South Extension 1 where he worked. Rishabh Kumar Sharma (26), his wife and two others were finally arrested on Thursday. After raiding five-six places unsuccessfully, police first traced Sharma (26) and his wife in Uttarakhand's Dehradun, but they had left the place by the time the cops reached there. Then Sharma made a call to a friend from his wife's mobile phone, which led to his arrest at Nizamuddin Railway Station while they were trying to flee to Gujarat. His wife, uncle and a friend were also arrested. The owner of the store had filed a complaint alleging that one of his employees who had been working as a cashier for the past seven-eight months had fled with Rs 1 crore on Feb 27.

Two-child norm for govt jobs in Rajasthan gets **Supreme Court nod**

NEW DELHI: More than 21 years after upholding validity of the mandatory 'twochild norm' eligibility criteria for candidates contesting panchayat polls, the Supreme Court has now put its stamp of approval on an identical norm for public employment, debarring candidates who have more than two children from seeking govt jobs. A bench of Justices Surya Kant, Diapankar Datta and K V Vishwanathan dismissed the appeal filed by ex-serviceman Ram Lal Jat, who had retired from service in 2017 and had applied for a conpost in stable's Rajasthan Police on May 25, 2018. His candidature rejected as Rule 24(4) of Rajasthan Police Subordinate Service Rules, 1989 that followed the norm set under the Rajasthan Service (Amendment) Rules,

2001, which provides



that "no candidate shall be eligible for appointment to the job who has more than two children on or after June 1, 2002." He had unsuccessfully challenged the rejection of his candidature for constable post Rajasthan high court, which in Oct 2022 had ruled that the fixation of norms squarely fell in the realm of policy, which could not be interfered with by the court. The Justice Kant-led bench said, "A somewhat similar provision, which was introduced as an eli-

gibility condition to contest panchayat elections, has been upheld by the SC in the case Javed and others vs. State of Haryana in 2003. This court held that the classification, which disqualifies candidates for having more than two living children, was nondiscriminatory and intra-vires Constitution, since the objective behind the provision was to promote family planning."The bench dismissed. Jat's appeal saying the HC judgment did not warrant any interference.

'Bail as a rule' principle losing ground in trial courts: CJI

DELHI: Chief Justice D Y Chandrachud on Saturday expressed concern over 'bail as a rule, jail an exception' principle losing ground in trial courts and said district judges must reverse the trend as well as public perception by giving due importance to citizens' personal liberties. Speaking to a pan-India congregation of district judges Kachchh in Gujarat, he said, "There is rising apprehension that district courts are increasingly reluctant to entertain matters concerning personal liberty.'

Al platforms need permits

NEW DELHI: With general elections on the anvil and following a controversy over unsubstantiated comments on PM Modi by Google's AI platform Gemini, govt on Saturday said it has issued an advisory for artificial intelligenceled internet companies to label any unverified information as potentially false and error prone. Any Al-led public information platform will need to have a permit before being allowed in India, said govt, while warning that it will not hesitate to deny permission in case of potential risks of misinformation or bias.The notice comes almost two-and-a-half months after govt had issued an advisory on the matter of deepfakes after several incidents of syntheticallymade content flowing into social media and internet channels. The latest advisory says AIled platforms should not throw up unlawful, misinformed or biased content that has

potential to threaten



the integrity of the nation or of the elec-

toral process. IT & electronics MoS Rajeev Chandrasekhar said AI platforms such OpenAl Google's Gemini will have to make disclosures about the nature of their responses to govt as well as India's digital citizens, clearly mentioning that the content can be false, error-prone, and unlawful as the model is still under trial and testing. "If you are an untested platform and you think the platform is still in early stages of training and therefore is unreliable, you need to do three things. Firstly, you need to tell govt that I am deploy-

ing it. Second, you need to inform consumers by having a disclaimer that I am a platform under trial. Third, you need to explicitly mention this to the consumer who is using it, and you need to get his or her consent for using the platform. Take Google Gemini as

an example. It will have to tell the government before launching that this is a bit buggy platform."

Asked whether govt will have powers to refuse the launch of such a platform in the country if it finds it unreliable, Chandrasekhar told, "We can reject it if we find there is more risk.

The unique registered investors on the Stock National Exchange of India crossed 9 crore (90 million) on February 29th, 2024. The total number of client codes registered with the Exchange stands at 16.9 crores (169 million) (Includes all client registrations done till date;

clients can register with more than one member). trading Unique investor registrations at NSE have seen an accelerating trend over the last few While years. increase from 6 to 7 crore (60 to 70 million) unique investors took about nine months, the next crore (10 million) investors came in eight months, and the jump from 8 to 9 crores (80 to 90 million) took only five months. Over 46% of all new investor registrations in the last five months originated from districts beyond the top 100 districts (by number of new registrations in the period)

New criminal laws: An era of accountability, transparency and justice

The Central government has notified that the three new criminal laws, namely the Bhartiya Sakshya Sanhita (BSS), Bharatiya Nyaya Sanhita (BNS) and Bharatiya Nagarik Suraksha Sanhita (BNSS), which aim to replace the colonial era Indian Evidence Act 1872 (IEA), Indian Penal Code 1860 (IPC), and Code of Criminal Procedure 1973 (CrPC), will come into effect from 1 July 2024. One of the most appreciable measures in the enactment of the new criminal laws has been the insertion of the words "electronic and digital records" in the definition of "document" in section 2(1)(d) of the BSS. The scope of "documents" in the new BSS has been widened and made futuristic to include server logs, locational evidence, voice mail messages stored on digital devices...etc. In the IEA 1872, the definition of "document" did not specifically include electronic records. For the admissibility of electronic records in evidence, compliance with Section 65B of IEA 1872 was required. To ease the process further, two new forms have now been included in the schedule of the BSS, which will not only authenticate the collection process but also speed up the appreciation process of digital evidence. These reforms in the domain of "electronic evidence" will help in plugging the loopholes that were present in the IEA 1872. In CrPC 1973, there was no specific provision for Zero FIR. Zero FIR means an FIR registered by the police in case of a cognisable offence, irrespective of the jurisdiction. Earlier section 154 CrPC provided for the registration of FIR but not Zero FIR expressly. Now, section 173(1) of BNSS explicitly provides that every piece of information disclosing the commission of a cognizable offence_, "irrespective of the area where the offence is committed"_, may be given orally or through electronic means to the police. In many instances, the police refuse to register an FIR, citing a lack of jurisdiction, and the helpless victims or complainants have to run from pillar to post to get an FIR registered. The new BNSS, by clearly providing for Zero FIR, will ensure that no common man faces difficulty in getting an FIR regis-

Section 173 further mandates that when such information related to the commission of a cognizable offence is communicated electronically, it shall be "taken on record by him (police officer) on being signed within three days by the person giving it." It will ensure that FIR is registered in a stipulated time without any delay. Section 105 is a new provision added to the

Section 105 mandates that search and seizure made by the police, including preparing the list of seized items and signature of witnesses, shall be recorded through audio-video electronic means. It further obliges the police officer to forward such recording "without delay" to the District Magistrate, Sub-Divisional Magistrate, or First-Class Judicial Magistrate. Section 105 of BNSS will ensure more transparency and curb the misuse of police powers by eliminating any likelihood of the police planting fake evidence. A new sub-section (3) has also been added in section 176 of BNSS, which provides for the procedure for investigation by the police. Section 176 was section 157 in the old CrPC. The newly added sub-section (3) specifically provides that where an offence is punishable with imprisonment of seven years or more, a forensic expert shall visit the crime scene to collect the forensic evidence. It further provides that such process of evidence collection shall be video recorded. It is a noteworthy step towards greater transparency and accountability in evidence gathering by the investigating agencies.

India and Mauritius: Gateways to Africa, investment and development

Prime Minister Narendra Modi and Prime Minister of Mauritius Pravind Jugnauth jointly inaugurated several infrastructure and connectivity projects in the strategic island nation on 29 February. Prime Minister Modi also recalled his promise given to the people of Agalega island, who have been disconnected from the mainland. He even reiterated the catchphrase 'Modi ki Guarantee' in the context of India's fulfilment of promises even in the context of foreign domains of development as India continues to support the developmental aspirations of friendly people in the Global South while becoming their voice at the global stage. Fighting for their cause in an unjust world has been a major marker of Indian foreign policy. India and Mauritius are crucial and critical in the Indian Ocean Region which is facing increasing traditional and non-traditional threats. As the maritime collaboration continues to expand within and beyond the confines of SAGAR(Security and Growth for All in the Region) doctrine and IORA(Indian Ocean Regional Association) the outreach of India's non-reciprocal "Neighbourhood First" and "Link Africa Faster" encompasses the fulfillment of developmental aspirations of the Mauritians - 70 per cent of whom are of Indian



origin, courtesy the French and British colonialism.

Mauritius since 2005 has been a gateway to foreign direct investment and often aced the charts for the highest investment being routed through Port Louis into India due to a unique Double Taxation Avoidance Treaty and Convention(DTAC). The FDI accounted for over 26 per cent of the total during 2000-2022 amounting to \$161 billion. No doubt since its renegotiation the FDI via this route has come down but Port Louis still retains that ease and charm for investors. Trade is also burgeoning to over half a billion dollars.

In the developmental domain too Mauritius takes the larger pie of the cake with highimpact socio-economic, infrastructural and developmental projects let alone a large number of scholarships and capacity-building assistance provided under various Government of India programmes. These have been tailored under India's Africa policy so succinctly outlined by Prime Minister Modi during his address to the Ugandan parliament in 2018 underscoring that India believes and works for 'Africa for Africans' approach and their wishes must be respected. Projects included the metro to the community centre and developmental projects to social housing, the largest cultural centre, civil services college and the establishment of the World Hindi Secretariat. As Prime Minister Modi said India during the last decade has extended over \$1 billion in Lines of Credit and \$400 million as grants and assistance. For New Delhi, Mauritius is

ready to play a more signifi-

cant and dynamic role as a to have direct and reliable gateway to Africa as the continent moves towards greater integration charting its own course of growth and development including the African Continental Free Trade Agreement(AfCFTA). Since Africa figures prominently in India's foreign and security policy calculus and naturally and mutually sustaining partnerships, Prime Minister Modi invited Mauritius as a special guest at the G20 Summit last September and successfully engineered the African Union (AU) 's inclusion as a permanent member in the G20 making it effectively a G21. India has also been a first responder and a HADR partner in every contingency Mauritius faced from the extensive medical and vaccine assistance during the pandemic to the Wakashio oil spill accident in 2020. Even this time the Prime Minister of Mauritius has agreed to follow the Indian model in digital public infrastructure like RuPay card and UPI as well as the first country to set up an Aushadhi Centre on a similar pattern as in India's Jan Aushadhi Scheme (JAS). Prime Minister Modi and Prime Minister Jugnauth virtually inaugurated the St James jetty an airstrip and six other high-impact developmental projects to cater to the needs of the people of Agalega who will now be able

connectivity with the mainland thereby ensuring aerial, maritime and digital connectivity within Mauritius. This collaborative effort reflects the deep-rooted partnership between the two nations in addressing various challenges in the Indian Ocean region, both leaders underscored.

Mauritius is also important from the point of view of maritime strategic calculations. New Delhi has been rendering all possible assistance including joint monitoring and preventing and countering threats in the maritime domain including its extensive and Extended Economic Zone (EEZ). military coup in Operation Myanmar, 1027 was launched against the military junta Three Brotherhood Alliance members comprising the Myanmar National Democratic Alliance Army(MNDAA) from the Kokang Region of Shan the Ta'ang State, National Liberation Army also from the Shan State and the Arakan Army (AA) based in the Rakhine State. On 27 October 2023, the Alliance simultaneously attacked military outposts, police stations and took control over key cities and highways in the northern part of Shan state. The rebellion quickly spread across Myanmar and by 7 November 2023 with the launch of Operation 1107 in support of Operation 1027 many

across the country joined hands. This was perhaps one of the rare occasions in the troubled history of Myanmar where Eastern Armed Organisations(EAO) from a variety of ethnic had together in a meticucoordinated attack against the junta. AA operating in Rakhine state largely was a surprise entry in this alliance but MNDAA had been an old player in the region. Subsequently, Myanmar many observers debated the pushback by the rebel groups as a victory for democracy, with some reports stating only 30-40 per cent of Myanmar was under the control of the junta.

After long drama, WTO meet adopts outcome document

ABU DHABI: The WTO which meeting, stretched into the sixth day due to wide gaps in positions, ended early Saturday after a long drama.

Well into extra time and after five or six extensions, around 11 PM (local time), ministers finally assembled for the closing ceremony to adopt the outcome document, which was put together after India agreed to the UAE's request to extend customs duty waiver on e-commerce, covering things like Netflix movies, for

another two years.

India, Indonesia and later Brazil wanted the exemption to end, but commerce and industry ministry Piyush Goyal agreed to the proposal after UAE trade minister Thani bin Ahmed Al Zevoudi met him on Friday evening.Just when organisers had start shifting sofas to the side rooms and water dispensers had disappeared as the meeting was about to end, Indonesia sprung a surprise, refusing to



accept the outcome document, citing its reservations on the extension, though over 160 members were already on board. At WTO, the outcome document cannot be accepted unless all countries support the text.

It took around 45 minutes for things to settle down after the Indonesian side said it did not have the political mandate to support an extension. After a few calls to Jakarta, which meant waking up ministers, the Indonesian side dropped its opposition and trade ministers returned to the hall to clear the outcome document. Now, it was the turn of commerce and industry minister Piyush Goyal to invoke e-commerce clause - this time to



The group suffered a major setback in its early years when its founder Yunus Khan was killed in an encounter in 1991.UJC was a conglomerate of Pak-based Jihadi outfits to bring all terrorist outfits active in J&K under a single platform.

Aircraft fuel sales back to pre-Covid level in February

NEW DELHI: Jet fuel sales scaled pre-pandemic levels in Feb as visa-free entry allowed by several countries allured more and more Indians to foreign shores, creating additional demand from international flights on top of burgeoning domestic air travel. But diesel demand, a key indicator of economic activities, continued in the slow lane, while petrol consumption posted healthy growth on back of people's continued preference for personal vehicles. Preliminary data of staterun fuel retailers on Friday showed jet fuel sales rising marginally above Feb 2020 level, when the world had started shutting down to stop the spread of Covid. Compared to last Feb, sales were higher by 7%, while 55% increase over the same month of 2022 underpinned the turnaround in demand. On a monthly basis, sales were up 3.5%. Jet fuel sales have been struggling to recover since March 2020 when the lockdown reduced overall fuel consumption by more than half, largely due to reduced international flights. Petrol consumption was the first to recover in late 2021 as people preferred personal vehicles

Byju's unable to pay salaries as funds locked: Founder Raveendran

and CEO at troubled edtech startup Byju's hit out at a group of investors, stating that their move to disable the company from using the funds raised through the rights issue has hindered disbursement of salaries to employees. "....I regret to inform you that we will still be unable to process salaries.....Unfortunatel y, a select few (4 out of our 150+ investors) have stooped to a heartless level, ensuring that we are unable to utilise the funds raised to pay your hardsalaries," earned Raveendran said in a letter to employees on Saturday which was reviewed by TOI.

"At their behest, the amount raised through the rights issue is currently locked in a sepa-



rate account," Raveendran said, adding that despite the successful closure of its \$200 million rights issue, the company is facing a crisis. Byju's said that it is making attempts to ensure that the salaries are paid by March 10. Four of the investors— Prosus, Peak XV Partners, General Atlantic and Sofina had approached the National Company Law Tribunal (NCLT), seeking a stay on the rights issue, stating that there

of siphoning off funds

by the company's promoters and the company is being investigated by the Enforcement Directorate (ED) and Ministry of Corporate Affairs (MCA). Although the court allowed Byju's to go ahead with the rights issue, it passed an interim order, directing the startup to keep the funds received as part of the rights issue in a separate escrow account. The court also said that the funds should not be withdrawn till the disposal of the oppression and mismanagement suit
