

Sunita Williams and Butch Wilmore's missions on the ISS were extended following issues with the Boeing Starliner spacecraft. Due to a helium leak, their return, initially planned for June 2024, is now uncertain. Nasa has indicated an alternative return plan using SpaceX's Crew Dragon capsule, potentially in February 2025, posing challenges for Boeing. Sunita Williams's husband Michael shared that space is her "happy place," despite the current situation caused by issues with their Boeing Starliner spacecraft.

Michael told The Wall Street Journal that 'Space was her happy place, even if she had to be there indefinitely.' As reported by the Wilmore's wife Deanna said, "You know, we probably don't expect him until February, February or March." The Starliner spacecraft encountered a helium leak in its service module, a critical component for its operations, resulting in the astronauts' prolonged stay. Williams and Wilmore are currently on the ISS as part of Boeing's Starliner Crew Flight Test (CFT). Originally scheduled to return on June 14, 2024, their mission has been extended due to the technical issues with the Starliner. The spacecraft has been undergoing crucial testing and evaluations since docking at the ISS on June 6 to ensure a safe return.

Prayagraj: Allahabad High Court rejected the PIL filed regarding toll fee. It was argued in the petition that declaring all the lanes of the toll plaza as Fastag lanes is unconstitutional and arbitrary, due to which double the fee is being charged for not installing Fastag. Petitioner Vijay Pratap Singh argued that collection of toll and payment of road tax amounts to double taxation. The court clarified



that toll fee is collected under the provisions of Section 7 of the National Highways Act, 1956 and related rules 2008. The court accepted the argument of the defendant's lawyer Pranjal Mehrotra, which said that the facility of toll payment through Fastag is beneficial for the passengers and there is no unconstitutionality in it. The Court also said that the purpose and authority of road tax and toll charges are separate and independent of each other. The contentions raised in the petition had no solid basis, and hence it was dismissed.

Why are UN peacekeepers unpopular in Africa?

In recent news, the Democratic Republic of Congo (DRC) is gearing up for elections, but a significant security development is poised to make waves—the departure of a long-standing UN peacekeeping force. Stationed in the DRC since 2010, this force, known as MONUSCO (United Nations Organisation Stabilisation Mission in the Democratic Republic of the Congo), has become a subject of celebration as it concludes its mission. However, the jubilation is not due to the success of fostering peace but rather a reflection of the controversial legacy left by the peacekeeping mission. The DRC has been plagued by conflict for years, especially in its eastern regions, witnessing violent clashes between armed groups. The UN mission was expected to bring stability and peace to the region, but unfortunately it fell short of expectations. Instead of being a force for good, MONUSCO became entangled in a web of criticism and controversy. The primary reason behind the lack of enthusiasm for MONUSCO's departure is its perceived ineffectiveness. Despite its decade-long presence, the mission did not succeed in quelling the ongoing conflicts in the region. Moreover, the peacekeepers themselves faced accusations of misconduct including involvement in sexual abuse scandals. The issue was not confined to the DRC alone, as similar incidents have marred UN peacekeeping missions in various parts of the world. One glaring example is the reported cases of sexual exploitation and abuse by peacekeeping personnel, as documented by the UN itself. The perpetrators, often repatriated to their home nations, rarely faced legal consequences, contributing to a pattern of impunity that has tarnished the reputation of UN peacekeeping forces globally. The backlash against UN peacekeeping missions is not unique to the DRC. Across the globe, these missions are increasingly viewed with scepticism. The fundamental issue lies in the structural problems inherent in these operations.

Structural challenges

UN peacekeeping forces lack a standing army and rely on member nations to contribute soldiers voluntarily. This practice,

US can't build a meaningful strategic partnership if it stays blind to India's core concerns

American exceptionalism dies hard. A messianic belief in own superiority, virtuousness and indispensability that has remained constant for the last two centuries shapes its foreign policy outlook and governs its gaze towards other sovereigns. This is and has been a common trait of all great powers. It looks great during unipolar moments, but as middle powers become more influential, power is diffused, balance shifts and unilateralism slowly erodes, the sense of entitlement seems out of place. Consider the fact that the United States is trying to develop a meaningful strategic partnership with India, a rising middle power with great power aspirations with whom Washington has dramatically transformed its relationship across a range domains, and yet it insists on extracting taxes and paeans from its purported strategic partner while appearing blissfully unaware of issues that are central to India's security concerns, such as terrorism and separatism. American insularity, even when unintentional, can be disconcerting. US ambassador to India Eric Garcetti had let slip in September that India has invited Joe Biden as the chief guest for Republic Day, that would have made Biden the second US president to attend the celebration after Barack Obama. After a period of suspense, Washington told New Delhi last week that Biden won't be able to make it due to "scheduling demands". India

wouldn't have made the invitation official or even public before getting a confirmation from the White House, but Garcetti's indiscretion puts New Delhi in a tight diplomatic spot. It couldn't have shortlisted a second option before Biden's denial, and whoever it approaches now to grace the occasion, a day of immense importance for the Indian Republic, will get an impression of being the second choice. The fiasco also leaves India seemingly at the receiving end of a nasty snub, at a time when America has levelled a "serious allegation" that a serving Indian government employee is involved in an assassination plot of a designated terrorist, an American citizen, on American soil. The plot was apparently foiled, and an Indian citizen named Nikhil Gupta has been detained by Czech authorities in Prague pending extradition to the US. The US over the century unfolding",

Justice department unsealed an indictment on November 29 in a New York court, claiming that an Indian spy had ordered a 'murder-forhire' plot through Gupta, an intermediary, to take out a separatist named Sikh Gurpatwant Singh Pannun, chief of the banned outfit Sikhs for Justice (SFJ) whom New Delhi identifies as a terrorist involved in instigating violent secessionism to carve out a Sikh theological state, Khalistan, out of India. The timing and manner of Biden's announcement left both sides scrambling to deny any link between the so-called murder plot and its investigation. US national security adviser Jake Sullivan told Washington Post that Biden "remains personally committed to carrying forward this partnership, which he has often described the most consequential partnership for the United States

and that both leaders have "affirmed a vision" of the two countries as "among the closest partners in the world" and that their partnership in emerging technologies, space and defence will continue. Sullivan also told the Hindustan Times that Biden shares a "close personal bond" with Prime Minister Narendra Modi and looks forward to engaging with Modi "in the weeks and months ahead". The severity of the protestations, that the US side was forced to make through media outlets to delink the two incidents, point to a culture of callousness in Washington's public diplomacy that has almost become systemic. As if the US is so convinced of its indispensability that it expects its allies and partners to absorb and adjust to its guirks. It also throws into sharp relief the more meascalibrated and ured approach to ties that India

brings to the table.

Throughout the Pannun episode, the one impression that the US has managed to get across is one of inconsistency and contradiction. The Biden administration has been at pains to sequester the controversy to insulate the relationship. The day after the US DoJ unsealed the charges and the story exploded on public domain, **US National Security Council** spokesperson John Kirby called for "accountability" while insisting that "India remains a strategic partner, and we're going to continue to work to improve and strengthen that strategic partnership with India. There have been countless highlevel visits from the Biden administration to manage the crisis while sending out a message of stability, commitment, and continuity. But the signals have been mixed, mercurial, and even paradoxical. While the executive is trying to fix the issue and move on, that can't be said about the US Department of State, the heavily politicised DoJ, US senators who have their own fat to burn or the security establishment, the perma-bureaucracy of the so-called 'deep state'. In a previous column, I dwelt at length on the glaring inconsistencies and loopholes in the indictment that gives the impression that we are reading the script of an Austin Powers flick. No doubt some of these aspects would be highlighted in the looming legal battles ahead.

What Wild Wild West of influencing is telling you about influencers

In the month of August this year, in her own children? The answer is simthe American state of Utah, a 12- ple: This world of influencing is like the wild, Wild West. Laws are inadequate. Regulatory oversight is lacking. So disorder prevails. Anyone with a mobile phone having access to the internet can become an influencer. Once they do, money comes easily and frequently, there is a term for this which is called the "creator economy". It is powered by millions of people who are building and monetising their own brand selling products, advice, inspiration, attention, and even fun to their followers. It may sound superficial. But this industry is projected to reach 480 billion dollars by 2027. Of some 2,000 global brands, 80 percent use influencer marketing, and 54 percent youngsters say they would become influencers if they could. Seems almost euphoric, but it really isn't. There are big loopholes here: Why are influencers saying what they are? Are they being paid to do so? Can you really trust what they say or do?

Security walls and closed doors: Unravelling Global North's refugee response

The number of refugees hosted by the Global North is much smaller. It is estimated that only 27 per cent of the refugees and asylum seekers are in countries of the Global North. More than just the distance refugees have to travel to get there, it's the security walls that these nations have built over decades and the new mechanisms that are created every passing year, that deter refugees from seeking entry. As forced displacement and refugee outflow reach unprecedented levels, policies and actions of the Global North are being driven by fear, self-inter-

est and racism. Asylum routes are vides for the pushback of mostly being shut down and irregular routes weaponised forcing people to death. This approach has been followed for decades now - prevent any inflow, except if it is for cheap labour and temporary residence. In contravention to the Convention and Protocol Relating to the Status of Refugees (which includes both the 1951 Convention and the 1967 Protocol), most European countries and the US have only tightened anti-migration and refugeeaccepting approaches. Italy's recent anti-migration plan pro-

male asylum seekers of adult age rescued in the central Mediterranean whom Rome does not deem qualified for international protection. UK's Illegal Migration Bill plans to house illegal migrants on ships before sending them back to their country of origin or a third country that is deemed safe. A settler colonial state itself, the Government of Australia had in 2012 set up offshore processing of asylum seekers arriving by boat to Nauru and Manus islands in Papua New Guinea. More recently, the United

Kingdom arrived at a bilateral deal with the Government of Rwanda for offshoring asylum seekers on Rwandan land, till their applications were processed. In 2021 the then Danish minister for immigration and integration has obtained from Denmark's Parliament a bill requiring all applicants seeking refugee status to be relocated to a "non European" country preferably in Africa while their situation was assessed with no eventual guarantee to be transferred to Denmark. Though it was later put on hold given group resistance, the trend continues.

It is now almost certain that elections will be held for the Pakistan National Assembly (NA) as well as the country's four Provincial Assemblies on 8 February. The Election Commission confirmed the election date after the Supreme Court cleared objections raised by the Lahore High Court against the appointment of civil servants as returning officers for the polls. The Supreme Court has also brushed aside specific grievances with the delimitation exercise. It held that as the election date has been announced these objections cannot be entertained. After the delimitation exercise the strength of the NA is 336. Of these 266 are to be general seats, 60 seats will be reserved for women and 10 for non-Muslims. The women and non-Muslim seats will be allotted to the parties on the basis of their performance in the general seats. The allocation of general seats on a provincial basis is thus: Punjab—141, Sindh—61, Khyber Pakhtunkhwa—45, Baluchistan-16 and the Federal Capital area—3. This election, as those in the past, will be won or lost on the basis of the performance of the parties in the general seats. Also, as in the past, Punjab has more seats than the combined number of the other three provinces and the Federal Capital Area; thus, the party which controls Punjab controls Pakistan. This is a permanent feature of Pakistan's political life. Army chief General Asim Munir will seek to make sure that former prime minister Imran Khan's Pakistan Tehreek-e-Insaaf (PTI) does not succeed in the elections. The events of 9 May when the PTI workers and supporters attacked army installations and the monuments of martyrs have ensured that the gulf between Khan

and Munir cannot be bridged. Khan has been in prison since May because he has been charged in a number of cases and the courts have not given him bail. Munir has also purged a large number of senior officers who were believed to have sympathies for Khan. The army is, therefore, firmly under his control. There have been desertions of leaders from the PTI. As of now, it appears that the army's desire to finish off the PTI electorally will prevail. With that, the PML(N) of the Sharifs should succeed in the Punjab. Its chances have increased with the return of its leader Nawaz Sharif two months ago from London where he has been since 2019.

However, Nawaz Sharif, thrice prime minister in the past is a shadow of the political leader he was. He looks infirm and without vigour. Instead of rousing his supporters and others by giving out a firm programme which will seek to resolve Pakistan's myriad problems, beginning with its grave economic situation, he is obsessed with the past injustices he and his daughter Maryam Nawaz have had to face. He is railing against his past adversaries, including the army, which manoeuvred the 2018 national elections in favour of Imran Khan. Nawaz Sharif is relying on Munir to create conditions which will tilt the electoral field in PML(N)'s favour in the polls. It was he who had insisted that Munir should succeed the former army chief General Qamar Bajwa in November 2022 even though there were technical difficulties in his elevation to head the army. Obviously, Nawaz Sharif feels that Munir nurses great grievances against Khan going back to the period when Khan, as prime minister, had pressured Bajwa to oust him from the DG ISI's post.

The government issues clarification on documents needed for citizenship under CAA

NEW DELHI: The centre has expanded the ambit of the rules issued under the citizenship law CAA through which Indian nationality will be given to persecuted minorities coming from Afghanistan, Bangladesh, or Pakistan. The Union home ministry announced that "any document" issued by the central or state governments or quasi-judicial bodies in India proving that either of the parents, grandparents, or great-grandparents is or has been a citizen of one of the three countries will be acceptable. The clarification of the home ministry came after many applicants seeking Indian nationality under the Citizenship (Amendment) Act, 2019 were reported to be facing difficulties due to a particular clause of the Citizenship (Amendment) Rules, 2024. "Any document that shows that either of the parents or grandparents or great grandparents of the applicant is or had been a citizen of one of the three countries i.e. of Afghanistan or Bangladesh or Pakistan," the earlier clause of the Citizenship (Amendment) Rules, 2024 says. In its latest clarification, the home ministry said: "It may be clarified that the documents under Sr No. 8 of the Schedule -1A may include any document issued by the central government/state government/ any judicial or quasi judicial body in India such as land record, judicial order etc., identifying or representing that the applicant or the parents or grandparents or great grandparents had been a national of Afghanistan or Bangladesh or Pakistan.

Dist judges retiring as HC judges get Rs 15k-25k as pension. How will they survive, asks CJI

NEW DELHI: The Supreme Court on Thursday expressed grave concern over the pittance of pension — between Rs 15,000 and Rs 25,000received by retired HC judges, who were appointed as HC judges after spending their entire life in the district judiciary.

These concerns were expressed by a bench of CJI D Y Chandrachud, and Justices J B Pardiwala and Manoj Misra after amicus curiae K Parameshwar sought early resolution of the issues relating to pensions of district judges, who get appointed as HC judges. The amicus had been advocating upward revision of the pension commensurate with the dignity of district judges. With both attorney general R Venkataramani and solicitor general Tushar Mehta present before the bench, CJI Chandrachud made an impassioned request to the top law officers to use their good offices for a satisfactory resolution of the vexed issue. When the AG said the govt



needed some time to ponder over the issue which has multiple dimensions including huge financial burden, the CJI said, "I see your predicament. But look at the persons from district judiciary who after being appointed as HC judges have a tenure of less than four to five years. They get a pension of Rs 15-25,000. Their tenure in the district judiciary is not counted. We have a slew of petitions by such retired HC judges."



A/to Meta, Facebook news may be blocked in Australia

Delhi: A corporate spokesman told a parliamentary hearing that Facebook's parent company, Meta, is thinking of removing news content from the platform in Australia if government the requires it to pay license costs. When questioned if Meta will prevent Australians from sharing news material in order to avoid paying fees, Mia Garlick, regional policy director for Meta, responded to lawmakers by saying that "all options are on the table". According to her, Meta was awaiting Canberra's decision on whether to implement an unproven 2021 law that would allow the government to determine how much US tech companies must pay media outlets for links. The statements provide the most evidence to date that Meta will adopt the same strict stance in Australia as it did in Canada in 2023 when that nation enacted



legislation of a similar nature. When the law was introduced in Australia, Meta signed agreements with News Corp and the Australian Broadcasting Corp, among other Australian media companies. However, Meta has since stated that it will not extend those contracts past 2024. The assistant treasurer of Australia will now have to determine if she wants to intervene and make Facebook pay for journalistic material. According to the assistant treasurer, Meta appears to follow the law only when it is convenient, but he is still gathering advice. Meanwhile, enacted."

World Bank Backs India's Green Hydrogen Drive

Delhi: India's Green Hydrogen Mission received a second \$1.5 billion loan from the World Bank, raising its total financing to \$3 billion. To meet National Green Hydrogen Mission goals, India's domestic green hydrogen market must be strengthened and private investment encouraged. Auguste Tano Kouame, World Bank's Country Director for India, praised India's success, highlighting \$70 billion in tenders and indications of interest. Green hydrogen generation will benefit from Second Low Carbon Energy Programmatic Development Policy Cooperation changes, focused on electrolyzers. The program supports renewable energy improvements, including battery energy storage subsidies. The World Bank wants India to produce at least 450,000 metric tons of green hydrogen and 1,500 MW of electrolyzers by FY 2025-26 under this program. Increasing private sector involvement is crucial. Mr. Kouame said, "Indian green hydrogen production is safe. The administration has taken substantial steps, and no limits appear." He suggested that banking partnerships might improve the local market and that regulatory frameworks should be expedited to attract private firms. One of the World Bank's most ambitious undertakings is in India's green hydrogen sector. If successful, India might become a leading green hydrogen generator, creating green jobs. Mr. Kouame noted, "India's Green Hydrogen Mission seeks 600,000 jobs, a large number for one industry. These less labor-intensive, knowledge-based employment are inclusive, especially for women."

He said DDA documents showed deputy governor VK Saxena and a chief engineer went to Satbari forest on Feb. 3 and verbally ordered 1,100 trees removed. Emails from DDA officials prove this, he added.

Panel warns officials about illegal tree cutting

Delhi: A three-member Delhi ministerial fact-finding committee has issued letters to senior DDA, forest, and Delhi Police officials for reportedly destroying 1,100 trees in Ridge without authorization. On Saturday, ministers Atishi, Saurabh Bharadwaj, and Imran Hussain constituted a committee to report to the forest minister. Does the opposition's request for a SC-appointed inquiry into NEET-UG 2024 irregularities make sense? The committee has ordered the principal secretary, DDA vice-chairman, principal commissioner (LD and LM), DDA commissioner (housing), deputy commissioner of police (south Delhi), station house officer (SHO), and other senior officials to attend a July 1 meeting. The committee's factual report to Supreme Court is due July 11. "As the next date of hearing in this matter is 12.07.2024 and the Hon'ble Supreme Court has directed GNCTD to file an affidavit based on the facts before 11.07.2024, your cooperation is needed to adhere to the strict timelines imposed by Supreme Court of India," Bharadwaj wrote in his email. Delhi's government and civic agencies were ordered to meet to consider comprehensive green cover measures by the court. A vacation bench of Justices Abhay S Oka and Ujjal Bhuyan expected the forest department and tree authority to monitor illegal felling.
