PM cited the remarks of Shiv Sena (UBT) leader Sanjay Raut likening him with Aurangzeb as he said, "The govt has approached the electorate based on its performance in the past 10 years. And it has also started working on a

roadmap for 100 days in its third term. On the other hand, the opposition parties are setting a new record. Today, Modi was abused for the 104th time. ### No decision yet on BJP-BJD tie-up, will beat 2014 record in UP: Shah

A decision is yet to be taken on a possible alliance with the Biju Janata Dal (BJD) but the Bharatiya Janata Party (BJP) will increase its numbers in Odisha this year, Union home minister Amit Shah said on Wednesday, attacking the Opposition over the recently implemented

(Amendment) Act, or CAA. Shah said that the BJP will get more than 25 Lok Sabha seats in West Bengal, which has 42 Lok Sabha seats, this year, and will break its 2014 record of 71 seats (73 including allies) in Uttar Pradesh. "We don't know yet if we will have an alliance (with BJD) or not. If we do, we will work as allies, and if we don't, we will fight to form the government alone. A decision will be taken by our national president," Shah said at News18's Rising Bharat Summit in New Delhi.

"People of Odisha love



Prime Narendra Modi very much. We will have many more seats there (Odisha) this time," he added. Odisha will vote in the Lok Sabha and assembly polls simultaneously in four phases on May 13, 20, 25 and June 1. There are 21 Lok Sabha seats and 147 assembly seats on which elections will be fought, with the BJD, BJP and Congress as key opponents.In 2019, the BJP had won eight and the BJD 12 Lok Sabha seats. In the assembly, the BJD won a landslide victory with 112 seats and the BJP won 23 seats. Shah's comments came amid mounting speculation about a Lok Sabha seats will go

#### **Jobs-linked PLI** scheme to boost several sectors'

Obviously, good indicator of the pack is that the platform or base is very very strong. Second is that in spite of global uncertainty and also the issues which have been faced in different markets, India has managed to stand its own ground. There are obviously two reasons for it. First, is that investment in infrastructure has made the difference in terms of making India more competitive and cost competitive. Second, the real benefit India has seen are gains from digital journey, and the fact that India is seen as the only growing market in world, is building the virtuous cycle. Across all sectors, you would see a good trajectory. Let us step back for a minute and look at the percentage of private capex investment. While obviously we won't have current year data, but if we look at approximately, it is between 36-37% of private sector capex investment, which is actually backing the economy. If we look at 2021-22, it was, I think, 36%. If you look at 2022-23, it was 37% and if we look at 2023-24 also, more or less, we are talking about 36-37%. If you look at it as a percentage, I don't think we are going down in any form or manner. It is not right to say that private sector capex is not happening. Private sector capex is happening and as a percentage, it is fine. Now, next issue which happens is how do we look at it from the perspective of growth parameters. I have explained to you earlier but now we have even more, I would call it proof of that because as the CEO poll, which we did as late as December as well, across steel, cement, energy, automotive, every sector that you look at, all of them have crossed the threshold of 75-85% capacity utilisation and in some cases, it is as high as

95% utilisation.

### **Gujarat to punish victims, witnesses** if ragging incidents not reported

Gujarat govt on Tuesday issued a govt resolu-(GR) and informed the Gujarat high court about it on Wednesday. This was undertaken after the

The punishment scribed for perpetrators of ragging is suspension from the institute, withdrawal of scholarship, debarment from exam and educational events, withholding results, expulsion from hostel, cancellation of admission, suspension from academic activities for up to four semesters, expulsion from the

#### South Asian country Army inducts first lot of desi anti-drone systems for China border deployment

**NEW DELHI:** The Army has now inducted an initial lot of seven new indigenous integrated drone detection and interdiction systems (IDD&IS) for deployment along the northern borders with China, even as DRDO is working on more powerful directed weapon systems in shape of high-energy lasers and high-powered microwaves. The vehicle-based IDD&IS, which provide for both "soft kills" of hostile drones through jamming and "hard kills" through lasers, has a detection range of 5 to 8 km. While the "soft kill" can jam the drones at ranges from 2 to 5

the effective "hard kill" range is over 800 meters."Produced by DRDO and Bharat Electronics, these IDD&ISs are Mark-1 variants inducted by the Army Air Defence (AAD). They will add to the existing counterdrone systems. There will, of course, be advanced IDD&IS versions with longer interception ranges," an officer said.

"The systems provide

an integrated capability

to detect low radar cross-section drones or unmanned aerial vehicles (UAVs) and enable their destruction through integrated application of soft and hard kills," he added. # Women now account for nearly 48% of Ayushman hospitalisations

NEW DELHI: Women account for nearly 48% of authorised hospitali-Ayushman Bharat-PM Jan Arogya Yojana (AB-PMJAY), data accessed by TOI show.

Top officials in National Health Authority (NHA), implementing agency of the scheme, told TOI that since its launch in 2018, 6.5 crore hospitalisations have been made under the scheme which involved treatment cost of Rs 81,979 crore. Of this, 3.2 crore hospitalisations for Rs 39,349 crore involved women. Officials said scheme utilisation by women beneficiaries has been higher than that of men in 10 states/UTs -Meghalaya (68%),

#### Curious case of the 'missing' East-West Metro passengers in Kolkata

Kolkata: A curious case of passenger mismatch has emerged underground with Metro Railway officials noticing a significant disparity in the number of people buying tickets to ride in the East-West Metro and the actual riders on its trains. That is because thousands entering through Howrah Maidan for joyrides are buying single journey tickets but taking multiple rides without disembarking from the train.

Officials said even if the registered ridership on Day One was 70,204, the actual number of rides could have been well past a lakh. "On Saturday, an ideal weekend for joyrides on India's first under-river Metro, the

actual passenger count must have been around 80,000 and not 67,240," mused an official. A train on the Esplanade-Howrah Maidan line takes the same tunnel (either the Sector V-bound or the Howrah-bound) on returning Esplanade to Howrah Maidan because there is no crossover for switching tracks at Esplanade. "The passengers from Howrah Maidan or Howrah Metro station continue to sit in the train after it reaches Esplanade and halts for a few minutes. Then they return to Howrah Maidan or Howrah, viewing the blue LEDlid under-river stretch for the second time. All on a single ticket," the official said.

**Lucknow:** Just as whisky is not only a man's drink, the liquor business is not for men only — at least in the City of Nawabs.

As per latest data as many as 370 out of 1,046 liquor shops in Lucknow have been allotted to women entrepreneurs this fiscal. In high spirits: One-third liquor thekas to be helmed by women in Lucknow this yr

From April 1, the women shop owners will take over the reins of more than one-third of the business which has been predominantly dominated by men in the past. Officials said that overall

participation of women has increased by 7% compared to the previous year in Lucknow and more shops have been taken over by women this time. Though no special incentives or relaxations are offered to the women, the upwards trend shows women are no more hesitant to take a plunge into the alcohol trade. District excise officer of Lucknow, Rakesh Singh said, "35% of the total licenses issued for the next financial year have been obtained by women entrepreneurs. As numbers of female applicants have been

going up over the past three years, their participation is also increasing in the same proportion." The maximum interest among the women has been for IMFL liquor shops through which trade of whisky, vodka, rum, gin and wine takes place followed by beer shops. ### PSU banks lead decline in complaints with regulator

Mumbai: RBI's integrated ombudsman has recorded a decline in the volume of grievances from regulated entities in FY23. Grievances dropped to 2.35 lakh in FY23 — a nearly 39% reduction from the 3.8 lakh recorded in FY21. This marks the second year in a row with a significant decrease in com- decrease or 72,830 in grievances from the plaints, following last year's drop to 3 lakh. Between 2020-21 and 2022-23, the public sector banks category experienced the most

substantial fall in griev-

ances, declining from



1.75 lakh to 1 lakh. This signifies a 41% fewer complaints.

Conversely, within the same period, the nonbanking financial companies category saw an increase in grievances, climbing from 31,158 to 33,072 — an rise of

1,914 complaints. Despite a sharp decline nublic sector, private, and foreign banks compared to the pandemic complaints years, against payment banks rose from 2,168 in FY21 to 3,456 in FY23.

Regarding categories,

most grievances are related to mobile and electronic banking. From 2020-21 to 2021-22, this category saw a modest reduction in complaints from 44,385 to 39,388, yet the proportion of overall complaints increased from 14.7%. to However, from 2021-22 to 2022-23, there was a significant rise in complaints (from 39,388 to 39,855) and their share of the total (from 14.7% to 20.3%). The decline in complaints was due to the drop in grievances under the 'others' category.

#### Man gets 3-week parole to arrange for fine amount

#### Any potential aggressor will face defeat

Vladimir Putin has threatened the use of tactical nukes during the Ukraine War five times and followed it up with some actions alarming NATO. On 24 February, 2022, the day he launched his "Special Military Operation", the Russian president said, "Any further expansion of the North Atlantic alliance's infrastructure or the ongoing efforts to gain a military foothold of the Ukrainian territory is unacceptable for us." Russia "has a certain advantage in several cutting-edge weapons. In this context, there should be no doubt for anyone that any potential aggressor will face defeat and ominous consequences should it directly attack our country". On 21 September, he repeated his Nthreat . "In the event of a threat to the territorial integrity of our country and to defend Russia and our people, we will certainly make use of all weapon systems available to us. This is not a bluff." On 30 September, Putin indirectly hinted at the use of nukes to protect Ukraine's illegally annexed regions of Donetsk, Kherson, Luhansk and Zaporizhzhia "with all the forces and means at our disposal". In February 2024, when French President Emmanuel Macron didn't rule out the deployment of NATO troops in Ukraine, Putin said, "Everything that the West comes up with creates the real threat of a conflict with the use of nuclear weapons, and thus the destruction of civilisation." This month, Putin said that if American troops are deployed in Russian territory or Ukraine, Russia would treat the move as an intervention. "From a military-technical point of view, we are, of course, ready [for a nuclear war]," he said. In some cases, Putin's actions indicated that he might resort to a tactical nuclear attack. On 27 February, 2022, he put the Russian Army's deterrence forces on high combat alert as top NATO officials were "indulging in aggressive statements directed" at Russia. On 25 March, 2023, Putin announced plans to deploy Russian tactical nukes in Belarus . In March 2024, Russia tested the nuclear-tipped RS-24 Yars ICBM, which travels at Mach 14 and has a multiple independently targetable re-entry vehicle.m One month after Putin's September 2022 threat, US President Joe Biden reacted on expected lines. "We have not faced the prospect of Armageddon since Kennedy and the Cuban Missile Crisis," he said CNN's chief national security analyst and anchor Jim Sciutto's book The Return of Great Powers, released this month, claims that an "analysis and highly sensitive new intelligence" showed that Russia wanted to use a tactical nuke against Ukraine in 2022. Sciutto claims that a senior US administration official told him that the fear wasn't "just -hypothetical".

# India's foreign policy, as of other countries, is determined by permanent factors

National interest in a broad sense can be defined: peace. security, economic development, prosperity for the people, a friendly neighbourhood. But this is not dependent only on national will. The interests of other countries can conflict with the interests of another; the world is becoming interdependent and so instability elsewhere can have a wider impact. A conflict can be inflicted on a country despite its interest in maintaining peace. Its security can be threatened by a powerful neighbour. The definition of national interest is thus subject to variables. India is one of the biggest countries in the world, an old civilisation, it has a self-image of a country that cannot subordinate itself to others and should have an independent role in international affairs.

Having emerged from colonial subjugation, it could not align itself with the West and give it control of its foreign policy. It chose to be nonaligned during the Cold War. This basic foundation of India's foreign policy is reflected today in its attachment to strategic autonomy, friendship with all to the extent possible, and balancing its external relations to increase its freedom of choice. The international situation is not static and therefore changes that occur



the collapse of the Soviet Union with which we had very strong ties. It was our biggest trade and defence partner. It played a vital role on our behalf on the Kashmir issue in the UNSC and in the 1971 war that led to the creation of Bangladesh.

During the period of US unilateralism when we were subject to huge pressure by the US on Kashmir, human rights, our nuclear and missile programmes, we became part of the RIC dialogue which later evolved into BRICS as a balancing act, even as we also began to improve our ties with the US in the context of the new geopolitical realities. We have persevered in maintaining close ties with Russia, with regular annual summits from 2000 onwards till 2021. Russia has never imposed sanctions on us. We have resisted western sanctions on Russia. We bought the S 400 air defence system despite the threat of secondary US require adjustments in for- sanctions. We have desisted

eign policy. Take for instance from condemning Russia's military intervention in Ukraine. Russia has become our biggest oil supplier. All this while our ties with the US have become stronger, with defence trade with Russia declining and that with the US, France and Israel increasing. An increase in a country's economic growth helps in the pursuit of a more active foreign policy. China's case is instructive. As it has grown economically, it has acquired the economic and financial muscle to pursue a more assertive foreign policy, beside strengthening its military muscle. India too is rising economically, and as it becomes a \$5 trillion economy and beyond, its ability to pursue its interests on the global stage will increase. Already, India is acting more confidently on the international stage, having become the 5th largest economy and set to become the 3rd largest before 2030. India is today being engaged by foreign powers as never before. The

relationship with India is a defining one in the 21st century. President Putin pays lavish compliments to Modi and India, stating that India under Modi pursues its national interest and resists pressure to the point that it has even surprised Putin India's foreign policy has been deeply affected by its partition and the creation of Pakistan which has tried to undermine India internally and externally since its creation, with war, terrorism, religious mobilisation of the Islamic world against us, and constantly internationalising the Kashmir issue. India has been on the defensive for decades on the Kashmir issue, accepting, in particular, US and UK interference on Pakistan's behalf. This defensiveness explains why despite continuous provocations from Pakistan, India has engaged Pakistan in a dialogue, even after the attack on our Parliament and the horrific Mumbai attacks, with a willingness to accept the inclusion of Kashmir as an agenda item in our composite dialogue. 

To my jaundiced eye, in that list of seven, the only ones that really matter are (1) and (2). They are precise and progress towards them can be quantified and measured. In passing, no timeline is stated for (6) and (7). They are openended, illustrating the vagueness.

### **Chhattisgarh security force** officer axed to death by Maoist hit team

RAIPUR: A Chhattisgarh Armed Force (CAF) officer was hacked to death by a Maoist hit team in Bijapur district of Bastar on Sunday morning. He was buying vegetables from a local market.

Inspector Tijau Ram Bhuvarya was killed barely 100m from the recently set up Jaigur security camp in Kutru (445km from Raipur) in Chhattisgarh, police said. The region is a Maoist hotbed, close to the Maharashtra border, locations like Gangaloor, Kirandul and Bhairamgarh have seen many a gun battle. Bhuvarya, head constable Shyam Bihari and some other personnel were out to buy vegetables on Sunday morning. Two Maoists, disguised as villagers, attacked him with axes and fled before anyone could challenge them.

By the time help arrived, the inspector had bled to death. He hailed from Bargaon village in Kanker district, around 345km north of where he was posted.

Bijapur SP Jitendra Kumar Yadav told TOI that it's the modus

operandi of small 'action teams' of Maoists to execute such attacks in public places, particularly weekly markets. "They attack all of a sudden and flee the spot within seconds," he said.

The attack comes barely 10 days after the Maoists' Dandakaranya **Special Zonal Committee** demanded "creation of a favourable environment for talks."

The insurgents were responding to deputy chief minister Vijay Sharma's offer unconditional talks via video-conference.



# NCERT is likely to continue with rationalised textbooks

Delhi: People familiar with the matter said the National Council Educational Research and Training (NCERT) is likely to continue with rationalised textbooks for several classes, including classes 10 and 12, in the upcoming academic year beginning next month. New textbooks for all classes in



2024-25 are "highly unlikely". Based on the new national curriculum framework, the council is creating new school textbooks. Officials acquainted with the subject say new textbooks for numerous classes, including 10 and 12, are unlikely before the school year."Textbook drafting is meticulous and cannot be rushed. All mistakes must be avoided. This year, the NCERT may publish textbooks for various primary classes

including class 9. A senior NCERT official stated, anonymity, that textbooks with rationalized curriculum will continue in other courses in 2024-25. The council told the CBSE in its previous curriculum committee meeting that the new 9-12 textbooks will not be released this year. "The board must release class 10 and 12 sample papers before a new session. In its last curriculum committee meeting, the board decided to

condition that it may be reviewed if the NCERT delivers books of classes 9 to 12 before April 2024, a senior CBSE official said. The books will likely not be issued before then. In June 2022, NCERT rationalised classes 6-12 curricula to "reduce the content load" on children because to the COVID-19 pandemic. In new textbooks published last year, the council eliminated chapters on Mughal courts, 2002 Gujarat riots, cold war, Mughal emperors, emergency, and periodic table. The updated books also deleted about passages Mahatma Gandhi, his assassin Nathuram Godse, and RSS's ban after Gandhi's assassination.

#### No change in JEE (Main), **NEET-UG, CUET-UG dates**

Delhi: JEE (Main), the engineering entrance test for centrally funded colleges and eligibility test for IIT entrance (JEE-Advanced), is scheduled between April 4 and 15, outside of the election date schedule. NEET-UG is on May 5 and CUET-UG is on May 15-31, as announced. NTA director general Subodh Kumar Singh said NEET-UG, the admission test for medical, dental, and allied health courses, will be held as scheduled since there is no voting on May 5 or the day before or after.

About CUET-UG, which is being registered online, NTA is not modifying the exam window but will decide on the dates later. We kept May 15-31 for CUET-UG. Singh said a final call will be made following registration.



#### PIB's fact check unit

**NEW DELHI: The min**istry of electronics and information technology on Wednesday notified the Centre's 'fact check unit' as per IT rules under the Bureau. The move comes weeks after Bombay HC refused to restrain the Centre from notifying the FCU, a decision that has been challenged in SC, which will hear the plea Thursday.

The FCU is empowered to decide if an information uploaded on online platforms and social media is accurate or not. In case, the data is found to be "fake", "false" or "misleading", the platform will have to take down the information that is brought to its notice by the FCU or run the risk of losing "safe harbour" status. The "safe harbour" clause in Information Technology Act provides legal immunity

to platforms.



Keeping the windows open while driving at high speed can be damaging as the direct wind can hit the eyes, causing injuries. To facilitate air circulation in such cases sunroofs are designed to recirculate the air within the vehicle without significant

disturbance. However, many individuals misuse the sunroof to stand out of the vehicle, sometimes to enjoy and sometimes to show-off, which poses a danger, particularly to the children.

"We've made this decision as the conference will be presided over by T M Krishna," Ranjani and Gayatri said in their social media posts. "We won't go anywhere if he is there. We are boycotting the entire season at the academy," Rajani said. The academy, she said, has not been considerate of the feelings of artists and

"We believe in a value system that respects art and artists, vaggeyakaras, rasikas, institutions, our roots and culture. We would be in moral violation if we were to bury these values and join this year's conference," the sisters' post stated. Krishna "has caused immense damage to the Carnatic music world, wilfully and happily stomped over the sentiments of this community and insulted the most respected icons like Tyagaraja and M S Subbulakshmi," it added. Krishna's actions have tried to spread a sense of

shame in being a Carnatic musician, vilified the fraternity, and have been exhibited through his consistent denigration of spirituality in music, the sisters claimed. They also said it would be dangerous to overlook his glorification of Periyar, who "proposed genocide of Brahmins", "abused women of the community" and "worked to normalise filthy language in social discourse".In a letter to Music Academy president N Murali — a copy of which was posted on social media — Dushyanth Sridhar said he had a "sea of ideological differences" with Sangita Kalanidhi designate of 2024. "I have no authority to question the selection of his name for the award. I am pained by many of his public statements on Dharma, Ayodhya, Sri Rama, and more," he said, adding it would be disrespectful to the values of life and teachings of Bhagavat Ramanuja, Vedanta Desika, and Kanchi Paramacharya to perform immediately after the

award ceremony.
