





Musk's child, Xavier, who now identifies as Vivian Jenna Wilson, underwent a name and gender change in 2022.

Musk asserts that he was pressured into approving puberty blockers for Xavier under false pretenses, claiming that he was told the child was at risk of suicide.

District Road Safety Committee meeting concludes

Prayagraj: District Road Safety Committee meeting was held under the chairmanship of Additional District Magistrate Finance and Revenue Special Correspondent Prayagraj, Sanyam Bharat, District Road Safety Committee meeting was held in Sangam Auditorium on Wednesday under the chairmanship of Additional District Magistrate Finance and Revenue Vinay Kumar Singh. It was told in the meeting that road accidents in the district were 87 in June 2024 compared to 127 in June 2023, which has decreased by -31.49 percent. Instructions were given to reduce road accidents by 50 percent in the coming month. The PDA was directed to close illegal cuts on the roads within the PDA and Municipal Corporation



areas in the urban areas. In view of the major accidents, the Chief Medical Officer was directed to keep Trauma near various national routes leading to the city and to

conduct physical health tests of school vehicle drivers and transport drivers. The department should take action against school vehicles operating without fitness. Health check-up of all the drivers and conductors of the district should be done in hospitals. Effective control should be maintained by determining the routes for running e-rickshaws in the city area. The branches of trees falling on the roads in the city area should be cut and trimmed so that the signal is clearly visible.

Police Department and Traffic were directed to send police station wise list of road accidents. To prevent over speeding, challan action should be taken by the Police Department (Traffic) and Transport Department. Traffic police were directed to take action against vehicles parked at illegal parking/encroachment sites. Effective action should be taken regarding vehicles not parking on the left lane. Public address system should be activated. Pending hit-run cases should be resolved. Transport Department, Health Department and Police Department were directed to select the eligible candidates for Good Samaritan and provide their list. Beautification work should also be done through gardening, this will further enhance the beauty of the city. The toilets installed there should be kept clean. He said

The bones of the hand were fractured and the blood supply was cut off as the muscles and nerves of the hand were also damaged.

patient was brought to life amidst heavy bleeding. He was brought in a critical condition and if there had been any delay in reaching the hospital, he could have lost his right hand. Fortunately, a multi-disciplinary team of emergency, anaesthesia, orthopedic and plastic surgery began the procedure. After carefully removing the machine from the arm, the tendons and nerves were repaired and the blood supply was restored. Un-

fortunately, the index finger could not be re-transplanted due to extensive damage. After the operation, the patient's condition is fine, blood supply is good and hand movement is normal. Thanking the hospital staff and the entire medical team after the successful surgery, Amod Kumar said, "I am thankful to the doctors of Yathar Hospital for I am very thankful to Dr., who saved my right hand and gave me hope to survive. At the time of the accident, I was in a lot of trouble physically and mentally, I felt that I would never be able to get my right hand back. But without any problem, the doctors spent the whole night to perform the surgery and fix my hand. In a few weeks, Amod Kumar will be able to return to work and meet the financial needs of his family.

Blue Screen Blues: Microsoft Triggered Cyber Meltdown and the **Case for Atma Nirbharta**

The champions of Atmanirbhar Bharat, isolationists among conservatives and the malcontents of globalisation are having a "told you so moment." The Microsoft outage has given all of them a chance to have a right royal moan about the perils of blind belief in the overarching credo of the liberal world order: that international post-World War II system characterised, at least in one context, by the encouragement of global trade, economic interdependence, and multilateral agreements. And it's not hard to see why. Look at the mayhem caused by a single rogue file called c-00000291*.sys. This teeny-weeny alphanumeric code in a single content update virtually fried the dendrites of the Microsoft Operating System that literally turned blue the pallor of death. Questions abound: did the firm tasked by Microsoft to ward off viruses and malware itself violate zealously adhered to software testing and development guidelines? Software updates are stringently tested at many levels before they are rolled out globally. The fact that this one slipped past shows that the checks and balances aren't as foolproof as they ought to be. The descent into defective code-induced dysfunction triggered global mayhem. The cost to businesses and economies could run into billions of dollars. This disruption was because of negligence, what if the next cyber pandemic is because of malevolence? no country except autarkies like China, Russia and North Korea, and the less technologically leveraged in the Global South, were spared. But because India is a paid-up member of the globalised, rules-based world order, it was strongly buffeted. Indeed, in a less connected world, a freak outage such as this would have had less impact. But that a single misplaced bit of computer code could bring nations to their knees reveals just how uncritically accepting we continue to be of "globalisation" as a project for the advancement of the human race. One would have imagined that we would have been less credulous by now, three years after a single sneeze triggered a global pandemic that stilled the globe and our lives. But clearly, some lessons are hard to learn. While no one needs to take the sledgehammer to globalisation, it is becoming obvious that there is a need to minimise risks. Perhaps, as a first step, by improving vigilance and incorporating redundancies throughout the global supply chain. This imperative of building self-reliance, however, will only gain ground when any prospective autopsy of the costs of globalisation is freed from politics. As of today, any inquiry into the status quo is dismissed by the Left as a "right-wing" lurch towards protectionism, spawned by a crude inward-looking parochialism. In India, examples abound. A certain section of the political class and commentariat mocked Prime Minister Modi for being blinded by exclusivism for deciding against joining an influential trading bloc like the RCEP. The decision, as it turned out, was the right one. Thailand joined the RCEP but in the last 18 months, its GDP growth has slumped to 2.7 per cent. This is largely due to trade imbalances after the RCEP's lead member, China, dumped goods, wantonly taking advantage of favourable tariff rates that its economic heft allowed it to impose across the RCEP. Of course, the stigmatisation of Atma Nirbharta is not only confined to trade-related policies but also foreign policy. Modi's "keep all options open" policy-driven engagement with Russia was the subject of scorn just a few weeks ago. Global interconnectedness has brought many benefits to many people. But the prohibitive costs of its many misses have brought ruin upon millions too.

New criminal laws are betting on DNA finger printing. India must prepare to offset risks

India's new criminal laws emphasise the use of technology and modern forensic methods to speed up justice and take the conviction rate up to "90 per cent". DNA fingerprinting, used extensively in the developed world, is one such technique. Other than producing scientific evidence against known suspects, DNA databases of previous convicts also assist investigators with unsolved crimes. However, is it the proverbial silver bullet as touted by many in the law enforcement community? DNA fingerprinting involves creating a profile of an individual's genetic make-up. This throws up various legal, quality control, privacy, and human rights issues. It is therefore crucial to examine the adequacy of the systems put in place to achieve the goals of these 21st-century legislations. A comprehensive, robust, and independent regulatory and oversight mechanism, established by a statute, is imperative. Developed in 1984 by British geneticist Sir Alec John Jeffreys, DNA fingerprinting entails analysing a person's DNA profile from human cells like hair, saliva, or blood and creating a profile used for identification in forensic investigations. It was first successfully applied in the twin rape and murder cases of two girls in the UK. The late Prof Lalji Singh at the Centre for Cellular and Molecular Biology (CCMB) in Hyderabad pioneered the use and application of forensic DNA technology in the Indian legal system in 1988. The Bharatiya



Nagarik Suraksha Sanhita (BNSS) 2023, which replaced Code of Criminal Procedure (CrPC), retains the provision for mandatory DNA profiling of rape case suspects, introduced in the CrPC in 2006. In addition, Section 176(3) of the BNSS mandates the collection of forensic evidence collection from crime scenes in offences punishable by seven years or more. Another new law, the Criminal Procedure (Identification) Act 2022 which replaced the coloniaera Identification of Prisoners Act 1920— allows the extraction and analysis of biological samples from convicts, preventive detainees, as well as those arrested for charges punishable by 7 years or more, or any offence against a woman or a child. Notably, the National Crime Records Bureau (NCRB) has been entrusted with the responsibility of collecting measurement records from states and maintaining a national database. According to Section Criminal 2(b) of the Procedure (Identification) Act 2022 the term 'measure-

ment' includes biological samples and their analysis, which also implies preparing DNA profiles. In fact, when the government withdrew DNA Technology Regulation Bill, 2019 in July 2023, it stated that most of its provisions had already been incorporated into the 2022 Act. However, without adequate safeguards, there is a risk that individuals may be arrested simply to include them in the database. Neither the BNSS nor the Identification Act define the 'DNA profile'. GeneWatch UK, in its comments on India's DNA Technology (Use Application) Regulation Bill 2019, noted that DNA profiling can be restricted to only non-coding DNA, a commonly used international standard. This prevents using DNA sections that code for personal characteristics, including medical conditions. Forensic geneticists, in the past, have been criticised for attempting to create mugshots—essentially predicting physical appearance—using genetic

information. Given the broad

whose biological samples can be collected by the state, such a restriction would help eliminate many possible misuses. The reliability of DNA fingerprinting has often been challenged, particularly concerning quality control during the handling of biological materials at different stages. Contamination of samples is a problem. Polymerase Chain Reaction (PCR), the most widely used technique for amplify small DNA quantities, also amplifies contaminants. There have been several high-profile cases of sample contamination. For instance, the defence in the OJ Simpson case argued extensively about the contamination of collected biological material. He was finally acquitted by the jury. Similarly, in the Pune Porsche hit-and-run case, the alleged culprit's blood sample was swapped with his mother's. Such examples highlight the need for strict quality control mechanisms and robust protocols for forensic labs (central, state, or private), investigators, medical practitioners, and data bank managers. Technology (Use Application) Regulation Bill 2019 proposed the creation of a DNA Regulatory Board. In India, it is unclear which agency will maintain the Scene of Crime DNA Profile Index, and who will conduct matching with the Convict or Arrestee Indices. A PIL is pending in the Supreme Court for using DNA fingerprinting to solve missing person and unidentified dead body cases. Sharing data with foreign law enforcement bodies by the NCRB is another ticklish issue. Profiles of investigators, medical practitioners, and forensic scientists should be prepared and maintained separately to distinguish their DNA from that of suspects in cases of multiple profiles resulting from collected samples. After the withdrawal of the DNA Technology Bill, no oversight body has been proposed to oversee the NCRB as a repository of national or state government databases.

Oversight bodies are crucial for the governance of DNA databases, ensuring they contribute effectively to the criminal justice system, meet ethical and regulatory requirements, thus maintaining public trust and accountability. As data will be stored digitally, ensuring data security and privacy is also essential.

HC says surrogate moms get maternity leave

The Orissa High Court ordered the state government to give a surrogate mother Orissa Finance Service (OFS) official 180 days of maternity leave. Court stated maternity leave shouldn't depend on how a woman becomes a mother. Surrogacy to treat and support all new mothers, regardless of how they became parents. Justice Panigrahi said the government should give surrogate mothers maternity leave if it could give adoptive mothers. 'The mother's caregiving and nurturing during the first few months of a child's life are vital to their growth. He said Article 21 of the Constitution guarantees the right to life, which includes motherhood and complete development for all children. Panigrahi added: "It is directed to the concerned department of the state to incorporate this aspect in the relevant provisions of the rules to treat a child born out of surrogacy in the similar manner as a child born out of the natural process and provide the commissioning mother with all the benefits provided thereto." The court noted that maternity leave gives surrogate mothers time to raise their children in a stable and loving setting. "Additionally, international conventions to which India is a signatory, such as the Convention on the Elimination of All Forms of Discrimination Against Women, mandate equal treatment and non- discrimination in matters related to employment and maternity," Justice Panigrahi said.



Apple alerts 98 countries, including India, about spyware



Delhi: The IT giant Apple has alerted consumers to a potential new mercenary malware attack similar to "Pegasus" in at least 98 countries, including India. "You are being targeted by a mercenary spyware attack that is trying to remotely compromise the iPhone associated with your Apple ID," according to the Apple alert. The iPhone manufacturer went on to say in the warning that this attack is "likely targeting you specifically because of who you are or what you do".

"Apple has great confidence in this warning, even though it's never feasible to identify such attacks with 100% certainty. Kindly consider it carefully," the business said. Similar alerts were sent to Indian users by the USbased technology corporation in October of last year. The internet giant may have used "mercenary spyware" like Pegasus from the NSO Group to target specific consumers in 92 countries, including those in India, by sending threat notifications in April of this year.



As hundreds of Chinese items lose tax exclusions, the US-China trade battle escalates



Delhi: Recently, the US has banned, restricted, or imposed high taxes hundreds Chinese imports to stimulate domestic production and reduce dependence Chinese commodities. The USTR has already added tariffs to half of 429 items. The USTR further excluded duties from "Section 301" probe of China's technology transfer, intellectual property, and innovation measures in previous announcements. The current 429 product-specific exclusions (352 reinstated and 77 COVID-related) expire

on May 31, 2024. The agency trade declared a 14-day transition period for all current exclusions until June 14, 2024, and to "extend certain exclusions through May 31, 2025" in a new notice. "To allow for a transition period, US Trade Representative extending all currently expiring exclusions June 14, through 2024," it stated. Chinese motors and medical equipment are excluded until May 2025. The USTD ruled that "extending these exclusions will support efforts to shift sourc-

ing out of China, or additional provide time where, despite efforts to source products from alternative sources, availability of the product outside of China remains limited". Last March, the USTR reinstated some "Section 301" tariff exceptions for Chinese Former goods. President Donald Trump began a trade war with China and imposed tariffs on nearly \$300 billion in Chinese goods, invoking Section 301 of the Trade Act of 1974. 
