Won't run away, I'm a fighter: Fadnavis on Maharashtra poll jolt

MUMBAI: Asserting that he was a fighter who took responsibility when things did not go right, deputy chief minister Devendra Fadnavis said on Saturday that the BJP got its political arithmetic wrong in the Lok Sabha election in the state. "'I am not one to run away, I am the one who fights," he said when the BJP held a meeting of its MLAs at its Dadar office for feedback on the factors that led to its dismal performance in the state. The BJP won nine seats this time compared to the 23 in 2024. Fadnavis said he had even requested the central leadership to relieve him of the deputy chief minister's post so that he could work full-time with the party for the upcoming assembly election. "Since I am leading the party in the state I take responsibility for the party's defeats," he said. "When I said relieve me and let me work in the party, I am not one who will run away, I am one who fights. Our inspiration is Chhatrapati Shivaji Maharaj. It is not true that I am disheartened or saying this in a surge of emotions. There was a strategy in my mind. You have all expressed confidence me... I met Amit Shah and told him what is in my mind. His opinion was not very different from yours but he said that whatever is going on now let it be and later we shall prepare a blueprint for Maharashtra," he said. "The gap in voteshare between the Maha Vikas Aghadi (MVA) and Mahayuti is only 0.3%. The MVA got 2.5 crore votes and the Mahayuti 2.48 crore yet with only a difference of two lakh votes they got 31 seats and the Mahayuti 17. We lost 11 constituencies by a margin of less than 5% votes. These include Dhule, Ahmednagar, Nanded, Bhandara-Gondia, Beed, Latur, Mumbai North-East, Mumbai North-Central, Amravati and Bhiwandi," he said.State party president Chandrashekhar Bawankule said they had passed two resolutions, one congratulating Narendra Modi on being sworn

4-member panel to review NEET-UG results of 1,563 candidates

NEW DELHI:

The ministry of education has constituted a four-member panel headed by a former Union Public Service Commission (UPSC) chairperson to review the grace marks awarded to more than 1,563 candidates in the medical entrance National exam Eligibility Entrance Test-undergraduate (NEET-UG). This was informed by the National Testing Agency (NTA) announced on Saturday.The medical/ dental entrance test results were announced on June 4, and thereafter aspirants have been alleging multiple issues, including irregularities in the exam demanding fresh examination. -



Akhil Meanwhile, Bharatiya Vidyarthi Parishad, the student wing affiliated to the RSS, on Saturday demanded a CBI inquiry into the allegations on the NEET-UG.Many aspirants have also approached courts for relief on the matter. Meanwhile a political slugfest commenced between AAP and BJP on the exams which recorded over 24 lakh registration and 97% attendance.

Earlier Congress leader Priyanka Gandhi Vadra criticised the government on purported irregularities in the medical entrance examination demanding a thorough investigation. According to NTA officials, the fourmember panel is being mandated to submit its recommendations within a week and the results of these candidates might be revised accordingly.

The neet comes amid allegations of inflation of marks leading to 67 candidates sharing first rank in the exam including six from the same centre in Haryana. Demanding re-exam candidates alleging that the

grace marks awarded to make up for the loss of time at six exam centres have led to the inflation of marks and tampered with the chances of other candidates.

Parents are held responsible for the actions of their minor children. They could face a three-year prison sentence and a fine of Rs. 25,000. Additionally, the registration of the vehicle involved in the accident can be cancelled for 12 months. If the minor has a driver's license, it will be immediately suspended and not reissued until the individual turns 25 years old.

from 18 to 25 years. States like Gujarat, Bihar, Nagaland, and Manipur have completely prohibited alcohol. In Goa, the legal drinking age is 25 years, while it is 21 in several others. In many states, if any level of alcohol is found in the blood of a minor while driving, it is considered illegal.

According to the Motor Vehicles Act, there are even stricter regulations regarding blood alcohol levels for commercial drivers. Bajaj Housing Finance Ltd files DRHP with SEBI for IPO

Varanasi: Bajaj Housing Finance Limited (BHFL), part of the Bajaj Group (with Bajaj Finance Limited and Bajaj Finserv Limited as promoters), has filed Draft Red Herring Prospectus (DRHP) with SEBI for an Initial Public Offering (IPO). BHFL is a non-deposit taking Housing Finance Company ("HFC"), registered with the National Housing Bank ("NHB") since September 24, 2015, and engaged in mortgage lending since Fiscal 2018.

Why Celebrities Are **Seeking Legal Protection For Their Personality Rights**

The Delhi High Court recently issued an order safeguarding the personality and publicity rights of film actor Jackie Shroff, restraining several social media accounts, AI Chatbots, and e-commerce websites from exploiting the actor's name, voice, or image for commercial purposes without his consent. Shroff petitioned the court against the unauthorised use of his name and persona, seeking protection against various individuals and entities utilising and misusing his identity without permission. The proliferation of Al-generated deepfake videos has exacerbated concerns for celebrities. Jackie Shroff's isn't the first instance of a film star resorting to legal action to protect their personality rights. Over the past two years, the Delhi High Court has issued interim orders to prevent the unauthorised use of Amitabh Bachchan and Anil Kapoor's name, image, and voice. The question arises: why are some celebrities turning to courts for the protection of their personality rights, while others refrain? "Where there is demonstrable misuse, people are approaching. Personality right is a facet of publicity right," says advocate Ameet Naik, who has represented Bachchan, Kapoor and now Shroff in their respective personality rights suits. In India, laws regarding personality rights are still evolving, with courts deriving principles from Article 19(1)(a) (freedom of speech and expression), Article 21 (protection of life and personal liberty), and intellectual property rights laws. "A few celebrities may choose not to pursue legal action due to various reasons such as the perceived insignificance of unauthorised use, the costs involved in litigation, or a desire to avoid negative publicity," says Shoeb Masodi, Partner, M&P IP PROTECTORS. Personality rights, as the name implies, pertain to the rights associated with the personality of a well-known individual, primarily applicable to celebrities whose names, images or voices are prone to misuse for profit. The concept dictates that only the owner or creator of these attributes has the right to derive monetary benefits from them. Personality rights have gained importance alongside the right to privacy given the kind of fame celebrities enjoy today. In 1995, the Supreme Court recognised a person's right to control the commercial use of one's identity in the R Rajagopal vs. State of Tamil Nadu case, commonly known as the Auto Shankar case. In 2015, the Madras High Court intervened to protect actor Rajinikanth's personality rights, halting the release of the movie Main Hoon Rajinikanth. The filmmakers had utilised the actor's name and style without his express nermission. with the title itself serving as a clear indication of its connection to Rajinikanth. In yet another case involving actor Amitabh Bachchan, the Delhi High Court in November 2022 restrained the use of the actor's name, image, voice, or any of his characteristics without his consent. It is crucial to note that in intellectual property right cases, it's often impractical to name all infringing parties, leading affected parties to seek blanket injunctions or ban orders, known as 'John Doe' orders. Originating from the UK, John Doe orders are passed by a court against unknown defendants and the world at large. In September 2023, the Delhi High Court ruled in favour of actor Anil Kapoor in a case filed by him to protect his image and personality from misuse by third parties. Kapoor had petitioned the court, stating that several parties were using aspects of his personality, including popular terms from his dialogues.

Issue was 'political presents' for the local authorities

Though historically intimately linked, two separate events took place recently, nearly 1,000 miles away from each other. e central sector of the Indo-Tibet boundary in Uttarakhand, Chief Defence Staff (CDS) General Anil Chauhan directed Army formations to work for the rehabilitation of the border villages of Nelang and Jadung, near the Line of Actual Control in Chamoli district. war, both villages were abandoned, and their residents were relocated to safer nearby areas.

Far away in the east, at the Tawang War Memorial in Arunachal Pradesh, the Indian Army, along with the Tawang administration and the local Monpa population, commemorated the 74th anniversary of the arrival of Maj Bob Khathing in the area In 1951, the Manipuri Naga officer took over the administration of the border town of Tawang, south of the McMahon Line; a communiqué of the Defense PRO in Guwahati thus explained, "After the valiant Major undertook a treacherous march from the plains of Assam to Tawang, negotiating Sela and Bomdila passes during peak winters, leading a contingent of 200 Assam Rifles troops and 600 porters for a difficult maiden mission, thus materialised the formal establishment of Indian civil administration at Tawang."



The above two events are linked as the takeover of both places' administration is the result of a decision of the Himmasinghji Border Defence Committee created by the Army Headquarters on November 12, 1950.

Let us remember the facts On October 7, 1950, the communist troops advanced in eastern Tibet, and after smashing the ill-trained and ill-equipped Tibetan army, Chamdo, the capital of Kham Province, fell to the invaders. On November 7, Sardar Patel, the deputy prime minister, despite his poor health, sent a long letter to the prime minister about the implications of the Chinese invasion of Tibet for India's northern border. Five days later, the dying Sardar (who passed away on December 15) constituted

esides Himmatsinghji, deputy minister of defense (chairman), it included Lt Gen Kulwant Singh, K Zakaria, head of the Ministry of External Affairs' historical division, SN Haksar, joint secretary also from MEA, Group Captain MS Chaturvedi from the Indian Air Force, and Waryam Singh, deputy director of the Intelligence Bureau. After discussing at great length the advisability of pushing forward a post to Tawang, it was decided to go ahead. It was also decided to send troops to Nelang (then written Nilang) and Jadung (then Jadhang), two tiny villages south of the Tsangchok-la, the pass marking the watershed in the area, in the Chamoli district.

The Role of

One man was central in the setting up of Maj Khathing's expedition to Tawang; it was Jairamdas Daulatram, the governor of Assam. It is sad that his role has been more or less forgotten today. On December 10, 1950, he managed to get the concurrence of the Ministry of External Affairs headed by Nehru; a Joint Secretary concurred with the Committee, "We cannot agree to a unilateral occupation of Tawang by the communists." The ball then started rolling, and preparations for the expedition began. Maj Khathing received detailed instructions from Nari Rustomji, the advisor to the governor, on behalf of Daulatram himself.

Precise tasks were given to the young and bold officer.

The first task was to occupy Tawang. Khathing was asked to explain to the local population and Tibetan officials that he was "doing no more than is being done by the administration in other parts of Indian territory;" in 1914, Tibet had agreed to the McMahon Line, north of Tawang being the boundary. The major was ordered to "treat any Tibetan or other officials you may meet with courtesy, but nevertheless let them understand that jurisdiction in the area vests in you and not in them." He was directed to submit detailed reports about the Tibetan 'influence' in the area and the

nature of taxes collected. He was further told to abolish all existing taxes and substitute them with lighter taxes to be paid to the Political Officer, representing the Indian government: "There will be no forced labour and everything needed will be duly paid for." An important task was to communicate to the local people that "none of their religious practices The sixth point was that in case Khathing met with armed opposition, he was to cable Shillong (the governor's office) immediately, "indicating the strength and position opposing Fortunately, due to Khathing's intelligence and diplomatic skills, this would not be necessary, and

74 years later, he was still considered by the Monpas as their liberator. Khathing was also asked to keep daily wireless telegraphic contact with Daulatram after crossing the Se-La pass. It is what Khathing did, and his dispatches and cables still make fascinating reading. Finally, Daulatram asked Khathing to "conduct [the] operation with tact, firmness, and discretion".

The logistics of the expedition were not easy; for example, the question of porters and loads was difficult to coordinate. One can imagine having as many as 200 troops and 600 porters to feed.



Delhi:This Rabi selling season, the Food Ministry announced that the Central government had purchased 262.48 lakh metric tonnes of wheat in various states, beating previous year's 262.02 lakh. The Rabi marketing season 2024-25 MSP outflow was Rs. 59,715 crores, benefiting 22.31 lakh farmers. Five states dominated procurement. Punjab procured 124.26 lakh metric tons (LMT), followed by Haryana with 71.49 LMT and Madhya Pradesh with 47.78 LMT. Rajasthan and Uttar Pradesh followed with 9.66 and 9.07 LMT. According to the Ministry, 728.42 LMT paddy equivalent to 489.15 LMT of rice has been acquired directly from 98.26 lakh farmers during the Kharif marketing scheme 2023-24, with a total MSP outflow of Rs. 1,60,472 crores. The Food Ministry said the Central Pool's wheat and rice stock had topped 600 LMT, allowing the country to meet its food grain needs under PMGKAY, other welfare initiatives, and market interventions.

'Not giving clean chit to anyone ... CM Kejriwal was at home': Swati Maliwal

NEW DELHI: Aam Aadmi Party (AAP) Rajya Sabha MP Swati Maliwal on Thursday recounted her ordeal of May 13, stating that she was assaulted by Bibhav Kumar, personal aide of Delhi chief minister Arvind Kejriwal.

In an exclusive interview with ANI, Maliwal described the incident in detail.

"On May 13 at around 9 am in the morning, I went to meet Delhi Chief Minister Arvind Kejriwal at his residence.

The staff asked me to sit in the drawing room and told her that Arvind Kejriwal ji was at home and he was coming here to meet me. After that the PA of Arvind Kejriwal ii Bibhav Kumar came in a state of aggression and I asked 'Kya Hua Kejriwalji aa rahe hai. Kya hogya?' I said this much, after which he slapped me. He (Bibhav Kumar) slapped me 7 to 8 times. When I tried to push him, he held my legs and mujhe ghaseet diya. Ensuring that my head bumped into the center table. I fell to the floor and he (Bibhav) started beating me with his legs. I was



screaming and begging for help but no one came there," Maliwal said. Maliwal stated that she is unsure whether the assault was carried out on someone's instruc-

tions or if Bibhav acted on his own accord, emphasizing that this is a matter of investigation. She expressed her cooperation with the Delhi Police and clarified that she is not giving anyone a clean chit, as the incident occurred while she was in the drawing room and

32-year old man killed after being hit by minor's motorcycle in Mumbai

NEW DELHI: A 32-year-old man was killed on Thursday after a 15 year-old boy allegedly hit him with a motorcycle in Mumbai.

Irfan Nawab Ali Shaikh, the victim sustained severe injuries from the crash and was immediately rushed to JJ Hospital for medical attention. However, he succumbed to his injuries.

In response to the incident, Mumbai Police have taken the minor into custody and sent him to a juvenile home. Additionally, the minor's father has been detained by the authorities. A case has been registered under section 304(2) of the Indian Penal Code (IPC) and sections 3 and 4 of the Motor Vehicle Act.

This comes following a similar incident in Pune where a Porsche crash involving a minor that killed two people. The 17-year-old driver, initially granted bail within 15 hours by the Juvenile Justice Board (JJB), faced lenient bail conditions that sparked widespread public anger. The bail terms, which included writing a reflective essay and working with traffic police, were perceived as too lenient given the gravity of the charges.

In response to the backlash, the Juvenile Justice Board in Pune revoked the minor's bail and ordered him to be held in an observation home. Furthermore, the board is now contemplating whether to try the teenager as an adult, which could result in a more severe sentence if he is convicted.

The father of the minor involved in the luxury vehicle accident has been sent to police custody until May 24.

Urbanization alone has led to an overall 60 percent enhancement in warming in Indian cities, with eastern tier-II cities leading the way. It was revealed through a study conducted by the researchers from IIT Bhubaneswar. This research provides a science based quantitative ranking of urbanization for Indian cities. study 'Urbanization regional climate change-linked warming of Indian Cities' published in the journal



'Nature Cities' provides insight by carefully separating regional climate change and urbanization in multiple cities. Sethi_Vinoj_NatCities2 showed 024 (1) (1) (1)

The researchers investigated the contributions of local-scale urbanization and regional climate change to the warming in 141 major Indian cities over the

past two decades. They took 18 years of highresolution land surface temperature data from NASA's Aqua satellite for the period between 2003 and 2020. 

Delhi: To prepare its players for the quadrennial spectacle, the National Rifle Association of India has imposed severe conditions on Paris Olympic shooters, including a "media blackout" and no personal coaches at the national camp. In its "national team protocol", the federation informs shooters that parents cannot "stay" or "visit" their wards at camps and that Pierre Beauchamp, the High Performance Director (HPD), must make an exception. According to the NRAI's "NRAI Olympic Team Undertaking and SOP for Paris 2024 Olympic Games - Pistol/Rifle Teams" letter to Olympic-bound shooters, the goal is to "ensure the clarity of the training and readiness plan for Olympic Games Paris 2024 by the shooters and the National Team Coaches and Sport Science support." "It is essential to have effective organization, discipline, planned and dedicated training programmes for the best performance of shooters participating as National Team India at the Paris 2024 Olympic Games," the note states. The letter states that only NRAI-approved personal coaches and sport science consultants with signed SOPs can assist the "National Training team for the concerned shooter(s) in assisting and/or discussing with the National Training Team under the leadership of the HPD and the chief coach (rifle and pistol)." Personal coaches without NRAI approval are prohibited. "The NRAI National Team program of the Olympic Games does not allow personal trainers, physiotherapists, nutritionists, or psychologists." Under "Media Blackout", the NRAI says shooters must avoid the media.

Delhi: The Delhi High Court ruled that schools must follow the Directorate of Education (DoE)'s computerized draw of lots for economically weaker section (EWS) admissions. Justice C Hari Shankar noted that the computerized draw of lots is based on the class strength communicated by the schools, and if a school does not have enough general students, it must apply to the DoE to reduce the number of EWS students. A pupil seeking admission to a private school's pre-primary class after a successful DoE computerized draw of lots petitioned the court. The school denied admission to the petitioner because the actual number of general category admissions was less than what was communicated to the DoE, and it had already admitted 25% of the actual number under the EWS category per legal mandate. " Once a school communicates the number of general category and EWS seats available with it for being filledl.
