## Past govts didn't conserve heritage due to slave mentality: PM Modi

**NEW DELHI:** Accusing Congress of ignoring Mahatma Gandhi, PM Modi has said the icon remained unknown to the world till the 1982 'Gandhi' was made, inviting swift retaliation from Congress chief Mallikarjun Kharge who said "those whose ideological ancestors along with Nathuram Godse were involved in the assassination of Bapu can never follow the path of truth shown by him".

Replying to a question on whether opposition didn't do enough to promote India's cultural heritage and pilgrimage sites when in office at the Centre, Modi said, "The question is not just about (that)... Gandhi was a tall personality... In the past 75 years, was it not our responsibility to let the world know about him? No one knew (of him)." When the film ('Gandhi') was made, it attracted global interest. We have not done this (the film was an India-UK co-production directed by Richard

Attenborough). If the world knows Martin Luther King and Nelson Mandela, Gandhiji was no less. This I am stating after my worldwide travels. We've to accept that Gandhi and, through him, India should have received its share of attention in the world. Gandhi is a solution to many of the global issues today, said PM Modi. Countering the PM, Congress's Jairam Ramesh said, "If there is someone who has destroyed the heritage of the Mahatma, it is the 'caretaker PM'. It is his govt that has destroyed Gandhian institutions in Varanasi, Delhi and Ahmedabad. The 2024 elections are between a Mahatma follower and a Godse follower. The defeat of

#### India in focus as UAE set to open cultural district in 2025

Abu Dhabi's Saadiyat Island aims to be a melting pot of global cultures Two over-a-millennium-old statues of Nataraja and Jina, a 12th century Pala dynasty manuscript, a sandstone frieze from Rajasthan dating to the short-lived Ghurid empire, and S H Raza's 'Bindu'. There's "an imprint of Indian history" on almost every gallery of Louvre Abu Dhabi, said Mohamed Al Mubarak, chairman of the department of culture and tourism (DCT) Abu Dhabi. India will be a central focus when Abu Dhabi unveils its Saadiyat Cultural District, with seven worldclass cultural venues, next year. The district on Saadiyat Island aims to be a melting pot of global cultures while being rooted to the land, foster dialogue, and challenge the Western lens of looking at art.

Three institutions are operational: Louvre Abu Dhabi, whose architecture is no less than the art it hosts; Berklee Abu Dhabi that offers music, performing arts and educational programmes; and Manarat Al Saadiyat, which hosts cultural events. The remaining-Zayed National Museum, the national museum of UAE; TeamLab Phenomena Abu Dhabi, an immersive digital art space; Natural History Museum Abu Dhabi; and Guggenheim Abu Dhabi, a contemporary art museum-are 76% complete and on track to meet the 2025 deadline, said DCT Abu Dhabi. Al Mubarak said the district "embodies 'cultural hope'... will convey a message of cultural diversity that will become more powerful over time, creating global connections, inspiring exchange, and fostering new ways of thinking to support the region, the Global South and the world". Asserting that one cannot tell the history of art without India, he told in an exclusive chat that the country is, "to some extent, the epicentre of culture". Varanasi: Mirzapur's Shastri Bridge, once hailed as an emblem of connectivity, now teeters on the brink of peril. Every day, the rumble of overloaded trucks sends shivers down its structure. As queues of trucks pass by, it shakes awfully. Oblivious to an unseen danger, countless commuters and bridgecrossers tread their paths. Amidst myriad risks, a flicker of hope gleams as a promise of a new bypass emerges, offering relief and aspirations. Yet, as engi-

neers toil tirelessly, the looming question remains: can they safeguard the future of a bridge and its surrounding area?

Continuous overloading has turned the Shastri Bridge into a significant threat, necessitating the establishment of active monitoring posts to ensure its safety. Immediate action is imperative in this regard.

There's no denying that the government is actively focused on the development of foundational structures. Consequently, development and connectivity in the region are on the rise. However, the success of development projects heavily relies on vigilance and timely maintenance to ensure the longevity and safety of crucial assets. Shastri Bridge in Mirzapur is also one such property. Regular bridge inspections are necessary to keep its structure secure over the long term.

Considering the current condition of Shastri Bridge, commuters are strongly advised to consider safer alternatives such as NH2 (currently named NH19), leading towards the Varanasi toll. This alternative route provides a reliable option for travellers seeking to avoid the overloaded Shastri Bridge, ensuring the safety of themselves and their loved ones. The Shastri Bridge over

the Ganga in Mirzapur is currently facing the challenge of overloading, despite undergoing several repairs. This raises serious concerns about the safety of the bridge itself and the lives of those who use it.

#### Eagle-eye watch at Sangam ghats amid increasing drowning incidences

temperature attracts the youth to the river ghats for bathing, drowning accidents are increasing in Prayagraj. On Monday, two youths drowned in the Yamuna while bathing. In response to Monday's incident, Jal police and local cops will monitor the ghats to control such incidents. Teams of divers and water police personnel will now keep a strict vigil at all ghats at Sangam, Arail Phaphamau, Ghat, Shivkuti, Subban Ghat on the Yamuna River in Kareli, and other ghats in the Atarsuiya area. Additionally, cops will also keep vigil at ghats on the Ganga River in the Dhumanganj

With temperatures reaching around 47 degrees Celsius in Prayagraj, many people, especially youths, are heading to different ghats to bathe and cool off. However, youths venturing too far into the rivers result in mishaps as they drown due to deep water and swift currents.

Police officials said that besides the deployment of divers and lifeguards, boatmen and fishermen at different ghats have been asked to keep watch on youths coming to bathe and warn them. Cops have been asked to patrol the ghats and warn youths to take baths in the rivers.

It is worth mentioning drowning.

Prayagraj: As the rising that deep-water barricading is installed at all ghats at Sangam to prevent people from going into deep waters. Police officials said people often cross the barricades while ignoring the warning signs. Why shouldn't persecuted Muslims like Shias and Ahmediyyas of Pakistan not be included in CAA? There are six good reasons why India is justified and wise not to include Muslims from these three nations.First, CAA is a nar-

row-window legislation to protect persecuted 'religious' minorities, not 'sects'. Muslims from these countries can still apply under the old Citizenship Act. Former Pakistani singer Adnan Sami got Indian citizenship and is a much loved and respected figure in India today. The US has a similar narrowwindow legislation called the Lautenberg-Specter Amendments which give preferential shelter to persecuted minorities from Russia and Iran.

Second, the historical premise of CAA is the Liaquat-Nehru pact that was signed after Partition in 1950 to safeguard minorities in the divided subcontinent. India kept its

population has grown by over 5 per cent in seven decades. But Pakistan, Afghanistan Bangladesh didn't keep their word. Percentage of religious minorities have dwindled to single digits in Pakistan and Bangladesh, and close to zero in Afghanistan. It must not accommodate demographic usurpation.Fifth, should learn what not to do from the western model of 'liberalism' which the Left and far-Left have long hijacked. In the name of 'multiculturalism' and 'cultural enrichment', Leftleaning parties in the West have facilitated unbridled immigration to grow their vote bank. It has gaslighted white populations to drop all survival instincts against demographic takeover.

Many centuries ago when the world at large didn't have much clue about statecraft and strategy, Kautilya had advised Chandragupta Maurya, his disciple, that the country with which his kingdom would share an immediate border will always be its enemy. But the enemy's enemy will be a friend and hence all strategic calculation must be undertaken keeping this basic premise in mind. It seems India was following this exact logic when a set of very interesting images from Afghanistan splashed across the media this week. An Indian delegation led by JP Singh, joint secretary in the Ministry of External Affairs, met Taliban's foreign minister Amir Khan Muttagi in Kabul. The Indian delegation also met former President Hamid Karzai,

officials of the UN Assistance Mission to Afghanistan as well as some people from the business community. This was the second such public engagement Taliban after the latter returned to power in 2021. The first public engagement took place in 2022 when at that time also, Joint Secretary Singh met Taliban's foreign minister Muttaqi. In the last three years since Taliban has come back to rule the country by establishing the Islamic Emirate of Afghanistan, India's diplomatic engagement with the new rulers has been on a very firm footing. Time and again, India's foreign policy establishment has invoked civilisational ties and the role of history to justify maintaining strong ties with Kabul. Not without Prime

## Irdai sets 3-hour limit to settle health claims

MUMBAI: regulator **Irdai** has brought in several reforms in health covers aimed at improving service standards for policyholders. The new norms will require insurers to approve cashless claims within an hour and provide final authorisation for discharge from a hospital within three hours. Insurers will also need to provide a one-month grace period for annual renewal of health policies and protect benefits under policies renewed within that period.

Irdai has issued a master circular on health insurance products that comes into effect immediately (with certain exceptions). The new cirprevious circulars, consolidates entitlements in a health insurance policy. Under the new norms, insurers have to ensure that hospitals release mortal remains immediately in the event of a death during treatment. Companies cannot repudiate a claim without the approval of Claims Review Committee. For settlement of claims, insurers must insurers and TPAs (third party administrators) must collect documents from hospitals and not call for them from the insured. Policyholders with multiple health insurance policies can select the

Insurance cular, which repeals 55 claim the admissible amount. The primary insurer will coordinate the settlement of the balance amount from other insurers. The new rules allow insurers to reward policyholders with no claims during the policy period by offering either an increased sum insured or discounted premium amounts.Policyholders, who want to cancel their policies, can receive a refund of the premium for the unexpired policy period. All individual health insurance policies are renewable and cannot be denied on the basis of previous claims, except in cases of fraud, non-disclosure, or mispolicy under which they representation.

#### After losing its last inhabitant, Tamil Nadu ghost village stands as example of perils of climate change

MADURAI: When 73-year-old Kandasamy

Naicker breathed his last Sunday in Meenakshipuram, it was the last breath of his village in Tuticorin district of Tamil Nadu. Naicker, the lone inhabitant, was a poignant symbol of a community once thriving, now a ghost village. Meenakshipuram in Sekkarakudi panchayat had 1,296 residents according to the 2001 census. Yet, the relentless grip of environmental changes, inconsistent rainfall, and enduring droughts gradually eroded the village's lifeblood, leading to a mass exodus over the past decade. Fields once fertile turned barren, pushing families to seek stability elsewhere. Amidst this exodus, Naicker clung to Meenakshipuram, outliving his wife by 20 years and continuing to reside in the village where he was born. He is survived by two sons and two daughters. Younger son Bala Krishnan reflected on Meenakshipuram's transformation. "The village was highly dependent on farming," he recounted. "The situation began to deteriorate due to the lack of rainfall and water shortage. People had to walk 3-4km to get water and other basic facilities, which made them disinterested in staying in the village." Naicker's last wish was to die in the village. Up until his final months, he managed his daily chores, cooking his own meals. Only recently did Krishnan arrange for someone to assist his father. Living in Kasilangapuram, 15km away, Krishnan would often bring food for his father, or Naicker would travel to his son's home.

## Monsoon set to arrive early and simultaneously over Kerala

NEW DELHI: In an uncommon phenomemonsoon expected to arrive both over Kerala and some parts of northeastern states simultaneously IMD with Wednesday predicting favourable conditions early onset/progress during the next 24 hours.

## IL&FS, arms told to recover Rs 150 crore from ex-directors

**NEW DELHI:** In a rare move, govt has asked the board of IL&FS and two of its arms to recover excess money of Rs 150 crore, including managerial remuneration and commissions, from ex-directors after the entities restated their accounts to show losses of Rs 9,600 crore for financial years 2013 to 2018, instead of a profit of Rs 1,869 crore estimated by the management board, which had to be superseded following massive irregularities. Directors of IL&FS Financial Services (Iand IL&FS Transport Network, where accounts were not found to be in order, are facing similar action, official sources told TOI.

A large part of the amount is to be recovered from four key directors Ravi Parthasarthy, Arun Saha, Hari Sankaran and Ramesh Bawa with the sum adding up to over Rs 100 crore. Milind Patel, Rajesh Kotian, and Vibhav Kapoor are some of the other directors, who face similar action.The independent directors, some of whom are big names in the corporate sector, have to refund a part of the commission paid during their tenure when the fraud was perpetuated. The list includes prominent names, such as, Maruti Suzuki chairman R C Bhargava, VBHC founder and director Jerry Rao, former HDFC boss K M Mistry, former LIC chairman S B Mathur, retired civil servant Michael Pinto and Rina Kamath.

#### Rush at OPDs as heat soars. doctors sound dehydrationexhaustion alert

KOLKATA: The hot and discomfort weather conditions in the past few days are taking a toll on the health of Kolkatans, especially those who have to remain outdoors for hours. Even though none of the city hospitals have recorded any heat stroke cases so far, doctors are getting a good number of people with heat exhaustion and dehydration. Health experts have cautioned people to take all precautions when outdoors to avoid severe consequences.

"Because of such hot and humid weather, the people who are engaged in outdoor activities are prone to develop heat exhaustion when the body starts sweating a lot due to the rise of the core body temperature resulting in dehydration.

Heat exhaustion makes the person feel weak, dizzy and thirsty. I have seen two to four such cases in the past one week, mostly middle aged men, probably due to their higher exposure to the sun," said internal medicine specialist Joydeep Ghosh of Fortis Hospital, Anandapur.

B P Poddar Hospital had tended to 14 persons in its emergency in the past three days, most of them down with extreme dehydration making them unwell while they were out in the sun. "37 patients came to our OPD with heat related issues. While most of them were middle-aged patients, some were school children. We had to admit two senior citizens because in addition to dehydration they had other issues like BP fluctuation and sodium, potassium imbalance," said Supriyo Chakrabarty, group advisor, BP Poddar Hospital.

**LUCKNOW:** UP govt's Varanasi farm has become the country's first conservation centre to breed two high-merit Gangatiri cow calves using embryo transfer technology (ETT) and IVF. The two female calves were born on March 26 and 27.

Gangatiri breed is native to eastern UP and Bihar. It got its name after Ganga as it is the belt along the river which is its natural habitat.

The breed has low input costs and is resistant to many diseases."Gangatiri is recognised nationally and has high significance as a source of livelihood to local farmers in the state," said Dr Neeraj Gupta, CEO of the UP Livestock Development Board. The ETT will help produce elite cows at a faster rate as a single mother can produce multiple highmerit progenies, he added. In the current case, four elite females at the farm were selected as egg donors. Semen from a high-merit bull was used to fertilise the eggs

in-vivo (inside the body).



After about seven days, the embryos were flushed from the donor cows and transferred into four surrogate cows, which may not have been of high merit. However, only two pregnancies were successful, and two calves were born, said Gupta. The ETT is being extensively used for the improvement of indigenous cow breeds at var-

ious places as elite cows are used as egg and sperm

"This technique will increase the efficiency as well as productivity of Gangatiri bovine herds . It has huge potential to multiply the income of farmers," said Ravinder, principal secretary of animal husbandry, dairying and fisheries, and chairman of UPLDB.

#### Tata Steel to invest \$ 2 billion to fund rejig of UK operations

Mumbai: Tata Steel will infuse \$2.1 billion (Rs 17,408 crore) in its Singapore arm, to repay debt of its offshore entities and to "support the restructuring costs" of its loss-making UK operations. Further, it will convert debt instruments worth \$565 million (Rs 4,661 crore) it holds in the Singapore arm into equity shares. The fund infusion as well as the conversion of debt into equity will be done in this fiscal, said Tata Steel.

Tata Steel's profit slides 65% to Rs 555 crore

The Indian company owns 100% of Singapore arm called T Steel Holdings, which in turn owns the overseas steel assets including the UK plant. T Steel Holdings posted a loss of Rs 4,367 crore in FY23. Tata Steel will also be raising Rs 3,000 crore in the form of non-convertible debentures (NCDs). The company has been raising money through NCDs now and then. Tata Steel is investing £1.25 billion (\$1.6 billion) to build a new electric arc furnace (EAF) at its Port Talbot plant in UK, while deciding to shut down two blast furnaces at facility by Sept. The move will lead to axing of 2,800 jobs at the plant."We will proceed with proposal to shut down heavy end assets this year, and set up EAF by 2027. This is a difficult period of change for our people... With respect to EAF, we will place equipment orders by Sept 2024 and have signed the agreement with UK National Grid securing high voltage connection, which will be available on schedule. We have as part of discussions with the unions, offered the best ever package of support for affected employees in Tata Steel UK. We have agreed to final terms of proposed grant package.

and "Rakesh Sharma" claiming to be associated with entity named "Choice Broking" operating through mobile number "9977690997" and person named "Kuldeep Valiya" claiming to be associated with entity named "R K Global Shares & Securities" and operating through mobile number "9112569388" are providing securities market tips for trading and assured returns on investment in the stock market.He is also offering to handle investors' trading accounts by asking them to share their login ID/pass-

"Investors are requested to take note that Choice Equity Broking and R K Global Shares & Securities, registered trading members of (NSE), have informed that the above-mentioned person is not associated with them in any manner," it added. "Generally, impersonators carry out their activities via social media platforms and messaging apps such as Facebook pages and WhatsApp groups. **MUMBAI:** Profit taking by nervous investors ahead of the Lok Sabha poll results on June 4 pulled leading indices down for the fourth consecutive session on Wednesday.

Rising crude oil prices

and fading chances of a rate cut by the US Federal Reserve also weighed on investor sentiment. As a result, even the improvement in India's sovereign rating by global ratings agency S&P was discounted by Dalal Street investors, brokers and analysts said.At the close of Wednesday's trading, the sensex was down 668 points or 0.9% at 74,503, while Nifty closed at 22,705 points, down 183 points. From its alltime peak of 76,010 points on Monday, the sensex has lost 1,500 points.
