DELHI: Haryana result reflects that Congress's singular focus on employment, Agnipath, development and law and order failed to take into account the persistence of Jat vs non-Jat politics in the state. While the party believed people's issues, with the added impetus of populist announcements, would sway voters beyond caste appeal, the poll result has belied its expectation.

After exit polls made Congress hopeful of a sweep in Haryana, result day was marked by a dramatic turn of events as the early soon got trends reversed.What appeared to be a close fight when counting started soon turned into a BJP show. It was nothing short of a shock defeat for Congress with its leaders alleging a conspiracy and saying that "democracy had lost and the establishment had won" in Haryana.The Lok Sabha results in May, where Congress managed to win five of the 10 seats in the state, had shored

Hooda's failure to reach out to in-house rivals accommodate them in the campaign and strategy created a gulf which, in the ultimate analysis, impacted the average Haryana voter. Kumari Selja's reported sulk was the talk of the campaign, as was the claim to the CM's post by multiple leaders. By all accounts, Hooda cornered the lion's share of candidates, pushing out the claims of other members.

But where the party also missed a trick is in how it designed its campaign. The overt focus on wrestlers' protest was also seen to impress the Jat tilt of Congress, and the decision to field Olympian Vines



How LG nominating 5 MLAs could shift balance of power

The votes are in and officials have begun counting ballots cast in the Jammu and Kashmir Assembly elections — the first in the region since Article 370 was abrogated. All eyes are on the Union Territory with its 90 seats up for grabs where parties have to attain the magical number of 46 to emerge victorious in the polls. However, as votes are being counted in this neck-to-neck race, the focus has turned to the issue of nominated Members of Legislative Assembly (MLAs), with the Congress, the National Conference and the Peoples Democratic Party (PDP) opposing it during government formation.

Matter of the 5 MLAs

When the region was reorganised under the Jammu and Kashmir Reorganisation Act, 2019, the legislation held a section according to which the Lieutenant Governor (LG) of the Union territory of Jammu and Kashmir "may nominate two members to the Legislative Assembly to give representation to women." This provision would be exercised by the LG if they felt that the Assembly lacked adequate representation of the women. However, in 2023, this was amended. An addition was made allowing for the nomination of three more members to the Assembly. Two members from the Kashmiri migrant community, one of whom is to be a woman, and one member from the "displaced persons from Pakistan-occupied Jammu and Kashmir". The nominations are at the discretion of the LG, meaning he, Manoj Sinha, can select any five individuals. However, some note that the LG's nomination would be based on the advice of the Union Home Ministry. The law, however, isn't clear if these members would have voting rights and could participate in government formation. But as the Jammu-Kashmir Assembly is modelled on the Puducherry Assembly, it seems that these nominated MLAs would then be given voting rights. Jammu and Kashmir Lt Governor Manoj Sinha's power to nominate five MLAs to the JK Assembly has become a bone of contention between the BJP and the opposition. File image/PTI

Why this matters

The nomination of five MLAs by the LG is significant for a number of reasons. Firstly, it changes the dynamics of the Assembly.

How?

Currently, the J-K Assembly is of 90 seats where the halfway mark is set at 45. However, if these MLAs are selected and given voting rights, the number of MLAs in the House increases to 95 and the halfway mark moves to 48. What this means is that the NC-Congress will need 48 MLAs, rather than the previous 45, to form the government. On the other hand, with five MLAs supporting the BJP, the saffron party would require only 43 MLAs to reach the majority mark. Secondly, the addition of five MLAs could change the dynamics of the House if it comes to a hung Assembly, which many exit polls are predicting could be the result of today's counting. Poll pundits note that these five MLAs could swing the results in the favour of the BJP. Jammu and Kashmir National Conference (JKNC) president Faroog Abdullah and Omar Abdullah show their fingers marked with indelible ink after casting vote during the second phase of Jammu and Kashmir Assembly elections. Senior Abdullah has said that he would approach the Supreme Court against the LG. This move has not gone down well with the opposition, namely the Congress and the National Conference. The Congress in the Union Territory likened it to electoral fraud, with Ravinder Sharma, spokesman of the party saying, "The right to form a new government lies with the elected MLAs of whichever party or coalition gains a majority in the elections. Any nominations contemplated before the government formation in J&K UT would be a fraud.

Workplace mental health: Time for sane Thinking

What defines the real wealth of a nation? Is it the towering skyscrapers that shape its skyline, the bustling industries that fuel its economy, or the global influence it commands? Perhaps it's something much deeper-the well-being of its people, their minds, and their hearts. In a rapidly transforming India, where the pace of professional life is accelerating, workplace mental health has emerged as a crucial but often overlooked concern. As organisations strive for efficiency and output, the mental wellbeing of employees is under increasing strain. According to a survey by the World Health Organisation (WHO), the global economy loses an estimated \$1 trillion per year due to depression and anxiety alone. A study by Deloitte (2022) reveals that nearly 80 per cent of the Indian workforce faces some degree of mental health issues, yet a mere 20 per cent seek professional help. This alarming gap is exacerbated by the stigma associated with mental illness, inadequate awareness, and limited access to mental health services in workplace settings. A recent tragedy in Noida has brought the issue of workplace mental health into sharp focus. A bank employee took her own life after enduring harassment from her colleagues. The deceased left behind a fivepage suicide note in which she revealed how her coworkers subjected her to derogatory slurs such as "bandariya" and "dimag se pagal". In the note, she named six of her colleagues, including two managers, who allegedly contributed to



her emotional breakdown. Another incident from Pune: a 26-year-old chartered accountant from Kerala took her own life after enduring four months of immense work pressure. Her mother's powerful letter to EY India sheds light on the "callous attitude" towards employee well-being that, unfortunately, seems to be a growing concern in many workplaces today. These heartbreaking incidents highlight the toxic environments that many Indian employees silently endure, emphasising the urgent need to address mental health issues in the workplace. For many Indian professionals, the culture of overwork, coupled with societal expectations, creates immense pressure to perform. Long working hours, tight deadlines, job insecurity, and an absence of worklife balance contribute to heightened stress, anxiety, and burnout. In a society where mental health is still a taboo topic, employees often refrain from discussing their struggles, fearing judgement or negative career consequences. No job

is worth a life, and it is time for a systemic change to ensure that every employee feels safe, valued, and heard. Government Policies and **Corporate Initiatives**

India has made strides in addressing mental health in the workplace, but much progress is still required. The Mental Healthcare Act, 2017, provides a legal framework ensuring individuals' rights to mental health care, including mandated insurance coverage for mental health treatments. However, its corporate implementation remains limited. The National Mental Health Policy (2014) advocates for workplace mental health awareness and encourages supportive environments, though widespread adoption yet to be seen. Nonetheless, companies like TCS and Wipro are pioneering employee wellness programs, offering counselling and stress management initiatives. The pandemic also spurred firms like Accenture, Google, and Microsoft to introduce teletherapy and burnout prevention strategies. However, the govern-

ment's 2024-25 Union Budget underscores a significant funding gap in addressing India's mental health challenges. Although the allocation for the National Tele Mental Health Programme has been increased to ?90 crore from the previous year's ?65 crore, this modest rise falls far short of the resources needed to meet the country's escalating mental health demands. A more comprehensive investment in workplace mental health remains critical for sustain-

able progress. **Role of Leadership** Corporate leadership plays a pivotal role in shaping workplace mental health. The tragic case of the Noida bank employee's suicide underscores the importance of leadership accountability in workplace preventing harassment. Had there been a proactive, supportive management culture that discouraged workplace bullying and provided a safe space for employees to raise their concerns, the outcome might have been different. Leaders must take responsi-

bility for creating a healthy, inclusive work culture that discourages toxic behaviour. Creating a mental healthpositive workplace culture requires a top-down approach where leaders not only encourage open dialogue but also normalise seeking help for mental health issues. Human Resources departments need to adopt a proactive role in identifying mental health risks and offering solutions, wellness checkins, and mental health days. A Holistic Approach

While government policies and corporate initiatives are crucial, sustainable change requires a multi-faceted approach.

Increased Awareness and

Training: Regular mental health awareness campaigns within organisations can help destigmatise mental health issues. Training managers and employees to recognise early signs of distress and offer support will create a safer environment for discussing mental health concerns. Mental Health Infrastructure: Companies need to invest in mental health infrastructure, including easily accessible counselling services, confidential helplines, and designated wellness officers. Telehealth platforms, which have seen increased use since the pandemic, can play a critical role in connecting employees with mental health professionals. Work-Life Balance: Flexible working hours, hybrid models, and vacation policies that prioritise rest over constant productivity can significantly reduce burnout. Encouraging employees to disconnect after working hours.

How Iran's pan-Islamic obsession pits it against Israel

Is a war between Israel and Iran on was even more powerful than the was often feared during the last two decades. However, it was not until earlier this year that the Islamic Republic actually chose to hit Israel directly. Under Operation "True Promise", Iran fired a barrage of around 300 ballistic missiles, cruise missiles, and suicide drones upon Israeli targets the night of April 13-14, 2024, almost a fortnight after Israeli airstrikes on the Iranian consulate in Damascus, Syria (April 1) had killed 16 persons, half of whom were officers of the Islamic Revolutionary Guards Corps (IRGC). Uzi Rubin, an expert of missile defence systems and a senior researcher at the Begin-Sadat Centre for Strategic Studies at Bar-Ilan University, disabuses the notion that the attack was a mere face saver aimed at inflicting minimal damages. Rubin argues that it was a strike of unprecedented magnitude, which capability.

the cards? Outbreak of full-scale Russian opening strike against hostilities between Israel and Iran Ukraine in February 2022. Israel's ability to intercept and deflect these attacks was a testimony to the success of its missile defence system. Recently, Tehran saw a merit in repeating those attacks as Operation "True Promise-2," after Israel boobytrapped Hezbollah's pager devices and launched devastating airstrikes in Lebanon that killed Hezbollah chief Hassan Nasrallah in his secret bunker. Whether Israel retaliates or decides to tactically overlook the volley, as it did last April, is a matter of speculation. If indeed Israel seeks reprisal, it has plenty of high-value targets on the ground in Iran to choose from. They include military and intelligence sites, military command sites, oil terminals and refineries, and even nuclear reactors. The killing of Hezbollah chief Hassan Nasrallah in Israeli airstrikes on the Dahieh suburb of Beirut, a predominantly Shia stronghold, was a tectonic event both for the group and the region. Nasrallah had been the leader of Hezbollah for over three decades. The outfit itself was designated as a terror group by the US and others in 1997, two years before even Al Qaeda was labelled as such. existential in nature than ever before. Along with Nasrallah, a majority of the group's military and political hierarchy has also been eliminated. While Israel's offensives against Hezbollah's leadership are not new, the 2006 Israel-Lebanon war, where Israel failed to deliver a thumping defeat, was a focal moment in its strategic thinking. The 2008 assassination in Syria of the group's second in command and founder of the Lebanese Islamic Jihad Organisation, Imad Mughniyeh, was a turning point, one that ultimately culminated in Israeli operations inside Lebanon over the past two months, such as targeting communication lines used via old pagers and walkie-talkies. Moving forreconstructing Hezbollah in a post-Nasrallah era will not be easy. Israel, with these strikes, followed by a real threat of a region-wide escalation, may have found ample time for itself to hope for a political alternative emerging from within Lebanon, a country where Hezbollah was a state within a state and challenged the normal functioning of politics. Lebanon has had no president since 2022. Along with Nasrallah, the killing of senior Hezbollah commanders, such as the southern front chief Ali

Karaki and Iranian command-Abbas Nilforoushan, er amongst others, also significantly disrupts the chain of command.

The Iranian retaliation against Israel in the form of ballistic missiles was explicitly highlighted as a response to these assassinations. The next leader of the group is widely expected to be Hashem Safieddine, a senior member and cousin of Nasrallah. Safieddine, by some accounts, is more radical and less politically astute than his predecessor. Sporting a black turban, he believes that he is a direct descendant of Prophet Mohammed.

Zakir Naik's Pakistan Visit Will Further Stoke Fire of Islamic Extremism

Controversial Islamic preacher Zakir Naik is currently on a visit to Pakistan, where he is scheduled to deliver a series of public lectures across major cities, including Karachi, Lahore, and Islamabad, from October 5 to October 20. His arrival at the invitation of the Pakistani government has ignited considerable concern regarding the potential ramifications of Naik's ideology on a nation already wrestling with escalating fundamentalism and sectarian violence. Born in 1965, Naik is infamous for his provocative and often divisive sermons that have gained a global audience. His lectures advocate a stringent interpretation of Islam and frequently challenge the beliefs of other religions, asserting a narrative of Islamic superiority. In 2016, he fled from India amidst allegations of inciting terrorism and hatred, subsequently finding refuge in Malaysia. Since then, he has continued to attract significant attention, both from supporters who view him as a visionary promoting interfaith dialogue, and critics who contend that his rhetoric often strays into incitement, fostering fundamentalist interpretations that may lead to radicalisation. One of the most concerning aspects of Naik's influence is its documented ties to extremist groups. In the past, multiple Bangladeshi militants have openly acknowledged being inspired by his teachings. Particularly alarming is the fact that Bangladeshi youth who carried out the 2016 Dhaka café attack at the behest of ISIS ideology had cited Naik's lectures as a crucial motivating factor behind their actions. These admissions reveal a disturbing truth: Naik's sermons are

not merely educational but can act

as a conduit for violent extremism. In light of this context, his forthcoming lectures in Pakistan are especially troubling. The country has long struggled with fundamentalist ideologies, resulting in the emergence of extremist factions that target minorities and incite sectarian violence. Naik's presence is poised to intensify these tensions, further polarising an already divided Pakistani society. For decades, Pakistan's landscape has been deeply scarred by religious extrem-

The emergence of fundamentalist groups has not only jeopardised the secular fabric of society but has also incited violence against religious minorities. Communities such as Ahmadis, Christians, Hindus and Shias have endured systemic discrimination, violence, and persecution, frequently rationalised by extremist interpretations of Islam. As the nation continues to grapple with its multifaceted identity, the influx of radical ideologies presents a significant threat to its minorities.

The Pakistani government has made no efforts to counter extremist narratives and hence the societal currents of fundamentalism remain robust. The minorities in Pakistanparticularly Ahmadis, Christians, Hindus and Shia Muslims—are surviving in a precarious situation. Ahmadis, for instance, are legally designated as non-Muslims and have to endure persecution, violence, and even murder. The blasphemy laws, frequently exploited to target these communities, have resulted in mob violence and wrongful imprisonments. Christians and Shia Muslims also face targeted assaults .from extremist factions.

"They will reach their minimum marriage age, and we want the girls to marry and live happily," he stated. This financial support plan cannot benefit the daughters of MPs, MLAs, or Ministers, the Chief Minister added.

Uttarakhand UCC panel finalizes draft, to submit it for Dhami govt's nod Delhi: A committee on the Uttarakhand Uniform

Civil Code on Monday put a final seal on the draft report, which now only awaits thumps up from the CM Pushkar Singh Dhami-led state government. "In the final meeting of the five-member draft committee today, the committee has put its final seal on the draft report of the UCC. After printing the UCC draft report, the committee will submit this report to Chief Minister Pushkar Singh Dhami," said Shatrughan Singh, chairman of the Uttarakhand Uniform Civil Code Draft committee told news agency ANI. In March this year, President Droupadi Murmu approved the Uniform Civil Code Uttarakhand Bill, 2024, which allowed the Uttarakhand government to issue a notification to make the UCC a law in the Himalayan state. Uttarakhand could become the first state in the country to implement the UCC Act. The Uttrakhand UCC contains laws relating to marriage, divorce, succession, live-in relationships, and related matters. The Uniform Civil Code in the state will make it compulsory for livein relationships to be registered under the law. In July, during BJP's extended state working committee meeting in Dehradun, CM Dhami announced the goal to implement the Uniform Civil Code by November 9, coinciding with the State Foundation Day.

"The UCC is a very big thing for our state. The people of the state had elected us for the same reason. I congratulate all the people of Uttarakhand on the implementation of the UCC. After the implementation, several complexities would be made easier," CM Dhami had said.



Government to prolong EV policy beyond March 25: Rai

Delhi: The government plans to extend the electric vehicle (EV) policy through March 2025, ending Delhiites' protracted wait for the subsidies and other benefits associated with buying an EV. This will probably be the final extension before EV policy 2.0 is implemented. A proposal for the extension will be drafted by department officials under the direction of the transport minister and presented to the cabinet for approval. "Work on the EV policy 2.0 has begun." The current policy will be extended one last time until then. Additionally, this would guarantee that buyers who have been waiting months for subsidies like road tax exemptions—will get them," an official stated. Since the policy's expiration on December 31, 2023, the buyers of electric vehicles have been without benefits for more than six months as a result of the non-renewal. According to the official, in order for the benefits to continue, it had to be extended in January of this year.

Maliwal, 2 others cleared in 2011 prohibitory order case

New Delhi: A Delhi court recently acquitted Rajya Sabha member Swati Maliwal and two men in an FIR registered against them over their protest raising anti-govt and pro-Lok Pal Bill slogans in 2011, allegedly in violation of Delhi Police's prohibitory order. The court of Additional Chief Judicial Magistrate acquitted Maliwal, Arvind Gaur, and Neeraj Kumar Pandey of the offences under sections 188 (disobeying an order from a public servant) and 34 (common intention) of the IPC, 1860, stating that the prosecution has "miserably failed" to prove its case against all three accused."The burden of proving its case always lies upon the prosecution, and the guilt of the accused has to be proved beyond reasonable doubt in every case. For the reasons assig ned herein above, the prosecution has miserably failed to prove its case whereby all the accused, namely Arvind Gaur, Neeraj Kumar Pandey, and Swati Maliwal, stand acquitted of the offence under sections 188/34 IPC," said the court.

According to the prosecution, the protest by the accused persons caused a traffic jam at Connaught Place inner circle, and they did not leave the spot despite warnings. A total of 13 witnesses were examined by the prosecution, of which 12 were police witnesses and one was a public witness. The court, taking on record the testimonies and the evidence produced, said that in order to prove its case, first and foremost, the prosecution was required to show that the order was promulgated in the manner prescribed by law and that the accused persons had knowledge of the prohibitory order, despite which they disobeyed the same. This is lacking in the present

case, the court said. The court stated that the quintessential link connecting the accused with the crime is missing in the case, and the prosecution has failed to establish the presence of the accused .
