NEW DELHI: India now inked another contract for the import of an additional 73,000 SiG Sauer assault rifles from the US, which will add to the 72,400 such guns bought earlier for frontline Army troops, amid the continuing military confrontation with China in eastern Ladakh. 'The SiG-716 `Patrol'

rifles, which are 7.62x51mm caliber guns with an effective 'kill' range of are 500-metre, meant for infantry battalions deployed along the borders with China and Pakistan. 1x1 polls

"I have realised that how the people could cast their vote and how my colleagues would seek votes for the assembly, which I am trying to devalue by not contesting in the elections, which was my mistake," said Omar, who lost to imprisoned independent candidate Engineer Rashid in Baramulla during the recent Lok Sabha elections.

Ganderbal is widely regarded as an NC stronghold, having elected three generations of the Abdullah family, starting with party founder Sheikh Mohammad Abdullah in 1977.

His son and current NC chief Faroog Abdullah won the seat in 1983, 1987, and 1996.

labourers, small business owners, and students standing with their bicycles amidst heavy vehicles. The reason? Potholes make it difficult for them to navigate, and as the heavy vehicles move forward, so do the two-wheeler riders, often damaging their bicycles in the process. This daily struggle

occurs when traffic jams

occur due to heavy vehicles on the bridge or when a part of the bridge is broken. Two-wheeler riders end up taking their vehicles onto the footpath because they can't ride through the potholes. Even pedestrians are forced to use the footpath due to the same reason. After all, everyone needs to reach school, office, or work on time. While this

may seem like a minor inconvenience, it becomes a significant issue when you're apprehensive about crossing a bridge that has deteriorated over time. 

#### **Blue Screen Blues: Microsoft Triggered** Cyber Meltdown and the **Case for Atma Nirbharta**

The champions of Atmanirbhar Bharat, isolationists among conservatives and the malcontents of globalisation are having a "told you so moment." The Microsoft outage has given all of them a chance to have a right royal moan about the perils of blind belief in the overarching credo of the liberal world order: that international post-World War II system characterised, at least in one context, by the encouragement of global trade, economic interdependence, and multilateral agreements. And it's not hard to see why. Look at the mayhem caused by a single rogue file called c-00000291\*.sys. This teeny-weeny alphanumeric code in a single content update virtually fried the dendrites of the Microsoft Operating System that literally turned blue the pallor of death. Questions abound: did the firm tasked by Microsoft to ward off viruses and malware itself violate zealously adhered to software testing and development guidelines? Software updates are stringently tested at many levels before they are rolled out globally. The fact that this one slipped past shows that the checks and balances aren't as foolproof as they ought to be. The descent into defective code-induced dysfunction triggered global mayhem. The cost to businesses and economies could run into billions of dollars. This disruption was because of negligence, what if the next cyber pandemic is because of malevolence? no country except autarkies like China, Russia and North Korea, and the less technologically leveraged in the Global South, were spared. But because India is a paid-up member of the globalised, rules-based world order, it was strongly buffeted. Indeed, in a less connected world, a freak outage such as this would have had less impact. But that a single misplaced bit of computer code could bring nations to their knees reveals just how uncritically accepting we continue to be of "globalisation" as a project for the advancement of the human race. One would have imagined that we would have been less credulous by now, three years after a single sneeze triggered a global pandemic that stilled the globe and our lives. But clearly, some lessons are hard to learn. While no one needs to take the sledgehammer to globalisation, it is becoming obvious that there is a need to minimise risks. Perhaps, as a first step, by improving vigilance and incorporating redundancies throughout the global supply chain. This imperative of building self-reliance, however, will only gain ground when any prospective autopsy of the costs of globalisation is freed from politics. As of today, any inquiry into the status quo is dismissed by the Left as a "right-wing" lurch towards protectionism, spawned by a crude inward-looking parochialism. In India, examples abound. A certain section of the political class and commentariat mocked Prime Minister Modi for being blinded by exclusivism for deciding against joining an influential trading bloc like the RCEP. The decision, as it turned out, was the right one. Thailand joined the RCEP but in the last 18 months, its GDP growth has slumped to 2.7 per cent. This is largely due to trade imbalances after the RCEP's lead member, China, dumped goods, wantonly taking advantage of favourable tariff rates that its economic heft allowed it to impose across the RCEP. Of course, the stigmatisation of Atma Nirbharta is not only confined to trade-related policies but also foreign policy. Modi's "keep all options open" policy-driven engagement with Russia was the subject of scorn just a few weeks ago. Global interconnectedness has brought many benefits to many people. But the prohibitive costs of its many misses have brought ruin upon millions too.

# New criminal laws are betting on DNA finger printing. India must prepare to offset risks

India's new criminal laws emphasise the use of technology and modern forensic methods to speed up justice and take the conviction rate up to "90 per cent". DNA fingerprinting, used extensively in the developed world, is one such technique. Other than producing scientific evidence against known suspects, DNA databases of previous convicts also assist investigators with unsolved crimes. However, is it the proverbial silver bullet as touted by many in the law enforcement community? DNA fingerprinting involves creating a profile of an individual's genetic make-up. This throws up various legal, quality control, privacy, and human rights issues. It is therefore crucial to examine the adequacy of the systems put in place to achieve the goals of these 21st-century legislations. A comprehensive, robust, and independent regulatory and oversight mechanism, established by a statute, is imperative. Developed in 1984 by British geneticist Sir Alec John Jeffreys, DNA fingerprinting entails analysing a person's DNA profile from human cells like hair, saliva, or blood and creating a profile used for identification in forensic investigations. It was first successfully applied in the twin rape and murder cases of two girls in the UK. The late Prof Lalji Singh at the Centre for Cellular and Molecular Biology (CCMB) in Hyderabad pioneered the use and application of forensic DNA technology in the Indian legal system in 1988. The Bharatiya 2022 the term 'measure-



Nagarik Suraksha Sanhita (BNSS) 2023, which replaced Code of Criminal Procedure (CrPC), retains the provision for mandatory DNA profiling of rape case suspects, introduced in the CrPC in 2006. In addition, Section 176(3) of the BNSS mandates the collection of forensic evidence collection from crime scenes in offences punishable by seven years or more. Another new law, the Procedure (Identification) Act 2022 which replaced the coloniaera Identification of Prisoners Act 1920— allows the extraction and analysis of biological samples from convicts, preventive detainees, as well as those arrested for charges punishable by 7 years or more, or any offence against a woman or a child. Notably, the National Crime Records Bureau (NCRB) has been entrusted with the responsibility of collecting measurement records from states and maintaining a national database. According to Section 2(b) of the Criminal Procedure (Identification) Act

ment' includes biological samples and their analysis, which also implies preparing DNA profiles. In fact, when the government withdrew DNA Technology Regulation Bill, 2019 in July 2023, it stated that most of its provisions had already been incorporated into the 2022 Act. However, without adequate safeguards, there is a risk that individuals may be arrested simply to include them in the database. Neither the BNSS nor the Identification Act define the 'DNA profile'. GeneWatch UK, in its comments on India's DNA Technology (Use Application) Regulation Bill 2019, noted that DNA profiling can be restricted to only non-coding DNA, a commonly used international standard. This prevents using DNA sections that code for personal characteristics, including medical conditions. Forensic geneticists, in the past, have been criticised for attempting to create mugshots—essentially predicting physical appearance—using genetic

information. Given the broad

whose biological samples can be collected by the state, such a restriction would help eliminate many possible misuses. The reliability of DNA fingerprinting has often been challenged, particularly concerning quality control during the handling of biological materials at different stages. Contamination of samples is a problem. Polymerase Chain Reaction (PCR), the most widely used technique for amplify small DNA quantities, also amplifies contaminants. There have been several high-profile cases of sample contamination. For instance, the defence in the OJ Simpson case argued extensively about the contamination of collected biological material. He was finally acquitted by the jury. Similarly, in the Pune Porsche hit-and-run case, the alleged culprit's blood sample was swapped with his mother's. Such examples highlight the need for strict quality control mechanisms and robust protocols for forensic labs (central, state, or private), investigators, medical practitioners, and data bank The managers. (Use Technology Application) Regulation Bill 2019 proposed the creation of a DNA Regulatory Board. This board was meant to advise the central and state governments on DNA labs and data banks and to grant accreditation to However, the bill was withdrawn in July 2023. While some functions of the DNA Regulatory Board have been assigned to the NCRB, it can-

The absence of an independent, full-time regulatory body in India does not bode well for standardising procedures across the board. Law enforcement agencies worldwide use DNA profile indices from crime scenes to help identify suspects in unsolved crimes. In India, it is unclear which agency will maintain the Scene of Crime DNA Profile Index, and who will conduct matching with the Convict or Arrestee Indices. A PIL is pending in the Supreme Court for using DNA fingerprinting to solve missing person and unidentified dead body cases. Sharing data with foreign law enforcement bodies by the NCRB is another ticklish issue. Profiles of investigators, medical practitioners, and forensic scientists should be prepared and maintained separately to distinguish their DNA from that of suspects in cases of multiple profiles resulting from collected samples. After the withdrawal of the DNA Technology Bill, no oversight body has been proposed to oversee the NCRB as a repository of national or state government databases. Oversight bodies are crucial for the governance of DNA databases, ensuring they contribute effectively to the criminal justice system, meet ethical and regulatory require-

ments, thus maintaining public trust and accountability. As data will be stored digitally, ensuring data security and privacy is also essential.

He seems mellowed, subdued, quieter, even reflective. Although the media seems less concerned about his overall well-being than a more popular political personage, the impact of that event cannot be discounted. The nation—the US needs to know to what extent he has been affected by this ordeal. But even more imperative are medical updates on the man who still has control over the nuclear balloon but cannot remember the name of his own Secretary of Defence or a Supreme Court justice's full name. Whether Biden remains in the race or steps aside in favour of someone younger and composed, he will still be in charge of the US at least till January 2025 and (supposedly) taking decisions that can have wide-ranging consequences. So his health is a crucial matter. Yet, the media and commentariat in the US is focusing voter attention only on the fact that he is doing well after being diagnosed with Covid-19 yet again. Despite having taken multiple booster shots of the vaccine in the past four years. The only question being mildly raised is whether he has the stamina to keep up with the pace of the Presidential elections. They are glossing over the

more important issue of Biden's fit-

and shuffling while walking, a very visible stiffness in his arms and legs, wooden smiles and all-too-frequent moments of blank incomprehension on his face do not portend well for a man who is one of the world's most powerful leaders. That the White House is behaving as if "aall izz well" is even more alarming in that context. One commentator observed that not since the Nixon era has the White House been so busy hiding information about a President. There is no problem with your average Grandpa being creaky and forgetful, but if that old man also happens to be POTUS, it becomes a matter of international consternation. There are precedents of US presidents not being open about their health. No one knew then, for instance, that John F Kennedy was taking a strong cocktail of steroids to deal with health issues though he exuded an image of robustness. And Franklin Roosevelt

Delhi: India, which forbids liquor advertising, will soon outlaw surrogate ads and event sponsorship, forcing Carlsberg, Pernod Ricard, and Diageo to rethink their marketing strategies. Such "surrogate ads" often circumvent the ban by showcasing less desirable things like water, music CDs, or glassware with logos and colors related to their main product, often pushed by Bollywood stars. "You can't take a circuitous

way to promote products. "If we find ads to be surrogate and misleading, then even those who are endorsing (products), including celebrities, will be held responsible." In India, Carlsberg advertises their Tuborg drinking water with film stars at a rooftop dance party and the phrase "Tilt Your World", echoing its beer commercials elsewhere, "Drink which say Responsibly". India is the world's eighth-largest alcohol market by volume, with Euromonitor estimating \$45 billion in annual revenues. The reforms imperil liquor companies. accounts for a tenth of Pernod's global revenues, while Diageo and Pernod hold a fifth of the whisky market.

The proposal states that "prohibition against engaging in surrogate advertisement" applies to sponsorships and commercials for extensions" that resemble alcohol brands.

Income tax returns (ITRs) touched a new record of nearly 7.3 crore, 7.5% higher compared to 6.8 crore in previous fiscal, by the July 31 deadline, the income tax department said on Friday.Out of the total ITRs of 7.3 crore filed for AY2024-25, 5.3 crore have been filed in the new tax regime compared to over 2 crore ITRs filed in the old tax regime," it said. While trial production would start a bit sooner, the insiders also mentioned that when the newest iPhone 16 models hit stores worldwide around September this year, the first iPhone Pro handsets will be produced in India.

Just like with the non-Pro series, Apple will export the iPhone Pro models to different worldwide markets after production stabilises in India. A year has passed since the plan's inception, during which time the supply chain for new gadgets has been under constant scrutiny. The company will continue to assemble the Pro models, as it has been successful thus far, according to one source. The results have been positive.

**Delhi**: To check the growth of illegal e- rickshaws, Delhi govt's transport department has decided to scrap the impounded and unregistered e-rickshaws within seven days if the owners do not apply for registration of their vehicles. Earlier, 90 days were allowed for this process."Under the rules, the registration window is 90 days. But since these rickshaws are illegal, they could be scrapped after seven days,' said a transport official on Friday. "The transport department has given a fresh push to booking illegally operating e-rickshaws. This month, till Aug 21, the department impounded 1,077 e-rickshaws, meaning over 50 of them seized every day.

The decision was taken after a high-level review meeting chaired by the lieutenant governor as a means to decongesting the city. According to estimates, there are 1.2 lakh registered e-rickshaws in the city. However, the actual number of e-rickshaws on the ground is perhaps twice that figure, necessitating a check on their illegal proliferation. "Because the unregistered e-rickshaws do not have number plates and so cannot be challaned online, they flout all traffic restrictions and often ply on roads where they are not permitted, thereby slowing down traffic and causing congestion," said the official.

"This improvement in the health of banks will help improve credit availability to our poor, farmers and MSMEs," he said Modi's X comments on the banking sector's FY24 milestone earnings. Public sector banks made a record Rs 1.4 lakh crore in net profit in FY24, up 34% from Rs 1.05 lakh crore.

Private banks grew 42% faster, raising their net profit to Rs 1.7 lakh crore from Rs 1.2 lakh crore a
