

The Delhi Jal Board will begin efforts to plug unlicensed borewells



Delhi: The Delhi Jal Board (DJB), which has formed 16 teams to investigate such activities throughout the city, will close down illegally operated borewells. The drive is a reaction to an ongoing case before the Green National Tribunal (NGT) concerning illicit groundexploitation. water According to Delhi

The water utility has formed 16 teams to investigate unlawful borewell activities throughout the city as part of the Delhi Jal Board's (DJB) upcoming push to shut them, according to officials with knowledge of the situation. A subdivisional magistrate, local assistant engineers and the executive engineer of DJB, as well as representatives from the tax department, make up the sealing teams. The district magistrate and DJB superintendent engineer will oversee each district's drive, according to a January 24 order from DJB CEO Cheshta Yadav. A top DJB official who was aware of the initiative stated that there will be 1-3 teams in each of Delhi's 11 revenue districts.

L-G urges the Department to amend the compensation structure for cooks

Delhi: The Department of Social Welfare was instructed by Delhi Lieutenant-Governor VK Saxena to carry out the Delhi High Court's ruling and pay cooks according to the updated pay scale established by the Seventh Pay Commission. Back in February 2016, the Central Administrative Tribunal (CAT) rendered a verdict that favored the cooks. The Delhi government then filed a case in the High Court challenging the CAT decision. In January of last year, the High Court ultimately ruled in favor of the cooks, according to officials. The chefs filed a contempt petition when the Delhi government refused to carry out the Delhi High Court's ruling, and in January 2024, the Delhi government eventually sent the file for the Lieutenant-General's



permission, according to Raj Niwas authorities. After clearing a file in this regard, the L-G noted that the department ought to have been more considerate of the requirements of workers its and shunned needless litigation and delays. Cost-effective prosthesis to restore their voice

NEW DELHI: In what could prove to be a boon for patients who have lost their ability to speak due to throat cancer, All India Institute of Medical Sciences, in collaboration with IIT Delhi, has developed a cost-effective prosthesis to restore their voice. According to doctors, many throat cancer patients are unable to speak after the removal of their larynx due to advanced stages of laryngeal disease. Larynx, or voice box, contains vocal cords and helps a person speak, breathe and swallow. A study conducted on 20 patients over three years has yielded positive outcomes, said AIIMS doctors. Until now, patients have been implanted with commercially available voice prosthesis costing between Rs 20,000 and Rs 40,000. However, the AIIMS-IIT prosthesis is free of cost for AIIMS patients. Following successful trial completion and approvals, it may be made available for other patients and could cost a few hundred rupees. Dr Alok Thakar, head and professor of otolaryngology and head/neck surgery, said the aim of developing the device was to ensure patients who lost their voice due to cancer in the larynx can speak again without shelling out thousands of rupees on an artificial voice box. "During the tracheoesophageal puncture (TEP) procedure, we create a small hole in the wall between the trachea and esophagus, the tube that moves food from mouth to the stomach. A small one-way valve, called tracheoesophageal prosthesis, is placed inside the hole to direct air into the throat," he said, adding the valve is made of silicon. He said the vocal cords are completely removed during total laryngectomy surgery and the sound source is lost. The TEP surgery with a prosthesis creates a path for air to move from lungs to the esophagus. This air causes the top of the esophagus to vibrate, producing a new tracheoesophageal voice, he explained. The device, weighing a few grams, enables throat cancer patients who had their larynx removed to speak. Prof Rakesh Kumar from the ENT department said on an average, annually four-five out of 25 patients suffering from larynx cancer face voice box removal risk. Usually, cancer occurs in the 50-60 age group. "It's not difficult to learn how to use the prosthesis. After surgery, patients just need guidance and practice. The prosthesis valve lasts sixeight months on an average. The replacement procedure doesn't require surgery. It is usually painless and can be done in OPD," he said. Doctors said TEP's main advantage is it generates the most intelligible, fluent and natural voice compared to other alaryngeal speech

DPCC has submitted an action-taken report to National Green Tribunal (NGT)

New Delhi: Delhi Pollution Control Committee (DPCC) has submitted an action-taken report to National Green Tribunal (NGT) on the pollution caused by dumping of construction and demolition waste near residential complexes in Vasant Kunj. In the report, DPCC stated to have issued a show cause notice to Delhi Development Authority (DDA) and Municipal Corporation of Delhi (MCD) and an environmental compensation of Rs 1 lakh was imposed. The tribunal had constituted a joint committee of DDA, DPCC and district magistrate (South West Delhi) in Sept 2022 to verify the factual position about heavy vehicular movement and dumping of construction material on the vacant land adjacent to Sector E-2, Vasant Kunj. After inspecting the area in Dec 2022, the committee issued directions under Air (Prevention and Control of



Pollution) Act, 1981 and Environmental (Protection) Act, 1986 along with Construction and Demolition Waste Rules, 2016 to DDA and MCD. As the issue remained unresolved, NGT in Nov 2023 ordered the DPCC to issue show cause notices and impose penalty on the DDA and MCD.

"DPCC has issued show cause notice on Jan 5, 2024 for imposition of Environmental Damage Compensation of Rs 1,00,000 to the superintendent engineer, DDA for past violations and damage to the environment," stated DPCC report dated Jan 11, uploaded on NGT website on Saturday.

A similar show cause for damages of Rs one lakh was sent to MCD deputy commissioner (Najafgarh Zone), said the report, adding both agencies were yet to submit their replies to the concerned authority. In 2022, residents of Sector RE02 and E-1.

edtech startup Byju's has launched a rights issue to raise \$200 million from existing investors at a valuation of about \$225 million-\$230 million, a 99% drop from its peak valuation of \$22 billion as it struggles with a funding crunch. New India champions and equity at Davos

As India's economic performance grows, its soft power grows in proportion. Prime Minister Narendra Modi as the charismatic leader of this 75-year-old republic and ancient civilisational culture, is thought to have answers to the dilemmas of the currently divided and troubled world. From a country that used to deliver unwanted lectures to the world, it is now much sought after. Modi's 'one world family' messaging during the recent G20 year hosted by India, ended by including the 55 nation African Union into its fold. India made the effort, achieved unanimity for the move, and successfully included the most exploited and savaged continent on earth onto the leading global platform where its ills can be addressed. Domestically, the inclusive tone is set by 'Sabka Saath, Sabka Vikas, Sabka Prayas, Sabka Viswas', despite the inevitable mockery and accusations of Hindu triumphalism. Together, these ideas resonate in an old-fashioned way in a world with two ongoing wars, one in Europe and the other in West Asia and the tendency to form opposing axes. A polarisation not seen since WWII is developing in a very worrisome way. Meanwhile, the fact that India has drawn closer to Saudi Arabia, the United Arab Emirates, and Israel than ever before, in practical, material, ways, gives the lie to the criticism of Hindu communalism. In addition, America has become a firm strategic partner with military and technological benefits for both. France is now a firm friend and defence manufacturing partner too, along with Russia. Other relationships have also undergone massive positive transformations, such as the one with Japan.

Modi, a grey eminence with unbounded energy, in his 73rd year now, is widely regarded as one of the most respected and influential voices in the pantheon of global leaders. With a gross domestic product growth of around 7 per cent per annum going forward, India is expected to occupy the 3rd position in the world by 2027. It will be behind only the US and China, with a GDP of \$10 trillion, up from its current \$4 trillion. It is the world's most successful economy now. By 2047, India's 100th year since Independence, it is expected to have become a highly developed country. It will also have multiples of its present per capita income for its vast population, expected to touch 1.70 billion by then. It is expected to have an economy of over \$30 trillion by then That India's soft power is growing alongside all this is not surprising, nor is it unprecedented. Ancient India was fabled for its wealth, the greatest in the ancient world. That it set off a series of marauding conquests and occupations was the other side of the coin not likely to be repeated in the 21st century. Its cultural, civilisational and dharmic influence spread all over the Far East including China and Japan. Without any aggression, attempt at domination or conquest. West Asia was also heavily influenced by Indian learning and innovation. And not a few so called inventions and discoveries claimed by the West were shamelessly lifted from India without acknowledgement. Davos, used to hosting world's leaders, its finest minds and economic thinkers, for over half a century now, witnessed a major presence from India this year, building on the interest generated last year. This in the presence of leaders from 300 countries. The rate of foreign direct investment into India has trebled, and is slated to grow exponentially into high technology areas such as chip-making, defence manufacturing, artificial intelligence, and other relocations of manufacturing from China. For its latest soft power projection, India deployed the thoroughly con-fident and articulate Union Minister for Minority Affairs, Smriti Irani. She led the charge for global gender equality and equity.

Union Home Minister's Internal Security strategy paying rich dividends

It is a mark of the present Union Home Minister's farsightedness and dedicated leadership that in his direct guidance a three-fold strategy of strengthening the internal security of the country has already produced good results. In a nutshell, this can be described as combining development with security in dealing with Maoists, taking the zero tolerance approach to terrorism beyond 'policy' to the turf of 'action' and integrating internal security with border security and law & order management to ensure total handling of the task of securing the nation. With his hands-on approach, Amit Shah has lent speed to the efforts initiated in multiple spheres towards this objective and pursued them on an untiring note. This was reflected in his prompt visit to Sukma in Chhattisgarh in April 2021 to make an in-depth examination of the circumstances in which CPI (Maoist) had ambushed security forces led by CRPF in Sukma-Bijapur road and caused the death of 22 personnel, his address at the All India Police Science Congress at Dehradun in October this year, and the follow up directed by him on Police Technology Mission earlier announced by Prime Minister Modi at the DGPs Conference held at Lucknow in 2021. The crucial details of this strategy need to be highlighted to get a



proper understanding of what all was being done. The Home Minister has formulated a comprehensive strategy for tackling Left Wing extremism. While putting down the violence with all the might at the government's command, modernising police forces, providing them with helicopters and UAVs for surveillance and upgrading some 250 police stations in the Maoistaffected regions, had been given priority. The Centre has funded the development of road infrastructure, opened post offices, bank branches and ATMs and tried to enhance the financial inclusion of people there.

To improve connectivity, mobile towers have been installed in 34 districts affected by the Maoist problem. The Ministry of Home Affairs has created a separate Left Wing Extremism Division to monitor the implementation of the new policy framework evolved by the present regime to deal

with the problem. Tribal communities and Economically Backward groups were being exploited and even threatened by the Maoists to sustain the Protracted People's War against the Indian nation. The extremists take to targeting schools, health centres, railways, roads, and bridges to thwart the development schemes of the government. The Home Minister has highlighted the need for CRPF and other security forces to adopt a people-friendly behaviour, handle welfare schemes for the locals and keep avenues for talks open wherever possible taking the help of civil society groups if available. It is the multi-prong responses combining counter-insurgency operations and development work, that have enabled the government to drastically curb the violence of Maoists and wean the population from the ideological influence of CPI (Maoist) in the Dandakaranya hinterland of the country. The

been working on a 'National Policy and Action Plan' since 2015 to deal with Left Wing Extremism through a collaborative approach between the Centre and the states and there is no doubt that the leadership of the Union Home Minister has made all the difference. Addressing the Anti-Terrorism Conference organised by the National Investigation Agency (NIA) in October last, Shah perceptibly underscored the importance of dismantling not just terrorism but the entire 'terrorist ecosystem' involving cryptocurrency, hawala, terror funding, organised crime and narco-terrorism. He lauded the compilation of data regarding terrorism in the last few years and emphasised that the fight against terrorism would require collaboration from global to local levels including various states. He called upon the NIA and the IB to standardise training programmes for all Central and state counter-terrorism agencies to ensure uniformity in their methodologies. The Centre's initiative in building data finds reflection in the success of the National Automated Fingerprint Identification System in bringing over 90 lakh fingerprints on record. On the occasion of Police Commemoration Day on October 21, the Home Minister said that while main-

taining a zero-tolerance policy against terrorism, the government had framed strong laws to curb its spread. In the context of the modernisation of Police forces, he announced that a Police Technology Mission had been established with the aim of creating the "world's best anti-terror force".

The focused attention given to the task of countering terrorist activities in the country, under the direction of Shah, has already resulted in a nearly 65 per cent decline in incidents of terrorism, insurgency and Maoist violence. In what should be considered a move of great strategic importance in the area of national security, the Home Minister told the 49th All India Police Science Congress at Dehradun in October last year that internal security, border security and good law & order management were the integral components of the system that made the country secure. The Ministry of Home Affairs has taken several measures to improve law & order throughout the country. The Home Minister has made a significant observation that "as we move towards becoming a robust economic power our police and security agencies must assume a more substantial role in safeguarding our economic institutions". The friction between India and the Maldives could generally be considered as falling mostly within the realm of strategic competition in a geopolitical space.

undertone. Not only is Muizzu anti-India, he also tilts towards conservative ideology and radical Islam. The Maldives, a Muslimmajority country, has seen a surge of radical elements in its society since about a decade and a half ago. Mauritius' cultural overtures also have a subtle hint of attracting Indian tourists, as they are likely to think of options other than the Maldives for holidays. While Lakshadweep may be gaining traction after Prime Minister Narendra Modi endorsed it as a tourist destination, it could take time for Lakshadweep to develop into a full-fledged tourist destination like the Maldives. Identifying this scope, Mauritius has subtly pitched itself as an alternative to the

As per the Pakistan-based news daily, PTI Karachi president Khurrum Sher Zaman, who is also contesting the February 8 elections from NA-241, accused the mayor and Sindh Governor Kamran Tessori of indulging in activities tantamount to a violation of the ECP's code of conduct. In a formal complaint sent to the provincial election commissioner, the PTI leader contended that both the governor and mayor were engaging in activities that violate the code of conduct of the ECP, undermining the principles of a fair and impartial electoral process.

In light of these serious allegations, Sher Zaman called upon the ECP to conduct a thorough and impartial investigation into the matter, Dawn News reported. He also urged the commission to take immediate action, including the "temporary removal" of the mayor of Karachi and the governor of Sindh from their offices until the investigation was concluded. "Furthermore, it is requested that the offices of Mayor Karachi and Governor Sindh be sealed to prevent any further misuse of their positions for political gains until the conclusion of the electoral process.

CBI raids activist Harsh Mander's office, residence in FCRA violation probe

The Central Bureau of Investigation (CBI) on Friday conducted searches at the office and residence of retired IAS officer and activist Harsh Mander in connection with a probe related to the violation of the Foreign Contribution Regulation Act (FCRA). The Ministry of Home Affairs (MHA) had recommended a CBI inquiry last year into the foreign funding of Aman Biradari, a non-government organisation (NGO) founded by Harsh Mander. This follows a money laundering probe initiated by the Enforcement Directorate (ED) in September 2021, where Mander's residence was previously raided. The investigation is centred around two NGOs associated with him.

Who is Harsh Mander?

· Harsh Mander is a rights activist associated with right to food, right to information, bonded labour and the right of adivasis.

• He is the Director of Delhi-based think tank Centre for Equity Studies.

 He is author of several books including Between Memory and Forgetting: Massacre and the Modi Years in Gujarat, Partitions of the Heart: Unmaking the Idea of India, The Right to Food Debates: Social Protection for Food Security in India.

Chinese military bodies, purchased Nvidia semiconductors banned by the US

BEIJING: Chinese military bodies, state-run artificial intelligence research institutes and universities have over the past year purchased small batches of Nvidia semiconductors banned by the US from export to China, a Reuters review of tender documents show. The sales by largely unknown Chinese suppliers highlight the difficulties Washington faces, despite its bans, in completely cutting off China's access to advanced US chips that could fuel breakthroughs in AI and sophisticated computers for its military. Buying or selling highend US chips is not illegal in China and the publicly available tender documents show dozens of Chinese entities have bought and taken receipt of Nvidia semiconductors since restrictions were imposed. These include its

A100 and the more powerful H100 chip - whose exports to China and Hong Kong were banned in September 2022 - as well as the slower A800 and H800 chips Nvidia then developed for the Chinese market but which were also banned last October. data needed for machine-learning tasks. The continued demand for and access to banned Nvidia chips also underlines the lack of good alternatives for Chinese firms despite the nascent development of rival products from Huawei and others. Prior to the bans, Nvidia commanded a 90% share of China's AI chip market. Purchasers included elite universities as well as two entities subject to US export restrictions -Harbin Institute of the Technology and the University of Electronic Science and lechnology of China, which have been accused of involvement in military matters or being affiliated to a military body contrary to US national interest.

Telangana postpones gram panchayat polls indefinitely

District collectors were directed to appoint special officers or persons-incharge or a committee of persons-incharge to perform the functions of the gram panchayat

The Telangana government on Thursday indefinitely postponed the elections to 12,777 gram panchayats in the state and placed their administration in the hands of special officers with immediate effect until further orders. The tenure of sarpanches and members of the gram panchayats came to an end on Thursday and they have been requesting the state government extend their term by another six months on the ground that they were not able to do anything for nearly two years due to the Covid-19 pandemic between 2020 and 2022. In a govern-ment order (GO No.



5), which was seen by HT, principal secretary (panchayat raj) Sandeep Kumar Sultania directed district collectors to appoint special officers or persons-incharge or a committee of persons-in-charge from Friday to perform the functions of the gram panchayat. According to the order, the special officers or persons-incharge could be of the rank of a tehsildar, mandal parishad development officer, agriculture officer, mandal educational officer, mandal pan-

chayat officer or similar rank officers. These officers or committees will perform the functions of the gram panchayat till the assumption of new members and sarpanches, who are elected by the people. The special officers have also been directed to take charge immediately. Meanwhile, some of the sarpanches also moved the Telangana high court on Wednesday, seeking to stop appointment of special officers to administer gram panchayats, but did not

get any relief, people familiar with the matter said. Justice Kaja Sarath refused to extend their term till the elections were conducted to the gram panchayats. The sarpanches also contended that they had spent their personal money running into lakhs to take up developmental works in their gram panchayats, but the state had not reimbursed them.

The judge, however, issued notices to the state government and the State Election Commission, asking them to submit their views on conducting elections to gram panchayats and appointing special officers, said sources. The president of Telangana's ruling Rashtra Bharat Samithi, K T Rama Rao, said sarpanches were retiring from the post and not from public service.
