Turnout touches 64% in Phase 1 of Lok Sabha polls, against 66% in 2019

NEW DELHI: The first phase of polling for the 2024 general election covering the largest chunk of 102 Lok Sabha seats across 21 states and UTs - witnessed an encouraging turnout of 63.5% (as of 11pm), while remaining largely smooth and peaceful even in vulnerable areas like the Naxal-hit Bastar region and West Bengal. Violence was reported in Manipur which still managed a turnout of 70.8%. The overall turnout for these seats in 2019 was 66%, barring delimited seats in Assam and Outer Manipur, a few assembly segments of which went to the polls in the first phase this time.



almost all over the country and rain in J&K's Udhampur, people came out in large numbers despite talk of a low-key campaign. Sources said the turnout is expected to go up further, with long queues seen at many polling stations well after polling hours. As per rule, all voters who are queued up at the polling station when polling time ends are allowed to cast their vote. Election Commission worked hard over the past couple of years to make a smooth and turnout

election a reality. The first phase turnout is encouraging should enthuse voters to come out in even higher numbers in the remaining phases, a senior EC functionary told.

West Bengal, which has a history of poll violence and clashes between rival party workers, saw peaceful polling on Friday barring stray altercations in Cooch Behar. EC said none of these incidents has had any effect on threats.In Bastar conpolling, as evident from the 79.4% recorded peaceful Lok Sabha across the three parlia-

mentary constituencies of Alipurduars, Behar and Cooch Jalpaiguri. Tripura too incident-free saw polling with the voter touching turnout 81.5% and Sikkim logged 80%, while other states where turnouts soared beyond 70% included Manipur, Puducherry (78.3%), Meghalaya (74.5%) and Assam (73.4%).Udhampur saw polling of 67.9% despite rain and terror stituency Chhattisgarh, voters defied threats from Left-wing extremists.

Naxal-hit Bastar gives ballots the thumbs-up, records 64% turnout

RAIPUR: Over 64% of Bastar's 14 lakh electorate defied the Maoist threat and turned up to vote by 5pm in the first phase of the Lok Sabha polls on Friday. This figure is expected to rise.

This is being held in the backdrop of the most aggressive anti-Maoist operations in nearly two decades of insurgency. As many as 62 Maoists have been eliminated since the polling dates were declared on March 12, including 29 in a single encounter in Kanker on Tuesday.Never before have Maoists been hit so hard ahead of any election.Over 60,000 security personnel, nearly half of whom were central forces deployed from other states, stood guard as the Maoist-hit region gave a thumbs up to democracy. KOZHIKODE: In a sharp retort to Congress's Rahul Gandhi, Kerala CM Pinarayi Vijayan said he and other Left leaders cannot be intimidated by jail threat or probe by Central agencies. Rahul said in Kannur on Thursday that CMs of two states are now in jail, but Vijayan has not even been questioned by ED despite corruption charges. Speaking at an LDF election rally here on Friday, Vijayan said Rahul's "grandmother had jailed us for one-and-a-half years (during the Emergency) when she

reigned over the country". "Rahul Gandhi is worried why Kerala chief minister is not being interrogated or taken into custody and why no case is being registered. Rahul Gandhi... you had a name in the past. You should not create a situation that shows that you have not changed," Vijavan said.Left leaders are not like former Congress leader Ashok Chavan, who joined BJP after reportedly saying that they cannot go there (to jail), he added. "We are not ones who have not faced interrogation. It was your follower who had referred a fabricated case to CBI as part of political vendetta. It was later dismissed by the vigilance dept. The CBI had questioned and they too came to the same conclusion. You (Congress) were in power then. You check with those who were in govt then and you will know that we were not shaken on hearing about the probe. Don't try to intimidate us by talking about jail, probe or Central agencies," Vijayan said. 60% wheat purchased through doorstep collection: Official

Prayagraj: As part of efforts to ensure smooth procurement of wheat from farmers across the state this season, the state government has set up 293 wheat purchasing centres in Prayagraj district alone and deputed nine agencies for the task. For the benefit of the farmers, wheat is even being procured right at the doorsteps of the farmers through mobile procurement vans. As much as 60% of the procurement in Prayagraj has been through these vans, said Prayagraj's regional food marketing officer BC Gautam.

Ahead of the Lok Sabha elections, the UP government had increased the number of wheat procurement centres by 10% which added up to more than 6,400 across the state. The move is part of its efforts to achieve the procurement target of 60 lakh metric tonnes (MT) in the Rabi marketing season of 2024-25. Since the minimum support price (MSP) of wheat is Rs. 2,275 per quintal (100 kg), the payout to the state's farmers against the targeted purchase would be to the tune of around Rs. 13,650 crore.

"Registration of farmers is being done not just at the centre but even in different villages. This time, the state government has set a target of purchasing 3.54 lakh metric tonnes of wheat in the district whereas last time the target was to purchase 3.02 lakh metric tonnes. Since March till now, 6,526 metric tonnes of wheat have been purchased which is five times the purchase made in the same month last year," BC Gautam said.

To meet the set target, instructions have been issued to all purchasing centre in-charges and it is being continuously monitored, he added. This time the Yogi government has set the support price of wheat at Rs. 2,275 per quintal which is Rs. 150 more than last year. Last time the support price was Rs. 2,125. Instructions have also been issued that payments will be made to the Aadhaar linked bank accounts of farmers within 48 hours of the purchase. This year, exemption from verification has been given for the sale of up to 100 quintals of wheat. Now Rs. 20 per quintal weighing fee at the purchasing centres will also be returned to the farmers. As a result, along with Rs. 2,275 per quintal of wheat, the weighing amount is also being sent to the farmers' accounts, officials said. To solve any problem, the food and civil supplies department has issued toll free number 18001800150 through which farmers can contact the District Food Marketing Officer.

Walls in UP Govt schools to display stories of women achievers

Prayagraj: The walls of the state's government-run primary and upper primary schools will now tell the stories of prominent Indian women. According to senior state education department officials with knowledge of the development, the state government has ordered that one wall each of all 1.54 lakh schools across 75 districts be dedicated for this mission under Mission Shakti Phase-4 special campaign. The aim is to motivate students to emulate these personalities.

These women role models include Rani Lakshmi Bai, Chand Bibi SavitribaiJyotiraoPhule, Sarojini Naidu, Mother Teresa, LataMangeshkar, PT Usha and SainaNehwal among others.

Confirming the development, Praveen Kumar Tiwari, the Prayagraj district's basic shikshaadhikari (BSA), said he issued an order dated June 10, 2022 to all Prayagraj district block education officers (BEOs) requesting that this initiative be implemented on priority in all government primary and upper primary schools operating in their respective areas. "The information about the women's personalities will be provided by either painting a classroom wall or placing flex. The authorities have been instructed to post large and clear images of the female personalities as well as concise write-ups about them," he continued.

Ujjwala beneficiaries not able to get passbook and gas connection

Koraon Prayagraj: In the Ujjwala Gas scheme run by the Government of India, allegations of huge corruption by the gas agencies have been made through the beneficiaries. As some beneficiaries accused the Indian Gas Agency operating in Ayodhya village of Tehsil Koraon, they said that Ujjwala gas cylinder was given by their employees but its passbook was not given even after months

had passed. Beneficiaries also allege that when they are asked about the passbook, these days they avoid it by saying that they also use the vehicles of the said gas agency to charge less gas and more money for the cylinders being transported to the area. Now in such a situation, neither any action nor any investigation is taken by those responsible against such gas agencies.

Canals desilted by irrigation department on paper only?

though the central and the state governments declared loan waiver to small farmers, their condition is not likely to improve until focus is shifted on all other agricultural facilities including irrigation. Farmers are still dependent on rains for irrigating their crops as water is often not released in canals and minors by the concerned officials. This often results in destruction of crops and heavy loss to farmers. The condition of irrigational facilities is not too good in Allahabad district especially in trans-Yamuna areas where farm-

Hi-tech landing system at Prayagraj airport soon

Prayagraj: Poor visibility due to dense fog or rain that often hampers the safe landing of aircraft, will soon be a thing of the past as efforts are being made to install hi-tech landing system at the Prayagraj airport. A survey has been conducted to install CAT-III landing system at the Prayagraj airport akin to the ones already functional at New Delhi, Kolkata and Lucknow airports, said Prayagraj airport officials. The technical team of Directorate General of Civil Aviation (DGCA) explored the possibilities of installing this state-of-the-art technology at the airport three days back. DGCA wants to install CAT-III system at the airport before Mahakumbh-2025, so that during the mega religious fair taking place during winters, there is no problem of landing of aircraft due to dense fog, officials added.

CAT-III refers to an Instrument Landing System (ILS) allowing flights to land in adverse weather conditions like fog, snow, or rain despite poor visibility. The

Instrument Landing System (ILS) is a precise guidance system for aircraft during runway approaches. It employs two radio beams, offering both horizontal and vertical guidance to pilots while landing.

Having completed the survey, now the DGCA team will give its report on CAT-III technology implementation at Prayagraj airport and based on the team's report, permission will be sought from the Indian Air Force to install CAT-III system on the runway of the airport here.

Prayagraj Airport's officiating director Rajesh Kumar said that Mahakumbh-2025 will be organised in winters. There will be dense fog here at that time and in view of the mega religious fair, the movement of aircraft here will increase manifold. To ensure smooth landing of aircraft in dense fog, it is necessary to install CAT-III system. With the installation of this system, passenger aircraft will be able to land at the airport even in low visibility of mere 50 metres, he added.

Mandates prompt age determination report filing in POCSO cases

the Allahabad High Court has directed that in the cases of POCSO Act (Protection of Children from Sexual Offences Act) the police authorities/investigation officers must ensure that a medical report determining the victim's age is drawn up at the outset and the same is submitted to the court without any delay.

Directing for mandatory medical report, Justice Ajay Bhanot observed, "This court has been finding that in large number of cases the age of the victim set out in the prosecution case is often at variance with the age determined by the expert medical boards in accordance with the latest medical protocols. At times there are multiple contradictions in age related documents available with the prosecution. Numerous cases of false implication and abuse of POCSO Act have also been noticed. Runaway couples of young age are criminalized in the process.

In the instant case as in a large number of bail applications under the POCSO Act, issues relating to the age of the victims having serious consequences on the life and liberty of accused persons arise for consideration.

It was the case of the accused that the victim was wrongly shown as a minor of 16 years in the FIR only to falsely implicate the applicant under the stringent pro-

Prayagraj: Hearing a bail application, visions of the POCSO Act.

The Court noted that in the instant case, the medical examination to determine the victim's age was not conducted at the time of the applicant's arrest. Instead, the report was prepared later, revealing the victim's age to be 17 years old.

Against this backdrop, while granting bail to the accused, the court took note of several instances of multiple contradictions within age-related documents provided by the prosecution. The court further said that the discrepancies in the victim's age in POCSO cases can substantially affect the rights and liberties of the

"False depiction of a victim as a minor in POCSO Act cases is an abuse of the process of court." court added. In numerous cases, the age determined by the Medical Board contradicted the minority of the victim set up in the prosecution case. Justice Bhanot further observed, "This court is finding that in many instances the accused-applicants have argued that medical determination of the victim's age was not carried out deliberately as it would establish the majority of the victim and repudiate the prosecution case. By falsely depicting the victim as a minor accused persons are wrongly implicated under the stringent regime of the POCSO Act only to cause their indefinite imprisonment.

HC quashes court order refusing to issue NOC for passport renewal of dancer Sapna Choudhary

Prayagraj: The Allahabad High Court court. Her lawyer argued in court that if has cancelled the trial court order staying the no objection certificate (NOC) for the passport renewal of dancer Sapna Choudhary. The High Court directed the passport authorities to decide on the application made by Sapna Choudhary for renewal or re-issue of her passport and pass orders within a month.

The court said that the right to travel



abroad is part of a person's freedom. Saying this, the bench of Justice Shamim Ahmed quashed the order of the Additional Chief Judicial Magistrate Court refusing to issue a no-objection certificate for the issuance of a passport.

Dancer Sapna Chaudhary had approached the High Court challenging the order of the ACJM court in which her application to renew his passport was rejected because the court had no jurisdiction to allow passport renewal.

Sapna filed a petition in the High Court against the order of the ACJM she is acquitted in future, she may suffer a huge loss by not going abroad for his

It was also argued that such refusal violates the applicant's constitutional rights under Articles 19 and 21 of the Constitution of India. After considering the arguments made by counsel for the parties and perusing the record, the court held

that citizens are entitled to a passport under Article 19(1)(d) and Article 21 of the Constitution of India.

The court found that the ACJM Court ignored the notification and the Office Memorandum of the Ministry of External Affairs and quashed the order. Consequently, Choudhary was directed to make a fresh application along with a certified copy of the High Court order for renewal/re-issue of his

passport before the concerned Regional Passport Officer within 20 days from the date of this order. In turn, the concerned Regional Passport Officer/Authority was directed to pass the order for renewal/reissue of the passport of the applicant within one month after deciding on the application and completing appropriate formalities as per law. The court also directed Choudhary to inform and obtain permission from the concerned trial court before going abroad and to appear before the trial court on a date fixed as directed by the trial court.

Police officers, govt doctors to appear virtually in courts

Prayagraj: The Uttar Pradesh Prosecution Department is planning to introduce a new system wherein government officials, mostly policemen and doctors, will be able to record their statements virtually in pending court cases. This is being done to reduce the pendency of cases in the courts of Uttar Pradesh.

The state government is gearing up to build infrastructure in the districts to have a central, computerised system under which police officers and government doctors can go to the office of the Joint Director of the Prosecution Department and record their statements for speedy proceedings in the courts.

ADG (Prosecution), Dipesh Juneja, said, "There is a huge pendency of cases in the district courts. What happens is that police officers who work in the capacity of investigating officers and doctors in medicolegal cases have to routinely go to the district courts to record their statements. Such officials are regularly transferred

from one district to another across the state.

"Because of the geographic size of Uttar Pradesh, it becomes difficult for these officials to physically go to the district courts. For example, one officer who was posted in Western UP and investigated a case there gets transferred to Eastern UP. Now that officer has to take leave, and travel to the district where he was posted earlier.

"This results in the loss of manpower and also requires large amounts of funds for travel, lodging

etc. So we plan to have a centralised system where a police officer or a government doctor can go and virtually record their statements. This will help us ensure speedy trials in cases, and also, save money." The Prosecution Department plans to launch the initiative in five districts soon -- Lucknow, Prayagraj, Varanasi, Noida, Barabanki, and Varanasi.

"Once the system is operational in these five districts, we will extend it to the other districts as well. In the future, we hope the common people can also

remotely from these computerised offices," said Juneja.

Joint Director (Prosecution), Atul Kumar Ojha, said: "Once an officer retires, he or she is not willing to go to a different district to record evidence. To get allowances for the same is a lengthy process. This system will allow them to do it from wherever they are based after their retirement. We hope to reduce the pendency of cases with this new system."

Why China is blocking Dalai Lama's Sri Lanka visit

The Sri Lankans have been trying to have the Dalai Lama visit since January 2023

The—70 per cent plus Buddhist—Sinhala population of Sri Lanka fervently wants to welcome the 87-year-old Dalai Lama into their country at the earliest. A group of Sri Lankan Buddhist monks who met the Dalai Lama in Bodh Gaya in 2022 invited him to come. Dalai Lama is revered by his direct followers and other Buddhist sects as the 14th reincarnation of the Buddha, Avalokiteshvara. The current monk was anointed at the age of 15 in 1950, the very year the

Chinese took over Tibet. The Sri Lankans have been trying to have the Dalai Lama visit since January 2023. They are trying once more now as fresh efforts intensify on the open invitation from the various Buddhist monasteries. Many Sri Lankan Buddhists feel the Dalai Lama can help sort out the island nation's economic woes with his wisdom and blessings. Leading Sri Lankan Buddhist leader Waskaduwe Mahindawansa went on television to state that the Chinese had pressured the Sri Lankan government to prevent the visit. The Chinese, ever political and strategic, want the Sri Lankan Buddhists to team up with Gandharan Buddhists in Pakistan rather than the Indian-orders that are opposed to the Chinese. And certainly, they do not want the Dalai Lama to visit and be honoured. The impediment to a Sri Lankan visit comes every time by way of China. Beijing's debt restructuring will play a crucial role in obtaining further soft loans from the IMF. This has tied the hands of the Sri Lankan government. The Chinese still regard the elderly Dalai Lama as a dangerous separatist with massive influence, a living and highly popular symbol of resistance to the Chinese takeover of Tibet. One of the thorny problems stretching beyond the present incumbent is that the Buddhist monasteries in Tawang, Leh, and elsewhere in India do not agree that the Dalai Lama's successor can be chosen by the Chinese. The Buddhists everywhere are furious at the constant insults hurled by the Communist Chinese against the Dalai Lama, who do not recognise him as a spiritual leader at all, calling him a 'wolf' in monks robes. The internal facts in Tibet are quite damning. Since 1949, over 1.2 million Tibetans have been killed, over 6,000 monasteries destroyed, and thousands of Tibetans imprisoned. The Tibetans are being relocated to dense city enclaves in Lhasa; their smart phones are monitored; and the Mandarin language is being pushed in place of the Tibetan. With all this and 74 years of effort, including much infrastructure development and the relocation of ethnic Han Chinese to Lhasa, the Chinese are still not the masters of Tibetan hearts and minds. Similar problems of nonacceptance of unbridled repression plague the Communist CCP in Xinkiang, Hong Kong, against dissidence of any kind in the country, and of course, Taiwan. The Chinese authorities bristle at everything the Dalai Lama says and does, and are disturbed every time the Dalai Lama travels within India or internationally. Still, the Dalai Lama has been very successful at promoting the Tibetan cause. The Chinese don't like the fact that the Dalai Lama is completely free in India. They objected strongly to the Dalai Lama's visit to the Tawang Buddhist monastery and other parts of Arunachal Pradesh as a state guest in 2016. China, typically and audaciously, claims 90,000 sq km of the state, even today as 'South Tibet'. China is firmly, opposed to the Nobel, Laureate and international apostle of spiritual optimism. My real worry, however, is that this acrimonious political wrangling on Sanatana Dharma could reduce this great religion to a new level of fundamentalist illiteracy. And such a consequence goes far beyond the immediate political for-

Is it compiled in a single text, like the Bible or Koran, which cannot be transgressed by believers? Is it written in stone, to be interpreted by one Pope or Ayatollah? It is exceptionally significant that in its entire history, not a single Hindu has been burnt on the stake or killed for blasphemy, as is not uncommon in some other faiths. Hindu faith had not one but six systems of philosophy attempting to understand the truth behind the vast and bewildering plurality of the cosmos. Each of them had a different interpretation. But the Charvakas ostracised, or worse, beheaded for blasphemy. Instead, they enriched the dialogic debate within Hinduism and were countered in a civilised manner by those opposed to them. In the 8th century CE, Adi Shankaracharya, who is considered the 'reviver' of

fear: na mantro na teertham na veda na yajnah: neither mantras, nor pilgrimages, nor the Vedas or yajna (rituals), matter. What matters is: Chidananda roopam, Shivo hum, Shivo hum: bliss and awareness, I am Shiva, I am Shiva.In many religions, the declaration of equating oneself with God would be considered blasphemy. For instance, in Persia, a Sufi mystic, Al Hallaj (858-922 CE), almost contemporaneous with Shankaracharya, was put to death for having the temerity to say: 'Ana'l Haq: I am the Truth'. But not so in Sanatana Dharma.

The basic point is Sanatana Dharma is eternal for the grandeur of its philosophical vision, and not only for its religious practice; it is eternal for the diversity it allows for in thought, and not necessarily its rituals. Therefore, narrowing the interpretation of Sanatana Dharma to exclude all differences of opinion is distorting its greatness and, indeed, the very reason for survival. Unfortunately, this is precisely what we see happening today. Anybody and everybody is 'hurt' by anyone who does not blindly endorse everything that is deemed by the 'hurt' to be a part of Sanatana Dharma, including those ills that urgently need reform, such

On Sunday, April 14, Israel experienced a barrage of missiles launched from Iran, marking a notable escalation in tensions between the two nations. Although Iran and Israel do not engage in direct conflict, their rivalry is entangled within the broader power struggle between Iran and Saudi Arabia. Both Tehran and Riyadh vie for regional dominance, not just through geopolitical manoeuvring but also through religious leadership. Lebanese analyst

Patricia Karam posits that Iran perceives the Israel-Palestine conflict fied later that year as an opportunity to bolster its influence over Shiite groups in the Middle East. Iran aligns itself with the so-called "axis of resistance," comprising regional military proxies closely linked to Tehran. Man gets 3-week parole to arrange for fine amount

New Delhi: Delhi High Court has granted three weeks' parole to a man convicted under the NDPS Act on the ground of arranging funds for payment of fine in terms of the sentence awarded to him. "This court is of the considered opinion that since the parole apart from re-establishing social ties, is sought on the ground of arranging funds for payment of fine, there appear to be sufficient reasons for releasing the petitioner on parole," said Justice Anoop Kumar Mendiratta.

The single judge bench observed that there were sufficient reasons for releasing the convict on parole, subject to him furnishing a personal bond of Rs 25,000 to the satisfaction of the jail superintendent.

One Harish Yadav was convicted and sentenced to 10 years. Later, he was further sentenced to simple imprisonment of six months in default of payment of fine.

NEW DELHI: A govtappointed panel has recommended enactment of a new law -Digital Competition Act - to allow the Competition Commission to monitor large digital enterprises and intervene before instances of anti-competitive conduct transpire.

The move is meant to deal with entities such as Google, Facebook and Amazon that use data ("the defining feature of digital markets") and supplement the Competition Act. It will apply to a list of pre-defined "core digital services"

that are susceptible to concentration, the 10member panel headed by corporate affairs secretary Manoj Govil said.

When it comes to anti-competitive practices, mergers and acquisitions is to be kept out of the proposed law, while in case of nine others the draft legislation has worked out a principle-based framework, laying down the broad contours of each of them.

ITC's top shareholder BAT to sell 3.5% stake for \$2bn

KOLKATA: British American Tobacco, one of the world's largest tobacco products companies that is also the biggest shareholder in tobacco-to-FMCG major ITC, is selling about 3.5% stake in the Indian conglomerate, aiming to garner about Rs 16,800 crore (about \$2 billion).

London-headquartered BAT will sell nearly 44 crore shares of ITC at a price band of Rs 384-400 through block deals on Wednesday, the deal's term sheet showed.

At the lower end of the price band, the shares are priced at a 5% discount to the stock's Tuesday close on the BSE at Rs 404.

ITC's block deal will be one of the largest in India. The biggest block deal in India was executed in May 2020 when global pharma major

GSK had sold 5.7% in FMCG major HUL for about Rs 25,600 crore. BAT holds a little over 29% stake in ITC but it is not the promoter of the company. BAT's top management has been talking about monetising

part of its stake in ITC for three to four months, provided it could successfully navigate India's strict foreign holding rules in tobacco companies. BAT had indicated that it's holding in ITC would not fall below the strategically important 25% mark. "They (BAT) will continue to remain a major shareholder in ITC," a source told. Pakistan inflation slows to 23.1% yr/yr in Feb

KARACHI: Pakistan's consumer price index for February was up 23.1% from the same month last year, marking the slowest rate of annual inflation since June 2022, data from the Pakistan Bureau of Statistics showed on Friday.

The country has been struggling with soaring inflation, which last May hit an all-time high of 38% on an annual basis, partly driven by new taxation measures the government imposed to comply with International Monetary Fund demands. Islamabad's funding agreement with the IMF expires on April 11. On a month-on-month basis the February CPI was unchanged, having risen every month since the fiscal year began last July.Pakistan's finance ministry projected in a monthly report on Thursday that inflation would hover around 24.5%-25.5% in February, with expectations of further easing to 23.5%-24.5% in March as the crop situation and the supply of commodities improves. The annual CPI for January had clocked in at 28.3%. February's improvement on that was partly due to base effects.

In January, Pakistan's central bank held its benchmark interest rate at 22% for the fifth policy-setting meeting in a row and raised its fullyear inflation projections.

ESSEN: For most of this century, Germany racked up one economic success after another, dominating global markets for high-end products like luxury cars and industrial machinery, selling so much to the rest of the world that half the economy ran on exports. Jobs were plentiful, the government's financial coffers grew as other European countries drowned in debt, and books were written about what other countries could learn from Germany. No longer. Now, Germany is the world's worst-performing major developed economy, with both the International Monetary Fund and European Union expecting it to shrink this year.

It follows Russia's invasion of Ukraine and the loss of Moscow's cheap natural gas - an unprecedented shock to Germany's energyintensive industrie.

The governor of the State Bank of Pakistan said the rise in its average inflation forecast for the fiscal year ending in June to 23%-25%.

World Bank maps out plans to further boost lending by \$100 bln-plus over a decade



WASHINGTON: The World Bank on Thursday proposed steps that would boost its lending to developing countries by an additional \$100 billion over a decade as part of an ongoing reform process aimed at helping the bank expand its mission to include climate change.

In a 24-page report to the joint ministerial committee that oversees the bank and the International Monetary Fund, the bank's management said it would ask shareholders to approve a hybrid capital measure and a new portfolio guarantee platform. that together could boost lending by over \$100 billion.

That amount would come on top of measures already being implemented that will boost the bank's lending to developing countries by up to \$50 billion.


