Himachal: Rebel MLAs disqualified; breather Sukhu govt

SHIMLA: The Sukhvinder Singh Congress Sukhu-led govt in Himachal Pradesh lived to fight another day, getting its six dissident MLAs disqualified under antidefection law for crossvoting BJP to victory in Tuesday's Rajya Sabha poll, and deciding to set up a six-member coordination committee to bridge the divide between govt and party. The committee will include the CM and state Congress chief. Jolted by the prospect of BJP eroding its hold on one of only three states it governs, Congress' central leadership declared after the crisis appeared to dissipate that the party was united in HP and



the Sukhu govt would last its term. Speaker Kuldeep Singh Pathania said disqualification petitions were received by the assembly secretariat against six Congress MLAs for defying the party whip in the election to Himachal's lone Rajya Sabha seat.The speaker's 30-page ruling, among the fastest on disqualification MLAs, cites various HC and SC orders on invoking the anti-defection law. Those disqualified are Sudhir Sharma (Dharamshala),

Rajinder Rana (Sujanpur), Indradutt Lakhanpal (Barsar), Ravi Thakur (Lahaul-Chaitanya Spiti), Sharma (Gagret) and Devendra Bhutto (Kutlehar). Congress retains HP majority but remains vulnerable Congress's designated

NEW DELHI: Anxiety among sitting BJP MPs as well as those aspiring for tickets surged on Wednesday, the eve of the party's first central election committee meeting. Home minister Amit Shah and BJP president J P Nadda held marathon deliberations with leaders from over 14 states and UTs amid speculation that a substantial number of incumbents could be benched. Two-termers are considered to be particularly vulnerable, with the party keen to ward off the risk of 'local incumbency' hindering its plans to leverage PM Modi's popularity to score its biggest LS win. The number of state units called for deliberations has reinforced the indication that the leadership, taking up from where it left off in the latest state polls, may announce its first list soon. Party circles were abuzz that the list, likely to be announced a day after the CEC meeting in which Modi, other par-


No hike in fertiliser prices, says government, offers Rs 24,420 crore subsidy



NEW DELHI: Govt on Thursday said there will be no increase in fertiliser prices and they will continue to get key farm input at old rates during kharif (summer) sowing season, while announcing the Cabinet's approval of Rs 24,420 crore subsidy for phosphatic and potassic fertilisers. Cabinet also added three new grades of fertilisers to aid farmers and enhance productivity of oilseeds and pulses. "Despite rising prices of fertilisers in global market, we have decided to keep prices same as last season," said I&B minister Anurag Thakur.

The kharif sowing season runs from April to September. The decision for nutrient-based subsidy rates for 2024-25 kharif season came early this year considering the model code of conduct is likely to be in force till May-end. As per govt, subsidy on Nitrogen has been fixed at Rs 47 per kg, phosphatic at Rs 28.7 per kg, potassium at Rs 2.4 per kg & Sulphur at Rs 1.9 per kilo for kharif season. Subsidy on phosphatic fertilisers has been increased to Rs 28.7 per kg for kharif season from Rs 20.8 per kg in 2023 rabi season. Thakur said subsidy on di-ammonium phosphate will continue at Rs 4,500 per tonne. He added that DAP-based fertilisers will be available for Rs 1,350 per bag, while muriate of phosphate fertilisers will be available for Rs 1,670 a bag & for NPK for Rs 1,470 per bag. The minister said price per bag remains unchanged and there will be no additional financial burden on farmers.

Numbers of children with acute malnutrition down 12%

NEW DELHI: Women and child development minister Smriti Irani on Thursday highlighted the pivotal role of the 'Poshan Tracker' in informing govt and stakeholders in a better way about the nutritional status of children.

She said since the Poshan Tracker became operationalised the ministry found out that when anganwadi workers measure 75 million children every month as per WHO standards, the numbers of children with Severe Acute Malnutrition Moderate Acute Malnutrition came down by around 12% as compared to the data reported under the National Family Health Survey - 5.



"Handheld devices are now available to 1.2 million anganwadis across the country. Every month anganwadi didis measure 75 million children under the age of 6 as per WHO standards across the country," she added. "The National Family Health Survey has a sample size of

600,000 families on the basis of which we in the country are informed about the status of children with regards to children with Severe Acute Malnutrition and those with Moderate Malnutrition However,

out that when we measured 75 million children as per WHO standards the numbers for SAM and MAM came down by 12% which is a huge gain for the nutrition ecosystem in India," Irani added.

Flow of Ravi water to Pakistan fully stopped: Report

NEW DELHI: The flow of water from Ravi river to Pakistan has been completely halted with the completion of the Shahpur Kandi barrage, as per media reports.

Shahpur Kandi barrage is situated on the border of Punjab and Jammu and Kashmir.

This means that the Jammu and Kashmir region will now benefit from the 1,150 cusecs of water that was previously allocated to Pakistan. The water will be used for irrigation purposes, benefiting over 32,000 hectares of land in the Kathua and Samba districts.

The Shahpur Kandi barrage project, which is crucial for irrigation and hydropower generation, has faced numerous challenges over the past three decades. Prime Minister Narendra Modi accorded the highest priority to the Shahpur-Kandi dam project as it has the potential to irrigate thousands of acres of agricultural land in Jammu and Kashmir, Union minister Jitendra Singh said on Sunday. On September 8, 2018, Jammu and Kashmir and Punjab signed an agreement to resume work on the Shahpur-Kandi dam project, which had been hanging fire for the last 40 years.



According to reports, the Indus Water Treaty signed between India and Pakistan in 1960, India has exclusive rights over the waters of the Ravi, Sutlej, and Beas rivers, while Pakistan has control over the Indus, Jhelum, and Chenab rivers. The completion of the Shahpur Kandi barrage allows India to make maximum use of the Ravi river, ensuring that the water previously flowing towards Pakistan from the old Lakhanpur dam will now be utilized in Jammu and Kashmir and Punjab.

The foundation stone for the Shahpur Kandi Barrage Project was laid by former Prime Minister PV Narasimha Rao in 1995. However, the project faced several disputes between the governments of Jammu and Kashmir and Punjab, leading to its suspension for over four and a half

India has already constructed several storage works, including the Bhakra Dam on the Sutlej, Pong and Pandoh Dam on the Beas, and Thein (Ranjitsagar) on the Ravi. These projects, along with others like the Beas-Sutlej link and the Indira Gandhi Nahar Project, have allowed India to utilize nearly its entire share (95%) of the waters from the eastern rivers. However, approximately 2 million acrefeet of water from the Ravi river is still flowing unutilized to Pakistan below Madhopur. With the completion of the Shahpur Kandi barrage, India can now harness the water resources from the Ravi river for its own benefit, contributing to agricultural and economic growth in Jammu and Kashmir and Punjab.

Two arrested in UP and Bihar linked to 2,700 complaints

GURGAON: frauds get reported every day. Work from home jobs that offer payments in return for simple tasks such as liking social media posts and videos before dropping the big bait make an investment and get a higher return. And then, the money and 'employers' vanish.Two such 'employers', operating from Prayagraj in UP and Gopalgunj in Bihar, were arrested earlier this month by a

Gurgaon police team. The two have now been linked to 2,700 cyber fraud complaints filed in different states - the most in UP (683), followed by Rajasthan (262) and Telangana (213). They allegedly cheated 112 others in Haryana. Of these complaints, 142 were made into FIRs and the two cheated online users of Rs 10.3 crore.Police are able to

Two-child norm for govt jobs in Rajasthan gets **Supreme Court nod**



DELHI: More than 21 years after upholding validity of the mandatory 'twochild norm' eligibility criteria for candidates contesting panchayat polls, the Supreme Court has now put its stamp of approval on an identical norm for public employment, debarring candidates who have more than two children from seeking govt jobs.

A bench of Justices Surya Kant, Diapankar and K V Vishwanathan missed the appeal filed by ex-serviceman Ram Lal Jat, who had retired from service in 2017 and had applied for a constable's post in Rajasthan Police on

May 25, 2018. His candidature was rejected as Rule 24(4) of Rajasthan Police Subordinate Service Rules, 1989 that followed the norm set under the Rajasthan Service Various (Amendment) Rules, 2001, which provides that "no candidate shall be eligible for appointment to the job who has more than two children on or after June 1, 2002." He had unsuccessfully challenged the rejection of his candidature for constable post in Rajasthan high court, which in Oct 2022 had ruled that the fixation of norms squarely fell

in the realm of policy, which could not be interfered with by the court. The Justice Kant-led bench said, "A somewhat similar provision, which was introduced as an eligibility condition to contest panchayat elections, has been upheld by the SC in the case Javed and others vs. State of Haryana in 2003. This court held that the classification, which disqualifies candidates for having more than two living children, was non-discriminatory and intravires the Constitution, since the objective behind the provision was to promote family

India will become the third largest economy...

"In my third term, I promise that India will become the third largest economy in the world," the Prime Minister said in his recent speech to the Lok Sabha. This is "Modi ki guarantee," he added. In the last 10 years, India has jumped six places, from 11th largest in 2014 to fifth in 2024. The Prime Minister has now set a target of 2029 to make India the world's third largest economy. Latest calculations by the IMF suggest it could happen even earlier, likely by 2027. That would leave the Indian economy behind only China and the United States. Compare this to the target of 2043 set by the previous UPA government while presenting its final budget in 2014. But senior Congress leader P Chidambaram, who had presented that budget in 2014, was not impressed. "China's GDP is five and a half times more than our GDP," he reminded us. Now, Chidambaram's numbers are a bit off the mark. China's GDP is a little under five times our GDP, not five and a half times. But that is not the point. There is a huge gap between India and China. We must deal with this difficult fact. But how did it get this way? To begin with, here are two surprising facts. In 2004, India's economy was about 37 percent the size of China. By 2014, it was only 19 percent. In other words, during the UPA years, India's economic size relative to China was cut in half. Second, when you are shopping, whether online or otherwise, does it ever bother you that so much of our stuff seems to be made in China? But it was not always this way. Would you believe that in 2004, India actually used to run a trade surplus with China? It was a surplus of \$1.75 billion in 2004. By 2014, it had turned into a deficit of \$38 billion! So how did we become so dependent on China? Here is that story. In a surprise result, the Congress party came to power after the 2004 elections. At the time, the world was just entering a period of high growth. For decades, India had been an economic underperformer. But now, everyone was talking about the BRIC (Brazil, Russia, India and China). These four emerging powers were supposed to lead the world. Everything was going upwards: markets, business confidence, economic growth numbers. India on the way to becoming an economic superpower? The UPA government could hardly believe its luck. But the Chinese were only too happy to take advantage of the UPA's giddy feeling. In April 2005, Chinese premier Wen Jiabao visited India. By the 2004-05 financial year, India was already running a small trade deficit with China, about \$1.48 billion. The Chinese premier must have felt extra welcome in India, because the UPA needed the support of the Communist parties to stay in power. That is when the UPA agreed on its first "trade target" with China. At the time, India's trade with China was worth about a billion dollars a month, or roughly \$12 billion a year. The two countries agreed to raise this to at least \$20 billion over the next three years. But this "target" was achieved quickly. Too quickly, in fact. Chinese President Hu Jintao traveled to New Delhi in November of 2006. India promptly agreed to double the "trade target" to \$40 billion a year. There wasn't much of anything 'bilateral' about this trade. Indian markets were being flooded with Chinese

Almost unbelievably, the UPA government did not seem to notice at all. Prime Minister Dr. Manmohan Singh even boasted about it during his visit to China. "Our trade target of \$20 billion by 2008 was reached two years ahead of schedule. The revised target of \$40 billion by 2010 is also likely to be reached two years ahead of schedule," Dr. Singh told a summit of business leaders in Beijing in January 2008.

West's glaring double standards on terrorism

The latest example of nations adopting double standards emerged post a drone strike launched by the Islamic Resistance, a pro-Iran group based in Iraq, on a US base in Jordan, killing three US service personnel and wounding 40 more. In retaliation, US air force struck multiple targets in Iraq killing at least 16 civilians and wounding dozens more. The Iraqi government spokesperson responded by accusing the US of 'violating international law and lying about the circumstances surrounding its retaliatory strikes'. Subsequently another US drone strike killed the commander of the Iraqi militia group Kataib Hezbollah, who was an Iranian, on Iragi soil. Similar strikes also took place in Syria. Both Iraq and Syria objected to the US unilaterally conducting air strikes on their soil. In the UN Security Council, Russia and China accused the US of violating the territorial integrity of these nations. They also accused the US of escalating the ongoing conflicts. But the US was least concerned. This is not the first time that the US has conducted strikes in

Iraq is not an enemy of the US but an ally whose armed forces are being trained by them. Since when is unilaterally launching air strikes and killing scores of civilians as a counter to three soldier deaths by a militant group



legally justified, especially when the nation involved is an ally. The US ignored the criticism of Iraq and did not even bother to respond or address its concerns, treating it as a non-entity, solely because Baghdad lacks military power. At the same time, it continues to demand that India investigate who is behind the attempted assassination of a known anti-India terrorist, Gurpatwant Singh Pannun. Why double standards?

In the West, even joking about hijacking an aircraft or being a member of the Taliban is considered a crime. People are arrested and face jail terms. However, Pannun, who threatened to hijack Indian airlines flights is permitted to do so without even a whimper from the US and Canadian governments. If this is not adopting double standards, wonder what would be. Canada accused India of interfering in their elections. A declassified Canadian government docu-

ment stated, 'India engages in foreign interference activities.' On the accusation the Indian spokesperson mentioned, 'We strongly reject such baseless allegations of Indian interference in Canadian elections, it is not govt of India's policy to interfere in the democratic process of other countries, in fact, quite on the reverse it is Canada, which has been interfering in our internal affairs.' Earlier Justin Trudeau had claimed that India was behind the killing of Hardeep Singh Nijjar, a declared terrorist by India. India refuted the accusation and sought evidence, which New Delhi claims is yet to be received. On the subject of interference, during the height of the farmers' agitation in 2020-21, Trudeau had mentioned, "The situation (farmers protest) is concerning and we're all very worried. Let me remind you, Canada will always be there to defend the rights of peaceful

protest." When Amritpal

preacher, was arrested in March last year, Canada's foreign minister, Melanie Joly stated, "We are aware of the evolving situation in Punjab, and we are following it very closely. We look forward to a return to a more stable situation." Justin Trudeau stated, "We are looking forward to a swift return to a more stable situation." On Canada's truckers' agitation over which Ottawa applied illegal laws, India's only comments were, 'We have noted that the government of Canada has actually invoked the Emergency Act. Let us leave it at that on that issue.' When comments from leaders of both states are compared, it is evidently Ottawa which is commenting on India's internal affairs, rather than New Delhi, though it accuses India of interference in its internal affairs. Globally, India was criticised over its handling of the farmers' strike, which remained largely peaceful, while Ottawa was backed and supported when it applied emergency laws to forcibly quell the truckers' agitation. Why double standards? Post Tucker Carlson's recent interview of Vladimir Putin, the European Union began considering imposing sanctions on him.

A member of the European Parliament mentioned, "As Putin is a war criminal and the EU sanctions all who

Simultaneously, European nations have adversely commented on freedom of press in India. society and restrictions are a

cause for concern." After raids on the BBC offices for tax evasion, India came in for western criticism on grounds of curbing press freedom. Not a word was mentioned when the BBC acknowledged in June last year that it has been paying lower taxes in India. Another example of double standards. Globally, India is ranked 161 in the press freedom index while European nations, seeking to impose sanctions on Tucker Carlson just for an interview are considered far more liberal. Simultaneously, those who interview Zelenskyy are praised. What a paradox. When a Surat court sentenced Rahul Gandhi to two years in a defamation case in July last year, leading to his suspension from the Lok Sabha, there were negative comments from the west. NEW DELHI: The economy grew at its fastest pace in six quarters in the three months to Dec, led by robust manufacturing and construction sector growth. The strong growth has boosted govt's track record of handling the economy against the backdrop of global challenges ahead of general elections.Data released by National Statistical Office (NSO) showed the economy grew by a faster-than-expected 8.4% in Oct-Dec, higher than upwardly revised 8.1% in the previous quarter and above 4.3% in the third quarter of 2022-23. Now, NSO estimates 2023-24 GDP

growth at 7.6%, above earlier estimate of 7.3%, making India world's fastest-growing major economy.

Data released by the commerce and industry minon Thursday istry showed eight core sectors, spanning coal, crude oil, natural gas, refinery products, fertilisers, steel, cement and electricity, grew 3.6% in January, slower than 4.9% in the previous months and below recorded January last year. "Core



sector growth slid to a 15 month low of 3.6% in January 2024, with contractions emerging in refinery products and fertilisers, and a sub-1% rise in natural gas. Encouragingly, the other five components displayed a moderate-tohealthy expansion, rang-

ing from 5.2% to 10.2% in January 2024," said Aditi Nayar, chief economist at ICRA. Separate data showed fiscal deficit at January-end was at Rs 11 lakh crore or 63.6% of the revised annual estimates, narrower than 67.8% in the corresponding period.

SoftBank cuts stake in Paytm

MUMBAI: SoftBank has cut another 2.1% stake in Paytm, reducing its shareholding in the fintech firm to 2.8%, the company said in a recent stock exchange filing. The Japanese investment behemoth which bets heavily on tech firms had invested over \$1 billion into Paytm and held about



18% stake in the Noidabased company at the time of its initial public

offering in 2021. Even as SoftBank has been offloading its stake in the firm, the developments come at a time when Paytm Payments Bank has come under regulatory scrutiny due to persistent non-compliance. Paytm founder and CEO Vijay Shekhar Sharma is the largest shareholder.

Government releases 2 tranches of tax devolution

With this release, states have received total of three installments of tax devolution in February, according to the finance ministry.

Uttar Pradesh will receive Rs 25,495 crore, followed hy Bihar which will get Rs 14,295 crore. Madhya Pradesh will receiver Rs 11157 crore and West Bengal Rs 10.692 crore. The release of the tex devolution comes ahead of the national elections likely to be held in April-May.

MUMBAI: Most brokerage houses are positive on the deal that Reliance Industries and Walt Disney struck on Wednesday to merge their media operations in India. The Disney India-Viacom18 joint venture, with near-monopoly in cricket broadcasting rights in India, is expected to push up advertisement rates and turn the broadcasting industry highly competitive, especially for smaller players. Analysts from various broking houses estimated that the merger would be value accretive to RIL's stock price - it is expected to add between Rs 35 and Rs 45 per share. Government clears 3 semiconductor manufacturing projects worth Rs 1.3 lakh crore

NEW DELHI:

Government Thursday cleared proposals for three semiconductor manufacturing units worth Rs 1.3 lakh crore, including the country's first fab manufacturing plant by Tata Group and Taiwanese Powerchip Semiconductor

Corp Manufacturing (PSMC) in Gujarat.

This will be a big push to India's electronics manufacturing set-up as the chips will be made within the country for the first time.

The Cabinet nod, which also includes a project involving Japanese Renesas Electronics, follows Rs 22,000 crore testing and packaging unit project of US company Micron, that was approved in June last year (production



expected to happen by close of this year). Untitled design (94) "India has taken a giant leap today in gaining a foothold in the coveted manufacturing eco-system. With these units, semiconductor manufacturing and its ecosystem will get established in India," communications minister Ashwini Vaishnaw said.Tata Electronics will set up a Rs 91,000 crore semiconductor fab project with PSMC at Dholera in Gujarat. The Minister of state for IT & plant will have a capacity to produce 50,000 electronics

wafers per month. PSMC is renowned for its expertise in logic and memory foundry segments.Tata Electronics said it is proud to lead India's entry into global semiconductor fabrication, and said construction for the project will begin this year. "This will also accelerate our progress towards providing high-technology employment opportunities for the youth," Randhir Thakur, CEO and MD of Tata Electronics, said.

Chandrasekhar said a slew of new proposals are in the pipeline and added that govt expects a total investment outlook of nearly Rs 2.2 lakh crore.Cabinet has also approved semiconductor unit of Tata Semiconductor Assembly and Test (TSAT) in Assam at an investment of Rs 27,000 crore. Renesas Electronics

Thailand's Microelectronics's project in Sanand in Gujarat at an investment of Rs 7,600 crore has also got green signal. Govt is close to approving a Rs 90,000 crore proposal of Israel's chipmaker Tower Semiconductors. Vaishnaw said all the units will create nearly 26,000 direct jobs and another one lakh indirect ones.

Drop in share of imported coal in consumption saves Rs 82 k crore forex outgo

NEW DELHI: The share of imported coal in overall consumption in the country has come down to 19.3% in the April-December period of the financial year ending March 31 from 21% in the previous corresponding period, translating into Rs 82,264 crore worth of forex savings, the coal ministry said on Thursday. The decline in the consumption of imported coal is a result of rising domestic production on the back of a concerted government push garnished with a slew of reforms to clean up the system and incentives announced since 2014.

The steady rise in coal production and improved availability has seen the CAGR (compounded annual growth rate) of imported coal consumption plummeting to about -2.7% between 2014 and 2024 from 13.7%.

UP will soon be the first state to have fire stations at tehsil level in the country: CM

Lucknow, Chief Minister Yogi Adityanath, Thursday, said that Uttar Pradesh has seen setting up of 73 fire stations in the last seven years and is well on the way to become the first state in the country to have a fire station at the tehsil

soon.Inaugurating/layi ng foundation stone of 38 fire stations virtually from his residence, CM Yogi said: "The UP Fire and **Emergency Services** was established in the state in the year 1944. However, until 2017, only 288 fire stations were established in the state, while in the last 7 years, 71 new fire stations have been set up. Today, we are moving ahead to become the first state in the country to have fire station at the tehsil level."The Chief Minister also flagged off 35 fire fighting vehicles on the occasion. He remarked: "We have advanced the program of exten-



sive reforms in law enforcement. As a result, rapid modernisation is taking place in fire services in view of its importance in dealing with emergencies. So far, we have allocated approximately Rs 1400 crore for the strengthening of departmental services."Chief Minister Yogi Adityanath highlighted the significant strides taken towards modernization of the department over the past seven years, including the prompt deployment of officials. These efforts have yielded visible

results, he stated, pointing out that previously, complaints about the complexity of the NOC process were frequent. "We implemented various changes to streamline it, leading to a substantial enhancement in Uttar Pradesh's ease of doing business ranking in recent years", he added.CM Yogi emphasized the need to prioritize reducing response times for fire tenders to mitigate loss of life property. "Significant enhancements have been made in this area.

When Apple wanted to buy Elon Musk's Tesla

For now, Apple has given up on making cars. But, once the iPhone maker thought about buying Tesla some years ago, which could have changed the course of its Project Titan.

The New York Times report shares new details about Project Titan. Citing two people who worked on the project for the past decade, the Times reported that Apple had discussions with Elon Musk about purchasing Tesla but ultimately decided to build its car rather than integrating another business. It's not the first time rumours have surfaced about Apple buying Tesla. In December 2020, Elon Musk himself confirmed that he had talked to Tim Cook about the possibility of Apple acquiring Tesla during the "darkest days" of the Model 3 development. According to Musk, Cook declined the meeting. Six months later, the Wall Street Journal reported that Cook had proposed the idea of Apple acquiring Tesla around the same time. Musk was interested, but on one condition: he would serve as CEO of Apple, not Tesla. The Project Titan, started a decade ago, aimed to create a self-driving car or an electric car similar to Tesla. To have its car on the roads, Apple hired several individuals from car companies and invested billions of dollars, but the company failed to meet the deadlines it set for itself and eventually abandoned the plan to create its car. So, at the end of the day, Apple and Tesla didn't make a deal. Tesla is the top electric car company today, and Apple could have combined it to gain electric car know-how. However, buying Tesla would have been too risky and expensive for Apple, even though it would have been a shortcut into the car business.

Leopard numbers rise 8% in four years

NEW DELHI: India's leopard population has increased by 1,022 (nearly 8%) in four years from 12,852 in 2018 to 13,874 in 2022. The latest assessment report released on Thursday however shows that the number has declined in certain states, like Chhattisgarh, Uttarakhand, Kerala, Odisha and Telangana, reports Vishwa Mohan. The actual number may be a bit higher as the estimates represent just around 70% of the leopard habitat as the Himalayas and semi-arid parts of the country were not sampled. This fifth such assessment cycle conducted a foot survey spanning 6,41,449 km to estimate carnivore signs and prey abundance. Camera traps were strategically



placed at 32,803 locations, resulting in a total of 4,70,81,881 photographs that captured 85,488 photos of leopards. Calling rise in leopard pop-

ulation "great news", PM on X said, "This significant increase in leopard numbers is a testament to India's unwavering dedication to biodiversity."

Fire kills 43 in Bangladesh capital Dhaka

NEW DELHI: A devastating fire broke out in a seven-storey building in an upscale area of Dhaka, the capital of Bangladesh, Thursday night, resulting in the death of at least 43 people.

The fire originated in a popular biriyani restaurant on Bailey Road at around 9:50 pm local time and quickly spread to the upper floors, trapping numerous people. Fire department official Mohammad Shihab stated that firefighters managed to bring the blaze under control within two hours.
