By entering a futures contract to sell US dollars at a predetermined rate, the exporter locks in a viable exchange rate.

The market for exchange-traded currency derivatives has been thriving for a decade because of positions taken by investors with a view on the currency. However, RBI said that its recent circular only reiterates its existing position. "The regulatory framework for exchange-traded currency derivatives has remained consistent over the years, and there is no change in RBI's policy approach," it said. The circular, issued on Jan 5, retained most of the earlier regulations, including a requirement that trades over \$100 million would require proof of exposure. This requirement of proof for higher value trades was being interpreted by participants to mean that those who did not have any exposure could participate in lower value transactions.

Gunfight resumes in Kishtwar, J&K

JAMMU: A gunfight broke out between security forces and terrorists near Danna Dhar forest of Chatroo in the upper reaches of Kishtwar district in Jammu division of J&K Sunday evening, following а brief exchange of fire that took place in the same area about 23 hours earlier.

A police spokesman said firing resumed after security forces spotted the terrorists hiding in the deep forest. No casualty was reported so far. On Saturday, the forces had engaged with a group of at least twothree suspected Pakistani terrorists in Chatroo.

The area has seen heightened security ops in recent days. On Sept 13, two soldiers were killed and as many wounded in a gunfight.

Why Celebrities Are **Seeking Legal Protection** For Their Personality Rights

The Delhi High Court recently issued an order safeguarding the personality and publicity rights of film actor Jackie Shroff, restraining several social media accounts. AI Chatbots. and e-commerce websites from exploiting the actor's name, voice, or image for commercial purposes without his consent. Shroff petitioned the court against the unauthorised use of his name and persona, seeking protection against various individuals and entities utilising and misusing his identity without permission. The proliferation of Al-generated deepfake videos has exacerbated concerns for celebrities. Jackie Shroff's isn't the first instance of a film star resorting to legal action to protect their personality rights. Over the past two years, the Delhi High Court has issued interim orders to prevent the unauthorised use of Amitabh Bachchan and Anil Kapoor's name, image, and voice. The question arises: why are some celebrities turning to courts for the protection of their personality rights, while others refrain? "Where there is demonstrable misuse, people are approaching. Personality right is a facet of publicity right," says advocate Ameet Naik, who has represented Bachchan, Kapoor and now Shroff in their respective personality rights suits. In India, laws regarding personality rights are still evolving, with courts deriving principles from Article 19(1)(a) (freedom of speech and expression), Article 21 (protection of life and personal liberty), and intellectual property rights laws. "A few celebrities may choose not to pursue legal action due to various reasons such as the perceived insignificance of unauthorised use, the costs involved in litigation, or a desire to avoid negative publicity," says Shoeb Masodi, Partner, M&P IP PROTECTORS. Personality rights, as the name implies, pertain to the rights associated with the personality of a well-known individual, primarily applicable to celebrities whose names, images or voices are prone to misuse for profit. The concept dictates that only the owner or creator of these attributes has the right to derive monetary benefits from them. Personality rights have gained importance alongside the right to privacy given the kind of fame celebrities enjoy today. In 1995, the Supreme Court recognised a person's right to control the commercial use of one's identity in the R Rajagopal vs. State of Tamil Nadu case, commonly known as the Auto Shankar case. In 2015, the Madras High Court intervened to protect actor Rajinikanth's personality rights, halting the release of the movie Main Hoon Raiinikanth. The filmmakers had utilised the actor's name and style without his express permission, with the title itself serving as a clear indication of its connection to Rajinikanth. In yet another case involving actor Amitabh Bachchan, the Delhi High Court in November 2022 restrained the use of the actor's name, image, voice, or any of his characteristics without his consent. It is crucial to note that in intellectual property right cases, it's often impractical to name all infringing parties, leading affected parties to seek blanket injunctions or ban orders, known as 'John Doe' orders. Originating from the UK, John Doe orders are passed by a court against unknown defendants and the world at large. In September 2023, the Delhi High Court ruled in favour of actor Anil Kapoor in a case filed by him to protect his image and personality from misuse by third parties. Kapoor had petitioned the court, stating that several parties were using aspects of his personality. including popular terms

'A balancing act': How global media reported PM Modi's Ukraine visit

During his visit to Kyiv, PM Modi extended India's support to the war-struck nation in a meeting with Ukraine's Volodymyr Zelenskyy. But how did the media react to his trip? Prime Minister Narendra Modi with Ukrainian President Volodymyr Zelenskyy in Kyiv on Friday. AP

Prime Minister Narendra Modi made history with his groundbreaking visit to Ukraine, becoming the first Indian PM to set foot in the country since diplomatic ties were established in 1992.

During his visit to Kyiv, Modi met with Ukrainian President Volodymyr Zelenskyy, shared a warm embrace and held a moment of silence at a memorial dedicated to children who lost their lives in the ongoing Russian invasion.

PM Modi also extended India's support, offering to help bring peace to the war-struck nation and positioning himself as a "friend" to Ukraine, igniting hope among many who see India as a potential mediator in the conflict between the two nations.

This visit, which came just months after Modi's trip to Moscow, has attracted considerable global media attention, with many reflecting on its potential implications for the conflict and India's foreign policy. From being labelled as a 'balancing act' to being called a 'symbolic gesture,' here's how international media reported on PM Modi's visit to



Ukraine. The agency reported that PM Modi's Ukraine visit comes at a "volatile juncture" in the war launched by Russia in February 2022, where Moscow is making slow gains in eastern Ukraine as Kyiv presses a cross-border incursion. It also reported the Ukraine visit had optics that "closely resembled" Modi's visit to Moscow last month where he called for peace and embraced Russian President Vladimir Putin.

Reuters that Modi's Ukraine visit was significant because New Delhi "really has a certain influence" over Moscow and it was "extremely important" to build relations with such countries to "explain...what the correct end to the war is and that it is also in their interests." The New York Times

The outlet said, "Modi has carefully calibrated his country's relations with the two warring nations." It quoted Harsh V. Pant, a professor of international relations at King's College London as saying that Modi's Kyiv visit was "about positioning India as a voice of the global south" on the war in Ukraine. Pant further told the NYT that Modi's trip created a chance "to talk about, in some ways, the impact this conflict has had" on poorer nations.

The American news agency said the visit to Ukraine could be an "attempt by Modi to strike a more neutral stance after what has been seen as his lean toward Russia". A Ukrainian analyst told AP that the outcome of Modi's first visit is likely to be modest, as this is just "the beginning of a complex dialogue between India, Ukraine, and Europe." "Establishing relations with India will be challenging and a long process," said Yurii Bohdanov on his Telegram channel. But stressed the importance of this relationship for Ukraine. Bohdanov

also noted that if India supports Ukraine's peace efforts, it could strengthen Kviv's influence in the "Global South," where India competes with China for influence. He added that this support could "increase pressure on Russia." Modi's visit to Ukraine is more about signalling the world that "while India will continue to have strong relations with Russia, it will still work closely with the West," the British media outlet wrote in a report titled, 'Diplomatic tightrope for Modi as he visits Kyiv after Moscow'. It also quoted Michael Kugelman, director of the South Asia Institute at the Wilson Centre think-tank in Washington, who said the trip will further reassert India's strategic autonomy.

However, the outlet pointed out that "behind the language, the fact remains that India has never condemned Russia's full-scale invasion" and has, in fact, "been helping to power Moscow's war economy" by buying Russian oil, even as Western sanctions have intensified.

The Chinese media outlet was rather critical of PM Modi's Ukraine visit labelling it as a "symbolic gesture...unlikely to significantly advance peace talks". The report titled 'Modi's Kyiv visit 'a symbolic gesture' for peace talk' said that the visit is framed as "an effort to balance its relations between the US and Russia", particularly.

Trademark dispute over tiffin box reaches Delhi HC: Cello CEO summoned

New Delhi: Shree Metals Vallabh in October 2023 had secured an injunction from Delhi HC against use of MAX FRESH trademark by Cello Industrial Plastic Works.A dispute over a trademark related to tiffin boxes has reached the Delhi High Court. Two leading manufac-turers of tiffin boxes and other utensils, Shree Vallabh Metals and Cello Plastic Industrial Works, have locked horns over the 'MAX FRESH' trademark.

Hearing the plea of Shree Vallabh Metals, recently, the Delhi HC has summoned the COO of Cello Household Private Limited to be present before the court on the next date of hearing."It is directed that Mukesh Kothari, Chief Operating Officer (COO) of Cello Household Private Limited, shall be present before the court on the next date of hearing,"

Justice Sanjeev Narula ordered.Justice Narula directed Cello Plastic Industrial Works to file an affidavit, giving full disclosure of the goods manufactured from 21 October, 2023 till the

date of hearing, along with GST returns thereof.The HC order came while hearing the petition filed by Shree Vallabh Metals over selling of products under "CELLO MAXFRESH" brand by Cello Plastic Industrial Works infringing the registered trademark.Cello Plastic Industrial Works was asked to submit the details of the current stock of "CELLO MAXFRESH" products available with the company in an affidavit.Shree Vallabh Metals, a leading manufacturer of home utensils adopted a trademark 'MAX FRESH' in 2010 and obtained registration for the same from the office of the Registrar of Trademarks.Vallabh Metals, a leading Mumbai-based manufacturer and exporter, has been selling its tiffin boxes and other home utensils under the trademark MAX FRESH. company also The exports its household utensils, including tiffin boxes, to countries like United Arab the Emirates and Saudi Arabia. The company's exports under MAX FRESH trademark stands

at more than Rs 50 crore.The grievance of the Vallabh Metal was that the Cello Group, who claims a right over

the word CELLO for utensils and other products, also adopted the trademark MAX FRESH for its range of products in 2015. Cello Group also filed an application for the trademark MAX FRESH but did not acquire registration.

Vallabh Metals moved the Delhi High Court against the trademark infringement. October 2023, the HC granted an injunction against CELLO on further manufacturing of products under trademark MAX FRESH with immediate effect.The HC had granted time till 31.03.2024 to the Cello Group to exhaust the existing stock. In the month of April-May, 2024, Vallabh Metals purchased tiffin boxes from e-commerce platform and found that the products were manufactured

in November 2023 and March 2024. Vallabh Metals had filed a contempt application before the Delhi HC for violation of the October 2023 order.





Legal Procedure to Report **Online Cheating and Fraud:** Amit Manchanda

Delhi: With the rise of technology and internet use, cvbercrime has become one of the most common crimes. WFH culture has caused a tremendous increase in these situations in our country. Therefore, this article discusses the laws and procedures for reporting this offense. The Ministry of Home Affairs/National Cyber Crime Reporting Portal defined cyber crime as "Any unlawful act where a computer or a communication device or a computer network is utilised to commit or facilitate the commission of crime".Different cyber crimes exist today. When investigating internet cheating and fraud, many offenders use viruses, trojans, and worms. Online auctions and job offers let crooks commit financial and money laundering crimes. Phishing involves stealing credit card and password information from victims via fake websites. The 2000 Information Technology (IT) Act, revised in 2008, governs most cyber crimes. The Indian Penal Code, 1860, also addresses the crime, which can be confusing. Hacking and data theft are covered by Sections 43 and 66 of the Information Technology Act and Sections 378 (Theft), 424 (Dishonest and fraudulent concealment), and 425 (Mischief) of the Indian Penal Code. Identity theft protection and online cheating are covered by Sections 66C and 66D of the Information Technology Act, 2008. The court also upheld interception under Section 69A and Section 79, which govern intermediary liability. This ruling reiterated that any law, virtual or real, must comply with the Indian Constitution. The 2002 Anti Money Laundering Act also addresses cybercrime in several Indian sectors. This Act aimed to seize money-laundering-related property. Since the Information Technology Act, banks must keep electronic records properly. Bank e-Records Maintenance Policies are a model.

Delhi: PWD officials claimed the railway underpass at Pul Prahladpur in southeast Delhi, which was famed for flooding every monsoon until a year ago, had been removed from waterlogging the hotspot list. Over time, the wet underpass became notorious for drownings. Every monsoon, it would be closed to traffic, causing delays. A senior PWD official said waterlogging has afflicted the site for 20-25 years, but it worsened in the last 10-15 years. He blamed the worsening condition on a Delhi Jal Board sewage pumping plant in Khanpur. Drain sewage over-

flowed onto highways during monsoons, causing waterlogging. 

As Karnataka exploits SC/ST cash for "guarantees," BJP, Congress object



Delhi: The Karnataka government's intention to use SCPTSP funding for the five guarantee projects announced before the 2023 assembly elections is expected to cause a stir. Congress' ally Dalit Sangharsh Samiti (DSS) will protest while BJP appeals to the judiciary. Senior government sources said "diversion" of SCPTSP funds is not new and has been done by past governments, but BJP's court case and DSS' "uprising" threat could hurt Congress in upcoming zilla and taluk panchayat elections. Last week, CM Siddaramaiah said his government has allocated Rs 39,121 crore for SCPTSP, Rs 3,900 crore more than in the previous year due to a rise in budget size and a decision to allocate 24.1% of the budget to SC and ST communities. However, using Rs 14,283 crore of the budget for the five guarantee schemes has caused political unrest. BJP calls it "misappropriation." "BJP is contemplating approaching the court since the decision to re-route SCPTSP funds meant exclusively for the welfare of these underprivileged communities is being misappropriated," said the MLC. "Redirecting funds by claiming they're being used on SC and ST communities implies that they're getting money while other communities get extra benefits. 

Beer sales during the heatwave generated significant excise department money, showing how extreme weather can affect consumer behaviour and local economies.



How first battle between Modi govt 3.0, INDIA bloc hits a flashpoint over NEET

New Delhi: With the Lok Sabha election results signalling a resurgent Opposition INDIA bloc, the raging row over alleged irregularities in the NEET-UG examination and the now-can-**UGC-NET** celled examination have become the first major issue of conflict between the new BJP-led NDA government and the Opposition alliance. This is set to make stormy the first session of the 18th Lok Sabha beginning June 24. The Congress-led Opposition has made its intent clear soon after the poll results — that it will not let the government rest, vowing that it would be a "fierce challenger" on issues of national importance. At a press conference in Delhi two davs ago. Congress leader Rahul Gandhi repeatedly attacked the government and Prime Minister Narendra Modi over their


Aundh-Baner residents grapple with inadequate garbage disposal problem and its consequences

Ill-equipped waste disposal systems, leading to garbage getting piled at various points, is a cause of worry for residents of Aundh, an area which is otherwise considered as one of Pune's most developed and progressive zones. Residents are concerned about the problems that could be caused by frequent dumping of trash at various spots in the Aundh-Baner areas, such as those between Jupiter Hospital and Nagras Road. "I know there are these agencies that dump garbage anywhere in Aundh; there are specific spots. There is no control at all," noted Subhabrata Sanyal, 51, a resident of Kumar Padmalay. He said the waste menace could also draw in more stray dogs, posing a threat to people going for morning and evening walks.

"When you walk onto the streets, you can see food littered all over, that attracts stray dogs. In case we go near the garbage by mistake, these animals could even attack us," observed Deepa Adiga, 47, a resident of Sylvan Heights. Residents blamed lack of a proper collection system by the municipality for the mounting garbage piles. "Sometimes the municipal truck may be arriving at a particular time and the waste is generated later, particularly by restaurants where the waste is generated very late at night, post 11 pm or midnight, after the restaurant is closed," said Anil Gokarn, founder of ProEarth Co., a company that deals with effective waste management.

No request yet from Nikhil Gupta for consular access: MEA

New Delhi: Indian authorities haven't received any request for consular access from Nikhil Gupta, the Indian national extradited to the US from the Czech Republic following allegations of his involvement in a foiled plot to assassi-Khalistani nate extremist Pannun. Gupta, who was arrested in the Czech Republic in June last year, was extradited to the US on June 14. "He was extradited to the US on June 14. We have so far not received any request for consular access from Gupta but his family has got in with us," touch Affairs External Ministry spokesperson Randhir Jaiswal said. "We are in touch with the family mem-



bers and are looking at the matter as to what can be done on their request," he said during his weekly media briefing while replying to a ques-tion. Gupta, 53, pleaded not guilty when he was produced in a court in New York on June 17. While Gupta was in custody of Czech authorities, Indian officials were given consular access to him on a few occasions. Last November, US federal prosecutors charged Gupta with working with an Indian government

employee in the foiled plot to kill Pannun in New York. Pannun, wanted in India on terror charges, holds dual of the US and Canada. The issue of consular access to Gupta would be decided in line with provi-

sions of the Vienna Convention on Consular of 1963, people familiar with the matter said. Article 36 of the Convention states that a detained person will have to make a request for consular access to authorities of his or her country. "Nevertheless, consular officers shall refrain from taking action on behalf of a national who is in prison, custody or detention if he expressly opposes such action," the article states.

that it has issued comprehensive guidelines on the proper application of the Pocso Act and the manner in which judges should compose their judgments. The SC had taken suo motu cognisance of validity of the HC

the order and had said on December 8 that judges were supposed to decide a case on the basis of law and facts, and should not resort to preaching in judicial proceedings. It had also questioned the

order acquitting the accused who was booked under the IPC and Pocso Act. The Calcutta high

court in 2023 had said, "Control sexual urge/urges as in the eyes of the society she is the looser when she gives in to enjoy the sexual pleasure of hardly two minutes."

The HC had made the observation while overturning a man's conviction under the Pocso Act.

The court determined that the relationship between the accused and the alleged victim was consensual in
