

'No excuse for violence...': White House on attacks against **Indian students in US**



NEW DELHI: In a press briefing or Thursday, the White House strongly denounced violence based on factors like race or gender, categorising such behaviors as unacceptable within the country. John Kirby, the Coordinator for Communications at the National Security Council, expressed the administration's dedication to preventing and thwarting such attacks. He underscored President Joe Biden and his team's concerted efforts to collaborate with state and local authorities in addressing the issue and ensuring accountability for those responsible. While responding to a question about recent attacks on Indian students and concerns among parents to send their children to the US, he said, "There's no excuse for violence, certainly based on race or gender or religion or any other factor. That's just unacceptable here in the United States and the President and his administration has been working very, very hard to make sure we're doing everything we can to work with state and local authorities to try to thwart and disrupt those kinds of attacks and make it clear to anybody who might consider them that they'll be held properly accountable." The statement comes in the wake of a sudden surge in attacks and fatalities involving individuals of Indian descent in the United States. On February 7, a 41year-old man of Indian origin passed away in the United States, several days after sustaining life-threatening injuries in an assault in downtown

Ajit's group real NCP, so no MLAs disqualified: Speaker

MUMBAI: A little over a week after Election Commission's order granting NCP name and symbol to Ajit Pawar, Maharashtra assembly Speaker Rahul on endorsed it, recognizing the deputy CM as real head of the party as his group has a legislative majority with 41 MLAs on his side and 12 with party founder Sharad Pawar. In a verdict similar to the one in Shiv Sena MLAs' case, Speaker dismissed disqualifica-



tion pleas filed by the rival factions against each other's legislators, thus not disqualifying any MLA from faction. either Narwekar, in his order, criticised Sharad Pawar faction, saving it could not use the Tenth Schedule of the Constitution (or antidefection law) to stifle dissent.

BJP says electoral bonds brought in for transparency

NEW DELHI: Shortly after Supreme Court struck down electoral bonds as "unconstitutional", BJP on Thursday defended the scheme saying it was started with laudable objective of bringing in transparency in poll funding. The party, however, said it respects SC verdict. "The electoral bonds scheme was brought in for transparency in electoral funding and reduce inflow of cash during elections.Even donors want secrecy... This is not the only effort PM Modi has made to bring more transparency in the election process," senior BJP leader Ravi Shankar Prasad at a press conference. Prasad, however, said that party will give a detailed response after a comprehensive study of judgment which runs into

hundreds of pages. Taking



a swipe at opposition which had alleged that the bonds could work as bribes to BJP from corporate groups, he said parties whose "DNA is based on corruption bribery" should not level such charges. Amid claims that electoral bonds denied opposition parties a level-playing field in elections., former Union minister said it is for people to decide who are in the field and who are out of it. People have thrown some parties out of the field and they could not now win even one seat in regions which used to be their strongholds.

RBI, Nepal's central bank ink deal for UPI link

MUMBAI: Reserve Bank of India has signed an agreement with Nepal's central bank for integration of UPI with National Payment's interface of the Himalayan country. The agreement was inked in the presence of RBI governor Shaktikanta Das and his Nepali counterpart Maha Prasad Adhikari. The signing comes

Payment Corporation of India's international arm inked an agreement to facilitate the deployment of UPI in Nepal. The terms of reference of Thursday's agreement include putting systems in place for integration of fast payment systems of India and Nepal. The integration is aimed at facilitating cross-border remittances.

Introduced in 2018, electoral bond scheme allowed anonymous political funding



Delhi: Every registered party having secured at least 1% of the votes polled in a recent Lok Sabha or state election was allotted a verified account for the bonds The electoral bond (EB) scheme of political funding, which the Supreme Court on Thursday struck down, was introduced in 2018 and allowed the purchase of bonds at any State Bank of India (SBI) branch in multiples of 1,000, 10,000, 1 lakh, 10 lakh and 1 crore. They could be bought through a KYC-compliant account with no limit on the number of electoral bonds that a person or company could purchase. Every party registered under section 29A of the Representation of the People Act and having secured at least 1% of the votes polled in the most recent Lok Sabha or state election was allotted a verified account by the Election Commission of India (ECI) for the bonds. On October 16, the Supreme Court referred a clutch of petitions against the scheme to a Constitution bench of five judges. It started hearing the petitions, filed by Association for Democratic Reforms (ADR), non-profit Common Cause, Congress leader Jaya Thakur, and the CPI (M), among others, on October 31. The bench

heard the matter on

three consecutive days when it picked holes in the 2018 EB scheme. It flagged a spate of "flaws" while the government mooted two suggestions. First, the government said the court could consider substituting SBI with the Reserve Bank of India (RBI) as the statutory bank for issuing EBs and keeping accounts. Second, the court could criminalise any instance of breach confidentiality regarding donors.

The court remained of the tentative view that the EB scheme did not appear to augur well with the need for transparency when such donations could very well be kickbacks.

With this, BJP saw an increase of 17.12% as compared to the last financial year (2021-22) when it received 614.626 crore. The total declared by the national parties for FY 2022-23 was 850.438 crore from 12,167 donations. "The Indian National Congress (INC) stood second in comparison after it received 79.924 crore which is a decrease from the previous FY 2021-22 (-16.27%). Similarly, the decrease in donations declared by CPI(M) was 39.56% (3.978 crore), and by the Aam Aadmi Party (AAP) was 2.99% (

What are electoral bonds?

Electoral bonds are money instruments that act as promissory notes or bearer bonds that can be purchased by individuals or companies in India. The bonds are issued specifically for the contribution of funds to political parties. These bonds are issued by the State Bank of India (SBI) and are sold in multiples of 1,000, 10,000, 1 lakh, 10 lakh, and ?1 crore. The donations made under this scheme by corporate and even foreign entities enjoyed 100% tax exemption



while the identities of the donors are kept confidential - both by the bank as well as the recipient political parties. How are the donations

made? The bonds can be pur-

chased through a KYCcomplaint account to make donations to a political party. Once the money is transferred, the political parties will have to encash the donations within a given amount of time.

Notably, there is no limit on the number of electoral bonds that a person or company can pur-

via electoral bonds? According to the provisions of the scheme, only the political parties

registered under Section Representation of the People Act, 1951 and which secured not less than 1 per cent of the votes polled in the last elections to the Lok Sabha or a state legislative assembly are eligible to receive electoral

bonds. **Electoral bonds scheme** and the case The electoral bonds announced by former finance minister Arun Jaitley during the 2017 Budget Session. Later, it was notified in January 2018 as a source of political funding by way of money bills introducing amendments to the Finance Act and the Representation of the People Act.

In order to implement the scheme, the Centre carried out certain amendments to the Companies Act, Income Act Foreign Contribution Regulation Act (FCRA), and the Reserve Bank of India Act. However, several petitions were filed in the Supreme Court, including those filed by CPI(M), Congress, and some NGOs, against the constitutional validity of the electoral bonds scheme. The hearing into this matter began on October 31 last year. Several arguments were made by the petitioners on the scheme including its legality.

Man beaten to death over land dispute in Basti, 3 held

Basti: In a shocking incident, 67-year-old Ram Millan Choudhary was beaten to death while his son Vishal Chaudhary and his sister Mala Devi sustained severe injuries when half a dozen armed miscreants barged inside their house and attacked them. The incident took

place in village Gausi Pur Derwa under Kalwari police station of the district in Basti on Sunday. Deputy Inspector general (DIG) RK Bharadwaj along with Superintendent of Police (SP) Gopal Krishna visited the village and assured the affected family that the assailants

would be arrested soon. Police confirmed that heavy police force had been deployed in the village as serious resentment was brewing against assailants. Police have registered a case after a written complaint was filed by Mala Devi against five accused.

Traffic jams mostly on Delhi periphery, barricades stay

Delhi: Vehicular movement in the Capital, especially in central and south Delhi, was significantly better on Wednesday compared to the serpentine traffic jams throughout Tuesday, despite no changes in the deployment of security personnel and barricading.

While there were fewer traffic congestions within the city, some key stretches near Singhu and Tikri borders reported snarls during



evening peak hours. "The farmers were scheduled to reach Delhi on Tuesday. Although the protesting farmers were contained at the Punjab-Haryana borders, we received inputs that some political and non-political groups in small numbers may march to central Delhi. Accordingly, instructions were issued to put barricades at strategic locations in the city and intensify the checking of vehicles. The arrangements disrupted vehicular movement and caused bottleneck congestion on roads leading to the police pickets. As commuters used alternate routes to avoid traffic snarls, the volume of traffic increased on those roads as well," said a senior traffic police officer. On Wednesday, security arrangements remained in place at key borders like Singhu, Tikri and Ghazipur, as well as within the city limits. Why agriculture sector across the world needs to break socialist trap

Ironical as it may seem, across the world, reasons for farmer protests have less to do with farming, weather, or food and more with geopolitics. The recent spate of unrest in Europe, for example, can be traced to war, tariffs, currency, fuel costs, logistics, and regulatory wokeism. Similarly, even in post-green revolution India, agriculture sector woes are less about farming and more about political brinkmanship. Therefore, the solution to these woes may not just lie within the paradigm of the farm-to-food value chain but even outside.

The world produces more food than it can eat. The quantity of food an average human being can consume in a day across all five food categories is only 300 grams. Extrapolated to 8 billion humans, it translates to a food requirement of 875 million tonnes each year. Double that quantity to feed animals to account for non-vegetarians, and the world doesn't need more than 1,750 odd million tonnes of agricultural or farm produce of any kind each year. Correspondingly, we produce 800 million tonnes of wheat, 600 million tonnes of rice, 100 million tonnes of pulses, a whopping 1200 million tonnes of corn, and much more in cereal, food grains, and oilseeds. Modern inventions like home refrigerators, commercial cold storage, and advanced food processing have further widened the gap between production and consumption. Arithmetically, we live in a world of agricultural abundance, and that perhaps is at the root of all disgruntlements. Long ago, agriculture stopped being about subsistence and became a sector of the economy. As transaction commerce moved from barter to monetary, agricultural produce became a commodity, and then cash and farming transitioned from occupation to profession to commerce. To fuel that commerce, marketing curated needs beyond just satiating hunger. These needs transcended boundaries in a globalised world, and demand got internationalised. Kiwi Fruit from New Zealand in a New Delhi breakfast and Japanese Edamame in a Johannesburg bar were not a surprise, but so was the downside. When cassava replaces wheat in African meals, war in Ukraine can impact the Congolese wallets, and civil unrest in West Africa can make Choco Latte expensive at Starbucks. What, then, is the solution to the seemingly recurring woes of agriculture? More importantly, does the farm sector deserve a solution? The agrieconomy, after all, accounts for a mere 5 per cent of the 105 trillion global GDP. Development economics hints at an inverse relationship with agriculture. But this can be misleading and risks taking those involved in this important sector lightly. Western Europe is perhaps doing that and facing consequences since the sector accounts for a woeful 1.5 per cent of GDP. The fact is that agriculture is the most "real" sector of the economy compared to its sectoral peers. The services sector, for example, has a disproportionate gross value add and hence skews the sectoral ratio in its own favor. If the number of people gainfully employed were a measure of sectoral contribution and importance, then agriculture would rank at the top. Besides, agriculture is the deepest foundation of the economy, nay, humanity. So, nurturing the sector should be a policy priority. And this should be the central perspective before we start dealing with the sector. Contextually for India, a comparison with China offers perspective on why it is important to lock in a long-term strategy in dealing with agriculture since both countries feed roughly the

Election results further divide Pakistan, expose deep rot and fissures

Pakistan was already in a serious political, economic and social mess. The elections just held have deepened that mess. The functioning of all Pakistani institutions has been badly exposed and their credibility eroded further. Imran Khan defied the Pakistani military and has paid a price for that. The judiciary has pliantly played the game of the Pakistani military by sentencing Imran Khan to long periods of imprisonment for provoking violence against the army, leaking state secrets and profiting from sale of gifts he received as Prime Minister from foreign dignitaries. His wife too has been given a prison sentence for an un-Islamic marriage with Imran Khan. The Pakistani military is seen, and sees itself, as the saviour of last resort of Pakistan's survival as an ideological nation. The army, as known, has always exercised real power in Pakistan directly or indirectly. Imran Khan himself was put in power by the army as an alternative to the traditional political parties. Having fallen afoul of the army because he wanted to exercise his prime ministerial prerogative in military appointments, he was removed from power. The army then manoeuvred for Nawaz Sharif to return from London and replace Imran



Khan. The judiciary cooperated by lifting the life-long election ban on Nawaz Sharif because of his criminal conviction for dishonest practices because, it ruled, that life-bans "abridge the fundamental right of citizens to contest elections and vote for a candidate of their choice". The Election Commission of Pakistan decided to bar PTI — Imran Khan's party — from using its iconic cricket bat symbol to identify party candidates in the election on the grounds of irregularities in its internal party elections. The Pakistan Supreme Court upheld the decision of the Election Commission. Members of Imran Khan's party were election under their party's announcing results, the clos-

Nawaz Sharif has made an appeal to all parties to come together to put crisis-ridden Pakistan back on the rails, and negotiations are being conducted with PPP and others. General Asim Munir has backed Nawaz Sharif's call in stating that "Pakistan's diverse polity and pluralism will be best represented by a unified government of all democratic forces imbibed with national purpose". In all this, the military as an institution has also taken a hit. The limits of its ability to control the political process have been exposed. It is not the first time though that the military has received public rebuffs, but such is its core control of power and policy in the system that it recovers from setbacks. The fact that challenged openly and persistently by Imran Khan and General Munir's determination to crush him and the PTI, the former Prime Minister's youthful supporters have resisted and emerged as the largest group-as independents-in the election, shows that the military's role in Pakistani politics is being challenged. Some believe that this show of resistance to the military's

political manipulation is a good augury for Pakistan's democracy. But then, Pakistan's political structure, the role of the armed forces, the domination of Punjab in its polity, the radicalisation of its society, the country's ideological underpinnings, the limited base of its economy and the difficulties in revitalising it because of vested interests are issues that are deeply linked to the possible evolution of a more

democratic Pakistan. Leaving aside the hurdles to any genuine democracy in Pakistan that its military represents, the political leaders of Pakistan have vied for power in the country without any genuine democratic convictions. Imran Khan's vision of Pakistan is not that of a modern democracy but of an Islamic welfare state based on moral and ethical principles — a Riyasat-i-Madina — that would transform Pakistan. As for other leaders, those of PML-N and PPP, they have been in and out of power, in and out of jail, tainted by corruption. They have fought elections without seriously committing themselves to plant the roots of a stable democracy in Pakistan. Pakistan sees Turkey as a model to emulate, but Turkey itself has moved towards an Islamic state. So, what lesson is there for Pakistan in this?

Why a legal guarantee of MSP is fraught with challenges

On November 19, 2021, Prime Narendra announced the repeal of the three farm laws. Thus ended the thirteen-month long farmers' agitation on the borders of Delhi. It took the Government about nine months to take the next step on the promise made to agitating farmers' unions. It was only on July 12, 2022, that the Union Government set up an expert committee under the chairmanship of former Agriculture Secretary Sanjay Agarwal. The committee has 29 members of which four are Secretaries to the Government of India and four represent the states. However, Punjab, Haryana and Uttar Pradesh are not represented in the committee. Several economists experts had



opposed the farm laws but none of them was included in the committee. Due to the complexity of the issues involved it is not surprising that the committee has not been able to submit a report. Now that general elections are only about ten weeks away, it is unlikely that the committee will be able to submit even an interim report. The terms of reference of the committee do not specifically mention legal guarantee for MSP. Instead, it mandates the committee to give suggestions of the following issues relating to MSP: Suggestions to

make available MSP to farmers of the country by making the system more effective and

transparent. Suggestions on practicality to give more autonomy to the Commission for Agricultural Costs and Prices (CACP) and measures to make it more scientific. To strengthen Agricultural Marketing System as per the changing requirements of the country to ensure higher value to the farmers through remunerative prices of their produce by taking advantage of the domestic and export opportunities.




Germany overtakes Japan as third-biggest economy

TOKYO: Once forecast to become the world's biggest economy, Japan slipped below Germany last year to fourth place, official data showed Thursday, although India is projected to leapfrog both later this decade.

Despite growing 1.9 percent, Japan's nominal 2023 gross domestic product in dollar terms was \$4.2 trillion, government compared showed, with \$4.5 trillion for Germany, according to figures released there last month. The change in positions primarily reflects the sharp fall in the yen against the dollar, rather than the German economy -which contracted 0.3 percent in 2023 -- outperforming Japan, economists said.

The Japanese currency slumped by almost a fifth in 2022 and 2023 against the US currency, including around seven percent last year. This was in part because in an effort to boost prices the Bank of Japan has maintained negative interest rates, unlike other major central banks



which have raised borrowing costs to fight soaring inflation.

"The overtaking... in size in dollar terms owes a lot to the recent collapse in the yen. Japan's real GDP has actually outperformed Germany's since 2019," said Fitch Ratings economist Coulton. Brian Germany's heavily export-dependant manufacturers have been hit particularly hard by soaring energy prices in the wake of Russia's invasion of Ukraine. Europe's biggest economy has also been hampered by the European Central Bank raising interest rates in the eurozone as well as uncertainty over its budget and chronic shortages of skilled labour. Japan is also heavily reliant on

exports, in particular cars, although the weak yen -- making exports cheaper -- has helped big firms like Toyota offset weakness in key markets such as China.

But it is suffering more than Germany in terms of worker shortages as its population falls and birth rates remain low, and economists expect the gap between the two economies to widen. Thursday's data showed that Japan's economy shrank an adjusted 0.1 percent quarter-on-quarter in the last three months of 2023, missing market expectations of 0.2 percent growth.

Growth for the third quarter was revised downward to negative 0.8 percent, meaning that Japan was in technical.

RBI bars fintechs from issuing business credit cards on KYC worries

MUMBAI: RBI has asked payment networks Visa and Mastercard to stop facilitating business credit card issues by fintech aggregators, also known as business payment solution providers.

Business credit cards, unlike consumer credit cards, are issued to businesses. These are used to make vendor payments and act as a substitute for working capital for the companies.

Historically, banks have been issuing these cards to corporates. In recent years, fintechs have issued such cards, onboarding vendors to enable them to accept payments made on



RBI governor asks banks to remain alert to build-up of loan risks

MUMBAI: In the central bank's first meeting with bank chiefs since July 2023, RBI governor Shaktikanta Das on Wednesday raised the issue of outlier growth seen in personal loans segment and the exposure to NBFCs.

In Nov 2023, RBI had hiked risk weights on unsecured personal loans and lending to NBFCs to slow down bank credit to these segments, which have been seeing runaway growth.Das said that the domestic financial system was resilient, but there is no scope for any complacency, and banks should continue to maintain their vigil around the build-up of risks. The RBI governor, howevcomplimented bankers on their improved financial performance.

According to sources, RBI is also concerned about the quality of underwriting in loans, which are distributed through intermediaries, including digital players. Das noted the issues relating to business model viability. He also said that banks must ensure that they do not relax underwriting standards when disbursing loans through co-lending arrangements with NBFCs.

Bank credit for personal loans grew 23% year-on-year as of Dec 2023 to Rs 13.3 lakh crore. Total loans in the individual loan segment (including home, consumer and auto loans) rose 28.5% to Rs 51.7 lakh crore. Bank credit to NBFCs grew 15% yearon-year to Rs 15.2 lakh crore for the same period. The overall increase in bank credit year-onyear stood at 19.9%

While Mahindra's tractors and farm equipment sales form only about a third of total revenue, they are far more profitable than its auto business, which comprise close to twothirds of the topline and includes the sale of SUVs and commercial vehicles.

Many scientists who study the intersection of climate change, flooding, winter storms and sea level rise agree the kind of damage Levy experienced was more of a sign of things to come than an anomaly. month's storms that destroyed wharfs in Maine, eroded sand dunes in New Hampshire and flooded parts of New Jersey still coping with hurricane damage from years ago are becoming more the norm than the exception, and the time to prepare for them is now. Climate change is forecast to bring more hurricanes to Northeast as waters warm, some scientists say. Worldwide, sea levels have risen faster since 1900, putting hundreds of millions of people at risk, the United Nations has said. Erosion from the changing conditions jeop-

Cisco to lay off over 4,000 employees; 34,000 jobs cut across 141 US tech firms this year

Cisco is strategically focusing on artificial intelligence and forming a partnership with Nvidia to stimulate growth. This is being seen as the reason behind redundancy of 5% of its global workforce. Company claims, with an employee count of 85,000, is undergoing layoffs and a broader restructuring effort to concentrate on highgrowth areas. But Cisco isn't the only one. The networking equipment giant has followed suit to hundreds of other US and Canada firms which strategically moved towards AI integration in its operations to announce massive layoffs since the beginning of 2024. While job cut announcements in the U.S. more than doubled month-onmonth to 82.307 in January, they were down 20% from a year earlier, according to a report by outplacement firm Challenger, Gray & Christmas earlier in February. On a broader scale, the technology sector in the United States is witnessing a wave of job cuts. In 2024, thousands of jobs have already been eliminated across various tech companies. Cisco's decision adds to the growing list of firms implementing workforce reductions. The technology industry, which experienced the highest number of layoffs in 2023, has already seen 34,000 job cuts across 141 firms in the current year, according to Layoffs.fyi. As companies across sectors in the U.S. and Canada grapple with economic challenges, the job cut announcements signal potential ongoing layoffs in 2024 as organizations strive to control costs.

Rhinos are returned to a plateau in central Kenya, decades after poachers wiped them out

Kenya Conservationists

Kenya are celebrating rhinos returned to a grassy plateau that hasn't seen them in decades. The successful move of 21 eastern black rhinos to a new home will give them space to breed and could help increase the population of the critically endangered animals. It was Kenya's biggest rhino relocation ever. The rhinos were taken from three parks that are becoming overcrowded to the pri-Loisaba Conservancy, where herds were wiped out by poaching decades ago. "It's been decades since rhinos roamed here, almost 50 years

ago," said Loisaba secu-

rity manager Daniel Ole

Yiankere. "Their num-



bers were severely impacted by poaching. Now, our focus is on rejuvenating this landscape and allowing rhinos to breed, aiming to restore their population to its former splendor." Moving rhinos safely is a serious challenge. The 18-day exercise involved tracking the rhinos using a helicopter and then shooting them with tranquil-

izer darts. Then the animals — which weigh about a ton each have to be loaded into the back of a truck for the move. Disaster nearly struck early in the relocation effort, when a tranquilized rhino stumbled into a creek. Veterinarians and rangers held the rhino's head above water with a rope to stop it from drowning

reversal drug took effect, and the rhino was released. Some of the rhinos were transferred from Nairobi National Park and made a 300-kilometer (186-mile) trip. Others came from two parks closer to Loisaba. Rhinos are generally solitary animals and are at their happiest in large territories. As numbers in the three parks where the rhinos were moved from have increased, wildlife officials decided to relocate some in the hope that they will be happier and more likely to breed. David Ndere, an expert on rhinos at the Kenya Wildlife Service, said their reproduction rates decrease when there are too many in a territory.

As per the order, the initial amount of Rs 2,000 given at the time of birth has been increased to Rs 5000 from the financial year 2024-25. For the completion of all vaccinations in one year, Rs 1,000 was given, which has been increased to Rs 2,000.Besides, Rs 2000 given for admission to the first class of a girl has now been increased to Rs 3000.
