Population to hit 152.2cr by 2036, sex ratio will improve to 952: Govt

NEW DELHI: By 2036, India's population is expected to reach 152.2 crore, with a slightly improved female percentage of 48.8% as compared to 48.5% in 2011, a report published by the ministry of statistics and programme implementation (MoSPI) showed on Monday.

The report - 'Women and Men in India 2023' projects that the proportion of individuals under 15 years of age will decrease from 2011 to 2036, likely due to declining fertility rates.

In contrast, the proportion of the population aged 60 years and above is anticipated to substantially increase during this period.

India's population in 2036 is expected to be more feminine compared to 2011, as reflected in sex ratio which is projected to increase from 943 (per 1,000 males) in 2011 to 952 by 2036, highlighting a positive trend in gender equali-



'If courts start denying bail ...': SC affirms 'bail is rule' even for special statutes **NEW DELHI**: The

Supreme Court on Tuesday granted bail to a man accused under the Unlawful Activities (Prevention) Act (UAPA), emphasising that the legal principle "bail is rule, jail is an exception" is applicable even to offences under special statues. The top court highlighted that denying bail in deserving cases would be a violation of

fundamental rights. A bench of justices Abhay S Oka and



Augustine George Masih underlined the importance of considering bail applications in accordance with the law, even in serious allegations. They stated, "Allegations of the prosecution may be very serious, but it is court's duty to consid-

Failure to comply with this clause can lead to suspensions, as seen in Bhagat's case. Why Celebrities Are **Seeking Legal Protection** For Their Personality Rights

The court was also informed that third parties were unfairly benefiting commercially from the sale of merchandise featuring his pictures and voice for ringtones. Most alarming was the online circulation of fake pornographic images and videos of the actor with other actresses. Notably, in its order, the Delhi High Court stated that satirical writing and genuine criticism would be safeguarded and not construed as violations of personality rights. While the word 'Jhakaas' can be used by people, they cannot exploit it commercially in the manner Anil Kapoor does. Similarly, it can be used for satire, criticism or parody, but not for monetary gains. In the Jackie Shroff case as well, the court declined to order the removal of a video titled 'Jackie Shroff is Savage, Jackie Shroff Thug Life', posted on a YouTube channel named 'Thugesh'. The court deemed the video a form of artistic expression and said imposing restrictions would have significant consequences. In the Anil Kapoor case, the court established the protection of personality rights in the realm of AI and deepfakes. However, this hasn't deterred the illegal use of celebrities' personal attributes for financial gains. Regarding the existing laws, advocate Naik says: "I feel the current laws and the jurisprudence that we got from the Delhi High Court in matters of Mr. Bachchan or Mr. Kapoor are good references. I personally feel the time has come for us to protect personality rights.

"A few celebrities may choose not to pursue legal action due to various reasons such as the perceived insignificance of unauthorised use, the costs involved in litigation, or a desire to avoid negative publicity," says Shoeb Masodi, Partner, M&P IP PROTECTORS. Personality rights, as the name implies, pertain to the rights associated with the personality of a well-known individual, primarily applicable to celebrities whose names, images or voices are prone to misuse for profit. The concept dictates that only the owner or creator of these attributes has the right to derive monetary benefits from them. Personality rights have gained importance alongside the right to privacy given the kind of fame celebrities enjoy today. In 1995, the Supreme Court recognised a person's right to control the commercial use of one's identity in the R Rajagopal vs. State of Tamil Nadu case, commonly known as the Auto Shankar case. In 2015, the Madras High Court intervened to protect actor Rajinikanth's personality rights, halting the release of the movie Main Hoon Rajinikanth. The filmmakers had utilised the actor's name and style without his express permission, with the title itself serving as a clear indication of its connec-

Sparked concerns about a possible war between Israel and the Lebanon-based terror group

The killing of a top Hezbollah commander in Beirut by the Israeli Defence Forces has sparked concerns about a possible war between Israel and the Lebanon-based terror group. The two previously fought a 34-day war in 2006 that ended in a stalemate. But what happened? Hezbollah vs Israel: What happened the last time they went to war in 2006?

Hezbollah on 12 July, 2006, killed three Israeli soldiers and captured two others in what it called operation 'Truthful Promise.' AP

Are Israel and Lebanon's Hezbollah going to war? This is what many are worried about in the aftermath of the Israel Defence Forces (IDF) killing a top Hezbollah commander in Beirut. Israel claimed that the commander Fouad Shukur was allegedly behind the weekend rocket attack that left 12 young people dead in the Israeli-controlled Golan Heights – an assertion that Hezbollah has denied. The two sides have exchanged near-daily strikes for the past 10 months against the backdrop of the war in Gaza, but they have previously kept the conflict at a low level that was unlikely to escalate into full-on war. However, that could now change. "The Israeli enemy has committed a great stupid act in size, timing and circumstances by targeting an entirely civilian area,"



Hezbollah official Ali Ammar told Al-Manar TV.

But what happened the last time Israel and Lebanon did

Let's take a closer look:

The war between Israel and Hezbollah kicked off with Hezbollah fighters crossing the border into Israel on July 12, 2006. As per Human Rights Watch, the militants attacked an IDF convoy near the border. They killed three soldiers and kidnapping two others – whom they brought back to Lebanon. The aim of the operation was in keeping with Hassan Nasrallah's objective to capture Israeli soldiers and exchange them for prisoners. Hezbollah also sought the return of the Israeli-occupied Farms. The terror group then announced it would enter 'indirect negotiations' with Israel. However, then Lebanese prime minister

Fouad Siniora denied that he knew what Hezbollah was planning. In a letter dated July 13, 2006, to the Secretary-General and the President of the Security Council, the Government of Lebanon declared that '[T]he Lebanese

Government was not aware of the events that occurred and are occurring on the international Lebanese border" and that "[T]he Lebanese Government is not responsible for these events and does not endorse them."

'Act of war'

However, Israel was having none of it. minister Ehud Olmert announced that the Lebanon government had committed an 'act of war.' "Lebanon is responsible and Lebanon will bear the consequences of its actions," Olmert vowed. Meanwhile, Israel's chief of staff Dan Halutz said "if the soldiers are not returned, we will turn Lebanon's clock back 20 years," as per ICRC. Udi tions on the border. They Adam, the head of Israel's Northern Command, added, "This affair is between Israel and the State of Lebanon. Where to attack? Once it is inside Lebanon, everything is legitimate – not just southern Lebanon, not just the line of Hezbollah posts." The IDF on July 13, 2006, began bombing bridges, roads, and important other Hezbollah positions including Beirut's Rafic Hariri International Airport. Israel also imposed a 'complete blockade' on Lebanon, as per Human Rights Watch. According to CSIS, Hezbollah was taken by complete sur-

prise. Hezbollah leader Hassan Nasrallah later admitted he would not have started the

war had he known its outcome. Reuters Indeed Nasrallah would later

announce that he would not have conducted the operation if he had known about the outcome. But that would come later. Hezbollah's immediate reaction was to fire a hail of rockets at Israel. The terror group is estimated to have fired 4,000 rockets – around 34 on average

As per CSIS, Hezbollah militants hid themselves along trees, patches of vegetation, caves, surface irregularities, and buildings along the slopes of the hills. From here, they launched missiles and rockets at Israeli posi-

also used civilian infrastructure to hide command centers, ambush Israeli fighters and allow its own militants manouvre space to Hezbollah also used antitank guided (ATGMs) to great effect. During the war, ATGMs accounted for the majority of Israeli infantry casualties including 24 tank crewmen. ATGMs also took out 20 tanks. The performance of Hezbollah's militants won praise from Western analysts, as per CSIS. According to ICRC, the government in Lebanon repeatedly asked the United Nations Security Council to call for an 'immediate and unconditional ceasefire' between Israel and Hezbollah.

The ceasefire

The war finally ended with the United Nations Security Council passing Resolution 1701 on August 11, 2006.

The resolution called for a "full cessation of hostilities based upon, in particular, the immediate cessation by Hezbollah of all attacks and the immediate cessation by Israel of all offensive military operations, and emphasising the need to address urgently the causes that have given rise to the current crisis, including by the unconditional release of the abducted Israeli soldiers. The resolution also called for a demilitarised zone on Lebanon's side of the border.

A warning against bogus syllabuses and sample question papers is released by CBSE

Delhi: The Central Board of Secondary Education

(CBSE) issued a warning alert informing parents and students to be wary of false information pertaining to the curriculum, study guides, and practice exams for the 2024-25 school year. The Board has issued a warning to pupils about the dangers of falling for online scams that spread false information. We've noticed that some websites and online portals are disseminating stale information and unreliable updates about curriculum, sample question papers, CBSE resources, and activities. The alert said, "These links and news erroneously assert to offer up-to-date information for the session 2024-25. "In the interest of the public, we wish to emphasize that information from unauthorized sources can be misleading and may cause unnecessary confusion among schools, students, parents, and other stakeholders," it continued. Due to significant discrepancies between theory and practical scores in a few courses, CBSE has recently instructed schools to assess practical exams appropriately. In a notification, the CBSE said that, based on data from prior years' results, it had used sophisticated AI techniques to identify significant disparities between theory and practical grades in specific courses among 50% or more students in about 500 CBSE-affiliated schools. In the meantime, the July 15th date of the CBSE supplementary examinations for Classes 10 and 12 has been set. The Class 12 supplementary test will take place on a single day, July 15, while the Class 10 CBSE supplemental exam 2024.

Currency circulation increases despite 2k note ban

Delhi: Despite the elimination of Rs 2,000 banknotes, the currency in circulation increased by Rs 1.3 lakh crore in FY24 from Rs 33.5 lakh crore at the end of March 2023 to Rs 34.8 lakh crore. Growth has slowed the most since 2018. In FY24, currency in circulation as a proportion of GDP fell since 4% i is slower than GDP growth. CIC grew 7% last year and over 10% the year before due to a pandemic cash rush. Currency in circulation grew 0.5% to Rs 35.3 lakh crore in the week ended April 5. RBI data shows that the increased issue of Rs 500 notes has more than offset the withdrawal of Rs 2,000 notes. ON May 19, 2023, RBI announced their withdrawal. In March 2024, Rs 2,000 notes were worth Rs 8,202 crore, down from Rs 3.6 lakh crore a year earlier. The value of Rs 500 notes rose to Rs 30.1 lakh crore from 25.8 lakh crore a year before.

Google cancels Play Store online gaming trial due to lack of rules

Delhi: Google paused its pilot program to list fantasy sports and rummv games on the Google Play Store, but gave India a "grace period". This means Google will not increase Play Store open access for more real-money games as planned in January. Existing Play Store apps will stay there. Google suspended the pilot, which began in July 2018 and was extended in January in India, Brazil, and Mexico, due to a lack of a "central licensing framework" that governs game legality. "Expanding our support of real-money gaming apps in markets without central licensing

more difficult than expected, and we need additional time to get it right for our developer partners and the safety of our users," a spokesman for Google said. The move hurts India's online gaming industry, which is divided over whether games are 'games of skill' or 'games of chance'. A Japanese company is creating battery material with an energy density that is 100 times higher

Delhi: TDK, a multinational electronics business based in Japan, has revealed that it has created a material for solid-state batteries that has an energy density that is roughly 100 times higher than that of traditional ones. The Tokyo-based company claims that a variety of wearable gadgets, including smartwatches, wireless earbuds, hearing aids, and environmental sensors, may make use of their technology. Although the new material is intended to replace current coin cell batteries, it makes use of lithium alloy anodes and an oxide-based solid electrolyte. "Batteries are quite safe since they employ solid electrolyte based on oxides. It stated in a statement that "it is intended for use in wearable devices and other devices that come into direct contact with the human body." "The battery can be applied for replacing coin cell primary batteries in compliance with EU battery regulations, which require them to be replaced by rechargeable batteries, which is expected to contribute to the reduction of environmental impact," it stated. According to the company, the new technology also makes it possible for batteries to be smaller and have a longer operating life.

Voda to sell 10% Indus share for \$1.1bn





Delhi: To prepare its players for the quadrennial spectacle, the National Rifle Association of India has imposed severe conditions on Paris Olympic shooters, including a "media blackout" and no personal coaches at the national camp. In its 'national team protocol", the federation informs shooters that parents cannot "stay" or "visit" their wards at camps and that Pierre Beauchamp, the High Performance Director (HPD), must make an exception. According to the NRAI's "NRAI Olympic Team Undertaking and SOP for Paris 2024 Olympic Games - Pistol/Rifle Teams" letter to Olympic-bound shooters, the goal is to "ensure the clarity of the training and readiness plan for Olympic Games Paris 2024 by the shooters and the National Team Coaches and Sport Science support." "It is essential to have effective organization, discipline, planned and dedicated training programmes for the best performance of shooters participating as National Team India at the Paris 2024 Olympic Games," the note states. The letter states that only NRAI-approved personal coaches and sport science consultants with signed SOPs can assist the "National Training team for the concerned shooter(s) in assisting and/or discussing with the National Training Team under the leadership of the HPD and the chief coach (rifle and pistol)." Personal coaches without NRAI approval are prohibited. "The NRAI National Team program of the Olympic Games does not allow personal trainers, physiotherapists, nutritionists, or psychologists." Under 'Media Blackout", the NRAI says shooters must avoid the media.
