UPA's policy mess & scams caused lost decade, says govt white paper

NEW DELHI: Government

Thursday tabled paper Parliament to back up its charge of economic mismanagement under UPA by listing an entire array of what it called failures — from public finances to external sector and banks allowing multiple frauds, that led to India "losing a decade".

The paper flagged nontransparent auction of coal blocks and telecom spectrum, retrospective taxation, unsustainable demand stimulus (post 2008 global financial crisis), poorly targeted subsidies and reckless bank lending "with undertones of favouritism", as the defining features of UPA's "decade of governance (or its absence)" and "policy misadventures and scams".Govt threw down the gauntlet to Congress by scheduling a full-scale debate on Friday, in a clear indication of intent to high-



agement during the 2024 LS poll campaign.

In contrast to UPA's performance, the Modi govt argued that it has taken a series of steps to fix the economy and initiated procedural

behavioural changes to make India the fastest growing major economy and the fifth largest in the world. The finance ministry document accused the UPA of bringing public finances to a "perilious state" with very high levels of fiscal deficit, which a comlight its economic man- mittee headed by for-

mer finance secretary Vijay Kelkar pointed out was higher than what was shown. Based on an analysis of budget documents, the paper estimated fiscal deficit being understated by up to 1.8 percentage points due to special bonds being issued by Manmohan Singh govt, which were not clearly shown in the books.

As a result of its "fiscal mismanagement", the UPA government's fiscal deficit ended up being far higher than it had expected, and it subsequently ended up borrowing 27% more 1991 reforms.

Perform transplant first, charge patient later, panel tells hospital

MUMBAI: Patients awaiting an organ transplant for years often turn down the chance when a donor finally becomes available, all because of insufficient funds on the very day the organ becomes available.

Now for the first time, the Zonal Transplant Coordination Committee (ZTCC), which distributes cadaver organs, has persuaded Jaslok Hospital, Pedder Road, to proceed with the kidney transplantation of a 12-year-old boy, urging it to perform the surgery first and raise the funds from various sources later.

The young recipient, the son of a mechanic who was not prepared with the requisite funds, would have been passed up for another patient on the wait-list if not for the ZTCC intervention.

The ZTCC now intends to encourage more hospitals to adopt a approach, ensuring that individu-



als in need of organs are not overlooked solely due to financial constraints. The cost of a transplant can range from Rs 7 lakh to Rs 30 lakh, depending on the organ involved and the centre where the surgery is being performed. "This issue is prevalent nationwide, where patients frequently find themselves unprepared financially on the day when an organ becomes suddenly available," S K Mathur, president, ZTCC, said. In situations where funds are anticipated from trusts or government schemes, hospitals can be confident that the necessary finances will eventually materialise. In the state, Mahatma Jyotiba Phule Jan

Arogya Yojana (MJP-JAY) pays Rs 2.5 lakh for kidney transplants. The new version of scheme will increase it to Rs 4 lakh.

The CM's Relief Fund also supports transplant patients. Mathur said Jaslok Hospital cooperated in the case of the 12-year-old boy, Aditya Chaudhary, and made the surgery possible. Recipients may face wait times ranging from months to eight or nine years and often receive short notice, sometimes just hours, to come for the transplant once an organ becomes available.

Odisha minor tried as adult, gets 20 yrs jail

BHUBANESHWAR: An Odisha children's court on Tuesday sentenced a 17-year-old minor to 20 years of jail after trying him as an adult under the amended Juvenile Justice Act of 2015 for alleged rape and murder of a five-year-old in Nayagarh district in 2020, re.

This is the first instance in Odisha of a minor being tried and found guilty under the amended law. The 2015 amendment empowers juvenile justice boards to treat as adults those minors who are accused of heinous crimes. It came about after the 2012 Nirbhaya case where one of the suspects was a juvenile and



escaped the gallows. In Odisha, the teenager was a neighbour of the deceased and his crime child went missing while playing outside her house on July 14, 2020. Her skeletal remains were found near a pond 500 metres from her home nine days later. As the death mystery deep-

ened a Navagarh police failed to unravel the truth, her parents attempted selfhad triggered outrage immolation outside the across the state. The assembly in November that year, drawing the govt's attention.Four days later, the govt constituted an (SIT) led by an ADG, Arun Bothra, to probe the case under the supervision of the Orissa high court. The minor was detained in December 2020. "We placed adequate

evidence, backed by scientific and forensic investigations, against the accused. The murder motive was sexual assault. We had found semen stains on the girl's dress," an SIT officer said. According to prosecutor public Chittaranjan Kanungo, 31 witnesses were examined during the trial. "Had the accused not been a minor, he would have been sentenced to life imprisonment or capital punishment," Kanungo said. Defence lawyer Bijay Mishra said he would challenge the verdict in

the high court.

AYODHYA: For centuries, people of Ayodhya have been praying to Lord Ram for their well-being but there has been another 'Sri Ram' in the holy city, providing relief and succour to the poor and the sick and healing wounds for more than 120 years. The Sri Ram Hospital housed in its heritage building, located less than a km away from the newlybuilt grand Ram Mandir, sits along Ram Path in the heart of the temple town. An old marble plague embedded on a wall in the main block bears an inscription - "This hospital built and endowed for the poor of Ajodhia by the Hon'ble Rai Sri Ram Bahadur was begun upon 5th Nov 1900 when the foundation stone was laid by the Hon'ble Mr J Hooper, ICS, Commissioner of Fyzabad Division." The inscription further reads that it was "opened to public use on 12th April 1902 by HH Sir James Digges Latouche, KCSI, Lieutenant Governor of the United Provinces of Agra and Oudh". Another plaque bears the same inscription in Hindi and Urdu. "As it's in Ayodhya and located close to Ram Janmabhoomi site, a very large number of people think it is named after Prabhu Shri Ram. Its founder Sri Ram, was a philanthropist who established this hospital which gets patients from Ayodhya and Faizabad towns, and also from Gonda and Basti districts," the hospital's administrative officer Yash Prakash Singh told PTI here. Though the hospital is under the Uttar Pradesh government and treatment is free, many people "also think it is a private facility".

NEW DELHI: "I was someone who ran away at the sight of a cockroach. If someone died nearby, I was afraid to pass by that house for days. Yet today, I spend almost my entire day around mortuaries and crematoriums performing the last rites for unclaimed bodies," says Pooja Sharma. Sharma, 26, does spend a lot of time now with the dead. Giving them a dignified farewell is an obsession with her. After she had to step in the absence of other males in the family at her murdered brother's last rites, the thought of what happened to those who had no family or kin for the final ritual gnawed at her. She took up the mission and claims that since 2022 she has provided 4,000 unclaimed bodies a proper goodbye.

"Soon after my mother's death in 2022 due to illness, my elder brother was killed in a brawl in our area. My father could not bear the shock and went into a coma.

5-month-old branded with hot iron, dies

BHOPAL: In what could be a fifth

Madhya Pradesh, a five-monthold infant who was allegedly branded with hot iron in a superstitious belief to cure pneumonia, died in Shahdol district. I.N.D.I. Alliance is falling apart

Bharat has seen more than 60 coalition governments since 1967, when the first non-Congress government in Uttar Pradesh was formed by the Samyukta Vidhayak Dal alliance with Charan Singh as the chief minister. The first experiment lasted a little over 10 months. Coalitions emerged and have existed in India mainly to keep a strong party or formation out of power. They come up when a political force becomes very strong. Earlier, coalitions were formed against the Congress, now parties come together against the BJP. Quite often, complete ideological strangers have come together to pull the plate from under a bigger dog. In 1977, Bharatiya Jana Sangh and Leftist-socialist forces came together as part of the Morarji Desai government to defeat the Congress after the Emergency. In 1989, the Left and the BJP came together to support the VP Singh government to keep the Congress out. In 2019, the Shiv Sena betrayed the mandate it got going into the elections with the BJP as partner and formed the Maha Vikas Aghadi government with the party's bitter ideological opponents, the Congress and the NCP. FirstUp: Budget Session in Parliament, ED to question Hemant Soren... News today On an average, coalition governments in India have lasted for 26 months. West Bengal's Left Front regime was a glaring exception. It was the longest serving coalition government which ruled for 34 years between 1977 and 2011. The 9-10 parties were tethered by a convergent Communist-socialist line, and they ruled without the anxiety of having to keep a bigger enemy out. It ruled with such absolute power that for long, the enemy was almost nonexistent. Now, let us look at what is happening to the Opposition I.N.D.I. Alliance. Nitish Kumar has ditched it and gone with the BJP, BRS has deserted it too, Mamata Banerjee has launched a vicious attack on Rahul Gandhi and Congress over the Bharat Jodo Yatra entering Bengal without her knowledge, Udhayanidhi tirade against Sanatan Dharma has made DMK's non-South partners squirm, Akhilesh Yadav is fuming at the slights from Congress leaders like Kamal Nath, more than half of NCP is with NDA while the patriarch Sharad Pawar and his daughter Supriya Sule are nominally with the Opposition, Jharkhand CM Hemant Soren has been arrested for corruption, Delhi CM Arvind Kejriwal may follow him soon, and RJD chief Lalu Prasad Yadav reluctantly prepares to cool his heels for some more months in the slammer. The alliance is in royal disarray, if not dead already. There are broadly five reasons for this. First, the Congress is the elephant in the room. It still thinks it is bigger than what it currently is, and certainly weightier than others. Both could be misplaced, and 2024 general election results might be the only, albeit unpleasant, way the party rightsizes itself in its own estimation. Second, the Congress's success could come at the cost of regional parties. Its allies are already alarmed by its success in Karnataka and Telangana feel their space is shrinking or could be cannibalised by the Congress later.

Third, there are too many 'secular' parties scrambling for the '20 per cent' minority pie. Mamata has spelt it out in as many words, accusing the Congress of trying to steal her Muslim votes. Fourth, the Congress does not have enough heft to carry an ideological hotchpotch. The BJP may get away with breaking a section of the NCP because its otherwise robust Hindutya subsumes the odd minority-leaning ally. The Congress cannot afford either a Shiv Sena trying to ride the Ram wave or a DMK continuously humiliating Hindus. And fifth, the I.N.D.I. Alliance does not have a deft backroom organiser like Harkishan Singh Surject of the '80s and '90s who brought disparate forces together. Pawar could have played that kind of a role, but he is too old

, besides having the burden of succession to worry about. The Congress's communication department, led by an irascible Jairam Ramesh, cannot forge a coherent coalition between the party's goal. and its messaging, forget taking allies along.

Temple entry ban non-Hindus but non-respectful

Before the pandemic skewed foreign tourist inflows, India got around 11 million annually, including desis holding other passports. But the number of Indians who visited pilgrimage places within the country in 2022 stood at a whopping 1.43 billion, which means they travelled to several such destination in a year, accounting for the largest segment of domestic tourism. And according to Statista, this faith-based tourism in India generated US\$902 million in 2022. So, in addition to local Hindus frequenting nearby temples, the chances are that tourists visiting them from elsewhere in India are mostly of the same faith too. And though customs and practices do differ from place to place and even temple to temple, there are some universally followed principles. The high court was right to point out that reasonable restrictions for conduct to ensure respect are more conducive to peaceful inter-community relations than a free-for-all.

As the case in question arose amid reports of "non-Hindus" using a certain Tamil Nadu temple's premises as picnic spots—and eating non-vegetarian food there rather than being mindful of the sanctity of the place, the court's caution is timely. Other incidents of "non-Hindus" bringing their "holy book" to temples and



attempting to conduct their religious practices within its precincts were also mentioned in the court's judgment and probably prompted the final order. In fact, the High Court aptly pointed out that if a non-Hindu who declines to follow customs is allowed inside the temple, it would affect the sentiments of the large number of Hindus there who practice the faith. And that in turn would affect the religious right of those Hindus guaranteed under the Constitution. The 'secular' Tamil Nadu government was also reminded that its HR & CE Department is mandated to protect the Hindu religion, its temples, customs and practices. The plea that "Non-Hindus not allowed" boards hurt the religious sentiments of those who would like to visit the temple did not stand to reason either. Given that exceptions will be made for those who sign an undertaking, the court rightly averred that if a non-Hindu is denied entry

because he does not have faith and declines to follow customs, "there is no question of hurting his sentiment." If there is no reverence for the deity, denial will hurt egos, not sentiments. Non-Muslims are not allowed inside Mecca much less the Kaaba itself.

There has been no protest about hurt sentiments on that count from visitors to Saudi Arabia who are not of the Islamic faith. Many Orthodox churches do not allow lay people, especially women, into the sanctum sanctorum, the equivalent of the garbha griha of temples. While many formerly prohibited places of Abrahamic faiths are now accessible, respect is a reasonable precondition for entry.lgnorant Indians could, of course, presume important Hindu temples, especially in south India, are actually picnic spots as these are managed by respective state governments by virtue of controlling their

through a series of legislations. Some state governments are deliberately lax about ensuring the decorum of the temples under their charge as the primary interest is controlling the use of the money collected in the hundis, so picnics are possible. Curiously, government control of places of worship applies only to temples, not places of worship of any other religion, no matter how prominent and wealthy those may be. Corruption is also rife among government employees controlling the temples. How states and centre are involved in religious matters—financial administration of temples cannot be wholly secular—given the separation of powers principle is strange too. That, however, is a separate debate. Why anyone would think that a functioning temple is an appropriate place for a picnic is hard to understand, although the Church of England has resorted to even parties inside some cathedrals in the hope that people drawn there by the food, alcohol and pop music would be captivated enough to come back to the Church, literally and figuratively. Nothing of the sort happened, and those who attended such parties did not

even end up thinking more positively about religion. Tourists are not allowed to whatever they please within

functioning mosques. Managements of Sikh gurdwaras around the world insist and ensure that all those who enter the premises cover their heads, male or female irrespective of faith—or even lack of it—and follow customs. No exceptions are allowed but nor has anyone protested against this "imposition". No one is "caught" picnicking in gurdwaras and mosques with hampers of forbidden food items either.

That a high court had to actually state that temples are not "picnic spots" speaks volumes about the attitude of the few who are unwilling to accept this simple fact without judicial muscle-flexing. Being mindful of devotees' sentiments in any place of worship should be natural. The current issue is not about barring non-Hindus (as those of all faiths can still enter temples after giving an undertaking to follow customs) but the disrespectful. No one should object to that. Earlier this month the Madras High Court directed the state government's Tamil Nadu Hindu Religious and Charitable **Endowments** (HR&CE) department to install boards in Palani Dhandayuthapani Swamy Temple (and all other Hindu temples), stating that non-Hindus are not permitted beyond the Kodimaram (flagstaff).



Govt, RBI measures have kept inflation in 2-6% range: Finance minister

NEW DELHI: Finance ministry on Monday said the Indian economy has remained resilient amid global headwinds on the back of robust domestic demand, an investment-led strategy due to a transformed climate and high level of public spending, macro-economic stability, apart from a spate of reforms initiated by government over the last 10 years.

A review of the Indian economy released by the ministry said inflation has been reigned in within 2-6% band because of steps taken by government

It, however, warned of risks to the external sector from sticky inflation, sluggish growth and fiscal pressures in the global economy, with the tension around Red Sea seen as a potential threat. "Potential risks are expected to emanate from ongoing geopolitical tensions and the recent surge in shipping costs due to re-routing to avoid security risks in international waters, which contains the potential for triggering inflation, especially in terms of energy costs," the 63-page document released ahead of the interim Budget said. When it came to India, it appeared upbeat on the overall prospect. "Ten years ago, India was the 10th largest economy in the world, with a GDP of \$1.9 trillion at current market prices. legend Geoffrey Boycott accused the England team of "losing the plot"

NEW DELHI: Boycott, writing in his column for The Telegraph, lambasted England for what he perceived as a reckless pursuit of attacking cricket, particularly in the fourth innings chase of 399 runs. He argued that England's "Bazball" mentality, epitomized by Brendon McCullum and Ben Stokes, led to their downfall.

"Bazball is great entertainment when it comes off. But once you believe in an ideal over substance then you have lost the plot," Boycott wrote, highlighting England's propensity to prioritize aggression over solidity. Pointing to Joe Root's frenetic

innings of 16 off ten balls, Boycott lamented the departure from Root's usual composed approach, attributing his dismissal to an ill-advised attempt at aggressive strokeplay. "Joe Root was dancing down the pitch trying to hit over the top and very soon swiped it up in the air. He only scored 16," Boycott observed, emphasizing the failure of England's aggressive mindset.



Boycott also criticized England's broader batting philosophy, suggesting that the influence of Twenty20 cricket has led to a mindset where every ball must be attacked aggressively, akin to cricket's answer to baseball.

"Twenty20 cricket seems to have got in their head and made them think that every ball must be scored off with an aggressive stroke, sweep, swipe or crossbatted shot," Boycott remarked, highlighting the team's departure from traditional Test cricket principles. Despite England's valiant effort in the fourth innings,

Boycott questioned the team's approach, emphasizing the importance of substance over style in Test cricket. He referenced England's previous struggles in the Ashes series, where a similar approach led to defeat."You would have thought England had learned from giving away the Ashes last summer. The 'gung ho' batting at Edgbaston and Lord's gave two Test matches away," Boycott recalled, urging England to prioritize building substantial innings over aggressive shot-making.

Delhi govt to expedite sewer link in unauthorised colonies



The submission, dated January 31, said that around 82% of Delhi was covered by a proper sewerage network Delhi chief secretary Naresh Kumar has informed the National Green Tribunal (NGT) that the Delhi government is looking to expedite the process of connecting unauthorised colonies and JJ clusters to sewage treatment plants by laying down a sewerage network. In a submission made to NGT, Kumar said that out of the 1,799 unauthorised colonies in the Capital, 1,031 were already provided a proper sewage network and 296 more such colonies will be included by November 2024.

He said that 284 such colonies were con-

During the last year, a sewerage network has been provided to 284 more unauthorised colonies, and now 1,031 of 1,799 Unauthorized Colonies have sewerage networks. Provide antirabies serum at PHCs

Delhi: Anti-rabies serum must be made available at all sub-health centers, primary health centers, and urban primary health centers, per a directive from the Center to all states and Union territories. According to the National Health Mission, financial assistance would be given for the purchase of the antirabies serum. When there is a possibility of serious exposure following contact with a rabid animal or when an animal is thought to be rabid, anti-rabies serum is given. In severe cases, it should be administered in addition to the rabies vaccine. According to experts, the majority of primary health centers do not carry it, and each dose costs more over Rs 10,000. In a recent letter to the states and UTs, an NHM official said that rabies is a fatal viral infection and that having access to medications for both prevention and treatment is crucial to preventing the financial and psychological toll that rabies has on fami-

Over 66K youth gain employment in 2023-24 through **Vocational Education and Skill Development**


Lucknow Committed to enhancing the skills of youth and

fostering employment opportunities, the Yogi government has achieved significant milestones during the financial year 2023-24. Specifically, the government has successfully facilitated the employment of 36,843 trained candidates from industrial training institutes. Additionally, through the Uttar Pradesh Skill Development Mission, a total of 29,354 trainees have been placed in various companies. As a result, more than 66,000 youth across the state have gained employment opportunities through vocational education. Notably, these employment opportunities have been extended to students from all 75 districts across the 18 divisions of Uttar Pradesh. This information was provided in response to a question asked during the budget session of the UP Vidhan Sabha. During a session at the assembly, Minister of State (Independent Charge) for Vocational Education and Skill Development, Kapil Dev Aggarwal, informed that, in accordance with directives from the Chief Minister, significant efforts are underway to seamlessly integrate youth into vocational education across the state. The overarching objective is to facilitate easier employment opportunities for them. He further elaborated that training is currently offered in 84 trades across industrial training institutes statewide, aligning with the curriculum standards and criteria set by the National Council for Vocational Education and Training (NCVET) of the Government of India. Additionally, through the Uttar Pradesh Skill Development Mission, skill training is being imparted in 386 short-term courses in various sectors. These courses include traditional trades as well as contemporary ones such as ITES, Electronics, Aerospace and Aviation, Telecom and Healthcare, reflecting the inclusion of new-age courses, he added. Students from all 75 districts received employmentThe department presented details about successfully employed students in the legislative House. Notably, students from all 75 districts of the state have secured employment opportunities following their training in industrial training institutes and skill development courses. Regarding candidates trained from Industrial Training Institutes, the highest number, 4,824 candidates, have been selected from the capital, Lucknow. Following this, 1,901 candidates have been selected from Kanpur city, 1,523 from Gorakhpur, and 1,414 candidates from Jhansi. Similarly, among the candidates trained through the Skill Development Mission, the highest number, 1,448 students, have been selected from Gorakhpur. This is followed by 1,298 from Ghaziabad, 1,168 from Shahjahanpur, 1,141 from the capital, Lucknow,
