Over 50% Indian EV owners want to get back to petrol/diesel vehicles

A Park+ survey of 500 electric vehicle owners from Delhi NCR, and Bangalore Mumbai, revealed that 88% suffered from charging anxiety, with maintenance costs and resale value also being major concerns. 51% preferred conventional vehicles. Tata Nexon EV emerged as the favorite. BYD was noted for its high pricing. Park+ has released a report based on a recently conducted survey, revealing key findings from a survey focusing on the experiences of electric vehicle owners in India. The survey included responses from 500 EV car owners in Delhi NCR, Mumbai, and Bangalore. According to data from the Federation of Automobile Dealers Associations (FADA), nearly 91,000 electric passenger vehicles were sold in India during the Financial Year 2023-

Key findings from the survey: A significant 88 percent of EV owners cited charging anxiety as a primary concern, surpassing the more commonly discussed range anxiety.

Many drivers preferred to limit their travels to short intercity trips under 50 km due to these challenges.

Moreover, 73 percent of respondents, maintenance costs were a major grey area. Many EV owners find it problematic that even local mechanics find it difficult to fix and EV. The inability to obtain second opinions on repair costs further compounded their concerns. Besides that, a substantial fall in the resale value of EVs was a worry for 33 percent of respondents. While the resale market for EVs is still developing.



Scrap Niti Ayog, restore planning commission: Mamata Banerjee

Bengal chief minister and Trinamool Congress Mamata Banerjee on Friday said, she will ask Prime Minister Narendra Modi "to scrap the Niti Ayog and restore the Planning Commission," at the Niti Ayog governing council meeting on Saturday, since the original version of the public policy think tank was an "effective platform and Niti Ayog is a powerless body, meant only for speeches." Banerjee, who arrived here on Friday for the meeting, while most of the INDIA bloc parties are boycotting it, said, she will speak out for her state, as well as for



the states ruled by the INDIA bloc parties, who were boycotting the Niti Ayog speaking to the media. The TMC chief, however, made it clear that the boycott of the Niti Ayog meeting "could have been better coordinated," if all the parties were to skip the meeting. "Possibly because it was a late decision after the budget was presented, each state reacted on their own," she added, when asked about her decision to attend the meeting. Lashing out at the Narendra Modi government, Banerjee "Bengal and all the opposition-ruled states have been discriminated against by the Centre, as is reflected in the Union budget. That is why most states decided to boycott the meeting."

Admitting that she was in two minds on attending the meeting, Banerjee said, "even I had thought of skipping it, so I

Kremlin spokesman Dmitry Peskov noted former US President Donald Trump is not significantly different from other American political elites, who share an anti-Russian sentiment. He acknowledged that during Trump's presidency, numerous sanctions were imposed on Russia. Although he exhibited some political wisdom in maintaining dialogue, it did substantially not impact Russia-US relations. former President Trump is 'not that different from the others,' the Kremlin said on Friday and added that he is a representative of a political elite that harbours anti-Russian sentiment. Kremlin spokesman Dmitry Peskov, when asked next about a commentary in the Wall Street said.

hostel residents, and frequent diners who often consume from street vendors or exposed food sources are at a high risk of getting the infection

due to compromised hygienic conditions." Among the array of health concerns exacerbated by the monsoon, hepatitis A has emerged as a pressing issue this year. According to WHO reports, fatalities related to viral hepatitis infections are on a constant rise claiming 3500 lives each day. Hepatitis A is a viral liver infection primarily transmitted through

Blue Screen Blues: Microsoft Triggered Cyber Meltdown and the **Case for Atma Nirbharta**

The champions of Atmanirbhar Bharat, isolationists among conservatives and the malcontents of globalisation are having a "told you so moment." The Microsoft outage has given all of them a chance to have a right royal moan about the perils of blind belief in the overarching credo of the liberal world order: that international post-World War II system characterised, at least in one context, by the encouragement of global trade, economic interdependence, and multilateral agreements. And it's not hard to see why. Look at the mayhem caused by a single rogue file called c-00000291*.sys. This teeny-weeny alphanumeric code in a single content update virtually fried the dendrites of the Microsoft Operating System that literally turned blue the pallor of death. Questions abound: did the firm tasked by Microsoft to ward off viruses and malware itself violate zealously adhered to software testing and development guidelines? Software updates are stringently tested at many levels before they are rolled out globally. The fact that this one slipped past shows that the checks and balances aren't as foolproof as they ought to be. The descent into defective code-induced dysfunction triggered global mayhem. The cost to businesses and economies could run into billions of dollars. This disruption was because of negligence, what if the next cyber pandemic is because of malevolence? no country except autarkies like China, Russia and North Korea, and the less technologically leveraged in the Global South, were spared. But because India is a paid-up member of the globalised, rules-based world order, it was strongly buffeted. Indeed, in a less connected world, a freak outage such as this would have had less impact. But that a single misplaced bit of computer code could bring nations to their knees reveals just how uncritically accepting we continue to be of "globalisation" as a project for the advancement of the human race. One would have imagined that we would have been less credulous by now, three years after a single sneeze triggered a global pandemic that stilled the globe and our lives. But clearly, some lessons are hard to learn. While no one needs to take the sledgehammer to globalisation, it is becoming obvious that there is a need to minimise risks. Perhaps, as a first step, by improving vigilance and incorporating redundancies throughout the global supply chain. This imperative of building self-reliance, however, will only gain ground when any prospective autopsy of the costs of globalisation is freed from politics. As of today, any inquiry into the status quo is dismissed by the Left as a "right-wing" lurch towards protectionism, spawned by a crude inward-looking parochialism. In India, examples abound. A certain section of the political class and commentariat mocked Prime Minister Modi for being blinded by exclusivism for deciding against joining an influential trading bloc like the RCEP. The decision, as it turned out, was the right one. Thailand joined the RCEP but in the last 18 months, its GDP growth has slumped to 2.7 per cent. This is largely due to trade imbalances after the RCEP's lead member, China, dumped goods, wantonly taking advantage of favourable tariff rates that its economic heft allowed it to impose across the RCEP. Of course, the stigmatisation of Atma Nirbharta is not only confined to trade-related policies but also foreign policy. Modi's "keep all options open" policy-driven engagement with Russia was the subject of scorn just a few weeks ago. Global interconnectedness has brought many benefits to many people. But the prohibitive costs of its many misses have brought ruin upon millions too.

New criminal laws are betting on DNA finger printing. India must prepare to offset risks

India's new criminal laws emphasise the use of technology and modern forensic methods to speed up justice and take the conviction rate up to "90 per cent". DNA fingerprinting, used extensively in the developed world, is one such technique. Other than producing scientific evidence against known suspects, DNA databases of previous convicts also assist investigators with unsolved crimes. However, is it the proverbial silver bullet as touted by many in the law enforcement community? DNA fingerprinting involves creating a profile of an individual's genetic make-up. This throws up various legal, quality control, privacy, and human rights issues. It is therefore crucial to examine the adequacy of the systems put in place to achieve the goals of these 21st-century legislations. A comprehensive, robust, and independent regulatory and oversight mechanism, established by a statute, is imperative. Developed in 1984 by British geneticist Sir Alec John Jeffreys, DNA fingerprinting entails analysing a person's DNA profile from human cells like hair, saliva, or blood and creating a profile used for identification in forensic investigations. It was first successfully applied in the twin rape and murder cases of two girls in the UK. The late Prof Lalji Singh at the Centre for Cellular and Molecular Biology (CCMB) in Hyderabad pioneered the use and application of forensic DNA technology in the Indian legal system in 1988. The Bharatiya



Nagarik Suraksha Sanhita (BNSS) 2023, which replaced Code of Criminal Procedure (CrPC), retains the provision for mandatory DNA profiling of rape case suspects, introduced in the CrPC in 2006. In addition, Section 176(3) of the BNSS mandates the collection of forensic evidence collection from crime scenes in offences punishable by seven years or more. Another new law, the Criminal Procedure (Identification) Act 2022 which replaced the coloniaera Identification of Prisoners Act 1920— allows the extraction and analysis of biological samples from convicts, preventive detainees, as well as those arrested for charges punishable by 7 years or more, or any offence against a woman or a child. Notably, the National Crime Records Bureau (NCRB) has been entrusted with the responsibility of collecting measurement records from states and maintaining a national database. According to Section Criminal 2(b) of the Procedure (Identification) Act 2022 the term 'measure-

ment' includes biological samples and their analysis, which also implies preparing DNA profiles. In fact, when the government withdrew DNA Technology Regulation Bill, 2019 in July 2023, it stated that most of its provisions had already been incorporated into the 2022 Act. However, without adequate safeguards, there is a risk that individuals may be arrested simply to include them in the database. Neither the BNSS nor the Identification Act define the 'DNA profile'. GeneWatch UK, in its comments on India's DNA Technology (Use Application) Regulation Bill 2019, noted that DNA profiling can be restricted to only non-coding DNA, a commonly used international standard. This prevents using DNA sections that code for personal characteristics, including medical conditions. Forensic geneticists, in the past, have been criticised for attempting to create mugshots—essentially predicting physical appearance—using genetic

information. Given the broad

whose biological samples can be collected by the state, such a restriction would help eliminate many possible misuses. The reliability of DNA fingerprinting has often been challenged, particularly concerning quality control during the handling of biological materials at different stages. Contamination of samples is a problem. Polymerase Chain Reaction (PCR), the most widely used technique for amplify small DNA quantities, also amplifies contaminants. There have been several high-profile cases of sample contamination. For instance, the defence in the OJ Simpson case argued extensively about the contamination of collected biological material. He was finally acquitted by the jury. Similarly, in the Pune Porsche hit-and-run case, the alleged culprit's blood sample was swapped with his mother's. Such examples highlight the need for strict quality control mechanisms and robust protocols for forensic labs (central, state, or private), investigators, medical practitioners, and data bank managers. Technology (Use Application) Regulation Bill 2019 proposed the creation of a DNA Regulatory Board. This board was meant to advise the central and state governments on DNA labs and data banks and to grant accreditation to labs. However, the bill was withdrawn in July 2023. While some functions of the DNA Regulatory Board have been assigned to the NCRB, it can-

categories of individuals not be designated as an independent regulator. Developed nations typically separate regulatory bodies from practitioners. The absence of an independent, full-time regulatory body in India does not bode well for standardising procedures across the board. Law enforcement agencies worldwide use DNA profile indices from crime scenes to help identify suspects in unsolved crimes. In India, it is unclear which agency will maintain the Scene of Crime DNA Profile Index, and who will conduct matching with the Convict or Arrestee Indices. A PIL is pending in the Supreme Court for using DNA fingerprinting to solve missing person and unidentified dead body cases. Sharing data with foreign law enforcement bodies by the NCRB is another ticklish issue. Profiles of investigators, medical practitioners, and forensic scientists should be prepared and maintained separately to distinguish their DNA from that of suspects in cases of multiple profiles resulting from collected samples. After the withdrawal of the DNA Technology Bill, no oversight body has been proposed to oversee the NCRB as a repository of national or state government databases.

The Technical Appraisal Committee will be chaired by the Director of Local Bodies, including the Chief Engineer, AD Accounts, Director C&DS, and PMU Representatives. This committee will also incorporate the State Program Monitoring Unit. In committees formed for Municipal Corporations, the Mayor will act as Chairperson, while the Municipal Commissioner will serve as Member Secretary and Convener. The DM, VC of the Development Authority, and an SE of PWD appointed by the Divisional Commissioner will be members. Projects will be approved by committees established at the civic body level under the 15th Finance Commission. 

Delhi : A new treaty **finali**zed by members the World Intellectual Property Organization (WIPO) requires patent applicants to reveal the nation of origin or the source of genetic resources if the claimed invention is derived from those materials or related traditional knowledge. One of the main demands of the developing world, led by India, is the treaty that will offer extra protection for Indian genetic resources and tradiknowledge, including yoga, siddhi, and ayurveda. The agreement was finalized by the Genevabased agency that is in charge of developing regulations pertaining to patents and trademarks. This will force some nations to revise

their domestic laws. Rather than trying to register patents to take advantage of the immense traditional knowledge and genetic resources, India has asked that the world's largest corporations give credit to these resources. Even while against misappropriation in India and other nations without disclosure requirements, the disclosure standards will offer protection international-

Currently, there are disclosure requirements in 35 countries, the majority of which are voluntary and lack the necessary legal framework to be implemented successfully. For the first time, the knowledge and wisdom that have long underpinned

economies, civilizations, and cultures will be recognized by the WIPO treaty on intelproperty, lectual genetic resources, and traditional related knowledge. resources are now part of the global intellectual property there is protection system. "As a source of traditional knowledge and wisdom and a reservoir of biodiversity, India has championed these historic achievements. is a huge victory for India and the nations of the global south," a government official declared. The fact that it took 150 nations and two decades of negotiations to reach agreement is an indicative of the resistance from nations like the US and transnational corporations.

District Courts receive instructions to facilitate smooth case hearings via VC

Delhi: the Delhi High Court directed the national capital's district courts to follow a number of guidelines to guarantee that video conferequipment functions properly during court sessions.

are given to restrict proceedings. According to the ruling, the Principal District & Sessions Judges are required to provide a report on the video conference to the Registrar General's office of this Court using the stipulated format.

Male infertility: Growing Public **Health Concern in India**

GURUGRAM: Infertility is a global health concern, with around 60-80 million couples all over the world facing issues every year, and an astounding 15-20 million of them reside in India alone. Factors include issues like an obstruction of the reproductive tracts (such as ejaculatory ducts and seminal vesicles) due to blockages which causes problems in semen ejaculation, hormonal balances in hormones produced by the pituitary gland, hypothalamus and testicles, or when testicles fail to produce sperm due to conditions that impair sperm-producing cells, and also due to the abnormal shape or quality of sperm that affects its morphology and movement making it harder to fertilize the

female ovum. Also, the

age of marriage has started to increase as couples prioritize their education and career. Most men and women now get married in their mid-to-late thirties and this leads to delayed parenthood. As men age their sperm quality also goes down, this makes it harder for the couple to conceive naturally. In addition to this many common issues men face on the daily also contribute to infertility. Issues ranging from stress, obesity, serious testicular injury or overheating of the testicles over a long period of time. Infertility issues can also be exacerbated by harmful consumption of addictive substances like alcohol or tobacco.

Dr. Priya Varshney, Senior Fertility Specialist, Hospital, Cloudnine Gurgaon says, "Male infertility
