
Rajiv Kumar mocks social media **EVM experts amid laughs**

Kumar took a dig at self-claimed experts using questionable prototypes to display the fallibility of real EVMs and VVPATs on social media, reminding them how the Supreme Court and high courts have heard EVM-related challenges 40 times in the past and rejected each of them.

The CEC said while he agreed for the need of totaliser for EVMs to maintain voter secrecy and that the technology was ready, "as of now even the result of a single EVM is being doubted". "If I were to combine votes of 14 EVMs, people will be even more suspicious," he said and added that time should be allowed for the political system to mature.

Kumar said the technology for migrants from across 72 assembly segments to vote through one EVM had been developed and that EC was ready to start remote voting electronically, "but it takes time to assimilate (new technology)". "Perhaps the time for the idea has not come yet," he conceded. Citing court verdicts upholding EVMs, Kumar said.

In record cut, fuel cheaper by Rs 15/L in Lakshadweep as infra tax ends

NEW DELHI: Staterun Indian Oil on Saturday slashed petrol and diesel prices by up to Rs 15.3 per litre in Lakshadweep islands, marking the sharpest fuel price cut ever in the country. PM Modi backs ED, says agencies given free hand

NEW DELHI: PM Modi on Saturday came out in strong defence of ED and other agencies and said he had given them a free hand to take up cases of corruption, unlike the trend before 2014 when agencies were not allowed to act freely. Asserting that he followed a zero tolerance policy towards corruption, Modi said the drive against graft would be further intensified in his next term. Though a reiteration of his backing for ED, the PM's remarks at a media event were significant because they came in the wake of the opposition's accusation that govt had used central agencies to intimidate opponents and coerce businesses to contribute to BJP's political coffer. The opposition intensified its campaign last week by drawing a linkage between dona-

tions made by a few business houses electoral through bonds and ED's probes facing them.

Modi He dismissed the criticism as a reflection of the anxiety that has gripped many because of his thrust on fighting corruption. "That is why they have taken to abusing me," he said. "Properties worth Rs 5,000 crore were attached before 2014 but in the past 10 properties years, worth over Rs 1 lakh crore have been attached. I never interfered with the working of the agencies and instructions were given to act on merit, the PM said and recalled the seizure of cash from opposition leaders to say that action on this scale was bound to disturb them. Electoral bonds donor list: Co started by Andhra Pradesh farmer's son is living life Megha-size

HYDERABAD: Many in the country's top business and political circles were stunned Thursday night when the electoral bonds donor list, made public by Election Commission of India, featured the Hyderabad-Megha based Engineering & Infrastructures Ltd (MEIL) group, as the sec-

ond-largest donor. MEIL, popularly known as Megha Group, contributed Rs 1,232 crore to political parties between April 2019 and Nov 2023, directly and through associated companies - Rs 966 crore by MEIL, Rs 220 crore by Western UP Power Transmission Co Ltd, Rs 40 crore by SEPC Power and Rs 6 crore by Evey Trans Pvt Ltd. But there



was nothing big about Megha's beginning. The seeds were sown in 1989 by Pamireddy Pitchi Reddy, a farmer's son from Krishna district of Andhra Pradesh. It was nurtured to become one of India's largest construction and engineering players by his nephew, Puritipati Venkata Krishna Reddy. with a small fabrication gradually expanded its

unit, MEE, fabricating pipes for small municipality water projects in the busy by-lanes of Hyderabad's fabrication hub of Balanagar. In early 1990s, Krishna Reddy joined the business and it soon graduated to a contractor for small irrigation and drinking water projects in unified AP in 1996. MEIL's journey began From here, the firm

footprint to states like Rajasthan and Karnataka after 2000 before rebranding itself as MEIL in 2006. Those familiar with Megha Group's journey point out that it took the firm about a decade to hit a turnover of Rs 100 crore and about two decades to cross Rs 1,000 crore. The big acceleration

came between 2010 and 2018, when MEIL

embarked upon a rapid diversification journey, foraying into new states, sectors and countries. This sent revenues hurtling past the \$1 billion mark in 2014-15, the \$2 billion mark in 2016-17 and \$3 billion in 2017-18. In the last 35 years, MEIL has metamorphosed into a Rs 40,000crore turnover multinational conglomerate with a footprint in over 20 countries. From just 4-5 employees in 1989, today it provides direct and indirect employment to over 2 lakh people across 25 firms spanning irrigation, drinking water, oil and gas, EV manufacturing, defence, telecom, railway infrastructure, solar and thermal power, and transport, among others.

NEW DELHI: Delhi's Rouse Avenue Court granted bail to Arvind Kejriwal on Saturday in a case related to him skipping Enforcement Directorate (ED) summonses. The relief to Kejriwal was granted on a bond of Rs 15,000 and a surety of Rs 1 lakh. The ED had filed two complaints seeking Kejriwal's prosecution for skipping multiple summonses in a money laundering case linked to the alleged Delhi excise policy scam. Customs seize over 2.99 kg gold worth Rs 1.72 crore

MUMBAI: Mumbai Customs uncovered nearly 3 kg of gold worth Rs 1.72 crore in five instances at Chhatrapati Shivaji Maharaj International Airport. "On March 14-15, Airport Commissionerate,

Mumbai Customs seized over 2.99 kg of gold valued at Rs 1.72 crore in five different cases Mumbai Customs said in a post on X.

"Gold was found concealed in dates, body cavity, on the body of Pax," it added.

Additionally, they seized 4.22 kg of gold, mobile phones, and laptops valued at Rs 2.35 crore in eight cases from March 10-12 at Mumbai Airport. The confiscated items included various gold jewelry, mobile phones like Samsung Galaxy and iPhones, and Dell laptops. These items were cleverly hidden in bags. The authorities are diligently monitoring such smuggling activities to maintain airport security and prevent illegal imports.

Underwater metro: Phones ready, prayers on lips, Kolkata dives under the Hooghly

KOLKATA: At 7.04am . around 2,000 passengers took the plunge under the Hooghly, cellphone cameras on video mode, prayers on their lips and a feverish excitement in their eyes. As the train approached the under-river section marked by blue LED lights and fish motifs on walls, a deafening roar drowned the recorded voice announcing the momentous occasion. Hundreds of smartphones stayed glued to the windows and the faithful folded their hands in reverence to the holy river as the historic 49 seconds went past in a jiffy. "This is a goosebump-moment. Whoever imagined that a day would come when we would be travelling below the Hooghly that separates Howrah and Kolkata? I am not a very religious person, but experiencing this remarkable engineerfeat ing brings immense joy," said



Gargi Mitra, whose home is a stone's from Eastthrow West's Howrah Maidan station. "I was about nine when construction started at Howrah Maidan. Since then, we have heard about the hiccups, hurdles and milestones achieved. Finally, we are on this Metro. It feels surreal," said 21-year-old Soumya Chatterjee, a student of Narasinha College in Dutt Howrah. Most of those on

Another bid to bring Adyar to life, this time for Rs 4,227 cr

The state government will soon begin a 4,227crore project to restore the 43.9km-long Adyar river by setting up sewage treatment plants and riverside parks. The latest attempt to clean up the river is set to begin in four months, according to Metro Water, which is the implementing agency.

A Mumbai-based company, Khilari Infrastructure Private Limited, along with Chennai-based P&C Projects Private Limited, will restore, maintain, and manage the river for 30 years. Sewage treatment plants to prevent direct sewage outfalls, riverside parks and walkways, and improving the water level and quality will be carried out. The construction work is scheduled to be completed in 30 months. In the 2024–25 state budg et, finance minister Thangam Thennarasu announced 1,500 crore for restoring the Adyar. "The amount is just the capital cost. The rest of the money is for energy, operation, and maintenance of the infrastructure," said Metrowater managing director T G Vinay. A new special-purpose vehicle called Chennai Rivers Transformation Company Limited has been formed to fund, monitor, and coordinate the restoration.

"The Chennai Rivers Restoration Trust will remain the nodal agency to restore Adyar, Cooum,



Kosasthalaiyar, and Buckingham Canal," he added. "This public-private model will be a game changer. We will release the money to the concessionaire only if they satisfy the 14 key performance indicators. Also, a single agency will restore the river. Hence, it will streamline the work done by different departments," said a senior Metrowater official. The key performance indicators include no untreated sewage discharge into the river and water quality maintained as per Central Pollution Control Board standards. Dissolved oxygen, free nitrogen, and biological oxygen demand should be within 10 mg/L each. The dissolved oxygen limit must be within 4 mg/L and the pH must be 6.5 to 8.5. Fourteen sewage treatment plants with a total capacity of 110 MLD will come up at Dr Radhakrishnapuram on Greenways Road, Lock Street East, Chitra Nagar at Kotturpuram, Jothiammal Nagar and Thideer Nagar in Saidapet, Nesapakkam, and Burma Colony.

Priority landing as flyer falls ill

Kolkata: A Kolkata-bound IndiGo flight, 6E 6556, from Ahmedabad made a priority landing around 7pm on Friday after a 64-year-old passenger fell ill inside the aircraft during landing, officials said. The passenger, who had started vomiting and defecating on the seat, was offered necessary medication at the airport before being shifted to a private hospital.

Will run as independent in Shimoga: KS Eshwarappa

SHIVAMOGGA/BENGALURU: Following up on a threat, KS Eshwarappa, former deputy CM and senior BJP functionary, on Friday said he will contest the Lok Sabha polls as an independent from Shimoga segment. The OBC leader's rebellion could pose a serious threat to the party's prospects across the state. Eshwarappa is incensed with BJP parliamentary board member BS Yediyurappa for not securing the Haveri ticket for his son, KE Kantesh. In a mark of retaliation, Eshwarappa now plans to queer the pitch for BY Raghavendra, incumbent Shimoga MP and Yeddiyurappa's son. Raghavendra is BJP's official candidate. Eshwarappa insisted that it is a fight against "dynastic politics and for Hindutva". "It is not against PM Modi," he said. He made the announcement after a nearly two-hour meeting with supporters in Shivamogga. At the meeting, 76-year-old Eshwarappa targeted Yediyurappa's family reiterating that the former CM had "cheated" him. "While Yed iyurappa lobbied for senior BJP functionaries Shobha Karandlaje and Basavaraj, he dumped me," Eshwarappa said.He added: "I am not here for political revenge. Ye diyurappa is a member of the parliamentary board, his younger son is an MLA and elder son an MP who is contesting for the fourth time.

Russian's Reflexive Control theory has alarmed NATO

"If there is no intention to doom the world to the catastrophe of thermonuclear war, then let us not only relax the forces pulling on the ends of the rope; let us take measures to untie that knot. We are ready for this." The Soviet premier's chilling message to American President John F Kennedy during the 13-day Cuban Missile Crisis brought the world to the precipice of a nuclear Armageddon. However, the crisis was averted after an exchange of messages between the two leaders. Khrushchev eventually removed the R-12 MRBMs and R-14 IRBMs with thermonuclear warheads from Cuba and stopped the construction of their launch sites, but his military and diplomatic manoeuvres hit the bullseye. Kennedy promised never to invade Cuba and withdrew the PGM-19 Jupiter nuclear MRBMs from Turkey More than six decades later, Moscow again raised the possibility of a nuclear spectre several times, triggering fears of an "Armageddon" in Washington. Vladimir Putin has threatened the use of tactical nukes during the Ukraine War five times and followed it up with some actions alarming NATO. On 24 February, 2022, the day he launched his "Special Military Operation", the Russian president said, "Any further expansion of the North Atlantic alliance's infrastructure or the ongoing efforts to gain a military foothold of the Ukrainian territory is unacceptable for us." Russia "has a certain advantage in several cutting-edge weapons. In this context, there should be no doubt for anyone that any potential aggressor will face defeat and ominous consequences should it directly attack our country". On 21 September, he repeated his Nthreat . "In the event of a threat to the territorial integrity of our country and to defend Russia and our people, we will certainly make use of all weapon systems available to us. This is not a bluff." On 30 September, Putin indirectly hinted at the use of nukes to protect Ukraine's illegally annexed regions of Donetsk, Kherson, Luhansk and Zaporizhzhia "with all the forces and means at our disposal". In February 2024, when French President Emmanuel Macron didn't rule out the deployment of NATO troops in Ukraine, Putin said, "Everything that the West comes up with creates the real threat of a conflict with the use of nuclear weapons, and thus the destruction of civilisation." This month, Putin said that if American troops are deployed in Russian territory or Ukraine, Russia would treat the move as an intervention. "From a military-technical point of view, we are, of course, ready [for a nuclear war]," he said . In some cases, Putin's actions indicated that he might resort to a tactical nuclear attack. On 27 February, 2022, he put the Russian Army's deterrence forces on high combat alert as top NATO officials were "indulging in aggressive statements directed" at Russia. On 25 March, 2023, Putin announced plans to deploy Russian tactical nukes in Belarus . In March 2024, Russia tested the nuclear-tipped RS-24 Yars ICBM, which travels at Mach 14 and has a multiple independently targetable re-entry vehicle.m One month after Putin's September 2022 threat, US President Joe Biden reacted on expected lines. "We have not faced the prospect of Armageddon since Kennedy and the Cuban Missile Crisis," he said CNN's chief national security analyst and anchor Jim Sciutto's book The Return of Great Powers, released this month, claims that an "analysis and highly sensitive new intelligence" showed that Russia wanted to use a tactical nuke against Ukraine in 2022. Sciutto claims that a senior US administration official told him that the fear wasn't "just -hypothetical" but "based on some information that we picked up".

Continuity and change in India's foreign policy: PM Modi's diplomacy

India's foreign policy, as of other countries, is determined by certain permanent factors, as for instance, its size, resources, geographical location and its neighbourhood. Other factors are its understanding of national interest, its historical experience, the composition of its population, its capacity to defend itself, the quality of its leadership, its self-image, and the existence of internal lobbies.

National interest in a broad sense can be defined: peace, security, economic development, prosperity for the people, a friendly neighbourhood. But this is not dependent only on national will. The interests of other countries can conflict with the interests of another; the world is becoming interdependent and so instability elsewhere can have a wider impact. A conflict can be inflicted on a country despite its interest in maintaining peace. Its security can be threatened by a powerful neighbour. The definition of national interest is thus subject to variables. India is one of the biggest countries in the world, an old civilisation, it has a self-image of a country that cannot subordinate itself to others and should have an independent role in international affairs.

Having emerged from colonial subjugation, it could not align itself with the West and give it control of its foreign policy. It chose to be nonaligned during the Cold War. This basic foundation of India's foreign policy is reflected today in its attachment to strategic autonomy, friendship with all to the extent possible, and balancing its external relations to increase its freedom of choice. The international situation is not static and therefore changes that occur require adjustments in foreign policy. Take for instance the collapse of the Soviet Union with which we had very strong ties. It was our biggest trade and defence partner. It played a vital role on our behalf on the Kashmir issue in the UNSC and in the 1971 war that led to the creation of Bangladesh. During the period of US uni-

lateralism when we were subject to huge pressure by the US on Kashmir, human rights, our nuclear and missile programmes, we became part of the RIC dialogue which later evolved into BRICS as a balancing act, even as we also began to improve our ties with the US in the context of the new geopolitical realities. We have persevered in maintaining close ties with Russia, with regular annual summits from 2000 onwards till 2021. Russia has never imposed sanctions on us. We have resisted western sanctions on Russia. We bought the S 400 air defence system despite the threat of secondary US sanctions. We have desisted from condemning Russia's military intervention in Ukraine. Russia has become our biggest oil supplier. All this while our ties with the US have become stronger, with defence trade with Russia declining and that with the US, France and Israel increasing. An increase in a country's economic growth helps in the pursuit of a more active foreign policy. China's case is instructive. As it has grown economically, it has acquired the economic and financial muscle to pursue a more assertive foreign policy,

tary muscle. India too is rising economically, and as it becomes a \$5 trillion economy and beyond, its ability to pursue its interests on the global stage will increase. Already, India is acting more confidently on the international stage, having become the 5th largest economy and set to become the 3rd largest before 2030. India is today being engaged by foreign powers as never before. The US president says that the relationship with India is a defining one in the 21st century. President Putin pays lavish compliments to Modi and India, stating that India under Modi pursues its national interest and resists pressure to the point that it has even surprised Putin India's foreign policy has been deeply affected by its partition and the creation of Pakistan which has tried to undermine India internally and externally since its creation, with war, terrorism, religious mobilisation of the Islamic world against us, and constantly internationalising the Kashmir issue. India has been on the defensive for decades on the Kashmir issue, accepting, in particular, US and UK interference on Pakistan's behalf. This defensiveness explains why despite continuous provocations from Pakistan, India has engaged Pakistan in a dia-

beside strengthening its mili- on our Parliament and the horrific Mumbai attacks, with a willingness to accept the inclusion of Kashmir as an agenda item in our composite dialogue. Former Prime Minister Vajpayee went to Lahore, Prime Minister Modi invited Nawaz Sharif to his swearing-in ceremony in 2014, and later made an impromptu visit to Lahore in 2015. 
Sebi approves trial run of same-day stock settlement

MUMBAI: Markets regulator Sebi on Friday said that it would soon start a pilot project for moving to a T+0 settlement regime in the stock market on an optional basis, limited to 25 stocks and with a select few brokers. The board will again review the roll-out after three and six months from the date of introduction of this proposed faster settlement system. Sebi in its board meeting that lasted till late evening also decided to ease certain disclosure requirements for foreign portfolio investors (FPIs), expanded the definition of promoter groups to determine promoter holding levels post and IPO, done away with security deposit requirement for public and rights offer of equities. It also directed to put in place specific rules to deal with market rumours, especially that impact a company's stock price and eased some of the rules governing alternate investment funds (AIFs), Sebi said in a release post its board meeting. The Sebi board also approved a proposal to exempt



additional disclosure sale proceeds as penalrequirements for FPIs having more than 50% of their India equity portfolio in a single corporate group but the holding is in a listed company with no identified promoter. However, this exemption would come with certain conditions like the aggregate holdings of all such FPIs is less than 3% of the company's equity capital. Pilots' deaths a wake-up call; can't defer new rostering rules for safety reasons,' **DGCA firmly tells airlines**

NEW DELHI: The Directorate General of Civil Aviation has declined to give airlines more time to implement the revised pilot duty hour norms which are aimed at improving safety by ensuring a fatigued and overworked pilot is not operating your flight. While airlines have said implementing the new flight duty time limitation (FDTL) norms that increase their pilot requirement from the mandated June 1, 2024, deadline will mean cutting flights, the Vikram Dev Duttheaded regulatory body has reiterated that flight safety is paramount. "The unfortunate instances of pilot deaths in the recent past ostensibly due to punishing roster schedules and consequent cumulative attendant impact on flight crew health and wellbeing is an urgent wake up call to address these issues without further delay... revised FDTL scheme has alleviation of flight crew fatigue as a core philosophy to achieve the intended objective of enhanced flight safety," the DGCA has told the Federation of Indian Airlines (FIA) in response to the latter's request seeking extension of the deadline for implementing the revised norms. "Our paramount objective is to ensure the safety of the skies... all airlines (should) harmonise their operating policies in tune with this overarching objective... all airlines (should) take all necessary steps towards rollout of the revised FDTL (rules) from June 1, 2024. US court bars Byju's from using \$533mn it borrowed

MUMBAI: In a major setback for troubled startup Byju's, a US bankruptcy court has passed an order in favour of the edtech company's term loan lenders, disabling the firm from transferring or using \$533 million received as part of loan proceeds, essentially freezing the assets.

Fee dispute: CCI to probe Google's app billing policy

MUMBAI: The Competition

Commission of India on Friday ordered a probe into Google's Play Store billing policy, which has been at the centre of the tech giant's dispute with local app developers who claim that it is discriminatory in

nature. In its 21 page order, the fair trade regulator observed that the revenue distribution model within Play Store appears to be skewed in favour of Google, with app developers potentially facing substantial costs. Reviewed a FM, copy of the order. The CCI said that it is of the view that prima facie, Google has imposed unfair price in violation of the Competition Act which warrants a detailed investigation. It has directed the Director General to complete the investigation and submit a



consolidated investigation report within 60 days. The CCI's recent order came in response to fresh complaints filed by Interactive People India which runs Shaadi.com, Mebigo Labs which owns Kuku Indian Broadcasting and Digital Foundation and Indian Digital Media Industry Foundation. In a statement, Google said that it is examining CCI's order. "The CCI had previously examined our service fee in detail between 2020 and 2022 and found no illegality. However, we take our

commitment to comply with local laws and regulations in India seriously and will cooperate with the process in every way,"

the company said. "Service fee charged by Google has been alleged to be excessive in nature and by requiring the app developers to pay such excessive service fee for processing payments through GPBS (Google Play Billing System) as well as ABS (Alternative Billing Systems) under UCB (User Choice Billing), Google is alleged to be imposing an unfair price....

World Bank maps out plans to further boost lending by \$100 bln-plus over a decade

WASHINGTON: The World Bank on Thursday proposed steps that would boost its lending to developing countries by an additional \$100 billion over a decade as part of an ongoing reform process aimed at helping the bank expand its mission to include climate change.

In a 24-page report to the joint ministerial committee that oversees the bank and the International Monetary Fund, the bank's management said it would ask shareholders to approve a hybrid capital measure and a new portfolio guarantee platform that together could boost lending by over \$100 billion.

That amount would come on top of measures already being implemented that will boost the bank's lending to developing countries by up to \$50 billion.



ED takes custody of tout **Hiren Bhagat in PMLA**

MUMBAI: There is more trouble for tout Hiren Romi Bhagat who along with his accomplices impersonated as officers of Enforcement Directorate (ED) threatened a developer and tried to extort Rs 164 crores. The special Prevention of Money Laundering Act (PMLA) court granted permission to the ED Mumbai office to take the custody of Bhagat, who is currently lodged in Arthur Road jail in connection with extortion cases. ED officials on Friday also intimated the 37th Metropolitan Magistrate regarding Bhagat's production warrant and late evening took Bhagat's custody from Arthur Road jail. The ED's probe is based on an FIR filed by the Mumbai crime branch against Bhagat and five others - Rajendra Shirsat, Rakesh Kedia, Kalpesh Bhosle, Avnish Dubey and Amesh Sawekar – who were arrested in December and Bhagat apprehended on January 21. Among the items seized are 13 kg of gold, 15 of the most expensive watches including Patek Philippe, foreign currencies equivalent to Rs 50 lakh, cash amounting to Rs 1.5 crore, documents relating to 18 high-end cars, property papers of 10 flats, and three automatic weapons: one MP-5, Beretta Tomcat, and Russian CZ-Scorpion. Additionally, extensive documents pertaining to the cases of EOW and ED have been found in searches of Bhagat's house and four bank lockers. The ED last week conducted searches at multiple locations in Mumbai on Thursday in connection with a Prevention of Money Laundering Act (PMLA) case registered against Hiren Bhagat as well Amey Sawekar. The ED case is probing the money laundering angle as huge amounts of cash, gold and immovable properties have been seized from Bhagat's house search.

Guidelines issued to make campuses inclusive for transpersons

MUMBAI: In an effort to make college campuses more inclusive, the state govt has for the first time come out with detailed guidelines for transgender students. Initiating action against colleges for refusing admissions on the basis of gender, reserving a section in hostels for transgender students and establishing cells to address issues of discrimination, mental harassment, sexual exploitation or any other violence against them, are some of the guidelines enlisted in the government resolution (GR) on Friday. The GR has come close on the heels of the govt's first-ever policy for transgender individuals approved by the cabinet earlier this week.

In December last year, the department had asked colleges and



universities to offer free-of-cost education to transgender students and bear their entire

tuition fees. Institutions have been asked to strictly follow the fee waiver policy in the new guidelines. These are in line with the National Education Policy, 2020, that speaks about making campuses inclusive for all students. A govt official said the department's policy was ready and since the state came out with its overarching policy, they also decided to release specific guidelines for higher

education institutions. To cater to the needs of all transgender students, colleges are expected to appoint coordinators to provide counselling, academic guidance and career advice. All nonagricultural universiprivate and ties, deemed universities and affiliated colleges in the state are expect-

ed to strictly follow the provisions of The Transgender Persons (Protection of Rights) Act, 2019, stated the guidelines.

Institutions need to adopt an inclusive policy to tackle issues of gender bias, negligence and segregation based on sexuality, it added. ensure equal opportunities for these students, institutions should organise awareness activities for both students teaching/nonand teaching staff.

Cattle traders 'forced to pay protection money', lodge plaint

MUMBAI: The cattle traders have lodged a complaint that despite paying all the government taxes, including cattle taxes, they are forced to pay "protection money" to the goons on the highway. Adil Kathawala, a cattle trader, has lodged an FIR at Deonar police station against four persons, including two transporters who threatened them to book them in false cases and extorted Rs 60 per cattle every time they transported goats to Karnataka traders.

The Deonar police have booked Ganesh Nakate, Vinod Nakate, and Pratik Nanaware, who had been extorting money from the cattle traders for several months.

The cattle traders have been regularly paying



the protection money of Rs 60 per goat to transport them out of Mumbai. However, trouble started in January when the extortionists stopped one of Kathawala's trucks carrying 196 goats at Kalamboli in Navi Mumbai for six hours, leading to the death of nine goats, causing a huge loss to the trader. The trader decided not to pay them.

Despite the losses incurred, the extortionists kept calling, threatening, and demanding money, irked the which traders. All traders decided to protest and lodge a complaint, said police official. а Kathawala, in his complaint, alleged that he has been in the cattle trade business since 1997 and supplies cattle to various other parts of the state at

wholesale rates. The cattle traders knew the risks involved in challenging the extortionists, who had until then operated with impunity. However, the traders also recognized the importance of standing up for their rights and the need to send a strong message that they would no longer tolerate such exploitation.

"Karnataka butchers who often come to Deonar abattoir to buy goats decided that we will send them goats, and they will pay for the transportation. So four to five traders supplied them with goats. Six months back, we engaged Nakate and Vinod Nakate for transporting goats to Karnataka. One truck carries around 200 goats at one time

LG nod for special zones at IGI Airport

New Delhi: LG VK Saxena has given the nod for setting up a Special Economic Zone (SEZ) and Free Trade Zone (FTZ) at Indira Gandhi International (IGI) Airport in the capital.

'Eliminate dirty cash but also protect donor privacy', says poll body chief

NEW DELHI: Chief Election Commissioner Rajiv Kumar, while reiterating that Election Commission is all for transparency, acknowledged the need for an institutional mechanism to control "unaccounted" money in donations that also protects donors' privacy and ensures they are not harassed for contributing to a certain political party. Responding to a question on electoral bonds at the EC press conference here, Kumar said there is no scope in a democracy for hiding things. "We (at EC) are all for transparency. (But) the country now has to find solutions through an institutional mechanism where a donor's privacy is also considered," he said.

In a landmark verdict on Feb 15, Supreme Court had scrapped Centre's electoral bond scheme that allowed corporate donors anonymity. It ordered EC to publish names of donors, the amount donated by them and their recipients. EC has since complied with the direction.

But Kumar on Saturday voiced his fear of unaccounted money making a comeback in political funding with the demise of bonds. "The unaccounted money which is used in elections... during elections, we are very particular to control it. But how we also control donations in the unaccounted form is something on which the entire nation should work...(such that) the donor's privacy is also protected and he is not harassed. How it (donation) is more and more white," he noted.


Bizman sold fake artworks: ED raids 6 sites, says evidence of cartel found

MUMBAI: Enforcement

Directorate (ED) conducted searches at six locations in Mumbai as part of a money laundering case involving art dealer Rajesh Rajpal, solicitor Vishwang Desai, and others who were accused of selling fake artworks.

ED said it has found evidence which showed operations of a cartel engaged in trading of fake artwork, generation of fake authenticity and provenance certificates, transfer of money through cash and involvement of other prominent art galleries and individuals.

ED said the cartel involved an art gallery in Mumbai, a corporate lawyer and bullion traders. Fake replicas of original paintings by renowned artists such as Jamini Roy and M F Husain



were being passed off as authentic with the help of fake certificates; and transfer of payment was done through hawala. The probe exposed a network of individuals claiming fake origins and creating counterfeit art pieces. Money trail revealed that proceeds from selling fake artwork were sent through domestic hawala to cartel members as commissions free/discounted or

artwork. Some cash generated was used to purchase antiques in collaboration with bullion traders and then sold in auctions through reputed auction houses, proceeds which of were received in bank accounts.

The case is based on an FIR registered by Tardeo police on complaint of India head of US-based private equity firm TPG Capital, who alleged purchas-

fake paintings ing worth Rs 17.9 crore from leading Indian artists.

Complainant, Puneet Bhatia, said he bought 11 paintings of various painters, including M F Husain and S H Raza. Bhatia's friends told him that the paintings appeared to be fake, and he approached a private agency which, upon inspection, informed him that signatures on the paintings were fake.
