### 'Disappointing, condemnable but not ... ': India on fugitive Zakir Naik's Pakistan visit

**NEW DELHI:** The central government on Friday reacted to controversial Islamic preacher Zakir Naik's Pakistan visit, calling it "disappointing and condemnable but not surprising". Naik, who is wanted in India for hate speech and terror-related charges, was warmly welcomed in Islamabad on October 1 for his month-long visit.

"We have seen reports that he (Zakir Naik) has been fitted into Pakistan and warmly welcomed there. It is not surprising for us that an Indian fugitive has received a high-level welcome in Pakistan. It is disappointing and condemnable but not sur-Randhir prising," minister of Jaiswal, affairs external spokesperson told media at a press brief. Naik, who has lived in exile since 2016, also met Pakistan Prime Minister Shehbaz Sharif, who praised him for his "insightful and impactful" lectures on Islam. He was born on October 18, 1965, to Abdul Karim Naik and Roshan Naik in Mumbai. He attended Kishinchand Chellaram College and then studied medicine at the Topiwala National Medical College, where he obtained a Bachelor of Medicine and Surgery (MBBS)

Naik attended South African Islamic preacher Ahmed Deedat's lecture in the late 1980s.



#### **Climate Policy Initiative**

It was only in 2022 that developed countries provided and mobilised \$115.9 billion in climate finance for developing countries. By the end of COP29, all parties must agree on a "new collective quantified goal" (NCQG) to guide the provision of climate finance, intended to replace the \$100 billion target after 2025. Progress on negotiating the NCQG has been slow. Disagreements persist on almost every aspect of the new target, including the amount of money to be provided, the sources of these funds, the recipients, and the specific forms of financial assistance. Current climate finance is grossly inadequate for the scale of action required. The \$100 billion target for climate finance is laughably insufficient. The United Nations Environment Programme (UNEP) Adaptation Gap Report 2021 estimates that the costs of adapting to climate change in developing countries could reach \$140-300 billion per year by 2030, escalating to \$280-500 billion per year by 2050. Furthermore, the Climate Policy Initiative (CPI) Global Landscape of Climate Finance 2021 report highlights that global climate finance flows reached a record \$632 billion in 2019/2020. Despite this record, the funding falls significantly short of the \$4.13 trillion annual investment required by 2030 to meet the Paris Agreement targets, as estimated by the International Energy Agency (IEA) in its Net Zero by 2050 report. Now even these estimates are seen as low. As highlighted by the Independent High-Level

Expert Group on Climate Finance in their November 2022 report, emerging markets and developing countries (excluding China) are staring at a financial chasm. These nations must mobilise approximately \$1 trillion annually by 2025, amounting to 4.1 per cent of their GDPdouble the 2.2 per cent spent in 2019. Fast forward to 2030, and the figure balloons to a staggering \$2.4 trillion per year, or 6.5 per cent of GDP. This glaring disparity underscores the urgent need to recalibrate climate finance targets.

if we are to meet the colossal demands of climate adaptation and mitigation. According to the Intergovernmental Panel on Climate Change's AR6 Synthesis Report on Climate Change 2023, the 2018 UNFCCC biennial assessments and the IPCC 1.5°C report estimated that global financial needs for achieving a 2°C warming target are \$1.7 trillion annually from 2020 to 2030-2035, and \$2.4 trillion annually for the 1.5°C target, specifically for the energy sector. The report concludes that global climate finance flows must increase by three to six times the current levels to meet the average annual financial requirements until 2030. This cannot happen in the absence of reforms in multilateral development banks (MDBs). A high-level expert group established by the G20 under India's presidency has proposed a 30point roadmap to reform multilateral development banks (MDBs) and triple their lending by 2030. The Independent Expert Group, led by former US Treasury Secretary Larry Summers and India's 15th Finance Commission Chairman NK Singh, emphasized urgent action to scale MDBs to be "fit for purpose" by 2030. Their report, 'The Triple Agenda: A Roadmap for Bigger, Bolder and Better MDBs', advocates for tripling MDBs' sustainable lending limits, introducing new financial instruments like pooled portfolio guarantees and hybrid capital, and attracting private investors. The report underscores the urgency of these reforms, warning against delays and weak responses, and sets a target of increasing MDB financing to \$390 billion annually by 2030. It also suggests establishing a pilot Global Challenges . Funding Mechanism (GCFM) attract additional to resources from various investors for priority goals.



"India has considered it its responsibility to place the priorities and concerns of the countries of the Global South on the world stage," he said. At the same time, while putting forward his vision of a developed India in 2047, he emphasised that "no section of society should be left behind in the country's development journey," followed by applying this "in the context of

international relations. The countries of the Global South are bearlongstanding sions". Then, Modi put forward the concern of ending monopolies in technology, one of the points of action at the end of the second Voice of the Global South Summit. On the sidelines of the G7 meeting, PM Modi also met Ukrainian President Volodymyr Zelensky. However, Modi skipped the Ukraine Peace Summit, organised just after the G7 meeting, by sending a secretarylevel delegation. The Indian delegation visited the summit but didn't sign the Joint Communique. This reflects a nuanced stance on the conflict, aligning with the broader Global South's cautious approach. 

# Next for Ayush 2021-2022 to improve Ayurveda education and healthcare

Delhi: Shri Prataprao Jadhav, Union Minister of State for Ayush (Independent Charge), said today that the National Exit Test (NExT) for Ayush will begin in 2021-2022. The Minister said the decision was based on the committee's suggestion to investigate student concerns. The committee suggests applying the NExT to 2021-22 students under the NCISM and NCH Acts, 2020, eliminating any ambiguity. The committee was led by Vice Chancellor National Institute of Ayurveda, Jaipur Prof. Sanjeev Sharma, who reviewed student ideas and submitted them to the Ministry. After a one-year internship, the problem-based test is required for licensing and membership in State or National Registers. It evaluates practical skills using clinical case scenarios, photos, and videos. Without completing their internship, interns who pass the National Exit Test (Next) can only register with a state or national registration board after one year. After several Ayush students expressed concerns about NeXT, the Union Minister of State (IC) for Ayush met with BAMS/BHMS students to discuss the NCISM & NCH NeXT exams.

The National Commission for Indian System of Medicine (NCISM) Act 2020 and National Commission for Homoeopathy



(NCH) Act 2020 took effect on June 11 and July 5, 2021. National Commission for Indian System of Medicine (NCISM) Act 2020 and National Commission for Homoeopathy (NCH) Act 2020 mandate the Commissions to undertake the National Exit Test (NeXT) within three years of enforcement. In collaboration with Inter University Accelerator Centre (IUAC), New Delhi, IIT Delhi, and Miranda House, DU, Shyam Lal College, University of Delhi (DU), held the 'National Summer School & Workshop on Semiconductors: Hands-on Training Undergraduates' to train BSc in Physics, Chemistry, Physical Sciences with Electronics students from Khalsa College, Acharya Narendra Dev College, Miranda House, Amity College, and Galgotias University. According to Pradeep Kumar Sharma, assistant professor of physics at Shyam Lal College, semiconductor technology like layout design and manufacture require technical skill and knowledge of electronic circuits and electronics basics, among other engineering courses. Due to the growing requirement for qualified workers, non-engineering students must learn semiconductor technology. This will increase student interest, improve their CVs, and encourage them to pursue a profession or research in the field in their master's degrees. Several departments teach Semiconductor Physics, Diodes, and Transistors to science undergraduates. "The subjects are not offered in the industryrequired format. Some semiconductor-related topics are offered in one department and others in another.

#### Rush at OPDs as heat soars, doctors sound dehydrationexhaustion alert

KOLKATA: The hot and discomfort weather conditions in the past few days are taking a toll on the health of Kolkatans, especially those who have to remain outdoors for hours. Even though none of the city hospitals have recorded any heat stroke cases so far, doctors are getting a good number of people with heat exhaustion and dehydration. Health experts have cautioned people to take all precautions when outdoors to avoid severe consequences.

"Because of such hot and humid weather, the people who are engaged in outdoor activities are prone to develop heat exhaustion when the body starts sweating a lot due to the rise of the core body temperature resulting in dehydration.

Heat exhaustion makes the person feel weak, dizzy and thirsty. I have seen two to four such cases in the past one week, mostly middle aged men, probably due to their higher exposure to the sun," said internal medicine specialist Joydeep Ghosh of Fortis Hospital, Anandapur. opd

B P Poddar Hospital had tended to 14 persons in its emergency in the past three days, most of them down with extreme dehydration making them unwell while they were out in the sun. "37 patients came to our OPD with heat related issues. While most of them were middle-aged patients, some were school children. We had to admit two senior citizens because in addition to dehydration they had other issues like BP fluctuation and sodium, potassium imbalance," said Supriyo Chakrabarty, group advisor, BP Poddar Hospital.

# 2 calves born in Kashi farm mark new start for Gangatiri breed

LUCKNOW: UP govt's Varanasi farm has become the country's first conservation centre to breed two high-merit Gangatiri cow calves using embryo transfer technology (ETT) and IVF. The two female calves were born on March 26 and 27.

Gangatiri breed is native to eastern UP and Bihar. It got its name after Ganga as it is the belt along the river which is its natural habitat.

The breed has low input costs and is resistant to many diseases."Gangatiri is recognised nationally and has high significance as a source of livelihood to local farmers in the state," said Dr Neeraj Gupta, CEO of the UP Livestock Development Board. The ETT will help produce elite cows at a faster rate as a single mother can produce multiple highmerit progenies, he added. In the current case, four elite females at the farm were selected as egg donors. Semen from a high-merit bull was used to fertilise the eggs in-vivo (inside the body).

After about seven days, the embryos were flushed from the donor cows and transferred into four surrogate cows, which may not have been of high merit. However, only two pregnancies were successful, and two calves were born, said Gupta. The ETT is being extensively used for the improvement of indigenous cow breeds at var-

ious places as elite cows are used as egg and sperm donors.

"This technique will increase the efficiency as well as productivity of Gangatiri bovine herds . It has huge potential to multiply the income of farmers," said Ravinder, principal secretary of animal husbandry, dairying and fisheries, and chairman of UPLDB.

# Cong to review 'anti-people laws', says Ramesh, mum on CAA repeal

Congress general secretary (communications) Jairam Ramesh on Friday said the party's position on Citizenship Amendment Act (CAA) was clearly stated in its manifesto where it promised to "review and change all anti-people laws" brought by BJP govt. 1.3 crore mutual fund accounts on hold owing to insufficient KYC

Delhi: KYC registration entities report 1.3 crore mutual accounts 'in hold' due to incomplete KYC. This is because people gave non-Aadhaar and non-OVDs during KYC registration. From April 1, 2024, SEBI will prohibit mutual fund transactions for investors having 'on hold' KYC status. This buying or involves redeeming mutual fund units. "After many investors' KYCs were still unupdated with PAN and Aadhar and the linkages were missing, KYCs had to be reclassified. Several of these KYCs used utility bills (electricity, telephone), bank account statements, etc., which Sebi no longer accepts." The report added, "7.9 crore investors (73%), have valid KYC. About 1.6 crore registered investors have limited investment access, and 12% can't manage their demat accounts and MF folios." KYC-verified status:.
