ED arrests Soren an hour after party names his CM successor

was arrested in a land scam by Enforcement Directorate (ED) on Wednesday, becoming the first sitting chief minister of Jharkhand to be taken into custody in a corruption case. Hours before he was whisked away by ED officials, Hemant handed over his resignation to governor CP Radhakrishnan around 8.30pm, even as the governing Jharkhand Morcha announced the name of his close aide and minister transport Champai Soren as the next CM. The arrest was a finale of the the cat-and-mouse game played by Hemant with the central agency for the last two days over his questioning in the alleged money laundering in a land scam that involved transfer and settlement of land parcels by forging records and documents. A consensus could not be reached over the name of



Soren for the top post due to a family feud, with his sister-in-law and three-term MLA Sita Soren opposing her name, sources said. This led to six-term MLA Champai emerging as Hemant's successor. Equipped with a letter pledging support of 47 MLAs to Champai in the 81-member house, the governing coalition sought an appointment with the governor.

However, till the time of going to press, the governor had not met the governing coalition and was silent about giving them an audience. JMM leaders said that in case the governor refused to meet the coalition members, they are prepared to parade the MLAs before the Rai Bhavan

and demonstrate their strength. "We are ready for a floor test as per time allowed by Raj Bhavan but before that, it has to pay credence to the fact that even after Hemant's resignation, the existing coalition enjoys a majority," said a JMM leader. Earlier, flanked by ED sleuths, Soren went to Raj Bhavan, sporting a smile, and was taken

away soon after he

submitted his resigna-

Later, JMM filed a case

in high court, challenging his arrest. Nearly three hours after Hemant submitted his resignation, he tweeted from his X handle @HemantSorenJMM: "...haar manunga nahin (Will not accept defeat)." Ahead of the resignation, ED made elaborate security arrangements to counter any backlash from Soren's supporters.

In what would come as a significant blow to its operations, Paytm has been barred by RBI to onboard new customers and not accept deposits across many of its services. Following a thorough system audit report and subsequent compliance validation by external auditors, the Reserve Bank of India (RBI) has imposed restrictions on Paytm Payments Bank, effective February 29. Paytm Payments Bank Ltd (PPBL) will no longer be permitted to accept deposits or top-ups in customer accounts, prepaid instruments, wallets, or FASTags. "Withdrawal or utilisation of balances by its customers from their accounts including savings bank accounts, current accounts, prepaid instruments, FASTags, National Common Mobility Cards, etc. are to be permitted without any restrictions, up to their available balance," the RBI said in a statement said.

Why an 'invitation to tea' is cause for fear in China

NEW DELHI: An invitation to a cup of tea is usually a cause for happiness, but in China the phrase has taken on a vastly different connotation. In a country where political elites, ministers and prominent public figures can 'disappear' overnight without a trace -- only for Beijing to disclose weeks later that they are embroiled in an anti-corruption or security case -- Chinese netizens have come up with creative ways to discuss disappearances without incurring the wrath of the authorities.'Invitation to tea'

For years now, Chinese netizens have used the phrase 'invitation to tea' as an euphemism for 'someone being summoned or investigated for suspected illegal activities by law enforcement departments', said a South China Morning Post (SCMP) report. The usage has become so widespread China's Ministry of State Security recently acknowledged usage by releasing a list of '10 Cups of Tea' basically ten offences that will invite investigation from intelligence agencies.

Delhi: The government of Delhi will request funding in the next budget to build a highsecurity jail in Narela. The jail's layout is modeled after Cellular Jail in the Andaman and Nicobar islands. Given impending Lok Sabha Elections, the Delhi budget, which is typically given in mid-



March, will be delivered between February 15 and February 20 this year. According to a top government official in Delhi, the department would insist on the funding for the jail. The official stated that the Delhi government is required to cover

Delhi: With Lok Sabha polls round the corner, the Centre has stepped up enrolment under the Ayushman Bharat -PM Jan Arogya Yojana or AB-PMJAY - the flagship health scheme of the BJP-led government which intends to provide health coverage of Rs 5 lakh to over 60 crore beneficiaries identified based on select deprivation, and occupational criteria, in rural and urban areas respectively, as per SECC database of 2011. As on Jan 12, 30 crore intended benefi-



ciaries have been issued Ayushman cards, according to government data. "Ayushman card creation is the most fundamental activity under AB-PMJAY, and concerted efforts are being continuously made to ensure that beneficiary every under the scheme has Ayushman card. As a

result of the persistent efforts, the scheme has reached the feat of 30 crore Ayushman cards created. More than 16.7 crore Ayushman cards have been created only during the last two financial years, government said. In a statement issued, the health ministry said, 14.6 crore women been issued Ayushman cards. With 4.83 crore Ayushman cards, UP tops the list of states with the highest number of cards issued.

GRAP Stage-3 limitations lifted as Delhi pollution improves



Delhi: Commission for Air Quality Management (CAQM) subcommittee revoked Stage-3 of GRAP in the Delhi-NCR with immediate effect, halting construction and demolition except for essential government projects, mining, and stone crushing, and banning BS III petrol and BS IV diesel vehicles in Delhi and surrounding areas. "AQI of Delhi has been progressively improving and has been recorded as 316 at 2.00 pm, which is about 85 AQI points below the threshold for invoking the Grap Stage III actions (Delhi AQI 4 0 1 - 4 5 0) . Preventive/mitigative/restrictive actions under all Stages up to Stage III are underway, so there is likelihood of

sustaining improvement," CAQM said. Added: "The forecast by IMD/IITM also do not indicate any significant deterioration and there is a likelihood of the AQI improving remaining in the lower end or very poor category in the next few days."The GRAP Stage-3 limits immediately activated across Delhi-NCR after air suddenly quality deteriorated Sunday. The region invoked limits three times this winter. CAQM began Stage 3 actions on November 3 after AQI exceeded 400 for the first time this winter (402). After rain lowered the AQI below 300 on November 29, the restrictions were lifted 27 days later.

Cost-effective prosthesis to restore their voice

NEW DELHI: In what could prove to be a boon for patients who have lost their ability to speak due to throat cancer, All India Institute of Medical Sciences, in collaboration with IIT Delhi, has developed a cost-effective prosthesis to restore their voice. According to doctors, many throat cancer patients are unable to speak after the removal of their larynx due to advanced stages of laryngeal disease. Larynx, or voice box, contains vocal cords and helps a person speak, breathe and swallow. A study conducted on 20 patients over three years has yielded positive outcomes, said AIIMS doctors. Until now, patients have been implanted with commercially available voice prosthesis costing between Rs 20,000 and Rs 40,000. However, the AIIMS-IIT prosthesis is free of cost for AIIMS patients. Following successful trial completion and approvals, it may be made available for other patients and could cost a few hundred rupees. Dr Alok Thakar, head and professor of otolaryngology and head/neck surgery, said the aim of developing the device was to ensure patients who lost their voice due to cancer in the larynx can speak again without shelling out thousands of rupees on an artificial voice box. "During the tracheoesophageal puncture (TEP) procedure, we create a small hole in the wall between the trachea and esophagus, the tube that moves food from mouth to the stomach. A small one-way valve, called tracheoesophageal prosthesis, is placed inside the hole to direct air into the throat," he said, adding the valve is made of silicon.

He said the vocal cords are completely removed during total laryngectomy surgery and the sound source is lost. The TEP surgery with a prosthesis creates a path for air to move from lungs to the esophagus. This air causes the top of the esophagus to vibrate, producing a new tracheoesophageal voice, he explained. The device, weighing a few grams, enables throat cancer patients who had their larynx removed

Prof Rakesh Kumar from the ENT department said on an average, annually four-five out of 25 patients suffering from larynx cancer face voice box removal risk. Usually, cancer occurs in the 50-60 age group.

"It's not difficult to learn how to use the prosthesis. After surgery, patients just need guidance and practice. The prosthesis valve lasts sixeight months on an average. The replacement procedure doesn't require surgery. It is usually painless and can be done in OPD," he said. Doctors said TEP's main advantage is it gener-

ates the most intelligible, fluent and natural voice compared to other alaryngeal speech methods.

3 Telugu inscriptions on Gyanvapi mosque walls shed light on mandir



HYDERABAD: Archaeological Survey of India's epigraphy wing in Mysuru found three Telugu inscriptions on the walls of Gyanvapi mosque in Varanasi.

A team of experts led by ASI director (epigraphy) K Muniratnam Reddy deciphered 34 inscriptions, including the three in Telugu, submitted a report on the exis-Kashi of Vishwanath temple. Muniratnam told that one of the inscriptions, dating back to 17th century, clearly mentioned names of individuals like Mallana Bhatlu, of Narayana

Bhatlu. "It is interesting to note that Narayana Bhatlu is a Telugu Brahmin who supervised the construction of Kashi Viswanatha temple in 1585. It is said that Hussain Sharqi Sultan of Jaunpur (1458-1505) ordered the demolition of Kashi Viswanatha temple in the 15th century. The temple was reconstructed in 1585. Raja Todarmal is said to have asked Narayana Bhatlu, an expert from south India, to supervise the temple's con-

struction. The present inscription supports the above Muniratnam

explained.

"This inscription is engraved on a wall of Gyanvapi mosque and it written in Telugu language. Though it is damaged and incomplete, it mentions Mallana Bhatlu and Narayana Bhatlu," the ASI director said.

The second Telugu inscription, which was found inside the mosque, made a mention of a 'govi'. Govis are shepherds.

The third inscription, dating back to the 15th century, was found by the ASI experts at the main entrance on northern side of the mosque. It has 14

How Indian education could benefit from more equitable, comprehensive?

Education is the pillar of economic growth. In developed countries in the West, investments made in education and related infrastructure especially during the middle of the previous century - have played a critical role in the overall development of these countries. In India, the most significant overhauls of the education system were undertaken in 2020, 1986, 1968 and 1948. Today, the Indian education system is considerably larger than it was in 1950. Back then, we had 20 universities, 496 colleges, and approximately two hundred thousand students enrolled in higher education. Today, India has more than 1,150 universities, 43,000 colleges, and 41.14 million students enrolled in higher education! Yet having so many students enrolled in higher education has led to a crisis the crisis of numbers. Consider that today, the US spends approximately 6 per cent of its \$25 trillion GDP on education. That country produces just 132,000 engineers annually. India, whose economy is approaching the \$3 trillion mark, produces 1.5 million engineers annually. Many such engineers aren't employed productively in India because they are too numerous and chase too few jobs. The crisis of numbers extends to graduates as well. Most studies by the World Bank and FICCI have found that a mere 35 to 36 per cent of Indian graduates are employable. With high enrolment numbers in India, education has become less relevant. Together, the crisis of numbers coupled with the crisis of relevance has led to a crisis of identity for the higher education system in India. These three crises have laid the seeds of a financial crisis.

National Education Policy

The NEP is highly innovative and pathfinding because it's designed to make learning more flexible, and it has an interdisciplinary approach, creates multiple exit points, defines the three tiers of education, catalyses research in a unique manner, and perhaps most importantly, focusses on improving support to faculty – the backbone of any education system. Unlike earlier policies that focussed on brick-and-mortar solutions, the NEP focuses on educators who nurture young minds. The NEP is the first education policy in India that's incorporated with all these unique features. With NEP's introduction, the education system in India is expected to take a different direction. It was only in 2020 that India came to comprehend what higher education system was best for the country. Though such an understanding was present in 1986 and 1968; however, when it came to imbibing the practices of what was needed, we fell short. The NEP signals a paradigm shift in terms of higher education in India because it makes education more quality-driven and relevant to society's needs. What remains to be seen is how well the NEP is implemented.

How to catalyse change in Indian education What is needed more than ever today are tech-

nology solutions that can scale higher education without compromising on quality. Equally important is recruiting faculty and professors who are highly passionate about teaching and learning. Currently, many in India become educators because they don't find opportunities elsewhere. Conversely, in leading education institutes abroad, those who become teachers or join academia are passionate about teaching. When passionate faculty are supported by technology in India, it will pave the way for a far superior education system. Also, research in academia needs to become more fruitful. Thus far, concerning research, the Indian educa-

How Lutyens' Delhi derailed Nitish Kumar's political career?

Robert Reich wrote an article highlighting the growing social divide in the US. He called it the "secession of the successful". A year later, he expanded the idea into a book, The Work of Nations, wherein he wrote how the "new elite is linked by jet, modem, fax, satellite and fibre-optic cable to the great commercial and recreational centres of the world, but it is not particularly connected to the rest of the nation". These 'successful' ones tend to 'secede' from society as they get richer and more successful. They tend to retreat into a reclusive, private world. Former diplomat and writer Pavan K. Varma highlights this "aggressive, selfish, insular" lifestyle of the Indian elite in his book, The Great Indian Middle Class, where he points out how they live in their bungalows surrounded by high walls, with secured from personal borewells and electricity diesel-powered gensets. When they need to socialise, they go to private clubs, use private transport, and have for all practical purposes cut themselves off from the larger Indian realities. They have not just seceded from their surroundings but are also eager to migrate abroad. The most popular alternative homes of Indian business families outside India can be found in the



UK, Singapore, Dubai, and Switzerland.

The traditional Lutyens' elites owe their existence and sustenance largely to the Nehru-Gandhi family that has been in power, directly or indirectly, till 2014. In fact, as author-journalist Sanjaya Baru writes in India's Power Elite: Class, Caste and a Cultural Revolution, "(N)o one represented this elite better than the country's first family, political Nehru-Gandhis, and the many families cutting across professions that benefited from serving the family's successive generations."

Baru continues, "From Motilal to Jawaharlal, on to Indira and Rajiv, and then Rajiv's widow Sonia and her children, the Nehru-Gandhi family symbolised this continuity in pre-Independence post-Independence power elite. Nehru, with his Allahabad Brahmin origins and upbringing, British education and his circle of friends from the British upper class — including the last British Viceroy and his family — was the quintessential representative of the pre-Independence upper class."

Till 2014, this power elite disdainfully called Lutyens' Club or Khan Market Gang by those on the other side of the ideological divide—retained power and pelf irrespective of which party was running the country. Even when Atal Bihari Vajpayee formed the BJP-led National Democratic Alliance (NDA) government at the Centre in the late 1990s, the Lutyens' elite still called the shots. Baru writes, "Vajpayee ... was himself a long-standing member of the Lutyens' elite and indeed belonged to what

Modi and his groupies would dub the 'Khan Market Gang', so to speak. For, my own first glimpse of Vajpayee in the early 1980s was in, of all places, Khan Market. He was carrying a Pomeranian in his arms and walking into a veterinarian's, simply smiled and walked on, as if he was running an errand in a familiar neighbourhood." He continues, "The ease

with which senior BJP leaders, including Jaswant Singh, Arun Jaitley and Brajesh Mishra, interacted with a range of the International Centre's) IIC's usual suspects and then went on to become powerful members of the Vajpayee government further reassured Lutyens' Delhi. Lal Krishna Advani and wife were frequent diners at the IIC dining room, and Arun Jaitley loved his walks around the Lodhi Garden and the long chat sessions with friends over tea and snacks at the IIC lounge. Jaswant Singh was a regular in the IIC's seminar circuit. Even after Vajpayee became [prime minister], one could find many [Prime Minister's Office] PMO officials at the watering holes of the Gymkhana Club and the IIC." Nothing had changed for India's traditional power elite. If anything, the Vajpayee regime had only reinforced a sense of invincibility in this class: That the more things change, the

more they remain the same... But it's not that Lutyens' Delhi got everything on a platter. It took a lot of planning and plotting and intense negotiations and lobbying sessions to get the 'right person' for the job. N.K. Singh is a classic example. The son of an ICS officer, NK or Nandu as he would fondly be called by his close friends, worked closely with different Congress regimes, but it was under Vajpayee that he arrived with a flourish. Baru writes, "When Vajpayee was defeated and Manmohan Singh took over, there was a shake-up in the bureaucracy and many Vajpayee loyalists were moved out of important positions, but the Lutyens' elite very quickly adjusted itself to the new dispensation, with 'our friend Nandu' (as N.K. Singh was called by his friends) replaced by a 'our friend Montek'." But the NK story doesn't end there. In 2013, it was he who, in order to stop the Modi juggernaut in the following year's Lok Sabha elections, pulled up the Nitish Kumar card. In his book, Single Man: The Life and Times of Nitish Kumar of Bihar, senior journalist Sankarshan Thakur recalls how "three nights before" Nitish Kumar parted ways with the BJP for the first time in 2013, N.K. Singh, by then a Janata Dal (United) (JDU) MP, was hosting a dinner at Cambridge.



The ASI report says its recent survey of the Gyanvapi premises revealed 34 inscriptions on spolia used in the mosque commissioned Aurangzeb, Devanagari, Grantha, Telugu and Kannada, and that they mention deities such as Rudra. Umesvara Janardhana. It also claims that sculptures of Hindu deities and carved architectural members were found buried under the soil in a cellar inside the compound. Why was a mosque built where Sri Ramji was born, he asked, clearly unaware of the tumultuous events of the early 16th century, much less the last decade of the 20th century. Born in the highlighting 1990s, he was also

there again. But at least he—his motivations friends' and emotions are unknown—does seem to harbour any animus towards those who had thwarted the rebuilding of a temple, through the courts and otherwise. That is probably because the medieval era mosque at that site did not retain any architectural remnants—spolia—of any older preceding structure, so there was no immediate recall or incontrovertible proof of what had been there. What will he make of Gyanvapi?

For decades a tiny but influential minority of 'historians' have tried to paper over the grim truth of the oddly Gyanvapi named masjid, denying evidence in Maasir-i-Alamgiri, written by Saqi Mustaid Khan, of Aurangzeb ordering the destruction of the Vishwanath temple and the building of the extant mosque. These historians even cancelled the brilliant Sir Jadunath Sarkar for

bemused by the fact Aurangzeb's zealotry, calling the Bengali historian communal instead!

Had the temple been

entirely destroyed (like the one in Ayodhya) the fiction that Gyanvapi was not an act of communal vandalism could have been maintained. But Aurangzeb's decision to retain an entire wall of Kashi's most prominent temple in the design of a new mosque that would sit on the plinth of the razed Hindu place of worship, however, reveals that he wanted the Hindus to feel the pain of that demolition for centuries and generations to come. The temple was the target of earlier Muslim rulers too, with the first demolition ordered by the Ghurid conqueror Qutubuddin Aibak in the 12th century. It was rebuilt a few decades later, away from the original site, only to be destroyed again in the late 15th century in Sikandar Lodi's reign. Akbar's Rajput generals, Raja Man Singh and Raja Todar Mal rebuilt it yet again in the late 16th century only for Aurangzeb to zealously decree its final humiliation in 1669.

Imran Khan party asks election commission to suspend Sindh Governor

ISLAMABAD: Pakistan Tehreek-e-Insaf (PTI) on Saturday filed a complaint against Karachi province Mayor Murtaza Wahab and the Sindh governor and asked the poll conducting authority to "temporarily remove" them from their offices to ensure free, fair, and impartial elections, Dawn News reported. This comes a day after the Election Commission of Pakistan issued a notice to Karachi Mayor Murtaza Wahab for violating its code of conduct. As per the Pakistan-based news daily, PTI Karachi president Khurrum Sher Zaman, who is also contesting the February 8 elections from NA-241, accused the mayor and Sindh Governor Kamran Tessori of indulging in activities tantamount to a violation of the ECP's code of conduct. NEW DELHI: Finance ministry on Monday said the Indian economy has remained resilient amid global headwinds on the back of robust domestic demand, an investment-led strategy due to a transformed climate and high level of public spending, macro-economic stability, apart from a spate of reforms initiated by government over the last 10 years.

A review of the Indian economy released by the ministry said inflation has been reigned in within 2-6% band because of steps taken by government

It, however, warned of risks to the external sector from sticky inflation, sluggish growth and fiscal pressures in the global economy, with the tension around Red Sea seen as a potential threat. 

Ashwin and Jadeja now boast a remarkable record of 504* wickets in 50 Tests, surpassing the previous milestone of 501 wickets in 54 Tests held by the iconic Kumble-Harbhajan duo. This remarkable feat solidifies their place as one of the most prolific bowling combinations in Indian cricket history.

Harbhajan Singh and pacer Zaheer Khan occupy the third spot with 474 wickets in 59

Overall, the list is led by England's pace duo of James Anderson and Stuart Broad, who have accumulated a staggering 1039 wickets in 138



matches, followed by Australian legends Shane Warne and Glenn McGrath with 1001 wickets in 104 Tests.

In the ongoing Test match in Hyderabad, Ashwin and Jadeja combined forces to dent England's progress after an initial aggressive start by the visitors. England, having opted for "Bazball" approach, reached 108/3 at lunch, with Joe Root (18) and Jonny Bairstow (32) at the crease, providing stability after losing three wickets in quick succession.

But soon after lunch break, Axar

Patel and Jadeja removed both the batter to reduce them to 125/5.

England's bold strategy includes three specialist spinners, and with Root contributing as a part-time bowler, Mark Wood stands as their sole fast bowler in the five-match series.

Chinese military bodies, purchased Nvidia semiconductors banned by the US

BEIJING: Chinese military bodies, state-run artificial intelligence research institutes and universities have over the past year purchased small batches of Nvidia semiconductors banned by the US from export to China, a Reuters review of tender documents show. The sales by largely unknown Chinese suppliers highlight the difficulties Washington faces, despite its bans, in completely cutting off China's access to advanced US chips that could fuel breakthroughs in AI and sophisticated computers for its end US chips is not illegal in China and the publicly available tender documents show dozens of Chinese entities have bought and taken receipt of Nvidia semiconductors since restrictions were imposed. A100 and the more powerful H100 chip - whose exports to China and Hong Kong were banned in September 2022 - as well as the slower A800 and H800 chips Nvidia then developed for the Chinese market but which were also banned last October. The graphic processing units - a type of chip - that are built by Nvidia are widely seen as far superior to rival products for Al work as they can more efficiently process huge amounts of data needed for machine-learning tasks. The continued demand for and access to banned Nvidia chips also underlines the lack of good alternatives for Chinese firms despite the nascent development of rival products from Huawei and others. Prior to the bans, Nvidia commanded a 90% share of China's AI chip market. Purchasers included elite universities as well as two entities subject to US export restrictions -Harbin Institute of Technology and the University of Electronic Science and Technology of China, which have been accused of involvement in military matters or being affiliated to a military body contrary to US national interest.

The former purchased six Nvidia A100 chips in May to train a deep-learning model.

Adani Group to provide Dharavi residents 350 sqft homes with independent kitchens and toilets

Dharavi redevelopment: Eligible residential tenements. before existing January 1, 2000, will separate kitchens and in-built independent toilets in each flat.

Dharavi Redevelopment Project Pvt Ltd (DRPPL), a collaboration between the Adani Group and the government Maharashtra,

announced that eligible residential tenements in Dharavi will receive flats featuring independent kitchens and toilets, with a minimum area of 350 sq ft.
