## Congress plans to redistribute wealth to 'infiltrators': PM Modi

'Distributed among those who have more children, among the infiltrators?" Modi said to a loud "no" from the big crowd'

#### JAIPUR/BANSWARA:

Congress is in the grip of "urban Naxals" determined to execute their beliefs and convictions through the party, PM Narendra Modi said on Sunday while drawing a link between opposition party's pitch for distribution of wealth in its manifesto and his predecessor Manmohan Singh's Dec 2006 statement that minorities have first right to the country's resources.

"Just look at their manifesto. What they have said is of grave concern and reflects their plan to implement their Maoist vision on the ground. They have said that if Congress gets to form govt, they would conduct a survey of everyone's assets: how statement

He said Congress's catchphrase "mohabbat ki dukaan" was part of an elaborate subterfuge for the reality of "fear, hunger and corruption being sold in Congress shops".

"I am more like a family member to you. You have known me for the last 23 years. You also know the work my govt has done in the last 10 years.

2k of 4.7k MP/MLA cases settled in 2023

**NEW DELHI: Supreme** Court's constant monitoring of progress in criminal case trials against MPs and MLAs has shown encouraging results with designated courts giving judgments in 2,018 of 4,697 pending cases last year alone. This reverses the trend of the past, when cases against former and sitting took years to be decided by trial courts, allowing elected representatives to continue their political careers unmindful of the threat of disqualification.

#### Rahul Gandhi, PM Modi alike in speaking against Kerala, says Kerala CM

KOZHIKODE: Kerala CM Pinarayi Vijayan said PM Narendra Modi and Congress's Rahul Gandhi have the "same voice when they speak against Kerala." Addressing media persons in Kannur on Sunday, Viiavan said both leaders shared a similar mindset in attempting to mask the state's progress with Continuing falsehoods. scathing attack, he said Rahul is recontesting from Wayanad after running away from north India. "In the last elections, he came to

Minister Prime Narendra Modi former accused Congress president Sonia Gandhi on Sunday of "lacking the courage" to contest Lok Sabha polls and instead choosing Rajya Sabha route to enter Parliament, while alleging that her party is in such a dire state that members of its "dynasty" will themselves not be voting for a Congress candidate. Addressing an elecrally Rajasthan's Banswara, Modi referenced the Gandhi family's decision to vote for an INDIA bloc nominee instead of a Congress candidate from New Delhi constituency,

where they are reg-

istered to vote.



AAP's Somnath Bharti is contesting from the seat as the common candidate for the alliance. "Congress is not contesting from the very place where the Gandhi family lives. If the 'shahi' family cannot vote for Congress, they do not have any right to seek your votes either," Modi said, adding: "Here (in Rajasthan), Congress functionaries, during door-to-door campaigning, are urging voters to not vote for Congress candidates...This is the situation of the party. you them?"Modi continued his criticism of Congress during a rally in Jalore, questioning the party's credibility, and made a pointed reference to Sonia Gandhi's decision to opt out of electoral politics. "Those who cannot contest polls and cannot win elections have run away from the field to enter Parliament via Rajya Sabha in Rajasthan," he said, referring to the five-term Rae

# Sangli, Mumbai South Central, and Bhiwandi seat talks stalled



For weeks, Sangli, Mumbai South Central, and Bhiwandi seat talks stalled. A key deal in Maharashtra's electorally critical Lok Sabha elections was declared by the Maha Vikas Aghadi (MVA) with the Shiv Sena (UBT) contesting 21 seats, the Congress 17 and the Sharad Pawar faction of Nationalist Congress Party 10.

At Shivalaya, Sena's south Mumbai office, former chief ministers Sharad Pawar and Uddhav Thackeray and state Congress chief Patole announced the seatsharing arrangement. The Congress claimed

Sangli, three Mumbai South Central, and Bhiwandi seats, while the Sena (UBT) declared its candidates for the first two and the Pawar faction for the third, stalling seat talks for weeks. Congress eventually gave up the seats. "We took a step back, we did not surrender," Patole told reporters. For the National Democratic Alliance, which hopes to win 400 Lok Sabha seats. and INDIA. which hopes to perform well in one province with strong regional leaders, Maharashtra is crucial. The unified Shiv Sena contested

Sabha seats alongside the BJP, which contested 25. The Congress contested 26 seats and the NCP 22.Sena-BJP won 41 of 48 seats, a landslide victory. The won four, Congress one. Seven NCP-SP and Congress candidates have been announced. The MVA will declare candidates for 13 seats—Madha, Satara, Ratnagiri-Sindhudurg, Raver, Jalna, Dhule, Palghar, Nashik, Thane, Mumbai North, North West, North Central, and Southover the next two days and present a manifesto focused on Maharashtra issues.

#### 1 in 4 Congress, 1 in 5 BJP from political families

Delhi: Given the political churn, not all political family candidates are running for the same party as their elders. Multigenerational politics is seen in the fact that one in four Congress candidates in the Lok Sabha elections are from political families, compared to one in five (of the 424 announced) Bharatiya Janata Party candidates. Thus far, 87 of the 424 BJP candidates are from political families, compared to 65 of 250 Congress candidates. For this analysis, A political family has a grandparent, parent, or elder sibling who is an elected or nominated member of Parliament or a state assembly or a key political party position. Analysts expect the BJP's list to include many political families for two reasons. First, the party has always prioritized winnability. Two, Prime Minister Narendra Modi stated in Parliament that candidates who follow their elders are fine. The BJP's Andhra Pradesh candidate is D Purandeshwari, daughter of Telugu Desam Party founder NT Rama Rao. She and BJP candidate Kiran Kumar Reddy (former CM) were Congress members. His Congressman father was connected to Indira Gandhi and PV Narasimha Rao. BJP candidates come from anti-Congress political families. Its Bihar candidate is the son of former Bettiah MP Madan Kumar Jaiswal. Newada candidate Vivek Thakur is the son of former Union minister CP Thakur. In Gujarat, the BJP nominated Poonamben Madam, daughter of six-term MLA and former mayor Hemantibhai Madam. Bharatsinhh Dabhi, son of two-term MLA Shankarji Okhaji Thakor, is another seasoned state candidate. BJP candidates from political families include Bansuri Swaraj, daughter of late Sushma Swaraj in New Delhi, BY Raghavendra, son of BS Yedyurappa (the sitting MP from Shimoga who was refielded), and former chief minister Basavaraj Bommai, son of SR Bommai.

#### Delhi industries department approves 21-acre e-waste facility

Delhi: Senior officials said the industries department has finalized the plan for a 21-acre facility in northwest Delhi's Holambi Kalan to house a recycling center and training facility for e-waste handling and processing. The Delhi State Industrial and Infrastructure Development Corporation (DSIIDC) has invited private applicants to set up the complex, which will have an integrated ecosystem for e-waste management supply chain, on a public-private partnership (PPP) basis

According to the project report, the integrated complex will be placed at the Urban Extension-2 road and have six primary sections: disinfection, dismantling, refurbishing manufacturing and recycling, testing, and training. "We will give the private operator 21 acres to create buildings, utilities, roads, and machinery.

## **Bournvita and Other Drinks Will No** Longer Be Listed as "Health Drinks"

Delhi Divva: The Central Government ordered all ecommerce sites to remove all so-called drinks and beverages, including the well-known milk supplement Bournvita, from the 'healthy drinks' category, dealing a severe blow to fitness drink businesses. The National Commission

## **DPCC** issues SOP to seize, dispose of plastic

**Delhi:** The Control Pollution Committee (DPCC) has a regular operating system for seizing and disposing of unlawful plastic items sold or used in the city. According to the amended plastic waste management laws, illegal plastic will be defined and DPCC staff will investigate various locations. It said that only a waste-to-energy plant would dispose of seized plastic products including polyethylene, earphones, silverware, etc. The DPCC procedure requires a team of authorities to take samples of plastic carry bags and sheets from the unit during inspection of all producers, importers, and brand owners and include them in the report. Teams must seize, transport, and store non-authorized

plastic objects at the



DPCC lab until dispos-"The unit owner/occupier must pay for seizure, loading/unloading, transportation, storage, waste-to-energy plant disposal, etc. A recent DPCC portal document indicated that the team would take geotagged photos and video of the seized samples and the full seizure procedure of banned/non-permissible stuff. It said that "all the seized nonpermissible plastic carry bags/sheets/

banned SUP items shall be disposed of through a waste-toenergy plant." The Centre banned 19 single-use plastics manufactured, imported, stocked, distributed, sold, and used in July 2022. From December 120-micron 2022. carry bags were forbidden. Earbuds with plastic sticks, balloon sticks, flag sticks, candy sticks, ice cream sticks, thermocol for decoration, and more were among the 19 items.

#### Currency circulation increases despite 2k note ban

Delhi: Despite the elimination of Rs 2,000 banknotes, the currency in circulation increased by Rs 1.3 lakh crore in FY24 from Rs 33.5 lakh crore at the end of March 2023 to Rs 34.8 lakh crore. Growth has slowed the most since 2018. In FY24, currency in circulation as a proportion of GDP fell since 4% i is slower than GDP growth. CIC grew 7% last year and over 10% the year before due to a pandemic cash rush. Currency in circulation grew 0.5% to Rs 35.3 lakh crore in the week ended April 5. RBI data shows that the increased issue of Rs 500 notes has more than offset the withdrawal of Rs 2,000 notes. ON May 19, 2023, RBI announced their withdrawal. In March 2024, Rs 2,000 notes were worth Rs 8,202 crore, down from Rs 3.6 lakh crore a year earlier. The value of Rs 500 notes rose to Rs 30.1 lakh crore from 25.8 lakh crore a year before.

By examining factors like income distribution, access to healthcare and education, and environmental sustainability, these methods provide a more comprehensive understanding of the factors that contribute to citizens' quality of life. Additionally, objective measures are less susceptible to fluctuations and can provide policymakers with reliable data to assess long-term trends and formulate effective policies to address societal challenges. In conclusion, while happiness surveys might sometimes feel as accurate as trying to forecast the weather with a broken umbrella, they do serve a purpose in highlighting the whimsical nature of human contentment. Perhaps, as we navigate the maze of statistics and subjective feelings, we can take solace in the fact that happiness, much like the perfect cup of coffee or the quest for the ultimate meme, is a journey rather than a final destination. So, let's raise a toast to the quirks of happiness surveys, the absurdity of statistical rankings, and the delightful chaos of being human. After all, if laughter is the best medicine, then a good chuckle about happiness rankings might just be the cure for our existential woes. Until 2023 Report was a publication of the Sustainable Development Solutions Network, a global initiative of the United Nations, and from 2024 onwards, it is a publication of the Wellbeing Research Centre at the University of Oxford. Who needs those when you can simply ask if someone had a good laugh yesterday? Speaking from personal experience, I am not sure about yesterday, but I did laugh a lot today, and that was when I looked at the World Happiness

Another flaw that the report indulges in is interpreting "aspirations" as unhappiness. Individuals from developing countries might be a lot more aspirational or ambitious; it does not necessarily make them unhappy with

In fact, the opposite can still be argued. Someone who draws meaning from their everyday struggle, one who wants to turn their start-up into a billion-dollar venture, might be extremely content with their life, wishing to take it to another level. Imagine hustling day and night, dreaming of a better future, only to be termed "depressed" by some reports that mistake ambition for anguish and growth for gloom. This year's World Report isn't the only one under scrutiny; the entire notion of happiness surveys seems flawed as it effectively ends up conveying nothing. Take the UN report averaging self-reported happiness scores from.

Marasimna, according to his court poet, had spent his life in war: he had participated in campaigns in Madhva Pradesh, slaughtered rival families, and even piled up the skulls of his enemies. Yet, in the last year of his life, he had erected Jain temples, and his ritual suicide was in a Jain monastery. Marasimha's kingdom disappeared within a few decades of his death, but Deccan Jainism retained its following for almost 500 more years. This is one part of its story. By the time of Marasimha's

death, Deccan Jainism was already a grand old counting religion, among its adherents writes in Religious Institutions and Cults in the Deccan that Jain monks began to appear in inscriptions from the 4th-5th centuries CE. Also around this time, other practices from North India, including permanent stone temples to gods and the use of Sanskrit in political settings, appeared in the Deccan. All these offered potent symbolic and political tools to newly emerging kingdoms, such as the Kadambas in presentday Banavasi and the Early Western Chalukyas in presentday Badami. Deccan Jainism was woven into

medieval South Indian kingship from the outset. **According** to a Deloitte report, the average CEO salary in India was Rs 13.8 crore, up 40% from pre-COVID-19 levels. Short- and longincentives account for more than half of the total compensation. The average remuneration, according to **Executive Performance** and Rewards Survey 2024, is Rs 13.8 crore, while the average compensation for CEOs who were also promoters or members of the promoter family is Rs 16.7 crore.

There are two main reasons why promoter CEO salary exceeds that of professional compensation. Because promoter CEOs tend to have longer tenures overall, professional CEOs undergo changes in office more frequently than promoter CEOs. "However, it's also critical to recognize that promoter CEO compensation varies great-



ly, which has an impact on the higher averages," stated Anandorup Ghose, Partner and CHRO Program Leader at Deloitte India. Despite an increase in CEO salary, Deloitte reports that over 50% of target compensation is "payat-risk." Pay-at-risk for professional CEOs is 57%, a significantly greater percentage than for promoter CEOs (47%).

Twenty-five percent of the target remuneration for professional CEOs comes from long-term incentives, most of which are provided in the form of share-linked incentives. "The wide gap between median and average CEO com-

pensation (Rs 9.3 crore versus Rs 13.8 crore) indicates the wide range of compensation numbers and some outliers on the higher end," it stated. Most businesses utilize a comprehensive scorecard that combines financial and nonfinancial measures and targets to evaluate the performance of their CEOs and CXOs. CEO and CXO incentives, however, are still skewed toward financompany-level objectives in those scorecards. Boardroom discussions have also moved from discussing the necessity of sharebased compensation to discussing how these schemes incentive benefit stakeholders."

Delhi: While midcap fund flows fell to multi-year lows in March, smallcap funds had a net outflow for the first time in 2.5 years, which could be viewed as an anomaly. This came after capital markets regulator Sebi ordered mutual funds to conduct stress tests on their small- and midcap fund portfolios in March and expressed worries over froth in certain small- and midcap stock pockets. The overall net equity inflows in March decreased by 16% to ?22,633 crore due to the smallcap outflows and the slowdown in midcap flows. The net inflows into equity funds decreased by 16% to ?22,633 crore from the previous month due to concerns about regulatory advice and restrictions on inflows into smallcap schemes by institutions like Kotak MF and ICICI Pru Smallcap Fund. But market experts thought the smallcap flight was an anomaly brought on by regulatory warnings.

#### Insurance company can't deny claim due to pre-existing condition

Delhi: The Supreme Court has ruled that an insurer cannot deny a claim based on a medical condition mentioned by the insured in the proposal form after the policy is issued. Justices D Y Chandrachud and B V Nagarathna further stated that a proposer must inform the insurer of all material circumstances. It emphasized that the proposer is presumed to know all insurance facts and circumstances. The proposer can only disclose what he knows, his obligation of disclosure includes material facts that he ought to know in the ordinary course of business. Delhi: The deadline for finishing the Go First airline's grounded resolution procedure has been extended by the NCLT insolvency tribunal by an additional sixty days. The National Company Law Tribunal (NCLT) has granted Go First three extensions, this time from April 4 to June 3. The resolution professional (RP) of Go First requested an extension of the timeframe to finish the corporate insolvency resolution process (CIRP), and the Delhi-based NCLT granted the plea with a twomember bench. The deadline for finishing CIRP was extended by the NCLT from February 13 to April 4. This came about following the tribunal's November 23rd, 2018, 90-day extension that expired on February 4th. #### DU tops CUET-UG 2024 with 26 lakh applications

Delhi: A research of CUET-UG 2024 application trends found that Delhi University (DU) is the most popular undergraduate university among 261 participating HEIs. DU has received around 26 lakh applications for its UG programs, which have 80,000 places in affiliated institutions and departments. This falls short of previous year's 28.3 lakh. This figure is not final because aspirants can add universities, institutions, and courses. The final number closer to counseling will likely be larger. There are five universities with over four lakh applications and 13 with over two lakh registrations. Two private universities had over four lakh applications, and two Delhi-based state universities have over three lakh. CUET-UG applicants can apply for several institutions and courses, and 13.47 lakh candidates are applying for UG admissions to central, participating state, deemed, and private universities this year. The next most applicants are Banaras Hindu University (8.4 lakh) and Babasaheb Bhimrao Ambedkar University (BBAU), Lucknow (5.1 lakh). Of 261 HEIs, 41 received over one lakh applications, including central universities like University of Allahabad (4.8 lakh), Jamia Millia Islamia (2.6 lakh), Central Universities of Haryana and Karnataka (2.3 lakh each), Jawaharlal Nehru University and Visva-Bharati (1.6 lakh each), and Aligarh Muslim University (one lakh). "Together with the candidate's marks, the UGC NET score would be released in percentile form for use in the PhD admissions process. According to UGC Regulations, 2022, JRF-qualified applicants are admitted to the PhD.
