Uttarakhand cabinet clears Uniform Civil Code, House set to follow

DEHRADUN: The Uttarakhand government, in a cabinet meeting chaired by chief minister Pushkar Singh Dhami at his residence on Sunday evening, approved the Uniform Civil Code (UCC) draft report.

The approved draft, which a five-member UCC panel had submitted to the government on Friday, will now be tabled during a specially-convened assembly session scheduled for February 6.

After the assembly passes it and it becomes an Act, Uttarakhand will become the first state post-independence to implement UCC. Governments of Assam and Gujarat have also shown interest in the adopting "Uttarakhand UCC model".

Nitish, who formed his new govt with BJP and allies on Jan 28 after dumping the RJD-Congress-Left Grand Alliance, claims the support of 128 MLAs, more than the majority mark of 122 in the 243-member assembly. But there are apprehensions that some could be absent during the floor test or cross-vote.

Key figures of Bihar Congress, including state president Akhilesh Singh, are leading the delegation to Hyderabad, the sources said. The MLAs were said to have flown to Telangana from Delhi, where they reportedly met AICC chief Mallikarjun Kharge on Saturday. Deputy CM Vijay Kumar Sinha (BJP) claimed Congress was scared. "It's like holding the MLAs hostage. They don't have trust in them. They must not think the MLAs are bonded labourers," Sinha said. Congress MLA. Prem Chandra Mishra hit back: "NDA should not think about us. We are intact. Instead, JD(U) will face a split." CBI charges Air India ex-CMD, IBM, SAP in software purchase case

DELHI: The NEW Central Bureau of Investigation has filed a chargesheet against the then CMD of Air India, Arvind Jadhav, SAP India and IBM India in connection with alleged irregularities in procurement of software worth Rs 225 crore by the national carrier in 2011, officials said on Sunday. CBI had registered the case on the recommendation of the Central Vigilance Commission (CVC), which had found prima facie procedural irregularities in the procurement of the software, according to sources in the investigation agency.

Isro's woman robot astronaut 'Vyommitra' to fly into space in third quarter of this year



NEW DELHI: lsro's woman robot astronaut 'Vyommitra' will fly into space ahead of its ambitious "Gaganyaan" manned mission, and the humanoid mission launch is scheduled for the third quarter of this year, space minister Jitendra Singh said here on Sunday. The minister also clarified that the final manned mission, in which three astronauts will go to space for seven days to experience space effects and perform zero gravity experiments, is scheduled to be launched next year, in 2025. "Vyommitra" is a name derived from two Sanskrit words "Vyoma" (meaning

"Mitra" 'space') and (meaning 'friend').

The Vyommitra, Jitendra Singh said, is equipped with the capability to monitor module parameters, will issue alerts and execute life support operations. It can also perform tasks such as operating six panels and responding to queries. Singh elaborated that 'Vyommitra' is designed in such a manner so as to simulate human functions in the space environment and interact with the life support system. Vyommitra made its debut during the opening session of the 2021 event titled 'Human Spaceflight.

India is importing red sanders from unexpected sources

The 'other' Sri Ram of Ayodhya, serving poor since 1900

AYODHYA: For centuries, people of Ayodhya have been praying to Lord Ram for their well-being but there has been another 'Sri Ram' in the holy city, providing relief and succour to the poor and the sick and healing wounds for more than 120 years. The Sri Ram Hospital housed in its heritage building, located less than a km away from the newlybuilt grand Ram Mandir, sits along Ram Path in the heart of the temple town. An old marble plaque embedded on a wall in the main block bears an inscription - "This hospital built and endowed for the poor of Ajodhia by the Hon'ble Rai Sri Ram Bahadur was begun upon 5th Nov 1900 when the foundation stone was laid by the Hon'ble Mr J Hooper, ICS, Commissioner of Fyzabad Division." The inscription further reads that it was "opened to public use on 12th April 1902 by HH Sir James Digges Latouche, KCSI, Lieutenant Governor of the United Provinces of Agra and Oudh". Another plague bears the same inscription in Hindi and Urdu. "As it's in Ayodhya and located close to Ram Janmabhoomi site, a very large number of people think it is named after Prabhu Shri Ram. Its founder Sri Ram, was a philanthropist who established this hospital which gets patients from Ayodhya and Faizabad towns, and also from Gonda and Basti districts," the hospital's administrative officer Yash Prakash Singh told PTI here. Though the hospital is under the Uttar Pradesh government and treatment is free, many people "also think it is a private facility", he said. Since its inception, the hospital, now officially called Rajkiya Sri Ram Hospital, has served the poor and the needy, and as life comes full circle for Ayodhya with the building of the Ram temple, it is also serving devotees with renewed vigour.

How demand for Maratha quota took dramatic turn?

MUMBAI: Maharashtra is facing deepening social tensions between two key castes on the quota issue. On one side is the politically influential Maratha caste to which 12 of the state's 19 chief ministers belong. On the other is the more populous Other Backward Class (OBC), which encompasses 346 castes and was granted a quota by the Mandal commission. Both castes command large While votebanks. Marathas are said to comprise roughly 30% of the state's population, OBCs account for around 52%. Traditionally, OBCs have backed BJP. Marathas were once mainly with Congress-NCP but deprived sections later drifted towards Shiv Sena and BJP. Demand for quota The Maratha quota

This 26-year-old Delhi woman ensures final rites for kinless dead



NEW DELHI: "I was someone who ran away at the sight of a cockroach. If someone died nearby, I was afraid to pass by that house for days. Yet today, I spend almost my entire day around mortuaries and crematoriums performing the last rites for unclaimed bodies," says Pooja Sharma. Sharma, 26, does spend a lot of time now with the dead. Giving them a dignified farewell is an obsession with her. After she had to step in the absence of other males in the family at her murdered brother's last rites, the thought of what happened to those who had no family or kin for the final ritual gnawed at her. She took up the mission and claims that since 2022 she has provided 4,000 unclaimed bodies a proper goodbye.

"Soon after my mother's death in 2022 due to illness, my elder brother was killed in a brawl in our area. My father could not bear the shock and went into a coma.

5-month-old branded with hot iron in Madhya Pradesh, dies

BHOPAL: In what could be a fifth such case within two months in Madhya Pradesh, a five-monthold infant who was allegedly branded with hot iron in a superstitious belief to cure pneumonia, died in Shahdol district. Health officials are however saying that it could not be conclusively said whether the infant was branded or not as there were three marks on the child's abdomen but were unlike in the other cases, the infant who was suffering with pneumonia also developed septicaemia. The deceased identified as Hrishabh Kol, son of Ramdas Kol resident of Pathra village was admitted to district hospital on Monday and later referred to medical college, where he died during treatment late on Wednesday. "Doctors are not able to conclude whether the kid was branded or not as the marks on abdomen are confusing. The toddler was suffering from pneumonia and had developed septicaemia. The malpractice of branding infants with hot iron is prevalent.



How Interim Budget 2024 provides an outlook for Vikisit Bharat 2047

The interim budget presented by Finance Minister Nirmala Sitharaman is an important validation of the need for fiscal prudence and discipline, even as India gets increasingly ambitious with its developmental targets. It follows the same set of rules that have worked in the past: Enhanced Capex spending and an invigorated renewable energy push with focused impetus on youth, women, the poor, and farmers. The budget doesn't try too hard; rather, it tends to keep things consistent and balanced while exuding confidence and clarity. Each group in society has its own wishes and hopes for something specific out of the budget. The budget has stood up to the expectations of all groups and taken care not to disappoint anybody.

The Middle Class and Taxpayers

This budget shows the path to transform and make the Indian economy stronger, and the middle class and taxpayers are important pillars of the economy. In the Interim Budget 2024, the Indian government has made significant announcements across various sectors. For housing, the plans include the construction of 2 crore additional houses under the PM Awas Yojana (Gramin) in the next 5 years. In an effort to empower the middle class and provide them with housing security, a new scheme is set to be introduced to assist the middle-class people who are residing in rented houses, slums, chawls, and unauthorised colonies in fulfilling their dream of owning a home. This initiative aims to provide support and opportunities for individuals in these diverse living situations to either purchase or construct their own houses, fostering increased accessibility to homeownership within the middle-class demographic.

In a significant move to provide relief to taxpayers, the government announced the withdrawal of old, minor, non-verified, non-reconciled, or disputed outstanding Direct Tax demands. This initiative covers amounts up to ?25,000 for the period up to FY 2009-10 and up to ?10,000 for financial years 2010–11 to 2014–15. This decision is expected to benefit approximately 1 crore taxpayers, fostering both ease of living and ease of doing business. By alleviating the burden of these relatively small tax demands, the government aims to simplify the tax system, making it more convenient for individuals and businesses and promoting a conducive environment for economic activities.

Empowerment of Annadatas and Sabka Vikas This government has always tried to focus on Yuva, Gareeb, Kisan, and Mahila. Promoting farmer interest, the budget talks about promoting private and public investment in post-harvest activities, including aggregation, modern storage, efficient supply chains, primary and secondary processing, and marketing and branding. Nano-DAP (fertiliser) on various crops will be expanded in all agroclimatic zones. A comprehensive programme for supporting dairy farmers will be formulated. Apart from this, expanding on the initiative introduced in 2022, the government is planning a strategy to attain self-sufficiency (Atmanirbharta) in oil seeds like mustard, groundnut, sesame, soybean, and sunflower. This comprehensive plan involves conducting research to develop high-yielding seed varieties, promoting the widespread adoption of modern farming techniques, establishing strong market linkages, ensuring effective procurement, adding value to the products, and providing crop insurance. By addressing these key aspects, the government aims to strengthen the oilseed sector, promote sustainable farming practices, and enhance the overall self-reliance of the country in oilseed production.

Gyanvapi: Truth, reconciliation and the way forward

Recently, the pristine land of Ayodhya saw the Pran Pratishtha ceremony and the returning of Ram Lalla to the temple built at the historical site. In a pivotal development in the legal dispute over Varanasi's Gyanvapi Masjid, a district court has granted permission for members of a family of priests to offer prayers in one



of the cellars within the the Babri Masjid in 1992, mosque complex. This particular cellar, known as Vyasji ka Tehkhana, was unsealed last night, and a puja ceremony took place around 3 am.

The Gyanvapi mosque, constructed in the 17th century, features four cellars, with 'Vyas ji ka Tehkhana' being one of them. Situated in the southern area of the mosque's fortified complex, it stands opposite a statue of the Nandi bull within the adjacent Kashi Vishwanath temple premises. The cellar, measuring about 7 feet in height and covering an area of 40 square feet, allegedly contains idols that were worshipped before its sealing in 1993, as claimed by petitioner Shailendra Pathak Vyas. The Muslim side refuted this assertion in court, stating that the petitioner failed to provide evidence of prayers being conducted there and denying the presence of any idol in the cellar. Following the demolition of

President's Rule was imposed in the state, and the following year, a government led by Mulayam Singh Yadav assumed office.

Citing concerns about law and order, Yadav prohibited prayers within the cellar temple. The petitioner contends that regular prayers were conducted by Somnath Vyas before the cellar was sealed. The mosque committee has expressed its intention to challenge the court's decision in the high court. Lawyer Akhlag Ahmed asserted that the order overlooked the Advocate Commissioner's 2022 report, the ASI's report, and a 1937 decision favouring their stance. He argued that the Hindu side failed to provide evidence of prayers before 1993 and that there is no idol in the designated place. Advocate Merajuddin Siddiqui accused district officials of colluding with the district magistrate, suggesting a

political agenda. He drew parallels to the Babri Masjid case, claiming that the Commissioner's and ASI's reports previously confirmed the absence of any contents inside the cellar.While it requires nothing more than a pair of eyes to establish that a temple existed at the site where the structure of the mosque today stands, there is ample architectural and textual evidence to back up this claim as well.According to Yugeshwar Kaushal, a PhD scholar specialising in South Asian Studies, Maharaja Jayachandra erected an elaborate temple at the site fol-

1170-89 AD. During Maharaja Jai Singh I's reign, Aurangzeb, motivated by religious zealotry, demolished the Kashi Vishweshwar temple in 1669. He then constructed the present-day Gyanvapi mosque on the remains, as stated by Kaushal. RBI orders Paytm Payments Bank to suspend most services after Feb. 29.

Delhi: The Reserve Bank ordered Paytm Payments Bank (PPBL) to suspend taking deposits or top-ups in user accounts, wallets, FASTTags, and other instruments after February 29. Customers may receive interest, cashbacks, or refunds at any time. The central bank stated that chronic non-compliances and serious supervisory concerns prompted the direction. The RBI barred PPBL from enrolling new customers immediately on March 11, 2022. Paytm group firm PPBL did not comment on the RBI's bank-related direction. After February 29, 2024, customer accounts, prepaid instruments, wallets, FASTags, NCMC cards, etc. cannot be deposited or topped up, except for interest, cashbacks, or refunds, which can be credited whenever "RBI. Up to their available balance, users can withdraw or use balances from savings bank accounts, current accounts, prepaid instruments, FASTags, and National Common Mobility Cards without limits. "No other banking services, other than those ... like fund transfers (irrespective of name and nature of services like AEPS, IMPS, etc), BBPOU and UPI facility should be provided by the bank after February 29, 2024," said. RBI also ordered the termination of One97 Communications Ltd. and Paytm Payments Services' 'nodal accounts' by February 29, 2024. One97 Communications owns 49% of Paytm Payments Bank Limited but considers it as an affiliate rather than a subsidiary. RBI noted that any pipeline and nodal account transactions commenced on or before February 29, 2024 must be settled by March 15, 2024, and no further transactions will be allowed.



Delhi: Despite strained with the relations Maldives, Delhi will prioritize Indian Ocean development projects. India increased its 2023-24 Maldives budget from Rs 400 crore to Rs 770 crore. Second only to Bhutan and Nepal, it has allocated Rs 600 crore for the Maldives in 2024-25. India has not let disputes with Male, particularly in defense and security cooperation, impede the \$500 million Greater Male Connectivity Project, its largest infrastructure project. Maldives allocations are grants, not loans. Bhutan retained its top budgeted allocation, with India allocating Rs 2,068 crore to Thimphu. Nepal gets Rs 700 crore. Including Bhutan's loan, India's 2024-25 estimate for grant and loan assistance to foreign governments is Rs 5,667 crore. This is 874 crore less than last year's revised projection. In 2024-25, India allocated Rs 250 crore for conflict-torn Myanmar, down from Rs 370 crore last year.

Consumer disputes body fines Unacademy for deceptive UPSC 'success' commercial

Delhi: The National Consumer Disputes **Redressal Commission** (NCDRC) stayed a Rs 1 lakh penalty on edtech firm Unacademy manipulating for UPSC advertisement numbers, pending further review. Unacademy appealed to the commission against a suo moto order by the Central **Consumer** Protection Authority (CCPA) that penalized the platform and directed it to stop advertising that 26% of UPSC were its rankers pupils.

The Consumer Protection Act, 2019 established the CCPA to regulate consumer violations, rights unfair and misleading advertising, and consumer rights promotion. Coaching institutes deliberately hid essential information and portrayed students as having taken courses long-term with the platform instead of free or simulated courses, misleading potential canthe CCPA didates, found. However,



Unacademy claimed that the authority had based the order on 'factually incorrect observations" since it was "unable to comprehend" or record the data in interim orders despite submitting proper data. president NCDRC Justice A.P. Sahi suspended the sentence hearing after Unacademy's appeal by counsel Sumeer Sodhi, adding the Bench needed to review the matter. "At first glance, the matter needs consideration.

The consumer commission said last week that the ruling impugned penalizing the Appellant [Unacademy] is suspended until further orders of the court.

Unacademy advertised in August 2022 that 3 of the top 5 UPSC rankers and 26% of all UPSC rankers were its students. Statistics underpinned its claims. Last September, the CCPA filed a suo moto action against Sorting Hat Technologies, the platform's corporate body, demanding it prove the claim's data. Schools are allowed to carry over empty EWS seats

Delhi: The Delhi High Court ruled that it is "legal and valid" to transfer open seats in the Economically Weaker Section/Disadvantaged Group (EWS/DG) category from one class in a given year to another class in the following year at the same institution. Carrying over empty EWS/DG vacancies to the next class in the next year does not infringe the Right of Children to Free and Compulsory Education (RTE) Act or any other legislative condition, according to a singlejudge bench chaired by Justice C Hari Shankar. "Every school is required by law to admit EWS/DG children to the extent of at least 25% of the strength of its entry-level class, which comes under Section 2(n)(iv) of the RTE Act. The HC emphasized that if a school defaults, it is legal to force it to make up the difference in the next year's higher class. According to the HC, the majority of these instances involve the school's refusal to accept EWS applicants in lieu of "carry forward vacancies" from prior years that went unfilled. It then stated that the student will be enrolled in the school's First Class as an EWS student until the conclusion of the current academic year. It further stated that in accordance with the Act, the DoE would pay the students' fees.

Delhi: IIT-Madras has become the first IIT to introduce sports quota for its UG admissions and will create two supernumerary seats in each course from the 2024-25 academic session. "IIMC is committed to giving its best to promote education, training, and research in mass communication," it stated. On August 17, 1966, the Ministry of Information and Broadcasting estab-



lished the institute. Information and Broadcasting Minister Anurag Thakur called IIMC's university status a "special and historic day" and stated, "This Institute has a glorious history of imparting quality education in media subjects like Journalism Advertising, and

Public Relations." He continued. "The granting of University status marks a new

beginning, as more courses could be added to the curriculum along with research and doctoral programmes, giving youth new options and pathways to explore. The IIMC trains Indian Information Service officials. The Ministry of Education declared IIMC a deemed university on the UGC's recommendation. The Information and Broadcasting Ministry

deemed approved university status in 2016.
