## 70+ citizens with private cover can also avail PMJAY: Centre

**NEW DELHI:**

Union Cabinet's decision to extend Ayushman Bharat Pradhan Mantri Jan Arogya Yojana (AB-PMJAY) to all senior citizens aged 70 and above comes just before govt completes the first 100 days in office in its third term. "The scheme will be rolled out soon. All eligible senior citizens would be issued a new distinct card under AB-PMJAY. The senior citizens of the age 70 years and above belonging to families already covered under AB-PMJAY will get an additional top-up cover up to Rs 5 lakh per year for themselves (which they do not have to share with the other members of the family who are below the age of 70). All other senior citizens of the age 70 years and above will get a cover up to Rs 5 lakh per year on a family basis," I&B minister Ashwini Vaishnaw said. He added that eligible senior citizens already

### IIT-Guwahati academic affairs dean quits amid stir over student suicide

**GUWAHATI:** IIT-Guwahati students temporarily halted on Wednesday their agitation over a 21-year-old 3rd-year B.Tech student's death after the dean of academic affairs resigned. The institute's director, Devendra Jaliha, assured students that their demands for the resignation of several more faculty members, including the hostel affairs board vice-chairperson and the associate deans of student and academic affairs, would soon be addressed. However, IIT-Guwahati authorities said they were yet to decide whether to accept the resignation letter of dean of academic affairs KV Krishna. The authorities have restricted media access to the institute. Protests had erupted on Monday following the alleged suicide of the Paswan community student, Bimlesh Kumar from Ballia, UP. "There is clear negligence on the part of IIT-Guwahati. How could they be so ruthless towards a student who submitted a medical reason for poor attendance and fail him in his third year, not for poor academics but for having low attendance."

## Congress names 40 more candidates, Surjewala son gets Kaithal ticket

**CHANDIGARH:**

Congress waited until midnight Wednesday to declare a list of 40 candidates for the Haryana polls, seemingly to minimise the chances of those who missed the bus filing nominations on their own before the Thursday deadline. The party, too, has only hours to decide who to give the remaining 9 seats to.

Congress issued its first list of 31 candidates last week, followed by another name hours later. Then came another list of nine nominees. These were mostly the so-called easy seats where the threat of rebellion was minimal, and also where strong claimants were fewer. All 28 sitting MLAs made the cut. With this delay, the party is hoping that it will be able to minimise rebellion from disappointed party members. The new faces nominated by Congress include RS MP Randeep Singh Surjewala's son Aditya Surjewala from Kaithal, Hisar MP Jai Prakash's son Vikas Saharan from Kalayat, Ambala MP

### Ajit Doval calls for joint Brics action against terror, meets Wang Yi

**NEW DELHI:**

Participating in the Brics NSAs' meeting in St Petersburg, NSA Ajit Doval spoke about modern security challenges, including in the digital domain, and terrorism, calling for joint efforts within the Brics framework to address these issues.

Doval, who had a brief interaction with Chinese foreign minister Wang Yi on the margins, also called for reform of multilateralism saying existing structures are no longer capable of handling modern threats and sensitive issues of common concerns. Govt sources confirmed Doval will have a formal bilateral meeting with Wang on Thursday. He is expected to address the LAC situation in eastern Ladakh and seek early completion of the disengagement process, and restoration of peace and tranquillity along the border areas, the relationship can become normal. The Brics NSAs also reviewed pressing security challenges facing the globe.

## Impasse on as Bengal junior doctors junk second govt invite for talks, set fresh terms

**KOLKATA:** Junior doctors rallying for justice to their raped and murdered colleague at Kolkata's RG Kar hospital rebuffed on Wednesday a second emailed invitation for talks with the Bengal govt and set fresh terms, including a "live telecast" of the meeting.

The doctors' continued strike in defiance of even Supreme Court's 5pm Tuesday deadline to return to work led senior govt officials to suspect what they termed "political instigation". The day had started with a semblance of hope as the junior doctors camping at Swasthya Bhavan, the health department's headquarters, since Tuesday evening sent feelers to the govt after a general body meeting. Prior to this, the West Bengal Junior Doctors' Front (WBJDF) wrote an email to CM Mamata Banerjee at 3.49am, agreeing to a meeting but setting additional conditions.

One of the new terms specified in the mail was to allow a 30-member delegation to participate in the talks. The doctors wanted West Bengal CM Mamata Banerjee to be present at the meeting. The govt replied to WBJDF's email at 3.23pm, inviting it to a meeting at 6pm with a delegation of 12-15 people. While reminding the protesting doctors that as law-abiding citizens they ought to follow SC's return-to-work directive, the state govt said "any condition (for talks) impedes open discussion". At 5.23pm, another mail from the association landed in govt's inbox, mentioning the conditions mentioned previously remained unchanged. The protesting doctors have a five-point charter of demands. They want the health secretary, director of medical education, director of health services and Kolkata Police commissioner to resign, besides a departmental inquiry and disciplinary action against hospital's ex-principal Sandip Ghosh.

## Communal violence erupts in Karnataka's Nagamangala during Ganesha idol immersion

**MANDYA:**

Nagamangala, a town situated 45 kilometers from Karnataka's Mandya district witnessed heightened tensions following a clash between two groups during a Ganesha procession around 8 pm on Wednesday.

The incident occurred when devotees from Badarikoppalu were carrying two Ganesha idols for immersion. As the procession reached a place of



worship, miscreants engaged in chanting praises to their deities, further escalating the tension in the town. Sources reported that a few individuals sustained injuries during the stone-pelting, and

the police faced difficulties in controlling the crowds who were at odds with each other. Youths from Badarikoppalu later halted the procession near the police station, demanding the arrest of the miscreants responsible for throwing stones at them. Senior officers from both the police and revenue departments rushed to the scene to pacify the crowd and defuse the tension.

## Centre seeks review of SC's mineral royalty judgment

**NEW DELHI:** Faced with a huge financial burden caused by the ruling of a nine-judge bench of Supreme Court enabling states to collect royalty on extracted minerals and to levy tax on mineral-bearing land, Centre has sought a review, pointing out several "errors apparent in the judgment". Interestingly, the Centre has roped in Madhya Pradesh as a co-petitioner to seek review of the July 25 judgment in an open



court hearing and argued that the issue raised by it "pertains to the fundamental rights of the citizens of the country and raises larger issue of public interest and grave injustice would ensue if the application for oral

hearing of the review petition is not allowed". When senior advocate Rakesh Dwivedi, appearing for some mineral-rich states, sought early listing of pending cases relating to dues .

## Tata Steel to get £500 million from UK for plant in Wales

**MUMBAI:** The UK govt will give 500 million pounds to Tata Steel to construct a greener electric furnace at the Port Talbot site in Wales, with the Indian company paying 750 million pounds. While the previous UK govt led by the Conservative party had agreed to give 500 million pounds to Tata Steel, no deal was signed with the company. The development comes as Tata Steel seeks to cut losses at its UK operations.

Tata Steel had acquired the UK plant as part of its acquisition of the Corus Group in April 2007 for 6.2



billion pounds and since then, the unit has hardly made any money for the company. Tata Steel has already closed one blast furnace at the Port Talbot site in July and will shut down the second one this month, making 2,500 workers redundant. While the deal with the UK govt secures

the long-term future of steel making in Wales, govt was unable to secure the 2,500 jobs that Tata Steel will cut over coming months, reported the Guardian. Under the new deal, those who will lose their jobs will receive an improved redundancy package.

The electric arc furnace (EAF) - which will melt scrap steel or iron to produce steel - is greener but far less labour intensive, with about 500 jobs being created during its construction. The electric arc furnace will be operational within three years, that is by late 2027.

Additional SP Rupesh Dwivedi said on Wednesday night that six suspects had been identified, two of whom have been detained from the jungles. Both Army officers were injured in

the mob attack. One of them managed to dial his senior officers but by the time police arrived from Mhow, 30km away, the woman had already been gang-raped. The two Armymen are undergoing the Young Officers course at Infantry School, Mhow, SP Rural Hitika Vasal said. According to the complaint filed by one of the lieutenants, the four of them had driven to Ahilya Gate near Jam Gate on Mhow-Mandleshwar road on Tuesday night.

Prayagraj: MP Ujjwal Raman Singh met Union Transport Minister Nitin Gadkari in New Delhi and raised two demands. First, outer ring road in Prayagraj and concrete bridge on river Ganga in Meja. Second, plantation on both sides of Rewa Road and Mirzapur Road, informed MP representative Vinay Kushwaha, who told



reporters that MP thanked Nitin Gadkari for the work going on the inner ring road and said that this proposal was given in the 2020 master plan by former MP Kunwar Revati Raman Singh, this scheme lagged behind by five years due to which today Prayagraj is struggling with traffic jam, hence if the proposal of Outer Ring Road is made and announced now, it will take 10 years for it to be built, then the situation will be like today.

The representative said that the Union Transport Minister assured MP Ujjwal to consider the outer ring road and said that outer ring roads will be built at a distance of 40-45 km from the city. On the demand of tree plantation, the minister said that I am for the construction of every national highway. Also, orders for tree plantation on both sides have been issued by including it in the action plan. If the action plan has been changed and tree plantation has not been done, then you should complain in writing, I will take action on it.

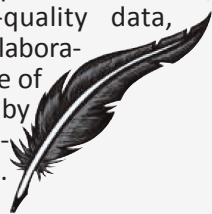

### AI is central to the future of climate finance, can attract investors

The report recommends a \$3 trillion annual increase in multilateral development banks' (MDBs) spending by 2030—including \$1.8 trillion toward climate action. However, MDBs offer concessional loans and add to the global debt, which hit a record \$307 trillion in 2023, a whopping 336 per cent of the GDP. Private sector engagement is crucial, yet its capacity to finance green projects is limited. Between 2016 and 2021, only \$120.8 billion was mobilised from the private sector, further highlighting the gap. In this context, artificial intelligence (AI) emerges as a transformative tool for climate finance, offering solutions for better decision-making, resource optimisation, and enhanced financial mechanisms to support sustainable initiatives. It can analyse vast datasets to assess climate risks accurately, aiding insurers and financial institutions in pricing risk and making resilient investments. Thus, AI can drive climate finance by exponentially improving risk assessment and management. AI algorithms can also help optimise investment portfolios by prioritising green investment opportunities over high-risk, carbon-intensive assets, balancing financial returns with environmental impact. Through its analysis of data trends, AI can uncover high-potential, underfunded areas for investment. Financial institutions worldwide need to be more efficient, and AI can help by streamlining operations and reducing costs. This will ultimately speed up the approval of climate finance proposals. One of the most critical areas of climate finance is risk pricing. AI can develop accurate pricing models for climate risks to reflect financial products' actual costs. Green bonds and sustainable finance require a greater push to increase funds flow. AI can raise investor confidence by automating compliance and reporting processes.

AI can be most beneficial in promoting structures like infrastructure investment trusts (InvITs). It can ensure funds are used effectively by monitoring and verifying the impact of investments. Similarly, compliance with fraud detection and climate finance regulations can also be improved with AI. Leveraging AI for climate action also poses several challenges. Reliable AI models depend on accurate, comprehensive, and high-quality data, necessitating stakeholder collaboration. It is also vital to be aware of the ethical and bias concerns by ensuring that the AI algorithms used are transparent.

form. The roast essentially replicates a schoolyard bullying scene. There's the bully, the one being bullied, and, of course, those who are complicit — the voyeuristic and the bystanders. As audience members and consumers of entertainment, we take on this role wholeheartedly and without guilt. Charlie Sheen's 2011 roast was Comedy Central's most watched, drawing in 6.5 million viewers. A 2015 roast of Justin Bieber was watched by 4.4 million people. Both were at their peak — Sheen in

terms of his infamy, and Bieber, who has always been equal parts adored and hated. The personal lives of celebrities are always public fodder and always will be. The rise of influencers testifies to the extent to which you can commercialise and commodify your life. The avalanche of hate is neutralised by the money that flows in. Roasts can be viewed from the same lens. However, comedic trends have always ranged from self-deprecating to self-hating to just hating everyone. And trends are

framed by what appeals to the public, which, in this case, is unkindness. Not to sound preachy or moralistic, but there is something concerning about the staggering popularity of roasts and the craze that surrounds them. There's no nuance, not much thought that goes into the jokes. It's a low-quality, easy-money endeavour. And perhaps that's why they continue to be made. Social contexts have changed. As a whole, society is more politically correct, more mindful of language.

## The defence services allocation includes the budget for the three services

Out of the total Rs 6.22 lakh crore, Rs 4.55 lakh crore has been allotted to the defence services, Rs 1.41 lakh crore for defence pensions (including defence civilians), and Rs 25,563 for MoD (Civil). The Defence Research and Development Organisation, and Defence Public Sector Undertakings. MoD (Civil) expenditure covers its secretariat expenses and those of organisations such as the Coast Guard, Border Roads Organisation (BRO), Defence Accounts Department (DAD), and the Defence Estate Organisation. Out of the defence services budget, Rs 1.7 lakh crore (27.66 per cent) is earmarked for capital expenditure, while Rs 2.8 crore is allocated for revenue expenditure, including Rs 1.63 crore for pay and allowances and Rs 92,088 for stores (covering repair, maintenance and operational cost of the equipment in inventory). The capital expenditure of Rs 1.7 lakh crore for military modernisation did register a 5.8 per cent hike over last year's budgetary estimates and 9.4 per cent over revised estimates. The latter increase was due to Russia's inability to supply contracted weapons and equipment. The real increase is barely adequate to account for inflation and the rising dollar rate. A heartening feature of the current budget is the 30 per cent increase in the allocation for the Border Roads Organisation. The gap between projections made by the Armed Forces and allocation has been 17-23 per cent. In a nutshell, the



defence budget is disappointing and barely adequate to maintain the current capability. Unfortunately, this has been the norm since 2010 and is a cause of grave concern. Even with a modest GDP growth of about 7 per cent, India is projected to be a \$21 trillion economy by 2047. The BJP-led government has itself defined the national goal of Viksit Bharat 2047, implying a status of a great power or at least the third pole in the international arena along with the US and China. Achieving this goal requires a transformed military to safeguard national interests and maintain absolute strategic autonomy. Time is running short. China, with an economy five times larger than ours, set a goal in 2015 to transform its military by 2035 and make it the best in the world by 2049. Nine years into this transformation, its declared defence budget in 2023, as per Stockholm International Peace Research Institute (SIPRI) was \$296 billion, three and a half times larger

than ours, which was assessed at \$83.6 billion. Pakistan's actual defence budget is approximately \$10 billion. India has to be prepared for a 2.5 front war—against China, Pakistan and Pakistan's proxy war in Jammu and Kashmir. And we are setting out to do so with a defence budget of \$ 83.6 billion! The situation is bizarre. With a niggardly defence budget, the politicians, carried away by their own rhetoric, dream of capturing the territories usurped by Pakistan and China. The military hierarchy instead of firmly advising the government about the shortcomings in preparedness says that it is prepared to fight and win the 2.5 front war. Neo-nationalism has further compounded the problem. An emotional and gullible public believes that India can defeat both China and Pakistan. If India followed the time-tested national security planning procedure of conducting an ethical strategic review, and a government-owned and monitored national defence policy to

transform the military, it would be clear that an allocation of 3 per cent of the GDP is essential. All these prerequisites lie within the political domain, and successive governments have wished the problem away. The military has compounded the issue by failing to implement in-house reforms to optimise, restructure, reorganise and modernise with the limited budget available.

High-technology wars of the 21st century cannot be fought with a military of the 20th Century. Two decades back, the eminent economist and former Prime Minister, Manmohan Singh, said, "The government can allocate about three per cent of the GDP for defence needs provided the economy grows at an annual eight per cent." Today our economy is growing at approximately 7 per cent. Surely, the government can provide 2.5 per cent of the GDP if not 3 per cent. With all other requirements remaining constant, an increase of 0.5 per cent of GDP will double the capital defence budget.

India is forecasted to achieve a \$4 trillion economy by the end of this year, and \$8 trillion by 2035. And this is the decade in which our military must transform itself to reduce the capability differential vis a vis the People's Liberation Army. It is time for the government to think like a great power and begin the transformation of its Armed Forces. And for this, an allocation of 2.5-3 per cent of GDP is inescapable.

China, our principal adversary, has been at the gates since April 2020, and its colusive partner, Pakistan, has stepped up terrorism through the back door. However, in the defence budget 2024-2025, "butter has got the better of the guns". With a budgetary allocation of Rs 6,21,940 crore, there is an increase of Rs 28,402 crore over the allocation of Rs 5,93,538 in 2023-2024, but a marginal decrease of Rs 1,949 crore compared to the revised budget estimates of Rs 6,23,889 crore. This year's allocation, which is 1.9 per cent of India's GDP and 12.9 per cent of annual national expenditure, is the lowest since 1960 as percentage of GDP. It is pertinent to mention that, despite economic constraints, past governments allocated the universal norm of 3 per cent or more of the GDP for defence from 1963 to 2010. However, in the last decade, our defence budget has been hovering around 2 per cent of the GDP. Since 2014, the defence budget has been barely adequate to sustain the military capability with incremental modernisation to maintain the dissuasive deterrent against China and offensive deterrent against Pakistan. However, it is grossly inadequate for transforming the Armed Forces to pose a challenge to China and to give a clear edge in the offensive deterrent against.

Pakistan. Consequently, we have been unable to compel China to restore the status

### Who will the Jats of the West support in the assembly elections?

The Jats of Muzaffarnagar riots believe that the farmers' movement has benefited SP before the 2022 elections. The Jats have not yet forgotten the SP government's conspiracy to break the Jat-Muslim unity through this. The Jat community also blames the SP for getting the

Jat reservation cancelled in the Supreme Court. The SP has been the biggest hurdle in the dream of making West UP a separate state.

All political parties in UP have their eyes set on the 2027 elections. Its semi-final is being considered to be the by-elections of 10 assembly seats. BJP is worried about losing 29 seats in the Lok Sabha elections in UP, while the All India Alliance wants to maintain its lead in the by-elections as well. The 2027 election is also a do or die election for Akhilesh. If at least 80 seats are not won from West UP, the path to Lucknow will not be easy. West UP is called Jat land and there are not many Yadav voters here. In such a situation, it will be a big challenge for SP to woo the Jats.

Right now the Jats are voting for RLD, BJP and SP, BSP after seeing the Jat candidate. But no special strategy of SP is visible to attract the Jats.

### Budget shows Modi govt's priority areas have changed after election

Rs 2000 crore for a new internship programme to be implemented by the department of consumer affairs. The government has also allocated Rs 1,000 crore for a new ITI upgradation scheme. The other areas of priority mentioned in the budget speech are productivity and resilience in agriculture, inclusive human resource development and social justice, manufacturing and services, urban development, energy security, infrastructure, innovation, research and development, and next-generation reforms. These have either not translated into any change in allocation (perhaps because the allocation in the interim budget was deemed adequate) or have led to relatively small changes. Under the priority area of energy security, the government has allocated Rs 6,250 crore for PM Surya Ghar Muft Bijli Yojana, which was launched earlier this year. For urban development, there is an additional allocation of Rs 4,000 crore for housing under the Pradhan Mantri Awas Yojana (Urban). While the first area that Sitharaman had emphasised in her budget speech was agriculture, the only major change in allocation towards this sector is Rs 4,700 crore for the Pradhan Mantri Annadata Aay Sanrakshan Yojana, under which remunerative prices are supposed to be provided to farmers. Further, while the government has continued the emphasis on infrastructure expenditure, the only major change in allocation from the interim budget is an additional allocation of Rs 6,000 crore for road works. Overall, most of the allocations in the Union budget are same as those in the interim budget. The only major deviations are in additional allocations for special assistance to states, which will likely be used for states ruled by BJP allies at the Centre, an acknowledgement of the need to do

more for employment creation, and in an allocation for price stabilisation. Since the Union budget envisages additional expenditure of Rs 54,744 crore over the expenditure budgeted in the interim budget, most of the additional allocations to the purposes and schemes discussed above did not require a reduction in allocations in other areas. Since the 2024 Lok Sabha election results were contrary to the government's expectations, there was a chance that the government may opt for major changes in allocation. However, the overall thrust of the expenditure strategy remains the same. Even the allocation for capital expenditure is the same. Beyond the allocation, the approach to using instruments of fiscal policy for addressing development problems also remains largely the same. On employment, for instance, the focus is on subsidies and direct benefit transfers, which have been the government's preferred instruments for most policy problems. The design of these schemes needs to be tested though. For instance, the direct benefit transfer to the first-time workers comes with the condition that if the worker is fired in the first year, the employer will have to reimburse the subsidy to the government. Since the benefit goes to the employee while the consequence of firing is on the employer, on the margins, this places an additional burden on the employer rather than reducing the cost of hiring. On the receipts side, the only major change is in the non-tax revenue. On account of a much larger dividend from the Reserve Bank of India (RBI) than was budgeted in the interim budget, the budgeted receipt on non-tax revenues is about Rs 1.46 lakh crore higher than in the interim budget. While there are some major changes in the direct tax regime — the most important being the changes in the rate.

Nonetheless, the report states that between 2013–14 and 2017–18, the proportion of female students at the university rose from 47% to 51%. JNTU also noted a number of other problems in the study, such as unresolved faculty promotions, irregular academic schedules, hold-ups in the admissions process, and improper meetings of the statutory authorities. The decline in research students is another issue mentioned in the paper. They have now been outnumbered by, with their absolute number falling from 5,432 in 2016–17 to less than 4,600 in 2021–22.

The advisor of the administration listened to the representatives of Rewa very carefully. He also took a copy of the presentation. In its "national team protocol", the federation informs shooters that parents cannot "stay" or "visit" their wards at camps and that Pierre Beauchamp, the High Performance Director (HPD), must make an exception. According to the NRAI's "NRAI Olympic Team Undertaking and SOP for Paris 2024 Olympic Games - Pistol/Rifle Teams" letter to Olympic-bound shooters, the goal is to "ensure the clarity of the training and readiness plan for Olympic Games Paris 2024 by the shooters and the National Team Coaches and Sport Science support." "It is essential to have effective organization, discipline, planned and dedicated training programmes for the best performance of shooters participating as National Team India at the Paris 2024 Olympic Games," the note states. The letter states that only NRAI-approved personal coaches and sport science consultants with signed SOPs can assist the "National Training team for the concerned shooter(s) in assisting and/or discussing with the National Training Team under the leadership of the HPD and the chief coach (rifle and pistol)." Personal coaches without NRAI approval are prohibited. "The NRAI National Team program of the Olympic Games does not allow personal trainers, physiotherapists, nutritionists, or psychologists." Under "Media Blackout", the NRAI says shooters must avoid the media.

**DELHI PRISON RULES 2018 ON PRISONERS' CONTACT WITH THE OUTSIDE WORLD**

**Rule 505:** A prisoner is allowed to have meetings with family members, relatives, friends and legal advisers twice a week. She is allowed to write any number of letters.

**Rule 507:** Every prisoner should submit a list of persons who are likely to interview him, interview him, or receive him, and shall be restricted to family members, relatives and friends. The conversation shall be limited to private and domestic matters and there shall be no reference to prison administration and discipline and to other prisoners or politics.

**Rule 508:** All communications addressed by a prisoner, who is a member of a state legislature or of Parliament, to the speaker or chairman of the house or to the chairman of a committee (including a committee on privileges) of such a house shall be immediately forwarded by the superintendent of the prison to deal with it in accordance with the rights and privileges of the prisoner as a member of the house.

The deadline for submitting these reports is set for November 10, 2024, by 11:59 PM. According to the notice published on September 9, 2024, on the NCTE website, all TEIs must complete the submission process through the designated NCTE portal at ncte.gov.in.

# Pranab's daughter walks back criticism of Rahul's leadership
