Govt okays Rs 76,200-cr port at Maharashtra

NEW DELHI: The Cabinet Wednesday approved developing a major greenfield port at Vadhavan Maharashtra, which will be an integral part of the India-Middle East-Europe Economic Corridor (IMEEEC). The development of this port - strategically located close to the international trade route, and with a potential to attract mother vessels - will entail an investment of around Rs 76,200 crore.Another 4,000 crore will be spent in building road and rail links.

Union I&B minister Vaishnaw Ashwini said with the operationalisation of the port, the country's container handling capacity will be doubled. Vadahavan port with 20-metre natural depth will have the capacity to handle 23.3 million TEU (twenty-foot equivalent unit), a measure of volume in units of twenty-foot-long containers. It will emerge as one of the 10

biggest ports in the world and will create up to 12 lakh jobs. The port, located around 130 km from Mumbai, will be developed in two phases - first phase by 2030 and second phase by 2039 - and will have a cumulative capacity to handle 298 million tonne cargo per annum. A joint venture of Jawaharlal Nehru Port Authority Maritime Board of Maharashtra will develop this infrastructure project on public private participation mode. There will be no funding from the Budget. "The port will act as

Retail inflation easing, food prices remain a concern: RBI

NEW DELHI: Retail inflation is gradually easing but the path has been interrupted by volatile and elevated food inflation, which may cause it to reverse after a temporary fall below the target during the second quarter of 2024-25, a RBI bulletin said on Wednesday. The central bank has consistently cautioned about the volatile food prices, particularly of vegetables and some cereals, which have come under pressure due to the heatwave sweeping across some states. While prediction of normal monsoon rains may augur well for crops and improve supplies, the impact of weather related shocks needs close monitoring.

"As long as food price

pressures persist, however, the goal of aligning inflation with its target remains a work in progress," according to the RBI document. The central bank has a target of keeping inflation at 4% (plus/minus 2%). Latest data showed retail inflation, as measured by the consumer price index (CPI), slowed to a 12month low of 4.8% in May. Vegetables and pulses prices remained under pressure while core inflation which is estimated after stripping out food and fuel was steady at 3.1%. Food remained inflation unchanged at 7.9%.

The central bank said the prospects for agriculture are brightening with early landfall of southwest

monsoon. The stubborn food price pressures have for the time being pushed back any hopes of a cut in interest rates as RBI would like to assess the price situation against the backdrop of the erratic weather patterns, experts say. RBI has kept policy the unchanged at 6.5% and has reiterated its stance of remaining focused on the withdrawal of accommodation to ensure that inflation progressively aligns to the target, while supporting growth. The RBI bulletin said high-

frequency indicators suggest the real GDP growth in the first quarter of 2024- 25 is broadly maintaining the pace it achieved in the preceding

Hooch kills 29 in Tamil Nadu's Kallakurichi; more than 70 under treatment

KALLAKURICHI: At least 29 people died on Wednesday after drinking illicit arrack near Kallakurichi in Tamil Nadu on Tuesday night. More than 70 others are being treated in hospitals in Kallakurichi, Villupuram, Salem and Puducherry.

Police arrested a bootnamed Κ legger alias Govindaraj Kannukutti, 49, on charges of selling illicit arrack and seized more than 200 litres of the brew.Samples tested at a forensic laboratory in Villupuram were found to have the poisonous

methanol. Police said dozens of people from Kallakurichi town and neighbouring areas had consumed illicit arrack sold by bootleggers Karunapuram Tuesday night. On reaching home, most of them complained.

Monsoon at a standstill since June 12, stalled movement delays Kharif crop sowing

NEW DELHI: The monsoon, which made its onset over Kerala two days in advance and arrived in the North-East six days before its normal date, has remained almost at a standstill since June 12 after making gradual progress and covering roughly 40% of the geographical area during the first 14 days. The current relatively longer hiatus has not only contributed to the current heat wave phase but also delayed sowing operation of kharif (summer sown) crops in north and North-West



Though the India Meteorological Department (IMD),banking on upcoming La Nina formation, still maintains that the country is most likely to get fairly good rainfall during July-Sept, it has downgraded its forecast for June rainfall for the

country as a whole from 'normal' to 'below normal' due to the current pause in the movement of monsoon La Nina conditions - climate pattern associated with the periodic cooling of ocean surface temperatures in the central and east-central equatorial

India. Past data shows that the summer monsoon was either 'normal' or 'above normal' in most of the last 22 La Nina years since 1954 except 1974 and 2000 when it was below normal. Travelling to the United States with a Puma, Adidas, or Nike fake? Your bargain buys might just get confiscated - or even destroyed - by US customs officials.

With US Customs and Protection Border (CPB) stepping up its surveillance of smuggling of counterfeit goods, many Indian students and travellers who flew into America in recent months had their fake luxury items seized at port entry.Some told TOI they had to watch the staff run scissors through their clothes or ditch them in the

trash can. CPB rules say an individual can carry one counterfeit item of each type (like one shirt, handbag, or pair of shoes) provided it is for personal use and not for sale. Anything in "excess" of this is banned. I travelled to the US to meet my son, who is pursuing a master's in supply chain management in Texas. I was carrying eight shirts, four trousers, some socks, and a pair of shoes. All the goods were still packed as I had just bought them, said a schoolteacher from Jamshedpur,

Jharkhand. "At the port of entry

officials checked my bags and bombarded me with questions about where I was travelling from, who the goods were for, if I was smuggling them, etc. Though I tried explaining to them that it was all for my son, they insisted that I could not take them as they were all counterfeit goods - copies of big brands - which I wasn't aware of. This license applies to banquet halls, restaurants, hotels, and boarding facilities as well as tents, canopies, enclosures, and open spaces. Entertainment-related Section 422 of the Delhi Municipal Corporation (DMC) Act was used to make the decision. A spokesperson said, "The license covers music, singing, dance, electronic, digital, laser display, holographic projection, and virtual performance. We charge Rs 15,000 for registration.

Prayagraj: For the new academic session 2024-25, it won't be mandatory for the students to have appeared in the Common University Entrance Test (CUET) for admission in the courses being run by colleges affiliated to Allahabad University. Instead, their Intermediate merit will be the basis for admission to these colleges.

The University Admission Cell has issued guidelines for the students studying in the colleges who haven't appeared in CUET. This time, the university administration has given the exemption for direct registration to colleges, officials shared.

Admissions in undergraduate courses are being taken in Allahabad University and affiliated colleges through CUET since the dents being admitted to academic session 2021-22. Due to this process, the varsity campus seats are getting filled, but many seats in the courses offered by colleges are left vacant.

For most of the last year, only 50% to 60% of undergraduate seats in colleges got filled.

To fill seats in colleges, the university has now permitted that admission of students can be taken even if a student has not appeared in CUET.

However, first, the colleges will have to give priority to the students who appear in CUET. If seats remain vacant, colleges will be able to admit students who have not appeared in CUET based on merit list made on students' intermediate abled as well as SC/ST catmarks. Moreover, the stu-

Earlier, the students had to register at the university, after which one had to register by paying fees at the college concerned.

Director of AU Admission Cell Prof JK Pati said that admission to varsity campus will be given based on CUET score and if a student has registered in the university and has not been admitted, then he or she will be informed about this. They will not have to register again in the colleges by paying fees yet again. The registration fee has been fixed at Rs. 300 for general and OBC category students and Rs 150 for dis-

BID TO BOOST GREEN COVER

Over 73 lakh saplings to be planted in Prayagraj

Prayagraj: As part of an initiative to give green cover a fillip, plans are afoot to plant over 73 lakh tree saplings during the massive tree plantation exercise set to be undertaken next month in Prayagraj. A total of 24 government departments have each been allocated specific targets for tree plantations. Collectively, they will plant a total of

district, officials said. The Yogi government is continuously striving to develop the state as a green province.

"The development of green belts and extensive tree plantations in the city is part of this effort and the government machinery has already become active," they added. Confirming the development, nodal officer of the campaign and divisional forest officer, Prayagraj, 73,15,160 saplings in the Arvind Kumar, said the

forest department would itself plant 22,45,300 plants this time. Besides, the rural

development department will plant 29,87,000 saplings and the agriculture department will plant 5,09,000 saplings, Kumar added. Similarly, the horticulture department will plant 3,69,000 saplings and the environment department will plant 2,27,000 saplings and so on. "All departments have been informed of their

targets and instructed to prepare accordingly," he said. The tree plantations being undertaken each year are yielding positive results. According to DFO, Prayagraj, green cover in Prayagraj's urban and rural areas has grown significantly in recent years. Green cover in the district has increased by 27.06 square kilometres over the previous years. These positive outcomes are the result of the government's special

emphasis on tree planting. The report from the Forest Survey of India, Dehradun, confirms the city's and district's continuous increase in greenery. According to the report, green coverage in the district rose by 2.32% in 2017, 2.36% in 2019, and 2.85% in 2021.

The government's record for plant survival during last year's tree plantation is also commendable. As per the officials, 95% of the

71,92,852 saplings planted the previous year are still alive and thriving. After the plants were tagged, they received continuous irrigation and maintenance. As many as 68,33,000 plants that were planted last year are still green and thriving. Furthermore, dense tree plantings using the 'Miyawaki' method will be prioritised in urban areas this time,

India must kill terrorists. Nijjar blowback shows it also needs laws to guide assassins

Two bullets had been fired into his gut, and one between his eyes: The assassins authored the end of the book Henry Liu had been writing. From his modest home in the suburbs of San Francisco, the investigative journalist had relentlessly attacked the Kuomintang dictatorship in Taiwan. The hit men—members of the crime cartel United Bamboo Gang, recruited by Taiwan's military intelligence chief Vice-Admiral Wang Hsi-ling—declined payment for the job, seeing themselves as patriots silencing a dangerous Communist agent. Later, his wife Helen Liu, offered a simple explanation for why her husband was murdered: "In Taiwan, people cannot speak freely. And he had a big mouth." Earlier this week, police in Canada arrested three Indian nationals for the murder of Sikh separatist Hardeep Singh Nijjar, fuelling suspicions that India's Research and Analysis Wing (R&AW) has been targeting Khalistan operatives in the West. The men, alleged to be linked to the crime network of jailed gangster Lawrence Bishnoi, are being investigated for their ties to Indian intelligence officers that Canada has claimed were involved in Nijjar's assassination. The government of India has angrily denied the allegations—but in recent weeks, senior political leaders have seemed to defend the country's right to use covert means against its enemies overseas. "Terrorists will be killed in their homes," Prime Minister Narendra Modi said in one recent rally, amid reports that R&AW was eliminating terrorists in Pakistan. For many Indians—enraged by seeing the perpetrators of terrorist attacks from 1993 bombings to 2008 Mumbai attacks sheltering in safe havens in Pakistan, or Khalistan supporters openly calling for violence from the West—the use of covert means seems a legitimate exercise of power. This is not new. Following the bombing of the Indian embassy in Kabul in 2008, then National Security Advisor MK Narayanan demanded the country pay Pakistan back "in the same coin." Lawyers and political philosophers familiar with the complex history of assassinations by nationstates, though, would likely urge reflection on exactly when such force might be used-and what its consequences could be. "Although I may kill a man," the Renaissance jurist Alberico Gentili counselled the kings and princes of his violent times, "I may not do so by treachery." They listened, for good reasons. There is, no doubt, something profoundly spurious about the moral outrage that has surrounded India's alleged assassination campaign: The UK attempted to kill Libyan leader Muammar Gaddafi, and murdered Irish terrorists at home and abroad and Israel has long staged targeted killings. The US, lawyer scholars Luis Chiesa and Alexander KA Greenawalt have persuasively argued, ignored international law to kill cofounder of Al-Qaeda Osama Bin Laden and Colombian drug cartel boss Pablo Escobar. For its part, Russia frequently—and crudely—kills regime opponents overseas. Like India, nationstates everywhere have struggled to deal with criminals and terrorists their adversaries choose not to act against. However, the absence of an ethical norm doesn't mean that the many powerful arguments against covert action can be ignored. For most of history, international relations scholar Ward Thomas writes, assassination was used without scruple. Leaders of the ancient world regarded killing for public purposes as a moral project, and murder was seen as a legitimate foreign policy tool in the 17th century. The American scientist Morgenthau noted that "the Republic of Venice, from 1415 to 1525, planned or attempted. about two hundred assassinations for purposes of its foreign policy".

Accolades for being seen to have elevated India

process in the world, the Indian Lok Sabha elections 2024, has attracted the attention of one and all across the globe. This general election is a watershed moment for Bharat which will initiate the country towards its new self of 'Viksit Bharat' by 2047. It is only with the efficient implementation framework created by the Narendra Modi government that India jumped from the 10th largest economy of the world in 2014 to the fifth largest economy today. By 2027, hopefully, we are going to be the third-largest economy. Along with this, India's influence has also increased on global platforms, strategically and scientifically. With the successful launch Chandrayaan-3 to the Moon, the nation has registered its presence strongly in the field of science and technology. It has also emerged as a major exporter in space industry and defence equipment. Also, providing Covid vaccines to the entire world during the pandemic and show-

tional platforms has added to India's prestige manifold in world today. But he was ruled out, cut into pieces, and caged in the same bracket as Rahul Gandhi: a reluctant politician, an oddball to the tenacious legacy. High court upheld a single-judge bench's order dismissing a plea

bench of Madhya Pradesh high court on Friday upheld a singlejudge bench's order dismissing a plea by Congress' Moti Singh Patel for his candidature to be accepted as the party nominee for Lok Sabha elections after official candidate Akshay Kanti Bam pulled out of the poll race at the last minute. The Indore bench, comprising Justice SA Dharmadhikari Justice Gajendra Singh, said Patel's application was "bereft of merit and substance".

Patel had approached the division bench after a single-judge bench of Justice Vivek Rusia on April 30 turned down his plea to overturn the rejection of his nomination by district election officer and to be allotted the Congress 'hand' symbol to contest polls. Consumer affairs secretary Nidhi Khare said the Union government will use an Indian Standards code to combat fake customer reviews and inflated ratings on e-commerce platforms, a global issue, as online shoppers complain more on the national consumer helpline. Online shoppers are heavily influenced by customer reviews and ratings. E-commerce sellers manipulate ratings and add paid reviews to encourage sales. "The presence of fake reviews online jeopardizes the trust-

worthiness and credibility of shopping platforms and can cause consumers to make wrong purchase decisions," said Khare, who led a stakeholdmeeting with Amazon and Flipkart executives. Mordor Intelligence estimates that India's e-commerce market would expand from \$112.93 billion in 2024 to \$299.01 billion in 2029, a 21.5% CAGR. The new standard (IS 19000:2022) assigns reviewers and adminparticular duties. New regulations compel organiza-

Delhi: US President Joe Biden lambasted Beijing for "cheating" as he raised tariffs on Chinese products such electric vehicles and semiconductors.

Beijing strongly opposed the sanctions as Biden sought to appear tough on trade ahead of a rematch with Republican Donald Trump in November's



presidential election. "We're not going to let China flood our market, making it impossible for American automakers to compete fairly," Biden declared in the White House Rose Garden. He said. "We're never going to allow China to unfairly control the market for these cars," before ordering duties. Trump's tariffs have been frequently criticized by Biden. He's been using similar tactics to win over blue-collar voters in swing Rust Belt states. The White House stated EV tariffs will treble to 100% this year and semiconductor duties will rise from 25% to 50% by next year. The sanctions targeted \$18 billion in Chinese imports, including batteries, vital minerals, and medical supplies. Biden said China has substantially supported critical sectors, forcing corporations to produce more than the world can consume and flooding the market with unfairly priced commodities. The president's announcement followed a review of tariffs imposed by then-president Trump on \$300 billion in Chinese imports. The Biden administration maintained tariffs.
