Shaken Hasina flees, Army in charge

DHAKA: Bangladesh's embattled PM Sheikh Hasina (76) Monday resigned and fled the country following more than a month of deadly demonstrations that began as protests against job quotas swelled into a moveprecipitating the end of her 15year rule.

A source close to her told AFP her security team, gauging the mood on the ground, asked her to leave her residence and the country immediately and she didn't get any time to pack up or record a farewell speech.

Government set to table Waqf Act Amendment Bill in this session

NEW DELHI: The Bill to amend Waqf Act is likely to be introduced in Parliament during current session, sources said, adding it has been discussed with alliance partners. This comes against the backdrop of continuous demands and representations made by common Muslims to make the regulation of Waqf properties transparent, Union parliamentary affairs minister Kiren Rijiju on Monday. Rijiju, however, did

not share details of the Bill. Endorsing the proposed amendments and emphasising their potential benefits for both the Waqf system and the broader community, BJP's Mukhtar Abbas Naqvi, said, "It's good for both - Waqf and 'waqt (time)'."

SC refuses to stay Calcutta HC order quashing expansion of OBC list

NEW DELHI: Supreme J B Pardiwala and Manoj Court on Monday refused to stay Calcutta high court's May 22 judgment quashing inclusion of 77 communities, 75 of them Muslims, in West Bengal's OBC list and sought details of surveys determining their social and educational backwardness and under-representation in govt jobs requiring their inclusion in the OBC list. Sen, aiming to be India's first male shuttler to win an Olympic medal, faced a tough matchup against Malaysia's world no.7 Lee Zii Jia in the bronze playoff. Despite a strong start,

DGGI sends show-cause notice to crypto exchange



AHMEDABAD: The Ahmedabad zonal unit of the Directorate General of GST Intelligence (DGGI) has issued a show-cause notice to a major cryptocurrency exchange, demanding Goods and Services Tax (GST) payment of Rs 722 crore. This marks the first time the DGGI has issued such a notice to a cryptocurrency firm, setting a precedent in India's efforts to regulate the rapidly growing virtual currency market. Sources confirmed that the notice was issued to the firm for collecting fees from Indian customers trading in virtual digital assets (VDAs) on their platform, categorized under online information database access or retrieval (OIDAR) services. Earlier this year, the cryptocurrency firm had received approval from India's financial intelligence unit (FIU) to register as a virtual asset service provider (VASP). However, the company was slapped with a Rs 18 crore penalty from the FIU last month for non-compliance with anti-money laundering (AML) regulations. Despite being a major player in the global cryptocurrency market, with a sizeable market share and operations in multiple countries, the company had not registered under the Indian GST framework. This oversight has now brought it under the scrutiny of Indian tax

"The company reportedly earned at least Rs 4,000 crore from transaction fees charged to Indian customers. The company has a user base of 90 million users globally, including a substantial number of customers from India too. Detailed investigation revealed that the earnings of these fees were credited to the account of a group company based abroad.

GST on health & life insurance fetched Rs 21,000 crore in 3 years

NEW DELHI: Amid growing demand for a cut, if not removal, of GST on health and life insurance, government Monday told Parliament that the levy fetched it Rs 21,256 crore during the last three financial years, with Rs 8,263 being collected during 2023-24. Responding to a Parliament question, minister junior finance Pankaj Chaudhary said another Rs 3,274 crore was

received as GST from reissuance of health policies during last three years. The GST Council had fixed 18% rate when the new regime kicked in from July 2017. According to the formula, the Centre collects 9% GST with a matching collection by states.

From the Centre's kitty, 41% is shared with the states in line with the devolution formula. To a question on

All nine lease holders will get 0.011 hectare respectively. Personality rights have gained importance

"A few celebrities may choose not to pursue legal action due to various reasons such as the perceived insignificance of unauthorised use, the costs involved in litigation, or a desire to avoid negative publicity," says Shoeb Masodi, Partner, M&P IP PROTECTORS. Personality rights, as the name implies, pertain to the rights associated with the personality of a well-known individual, primarily applicable to celebrities whose names, images or voices are prone to misuse for profit. The concept dictates that only the owner or creator of these attributes has the right to derive monetary benefits from them. Personality rights have gained importance alongside the right to privacy given the kind of fame celebrities enjoy today. In 1995, the Supreme Court recognised a person's right to control the commercial use of one's identity in the R Rajagopal vs. State of Tamil Nadu case, commonly known as the Auto Shankar case. In 2015, the Madras High Court intervened to protect actor Rajinikanth's personality rights, halting the release of the movie Main Hoon Raiinikanth. The filmmakers had utilised the actor's name and style without his express permission, with the title itself serving as a clear indication of its connection to Rajinikanth. In yet another case involving actor Amitabh Bachchan, the Delhi High Court in November 2022 restrained the use of the actor's name, image, voice, or any of his characteristics without his consent. It is crucial to note that in intellectual property right cases, it's often impractical to name all infringing parties, leading affected parties to seek blanket injunctions or ban orders, known as 'John Doe' orders. Originating from the UK, John Doe orders are passed by a court against unknown defendants and the world at large. In September 2023, the Delhi High Court ruled in favour of actor Anil Kapoor in a case filed by him to protect his image and personality from misuse by third parties. Kapoor had petitioned the court, stating that several parties were using aspects of his personality.

, including popular terms from his dialogues. , like 'Jhakaas,' 'Lakhan,' 'Mr. India,' 'Majnu Bhai,' and 'Nayak', without his permission. The court was also informed that third parties were unfairly benefiting commercially from the sale of merchandise featuring his pictures and voice for ringtones. Most alarming was the online circulation of fake pornographic images and videos of the actor with other actresses. Notably, in its order, the Delhi High Court stated that satirical writing and genuine criticism would be safeguarded and not construed as violations of personality rights. While the word 'Jhakaas' can be used by people, they cannot exploit it commercially in the manner Anil Kapoor does. Similarly, it can be used for satire, criticism or parody, but not for monetary gains. In the Jackie Shroff case as well, the court declined to order the removal of a video titled 'Jackie Shroff is Savage, Jackie Shroff Thug Life', posted on a YouTube channel named 'Thugesh'. The court deemed the video a form of artistic expression and said imposing restrictions would have significant consequences. In the Anil Kapoor case, the court established the protection of personality rights in the realm of AI and deepfakes. However, this hasn't deterred the illegal use of celebrities' personal attributes for financial gains. Regarding the existing laws, advocate Naik says: "I feel the current laws and the jurisprudence that we got from the Delhi High Court in matters of Mr. Bachchan or Mr. Kapoor are good references. I personally feel the time has come for us to protect personality, like the one provided by the Copyright Act." However, the

Modi government's stance towards fiscal policy

Finance Minister Nirmala Sitharaman's presentation of the interim budget on 1 February and the Union budget on 23 July, the main event was the Lok Sabha election that brought the BJP-led NDA back to power but with a reduced majority. The impact of this sole event is evident in the differences between the two budgets, which not only inform us about the shift in the Narendra Modi government's stance towards fiscal policy but also tells us how the ruling party is reading the election results and what it intends to do about them.Here is how the two budgets compare in terms of allocation and what they reveal are the government's priority areas. There are only a few changes in expenditure allocations, and most of them can be linked to the areas that the finance minister emphasised in her budget speech The biggest change is in the budgeted transfers to the states. For 'special' and other 'needbased assistance' for which budget provision is not made, the Centre earmarked only Rs 4,000 crore in the interim budget; but in the Union budget, this has been raised to Rs 20,000 crore. The other is zero interest loans for capital expenditure for 50 years, which basically makes them a grant. For this, the government has allocat-



ed Rs 1,50,000 crore in the Union budget, up from Rs 1,30,000 crore in the interim budget. These as well as the emphasis on certain states in the finance minister's speech reflect the realities of coalition politics. The Modi government wants more freedom of action in making states. Another difference is in the allocation for the price stabilisation fund (PSF) scheme, which will be used for "maintaining buffer stock of pulses, onions and potatoes and making sufficient availability of said commodities in the market so as to cool down the prices as and when required". From no expenditure made in the last two years and no allocation in the interim budget, the government has moved to allocating Rs 10,000 crore to this fund, the biggest so far. Perhaps the government is expecting some of these commodities to see high

inflation and is willing to absorb some losses to bring down the prices. The finance minister's speech emphasised employment and skilling, with new allocations. About Rs 10,000 crore has been allocated for a new Employment Generation Scheme. Sitharaman announced three schemes. The first is a subsidy of up to Rs 15,000 to people entering the workforce in the formal sector, which would be given as a direct benefit transfer in three instalments. The second is to incentivise additional employment in the manufacturing sector, linked to the employment of firsttime employees, by providing an incentive directly both to the employee and the employer with respect to their EPFO contribution in the first four years of employment. The third

ment to employers up to Rs

3,000 per month for two

Delhi : A new treaty **finali**zed by members the World Intellectual Property Organization (WIPO) requires patent applicants to reveal the nation of origin or the source of genetic resources if the claimed invention is derived from those materials or related traditional knowledge. One of the main demands of the developing world, led by India, is the treaty that will offer extra protection for Indian genetic resources and tradiknowledge, tional including yoga, siddhi, and ayurveda. The agreement was finalized by the Genevabased agency that is in charge of developing regulations pertaining to patents and trademarks. This will force some nations to revise

their domestic laws. Rather than trying to register patents to take advantage of the immense traditional knowledge and genetic resources, India has asked that the world's largest corporations give credit to these resources. Even while there is protection against misappropriation in India and other nations without disclosure requirements, the disclosure standards will offer protection international-

Currently, there are disclosure requirements in 35 countries, the majority of which are voluntary and lack the necessary legal framework to be implemented successfully. For the first time, the knowledge and wisdom that have long underpinned

Four Naxalites killed in encounter with security forces in Maharashtra's Gadchiroli

NEW DELHI: Four Naxalites were killed in an encounter with security forces in Gadchiroli district of Maharashtra Tuesday. The superintendent of police in Gadchiroli, Nilotpal, said that the security teams encountered gunfire from the Naxals during an early morning search operation in the Kolamarka mountains.

"A credible intelligence was received on Monday afternoon that some members of Telangana state committee have crossed Pranhita river from Telangana into Gadchiroli with an aim to carry out subversive activities during the Model code of conduct period of upcoming Lok Sabha elections," Gadchiroli SP said. In response, multiple teams including C60 and CRPF QAT were dispatched from Aheri Sub Police headled quarters Additional SP Ops Yatish Deshmukh for

area searches.



"One of the teams comprising of 4 C60 parties while searching today early morning in Kolamarka mountains 5 km SE of SPS Repanpalli were fired indiscriminately by Naxals, which was retaliated strongly by our C60 teams. After the firing stopped and area searched, 4 male naxal bodies have dead recovered," been Gadchiroli SP added. The recovered items included weapons and personal belongings.

Among the deceased high-ranking were Naxal leaders DVCM Vargeesh and DVCM Magtu.

The operation also platoon targeted members Kursang Raju and Kudimetta Venkatesh, all of whom carried a combined cash reward of 36 Lakhs as declared by the Maharashtra government, SP said. Following encounter, search and anti-naxal operations are underway in the region.
