Minimum wages for unorganised sector to rise as variable DA up

NEW DELHI: The Centre unveiled increase in minimum wage rates for workers in the unorganised sector by revising the varidearness allowance (VDA).

The minimum wage rates are categorised based on skill levels unskilled, semi-skilled, skilled, and highly skilled - and by geographical area: A, B, and C (categorised by cost of living).

After revision, minimum wage rates in area 'A' for workers in construction, sweeping, cleaning, loading and unloading for unskilled work will be Rs 783 a day (Rs 20,358 per month), according to the statement.

"This adjustment is aimed at helping workers cope with the rising cost of living," said an official statement.

Undertrial in Pulwama terror attack case shifted to Jammu GMCH

JAMMU: Bilal Ahmed Kuchay — a 27-year-old undertrial prisoner involved in the Pulwama terror attack in which 40 CRPF personnel were killed on Feb 14, 2019 — was shifted from Kishtwar District Jail to Jammu GMCH's ICU early Tuesday after he developed health complications. The 27year-old suffers from Guillain-Barré drome, a condition wherein the body's immune system attacks the nerves, causing weakness, numbness or paralysis. NIA had arrested Bilal, a sawmill owner, in July 2020 for his links with the Pulwama attack and booked him under relevant sections of the law, including UAPA. A native of Hajibaal-Lalhar, Kakapora, in Pulwama district, Bilal was the seventh accused arrested.

"Pervasive problem of violence against women in India" will not be solved

LONDON

A new academic study has found that the "pervasive problem of violence against women in India" will not be solved by men protecting women, as such patriarchal sexist beliefs can also be harmful. The first large-scale analysis of associations between sexism and tolerance of violence against women in India, written by academics in the UK, New Zealand and US, has found that patronising beliefs about women



that are framed in protective terms can make them more vulnerable to violence as they create a power dynamic in which women are subordinate to their male partners. "Prescriptions that women should be protected from out-

siders can simultaneously legitimise men's dominance within relationships, thus reinforcing the very inequalities that make women more vulnerable to violence," the paper said.

research paper, titled "Ambivalent Sexism and Tolerance of Violence Women in India", has been published by Psychological Science, a top empirical journal in psychology and the flagship journal of the USbased Association.

Biden gives 'salesman' Zelenskyv more weapons as Trump fumes about US getting suckered

WASHINGTON: US President Joe Biden Thursday announced an \$8 billion "surge" in "security assistance" to Ukraine, including supply of a glide bomb that will enhance Kyiv's strike capability against Russia. Moscow has warned that use of missiles that can strike deep into Russia could trigger nuclear retaliation.

The White House announcement of the military aid, which came ahead of Zelenskyy's meeting Biden and with Kamala Harris in Washington, drew a furious response from the MAGA leadership and its rank and file, which is accusing the Ukrainian leader of bilking American taxpayers and leading the US into a world



war. MAGA supremo Donald Trump denounced Zelenskyy as the "greatest salesman in history" saying at a rally that "every time he comes into the country, he walks away with \$60 billion," while arguing the US is stuck in the Ukraine-Russia war and will not be able to get out unless he becomes president. 

Therefore, taking these medications, whether in injectable or oral form, should never be done without proper medical supervision. Traditional

medicine teaches that every individual has a unique body type and metabolism, and taking any medication without assessing a person's constitution can be ineffective or even harmful," says Dr Ravishankar Polisetty, the pioneer of Poly Scientific Ayurveda (PSA).

France offers a welcome breather for India

Prime Minister Narendra Modi with chief guest French President Emmanuel Macron during the 75th Republic Day parade, at the Kartavya Path, PTI Between them, US President Joe Biden and rival Republican Party's Nikki Haley seem bent on pushing India closer to France for a balanced relationship in the western world that has all the ingredients of strategic stability, both in the bilateral and multilateral contexts. That is if one were to leave out India's Russia relations, which many believed were rocky but became sort of rock steady all over again owing to the Ukraine War, where the long American arm was seen all over

Yes, Nikki Haley, 51, is not even Biden's likely rival in the US presidential polls in November. She did not mean to question, challenge or rebuke India, either. Instead, by claiming that India was moving closer to Russia than the US, implying that the Biden presidency did not inspire confidence not only in New Delhi, but also in Tokyo and Seoul, Canberra and Wellington, Halley was only targeting the incumbent back home. But her choice of India, and not any of America's NATO allies, for example and her choice of words, gave the impression that she was trying to convince a certain section of Republican voters that she was all American, and not Indian. It has to be front-runner and former president Donald Trump. Halley is trailing the Republican primaries and polled lower than their kind of NOTA in Nevada, but that does not make sure that Trump's name will be on the ballot. Indications are that at some point, either the Republican Party bosses or American courts could make it embarrassing for Trump's name to be on the ballot. Halley seems hoping for that day and is persisting in the primaries precisely for this reason. Maybe, like a typical Indian-origin woman that she is, Halley is hoping for 'sympathy votes' or 'survivor's votes', first in the primaries and later in the presidential poll. Of course, there is a long way to go this time than any time in the

Disappointment for India

Biden kept India waiting and eventually turned down the invitation to be the chief guest at the annual Republic Day celebrations. Information about India's invitation having spread after a time (generally it is kept secret until accepted - which again used to be a formality), Biden's avoidablydelayed rejection was a disappointment for India. It is not known how the Indian-American supporters of Biden and the Democratic Party feel about it. Not-so-official news sources claimed that Biden's decision owed to the election year commitments on campaigns and other essentials. In his place, another Democratic president. Barack Obama, took a short break from his socalled pressing engagements back home to be present in Mumbai first and Delhi next, where he was the chief guest at the 2015 Republic Day. Of course, in true American form and style, it was not a visit confined to honouring contemporary India's tryst with destiny. Obama did hard-selling business in an election year and took back orders for Boeing, which he said would ensure 20,000 Americans did not lose their jobs. Biden was constrained by domestic perceptions, both inside the Democratic Party and outside.Maybe, Team Modi too thought that having Biden would be a high-profile commencement to the ruling BJP-NDA's campaign for the Lok Sabha polls in the summer. To an extent, it compares with the 'Namaste Trump' show that India put out for the US President of the time, in February 2020 amid the farmers' rally in New Delhi. The Ahmedabad rally in particular was only a mirror-image of the Trump show for the Indian prime minister, 'Howdy Modi' in Houston months ear-

lier in Houston, Texas. This is as far as India's American relations go. Of course, there are the larger.

Anchored in Shivaji's spirit, India's naval operations get a desi touch in international waters

By carrying out back-to-back rescue operations in the past month, the Indian Navy has emerged as the bright spot in the otherwise unstable waters of the Red Sea. The Israel-Hamas war has not only thrown the Middle East into a flux but its effects are now also spilling over to South Asia and the wider expanse of the Indian Ocean

The worsening security concerns in the Red Sea due to constant attacks from the Yemen-based Houthis on cargo ships have further been exacerbated with Somali pirates also targeting the ships passing through this region. As the security situation in the Red Sea and also in the Arabian Sea has deteriorated, the Indian Navy has now emerged as the net security provider in the Indian Ocean Region. Indian Navy has always been exemplary in its duty and in particular, has always been proactive in benign causes like Humanitarian Assistance and Disaster Relief (HADR) operations. However, with the spill-over effects of the war in the Middle East threatening the security of the Indian Ocean Region, India is asserting its position as the resident power and as the primary stakeholder in the security architecture of the region. India's rescue operations and in particular the role of the Indian Navy not only correspond to the existing global order. The current security concerns may have pronounced the role of the Indian Navy. But there is also a strong civilisational undertone to India's



naval operations. This undertone could be considered from decolonisation and indigenisation perspectives. The decolonisation narrative has been a major issue in the Indian political discourse for a long time. However, in the past few months, there has been a tangible and accelerated effort towards decolonisation and indigenisation across different spheres. Some important steps in this direction include the use of the name Bharat instead of India. This was the highlight when India hosted the G20 Summit in September 2023 as the placard in front of Prime Minister Narendra Modi displayed the name Bharat. Besides, three criminal justice laws, the Bharatiya Nyay Sanhita, the Bharatiya Suraksha Sanhita and the Bharatiya Sakshya Act, recently passed by the Indian parliament also seek to replace the colonial-era Indian Penal Code, the Code of Criminal Procedure and the Indian Evidence Act. The recent consecration of the Ram Temple in Ayodhya is projected as one of the most prominent steps towards

decolonisation. Also, the scope of the decolonisation narrative has now expanded. For decades, only the 200year British rule in India was earmarked as the colonial period in the collective memory of the Indian people. Now the 200-year period is being replaced by a period of about 1,000 years which includes the Islamic invasions in India. This indigenisation process which is becoming visible in the political, legal and cultural domains is gradually gaining emphasis in the security domain as well. Just as the decolonisation debate had been restricted to British rule, the same principle was evident in Indian strategic thought as well for a long time. As one of the relics of British rule, the continental mindset had remained a norm in Indian strategic thought for a long time.

The continental mindset crept into India's security outlook as a legacy of the British who were engaged in the Great Game with Russia. It led to the British focusing more on the territorial aspect of security to stop India. This included courting countries and regions in the Northwest and Northeast such the Central Afghanistan, Asian Khanates (as they were then known), Tibet and China. This thinking consolidated even after independence as India faced perpetual security concerns from Pakistan and China. As a result the fact that India was one of the major maritime nations in the world since time immemorial was greatly sidelined. However, in the past about one decade, the maritime domain has been regaining its importance in India's strategic circles. The emergence of the geostrategic concept of the Indo-Pacific Region and China's belligerence in India's neighbourhood and extended neighbourhood have caused India to increase its focus on strengthening the naval arm of its military. The growing focus on the Indian Navy has essentially been accompanied by decoupling the Indian Navy from its British legacy and taking it back to its indigenous roots. To achieve this, the government has evoked Chhatrapati Shivaji Maharaj who is considered as the Father of the Indian Navy. Shivaji, who inherited a landlocked region, recognised the importance of sea access and navy. His strategic vision proclaimed: 'He who owns the Navy owns the Sea'. Shivaji foresaw that the Navy was essential not only to defend his kingdom but also to protect sea trade. At the peak of his rule, Shivaji successfully

Russia's advances against built sea forts to defend the coastlines extending through Konkan. Starting from scratch with around 18-20 ships Shivaji built a fleet of more than 500 ships. To decolonise and indigenise its naval strategic thought, India is now identifying itself with Shivaji and letting go off the British legacy. In September 2022, Prime Minister Narendra Modi unveiled the Indian Navy's new ensign that is inspired by Shivaji and dropped St George's Cross from the colonial era. On 4 December, 2023, on the occasion of Navy Day, the Indian Navy held an operational demonstration (Op Demo) at Tarkali Beach on the West Coast against the backdrop of Sindhudurg Fort built by Shivaji.Further recently the government has proposed listing of Maratha Military Landscapes of India for the UNESCO World Heritage List for the year 2024-25. This list includes 12 forts, 11 of which are in Maharashtra and one is in Tamil Nadu. It is pertinent to note that out of these 12 forts, four forts Sindhudurg, Vijaydurg, Suvarnadurg and Khanderi are sea forts in Maharashtra along the Konkan coast. These four forts were developed by Shivaji as the naval bases of his state. The Navy had played an important role in consolidating the Maratha rule, which reached its peak during the reign of Shivaji. Maharashtra Polls: Congress, Pawar Bargain Hard with Uddhav

Intense negotiations are underway ahead of the crucial assembly elections Maharashtra. Former Chief Minister Uddhav Thackeray was recently in Delhi to meet Rahul Gandhi, Mallikarjun Kharge, and Sharad Pawar for discussions. The opposition alliance, MVA/INDIA, which includes the Congress, the Shiv Sena (Uddhav Bal Thackeray, or 'UBT'), and the Nationalist Congress Party (Sharad Pawar), aims to build on the momentum from the general Mahayuti/National Democratic Alliance (NDA) government, consisting of the Bharatiya Janata Party (BJP),

Shiv Sena (Eknath Shinde), and the NCP (Ajit Pawar), by capitalising on perceived anti-

incumbency. During the general elections in 2024, the Shiv Sena (UBT) contested 21 seats, the Congress 17, and the NCP (SP) 10. The Shiv Sena (UBT) had the lowest strike rate, winning only nine of the 21 seats (43%), while Congress and NCP (SP) had strike rates of 76% and 80%, winning 13 and eight seats, respectively.

This disparity has led to conelections and challenge the cerns within the Congress and NCP (SP) that the Shiv Sena (UBT) was allocated more seats than warranted, and that this should not serve as the

basis for seat-sharing in the assembly elections. The Shiv Sena (UBT) wants to contest the maximum number of seats again in the assembly polls. The Chief Ministerial candidate is another contentious issue. Uddhav Thackeray has stated that it is up to the MVA

leadership to decide whether he should be the alliance's CM candidate. While the Shiv Sena (UBT) is advocating for a CM candidate, the Congress and the NCP (SP) prefer to go to the polls without a designated name and decide the top post based on the number of MLAs each party secures. These are the various seat-sharing formulas under consideration: This formula proposes that all three parties—Sena (UBT), NCP (SP), and Congress—contest approximately 90-95 seats each, leaving the remainder for smaller parties. This approach is supported by their similar vote shares (16%-17%) in the 2019 assembly polls.

The Supreme Court has also brushed aside specific grievances with the delimitation exercise. It held that as the election date has been announced these objections cannot be entertained. After the delimitation exercise the strength of the NA is 336. Of these 266 are to be general seats, 60 seats will be reserved for women and 10 for non-Muslims. The women and non-Muslim seats will be allotted to the parties on the basis of their performance in the general seats. The allocation of general seats on a provincial basis is thus: Punjab—141, Sindh—61, Pakhtunkhwa—45, Khyber Baluchistan—16 and the Federal Capital area-3. This election, as those in the past, will be won or lost on the basis of the performance of the parties in the general seats. Also, as in the past, Punjab has more seats than the combined number of the other three provinces and the Federal Capital Area; thus, the party which controls Punjab controls Pakistan. This is a permanent feature of Pakistan's political life. Army chief General Asim Munir will seek to make sure that former prime minister Imran Khan's Pakistan Tehreek-e-Insaaf (PTI) does not succeed in the elections. The events of 9 May when the PTI workers and supporters attacked army installations and the monuments of martyrs have ensured that the gulf between Khan and Munir cannot be bridged. Khan has been in prison since May

not given him bail. Munir has also purged a large number of senior officers who were believed to have sympathies for Khan. The army is, therefore, firmly under his control. There have been desertions of leaders from the PTI. As of now, it appears that the army's desire to finish off the PTI electorally will prevail. With that, the PML(N) of the Sharifs should succeed in the Punjab. Its chances have increased with the return of its leader Nawaz Sharif two months ago from London where he has been since 2019.

However, Nawaz Sharif, thrice prime minister in the past is a shadow of the political leader he was. He looks infirm and without vigour. Instead of rousing his supporters and others by giving out a firm programme which will seek to resolve Pakistan's myriad problems, beginning with its grave economic situation, he is obsessed with the past injustices he and his daughter Maryam Nawaz have had to face. He is railing against his past adversaries, including the army, which manoeuvred the 2018 national elections in favour of Imran Khan. Nawaz Sharif is relying on Munir to create conditions which will tilt the electoral field in PML(N)'s favour in the polls. It was he who had insisted that Munir should succeed the former army chief General Qamar Bajwa in November 2022 even though there were technical difficulties in his elevation to head the army. Obviously, Nawaz Sharif feels that Munir nurses great grievances against Khan going back to the period when Khan, as prime minister, had pressured Bajwa to oust him from the DG ISI's post.

Comments by Mr. Abheek Barua, Chief Economist -**HDFC Bank on RBI RBI Monetary Policy Committee**

Ambala/Hisar: As expected, the RBI kept its policy rate and stance unchanged. Although, the MPC decision saw two dissents instead of the one seen in the previous policy. The one positive out of the policy was the upward revision in the GDP growth forecast to 7.2% from 7% earlier for FY25. On the other hand, inflation forecasts were kept unchanged.

The RBI remains in a wait and watch mode to assess domestic developments like the monsoon performance, food inflation, and the new fiscal strategy before moving on rates. We continue to see the possibility of a rate cut in Q4 2024. Despite the governors' emphasis that monetary policy decisions are driven primarily by domestic considerations, we think that any rate cut action could end up being aligned with the timing of the Fed's rate cut cycle to limit financial market volatil-

On the regulatory front, the increase in bulk deposit limit to INR 3 crore from INR 2 crore, signals the RBI's intention to encourage banks to garner greater retail deposits to fund credit growth.



Ghaziabad Residents Drink Nearly Rs 400 Crore in Beer During Heatwave



Delhi: The excise agency reports that Ghaziabad residents have consumed approximately Rs 400 crore in beer due to the past three months' scorching. Officials credit high heat and consistent prices for this record sales result. People in Ghaziabad and the National Capital Region sought ways to cool themselves due to extreme heat. In addition to lemonade, lassi, and buttermilk, many Ghaziabad inhabitants chose alcoholic beverages, especially beer, which generated large excise money. Ghaziabad beer drinkers spent Rs 397.16 crore during April to June 2024, up 106% from the previous year. Even more, beer can sales rose 116%. Over 13.3 million cans were sold this year, up from 11.5 million last year. Beer helps many cope with soaring temperatures. Due to this tendency, the excise department saw significant income growth throughout these three months. District excise inspector Rakesh Kumar said the severe heat and stable beer pricing drove record sales. said, "The data clearly shows that the intense heat and no price hike were the primary reasons for the exceptional revenue of Rs 397 crore." 

Aundh-Baner residents grapple with inadequate garbage disposal problem and its consequences

Ill-equipped waste disposal systems, leading to garbage getting piled at various points, is a cause of worry for residents of Aundh, an area which is otherwise considered as one of Pune's most developed and progressive zones. Residents are concerned about the problems that could be caused by frequent dumping of trash at various spots in the Aundh-Baner areas, such as those between Jupiter Hospital and Nagras Road. "I know there are these agencies that dump garbage anywhere in Aundh; there are specific spots. There is no control at all," noted Subhabrata Sanyal, 51, a resident of Kumar Padmalay. He said the waste menace could also draw in more stray dogs, posing a threat to people going for morning and evening

"When you walk onto the streets, you can see food littered all over, that attracts stray dogs. In case we go near the garbage by mistake, these animals could even attack us," observed Deepa Adiga, 47, a resident of Sylvan Heights. Residents blamed lack of a proper collection system by the municipality for the mounting garbage piles. "Sometimes the municipal truck may be arriving at a particular time and the waste is generated later, particularly by restaurants where the waste is generated very late at night, post 11 pm or midnight, after the restaurant is closed," said Anil Gokarn, founder of ProEarth Co., a company that deals with effective waste management.

No request yet from Nikhil Gupta for consular access: MEA

New Delhi: Indian authorities haven't received any request for consular access from Nikhil Gupta, the Indian national extradited to the US the Czech Republic following allegations of his involvement in a foiled plot to assassi-Khalistani nate extremist Pannun. Gupta, who was arrested in the Czech Republic in June last year, was extradited to the US on June 14. "He was extradited to the US on June 14. We have so far not received any request for consular access from Gupta but his family has got in with us," touch Affairs External Ministry spokesperson Randhir Jaiswal said. "We are in touch with the family mem-



bers and are looking at the matter as to what can be done on their request," he said during his weekly media briefing while replying to a question. Gupta, 53, pleaded not guilty when he was produced in a court in New York on June 17. While Gupta was in custody of Czech authorities, Indian officials were given consular access to him on a few occasions. Last November, US federal prosecutors charged Gupta with working with an Indian government

employee in the foiled plot to kill Pannun in New York. Pannun, wanted in India on terror charges, holds dual of the US and Canada. The issue of consular access to Gupta would be decided in line with provisions of the Vienna Convention Consular of 1963, people familiar with the matter said. Article 36 of the Convention that a detained person will have to make a request for consular access to authorities of his or her country. "Nevertheless, consular officers shall refrain from taking action on behalf of a national who is in prison, custody or detention if he expressly opposes such action," the article states.


