India, Italy seek to enhance ties in clean energy, Al and telecom

33% of seniors without income, 65% financially insecure: Study

NEW DELHI: One in every three elders reported not having any income in the past one year, 32% elderly or their spouses had an annual income of less than Rs 50,000 and only 29% elderly reported having access to social security schemes like old-age pension, contributory pension or provident fund. Nearly, 65% of elders reported that they were financially not secure with their current income andaccess to savings and investments.

These findings are part of a report released by voluntary organisation 'HelpAge India' on the eve of World Elder Abuse Awareness Day observed on June 15.As many as 5,169 elders and 1,333 caregivers' primary family members were surveyed across 20 Tier I and Tier II cities, in 10 states. The study captured the experiences of elderly from cities like Jaipur, Faridabad, Panipat, Kanpur, Indore, Kolkata, Bhubaneswar, Ahmedabad, Mumbai, Solapur, Chennai and Bengaluru.


These findings are important in backdrop of significant demographic shift in India with population above 60 to double from 10.5% in 2022 to 20.8% by 2050. The report, 'Ageing in India: Exploring Preparedness Response Challenges', showed that only 31% elderly reported access to health insurance. Elder abuse continues to be a major concern, with 7% elderly admitting to being a victim of abuse with sons (42%) and daughters-inlaw (28%) being primary perpetrators. "A higher percentage of elderly who faced abuse in past year were illiterate, and the abuse increased with decrease in income of elderly, as majority of the respondents (73%) who faced abuse reported an annual income of less than Rs 100,000," the report said.

Tata Group may take majority stake in this Chinese smartphone company in India

NEW DELHI: The Tata Group is reportedly advanced discussions to acquire a majority stake in the Indian unit of BBK Group-Chinese owned smartphone maker Vivo, according to sources familiar with matter who the spoke MoneyControl.

While the talks have progressed significantly, with a focus on valuations, a final deal has not yet been reached. MoneyControl's sources indicate that Vivo is seeking a higher valuation than what the Tata Group is currently offering. However, the Tata Group remains interested in the potential acquisition.

AU entrance test for PG courses this month, results by July

Prayagraj: The process of applying for admission to 62 postgraduate courses in Allahabad University (AU) and its 11 affiliated colleges concluded on Wednesday. Nearly 57,803 candidates had registered by Wednesday evening and of which, 34,357 finally submitted the applications by paying the fees after completing all formalities. Officials said the AU administration is preparing to conduct the entrance examination in June itself with results likely in the first or second week of July. The counselling is expected in the third week of July. The entrance examination will be conducted in both online and offline mode in both the cases, along with New Delhi, centers will be set up in Prayagraj, Lucknow, Kanpur, Gorakhpur, Varanasi, and Bareilly. Online examinations will be conducted only in Bhopal, Kolkata,

Patna and Thiruvananthapuram, officials said. Enrolled students can make alterations in application forms online till June 15. The official website will remain open from June 14th to June 15th till 5 pm for a record number of 34000 students, who have applied for postgraduate courses in AU and constituent colleges this year, to make any alterations to their application forms. Last year 31,248 candidates applied. "These amendments could be made in 15 categories, including names of father-mother, date of birth, gender, address, marital status, aadhaar card number, annual income of guardian, domicile state, educational qualification, hostel, police case, ABC ID, e-mail and mobile number," said professor JK Pati, AU's director, admissions. He said amendments in the applicant's name, course, and disability category will not be allowed. The submission of applications for the postgraduate entrance test (PGAT) began on May 16. Earlier, the last date of submitting application was June 5th, later extended to June 12th.

After the construction was completed, the engineers from Municipal Corporation started pressuring the executing agency to remove one of the two furnaces of the newly-constructed cre-

The plan for the construction of the crematorium was made and approved a year ago, after the Prayagraj Municipal Corporation (PMC) leased land from the Northern Railway for the construction of this electric crematorium at Phaphamau Ghat. In exchange for the connection, said a repreration had deposited a fee of Rs. 46,000 to the Northern Railway (NR). The construction of the crematorium started last year after getting permission from the NR. Its foundation stone was laid by Prayagraj Mayor Umesh Chandra Ganesh Kesarwani.

Even as its construction continued, no one objected to the two furnaces. The municipal corporation administration even sent a notice to the executing agency and imposed a fine for not completing the work on time. Based on two furnaces, an application was made a month ago for a 200kilowatt electricity connection combined with a deposit of Rs. 55 lakh for the sentative of the executing agency. Now for removing one of the furnaces, one will have to apply again to the power department to rewatts. Though the PMC officials remained tightlipped on the demand to remove one of the two furnaces, even though the facility was set up according to the approved plan, Mayor Umesh Chandra Ganesh Kesarwani conceded that the engineers should have taken the right action during the construction phase. He further said that he would speak to the officials to remove the hurdle and get the crematorium functioning as the

Primary schools cater to students till class 5, upper primary from classes 5 to 8 and composite schools from classes 1 to 8. The data for academic session (2023-24) was shared by officials at a Delhi meeting held in connection with the annual action plan and budget (2024-25) for the Samagra Shiksha Abhiyan in the Department of School Education and Literacy under the Union ministry of Education, New Delhi.

"The most worrying thing is that the teacher-student ratio in 37.13% of these schools is not in as per RTE norms. Now, construction has already instructions have been issued to provide teachers in schools as per the set standard,"

said an official of the state basic education department.

As per the data (copy of which is with HT), 56 schools have no students. What's more, 12.50% of teaching posts are vacant in the State Council of Educational Research and Training (SCERT), the institution responsible for quality enhancement and teacher training in government primary and upper primary schools and 40.57% of teaching posts are vacant in the District Institutes of Education and Training (DIETs). "Instructions have been given to fill these posts on priority as well," as per the minutes of the Delhi meeting.

As many as 88 of the 99 Kasturba Gandhi Residential Girls Schools that were upgraded, have not yet been made operational, as per government data. Academic blocks and hostels are being built for the girl students in these upgraded schools so that after passing class 8, the girl students are able to stay in these hostels and complete their studies till class 12, officials said.

They said instructions have also been given to fill up the 12.05% vacant seats in Kasturba schools.

Bloody stalemate, no signs of breakthrough

In the book 'The Fathomless Caves', Kate Forsyth, the author, describes war as, "An unpredictable beast. Once unleashed, it runs like a rabid dog, ravening friends and foes alike. It can drag on for years, a slow attrition of nerve and fortitude, or be over in one brilliant flash, an extravagant configuration of flame and blood and sweat." The Russian-Ukraine War fits well into the above descrip-

When President Putin launched 'special military operations' to 'demilitarise and denazify' Ukraine on February 24, 2022, it was universally given that the war would be over in a few days, with Russia inflicting a crushing defeat on Ukraine.Ironically, two years later, the conflict rages on, degenerating into a state of stalemate with little change in the ground situation. Although a classic limited war, its politico-economic impact has been felt far and wide, with serious geo-strategic ramifications. Militarily, it has gone on to redefine the very nature of warfare. The Russian offensive commenced as a typical military campaign, preceded by missiles and airstrikes, followed by a large-scale ground invasion along multiple fronts. The northern thrust was launched from Belarus towards Kyiv, the southern one was from Crimea, and the south-eastern push was from Luhansk-Donetsk towards Kharkiv.

. In the wake of heavy losses and stiff Ukrainian resistance on the outskirts of Kyiv, the Russian Northern thrust stalled within a month, towards the end of March. By April, the Russian Army had retreated to consolidate gains around the Luhansk and Donetsk areas. However, the Russians did succeed in capturing Mariupol in May after a prolonged siege. Having stabilised the situation, in August, the Ukrainian forces launched a limited counterattack in the south and a month later in the north-east, succeeding in recapturing Kharkiv and Kherson by November, thus forcing the Russians to withdraw east of the Dnieper River. With winters setting in, the pace of operations had slowed down. The Ukrainians resorted to launching a number of drone strikes against the Russian bases. A period of lull was used by the belligerents to consolidate their positions and gear up for the next phase. By the end of 2022, around 8 million refugees had fled Ukraine. Both sides had suffered heavy casualties; more than half a million Russian and Ukrainian soldiers were killed or wounded, besides over 10,000 civilian fatalities. Towards early 2023. Ukraine launched a major counteroffensive on a wide front. However, it soon went awry. The frontal assaults by the Ukrainian mechanised forces against the Russian multi-layered field fortifications complemented with minefields made no headway, and the offensive soon petered out. On the other hand, the Russian Army achieved a major success in May 2023 with the capture of the strategically important city of Bakhmut after months of fighting, with Prigozhin's Wegner militia making a major contribution. In 2024, Russia is prepared for a grand offensive to gain an upper hand, sensing exhaustion amongst the Ukrainian ranks and Kyiv's depleting manpower, equipment, and resources. Russia has revived its defence industry and

also revamped its warfighting potential with military supplies, particularly ammunition, missiles, and drones from North Korea and Iran. The recent seizure of Avdiivka, an important town 20 kilometres east of Donetsk, will definitely offer a significant operational advantage to the Russians in the

Additionally, it is a symbolic victory and a huge morale booster for the Russian Army. The state of stalemate notwithstanding, the scope of conflict has enlarged.

Pollution becomes a major problem in the National Capital Region

Pollution becomes a major problem in the National Capital Region of New Delhi and its surrounding areas as winter sets in. This has become a big problem for the last several years not only in Delhi but for the residents of the surrounding areas. In view of this problem, the Yogi government of Uttar Pradesh has tried to provide relief to the citizens and to provide a source of income to the farmers instead of loss from the stubble generated from the paddy crop other than rice. It is noteworthy that in some areas of Uttar Pradesh, Punjab Haryana, and administrative Rajasthan, action is being taken continuously against farmers due to stubble burning. In which, apart from imposing fine on paddy farmers by the local administration, action is being taken to send them to jail. Due to which farmers are troubled. Seeing this problem of farmers, the Yogi government of Uttar Pradesh is trying to get rid of the pollution caused by stubble burning. For which the government is working on the technology of producing compressed gas (CNG) from stubble in the state, which will provide income as well as employment to a large number of people of the state. Along with this, pure organic fertilizer (green energy) will also be produced, the con-



sumption of the produce will ensure better health.

In fact, in view of this problem in the state, CM Yogi had already released the Bio Energy Policy 2022 to encourage bio energy. Under this policy a target of large scale investment was set. In which many big investors of the country had signed an MOU (Memorandum Understanding) with the state government in the Global Investors Summit, which is now going to come to fruition. The Yogi government had set a target of biogas plant in every tehsil, some of which are ready to start soon. Among the plants which are ready to start is Buland Biogas of Bulandshahr district, which is being established in village Lauhgala tehsil. Buland Biogas had signed an MoU worth Rs 18 crore 75 lakh with the state government, the price of which has now increased to around Rs 21 crore. According

to government representatives, this plant will start its production in December. This plant will produce 3 tonnes of CNG per day, which will reduce the dependence on petrol and diesel in the state. 80 to 100 people will also get employment. In these, both skilled and unskilled people will get employment. While talking to Dainik Bhaskar, owner of Buland Bio Gas, Athar Ahmed said that the plant produces not only stubble but also compressed biogas from degradable waste like straw, cow dung, chaff, sugarcane dung, municipal waste or a mixture of all the

Is made. With the help of this technology, CNG is purified. License for this plant has been obtained from PSU Indian Oil of the Ministry of Petroleum, Government of India. However, the government and the people running the institute believe that the

best thing about this project is a maximum subsidy ranging that it will produce organic fertilizer in large quantities. The waste generated in the production of compressed gas will be 100 percent organic. This waste will be solid as well as liquid. The liquid organic fertilizer produced by the plant will be given to the farmers free of cost for 3 years. These farmers will be identified by the DM or CDO of the districts. This will benefit those farmers who are not able to buy fertilizer, DAP, urea. The advantage of organic fertilizers and liquid fertilizers is that a thick layer of fertilizers has been spread in the fertile lands. It takes time to reach the roots of trees and plants. At the same time, if organic fertilizer is added to it, it will reach the roots in 2 to 3 hours.

This will not only benefit the farmers but also the common people will be able to get pure organic food. People's health will be benefited by pure eating habits. It is believed that considering the need of the hour, the Yogi government of the state has taken this project forward very rapidly and brought Bio Energy Policy-2022 for it. The government provided all the facilities in this. The first facility is that those who have received a LOI license can apply for it. Apart from this, along with the Central Government, the State Government is also providing

from Rs 75 lakh to Rs 20 crore. Not only this, the surcharge on electricity has been exempted for 10 years. Stamp duty has also been exempted for 10 years and land development charges have also been made free for 10 years. Facing political persecution with resilience

Maryam Nawaz Sharif will rule the Takht-e-Lahore. Jind Kaur, popular as Rani Jindan, took over as queen regent in 1843, ruling on behalf of her fiveyear-old son Duleep Singh, who ascended the throne after the death of his father Maharaja Ranjit Singh. She remained queen until the end of the First Anglo-Sikh War in 1846. Nearly 180 years later, Pakistan Punjab is finally getting its first female chief minister. No mean achievement in a political male-dominated setup where women are often relegated to the sidelines. And certainly not a small feat in a family where every third person has been or wants to be the chief minister of Punjab province. Maryam's first prominent appearance was in a BBC interview, where she detailed her father's incarceration by General Pervez Musharraf in the October 1999 coup. While Nawaz and other male members of the family were imprisoned, his fearless wife Kulsoom and daughter Maryam rallied for public support. "I can smell the danger, but who is on the wrong side? Ultimately Gen Musharraf is going to be in trouble," Maryam had said. First lesson learnt – dictators die politically, but civilian leaders live through generations. Facing political

persecution with resilience and defiance made Maryam Nawaz a political force long before she began her parliamentary career. The 'How to Become a Successful Politician in Pakistan' guide will have one chapter, really — let thyself be persecuted at the hands of the real rulers of this land. In the case of Maryam, this persecution began years before she fought her first provincial and national election in 2024. If Nawaz was targeted by the Pakistan Army, Maryam was hounded with trumped-up political court cases that only served to enhance her popularity. Let's rewind to July 2018, when hundreds of paramilitary

soldiers apprehended the father and daughter at Lahore airport, taking them into custody just days before the general election that year. The imagery of a defiant daughter, standing next to her father and willingly accepting arrest, is what catapulted Maryam.

Assuring that he had and would scrupulously abide by the interbail conditions, Kejriwal requested SC to extend his interim bail period by a week till June 9 to enable him to

undergo the tests. The CM said he suffered from "an aggressive form of diabetes mellitus, which is very volatile and undergoes a wide range of swings in blood glucose, including episodes of high sugar, that is hyperglycemia, and low sugar, that is hypoglycemia".

He claimed that during his incarceration from March 21 till his release on May 10, the "negligent and callous. behaviour of jail authorities" were partly responsible for his health-related complications, adding that during the period of custody, he suffered weight loss of around 6-7 kg, which he was not able to regain. even

Rly tracks cleansed of 60% rubbish

Delhi: Senior officials claimed the Municipal Corporation of Delhi (MCD) has removed 60% of the 28,000 tons of debris around railway lines in the Capital and has set a June 30 deadline to clean the tracks. MCD has charged Northern Railways ?6 crore for waste removal and processing. Approximately 48,000 slum houses surround Delhi's 105km railway network. Railway passengers and slum inhabitants have long dumped garbage beside the tracks, according to officials. According to MCD authorities, the civic body has located and mapped the nearest dustbins, dhalaos, and erected garbage compactor stations to remove garbage off tracks. Northern Railways asked MCD to inspect legacy debris along train tracks in June 2023 in accordance with monitoring agencies and the National Rights Commission (NHRC).

The authority claims to have generated the most money from its housing projects in 2023-24 and wants to increase it in 2024-25. An official said, "In 2023-24, we sold 7.978 units and earned Rs 2,803 crore, the most ever from housing inventory sales. In three phases of the Diwali Special



Housing Scheme, we seen the authority's provided premium properties including penthouses, super HIG, tion at Sector 19B and 14 in Dwarka and other sectors of Loknayak Puram, Rohini, Dwarka, etc." Before this year, DDA's peak income was Rs1500 crore in 2015-16. Some years have

Pul Prahladpur railway underpass eliminated from water logging areas

Delhi: PWD officials claimed the railway underpass at Pul Prahladpur in southeast Delhi, which was famed for flooding every monsoon until a year ago, had been removed from the waterlogging hotspot list. Over time, the wet underpass became notorious for drownings. Every monsoon, it would be closed to traffic, causing delays. A senior PWD official said waterlogging has afflicted the site for 20-25 years, but it worsened in the last 10-15 years. He blamed the worsening condition on a Delhi Jal Board sewage pumping plant in Khanpur. Drain sewage overflowed onto highways during monsoons, causing waterlogging. "The old pump house was a few meters from the main

road, and by the time

the water reached it



through the pipes, it would have spiraled out of control," he said. The official said a 7.5-lakh-litre sump and a pipeline were built to empty storm water into a neighbor-Municipal Corporation of Delhi drain. To drain the water and clean the underpass, a permanent pump building with six 100-horsepower motors was built. Future growth is possible, and two additional pumps can added, the spokesman said. He said the agency has two pumps attached to a two-foot, 600-

mm-diameter conduit to flush water into an open drain. Other problems included plastic and other solid trash clogging pipes in the sewage. The official added these positive displacement pumps have automated screens that filter water waste. "Sumps also fill with silt, but the pumps circulate a certain amount of water through a jetting system so that silt does not accumulate, requiring no manual intervention," he said. These pumps now operate without manual intervention from the department.

At Roshanara Bagh, MCD envisions Delhi's largest nursery

officials said the Municipal Corporation of Delhi (MCD) has begun the second phase of its plan to develop Roshanara Bagh nursery over 8.5 acres and increase its production capacity. Before the monsoon, the civic body will add fruiting, creeper and climber, and succulent sections. "A senior MCD official said the second phase will focus on an open-air nursery section, with the largest area set aside for fruit-bearing trees, climbers to green flyovers and succulents. Roshanara Bagh nursery will treble its yearly sapling capacity to 150,000-200,000 under the second phase, the source stated. According to the individual, the first phase included a polyhouse-based climate-



controlled nursery, the MCD's first, that produces 30,000-40,000 saplings that cannot be cultivated outdoors. The nursery controls temperature and humidity with its polyhouse structure. The city government established its first high-tech nursery in the Mughal-era park in December 2022. The space was neglected

and filled with build-

Polyhouses, shaded nurseries, an open-air nursery, bamboo machan, seating, and a single-story gardening structure have been built on 3.5 acres, according to the MCD official. The nursery contains a boom irrigation system and climate control capabilities to monitor light, humidity, and temperature in a poly-

house. The public might learn gardening skills in later levels. Cutting, layering, grafting, budding, and tissue culture are taught at the center, the source said. A second official said this year's annual greening campaign will focus on a lot of fruiting trees like jamun, guava, mulberry, and mangoes in the new location.

Gunmen kidnap Manipur fashion designer, shoot him in leg

IMPHAL: Popular fashion designer of Manipur, Kumarjit Laishram, was shot in the leg by unidentified gunmen in Imphal West district's Khumbong area, police said. The Koireng group of the proscribed UNLF claimed responsibility for the shooting, saying Kumarjit was punished for his involvement in unethical activity of "supplying women to high-profile people" in the state.

Kumarjit, 30, a resident of Takyel Khonbal Maning Leikai, also runs a beauty salon and spa close to his house. Sources said he was kidnapped by the assailants on Friday night and was found with a bullet wound in his left calf near the Khumbong community health centre around 8.40am on Saturday. He is undergoing treatment at a hospital here. Police registered a case in the matter and have begun an investigation. With Saturday's shooting, four people, including two women, have so far been shot, all in their leg, in the Valley districts by unknown armed men since the beginning of this month. This poses a challenge to the law and order situation in the state which is already embroiled in a simmering communal conflict.

Grant citizenship to daughter of OCI card-holders: HC

NEW DELHI: Delhi high court has asked the Centre to grant citizenship to a 17-year-old girl, raised in India to parents who held Overseas Citizens of India (OCI) cards and US citizenship at the time of her birth.

"The petitioner, despite having been born in India to two OCI card holders, educated in India and lived in India with her family, is unable to obtain a passport.

These are clearly special circumstances as contemplated under Section 5(4) of the Act," Justice Prathiba M Singh noted while referring to provisions of the Citizenship Act of 1955 and the Passports Act of 1967.

Petitioner Rachita Francis Xavier had



Following the resignation of representatives of Prosus, Peak XV Partners and Chan Zuckerberg Initiative from the board of Byju's in June last year, it has been reduced to a familyrun entity, comprising Raveendran, his wife and co-founder Gokulnath and his brother Riju Raveendran."This EGM is procedurally invalid, contractually in contravention of our AOA (Articles of Association) and SHA (Shareholders Agreement), legally on the wrong side of the Companies Act, 2013," a company spokesperson said in a statement on Thursday. Byju's said that with Raveendran and board members deciding to skip the EGM, it will not have the required quorum and cannot proceed to discuss or vote on the agenda. "As custodians of Byju's, it is the responsibility of the founders to respect the established procedures of law and protect the company's integrity," the company added. The EGM is supposed to take place on Friday morning, according to the EGM notice reviewed by. Investors claim that they will hold the EGM as per plan but if the resolutions are put to vote, then they will test the law in court, lawyers said.


