In SC, govt praises PV, Manmohan for ending 'licence raj'

NEW DELHI: BJP-led NDA govt on Tuesday praised former PM Narasimha Rao and his then finance minister Manmohan Singh in Supreme Court for pioneering economic liberalisation in 1991 to end 'licence raj' while taking care to ensure that overarching control over any industry remained with the govt in order to deal with exigencies. Solicitor general Tushar Mehta told a nine-judge bench led by CJI D Y Chandrachud that while post-economic reforms ushered in by Rao and Singh liberalised many laws, including company law and MRTP Act, govts headed by different political dispensations over the next three decades did not consider it necessary to amend the Industry (Development and Regulation) Act, 1951. He was responding to a question from the bench, also comprising Justices Hrishikesh Roy, Oka, B V A S Nagarathna, JB

Pardiwala, Manoj Misra, Ujjal Bhuyan, Satish C Sharma and Augustine G Masih, which had sharply criticised IDRA, 1951, saying the archaic legislation appeared regressive and reflective of licence raj days.Mehta said winds of change did not touch IDRA, giving the Centre overarching control over the entire spectrum of industries, even though with passage of time, the Union govt gave up regulating most of them. But the Centre relinquishing control over industries did not mean it did not have the power to regulate them, he added. This regulating control he added.

was retained by the Centre in national interest and to meet exigencies like the Covid pandemic. If the Union govt did not have the power to regulate industrial alcohol and direct most of it to be utilised to produce hand sanitisers during Covid and had to wait for permission from states, the robust response to the pandemic would have suffered, Mehta said. "The Centre retains its regulatory power over industries, though it may not exercise it, to meet unforeseen exigencies arising from situations not within contemplation right now,"

Centre sets up panel to address queer community concerns

NEW DELHI: The Centre has constituted a sixmember committee to examine and recommend on various issues affecting queer community. This is in keeping with the Supreme Court's judgement in Oct last year in which it examined the issue of same sex marriages. The top court had asked the govt to form a committee to address the concerns of the queer community.

Ramdev, aide say sorry to SC, offer to issue public apology

Baba Ramdev and his disciple Balkrishna appeared before the Supreme Court and admitted to giving misleading advertisements about Patanjali products, apologizing with folded hands. The court criticized their actions, stating there was a procedure to get products recognized by a competent authority and admonishing them for irresponsible behavior. Despite their defense of ignorance of the law, the court reminded them of previous orders they had violated. Pushed to the wall by the Supreme Court for violating its order, Baba Ramdev and his disciple Balkrishna on Tuesday admitted to giving misleading advertisements about Patanjali products and sought to apologise to the court with folded hands. At the outset of the hearing, a bench of Justices Hima Kohli and Ahsanuddin Amanullah said it wanted to talk to them in person and asked them to come to the front. Appreciating Ramdev for his contribution in the field of yoga, the court quizzed him on why he violated laws and its orders. Ramdev replied that he did not have an understanding of law and it was done in ignorance and it was unbecoming of him to make such statements. He said the mistake would not be repeated. Talking in Hindi with the judges, he said Patanjali had conducted clinical trials of its products, which were very beneficial. The bench, however, said there was a procedure to get his products recognised by a competent authority and it did not give him licence to criticise modern medicine. The court told him that his behaviour had been irresponsible. Noting that he had a legal team to assist him and the company, the bench said it could not accept his defence of ignorance of law."We cannot forget the history of the case. We passed three orders... You are not so innocent that you were not aware about the court orders," the bench said. Thereafter, the bench interacted with Balkrishna who also apologised with folded hands.

Parayagraj: Under the chairmanship of the District Election Officer Navneet Singh Chahal, a meeting was held at Sangam Auditorium on Tuesday with the representatives of all the political parties regarding the Lok Sabha General Election-2024. A meeting was organized regarding General Elections-2024. In the meeting, representatives of political parties were given detailed information about the nomination process, Suvidha portal, expenditure, Saksham App, CVigil App and other guidelines of the Election Commission. It was told in the meeting that only online applications can be made for all types of permissions. Offline



applications of any kind will not be accepted. It was told in the meeting that it is mandatory to take permission for any kind of event related to campaigning and for the use of vehicle. If any program related to election campaign is organized or vehicle is used without taking permission, then it will be considered illegal. Will be considered a violation of the code of conduct. For any type of permission, online applications will be made on the Suvidha portal. Similarly, information about CVIGIL app was also given. It was told that violations of the Model Code of Conduct can be reported on the CVigil app. Once the complaint is registered, the complaint will be immediately investigated and necessary action will be taken immediately. It was told in the meeting that it will be mandatory for the candidates to open a separate account for election related expenses, through which only election related expenses can be incurred. In the meeting, while giving detailed information about the guidelines of the Election Commission related to the nomination process, it was told that only five people, including the candidates, will be allowed to enter the RO room at the time of nomination. Krishna Janmbhumi-Shahi Idgah dispute maintainable argues Hindu side in Alld HC

side submitted Tuesday in the Krishna Janmbhumi-Shahi Idgah dispute in the Allahabad High Court that the suit is maintainable and the plea regarding application of the places of worship Act and the waqf Act can only be determined by evidence. The matter is being heard by Justice Mayank Kumar Jain on applications under Order VII Rule 11 of Code of Civil Procedure, 1908 (CPC), moved by the Muslim side regarding maintainability of suits. Under Order VII Rule 11 of CPC, the court is empowered to summarily dismiss a well as the Waqf Act, 1995

Prayagraj: The Hindu suit at the threshold, without proceeding to record evidence and conducting a trial, on the basis of the evidence adduced, if it is satisfied that the action should be terminated on any of the grounds contained in this

provision. The court fixed April 22 as the next date of hearing. In reply to the arguments raised by the Muslim side, the counsel for the Hindu side, Vishnu Shankar Jain, submitted that the suit is maintainable and the plea regarding the application of the Places of Worship (Special Provisions) Act, 1991 as

can only be determined by evidence by the parties in suit and cannot be decided while hearing an application under Order VII Rule 11 of CPC.

Jain said the waqf Act will not apply merely by saying that now a mosque exists there. The religious character of the property cannot be changed merely by demolishing it.

He further submitted that it has to be seen and decided whether the alleged waqf deed is valid or not. All these things have to be seen in trial and thus, the present suit is maintainable, Jain said. On the question

Global renewable energy discourses

India's progress in renewable energy infrastructure Some of the above factors provide the structural framework for locating India's approach to renewable energy security discourses. One needs to underline here that over the years, India has made tremendous progress with regard to boosting the domestic infrastructure for harnessing renewable energy. This progress is evident from the fact that by 2030, India will be able to harness 500 GW of renewable sources, as per the report of the Ministry of New and Renewable Energy, Government of India. This demonstrates India's commitment to harnessing clean energy. Similarly, a recent report published by the Ministry of New and Renewable Energy highlights that the installed capacity of various sources of renewable energy is "Solar, 48.55 GW; Small Hydro, 4.83 GW; large hydro, 46.51 GW; biopower, 10.62GW; Nuclear, 6.7 GW".

A cursory survey of India's quest for harnessing renewable energy demonstrates that over the years, India has scaled up its renewable energy sector. In this regard, it is pertinent to highlight that India started its journey to acquire renewable energy by diversifying into the nuclear energy sector in 1945 when the Tata Institute of Fundamental Research (TIFR) was established. It is pertinent to highlight that in 1957, the Atomic Energy Research Centre came up and was later renamed the Bhaba Atomic Energy Research Centre (BARC) in 1967. Over the years, India has made a quantum in harnessing nuclear energy the commissioning of the first civilian. nuclear reactor, Apsara, as the BARC website suggests, in 1957.

The two recent wars — the Russia-Ukraine War as well as the Israel-Hamas War — as well as sanctions on Iran and Russia have had much impact on global energy geopolitics. Contrary to expectations, the above-mentioned wars have also demonstrated the vulnerability of developed countries in terms of accessing energy, especially those in the advanced Global North, like European countries, which are facing major challenges due to the wars. In this regard, it may be added that the Red Sea chokepoint crisis has further aggravated the global energy crisis. Some of the aforementioned geopolitical crises have demonstrated that many advanced European countries were ill-prepared to face the recent crisis, thus putting stress on their access to energy. However, Global South countries have also faced challenges equally due to the above-mentioned wars. What needs to be underlined is that Global South countries are in a precarious position due to the non-availability of energy, which has aggravated other crises, including food and related crises. The reason for identifying the vulnerability of the Global North and Global South in the present geopolitical crisis is to locate how the energy crisis affects the accessibility of energy. In this context, one must emphasize the importance of renewable energy discourses. It is pertinent to highlight how India provides a leadership role to the global community, particularly to the Global South, in addressing the issues of the energy crisis by initiating a host of renewable energy initiatives. Three important issues need to be addressed while discussing India's role in the global renewable energy discourses. These are: India's initiative with regard to the renewable energy sector. How India's policy towards the renewable energy sector will provide a model for the Global South countries in particular and Global North in general in addressing the crisis.To assess India's contribution to global discourses on the renewable energy sector. These three above-mentioned vectors will provide a blueprint for India's contribution to the global renewable energy discourses.

Ukraine has already lost the war and it is time NATO pulled the plug

Those opposed, think that letting Ukraine join NATO while the war with Russia has raged on for over two years now, will likely provoke sharp and dangerous reactions from President Vladimir Putin. Besides, there is a growing perception that Ukraine has already lost the war and it is time NATO pulled the plug.

Placing NATO on Russia's doorstep with the inclusion of Ukraine, even though it cannot pay its way with a devastated economy, is a violation of previous understandings, according to Russia. It was one of the reasons why Russia went to war against Ukraine in the first place. The other was Ukraine's harsh treatment of Russian-speaking populations in the Donbas region bordering Russia. However, Secretary of State Antony Blinken recently told reporters in Brussels that 'Ukraine will become a member of NATO. Our purpose at the summit is to help build a bridge to that membership'. If Biden does not win the presidency in November, then this process of 'bridge' building will most likely not be pursued. Trump is certainly not in favour of mollycoddling Ukraine's security at the expense of Russia. Various member countries such as Poland that want Ukraine in NATO may not find much purchase with Trump in the

White House. Candidate Donald Trump has let it be known he will 'settle' the war in Ukraine, if elected to office, 'in 24 hours', without specifying how. His formula flies in the face of those in Europe and America who do not want to concede any Ukrainian territory to Russia. Trump favours ceding the territory claimed by Russia in

the Donbas region. and beyond. Others think this will encourage Russia to invade again but surely this can work both ways. There will have to be a massive international reconstruction effort in what remains of Ukraine after a settlement in any case. This means business for many. Nevertheless, the brightest hope of a swift end to the war in Ukraine is Trump back in the saddle.

Similarly, Trump has a 2020 formula for ending the war in Gaza. He wants Jerusalem and the West Bank-occupied territories as part of Israel and simultaneously а Palestinian state established. Only America can make this happen. This solution is likely to be supported by the major Arab countries already drawn in by the Abrahamic Accords from Trump1.0. Trump's ideas on Iran, North Korea, China, Taiwan, Japan, the Philippines, and Vietnam, are not that different from those of Democrat President Joe Biden and the State Department. They will have to evolve after he comes to office of course. India will continue to be considered a strategic ally of the US in the South Asian region and as a bulwark against Chinese hegemony. There will be more collaborations, joint ventures, American investment, and defence technology transfer. India is likely to rapidly gain from more manufacturing relocations from China. Trump and Narendra Modi also have a personal

chemistry that will help. However, the IT industry may face challenges with visa restrictions on working in the US.Pakistan will probably receive less American support than it does at present with a Republican administration in office. It will most likely be clubbed with China strategically. American relations with Russia will proceed at a better pace, as Trump has no real quarrel with Putin, and Trump will withdraw all sanctions against Russia and encourage his western allies to do so. To some extent this will free Russia to forge better ties with the West, instead of being limited to a Chinese embrace. The presumptive Republican Party nominee Donald Trump, is inching ever closer to the US presidency as his legal challenges melt away. Polls show him ahead of President Joe Biden. Even critics who think it will be a close election give Trump a 50-50 chance right now.NATO in Europe, much closer to the war in Ukraine than the US across the Atlantic, is scrambling to mobilise resources to 'Trump-proof' themselves in anticipation. Trump has recently said Russia can do 'what the hell it likes' to any European country that does not pay its share in NATO and its war support to Ukraine. Europe realises it needs to think much beyond Ukraine

going forward because Trump's transactional and quid-pro-quo style will not treat their security as guaranteed by Uncle Sam. Finland, for example, has just ordered 64 F-35A fighter jets from the US and has decided to double

artillery shell production. The outgoing NATO Secretary General, Jens Stoltenberg, is drumming up support for the now 32 member-country NATO to establish a new fiveyear, 100-billion-euro fund for the battle in Ukraine. But many in Europe and America realise that Ukraine is militarily unequal, finding it difficult to find more conscripts let alone trained soldiers and that there is massive corruption in addition to gross incompetence. Twenty of the 32 member-NATO have set a target of spending 2 per cent of GDP for defence this year as called for earlier. But Trump says NATO security guarantees would only apply to those countries that actually meet their defence spending commitments. This will profoundly change the NATO way that operates.Stoltenberg, a former prime minister of Norway and an international diplomat wants Europe to assume leadership of the Ramstein Group which gathers more than 50 countries to coordinate weapons deliveries to Kyiv. This sounds like a fond hope rather than a practical strategy.

Despite the relentless scrutiny and controversies galore that have dogged, from the very inception, his comeback campaign, Trump remains a rallying figure for American conservatives across the nation. However, this support base is by no means traditional or uncomplicated. The old guard Republicans view him as too much of a maverick if not an outright megalomaniac. Washington insiders, so used to wheeling and dealing across the aisles with their Democratic counterparts, find in Trump an unpredictable if not inconvenient leader. American conservatism is centuries old. It relies as much on the rule of law as on privilege. Trump has the distressing ability to call the former into question. As to the latter, he does not represent old money. On the contrary, he is seen as a bit of an upstart. Trump's standard operating procedure is to revile and discredit not only his adversaries and opponents, but also those very judicial and legal processes that have now been used against him to stop him in his tracks. But by undermining the institutions that make the United States great, Trump may be playing into the hands of arch-rival China. Chinese propaganda has been emphasizing that the US is a broken society and polity, no longer fit to serve as an example to

other nations let alone rule the world. During his widely publicised trials, Trump comes across as someone, who far from being contrite for his alleged misdemeanors and indiscretions is consistently and deliberately defiant and disrespectful of the laws of the land. True, many of the members of the prosecution ranged against him are Democrats; even so, in the eyes of the people the trials show Trump as somewhat beyond the pale of the law. This makes him a destabilizing and divisive figure. There is, of course, the further question: what if he is actually convicted and declared a felon? What if he serves time in jail, during

his campaign? Or, worse, what if he wins when he is serving a term? This would take America into totally unchartered waters. It is not as if no US presidential candidate has stood for election while being in jail. But the last time this happened was certainly not in living memory. US history buffs would know that the Socialist candidate for US presidency, Eugene Victor Debs (1855-1926) stood for election five times. Of these, his last attempt, in 1920, was when he was imprisoned. Of course, Debs was never a serious candidate, nor did he ever poll more than 6 per cent of the popular vote. It is also an irony of history.

It's the first outflow of smallcap money in 2.5 years

Delhi: While midcap fund flows fell to multi-year lows in March, smallcap funds had a net outflow for the first time in 2.5 years, which could be viewed as an anomaly. This came after capital markets regulator Sebi ordered mutual funds to conduct stress tests on their small- and midcap fund portfolios in March and expressed worries over froth in certain small- and midcap stock pockets. The overall net equity inflows in March decreased by 16% to ?22,633 crore due to the smallcap outflows and the slowdown in midcap flows. The net inflows into equity funds decreased by 16% to ?22,633 crore from the previous month due to concerns about regulatory advice and restrictions on inflows into smallcap schemes by institutions like Kotak MF and ICICI Pru Smallcap Fund. But market experts thought the smallcap flight was an anomaly brought on by regulatory warnings.

Insurance company can't deny claim due to pre-existing condition

Delhi: The Supreme Court has ruled that an insurer cannot deny a claim based on a medical condition mentioned by the insured in the proposal form after the policy is issued. Justices D Y Chandrachud and B V Nagarathna further stated that a proposer must inform the insurer of all material circumstances. It emphasized that the proposer is presumed to know all insurance facts and circumstances. The proposer can only disclose what he knows, his obligation of disclosure includes material facts that he ought to know in the ordinary course of business. Krishnamurthy Subramaniam, the Executive Director of International the Monetary Fund (IMF), said on Tuesday that India will continue to be a driver for global growth in the foreseeable future.

In an interview with ANI, he noted that India, ever since the COVID-19 pandemic, has witnessed consistent growth at 7 per cent plus. He predicted that India will have 8 per cent growth in the fourth quarter and called it "good" growth considering the current global economic situation.





'Dry promotion': New job trend causing concern among employees

NEW DELHI: The emergence of Artificial Intelligence (AI), particularly in the post-pandemic years, has pushed big multinationals and startups to rejig their work structure in accordance with the evolving trends, one such step being the ever-despised layoffs.While layoffs continue to serve as grim reminders about the flaky global job market, a new phenomenon called "dry promotion" has become a part of corporate corridor discussions. Dry promotion means elevating an employee's position in the company without a monetary hike. This implies a change in title, more workload, and increased responsibility without a raise in salary.Compensation consultant Pearl Meyer's recent report has revealed that more than 13% of employers chose to give their employees new job titles instead of money. This number was only 8% in 2018, reported the Wall Street Journal. Also, a recent survey conducted by Mercer, a benefits-advisory firm, involving 900 companies revealed a shift in the allocation of salary budgets for promotions in 2024 compared to the previous year. The data indicates a decreasing trend in promotion-related hikes, signaling a potential impact on employee satisfaction. Experts see this change as a reflection of the weakening bargaining power of the average worker. The current scenario, characterized by cost-cutting measures, has led to a rise in dry promotions, where employees are given added responsibilities without a corresponding increase in compensation. This shift contrasts with past practices of offering raises to retain staff during labor shortages.

DoE instructs NE district schools to resolve desk issues by next week

Delhi: In response to the Delhi High Court's criticism of the government schools in Northeast district, the Directorate of Education (DoE) has sent out a circular instructing all institute heads to make sure that there is a sufficient supply of desks for students. The April 12 circular addressed the issue of some schools still lacking multiple desks in spite of prior attempts. It has requested that, by April 20, school leaders identify desks that may be repaired and get them fixed. The education zonal deputy directors (DDEs) have been directed to locate extra, functional desks in schools and make arrangements for their transfer to the schools that are experiencing a scarcity. By April 17, the relevant head will send a demand request with the necessary explanation to the DDE in question if the schools still need more desks.

CBI books Megha Engineering, officials of NMDC & MECON

NEW DELHI: Central Bureau of Investigation (CBI) has registered a case against Megha Engineering and Infrastructure Ltd, two MECON, and eight NISP and NMDC officials over alleged corruption of Rs 315 crore.

MECON officials have been booked for receiving an alleged bribe of around Rs 78 lakh in clearing bills of Rs 174 of crore Megha Engineering in connection with works related to Jagdalpur integrated steel plant, officials told news agency PTI on Saturday.

According to the FIR, the CBI had registered a preliminary enquiry on August 10, 2023 about the alleged bribery in Rs 315 crore project related to works of intake well and pump house cross-country and pipeline at the integrated steel plant Jagdalpur which was awarded to the company.

Based on the findings of the preliminary enquiry, a recommendation was made on March 18 to register a regular case into the alleged bribery which was filed on March 31.

Manish Sisodia interim bail: Delhi court issues notice to ED, CBI



NEW DELHI:

A Delhi court on Friday issued a notice to Enforcement Directorate (ED) and Central Bureau of India (CBI) following Aam Aadmi Party (AAP) leader and former deputy chief minister Manish Sisodia's request for interim bail to campaign in general elections. Rouse Avenue Court's special judge Kaveri Baweja instructed the central probe agencies to respond by April 20, when the court will review the plea.

CBI and ED have alleged irregularities in the modification of Delhi's excise policy, including undue favors to license holders, waivers of license fees, and extensions without proper approval. As we brace for the seek help only after impending political showdown with candidates giving it their vocal all, spare a thought for the unsung hero — the voice box that often bears the brunt of their campaign rhetoric. With World Voice Day approaching on — a day dedicated to spotlighting the role vocal cord health plays in our personal and professional lives - it might be timely to explore how politicians, notorious for pushing their voices to the limit, struggle to keep their pipes in shape. Voice surgeon Dr Nupur Nerurkar says she often encounters politicians with "phonotraumatic lesions" or benign growths on the vocal cords due to overuse or non-stop speeches. "I see politicians all year round. That's because unfortunately, most

three to six months of symptoms," savs Nerurkar whose yearly tally sees close to 15 politicians lining up for assistance with raspy, fatigued voices. The vocal folds, Dr Nerurkar explains, is in the shape of a 'V' roughly in the middle of the larynx and when one speaks, the folds vibrate 100 times in a second in men and 200 in women.While people whose jobs require them to talk a lot are more prone to voice disorders - think singers, teachers, RJs, actors, builders, housewives, and call centre workers - "What distinguishes politicians is that they not only speak loudly and continuously but their speeches are often emotionally charged. Also, they frequently address small gather-

ings or party meetings without a microphone, which further increases vocal strain," says Nerurkar, adding that this relentless strain on the mid membrane of the vocal cord, also called the 'striking zone', takes its toll resulting in swollen tissues and the arrival of pesky bumps - nodules, polyps, or cysts. Based on a study that Nerurkar had conducted in 2016, politicians tend to fit into a personality type, with an increased chance of developing these vocal disorders. "We discovered a strong correlation between personality type and vocal health, and that the incidence of vocal abuse and subsequent vocal pathologies are heavily governed by the person's personality traits," explained Nerurkar.

Researchers examined 100 individuals, half with vocal issues and half with healthy vocal cords, analysing personality traits, speech speed, and volume to identify factors causing polyps, nodules, and cysts. Interestingly, it wasn't speech speed or volume that mattered most, but personality type. "Type A individuals, known for speaking loudly and quickly, were more prone to vocal problems compared to Type B who spoke more softly and slowly. Politicians typically fall into the Type A," she said. It's become a familiar sight over the years for audiologist and speech therapist Dr Piyush Gujarathi, to see politicians flocking to him with voice woes. "When their voice takes a hit, politicians tend to get jittery. because speech holds
