Hundreds of people posted in Allahabad, Agra, Kanpur Nagar, Meerut, Ghaziabad, Gautam Buddha Nagar, Muzaffarnagar, Varanasi, Bareilly, Gorakhpur, Banda, Mirzapur and many other districts. Chief Constable Drivers and Chief Constable Armed Police have filed petitions separately group wise in the Allahabad High Court, demanding promotion to the post of Sub-Inspector Driver and Sub-Inspector Armed

Prayagraj: Of over 1.26 has been making Aadhaar rectly in bank accounts of cards for students of its schools for five years now, Aadhaar numbers of a large number of children have not been made till date, say teachers of these schools.

Due to this, there will again be a delay in transferring the financial assistance amount of Rs. 1,200 given annually to each student every year for their free school uniforms, bags, shoes, socks

their parents/guardians, they add.

This financial aid is sent by the state basic education department directly in the bank accounts of the parents of the students through direct benefit transfer (DBT). But first, this amount is received by the parents of those children whose Aadhaar numbers are available.

Director general (school

education), U.P., Kanchan Verma, while sending a report of May 27, directed all basic shiksha adhikaris (BSAs) to complete the Aadhaar verification process as soon as possible so that the assistance amount can be made available to the students well on time.

As per state basic education department's data, maximum 44,477 students don't have Aadhaar numbers in Lakhimpur Kheri.

Likewise, there are 35,081 students in Bahraich, 34,573 in Azamgarh, 28,130 in Hardoi, 27,161 in Jaunpur and 25,297 in Budaun who do not have Aadhaar cards. "The Aadhaar card making process of students lacking them in Prayagraj is under way in full swing and we are undertaking the exercise as a top priority," said Kumar Tiwari.

A Shaky World Order: Can India Navigate A Russia-**China-Iran Axis?**

The world today appears to be on the verge of a cascade of conflicts. Over two years since it started, the Russia-Ukraine war does not seem to be heading towards an imminent settlement. Likewise, despite calls for a ceasefire, the Israel-Hamas conflict appears unlikely to abate anytime soon. And now, events over the past month involving Israel and Iran have demonstrated the potential for a wider regional conflict. While the wars in Eurasia and the Middle East may seem disjointed and seeped in their own historical and political contexts, they are also interconnected in a broader sense of the emerging great power competition for the future of the world order. What we are witnessing today is an era of great power competition in an increasingly multipolar world. The US and China are the chief protagonists in this new order, although each is constrained by its domestic politics and capacities. This creates a certain power vacuum, but also space for autonomy of action, balancing and bandwagoning, and even adventurism by middle powers. In this environment, while there are no distinct blocs that have emerged, there are certain alignments that are becoming more prominent. For instance, NATO seems to have found a fresh purpose following Russia's assault on Ukraine, but there are deep concerns related to American policy continuity. Likewise, there is the emergence of a Russia-Iran-China axis based on common interests and grievances with the West. But there are limits to the nature of support that each lends to the other. After years of mutual antagonism, Israel and Iran now appear to be on the brink of a new conflict. The proximate cause for this can be traced back to Israel's frustration with what it argues is Iranian support for Hamas, and other groups such as the Hezbollah, the Houthis, the Syrian government and groups in Iraq. Over the course of the past month, the two countries have engaged in a cycle of attack and counter-attack. Neither seems to desire a major escalation. But the ladder of escalation often follows its own logic, which can put the best-laid plans to waste. Two strategic outcomes can be observed amid these recent events. First, the persistence of the war in Gaza and the emerging spillovers have exposed the limitations of American and Chinese power, particularly since the situation does not necessarily serve either's strategic interests. Second, there is a clear alignment, albeit with increasing friction, between the US and Israel. The US has been at the forefront, supporting Israel in its war against Hamas, and led its defence amid the recent Iranian strikes. It is interesting to note that this effort was supported by regional actors like Saudi Arabia, the UAE and Jordan. In addition, options to coerce Iran economically are being discussed in both the European Union (EU) and the US. On the other hand, China and Russia have been critical of Israeli actions since October 2023. Amid the Iran-Israel tensions, Beijing has backed Iran and sought to preserve its tenuous effort at reconciliation between Saudi Arabia and Tehran. Russia, meanwhile, has become Iran's largest military backer since 2022 and threw its diplomatic weight behind Iran's "retaliatory measures" on April 14 against Israel. On the other side of the world, the war in Ukraine is well into its third year. The conflict has fundamentally reshaped European geopolitics and geoeconomics. The war has re-energised transatlantic unity for the moment. However, the direction of American domestic politics has a significant bearing on this momentum. Beijing has sought to straddle the line in Europe by trying to appear neutral while backing the Russian call for a new regional security architecture. It has supported Russia's defence industrial complex with the supply of dual-use items., but has been cautious to avoid direct weapons support.

Impact of mobilization of caste panchayats on voting

In the first phase of voting of this Lok Sabha election, a large number of Jat voters were seen missing in Western UP, called Jatland. Rajputs and Thakurs have also opened a front against the BJP governments in the entire northern region of India. Their Panchayats are being held and despite the persuasion of many big Rajput and Thakur leaders, their opposition is not calming down. According to the India Meteorological Department's (IMD) latest forecast, India is expected to receive decades, above-normal rainfall resources have led to during the upcoming overuse of groundwa-June-September southwest monsoon season. This is great news after a gap of eight years; 2016 was when India experienced last decent rain. The country's dependence on monsoon can be gauged from the fact that it receives about 70-90% of its annual rainfall in the four months of June-September. Normal monsoon has a direct impact on the country's economy. Evenly-distributed rainfall is crucial for the 61% of Indian farmers who are dependent on monsoon for agriculture. A monsoon positive enhances agricultural production, which in to withdraw groundwa-

According to the Central Groundwater Board of India, 18% of India's groundwater assessment units are overexploited or critical, meaning that the rate at which water is extracted is higher than the rate at which the aquifer can recharge. The overuse of groundwater for agriculture has increased since the 1960s, especially after the Green Revolution. To fulfil requirements, a largely ungoverned groundwater irrigation economy has mushroomed in rural areas. Increased availability of borewells and free or subsidised electricity have allowed farmers

ter at will, leading to the resource's overexploitation. The practice raises concerns given that about 75% of the annual groundwater recharge takes place during the southwest monsoon. With climate change altering monsoon patterns, these recharge cycles can get disrupted, consequently leading to high crop failures. The IMD's latest monsoon prediction is music to not only farmers but also lakhs of people in Indian cities that have been battling waterrelated crises. Bengaluru is foremost among them these days. It has two major sources of water while Cauvery water takes care of 60% of the city's water needs, the rest is fulfilled by borewells handled by Bengaluru's water supply authority.

Panchayats of these three ties have always resolved all small and big disputes in the villages through their Panchayats. Apart from this, the kindness among the farming communities, especially the big farmers, is so much that no one can go through their doors without eating and drinking. About four years ago, when the Corona epidemic was spreading globally and there was chaos all around, people suffering from Corona were dying and villagers living in cities were returning to their homes on foot hungry and thirsty, then the farmers He had opened the stores of his house and helped such helpless travelers a lot. Not only this, almost all the works were closed at that time, but the farmers kept the country's GDP intact by working day and night in their fields. At that time, only one or two leaders would have come forward to help the people, the rest of the help was

either done by the farmers, or by those who were sons of farmers and were in jobs. But the way farmers have been ignored in this country for the last few years and especially what has happened to them during the farmers' movement, it is clear that the resentment of Jats, Rajputs and other big castes was bound to come to the fore. But it is not wise to stay away from voting and separate from each other. However, if we talk about reduction in voting, we will see that while 69.2 percent voting took place in the 2019 Lok Sabha elections, this time only 55 to 66 percent voting took place at various booths. If the voting percentage remains the same in future, then it will be a big warning not only for the democracy of the country but also for the Election Commission about the dissatisfaction of the voters. Because voters are the basis of elections and if voters do not vote, then how will governments be elected? The fewer voters will vote, the easier it will be for the political parties to manipulate them in their favor and it will also be easier to win, because the mood of the voters is such that the angry voters do not vote or Those who vote for a particular party get burnt on NOTA, whereas those who vote only vote in any circumstances and in this way, even if the voting percentage is low, that party can also win, due to which a large number of voters are attracted. The section should be angry. But this is not even 100% true. Because many times people come out in large numbers for anti-voting and those voters get angry, who are stuck to one party and are angry with that party for some reason. But they do not get angry and vote for other parties, rather they prefer to sit at home and protest against voting. If we want to see such examples, we will see that in the 2018 assembly elections in Rajasthan, the Rajputs there had opened a front against the BJP and the result was that the BJP had lost in Rajasthan. Despite being less in number than other castes, the opposition of Rajputs proved too much for BJP and after two fiveyear plans, BJP could return to power in Rajasthan in the year 2023.

This time, the way the resentment of Rajputs has come to the fore in the northern region of India after the Jats from Western Uttar Pradesh, anything can happen. In fact, for the last one year,

BJP has been continuously trying to target every caste in the country except Muslims, which have good numerical for a particular party come to strength.

It was with the very idea of introducing more transparency into the election process that the concept of VVPAT was proposed in 2010. Following discussions with political parties and others, the idea was referred to the ECI's Technical Expert Committee. Finally, VVPAT machines were attached to EVMs and trials were conducted in some constituencies during the 2013 assembly elections. Following that, the ECI decided to introduce VVPATs in a phased manner, and in the 2019 General Elections, all EVMs were used with VVPAT machines. Let me point out two things. Firstly, it was precisely to remove doubts regarding the EVMs that VVPAT machines were introduced - to provide voters with a means to verify that their vote was cast correctly and for the audit of stored electronic results. Using these machines, voters can review a physical ballot to confirm their electronic vote. Secondly, it was the VVPAT machines that malfunctioned in the recent by-polls, and not the EVMs," writes former.

What A Caste Census Can Come To Mean

I was born in the Indian Muharram Railways township of Tundla, a major junction on the historic Delhi-Howrah trunk route, in the heartland of Uttar Pradesh. The town had a population of just 30,000 then, almost equally divided between the railwaymen and their dependents and 'the townwallahs', as the others shopkeepers, traders, professionals and some farmers - living there were fondly called. Tundla was like a microcosm of India, with people from all parts of the country, representing all religions, faiths, languages, traditions, colours and festivals, living there. Ramlila, Durga Puja and Guru Parva festivities always fascinated me, as did the sombreness of the

processions. Nobody ever asked me my caste or, for that matter, my religion. My parents were refugees, thanks to the unfortunate Partition. My father had to leave behind his ancient village in the Frontier, bordering Afghanistan, and my mother had to flee from Mianwali in western Punjab. But it did not matter to our neighbours or friends. It was a childhood full of carefree joy, play and happiness. The whole town was like a family, which would transform into a big mela (a fair) on occasions like Diwali, Durga Puja and 'chhabbis janvary' (January 26, the Republic Day of India). I did not know anything about caste. Two families living opposite our house

were Dalit, which I had heard mostly in whispers - from the priest of our local temple, but we all prayed together, celebrated together, and often ate together. I am sure the caste fissures were all there, and probably profoundly, but they were under the radar, never paraded nakedly. Caste was a reality, a big social cleavage in villages just outside our microcosm, but I also know for sure that most even in those villages would have wanted to be like us. Honestly, I did not know - and did not care to know - my caste until I was already settled, had travelled all around the world, married and even had the first child. The 1990 violence over the implementation of the Mandal

shattered report me. Suddenly, everybody was asking each other about their caste. If you used only 'Kumar' or 'Singh' or 'Bharti' as your last name, people were careful not to offend you, staying neutral on the Mandal debate in social gatherings. It was in such an atmosphere and anxiety I called up my father one evening to ask him about our 'caste'. He was baffled. All he managed to say was, "We are Hindus, Panjabi Hindus." I persisted, "That I know, but what is our caste ... I mean caste?" I listed out all the four varnas and asked him to tick the right box. He said, "We are Arora. I do not know beyond that." There was no Google in those days.

Precision herbicides use essential for cotton protection – Godrej Agrovet

However, challenges arise from labor shortages and excess soil moisture, especially during frequent irrigation or heavy rains in the kharif season, hindering timely cultural practices. To overcome these, adopting herbicides during critical periods becomes essential for effective weed control, ensuring higher yields. "Identifying the critical period of weed competition is crucial for effective weed management in cotton. As a long-duration crop, cotton faces a critical weed competition period of up to 45 Days After Sowing (DAS), during which maintaining a weed-free condition is imperative for optimal results. This makes the need to protect cotton crop during early post-emergent phase viz. 5-15 DAS extremely crucial," added Rajavelu. Due to the varied weather patterns the weed emergence and type of weeds are changing.

With effective weed management becoming a critical issue due to this, it is advisable that farmers select the right herbicide. Be it solo or scientific in-can mixture herbicides, it is important for farmers to go as per the label

recommendation and avoid own tank mix combinations which may not be advisable given the uncertainties of weather and weed emergence that can happen at the farmer field.

Delhi high court orders parents to pay for school AC

Delhi: The Delhi High Court recently ruled that parents must pay for school air conditioning, just like laboratory costs. While dismissing a public interest litigation, the division bench of acting chief judge Manmohan and justice Manmeet Pritam Singh Arora made the comment. The petition asked the Delhi government's DoE to restrict a private school from charging for classroom air conditioning. Air conditioning is a school facility, thus parents must pay for it like lab and smart class fees. When choosing a school, parents must consider the facilities and expenses for their children. The bench ruled on May 2 that school management cannot bear the cost of such facilities. Manish Goel filed the PIL because his child's Delhi private school charged Rs 2,000 per month for AC.

The petitioner said the school management should give AC to kids with its own funds. The bench heard from the DoE that it was investigating and asking for an action-taken report after

Delhi: Uttar Pradesh will have 11% of JEE-Advanced 2024 candidates, the entryway to 23 IITs. According to JEE (Main) qualification data, over 54% of the 2.5 lakh IIT entry candidates are from six states and approximately 73% from 10. Although over 75% of enrolled applicants took both the January and April sessions of the JEE (Main), an entrance test for centrally financed technical institutes and others, just 28% improved their scores in the second sitting. One of India's toughest competitive tests, JEE (Advanced), requires students to place in the top 2.5 lakh in JEE (Main) and vie for 17,000 IIT seats.

Canada will limit international students' job dreams to 24 hours per week.

Delhi: The Minister of Immigration, Refugees, and Citizenship of Canada has announced that international students can only work 24 hours per week. Marc Miller announced on social media X. "We removed the 20-hour/week work requirement for international students to aid post-pandemic rehabilitation. I stated today that this provision would be lifted and that offcampus student employment hours will be limited to 24 hours/week starting this autumn "on his official X account. International students might work more than 20 hours per week off campus under the old rule. The rule expired April 30, 2024. Miller added that kids on academic break can work unlimited hours. According to Miller, this adjustment will let students focus on their studies instead of working lengthy hours. International students come to Canada to study first. Students can work while focusing on class with this improvement. He claimed the program will remain strong while protecting youngsters. According to the Canadian government, recent US and Canadian studies have shown that students working more than 28 hours per week perform worse academically and are more likely to drop out. Most nations that accept international students have limited their working hours while studying. Australia now allows students to work 48 hours within two weeks.

US students must also meet additional standards before working off campus.

Canada is reducing the number of start-up visas it will accept, this year

Delhi: Although Canada attempted to improve the attractiveness of its start-up visa program in July of last year, an announcement tonight will terminate the aspirations of prospective immigrant entrepreneurs. In reality, a number of them who received early investment or assistance from business incubators can wind up in a limbo. Beginning on April 30, Canada will only accept petitions for permanent residency linked to ten or fewer startups per approved organization for processing each year. The Immigration, Refugees Citizenship and Canada (IRCC) released a statement stating that this action was taken to expedite application processing and minimize backlogs. To put it simply, there are currently about 82 of these

approved organizations, which include company incubators, angel investors, and venture capital funds (VCFs). It follows that, if the number of these organizations stays the same, no more than 820 applications will approved. be Furthermore, as per the release, entrepreneurs whose start-up is backed by Canadian funding or a business incubator that is affiliated with Canada's Tech Network will be eligible for priority processing. In order to be eligible for permanent residence, entrepreneurs must demonstrate that they

have sufficient means to support themselves and their family upon arrival in Canada. The Startup Visa (SUV) program does not require applicants to invest any of their funds or have a minimum net worth.

It's essential to have support from one or more of the approved partners, such as venture capital funds (VCF), angel investor groups (who must invest a minimum of 200,00 CAD and 75,000, respectively), or be accepted into a program offered by a business incubator. The authorities added New Delhi is also in negotiations to collaborate with a Tashkent institute. 

US GDP growth was slower last quarter on soft consumer spending

The US economy grew at a slower pace in the first quarter than initially reported, primarily reflecting softer consumer spending on goods. Gross domestic product rose 1.3% annualized in the first three months of the year, below the previous estimate of 1.6%, Bureau of Economic Analysis figures published Thursday showed. The economy's main growth engine personal spending advanced 2.0%, versus the previous estimate of 2.5%.The numbers underscore a loss of momentum to start 2024 after continual upside surprises in 2023. High interest rates, waning pandemic-era savings and slower income growth are some of the key factors weighing on American households and businesses Consumer spending was marked down as

particularly autos – were much softer. Federal government spending slowed, while imports picked up compared to the first estimate. Net exports subtracted from growth for the first time in two years. The downward revision to consumer spending was partially offset by stronger business and residential investment. Delhi: Delhi Development Authority informed the National Green Tribunal that it had given Delhi Jal Board land in Mahipalpur for a sewage treatment plant. DJB promised to finish the plant quickly after land ownership. Vasant Kunj Sector E-2 residents wrote to the green tribunal in 2022, alleging that wastewater in the open drain on the northern side of the DDA Legal Housing Complex Society wall was stagnating and sewage was seeping through the boundary wall into the society. DDA informed DJB to pay Rs 708.5 per acre to finalize land assignment in its NGT report. They stated DJB officials had submitted the payment request for approval. Priority will be given to land payments after approval. The DDA indicated that purified water will be used to maintain south Delhi's plantations and waterways after the STP is built. Another DJB report to NGT stated, "Currently, the allotment process is ongoing, and the construction will be completed within a reasonable time after obtaining possession of the land."

District Courts receive instructions to facilitate smooth case hearings via VC

Delhi: On May 20, the Delhi High Court directed the national capital's district courts to follow a number of guidelines to guarantee that video conference equipment functions properly during court sessions.

The Delhi High Court's Acting Chief Justice Manmohan issued the following directives. The video conference must remain active throughout court hours.

At the court end, the video will be turned on. According to the office order of June 5, 2023, it will be made sure that the video conference at the court's end won't be kept silent unless the court orders otherwise. According to the office order of June 5, 2023, it will be



made sure that the video conference is not locked and that litigants, counsel, and members of the public can all attend without difficulty, unless the court orders differently. Each Court is required to make certain that the item number is visible

throughout the video conference.

Every court must make sure that, in accordance with Office Order of June 5, 2023, a message appears on the video conferencing screen when the court retires, is not in session, is on leave, or when instructions

are given to restrict the proceedings. According to the ruling, the Principal District & Sessions Judges are required to provide a report on the video conference to the Registrar General's office of this Court using the stipulated format.
