Congress pushing Sharia in name of personal law but BJP will bring UCC: PM

Accusing a "communal, casteist and nepotist" Congress of pushing Sharia under the guise of seeking to retain Muslim personal law, PM Narendra Modi pledged Friday that BJP would implement the proposed Uniform Civil Code (UCC) across the coun-

"There should be a uniform civil law for all, regardless of whether you are a Hindu, a Muslim, a Sikh, a Christian or a Buddhist.But Congress is opposing UCC. Congress also opposes CAA and talks about bringing back Section 370...This nation will be built by sons of the soil and not those who have received everything as inheritance," Modi said at a campaign rally in Mandi, where BJP has fielded actor Kangana Ranaut. Videos The PM said Congress's stand on critical issues reflected its intention to keep India wallowing in poverty and take it backwards.

he said. The PM alleged that a conspiracy had been hatched to snatch reservations from SCs, STs and OBCs and distribute these among Muslims, just as Congress had already done in Karnataka.

Referring to Calcutta HC's order this week invalidating OBC certificates based on new classifications in Bengal since 2010, he

said another opposition figure — CM Mamata Banerjee had already refused to honour the ruling. You have all seen the way Congress politicians use derogatory language while speaking about Mandi and Kangana. This is an insult to Mandi, to Himachal and to all the women of the state," he said.

Searches in J&K's Samba after 'suspicious movement' intel

Canada set to lift restrictive citizenship by descent norms: Indian diaspora to benefit say experts

MUMBAI: Canada's immigration minister, Marc Miller, on Thursday night introduced a legislation that will extend citizenship by descent beyond the first-generation. This news has been welcomed by several immigrants including the Indian diaspora.

The Citizenship Act was amended in 2009 to add a 'first-generation limit' to citizenship by descent. This meant that a Canadian citizen parent could pass on citizenship to a child born outside Canada only if the parent was either born in Canada or naturalized before the birth of this child.

However, as a result of the firstgeneration limit, Canadian citizens who were born outside Canada could not in turn pass on citizenship to their child, if the child was also born outside Canada.Nor could they apply for a direct grant of citizenship for a child adopted from outside Canada.

The proposed amendment comes in the wake of a court ruling, last year, which held the first generation limit to be unconstitutional.

HC junks Rs 2.5cr recovery notice to Haldwani riot mastermind

Dehradun: Uttarakhand HC on Friday quashed a recovery notice of Rs 2.5 crore served to Abdul Malik, the alleged mastermind of the violence in Haldwani's Banphoolpura area. Malik is currently in jail. The notice sought compensation for the destruction caused during the unrest on Feb 8 when a team of local administration and municipal corporation officials launched an antiencroachment operation, demolishing an "unauthorised" madrassa and a prayer place. The structures were built on govt land.

How 'mystery of lost key' has s piced up Odisha elections

NEW DELHI: When most of the top opposition leaders flew to Bihar last year to present a 'formidable front' against the ever-strong Bharatiya Janata Party (BJP), Odisha CM Naveen Patnaik was one of the few big faces missing at the Patna meeting, which saw the birth of the INDIA bloc.

A month before the June 2023 Patna meeting, Patnaik had made it clear that he would go solo in the upcoming elections, calling it a 'principle' of his party, Biju Janata Dal (BJD).

Two months later in August, Patnaik's BJD backed Centre's Delhi Services Bill and also voted against the noconfidence motion moved by the INDIA bloc against the Modi

Sabha, where the BJP lacks majority of its own. With Patnaik backing the BJP-led NDA, the INDIA bloc was dealt a heavy blow in Parliament as it failed to stop the Delhi Services Bill, marking defeat in a battle that Delhi CM Arvind Kejriwal had said was a "semifinal" before the 2024 parliamentary polls.Next month in September, the BJD chief rated PM Modi's government "8 out of

initially pulled his punches as he made no mention of CM Patnaik. He, however, did attack the state government by mentioning BJD -- the PM named BJD 15 times in his two speeches.In the following rallies, the PM launched a stronger attack, making a broad claim that June 4 would be the expiry date of the BJD government Odisha and that the BJP would announce the CM face.

Addressing the Challenges of Low Voter Turnout in Elections - Atul Malikram

PRAYAGRAJ: Voting for the five phases of the 2024 Lok Sabha elections has concluded, with an average voter turnout of around 57.44 percent across 429 seats. The Election Commission views a turnout of less than 60 percent as concerning. In light of this, it is crucial to address the factors contributing to the declining voter participation and to identify measures that could improve turnout.

To tackle this issue, we must first raise pertinent questions, seek solutions. and consider making certain facilities more accessible. For instance, why shouldn't any adult citizen be able to vote from any location within the country? Why not implement mobile polling booths for individuals over 75 years old or those who are unwell? Additionally, why can't there be a system to transport voters over 75 years old or those in need? Furthermore, why shouldn't voters who are traveling for tourism or essential work be able to cast their votes? Although elections incur costs amounting to thousands of crores of rupees, if increasing voter turnout can be achieved by investing a few crores more in such initiatives, then these measures should be taken into serious consideration.

According to the rules of the Election Commission, you have the right to vote only in your constituency, and for this, you need to register yourself in the voter list. While this is understandable, why not develop a system that accommodates voters who, due to employment, business,

tourism, or medical emergencies, are unable to be in their constituency on polling day? Arrangements could be made in private or government buildings in every city to allow these voters to exercise their right We live in an era of ad-

vanced technology with new innovations emerging daily. Why not create a technology-based system that allows a voter from Indore to cast their vote even if they are in Kanpur? This could be done through an online mode, with the vote being registered at the Indore polling station. Although there may be some initial challenges, these can be addressed to solve the issue of low voter turnout.

Just as members of the Army, security forces, or employees on election duty can cast their vote on a ballot paper from their place of work, similar arrangements should be made for individuals who, for various reasons, cannot be at their polling station. Such measures would ensure that everyone has the opportunity to participate in the electoral process, regardless of their location on polling day.

In the current Lok Sabha elections, there are 2.18 lakh voters over the age of 100. Why not arrange for mobile booths to accommodate these elderly voters? Mobile booths could operate in every city, positioned near the homes of identified voters, making it easier for them to cast their vote. Additionally, arrangements could be made to transport elderly individuals over 75 years of age to the polling station.

Ahead of polling, cops form special unit to curb rumours on social media

Prayagraj: For peaceful polls in Prayagraj on May 25 and to curb rumours on social media, the Prayagraj Police Commissionerate officials have taken additional steps. Besides carrying out flag march in the city and rural areas, a special team of cops having expertise in handling social media platforms and tracing culprits through IP address and special software has been constituted. Police officials said a separate control room of cyber cell has been formed for ensuring peaceful and rumour free polls. The control room will have a team of 40 policemen who are experts in surveillance and handling social media sites. The control room termed 'Serious Organised Crime Unit (SOCU)' is keeping strict eye on persons who may cause trouble during polls through data analyses and social media profiling. The unit can keep tabs on social media through special software and intercepting app-based communications.

Through hi-tech apps, the unit can trace IP address and location of persons who spread rumours on social media or are making objectionable posts. Moreover, the unit may also trace calls made through social media apps, officials added. Police officials said that all preparations are complete for peaceful polls. Units of CRPF, BSF, RPF have arrived for poll duties and have been briefed. Flag march and patrolling in the city and rural areas are being carried out to instill a sense of security among voters. Possible troublemakers and those who may pose a threat to peace during polls are under police scanner.

Nishads key players as riversutra flows through U.P's poll terrain

Prayagraj: Key poll players are leaving no stone unturned to woo the riverine community of Nishads and their associated subcastes in eastern Uttar Pradesh in the hope of sailing to victory in the ongoing Lok Sabha elections with their support. The riverine community has a decisive say in 37 parliamentary constituencies, 27 of which will vote in the sixth and seventh phases of the

current election. Currently categorised as OBCs, the Nishads are seeking inclusion in the Scheduled Castes and the Nishad party, led by Uttar Pradesh fisheries minister Sanjay Nishad, is spearheading the cause.

In particular, the polls in recent decades have highlighted the electoral importance of this community. The 2022 Uttar Pradesh assembly election was one such democratic exercise at the hustings that put the Nishads in the spotlight.

In recognition of the riverine community's vital role, Congress general secretary Priyanka Gandhi Vadra had launched the "Nadi Adhikar Yatra" in support of the riverine Nishad community's rights to water resources from Baswar village, 15 km south of Prayagraj city on the Yamuna riverbank, before the 2022 Uttar Pradesh assembly election.

The yatra set the tone

Congress, Bharatiya Janata Party (BJP), Samajwadi Party (SP) and the Bahujan Samaj Party for the riverine community votes comprising OBCs and 22 influential sub-castes like Nishads, Mallah, Kewat, Binds, Kashyaps and Nishads in the 2022 assembly election in east Uttar Pradesh.

In a counter-ploy, the BJP launched "kamal nauka rallies" along the Ganga and Yamuna riverbanks, highlighting its government's welfare schemes for the community. Besides, the BJP allot-

ted seats to its ally the Nishad party and won a second successive term with an absolute majority. The Nishad party's tally of seats increased from one in 2017 to six in 2022. The winners included Sanjay Nishad's son Sarvan Nishad who bagged the Chauri- Chaura seat. Sanjay Nishad's elder son Praveen Nishad won the Sant Kabir Nagar Lok Sabha seat in 2019.

"The riverine community has been demanding inclusion in the scheduled caste category for several years," says Prashant Trivedi, faculty at the Giri Institute of Development Studies, Lucknow.

All the major political parties have promised them the SC status but the matter is still pending, he adds.

The community is fightfor the fight among the ing for its rights at two levels -- mobilizing under the banner of the Nishad party and seeking assistance from other parties where the Nishad party's presence is negligible.

Residing near rivers, the community has a sizeable presence in several districts of East Uttar Pradesh. Majority of community members are with the Nishad party. But in several constituencies, they support other parties if the candidates of their caste are contesting on other parties' symbols, he says.

As the vote of the community is decisive on several seats, all the political parties are working to win their support, Trivedi says.

"The demand for the SC status is being raised for the last 20 years and the main criterion for it is untouchability. Riverine community members assert that they associated with Nishadraj whose valour is mentioned in the epic Ramayana. Since there is no caste discrimination against them, the community is not likely to get the SC status on technical grounds. The leaders of the community should focus on other issues for economic empowerment - rights to water resources, land and pond The Nishad patta.

Prayagarj, Devi Patan, Gorakhpur and Varanasi divisions, says NK Sinha, a political observer.

Around 22 sub-castes, including Nishad, Kewat, Mallah, Bind, Kahar, Kashyap, Dhimar, Raikwar, Turaiha, Batham, Bhar, Rajbhar, Dhiwar, Prajapati, Kumahar, Manjhi and Machua, are demanding inclusion in the SC category, Sinha says.

"They are a dominant force in the river basin area that passes through Central and East UP and no political party can ignore them," he adds.

During the SP regime, the then chief minister Mulayam Singh Yadav and later the present chief minister Yogi Adityanath sent recommendations to the central government their reclassification from OBC to SC, Sinha says.

Even as the campaign for the 2024 Lok Sabha election is in full swing in Prayagraj (Allahabad Lok Sabha constituency), silence prevails at Baswar vil-

A resident Chander Nishad says, "The parties made several promises in the 2019 Lok Sabha election and the 2022 assembly polls, but the community's problems have not been resolved. In the 2022 assembly election, we supported BJP candidate Piyush Ranjan Nishad who won the Karchana seat." Sand mining ban is a key concern of neighbouring Phulpur conthe community.

In 2013, the National Green Tribunal stopped the extraction of sand from rivers using heavy machinery, but big contractors continued the mining activities. The Nishad community residing on the riverbanks used small boats for mining but in June 2019, the government banned the use of these small boats, too, in sand mining and action was taken against the community involved in sand min-

"We are demanding mining contracts for our livelihood, but there is no response from the government," Chander Nishad

Vandana Nishad, who led the Nadi Yatra with Priyanka Gandhi, says the fall in earnings from the fisheries business, ferrying of passengers and goods on boats and ban on sand mining has hit the riverine community's earnings. "The much-hyped SC category status to the community is pending. We are not getting jobs in government services. The community is struggling for livelihood. The state government should allot us agricultural land and ponds for our livelihood," she says.

Another villager Gyan Chand Nishad says there are 7% Nishad voters in Allahabad Lok Sabha constituency and 7% in the

stituency (both in Prayagraj district).

"Our community's vote is decisive. There is a division of Nishad votes between NDA and INDIA in 2024 Lok Sabha election but a majority of the votes will go to the BJP candidate," he says. On the northern pe-

riphery of the district, 35 km from Prayagraj city, Shringverpur village is humming with activity as hundreds of labourers place pink stand stone labs around the 51-feethigh statue of Lord Ram and Nishadaraj on a high platform. This a holy place for Hindus, particularly the Nishads. According to the epic Ramayana, Lord Ram, Sita and Lakshman arrived at this place to the Ganga on their way to forest exile.

The local king Nishadraj ferried them

across the river in his boat. "The development of Shringverpur Dham is a matter pride for Nishads. Our identity and legacy will be glorified as thousands of people from across the country will visit here to seek blessings of Lord Ram and Nishadraj," says Nanhe Nishad, resident of Shringverpur.

A 20-acre park and a museum dedicated to the history of the Nishad community is being constructed. Previous govern-

ments did not care for the respect and welfare of the community, he says.

Mohammad Mansur Ali, who runs a bike service center, says Nishad party chief Sanjay Nishad has given call for removal of the mosque located in the premises of the Nishadraj fort. "It might disturb communal harmony in the area. The NDA is trying to polarize voters on the mosque issue to get the Nishad community votes in the 2024 Lok

Azam Khan, family's conviction in fake certificate case stayed

Allahabad High Court on Friday, May 24, granted relief to senior Samajwadi Party leader Mohd Azam Khan and his family in a fake birth certificate case. Hearing the matter, the court put a stay on Khan's sevenyear sentence. However, the sentences of his wife Tanzeen Fatima and son

stayed, although they have been granted bail.

Stating that all three have been granted bail, Khan's advocate, Sharad Sharma, said, "Azam Khan's conviction has been stayed, while Tazeen Fatima and Abdullah Azam's convictions have been rejected."

The Abdullah Azam were not January 3, 2019, when in the alleged forgery case on October 18, 2023.

According to the charge sheet, in the certificate issued by the Rampur municipality, Abdullah Azam's date of birth was mentioned as January 1, 1993. The other certificate showed he was born in Lucknow on September 30, 1990. The trio was found guilty under Sections 420 (cheating), 467 (forgery of valuable security), 468 (forgery for the purpose of cheating), 471 (using as genuine a forged document), 472 (making or possessing a counterfeit seal, etc. with intent to commit forgery), and 120 (B) (criminal conspiracy) of the Indian Penal Code (IPC). Azam

Khan was also disqualified from the Assembly last year after a court sentenced him to three years in jail in a 2019 hate speech case. Khan had won the Rampur Sadar Assembly seat in the 2022 Uttar Pradesh Assembly polls for a record 10th time. He then gave up the Rampur parliamentary seat,





The role of state fiscal capacities in national growth

India's economic progress is a composite reflection of the growth trajectories of its states. Given the federal structure of the country, each state operates with a degree of autonomy in implementing policies that drive their individual economies. This results in a broad spectrum of growth rates across states, highlighting significant disparities. For the nation to achieve holistic growth, it is imperative for all states to experience economic advancement. Despite this, there is a notable discrepancy in the attention paid to fiscal matters at different levels of government. The Union Budget, detailing the central government's finances, often garners substantial scrutiny and debate for its potential impacts on the nation's economic direction. In contrast, state budgets, which are crucial for addressing local needs and fostering regional development, do not attract a similar level of public and analytical scrutiny. Fiscal capacity, the government's ability to generate revenue from available tax and nontax bases, is crucial for several reasons. First, it underpins a government's ability to provide essential public goods and services. These range from healthcare and education to infrastructure and defense, which are fundamental for the welfare of the citizenry and the smooth functioning of the economy. Without adequate fiscal capacity, governments may struggle to maintain these services at levels that meet public demand and expectations, potentially leading to social unrest or a decline in the quality of life. Second, fiscal capacity is vital for economic development and growth. Governments need resources to invest in infrastructure projects like roads, bridges, and digital networks, which are critical for enhancing productivity and competitiveness. Such investments not only improve current living standards. but also set the stage for future economic expansion. The Asian Development Bank Institute (ADBI) in 2017 and the World Bank in 2015 highlighted the risk of economies falling into a 'middle-income trap' where they are unable to transition to high-income status due to inadequate fiscal capacity among other factors.

Moreover, fiscal capacity is essential for macroeconomic stability. It allows governments to manage economic cycles more effectively, applying fiscal stimulus in downturns and restraint in booms to maintain economic stability. The Covid-19 pandemic's impact on Indian states underscored this point, as reduced fiscal capacities constrained their ability to respond effectively to the crisis and its economic repercussions.

Finally, a robust fiscal capacity enables equitable social development. It allows for redistributive policies that can mitigate income inequality and fund social safety nets for the vulnerable. Studies have shown that factors such as high per capita income, education levels, and low corruption contribute to higher fiscal capacity, which in turn can be used to foster a more inclusive society.

Given that state governments account for over 60 per cent of general government expenditure in India, enhancing their revenue-generating capacity is imperative for the needed investment in areas such as education, research and development, and skill development.

The Reserve Bank of India recently released a report on state finances, which gives an insight into the state budgets of 2023-24. It has some important findings.

First, revenue mobilisation in Indian states comprises both tax and non-tax revenues, with a significant portion coming from state's own tax revenues (SOTR). Over the years, there has been a noticeable increase in SOTR, growing from 5.7 per cent of GDP in 2003-04 to 6.9 per cent in 2022-23. This growth, particularly in the post-GST era, reflects a shift in the composition of tax.

Modi government at the Center is trying to win more than 400 seats

But despite opposition on many issues across the country, not only the Modi government at the Center and Prime Minister Narendra Modi, but even a single BJP worker is not ready to bow down. Not only this, the Modi government at the Center is eager to come to power at the Center for the third time by crushing every protest, every movement and every person who opposes its policies like an intoxicated elephant. In fact, if we look at the two tenures of the Modi government at the Center in the last 10 years, we find that it has not refrained from crushing any movement, any protest or any opposition. Be it the movement by ex-servicemen demanding One Rank One Pension, be it the movement of farmers, be it the



movement of the country's daughters and women wrestlers, or any demonstration by unemployed youth demanding jobs, Be it the movement of women employees of Anganwadi centres, or the protests against EVM Tehelka, or the movements in Jammu and Kashmir and Ladakh to the North-Eastern states. In this way, if we look at the last 10 years of the tenure of the Modi government at the Centre, about twenty types of movements took place at various places; But most of the movements were either crushed badly by this government which suppressed democracy or they were suppressed to such an extent that their voice could not reach the country and abroad. The remaining work in ending these movements was done by a special group of Modiya and those people who have got contracts for various odd jobs in the country. However, if we look

at the movements going on in the country in the last 10-12 years, then first of all we have to look at the protests that took place across the country against the Anna movement and the Nirbhaya incident, due to which the UPA central government was ousted. However, the UPA central government of that time also tried to crush both types of movements; But not to the extent that the Modi government at the Center has done anything to crush all the movements. If we talk about the time after Prime Minister Narendra Modi came to power at the Centre, then the Patel movement of Gujarat, Maratha movement of Maharashtra, farmers movement of Maharashtra, farmers movement of Tamil Nadu, Anganwadi movement, teachers' movements in different states.

Apart from the movement of unemployed youth and the movement of Hanuman Prasad Beniwal

women wrestlers, all the farmers' movements across the country and the farmers' movement that started in the year 2020 have been crushed by the Modi government at the Center and the BJP state governments. Their demands and problems have been ignored. And the agitators and protesters have been kicked and water cannons have been used. In the first farmer movement against the three agricultural laws, an attempt was made to end the movement by putting all kinds of pressure on the farmers, and this time, when the central government did not fulfill its promises, the farmers decided to march to Delhi. Supreme Court refuses to hear plea on voter turnout data in midst of polls

NEW DELHI: Supreme Court on Friday refused to entertain an NGO's plea for a direction to Election Commission to declare authentic voter turnout figures at the end of each phase of polling and said it was not inclined to issue any interim order amid electioneering. Hearing an application

filed by NGO 'Association for Democratic Reforms' (ADR) in its PIL pending since 2019 and seeking identical mandamus to EC, a vacation bench of Justices Dipankar Datta and Satish Chandra Sharma said, "We are prima facie not inclined to grant interim relief as prayed for in the application as the prayer is similar to that in the 2019 petition.Grant of interim relief would amount to grant of final relief." The Justice Datta-led bench said the voter turnout app was a voluntary step taken by EC to inform the public about approximate voting percentage. "EC is not statutorily required to upload preliminary data. Sometimes a good initiative is like 'aa bail mujhe maar' (counter-productive)," it said,



tention that it was not mandated to put out voter turnout figures after polling for each phase and that it decided to provide the figures on its voter turnout app on its own. Appearing for EC, advocate Maninder Singh took the wind out of the application by claiming that it was based on "suspicions, apprehensions and falsehood" and urged the bench not to entertain such a plea as the "socalled public interest petition" was causing grave harm to the electoral process. "Low voter turnout could possibly be due to the continuous attempts by certain elements to create an

atmosphere of suspicion around the electoral process," he said. Singh said the court, in its April 26 judgment, had scrutinised every ADR allegation and dismissed it while questioning its bona fide. "But the PIL factory, within hours of the pronouncement of the judgment, filed this application raising another set of apprehensions based on suspicions. No fact is pleaded to substantiate the allegations," Singh said, adding that as per Article 329(b) of the Constitution, no court shall call into question a parliamentary election except on filing of an election petition after the conclusion of the poll process.



ED arrests one more in TDS refund fraud case

MUMBAI: The Enforcement Directorate (ED) arrested another accused, Purshottam Chavan, in a money laundering case connected to a Rs 263 crore Income Tax Refund fraud on Monday, following the arrest of his accomplice Rajesh Batreja last week. This case involves the former Income Tax (I-T) inspector, Tanaji Adhikari, who gained the confidence of his seniors while working in the Income Tax department and cleared fraudulent TDS refund claims into the account of his accomplices. The ED said Chavan was involved in possessing part of the Proceeds of Crime (POC) and he was in regular contact with Batreja for the diversion of cheated money through hawala transactions. Chavan and Batreja had shared incriminating messages, which are part of the ED's findings. The ED mentioned that Chavan attempted to hamper the investigation by destroying evidence and during the search of his premises, they found many property documents and foreign currency. Earlier, the ED had arrested former income tax inspector Tanaji Adhikari, and businessmen Bhushan Patil and Rajesh Shetty in the case, who are currently in jail custody. The ED alleged that Batreja assisted Tanaji Adhikari in diverting POC of Rs. 55.50 Crore into three shell companies to convert the same into cash for sending it outside India via the hawala channel. Afterward, he brings part of the money to India as an investment in two companies. Until now, the ED has seized or attached properties worth Rs 168 crore in the case and last year had already filed a chargesheet against Tanaji Adhikari and 10 others in the case. Adhikari, who was the senior I-T tax assistant at the Income Tax office handling the refund of tax deducted at source.

In 2023-24, the analysis studied 10,093 complaints and 8299 advertising campaigns. Nearly ments picked up by ASCI were not contested by The majority of violations were on account of misleading claims at 81%, followed by ads that promoted harmful situations or products at 34% (the same ad can be processed for multi-

ple objections). Manisha Kapoor, CEO & Secretary General of ASCI, said, "2023-24 has been a truly challenging year, and ASCI stepped up to this by focusing our efforts on digital. About 3200 advertisements were shared with various regulators, such as MIB, Ayush, and MahaRera, for direct violations of the law. point highlighted last We see this as a continuing area of focus. With the highest number of violative ads seen online, advertisers and platforms must work more closely with regulators and self-regula-

tors to keep consumers protected". Further, digital media

remained the primary source of violations, accounting for 85% of ads processed, and had a lower compliance rate of 75%, compared to 97% for print and TV.

Non-recovery of cash not prima facie proof no graft took place: HC on Sisodia

NEW DELHI: Non-recovery of ill-gotten money can't be prima facie proof that no corruption has taken place because a person now uses new technologies to commit offences without leaving behind any trace, Delhi high court has observed, while denying bail to AAP's Manish Sisodia in the city excise policy case.

In its order pronounced Tuesday and uploaded Wednesday, HC said "recovery of cash from a person may not necessarily be a mandatory requirement in a money laundering case where allegations are part of a conspiracy comprising multiple accused." 

"As custodians of Byju's, it is the responsibility of the founders to respect the established procedures of law and protect the company's integrity," the company added. The EGM is supposed to take place on Friday morning, according to the EGM notice reviewed by.
