**NEW DELHI: External** affairs minister S Jaishankar held discussions Abdullah Ali Al-Yahya, his Kuwaiti counterpart, in the wake of the devastating fire that claimed the lives of over 40 Indian nationals in Kuwait. During the conversa-

Jaishankar emphasised the need for the swift return of the mortal remains of those who perished in the tragic event.

Taking to X, formerly known as Twitter, Jaishankar said, "Spoke to Kuwaiti FM Abdullah Ali Al-Yahya on the fire tragedy in Kuwait. Apprised of the efforts made by Kuwaiti authorities in that regard. Was assured that the incident would be fully investigated and that responsibility will be fixed."

He urged the early repatriation of the mortal remains of those who lost their lives. He also emphasised that those



injured were getting the requisite medical attention.

"We will review the situation after MoS @KVSinghMPGonda this tragic event. A reaches Kuwait tomorrow," he added.

## Retail inflation at 12-month low, IIP holds steady at 5%

**NEW DELHI:** Retail inflation eased slightly to a 12-month low in May with prices of some food items moderating marginally, while the index of industrial production (IIP) growth held steady at 5% level in April.

Data released by the National Statistical Office (NSO) on Wednesday showed retail inflation, as measured by the Consumer Price Index (CPI), rose an annual 4.8% in May, nearly at the same level as the previous month.Rural inflation was higher at 5.3%, while urban was at 4.2%. The food price index was at 8.7%, similar to the level in Vegetable prices con-April. This is the ninth consecutive month when retail inflation has been below the 6% upper tolerance level of RBI. The data showed food and beverages inflation at 7.9%, while fuel and

#### Govt inaction lets firm sell human milk using HC stay

Neolacta, a Bengaluru-based company, continues to sell human milk despite licence cancellation. Interim stay by Karnataka high court and inaction of govt agencies allow this. India is the only country in Asia where breast milk is sold for profit.

Govt inaction lets firm sell human milk using HC stay

Nearly two years after its licence was cancelled, Neolacta, a Bengaluru-based company, continues to process and sell human milk despite this being not permitted under the Food Safety and Standards Act, 2006. It is able to do so because of an interim stay granted in Sept 2022 by the Karnataka high court on the cancellation of licence and because no govt agency has moved to have the stay vacated.India is the only country in Asia where breast milk is being sold for profit.

When granting the interim stay, the high court order stated: "It is open to the respondents to move the matter at any time." Yet, none of the respondents in the high court case -- the Ayush department of Karnataka, the Ayush state licensing authority or the union Ayush ministry -- made any effort to get the stay vacated till March this year.

With FSSAI cancelling the licence of other companies trying to commercialise human milk, Neolacta now has a virtual monopoly on selling human milk for profit. However, no govt agencies moved. Seeing the continuing inaction of the union Ayush ministry, **Breastfeeding Promotion Network** of India (BPNI), a non-profit working to protect, promote, and support breastfeeding, wrote to the union health ministry on March 19, urging it to intervene in the high court to explain govt's objections to get the stay vacated. On March 25, Ayush ministry moved to vacate the stay. Before this, the Ayush ministry had only filed objections in June 2023.

Neolacta was established in 2016 with a licence from the Karnataka office of the FSSAI in the category of dairy products.

#### PM Modi to come face to face with Trudeau at G7, may take up separatist issue

**NEW DELHI:** With PM Narendra Modi and his Canadian counterpart Justin Trudeau set to come face to face at the G7 summit in Italy on Friday, the govt reiterated that India's main issue with Canada remained the political space given to anti-India elements who advocate violence and extremism.

PM Modi will arrive in Italy on Thursday for what will be his consecutive fifth participation in the summit of the economically advanced nations as the leader of an invitee country.He will look to address issues related to the Global South while underlining the significance of dialogue and diplomacy for resolving the Russia-

Ukraine conflict, an



issue high on the G7 agenda along with the Gaza conflict.

The PM will participate in the G7 outreach session on Friday and is also expected to have many bilateral meetings with G7 and other invitee leaders. Foreign secretary Vinay Kwatra on Wednesday only confirmed a meeting with Italian PM and host Giorgia Meloni, as he said the list of bilateral meetings was still being finalised. A meeting

with Trudeau wasn't ruled out.

"The main issue is

the political space that Canada provides to anti-India elements that advocate extremism and violence. We have repeatedly conveyed our concerns to them and we expect them to take strong action," Kwatra said, briefing reporters about Modi's G7 visit.The summit is being held in a luxury resort in the southern region of Puglia. As expected,

Modi will skip the peace summit on Ukraine Switzerland and return straight to India. India will be represented by senior officials at the summit.

Asked about the focus on Russia-Ukraine conflict, Kwatra said India has always maintained that dialogue and diplomacy is the best option. He recalled Modi's remark in Sep 2022 before Russian President

Vladimir Putin that "today's era is not of war".

Kwatra spoke about the consequences of the war including its derivative impact on food, fuel and fertiliser availability, challenges

to global supply chains and disruptions in the global economy.

## BSP failed to play spoiler for Oppn, hurt BJP more: Javed Urfi

Prayagraj: "After being outrightly rejected by the people again, Mayawati has once again blamed Muslims for her loss, arguing that despite fielding a large number of candidates from the minority community its voters failed to back her Bahujan Samaj Party. Going solo proved to be disastrous for Mayawati as the BSP not only failed to open its score but could only manage to secure around 9.4% votes in Uttar Pradesh where Dalits make up 21.5% of the population. This was even worse than its performance in 2014, when although the BSP could not convert any seats, it mustered a decent vote share of 19.77% and was runner-up on 34 seats out of the 80. On June 5, Mayawati, in a statement warned Muslims that she would field them in future only after "a lot of

thought" to avoid a "terrible loss" like this. She also claimed that most voters of her Jatav community, UP's largest Dalit caste, still backed the BSP," said Congress leader Javed Urfi while commenting on Maywati comments on Muslims, blaming them for BSP poll rout.

Addressing queries of mediapersons outside Prayagraj a8irport, after returning from Delhi, he opined, "Mayawati's disingenuous call to fault Muslims for their political adeptness reeks of a disgruntled leader who failed to make any impact on the election. But she does have the right to feel upset, as despite deploying all dubious tactics and tacitly backing the incumbent, the BSP failed to play the role of a spoiler for the Opposition parties. The results also demonstrated that the BSP was not indispensable to the Opposition, further reducing Mayawati's bargaining chip. Assuming that Mayawati is correct in assessing that most of her 9.4% vote share came from Jatavs (which is difficult to ascertain), her move to field 20 Muslims, as against the six by the INDIA bloc, proved inadequate to divide or distract the Muslim community to the BJP's advantage."

To corroborate and vindicate his arguments he cited an analysis, which claims that there were 47 Lok Sabha seats in UP, where the BSP's vote share was more than the victory margin of either the SP or the BJP. Of these 47, 31 were won by the INDIA alliance. "This means that the Opposition benefitted more from the BSP deciding to contest alone. There were 16 seats that the BJP won where its victory margin was less

33 seats in UP, the BSP's vote was irrelevant as it did not impact the final outcome whatsoever. An important question on everyone's mind this election was, which way would the Dalit vote, in particular Jatavs, swing now that there was no grand alliance of the SP and BSP? In 2019 and 2022, the SP believed that on many constituencies, Dalit voters of the BSP were strategically made to shift to the BJP to ensure that the SP did not get the advantage. In fact, barring Amroha, which the BJP won after defeating the sitting Muslim MP of the Congress, Kunwar Danish Ali, the BSP's Muslim candidates did not hurt the IN-DIA bloc on any seat.

On the contrary, on nine seats, the INDIA bloc candidate managed to defeat the BJP even when the victory margin was less than the votes polled by the Muslim candidate of the BSP. In simple words, the BSP's Muslim candidates could not spoil the game for the Opposition, if that was the intent of the party to make

its presence felt. These nine seats were Saharanpur, Aonla, Azamgarh, Budaun, Firozabad, Ambedkar Nagar, Sant Kabir Nagar, Sambhal and Etah. That Mayawati fielded Muslims on these seats, many of which the Opposition looked strong to win from day one, also compels us to question her intentions, which seemed focused on damaging the SP. In Azamgarh, Budaun and Firozabad, Akhilesh Yadav's cousins Dharmendra Yadav, Aditya Yadav and Akshay Yadav won, respectively. In Saharanpur, a seat with a substantial Muslim population, Imran Masood of the Congress was the winner. Ambedkar Nagar was won by senior Kurmi leader Lalji Verma, while in Sambhal, the SP's Muslim candidate Ziaur-Rehman Barq retained the seat for the party," he said prior to signing off.

## **Editorial**

#### **Growth trajectories** of its states

India's economic progress is a composite reflection of the growth trajectories of its states. Given the federal structure of the country, each state operates with a degree of autonomy in implementing policies that drive their individual economies. This results in a broad spectrum of growth rates across states, highlighting significant disparities. For the nation to achieve holistic growth, it is imperative for all states to experience economic advancement. Despite this, there is a notable discrepancy in the attention paid to fiscal matters at different levels of government. The Union Budget, detailing the central government's finances, often garners substantial scrutiny and debate for its potential impacts on the nation's economic direction. In contrast, state budgets, which are crucial for addressing local needs and fostering regional development, do not attract a similar level of public and analytical scrutiny. Fiscal capacity, the government's ability to generate revenue from available tax and nontax bases, is crucial for several reasons. First, it underpins a government's ability to provide essential public goods and services. These range from healthcare and education to infrastructure and defense, which are fundamental for the welfare of the citizenry and the smooth functioning of the economy. Without adequate fiscal capacity, governments may struggle to maintain these services at levels that meet public demand and expectations, potentially leading to social unrest or a decline in the quality of life. Second, fiscal capacity is vital for economic development and growth. Governments need resources to invest in infrastructure projects like roads, bridges, and digital networks, which are critical for enhancing productivity and competitiveness. Such investments not only improve current living standards. but also set the stage for future economic expansion. The Asian Development Bank Institute (ADBI) in 2017 and the World Bank in 2015 highlighted the risk of economies falling into a 'middle-income trap' where they are unable to transition to high-income status due to inadequate fiscal capacity among other factors.

Moreover, fiscal capacity is essential for macroeconomic stability. It allows governments to manage economic cycles more effectively, applying fiscal stimulus in downturns and restraint in booms to maintain economic stability. The Covid-19 pandemic's impact on Indian states underscored this point, as reduced fiscal capacities constrained their ability to respond effectively to the crisis and its economic repercussions.

Finally, a robust fiscal capacity enables equitable social development. It allows for redistributive policies that can mitigate income inequality and fund social safety nets for the vulnerable. Studies have shown that factors such as high per capita income, education levels, and low corruption contribute to higher fiscal capacity, which in turn can be used to foster a more inclusive society. Given that state governments account for over 60 per cent of general government expenditure in India, enhancing their revenue-generating capacity is imperative for the needed investment in areas such as education, research and devel-

opment, and skill development. The Reserve Bank of India recently released a report on state finances, which gives an insight into the state budgets of 2023-24. It has some important findings. First, revenue mobilisation in

states comprises both tax and non-tax revenues,

with a significant portion coming from state's own tax revenues (SOTR). Over the years, there has been a noticeable increase in SOTR, growing from 5.7 per cent of GDP in 2003-04 to 6.9 per cent in 2022-23. This growth, particularly in the post-GST era, reflects a shift in the composition of tax. revenues. with the State Goods and Services Tax (SGST) becoming a predominant source.

## As hundreds of Chinese items lose tax exclusions, the US-China trade battle escalates



Delhi: Recently, the US has banned, restricted, or imposed high taxes hundreds Chinese imports to stimulate domestic production and reduce dependence Chinese commodities. The USTR has already added tariffs to half of 429 items. The USTR excluded further duties from "Section 301" probe of China's technology transfer, intellectual property, and innovation measures in previous announcements. The current 429 product-specific exclusions (352 reinstated and 77 COVID-related) expire

on May 31, 2024. The trade agency US declared a 14-day transition period for all current exclusions until June 14, 2024, and to "extend certain exclusions through May 31, 2025" in a new notice. "To allow for a transition period, US Trade Representative extending all currently expiring exclusions through June 14, 2024," it stated. Chinese motors and medical equipment are excluded until May 2025. The USTD ruled that "extending these exclusions will support efforts to shift sourc-

ing out of China, or additional provide time where, despite efforts to source products from alternative sources, availability of the product outside of China remains limited". Last March, the USTR reinstated some "Section 301" tariff exceptions for Chinese goods. Former President Donald Trump began a trade war with China and imposed tariffs on nearly \$300 billion in Chinese goods, invoking Section 301 of the Trade Act of 1974. #### Comments by Mr. Abheek Barua, Chief Economist -**HDFC Bank on RBI RBI Monetary Policy Committee**

Ambala/Hisar: As expected, the RBI kept its policy rate and stance unchanged. Although, the MPC decision saw two dissents instead of the one seen in the previous policy. The one positive out of the policy was the upward revision in the GDP growth forecast to 7.2% from 7% earlier for FY25. On the other hand, inflation forecasts were kept unchanged.

The RBI remains in a wait and watch mode to assess domestic developments like the monsoon performance, food inflation, and the new fiscal strategy before moving on rates. We continue to see the possibility of a rate cut in Q4 2024. Despite the governors' emphasis that monetary policy decisions are driven primarily by domestic considerations, we think that any rate cut action could end up being aligned with the timing of the Fed's rate cut cycle to limit financial market volatil-

On the regulatory front, the increase in bulk deposit limit to INR 3 crore from INR 2 crore, signals the RBI's intention to encourage banks to garner greater retail deposits to fund credit growth.



Byju's said that with Raveendran and board members deciding to skip the EGM, it will not have the required quorum and cannot proceed to discuss or vote on the agenda. "As custodians of Byju's, it is the responsibility of the founders to respect the established procedures of law and protect the company's integrity," the company added. The EGM is supposed to take place on Friday morning, according to the EGM notice reviewed by. Investors claim that they will hold the EGM as per plan but if the resolutions are put to vote, then they will test the law in court, lawyers said.



## Joe dramatically raises US tariffs on Chinese EVs

Akhand Bharat Sandesh

Delhi: US President Joe lambasted Beijing for "cheating" as he raised tariffs on Chinese products such electric vehicles and semiconductors. strongly opposed the sanctions as Biden sought to appear tough on trade ahead of a rematch Republican Donald Trump in November's US presidential election. "We're not going to let China flood our market, making it impossifor American automakers to compete fairly," Biden declared in the White House Rose Garden. He said, "We're never going to allow China to unfairly control the market for these cars," before ordering duties. Trump's tariffs have been frequently criticized by Biden. He's been using similar tactics to win over bluecollar voters in swing Rust Belt states. The White House stated EV tariffs will treble to 100% this year and semiconductor duties will rise from 25% to 50% by next year.



#### File ITR or risk scrutiny

Delhi: A taxpayer will be investigated if they do not file an income-tax return after an inquiry notification. This notification under section 142(1) is provided when a taxpayer has not submitted the tax return or to request preliminary information about a detail such as bank interest or long-term capital gains/loss on property sale. This advice is part of the Central Board of Direct Taxes' new comprehensive rules for mandatory I-T return selection for complete inspection. Annual guidelines cover survey, search and seizure, tax evasion, and cases where no I-T return was filed in response to an inquiry notification for the current financial year (selection and thorough inspection). It also includes non-registration or termination of registration under sections 12A/12AB for charity organizations seeking tax benefits. In addition, if the taxpayers' income increased on a recurring issue in an earlier year, the I-T return will be picked up under obligatory inspection standards, subject to monetary restrictions. "The guideline states that all I-T returns filed during FY24 will have the outer time limit for issue of a notice by June 30, 2024." In selective cases, complete scrutiny is performed to ensure the taxpayer has declared income correctly and paid taxes.

Delhi: The All India Institute of Medical Sciences will open a cath lab for emergency patients to provide primary neuro, cardiac, and endovascular procedures in the "golden hour". The emergency department has no specialized Cath Lab. After considering the patient load and the requirement for fast actions, especially in emergencies, this strategic option was made. Officials noted the number of functioning Cath Labs falls short of meeting rising demand, resulting in longer wait times for sophisticated brain and cardiac treatments. Delhi: The Delhi High Court ordered MCD and DDA to close Mukherjee Nagar's tutoring centers that violated fire safety rules. A team of lawyers revealed that various MCD-claimed actions continued to operate, prompting Justices Yashwant Varma and Ravinder Dudeja to issue the instruction. The bench heard a number of coaching centre petitions, including one it filed after noticing a fire at one in Mukherjee Nagar last year. The amicus claimed numerous premises violated fire safety rules, and one had an electrical board at the door that blocked fire escape. . "In light of apparent violation of sealing directions issued by us, we direct MCD/DDA to take action forthwith." HC also clarified that a building's "character" for identification as an educational building and fire safety norms must be determined by its "use" and asked MCD, DDA, and Delhi Fire Services to conduct a new survey within four weeks to identify non-compliant centres.
