Raging wildfires disrupt life in Uttarakhand, claim 4th life in 3 days

DEHRADUN: Raging fires in several forest ranges of Uttarakhand have claimed the life of a 28-year-old woman the fourth casualty in the past three days — even as the Adi Kailash helicopter darshan service, which began last month, has been suspended for the second day in a row. Flight arrivals at the Naini-Saini airport in Pithoragarh have been stopped due to low visibility in fire-induced haze. at Dunagiri temple, a prominent shrine in Almora district, were forced to flee on Saturday as fire engulfed the passage to the shrine, lined with bells. Videos showed pilgrims screaming and scrambling for safety, as leaping flames appear to give chase. Forest officials attributed the rapid spread of the fire to strong winds that transformed it into a "crown fire". Priests and the forest department team quickly helped pilgrims to safety and no casualties were reported.



Locals said the fires have left a trail of ash dust everywhere and they are breathing it in. "There are a few places on the road from Haldwani where rocks have fallen and there are landslides due to the fires. We are seeing the hills burning at night and in daytime, the smoke prevents visibility. It's almost like an apocalypse," said a resident of Mukteshwar. In Chamoli district, the blaze engulfed a large kiwi orchard. Fires on hilltops in parts of Garhwal region like Rudraprayag and Chamoli were also reported on Sunday.

about 910 incidents of forest fire have been reported since Nov 1 last year, when the blaze was first reported in the state, destroying over 1,144 hectares of forest land. The fires have been raging for almost six months now, unlike not California

wildfires. Kumaon division is the worst-affected, reporting the maximum of 482 incidents. The wildfires have resulted in the deaths of five people so far. The most recent death was that of a 28-yearold woman labourer of Nepalese origin. The victim, identified by her Forest officials said that first name, Puja, 28,

was grievously injured while trying to douse a forest fire near a pine resin factory in Almora district three days ago. She died of burn injuries on Saturday. Her husband and two others had died last week while battling the same fire. The fires have also

impacted tourism activities, putting a question mark on trekking and mountaineering trips in Kumaon region, with many groups who were planning such trips now unsure whether to go "Normally, ahead. trekking season starts after May 10 in the Kumaon region. While Kamalpreet Singh (23) was in Canada for studies and comes from a farmer's family in Jalandhar, relatives Karanpreet Singh (28) are also agriculturists and say he worked as a driver.

Third suspect, Karan Brar, also went to Canada for studies.

"Most youths here go abroad. He went there on a study visa in 2019," said Kamalpreet's father Satnam Singh, a key official in Chak Kalan near Nakodar in Jalandhar district.

On Kamalpreet's association with other two accused, Satnam said he was aware of his friendship with Karanpreet and they had stayed together in the same house in Canada. "I have heard Karan's name for the first time," said Satnam.

Also an agent at the local grain market, Satnam recalled that Kamalpreet would call the family every week. "For us, everything was normal till we received this shock," he said. At Sundel village in Gurdaspur district's Aliwal, Karanpreet's family said they had spoken to him on the phone a day before his arrest on Friday and that "everything was normal". "He appeared normal without any indication of being in trouble," said Karanpreet's dad Sukhdev Singh.Punjab police visited their home for an inquiry about Karanpreet. Sukhdev said Karanpreet had hired a lawyer and will be produced in court on Monday.



Fungal, bacterial skin allergy cases up

Prayagraj: With summer season at its peak, skin allergies including photo-dermatitis and fungal infections have started troubling city residents. Dermatologists in city hospitals say while there has been a jump of 10-15 times in photo-dermatitis cases, the number of fungal infection cases too has increased by about 10 times in the hospitals. Experts say whereas photo-dermatitis is caused due to prolonged exposure to ultra-violet rays of the sun, fungal allergies are caused by sweating in the hot weather.

"Since summer has already begun, there has been an increase in the number of patients seeking consultation for skin allergies at our clinic. Nearly, half a dozen patients come to our clinic on a daily basis, out of which several cases are that of photo-dermatitis (the number on routine days in other seasons is usually one or two only), whereas the number of fungal infection cases has risen to 10-12 a day against 0-2 cases on routine days in other seasons. In the case of fungal allergy, there is an itchy disorder due to sweat. It mostly is witnessed in the foot, groins and arms area, whereas photo-dermatitis is because of exposure of the face and outer area of forearms to direct sunlight. In this infection, the affected area becomes reddish and later turns white," says skin specialist Dr. Naveen Kumar Yadav.

Other doctors echoed his views and claimed that though skin infections are prevalent in all age groups, it is more common in the extreme age groups, like children and the elderly, while skin allergies have mostly been reported in the young and middle-age groups. The extreme age group people cannot bear the allergies, so they are less prone to it, but as their immunity is less, they are easy prey to infections. The young and middleage groups are more prone to allergic reactions because of increased exposure to sunlight.

A person can fall severely ill in such extreme weather conditions. It is therefore, necessary to take extra care during summer season to avoid falling prey to heat stroke. Experts say that the people who travel in sun mainly due to office work are likelihood of falling ill. Thus, they should take extra care of themselves. > People should wear dresses that cover their body parts including hands, neck and face to avoid sun burn or skin related ailments. Heat stroke, also known hyperpyreixia, occurs due to overheating of the body during summers. This may also occur in people who are

According to experts, certain people, who lack sweat glands, are more prone to heat stroke. While, unsuitable clothing and poor eating and living conditions always increase the risk. People who are exposed to sun for longer period and lack sweating, may develop body temperature as high as 105 degree Fahrenheit, which is also known as summer-fever. Due to abnormal rise of body temperature, the central nervous system and brain may get commonly. The people

can faint even. Thus, there is a dire need in such a season to drink lots of water.

The recent records of the Outpatient Department (OPD) of the district hospitals show that there is a sudden spurt in the number of patients coming for treatment of heat-related diseases, including heat stroke. According to the doctors, around 30% increase in patients with heat related diseases has been reported in the past one week when mercury had crossed 40 degree Celsius mark.

The Met department also stated that the hot winds (loo) have started blowing across the city which, though are not good for the people, but will add sweetness to the musk melons. The streets wore a deserted look on Thursday afternoon as most of the people preferred to stay indoors.

Librarian posts vacant in govt colleges for over a decade

Prayagraj: At a time when the state government is taking initiatives to improve the quality of teaching in higher education institutions, over 300 librarian positions have been lying vacant in government and government-aided degree and postgraduate colleges for over a decade.

In the absence of regular librarians, the duties are performed by either teachimpacted are the state's 321 government-aided degree colleges, where over 200 librarian positions are currently vacant. Previously, managers of the colleges concerned used to select librarians at their level.

"According to the Supreme Court rulings, librarians have been provided the pay scale set by the

UGC from January 1, 1986, and college administrations are not permitted to make appointments to jobs receiving UGC pay scales. As a result, on May 13, 2009, the state government prohibited the appointments of librarians at the level of managers at these colleges," informed the principal of a government-aided degree college.

Following that, the duty for appointing librarians at government-aided degree colleges was delegated to the Prayagraj-based Uttar Pradesh Higher Education Services Commission (UPHESC) at a state cabinet meeting in November 2012

"However, the Directorate of Higher Education has not requested requisition of empty librarian positions

from institutions since then, nor has the recruitment process kicked off," the principal claimed. Even state higher education department officials admit that, in addition to the 200 or so librarian positions that are empty at government-run degree schools, more than 100 librarian positions are vacant in 170 government degree colleges located around the state. "At the moment, librar-

ians work in just 36 of the 170 government-run degree colleges in Uttar Pradesh. Even librarian positions have not been created in almost two dozen colleges, and more than 110 colleges do not have regular librarians. The appointments in these cases would be made through the Uttar Pradesh Public Service Commission

(UPPSC). However, after 2005 and 2008, the commission did not issue any advertising for the recruitment of librarians in these institutions," the authorities explained. Secretary of UPHESC

stated that the recruitment process could not begin due to non-receipt of requisition regarding vacant posts of librarians from the UP Directorate of Higher Education.

Suresh Kumar Tripathi, former MLC stated, "On the one hand, we have competent librarians looking for jobs in UP, while on the other hand, we have institutions starving for librarians to run their libraries professionally. I request the state administration to quickly hire librarians to fill all vacant positions.'



Growing clamour for green space with residences

Prayagraj: The growing clamour for green space within their residences is rapidly catching up among residents. The idea for developing green space within the house is to seek comfort and relief from scorching summer heat which makes life deplorable for citizens during power cuts. However, people adopting gardening as a hobby during summer season need to learn some basic rules, which will go a long way in keeping their green space alive.

"Over watering the plants or the lawn during summer is the most common mistake that people commit, as far as longevity of the plants is concerned. Each plant has different needs; one should water plants sensibly and in the evenings, so that it keeps the plants moist overnight. Classifying the plants is one of the elementary factors, if the plants are arranged according to the amount of sunlight they need, things can be lot easier for the caretaker of the garden" said Kailash Sharma.

Indoor plants, half shade plants and full shade plants are the three major classifications for household plantation. Half shade and full shade are two types of plants which need sunlight for their survival, although the difference between them is that half shade plants need only a definite amount of shade, and full shade may need an enclosure where only nominal amount of sunlight enters. "One should keep full shade plants inside a net shade in summer and should move half shade plants to the shaded parts of the garden, as summer heat may pose danger to them and over exposure to the sun may even destroy them. Organic manure is also the key to keep moisture stored for a long time," he explained.

Another nursery owner said "Watering should be done only when the sun's heat is not at its peak, that is before 9 am, or when it is fading that would be after 5 pm. One should completely avoid cutting plants or shaping them during the summer. As far as lawn cutting is concerned it should be done in the evening and the lawns should be watered immediately after it's mowed." He further added "chemical fertilizers are a complete no-no during summers and only old animal manure should be used during this season. Also, one should clean the lawn thoroughly after it's mowed, as the leftovers of the lawn may kill the living grass."

Salaried class beware: First week of every month lucrative for looters

PRAYAGRAJ: There is no doubt that the first week of the month has a big attraction for highway robbers on bikes. This is the time when people collect arrears or go to banks to get their pension money or withdraw money for monthly expenses. Employers also go to banks to withdraw salary funds for their staff. In short, bank transactions of the recurring nature are at their peak in the first week of every month. That could explain why roadside snatchings are so common round this time of the month. It would seem that the robbers keep an eye on who all are visiting a bank. They have an intricate grass root network of informers, who provides tip off, when a man moves out of the bank, with the presumption that he has withdrawn money. On mobile phones the crooks can inform each other about it and plan their move.

Several cases have occurred in the first week of last month when women reporting cases where a man zoomed past on a motorbike, hit them and snatched their purses, an officer said. He called it a "terrorising" crime for women. That sense of panic has been quelled to some extent, with habitual offenders wary of an arrest owing to the spate of arrests. However, a desperate citizen called up on phone and said: 'If all road crimes are being committed by criminals on bike, and if cops cannot catch them, should they not be put off the roads at least during the first week of every month? He says, 'Can't the Government put a limit on the speed of the bikes at the manufacturing stage itself, fixing the limit at 40kmh?'

Composite reflection of the growth trajectories

India's economic progress is a composite reflection of the growth trajectories of its states. Given the federal structure of the country, each state operates with a degree of autonomy in implementing policies that drive their individual economies. This results in a broad spectrum of growth rates across states, highlighting significant disparities. For the nation to achieve holistic growth, it is imperative for all states to experience economic advancement. Despite this, there is a notable discrepancy in the attention paid to fiscal matters at different levels of government. The Union Budget, detailing the central government's finances, often garners substantial scrutiny and debate for its potential impacts on the nation's economic direction. In contrast, state budgets, which are crucial for addressing local needs and fostering regional development, do not attract a similar level of public and analytical scrutiny. Fiscal capacity, the government's ability to generate revenue from available tax and nontax bases, is crucial for several reasons. First, it underpins a government's ability to provide essential public goods and services. These range from healthcare and education to infrastructure and defense, which are fundamental for the welfare of the citizenry and the smooth functioning of the economy. Without adequate fiscal capacity, governments may struggle to maintain these services at levels that meet public demand and expectations, potentially leading to social unrest or a decline in the quality of life. Second, fiscal capacity is vital for economic development and growth. Governments need resources to invest in infrastructure projects like roads, bridges, and digital networks, which are critical for enhancing productivity and competitiveness. Such investments not only improve current living standards. but also set the stage for future economic expansion. The Asian Development Bank Institute (ADBI) in 2017 and the World Bank in 2015 highlighted the risk of economies falling into a 'middle-income trap' where they are unable to transition to high-income status due to inadequate fiscal capacity among other factors. Moreover, fiscal capacity is essential for macro-

economic stability. It allows governments to manage economic cycles more effectively, applying fiscal stimulus in downturns and restraint in booms to maintain economic stability. The Covid-19 pandemic's impact on Indian states underscored this point, as reduced fiscal capacities constrained their ability to respond effectively to the crisis and its economic repercussions.

Finally, a robust fiscal capacity enables equitable social development. It allows for redistributive policies that can mitigate income inequality and fund social safety nets for the vulnerable. Studies have shown that factors such as high per capita income, education levels, and low corruption contribute to higher fiscal capacity, which in turn can be used to foster a more inclusive society.

Given that state governments account for over 60 per cent of general government expenditure in India, enhancing their revenue-generating capacity is imperative for the needed investment in areas such as education, research and development, and skill development.

The Reserve Bank of India recently released a report on state finances, which gives an insight into the state budgets of 2023-24. It has some important findings. First, revenue mobilisation in Indian states comprises both tax and non-tax revenues, with a significant portion coming from state's own tax revenues (SOTR). Over the years, there has been a noticeable increase in SOTR, growing from 5.7 per cent of GDP in 2003-04 to 6.9 per cent in 2022-23. This growth, particularly in the post-GST era, reflects a shift in the

composition of tax. revenues. with the State Goods and Services Tax (SGST) becoming a predominant

What this means is that Sanatana Dharma has allowed for differences of opinion within its fold, including trenchant criticism of some aspects of it, by its own fol-

lowers. The Hindu faith had not one but six systems of philosophy attempting to understand the truth behind the vast and bewildering plurality of the cosmos. Each of them had a different interpretation. In addition, there is the Lokayita Charvaka school, which cogently argued the materialist school of thought, denied the existence of God, and considered the Vedas, regarded as Shruti or revealed texts by many Hindus, as devoid of all sanctity. But the Charvakas were not ostracised, or worse, beheaded for blasphemy. Instead, they enriched the dialogic debate within Hinduism and were countered in a civilised manner by those opposed to them. In the 8th century CE, Shankaracharya, who is considered the 'reviver' of Hinduism, could say without fear: na mantro na teertham na veda na yajnah: neither mantras, nor pilgrimages, nor the Vedas or yajna (rituals), matter. What matters is: Chidananda roopam, Shivo hum, Shivo hum: bliss and awareness, I am Shiva, I am Shiva. In many religions, the declaration of equating one-

self with God would be considered blasphemy. For instance, in Persia, a Sufi mystic, Al Hallaj (858-922 CE), contemporaneous with Shankaracharya, was put to death for having the temerity to say: 'Ana'l Haq: I am the Truth'. But not so in Sanatana Dharma. The basic point is Sanatana Dharma is eternal for the grandeur of its philosophical vision, and not only for its religious practice; it is eternal for the diversity it allows for in thought, and not necessarily its rituals. Therefore, narrowing the interpretation of Sanatana Dharma to exclude all differences of opinion is distorting its greatness and, indeed, the

very reason for survival. Unfortunately, this is precisely what we see happening today. Anybody and everybody is 'hurt' by anyone who does not blindly endorse everything that is deemed by the 'hurt' to be a part of Sanatana Dharma, including those ills that urgently need reform, such as the pernicious caste system and gender disparity. If this is the criteria, then Veer Savarkar, the icon of Hindutva, would be hounded today, because he wrote extensively and consistently about what is wrong in the Hindu faith and practice. He called these the 'seven fetters, including the misinformed religious sanction given to the system.

INDORE: Four women were arrested for allegedly beating up, stripping and parading a 30-year-old woman over a dispute at a village in Madhya Pradesh's Indore district on Wednesday. A video of the purported incident that occurred during the Holi also surfaced on social media. "four forcibly pulled the victim out of her house, beat her up and humiliated her by stripping her naked in public at Bachhora village of Gautampura police station area," Superintendent of Police (Rural) Sunil Mehta said. 

NEW DELHI: Government is looking at rolling out a fresh multibillion-dollar incentive package for semiconductor companies after nearly exhausting the Rs 76,000crore plan that was launched in Dec 2021 for supporting investing companies, top sources told TOI. Preliminary work on the new package, which is "in all likelihood be much bigger than the previous one", has already begun, even though announcements in this regard will be made only once the new govt takes charge post the national elections, they said."The new package would be one of the key agendas for the new govt and will be taken up on a priority basis," one of the sources said, pointing out that new proposals that are coming in for semiconductors necessitate a fresh package. "The matter would be tabled before the new Cabinet as some of the proposals are at an advanced stage and would require immediate assurances from the state in terms of incentives," the source said. Success of Dec 2021 package is prompting the govt to work out a new one, especially in view of the aggressive stance of countries such as the US and China, which have announced much bigger packages for companies that are investing in semiconductors. Under the current plan, govt extends fiscal support of up to 50% of a project's cost to eligible display and semiconductor fabricators. This has been almost exhausted after the spate of investments that came in.India, which had previously failed to get any credible proposals for semiconductor manufacturing after trying for decades, finally managed to score big after American Micron emerged.

High court upheld a single-judge bench's order dismissing a plea

INDORE: A division bench of Madhya Pradesh high court on Friday upheld a singlejudge bench's order dismissing a plea by Congress' Moti Singh Patel for his candidature to be accepted as the party nominee for Lok Sabha elections after official candidate Akshay Kanti Bam pulled out of the poll race at the last minute. The Indore bench, comprising Justice SA Dharmadhikari Justice Gajendra Singh, said Patel's application was "bereft of merit and substance".

Patel had approached the division bench after a single-judge bench of Justice Vivek Rusia on April 30 turned down his plea to overturn the rejection of his nomination by district election officer and to be allotted the Congress 'hand' symbol to contest polls. Indore votes in the fourth phase on May 13. Patel's candidature was rejected during scrutiny on April 25. Bam's papers were cleared 'approved Congress candidate', but he suddenly pulled out on April 29, the last day for to have given a day's

withdrawal of nominations. It left Congress without a candidate in Indore for the first time ever.Patel's Khandelwal Vibhor contended before the division bench that the returning officer may have been right in rejecting Patel's nomination on April 26 since at that time he was not the approved Congress candidate and his form was not signed by 10 proposers. The erstwhile state was bifurcated on August 5, 2019, into two Union Territories -- Jammu Kashmir, and Ladakh. Article 370, which gave special status to Jammu and Kashmir, was also abrogated on that day.

As per the provision of Jammu **Kashmir Reorganisation** Jammu Act, Kashmir has been made a UT with a legislative assembly and Ladakh has been made a UT without any assembly.

Courts cannot direct states to implement particular schemes: SC

NEW DELHI: The scope of judicial review in examining policy matters of the government is very limited and the courts cannot direct the States to implement a particular policy or scheme on the grounds that a "better, fairer or wiser" option is available, the Supreme Court has said. The observation came while disposing of a PIL seeking formulation of a scheme on setting up of community kitchens to combat hunger and malnutrition.

The top court refused to pass any direction in the matter observing that the National Food Security Act (NFSA) and other welfare schemes are being implemented by the Centre and states.A bench of Justices Bela M Trivedi and Pankaj Mithal said legality of the policy, and not the wisdom.
