Share of Hindu population down by 7.82% in India: Highlights from EAC-PM report

Advisory Economic Council to the Prime (EAC-PM) Minister recently published a study that analyzed the shifts in religious demographics across various countries from 1950 to 2015. The study, named "Share of religious minorities: A cross-country analysis,' shed light on change in demographics from 1950 to 2015.

According to the findings, India's Hindu majority population experienced a decline of 7.81 per cent during the 65-year period.

In contrast, the Muslim community in India witnessed a significant increase of 43.15 per cent within the same timeframe. The study aimed to provide a comprehensive understanding of how religious composition has evolved in different nations over the past several decades, offering valuable insights into this critical dimension of demographic transformation.

According to the report, the global aver- a diversification of reli-



age for the share of the majority religious denomination in 1950 was 75%. By 2015, this figure had decreased by approximately 22%, indicating a global trend towards greater religious heterogeneity. The study highlights significant regional differences. For instance, more than half of the countries with the largest demographic shifts are located in Africa, where shifts from animist majorities to other religious denominations were most common. Countries like India and several OECD nations have also seen declines

in their majority reli-

gious shares, signaling

gious demographics. In contrast, many Muslimmajority countries have seen an increase in the share of their dominant religious groups.

President Putin warns of global clash as **Russia marks Victory**

NEW DELHI: Russian President Vladimir Putin cautioned against a potential global conflict and asserted Russia's determination to safeguard its status as the world's largest nuclear power in his address on Thursday.

As Putin led the commemoration of the victory over Nazi Germany in World War Two, he criticized Western elites for disregarding the pivotal role played by the Soviet Union in defeating Nazi Germany and accused them of instigating conflicts worldwide.

Speaking on Red Square amid a rare May blizzard, Putin highlighted Russia's commitment to prevent a global clash while maintaining the readiness of its strategic forces. "We know what the exorbitance of such ambitions leads to. Russia will do everything to prevent a global clash," Putin said on Red Square. He said that the current conflict with Ukraine is part of a broader struggle with the West, stemming from what he perceives as Russia's post-Cold War humiliation and encroachment on its sphere of influence. Putin's rhetoric echoes the narrative that Russia's actions in Ukraine are justified, portraying them as reclaiming territories historically linked to Russia. However, Ukraine and Western nations view Russia's actions as imperialistic and have pledged to resist its expansionist efforts. Putin criticized Western nations for purportedly attempting to downplay the lessons of the war, emphasizing the importance of honoring all allies involved in defeating fascism. The commemoration on May 9, known as Victory Day in Russia, marks the Soviet Union's triumph in what Russians refer to as the Great Patriotic War. Amid tensions with the West, the parade in Moscow showcased military hardware, including the Yars intercontinental strategic missile, symbolizing Russia's military capabilities. Notably absent from the event were leaders from Western nations, indicative of the strained relations between Russia and the West. Against the backdrop of escalating tensions.

For this reason, people should not be careless and in case of such complaint, immediately contact the doctors of the local CHC. Constant fluctuations in temperature are directly affecting people's health. Due to this, the number of patients suffering from seasonal diseases and viral fever etc. is increasing. Patients coming to the hospital are also being advised to be careful about their eating habits in summer. The maximum temperature has dropped by 1 degree in 24 hours. However, there was no respite from the heat. Even on Thursday, people were troubled by the heat due to the strong sunlight. On Thursday, the maximum temperature dropped by 1 degree to 39.5 degrees Celsius. Whereas the minimum temperature increased by 1.4 degrees. She said that she was ultimately forced to transfer Rs. 1.48 crore in different bank accounts in lieu of her name being cleared from the 'drug' case.

Later, upon realising that she had been duped, Kakoli approached the

that the gang operates through agents who take access to bank accounts from people on the pretext of providing them commission. Voter turnout during Phase 4?

Temperatures are rising and it is amid this unpleasant weather that India is heading to the second phase of its general elections. The Lok Sabha polls are being held in seven phases, with the counting of votes on 4 June. Extreme heat is being blamed for the low voter turnout in the first phase of polling on 19 April when 102 Lok Sabha seats spread across 21 states and Union Territories voted. A dip of 4.4 per cent was recorded in these seats, as the voter turnout stood at 65.5 per cent this year from 69.9 per cent in the 2019 general elections. As 13 states and Union Territories go to polls on 26 April in the second phase, will the heatwave impact the voter turnout?

Which states are going to poll?

The 4th phase of polling will cover 89 constituencies in 12 states and one Union Territory. Kerala's all 20 Lok Sabha seats, 14 in Karnataka, 13 in Rajasthan, eight seats each in Maharashtra and Uttar Pradesh, seven in Madhya Pradesh, five each in Assam and Bihar, three each in West Bengal and Chhattisgarh and one each in Tripura, Manipur and Jammu and Kashmir.

Are there heatwave predictions?

There is a heatwave warning for parts of four states - West Bengal, Bihar, Uttar Pradesh and Karnataka – going to polls in the second phase. According to the India Meteorological Department (IMD) forecast, hot and humid weather is expected in Assam, Meghalaya, Tripura, Konkan, Goa, Coastal Karnataka, Tamil Nadu, Puducherry, Karaikal, Kerala and Mahe. "Heatwave to severe heatwave conditions likely to prevail in some pockets over Gangetic West Bengal and in isolated pockets over Odisha; heatwave conditions in isolated pockets over Uttar Pradesh, sub-Himalayan West Bengal, Jharkhand, Bihar, Coastal Andhra Pradesh and Yanam, Rayalaseema, Telangana and interior Karnataka," as per the IMD. Speaking to NDTV, Dr Naresh Kumar, senior scientist at the IMD, said that the weather agency has issued a red alert for West Bengal for the next three days.

"Temperatures in Bihar will exceed 40 degrees Celsius. A heatwave is expected in eastern Uttar Pradesh after 24 hours and in western Uttar Pradesh after two days. The temperature will remain hot and humid in Kerala too," he said. The IMD previously warned that heatwaves lasting 10 to 20 days, unlike the normal four to eight days, are expected between April and June. What is the EC doing?

A day back, the IMD Director General, Mrutunjay Mohapatra, assured the Election Commission of India (ECI) that heatwave is not a major concern for the second phase of elections. The ECI Monday (22 April) formed a task force consisting of officials from the IMD, the poll body, the National Disaster Management Authority (NDMA), and the Ministry of Health and Family Welfare to assess the impact of heatwave and humidity five days before each phase of polling. The remarkable rise of Biharis in Delhi: From cheap labour to influential vote-bank

The emergence of the Purvanchalis/Biharis as the most influential electoral community is a story of a long journey of struggle and perseverance. During the watershed Assembly election in Delhi in 2013, the then Chief Minister Sheila Dikshit was looking forward to a fourth term. The confidence emanated from the development overhaul she carried out during the 2010 Commonwealth Though the Congress government at the Centre was mired in allegations of corruption, Dikshit felt assured of steering clear of it. However, then Congress member of Lok Sabha from West Delhi, Mahabal Mishra, had warned Dikshit about an impending defeat and had suggested to her that she could gamble by giving a large chunk of tickets to the party workers from Purvanchal (migrants from east UP and Bihar). Dikshit, who was never comfortable with Mishra, saw it as a ruse on the part of the Purvanchali leader to create a claim for himself as a rival to her. As the results came out, she was dismayed that her development drive was drowned in the cacophony let loose by the Anna Hazare movement, whose product is the Aam Aadmi Party (AAP). The arrival of Arvind Kejriwal and the AAP marked the beginning of a new



genre of politics. During the past three decades, Delhi has undergone a deep demographic change. The migrants arriving in the city, which is North India's El Dorado, have given a new character to its social and cultural life. From being poor tenants in the unauthorised colonies, they are now proud holders of plots but have been fighting with successive governments for the assertion of their civic rights. Their struggle has not been limited to the recognition of their housing plots. They eke out a living fighting various forces of corruption aka government. The Congress and the BJP all those years instead of holding their hand depended on poll malpractices, exploiting their poverty to get their mandate. The migrants from the eastern districts of Uttar Pradesh, Bihar, Jharkhand and some districts of Madhya Pradesh bordering these areas for

long looked for a role in the politics of the national capital. When Kejriwal, during the campaign in 2015, said to accept liquor and money from the Congress and the BJP but vote for him, he showed that he had his ear to the ground. In that poll, the AAP had put up Purvanchali candidates in 15 out of 70 seats and they all romped home. Today, Mahabal Mishra is AAP's candidate from West Delhi. His son Vinay is an AAP MLA from their traditional Dwarka seat. For the 2024 Lok Sabha polls, for which voting is scheduled in Delhi on May 26, the BJP has fielded one Bihari candidate Manoj Tiwari, the sitting MP from the North East Delhi seat. AAP-Congress has fielded three Biharis – Kanhaiya Kumar from North East Delhi, Somnath Bharti from the New Delhi seat and the veteran Mahabal Mishra from the West Delhi seat.

While Kanhaiya Kumar and North East Delhi seat, they Manoj Tiwari are imports into the capital's politics, Mishra Somnath Bharti have grown politically in the national capital. One may recall that Mahabal Mishra was the first Bihari to win an electoral battle, winning a seat as a corporator from Nasirpur in Outer Delhi in

Though before him, a Purvanchali, Lal Bihari Tiwari had won Assembly polls from the East Delhi seat of Ghonda and become a minister in the state BJP government. Later, Tiwari won three consecutive Lok Sabha polls in 1997 (bypoll), 1998 and 1999. However, there is a marked difference in the politics of Tiwari and the present-day Bihari politicians in the capital - from meek submission to that of aggressive assertion According to the data released by the Election Commission, Delhi has a total of 1,47,42,145 voters 79,98,652 67,42,330 female and 1163 from the third gender. This is up by about 6.5 per cent from 1,38,46,482 in 2019. According to estimates, 33.5 per cent of the total 1.48 crore voters across the seven Lok Sabha constituencies are Purvanchalis. Their presence varies from 24 per cent in Chandni Chowk to 41 per cent in East Delhi. On the reserved seats).

Today, they are not just at par but more influential than other major electoral blocks like that of Punjabis, Vaishyas, Gujjars, Jats and minorities. Numerically, the two formations together have fielded two Vaishyas, two Gujjars, two Punjabis, one Jat, three Scheduled Caste (two from

55% Covidshield recipients had mild side effects: AMCH study

GUWAHATI: A study conducted by physicianscientists from Assam Medical College Hospital (Dibrugarh), supported by ICMRrecognised multidisciplinary research laboratory, has revealed that 55% of Covishield vaccine recipients experienced only minor side effects like fever and headache. These symptoms occurred within a week of getting inoculated with the first dose.Researchers confirmed no long-term adverse effects after a year."In our study, we found that 55% experienced minor adverse events such as fever, headache, body ache and pain at the injec-



tion site. The remaining 45% of the recipients had no adverse events at all. After the second dose, only 6.8% showed minor adverse events following immunisation (AEFI). Most importantno participant showed any major adverse events during the entire one year period of study," said

associate professor of pathology at AMCH, Gayatri Gogoi, the principal investigator of the study done in Assam's Dibrugarh district.The major (serious and severe) adverse events were defined as disabling, rare life-threatening conditions that may lead to long-term problems.

Ferozepur: A youth was lynched by a mob after he was accused of tearing the Guru Granth Sahib at a gurdwara in Bandala village, Ferozepur district, Saturday. The mob allegedly beat Lakhwinder Singh to death on the spot. Apart from people visiting the gurdwara, locals also thrashed the youth. Lakhwinder was in his early 20s and lived in Talli Ghulam village. An FIR was registered at Arif Ke police station. Lakhwinder's father, Bakshish Singh, claimed his son was mentally upset and had received treatment in Delhi. After being beaten till he was unconscious, Lakwinder was taken to hospital where he was declared brought dead.

Jaleel to contest from Aurangabad, says Owaisi Chhatrapati Sambhajinagar: Putting an end to speculations of Aurangabad MP Imtiaz Jaleel contesting the Lok Sabha polls from Mumbai, All India Majlis-E-Ittehadul Muslimeen (AIMIM) president Asaduddin Owaisi on Monday announced Jaleel's candidature from Aurangabad again. Owaisi took to X and announced that his party's Bihar president Akhtarul Iman would be the party's candidate from Kishanganj (Bihar) and Imtiaz Jaleel would contest from Aurangabad. Owisi himself will contest from Hyderabad.

During a media interaction in Hyderabad, Owaisi said: "In addition to these three candidates, party's state presidents in Maharashtra, Bihar and Uttar Pradesh are working on finalising the number of seats to be contested. We will make an official announcement." When contacted, Jaleel said: "I thank the people of my constituency for letting me represent them in Parliament for five years. I did my best to raise the voice of the common people and fought hard against the wrong govt policies. Now, I will again approach people and if they feel I have done good work, then they would definitely stand with me. My initial two years as MP were lost because of Covid. Hope people will give me an opportunity to continue serving them." Jaleel, after winning the MLA elections in 2014, contested and won the LS elections against Shiv Sena's Chandrakant Khaire with a narrow margin in 2019 elections. He had openly expressed desire to contest the upcoming Lok Sabha polls from Mumbai .(North Central). Jaleel had cited communal violence on Thane's Mira Road during the Ram temple consecration, followed by civic body's action of demolishing several 'encroachments.

Paytm shares start flat on bourses after declining 3.74% on Thursday

Shares of One97 Communication, owner of brand Paytm, were trading flat on BSE and NSE on Friday. Shares were trading at 391.00, marking an increase of 0.68% or 2.65 points from its previous close at 09:27

shares Earlier, Paytm dropped by 3.74% to settle at 380.45 on Thursday, after hitting upper-circuit for four consecutive session.

The stock prices, on Wednesday rose to Rs 395.25 and Rs 395.05 on the BSE and NSE, respectively, defying market broader trends.

This surge follows Paytm's recovery from a recent slump, with its stock rebounding more than 21% from last Thursday.

Reports indicate that Enforcement Directorate(ED) found no significant violaof foreign exchange rules in its ongoing investigation into Paytm Payments Bank Ltd (PPBL). However, it came



across some lapses in the company's KYC processes and reporting of suspicious transactions. The scrutiny on Paytm has intensified as the Reserve Bank of India (RBI) tightens oversight on fintech firms globally. Recent actions by the RBI include directing to cease certain operations of PPBL due to non-compliance issues, affecting e 9 7 O n Communications despite its 49% stake in the banking entity. The RBI's stricter stance comes as concerns over customer due diligence, data privacy, and systemic risks prompt a reevaluation of oversight mechanisms, primarily

focusing on digital customer identification practices.

In response, the RBI has increased inspections and meetings with fintech companies, aiming to tighten compliance ensure the integrity of the financial ecosystem.

ry landscape may lead to higher compliance and capital requirements for fintech firms, potentially resulting in sector consolidation. Industry stakeholders Ashish Fafadia of Blume Ventures believe this scrutiny will foster compliance and support investment in law-abiding

Premature move on monetary policy front could undermine efforts to check inflation: RBI

MUMBAI: The Reserve Bank of India's job to bring down inflation is not over, and any premature move on the policy front could undermine the success achieved so far on the price situation, according to RBI governor Shaktikanta According to the minutes of the February Monetary Policy Committee (MPC) meeting released by the central bank on Thursday, Das had said at this juncture, monetary policy must remain vigilant and "not assume that our job on the inflation front is over". He stressed that the MPC must remain



committed to successfully navigate the "last mile" of disinflation that can be sticky.

Das made the remarks while voting for status quo in the key interest rate earlier this month.

"As markets are frontrunning central banks in anticipation of policy pivots, any premature move may undermine the success achieved so far," the governor said, as per the minutes.

100% FDI in space sector a game changer: IN-SPACe chairman Pawan

BENGALURU: A day after the union cabinet, in line with the Centre's reforms to open up the space sector, allowed 100% foreign direct investment (FDI) under the automatic route, space regulator and promoter Indian National Space Promotion and Authorisation

(IN-SPACe) chairman Pawan Goenka termed it a "game-changing decision that will propel India to new heights in the space sector".

Lauding PM Narendra Modi's vision Goenka said the move will boost participation of non-government entities in space research and man-

ufacturing. "By opening doors for massive investment and global collaboration, this move will transform India's space capabilities," he said.

Byju Raveendran, board to skip 'procedurally invalid' extraordinary general meeting

MUMBAI: A day ahead of the extraordinary general meeting (EGM) which a group of Byju's major investors have called to seek removal of Byju Raveendran from position of CEO as well as a reconstitution of the firm's board, Byju's said that Raveendran and the board members will not attend the EGM which it said is "procedurally invalid." Following the resignation of representatives of Prosus, Peak XV Partners and Chan Zuckerberg Initiative from the board of Byju's in June last year, it has been reduced to a familyrun entity, comprising Raveendran, his wife and co-founder Gokulnath and his brother Riju Raveendran."This EGM is procedurally invalid, contractually in contravention of our AOA (Articles of Association) and SHA (Shareholders Agreement), legally on the wrong side of the Companies Act, 2013," a company spokesperson said in a statement on Thursday. Byju's said that with Raveendran and board members deciding to skip the EGM, it will not have the required quorum and cannot proceed to discuss or vote on the agenda. "As custodians of Byju's, it is the responsibility of the founders to respect the established procedures of law and protect the company's integrity," the company added. The EGM is supposed to take place on Friday morning, according to the EGM notice reviewed by. Investors claim that they will hold the EGM as per plan but if the resolutions are put to vote, then they will test the law in court, lawyers said.

Foreigners pursue every avenue to access hot India bond trade

Overseas investors are showing such keen interest in India assets that they are taking proxy exposure to the country even if they don't have the license or physical presence to trade there.

Foreign funds lacking direct access to India's \$1 trillion government debt market are increasing their exposure via instruments such as supranational bonds and swaps ahead of the nation's upcoming inclusion in global bond indexes.
