AstraZeneca in court papers says Covid vaccine can have rare side effect

LONDON: AstraZeneca has said in court documents that its Covid vaccine can cause a rare side effect, the UK's Daily Telegraph newspaper reported. The statement by the pharmaceutical giant comes as it is being sued for over £100 million (a little over Rs 1,000 crore) in class action over claims its vaccine caused death and serious injury in 51 cases, according to court documents seen AstraZeneca is contesting the claims but has accepted, in a legal document submitted to the high court in February, that its Covid vaccine "can, in very rare cases, cause thrombosis with thrombocytopenia syndrome", which causes people to have blood clots and a low blood platelet count.In India, the vaccine was sold under the brand name Covishield manufactured by the Serum Institute of India (SII) in Pune. When contacted, SII declined comment. One of the claimants is



Jamie Scott, a father of two, who was left with a permanent brain injury after developing a blood clot and a bleed on the brain that prevented him from working after he received the AstraZeneca vaccine in April 2021.

The product information relating to the AstraZeneca-Oxford vaccine was updated in April 2021, with the approval of the UK regulator MHRA, include the possibility that the AstraZeneca-Oxford vaccine is capable, in very rare cases, of being a trigger for thrombosis withthrombocytopenia syndrome

and publicly available, the UK newspaper reported.

The vaccine, developed with Oxford University, is no longer used in UK. Lawyers representing families suing the drugs company argue that the

vaccine was not as safe as individuals were entitled to expect. They are suing the firm under the Consumer Protection Act of 1987, arguing the maximum £12,000 (more than Rs 12 lakh) payout they could get from the UKgovt-run vaccine compensation scheme is inadequate.

Nestle working on Cerelac with 'no added sugar'




NEW DELHI: Under attack for high sugar content in baby food Cerelac sold in the country, the Swiss FMCG major is planning to launch the popular infant formula with "no added sugar" in India.

The company has already been on a journey to reduce it to a bare minimum, but this will momentum gather now. Nestle's chairman and managing director Suresh Narayanan said here Monday.

"Hopefully we would like to see a product with no added sugar... the journey to make our products more efficacious continues, and the direction of the company is very clear. The company has reduced sugar by 30% in the last five years... the journey continues and what proportion gets dropped over a period of time, the efficiency of science and R&D will tell. But in the end position, we would like to look at a product at some time hopefully with no added sugar".

Narayanan, who took charge of Nestle's Indian operations at the height of the Maggi controversy, claimed that Cerelac complies with local food norms, with the added sugar content in the baby food much lower than what India's food regulator permits, and in compliance with Codex, the international food standards body. The FSSAI prescribes a maximum permissible level of added sugar to 13.6 gm per 100 gm of serving for baby cereal.

"By targeting Muslims on one hand and the sympathising with Pasmanda on the other, the BJP is play-4,31,000/- and | ing on the tension between the religious and social identity among the Muslims highlighted by the Pasmanda movement," he emphasized and argued that the religious identity of Muslims and the politics of Muslims/minorities have only prioritised the interests of the upper-caste Ashraf Muslims. He stressed that their social identity as Pasmanda Muslims and demanded their recognition as such. "Although the social and political discourse of the Pasmanda movement is absent from the discourse, this is the first election in which the Pasmanda Muslims see Farooq Naseer.

"The BJP has been trying to reach out to Pasmanda Muslims for their support. Though it doesn't have a separate slogan Pasmanda Muslims the party claims they too fall under the slogan of Sabka Saath, Sabka Vikas. Although the BJP has not announced any policy for Pasmanda Muslims, they have exposed the opposition parties' neglect of a large section of one of their core voters, Muslims. For the uninitiated, Indian Muslims are stratified into three categories: ashraf, Ajlaf and Arzal. While the Ashraf category includes caste groups that claim foreign descent, such as Syed, Sheikh, Mughal and Pathan, the Ajlaf category includes occupational castes, like the Ansaris (weavers), Mansuris (cotton traders) or the Quraishi (butchers). Arzal consists of the former untouchables castes, also referred to as Dalit Muslims, who, along with Dalit Christians, are demanding to be included in the reservation for SCs," he ex-

"Pasmanda is the collective of the Ajlaf and Arzals. It broadly corresponds to the category of Bahujan, including Other Backward Classes and Scheduled Castes



Pasmanda is a Persian word that refers to the 'ones left behind' and is used to describe depressed classes among Muslims, estimated to make up 80-85% of India's Muslims. Pasmanda Muslims have been historically marginalised. They have been treated as Razil and kamin (of low origin) and expected to only engage in traditional jobs, which were considered of low status by the elite (ashraf) Muslims. Islamic scholars have

legitimised these nomenclatures, from Ziauddin Barani to Ashraf Ali Thanwi and Ahmed Raza Khan Barelwi. Due to limited opportunities outside their traditional occupations, Pasmanda Muslims have been historically marginalised economically and were dependent on upper-caste zamindars for their survival," he informed. "The Pasmanda move-

ment, which started in the 1990s in Bihar, sparked new discussions on politicisation of caste. The Pasmanda movement denounced the domination of Ashraf Muslims over Muslim representation and organisations. It suggested that Muslim politics does not promote the interests of most Muslims but only of a small proportion of dominant elites (Ashrafs). It focused on the internal division within Muslim society and challenged the notion of a monolithic Muslim identity and politics. Headquarters, **OUTLAWS PREFER DESI 'KATTAS' FOR EXECUTING CRIMES**

85% crimes like murder, snatching or robbery are committed with country-made weapons

PRAYAGRAJ: Law breakers have devised stylish models of countrymade pistols, which are better in designs and similar fire power as compared to the factory made ones. The latest entrant to the illegal arms market is the Bihari katta (country made pistols of 0.315 bore and 0.12 bore being manufactured in Bihar and smuggled to eastern parts of UP) are in great demand

among law breakers. In fact, these startling revelations came to fore when men-in-khaki had ensured the arrest of a key

arms supplier in Kydganj area and seized a huge cache of cartridges and few pistols from his hideouts. The arrested key operator claimed to have smuggled Bihar-made pistol and cartridges in the region including Allahabad neighbouring districts on

a profit sharing basis and had accumulated wealth. Surprisingly, when police seized a huge cache of

cartridges and few country made pistols, they could not believe it that these pistols are so finewhich in fact have a better to go by, for an escalating look as compared to the factory made ones.

A senior cop said, "You cannot differentiate between an original (factory made) and these seized country-made pistols at the first go, as manufacturers are expert in designing these countrymade pistols similar to factory made ones.'

Incidentally, specially designed pistols having good capacity are in demand and law breakers are ready to shell out some extra bucks. If the recent shaped and well designed, crime trends are anything

number of murders, chain/ purse snatching, and even robberies being executed in the region in last three years, country-made pistols, popularly known as 'kattas' has always been a favourite with the law breakers.

The range police claimed to have recovered over 800 country-made pistols in the region com-Allahabad, prising Kaushambi, Fatehpur and Pratapgarh, which shows that an illegally thriving arms bazaar has surfaced, exposing the claims of the law enforcement agencies that fresh strategy was needed to bust the mod-

Gone are the days when a simple desi 'katta' of Madhya Pradesh or Kolkata-made sophisticated desi pistol was in demand. Today, Bihari kattas are available for a price, sometimes on rent as well. Most outlaws more or less are preferring a stylish or designed katta, as it is easy to operate as well as easy to dispose off. Police records state that about 76 per cent crime are being executed by the countrymade weapons or its refined version.

An Additional Superintendent of Police requesting anonymity said, "Probes into recent unearthing of arms manufacturing units busted by the police candidly pointed out that 'country-made stylish and fine shaped kattas' manufacturing was a wide-scale and flourishing business and those involved in the trade earned hefty profits for the same."

Spate of illegal arms factories either sprouting in remote corners of Bundelkhand or its

neighbouring states have been compounding the woes of the police. In eastern and central UP districts, producing a 'katta' is termed a trade and this has also taken a shape of an organised industry. Manufacturers are experts in producing good shaped butts, barrels and triggers and they even smuggle these to other states.

"Hardcore criminals eventually want to procure a factory-made sophisticated weapon," said a DSP-rank official adding that as these smuggled weapons were expensive of customers, more and more outlaws still preferred desi 'kattas' in executing crimes.

Senior cops admit that illegal weapons outnumber the legal ones by more than 15 times in the region and more than 85% crimes like murder, snatching or robbery are committed with the help of desi or country-made weapons. However, SSP has issued specific guidelines to his subordinates to tighten the noose around manufacturers and suppliers and also to ensure their arrest at the earliest.

Russia has economically become more dependent than ever on China

Russia, meanwhile, has economically become more dependent than ever on China. It views China as indispensable in shaping a new global order. The recent visit by Russian Foreign Minister Sergei Lavrov to China underscored the strategic nature of the relationship. Chinese Foreign Minister Wang Yi was blunt in stating that their ties were "irreplaceable in maintaining global strategic stability and promoting cooperation among emerging powers". Both men condemned the US for creating "closed military-political alliances [like NATO] with a limited set of members", and expressed willingness to create alternative institutions where China and Russia can shape norms in a way that suits their interests. Iran, too, has played a quid pro quo role in supporting Russia in its war against Ukraine, both diplomatically and militarily. In fact, as per a recent US Congress report, Iran not only maintains a steady supply of drones, air-to-ground munitions, and artillery ammunition to Russia, but it is also building a drone production factory inside Russian territory. Moreover, Russia, China and Iran are increasingly deepening cooperation in the Indo-Pacific. In March, they held the fourth edition of their annual trilateral naval exercises in the northern Indian Ocean. The cascade of conflicts obviously has a negative impact on India's external environment. A more volatile world makes pursuing development security all the more challenging. Within this context, the emergence of a strong partnership between China, Russia and Iran, founded on an anti-Western sentiment, has serious implications for India. For starters, efforts by the three countries to shape norms across the Global South and the Indo-Pacific, or at institutions such as the BRICS and the Shanghai Cooperation Organization, could chip away at India's strategic space. This is particularly the case given India's democratic values, deepening ties with the US and Europe. and its strategic competition with China. Moreover, their closer military cooperation in the Indo-Pacific portends the emergence of a Cold War-style camp confrontation. This is detrimental to India's approach of multi-alignment and maintaining strategic autonomy. The world today appears to be on the verge of a cascade of conflicts. Over two years since it started, the Russia-Ukraine war does not seem to be heading towards an imminent settlement. Likewise, despite calls for a ceasefire, the Israel-Hamas conflict appears unlikely to abate anytime soon. And now, events over the past month involving Israel and Iran have demonstrated the potential for a wider regional conflict. While the wars in Eurasia and the Middle East may seem disjointed and seeped in their own historical and political contexts, they are also interconnected in a broader sense of the emerging great power competition for the future of the world order. What we are witnessing today is an era of great power competition in an increasingly multipolar world. The US and China are the chief protagonists in this new order, although each is constrained by its domestic politics and capacities. This creates a certain power vacuum, but also space for autonomy of action, balancing and bandwagoning, and even adventurism by middle powers. In this environment, while there are no distinct blocs that have emerged, there are certain alignments that are becoming more prominent. For instance, NATO seems to have found a fresh purpose following Russia's assault on Ukraine, but there are deep concerns related to American policy continuity. Likewise, there is the emergence of a Russia-Iran-China axis based on common interests and grievances with the West. But there are limits to the nature of support that each lends to the other. After years of mutual antagonism. , Israel and Iran now appear to be on the brink of a new conflict.



What ED said in SC while opposing Kejriwal's plea against arrest

Courts cannot direct states to implement particular schemes: SC

NEW DELHI: The scope of judicial review in examining policy matters of the government is very limited and the courts cannot direct the States to implement a particular policy or scheme on the grounds that a "better, fairer or wiser" option is available, the Supreme Court has said. The observation came while disposing of a PIL seeking formulation of a scheme on setting up of community kitchens to combat hunger and malnutrition.

The top court refused to pass any direction in the matter observing that the National Food Security Act (NFSA) and other welfare schemes are being implemented by the Centre and states.A bench of Justices Bela M Trivedi and Pankaj Mithal said legality of the policy, and not the wisdom or soundness.

Delhi industries department approves 21-acre e-waste facility

Delhi: Senior officials said the industries department has finalized the plan for a 21-acre facility in northwest Delhi's Holambi Kalan to house a recycling center and training facility for e-waste handling and processing. The Delhi State Industrial and Infrastructure Development Corporation (DSIIDC) has invited private applicants to set up the complex, which will have an integrated ecosystem for e-waste management supply chain, on a public-private partnership (PPP) basis by April 15.

According to the project report, the integrated complex will be placed at the Urban Extension-2 road and have six primary sections: disinfection, dismantling, refurbishing manufacturing and recycling, testing, and training. "We will give the private operator 21 acres to create buildings, utilities, roads, and machinery.

The operator can sell recycled items, recovered components, and training courses, among other revenue sources " Computers, mobile phones, electronics, household appliances, and medical equipment are common e-waste items. Delhi is a major e-waste hub, producing 2.3 lakh tonnes, or 9.5% of the national total.

City relies on its few registered e-waste collection centers in Mandoli, Okhla, Peeragarhi, Patparganj, and Badarpur to disassemble and recycle collected material. A lot of e-waste winds up in landfills or with waste pickers, where it is dismantled and reprocessed in violation of environmental safety standards.

Currency circulation increases despite 2k note ban

Delhi: Despite the elimination of Rs 2,000 banknotes, the currency in circulation increased by Rs 1.3 lakh crore in FY24 from Rs 33.5 lakh crore at the end of March 2023 to Rs 34.8 lakh crore. Growth has slowed the most since 2018. In FY24, currency in circulation as a proportion of GDP fell since 4% i is slower than GDP growth. CIC grew 7% last year and over 10% the year before due to a pandemic cash rush. Currency in circulation grew 0.5% to Rs 35.3 lakh crore in the week ended April 5. RBI data shows that the increased issue of Rs 500 notes has more than offset the withdrawal of Rs 2,000 notes. ON May 19, 2023, RBI announced their withdrawal. In March 2024, Rs 2,000 notes were worth Rs 8,202 crore, down from Rs 3.6 lakh crore a year earlier. The value of Rs 500 notes rose to Rs 30.1 lakh crore from 25.8 lakh crore a year before.
