PM Modi launches Rs 1.2 lakh crore grain storage plan

NEW DELHI: PM Modi on Saturday inaugurated and laid foundation stone of multiple initiatives, including a pilot project for world's largest grain storage plan for cooperative sector, and said modernisation of agriculture systems is must for making India a developed country.

Currently, there exists a huge gap between grain production and storage capacity in the country. Data shows that storage capacity with regards to foodgrain production is only 47% in India, whereas it is 161% in the US, 149% in Brazil, 130% in Canada and 107% in China. Other key projects, whose foundation stones the PM laid, include additional 500 primary agricultural credit societies (PACS) for construction of godowns and other agri-infrastructure. He also inaugurated a project for computerisation in 18,000 PACS under overall digitalisation plan with a financial

'Can't extend NSA detention, need new order': Allahabad high court

PRAYAGRAJ:

Allahabad HC has ruled that state cannot review or extend detention under National Security Act (NSA), 1980, beyond the period prescribed in its confirmatory order.

A fresh order is needed for further detention, HC made it clear, ordering release of a person detained under NSA, with the period of detention extended multiple times.

Allowing the petition



filed by Mohammad Asim of Kanpur, the division bench said: "Confirmatory order was passed on May 9, 2023, whereby the petitioner was directed to be detained for three months from

detention order of April 20, 2023. Therefore, after expiry of three months, petitioner's detention becomes illegal & he is liable to

be released."

The petitioner argued that orders extending his detention beyond three months were illegal, since the state lacked authority to review or extend detention beyond what was specified in the initial confirmatory order.

While TDP will contest in 151 assembly and 22 Lok Sabha constituencies, Jana Sena will put up candidates in three Lok Sabha and 24 assembly seats. The seat adjustment was finalised after a meeting between

president Chandrababu Naidu and Jana Sena chief Pawan Kalyan.It's not clear yet if BJP would join TDP-Jana Sena alliance or contest on its own in Andhra Pradesh. If BJP joins the alliance, TDP and Jana Sena may have to forgo a few constituencies in favour of BJP candidates. Later, the two parties

announced the first list of candidates for some of the constituencies. Though Jana Sena got three Lok Sabha seats under the pact, it is yet to be decided which three seats would be allotted to Pawan's party. Naidu and Pawan addressed a press conference and said the alliance was arrived at in the "broader interests.

NEW DELHI: Indian Navy has come to the aid of yet another merchant vessel that had caught fire after being hit by a drone or a missile in the Gulf of Aden, in seventh such instance past couple of months. Destroyer INS Kolkata, which was missiondeployed in the Gulf of Aden, responded swiftly to the distress call by Palauflagged merchant vessel Islander after it was hit by a drone or missile.

Air Mauritius flight MK 749 delayed for over 5 hours, passenger facing problem

MUMBAI: Passengers on Air Mauritius flight MK 749 from Mumbai to Mauritius are experiencing a concerning situation.

As per a passenger, the flight, originally scheduled to depart at 4:30 am, has been grounded for over 5 hours due to an engine problem. Passengers being boarded around

the aircraft, enduring extreme discomfort with air conditioning not functioning.

Meanwhile, a 78-year-old passenger, identified as Banudutt Boolauky, is reportedly struggling due to breathing difficulties. Attempts to contact airport authorities and Air Mauritius have reportedly been unsuccessful."Flight MK 749 Air Mauritius from Mumbai to Mauritius was to depart at 4:30 am. Passengers boarded at 3.45 am onwards. The plane has developed an engine problem but the passengers remain locked inside the plane for the last 5 hours and are not being allowed to disembark. A 78-year-old passenger on the plane, Banudutt Boolauky, has developed breathing problems as Acs are not working and he is lying at the back of the plane. Have contacted the airport helpline and Air Mauritius but nothing has been done so far," a passenger said.

According to a passenger, the flight has been cancelled and other necessary arrangements are being made.

Assam takes big step towards introducing Uniform Civil Code

NEW DELHI: In a late night development. the Assam cabinet on Friday took the first big step towards introducing the Uniform Civil Code in the state by scrapping the Assam Muslim Marriage & Divorce Registration Act 1935.

The move comes less than three weeks after Uttarakhand became the first state to pass the Uniform Civil Code. Cabinet minister Mallabarua Jayanta termed it as a step towards achieving UCC.

He stated that now all matters pertaining to Muslim marriages and divorces would be taken care of under the Special Marriages

The decision was taken today in a cabinet meeting which was chaired by chief minister Himanta Biswa

PATIALA: After the death of a youth in the ongoing farmers' protest, farmer leader Sarwan Singh Pandher has said that they will not cremate the person until he gets jus-

Lok Sabha polls: Doors still open for alliance, Congress says after Mamata's seat-sharing snub

NEW DELHI: Senior Congress leader Jairam Ramesh on Saturday cleared the air on seatsharing possibilities with Mamata Baneriee's Trinamool Congress (TMC) in West Bengal, saving 'discussions are under way'. Reaffirming the opposition's objective to strengthen the INDIA bloc against BJP-led NDA ahead of the Lok Sabha polls, the Congress general secretary in-charge communications said, "Mamata Banerjee and TMC have said that they want to strengthen INDIA Alliance and the biggest motive is to defeat the BJP". The chances of an alliance between Congress and the TMC in West Bengal have been hanging in limbo ever since chief minister Mamata Banerjee asserted that her party would fight it alone in its home state. CM Mamata Banerjee announces TMC will contest Lok Sabha polls alone in West Bengal Mamata made the announcement after Congress refused to accept TMC's offer of two Lok Sabha seats in the state. She, however, kept doors for post-poll adjustments open on the "all-India level" and insisted the Trinamool would do "whatever is needed to defeat the BJP". Speaking on the Mamata's earlier discontent with the Congress party over seat-sharing, Jairam



Ramesh said, "heated discussions keep taking place between the two parties but we respect Mamata Banerjee".

"There are occasional flare-ups

and heated exchanges during such discussions. But we respect Mamata Banerjee as one of our leading Opposition leaders," Jairam Ramesh said. Other than TMC in West Bengal, Congress and Arvind Kejriwal's Aam Aadmi Party in Delhi are close to finalising a deal. "Today, Aam Aadmi Party (AAP) and Congress will officially announce a seat-sharing deal for Dellhi (for the Lok Sabha

polls). A lot was being said

about the Congress dragging its feet and not interested in an electoral tie-up (with the AAP). However, as I have always maintained, these things take time," the Jairam Ramesh said on Saturday, According to reports, AAP will contest four Lok Sabha seats in the national capital, while the Congress will get the remaining three. AAP national convenor and Delhi Chief Minister Arvind Kejriwal said on Wednesday that the talks over the alliance were delayed and hinted at fresh developments in the next one or two days. In the 2004 elections, the Congress won 6 seats and the BJP 1 while

How Nvidia became 'envy' of the world


The year was 1993, when Jensen Huang was sitting at California Diner. He had two other people with him, and together, they were starting a new company. They wanted to make a graphics chip—one that would make competitors green with envy. They chose the name NVision, but the name was already taken. So, Huang suggested Nvidia. It is from the Latin word invidia, which means envy. About 30 years later, Nvidia is truly the envy of the world. The company reported its earnings in the fourth quarter, and that was over \$22 billion-22 percent higher than the last quarter. When you compare it to last year, revenue is up by 265 percent. Nvidia is already a Wall Street darling. Its stocks have tripled in value since last year. This time, Wall Street had lofty expectations. Nvidia managed to beat that too, and it sent the markets rallying. Nvidia's shares jumped 12 percent in pre-market trade. It caused other tech stocks to soar. Asian markets joined the sentiment. Japan's Nikkei hit a record high. It was the first time since 1989. Traders in Tokyo even broke out in applause. Europe's Stoxx 600 hit a twoyear high. It rose to almost 496 points in early trade. So, the mood in the markets, driven by artificial intelligence, is bullish. Investors believe AI is the future, and leading that wave is Nvidia. Here is what founder Jensen Huang said: "Accelerated computing and generative AI have hit the tipping point; demand is surging worldwide across companies, industries, and nations." So Huang says AI is at a tipping point. AI systems need millions of powerful chips to run, which means Nvidia will only keep growing. This company is the world's most valuable chipmaker. It dominates the market for chips especially used in AI systems. For example, ChatGpt was trained on thousands of Nvidia chips from companies like Microsoft, OpenAI, Amazon, Meta, and Google. All of them have deals with Nvidia. They are buying chips in bulk. This is because it's the only player offering what they want. Nvidia has had a headstart in this race; it took a bet years ago, which has paid off. Nvidia became a \$1 trillion company. It is America's third-most valuable company after Apple and Microsoft. Right now, Nvidia is the most-traded stock on Wall Street. It is planning to ship a new chip called B100. It is said to be exponentially more powerful, and it has further raised expectations. But it is not like they have no challenges; top on their list are restrictions. The US has restricted the export of high-end Al chips to China. Nvidia is still selling to China, but the numbers have dropped significantly. Then, there is supply, and the company is scaling at a record pace. Yet, it is struggling to keep up with the demand, and the third challenge is competition. Nvidia has a target on its back. Everyone wants to make chips now. As of today, their biggest rival is a company called Advanced Micro Devices (AMD). It has released a new AI chip. Meanwhile, OpenAI is toying with the idea. It wants to start its own AI chip venture, and it wants \$7 trillion for that. Intel is investing in space. It has struck a deal with Microsoft that could be worth billions of dollars. Amazon also has a custom-built chip for training AI models. So, the race is very much on. At this point, the others are trying to catch up, but this is a high-stakes game, and Nvidia will have to work very hard to remain on top of the curve.

How Kibithoo, India's first village, shows a shift in geostrategic perception

icant shift in policy formulation under the leadership of Prime Minister Narendra Modi and customised for India's North East, has shifted the border perception from a restrictive space to a participatory one. The participatory space combines developmental, geopolitical, and geostrategic resetting. This redefining process conceptualises border space as not the nondescript last mile of the country's geography but, most importantly, its effective beginning. Hence, Kibithoo terming Arunachal Pradesh 'not as India's last village' but as 'India's first village' demonstrates the altered perception of the border as a space of activity, unity, and interconnection. The convention of binary formation—centre and margin—has become irrelevant in the new Bharat we see today. The response to China's acts of territorial intervention at Doklam, Galwan Valley, and Tawang and its designs of shifting cartography has been equally swift and definitive. The scale of retaliation has been specific enough not to indulge in provocative acts along the border. This retaliation has been possible because of the robust infrastructural developments that have gone into making the

border space stronger,

Act East Policy (AEP), a signif-



resilient, and effective. This indicates that every inch of Bharat's land is essential, and the negative metaphor of 'not a blade of grass grows' holds no merit any more. Kibithoo, 'India's first village' is located in the Anjaw district of Arunachal Pradesh at a height of 1,305 metres above sea level. The Lohit River finds its winding course through the district. It is the first circle headquarters, situated at the border of India and the Tibetan Autonomous Region (TAR). The unceasing trade and cultural communication the people of Anjaw district had with their Tibetan counterparts was disturbed in the event of Chinese aggression in Tibet and its subsequent annexation in the 1950s. The disturbed geopolitics of the region under Chinese brinkmanship made every

scope of possible reconnection remote. The event of annexation followed by the India-China War in 1962 complicated the geopolitics in the region to an irreparable extent. The Chinese territorial desire and the streak of expansionism have not seen any possible reduction since then. It takes every potential scope for conflict intensification and expects to get some dividend out of it. This has been the standard practice that Beijing has followed with great meticulousness. This cunning of China has finally reached a fitting reply in the form of solid responses from India whenever such territorial and diplomatic excesses have been made since 2014. The rising Bharat is competitive enough to derail China's scope of global significance in manufacturing, supply chain, science

and technology, and diplomacy. Under AEP, the areas that have received the most attention are infrastructure and capacity building.

This capacity building has not been confined to any specific location. This has been quite comprehensive, and the northeast has taken massive infrastructure attention because it has not gotten the required depth for a time. Arunachal Pradesh, in particular, has become the centre of geopolitical gravity as China continues its conventional practice of salami slicing. Apart from building airports and roads to enhance the communication and transport infrastructures, the 1,700 km long frontier highway along the McMahon Line connecting the bordering districts of Tawang, East Kameng, Upper Subansiri, West Siang, Tuting, Mechuka, Upper Siang, Dibang Valley, Desali, Chaglagam, Kibithoo, Dong, Hawai, and Vijaynagar from Bhutan to Myanmar is a geostrategic milestone. The work in this direction has already begun, and it might take just a few years, considering the climatic conditions and geographic impediments. With the scale with which China has enhanced the infrastructural depth on the other side of the border, competitive infrastructural developments have become a geostrategic imperative. Apart from playing a significant role in augmenting India's strategic and defence readiness, it will also act as a catalyst for inducing development and economic wellbeing. India's competitiveness in response to China's infrastructural power along the McMahon Line has unsettled the latter and its expansionist proclivities. The required deterrence from the Indian side keeps China on uncertain ground. The territorial integrity of India is its priority. This has been made evident through the response given to China as and when it indulges in artificial claims and irrational acts of interference. This shift in attitude suggests the emergence of a new India where every inch of its land is indispensable because it constitutes territorial integrity. The reversal of the conceptual understanding of border space from peripherality to activity indicates the renewal of the territorial imagination. The binary between the border and the hinterland has collapsed.

There is only one territory, and quality assessment as a defining criterion for allocating importance is suspended. The subjective claims of quality should not be underlined to exercise determination of territoriality and grading processes.

Maldives: Joint sea-exercises with India

As if putting the differences of the past weeks behind, possibly for good, the Maldives joined India's biennial 'Milan' naval exercise in the eastern coastal city of Visakhapatnam, from 19-27 February. President Maumoon Abdul Gayoom, which the Indian forces helped, thwart through 'Operation Cactus' in 1988. The aim was to synergise bilateral strengths to meet future eventualities but it

Russia-Ukraine war enters third year: Bloody stalemate, no signs of breakthrough

In the book 'The Fathomless Caves', Kate Forsyth, the author, describes war as, "An unpredictable beast. Once unleashed, it runs like a rabid dog, ravening friends and foes alike. It can drag on for years, a slow attrition of nerve and fortitude, or be over in one brilliant flash, an extravagant configuration of flame and blood and sweat." The Russian-Ukraine War fits well into the above descrip-

tion. When President Putin launched 'special military operations' to 'demilitarise denazify' Ukraine on February 24, 2022, it was universally given that the war would be over in a few days, with Russia inflicting a crushing defeat on Ukraine. Ironically, two years later, the conflict rages on, degenerating into a state of stalemate with little change in the ground situation. Although a classic limited war, its politico-economic impact has been felt far and wide, with serious geo-strategic ramifications. Militarily, it has gone on to redefine the very nature of warfare.

The Russian offensive commenced as a typi-



cal military campaign, preceded by missiles and airstrikes, followed by a large-scale ground invasion along multiple fronts. The northern thrust was launched from Belarus towards Kyiv, the southern one was from Crimea, and the south-eastern push was from Luhansk-Donetsk towards Kharkiv. In the wake of heavy losses and stiff Ukrainian resistance on the outskirts of Kyiv, the Russian Northern thrust stalled within a month, towards the end of March. By April, the Russian Army had retreated to consolidate gains around the Luhansk and Donetsk areas. However, the Russians did succeed in capturing Mariupol in May after a prolonged siege. Having stabilised the

situation, in August, the Ukrainian forces launched a limited counterattack in the south and a month later in the north-east, succeeding in recaptur-Kharkiv Kherson by November, forcing

Russians to withdraw east of the Dnieper River. With winters setting in, the pace of operations had slowed down. The Ukrainians resorted to launching a number of drone strikes against the Russian bases. A period of lull was used by the belligerents to consolidate their positions and gear up for the next phase. By the end of 2022, around 8 million refugees had fled Ukraine. Both sides had suffered heavy casualties; more than half a million Russian and Ukrainian soldiers were killed or wounded, besides over 10,000 Towards early 2023, Ukraine launched a major counter-offensive on a wide front. However, it soon went

RBI lays out road map for Paytm's UPI transition



MUMBAI: RBI has outlined a plan for the seamless transfer of the UPI virtual payaddress (@paytm) and the merchant QR codes from Paytm Payments Bank (PPBL) to its parent One97. This move ensures customers can continue to scan and pay using their Paytm app and merchants can display the Paytm QR code for accepting payments even after March 15, as long as the underlying bank account is not PPBL.

RBI said that additional measures are necessary to ensure smooth digital payments for UPI customers using

the '@paytm' handle operated by Paytm Payments Bank. The RBI had previously imposed certain business restrictions on Paytm Payments Bank, which resulted in a ban on all deposits into any bank account, whether savings, current, wallet or Fastag after March 15. To continue providing UPI services through its app, One97 (which owns and operates under the Paytm brand) must obtain a third-party application provider licence from NPCI. RBI said that to facilitate the smooth migration of '@paytm' handles, the NPCI must certify 4-5 banks

as Payment Service Provider banks capable of processing highvolume UPI transactions. These banks will step into the shoes of PPBL for processing transactions. During the transition period, Paytm will not be able to onboard new customers for UPI.

In the case of PhonePe and GPay, big banks -HDFC, ICICI, SBI, Axis and Yes Bank are the processing banks. Although there is not much revenue for the transaction processing banks, by participating in the transaction chain they can get visibility on customer transactions which

The initiative will enable yield of approximately 90 GWh of renewable energy annually with a CO2 reduction of 642 lacs kg [64,200 metric tonnes], according to CleanMax. Genuine' penny stock investors get court relief

The income tax department views the sale proceeds of such shares as "unexplained cash credit" or "unexplained money", subjecting it to a flat tax rate of 60%. When combined with a surcharge of 25%, penalty, and cess, the aggregate tax rate can soar past 80%. If such individuals can prove they are genuine investors, they do succeed at the appellate level - be it at the Income-tax Appellate Tribunal (ITAT) or in further appeal to high courts. It is best to be armed with proper documentation, aver tax experts. I-T sleuths across the country are vigilant against penny stock scams (see table), which facilitate money laundering and allow investors to claim tax benefits such as longterm capital gains (LTCGs) or short-term capital losses or business losses. These losses which can be offset against income help reduce the overall tax liability. In cases where a penny-stock scam is uncovered, the I-T officer, by relying on the investigation report, holds the LTCGs arising on sale of such shares to be unaccounted income subjecting it to high tax rates - genuine investors who have traded in such shares get hit. While gains from listed shares held for over a year are considered long-term, these gains are no longer taxfree. Since April 1, 2018, LTCGs exceeding Rs 1 lakh is taxed at 10%, but it is still a sharp contrast to the 80% rate, which causes nightmares to genuine investors who are inadvertently caught in the net. Tax experts emphasize that the I-T department can successfully challenge LTCGs claimed by the investor only if they have evidence linking the taxpayer to the penny-stock

India to contribute to 20% of global growth in next five years: KKR

Mumbai: A report by KKR's chief investment officer said that India is likely to contribute a fifth of the global incremental growth for the next five to seven years. Bengal DGP admits to lapses, inaction in restive Sandeshkhali



SANDESHKHALI: Fresh violence rocked Sandeshkhali on Friday villagers Bermajur II panchayat area attacked yet another bheri (fish farm) owned by Siraj, brother of absconding strongman Sheikh Shahjahan, and thrashed a local party functionary, reported. spot and detained 11 people, but women mobbed the vehicles to stop them from being ferried to Sandeshkhali police station. Some of the women lay on the road while other villagers used logs to block the road and burnt tyres, demanding immediate release of the accused. DGP Kumar said action would be taken against those who indulged in vandalism but assured the villagers that their landgrab complaints would be investigated.



State finance panel report affirms 'economic injustice' to Karnataka

BENGALURU: In what appears to be an affirmation of the govt's stand on devolution of taxes by the Centre, the fifth State Finance Commission, in a report presented in the legislative assembly on Friday, said Karnataka received Rs 25,435 crore less than what was recommended by the 14th Finance Commission.

In its report for 2024-25, the commission said Karnataka suffered a significant reduction in its share of central taxes and duties, plummeting from 4.7% to 3.6% due to a decision of the 15th Finance Commission. It says Karnataka faces further dep- rivation of approximately Rs 16,000 crore until the conclusion of 2025-26. The commission emphasised the importance of equitable distribution of finances to states in the spirit of cooperative



federalism, stating that it should be "just, fair, and appropriate".

It criticised the 14th

and 15th Finance

Commissions for basing devolution solely on population (90%) and geographical (10%), while neglecting other crucial indicators considered by previous commissions. It said this approach favoured states with larger populations and geographical areas, disadvantaging those who have managed population growth and achieved higher human development indices.

The panel, established in Nov 2023, also recommended the Bruhat

"Of the five species found in Bengal, three - great, rufous-necked and wreathed hornbills - are globally threatened and listed as 'Vulnerable' on IUCN Red List. The conservaaction plan attempts to chart out strategies to ensure that hornbill species in the region are protected," said Arjan Basu Roy, principal investigator of the Hornbill Project of Nature Mates-Nature Club, in association with Nature Conservation
