The minister's plea comes amidst a significant decline in Indian tourist arrivals following derogatory remarks made by three Maldivian officials against India and Prime Minister Narendra Modi on social media. The backlash led to numerous cancellations and a drop in India's position from the top visitor country to the sixth position after January. According to a report by sun.mv, tourist arrivals from India declined by 42 per cent in the first four months of this year compared to the same period last year.

The strained relations between India and the Maldives have been attributed to the new administration led by President Mohamed Muizzu, who is widely seen as a pro-China leader.

Since assuming office in November last year, Muizzu has maintained his election promise of evicting Indian military personnel from the Maldives, forcing the withdrawal of 88 Indian military personnel manning three aviation platforms gifted by India. Muizzu has previously accused India of meddling in the affairs of the Maldives and won the presidential elections in September last year with an "India Out" campaign.Despite the current challenges, the Maldives remains a key maritime neighbour for India in the Indian Ocean Region and holds a special place in India's initiatives like 'SAGAR' and the 'Neighbourhood First Policy'.

Can a candidate contest from two seats in Lok Sabha Elections?

NEW DELHI: In India, the concept of a candidate contesting from two seats or constituencies in the Lok Sabha Election is not uncommon, although with certain legal provisions and historical precedents. Recently, the question around dual candidature arose when Congress leader Rahul Gandhi filed his nomina-Uttar from tion Pradesh's Rai Bareli after contesting from Kerala's Wayanad in the second phase. Apart from Rahul Gandhi, in the Odisha assembly election, being held there simultaneously, chief minister Naveen Patnaik has filed nominations from two seats --Kantabanji and Hinjili assembly seats.According to the Representation of the People Act, of 1951, an individual is legally permitted to contest elec-

tions from two Lok Sabha constituencies simultaneously. However, if the candidate wins from both constituencies, they

must vacate one seat within fourteen days, triggering a by-election in the constituency they choose to relinquish.

This provision is in place to prevent an individual from holding multiple seats in the Lok Sabha, ensuring representation is not concentrated in the hands of one individual and promoting fairness in the electoral process. Historically, have been instances where prominent politicians have contested from two constituencies in the Lok Sabha Elections.One notable example is former Prime Minister Atal Bihari Vajpayee, who contested from Lucknow and Gandhinagar.



India must kill terrorists. Nijjar blowback shows it also needs laws to guide assassins

Two bullets had been fired into his gut, and one between his eyes: The assassins authored the end of the book Henry Liu had been writing. From his modest home in the suburbs of San Francisco, the investigative journalist had relentlessly attacked the Kuomintang dictatorship in Taiwan. The hit men-members of the crime cartel United Bamboo Gang, recruited by Taiwan's military intelligence chief Vice-Admiral Wang Hsi-ling—declined payment for the job, seeing themselves as patriots silencing a dangerous Communist agent. Later, his wife Helen Liu, offered a simple explanation for why her husband was murdered: "In Taiwan, people cannot speak freely. And he had a big mouth." Earlier this week, police in Canada arrested three Indian nationals for the murder of Sikh separatist Hardeep Singh Nijjar, fuelling suspicions that India's Research and Analysis Wing (R&AW) has been targeting Khalistan operatives in the West. The men, alleged to be linked to the crime network of jailed gangster Lawrence Bishnoi, are being investigated for their ties to Indian intelligence officers that Canada has claimed were involved in Nijjar's assassination. The government of India has angrily denied the allegations-but in recent weeks, senior political leaders have seemed to defend the country's right to use covert means against its enemies overseas. "Terrorists will be killed in their homes," Prime Minister Narendra Modi said in one recent rally, amid reports that R&AW was eliminating terrorists in Pakistan. For many Indians—enraged by seeing the perpetrators of terrorist attacks from 1993 bombings to 2008 Mumbai attacks sheltering in safe havens in Pakistan, or Khalistan supporters openly calling for violence from the West-the use of covert means seems a legitimate exercise of power. This is not new. Following the bombing of the Indian embassy in Kabul in 2008, then National Security Advisor MK Narayanan demanded the country pay Pakistan back "in the same coin." Lawyers and political philosophers familiar with the complex history of assassinations by nationstates, though, would likely urge reflection on exactly when such force might be used-and what its consequences could be. "Although I may kill a man," the Renaissance jurist Alberico Gentili counselled the kings and princes of his violent times, "I may not do so by treachery." They listened, for good reasons. There is, no doubt, something profoundly spurious about the moral outrage that has surrounded India's alleged assassination campaign: The UK attempted to kill Libyan leader Muammar Gaddafi, and murdered Irish terrorists at home and abroad and Israel has long staged targeted killings. The US, lawyer scholars Luis Chiesa and Alexander KA Greenawalt have persuasively argued, ignored international law to kill cofounder of Al-Qaeda Osama Bin Laden and Colombian drug cartel boss Pablo Escobar. For its part, Russia frequently-and crudely-kills regime opponents overseas. Like India, nationstates everywhere have struggled to deal with criminals and terrorists their adversaries choose not to act against. However, the absence of an ethical norm doesn't mean that the many powerful arguments against covert action can be ignored. For most of history, international relations scholar Ward Thomas writes, assassination was used without scruple. Leaders of the ancient world regarded killing for public purposes as a moral project, and murder was seen as a legitimate foreign policy tool in the 17th century. The American scientist political Hans Morgenthau noted that "the Republic of Venice, from 1415 to 1525, planned or attempted about two hundred assassinations for purposes of its foreign policy".

Narendra Modi, Opposition and International Media

The largest democratic process in the world, the Indian Lok Sabha elections 2024, has attracted the attention of one and all across the globe. This general election is a watershed moment for Bharat which will initiate the country towards its new self of 'Viksit Bharat' by 2047. Besides, it also holds the possibility of establishing India's dynamic presence on the global stage. In academic discourses, it is often said that in the last ten years, under the dynamic leadership of Prime Minister Narendra Modi, India, today is in the final stage of decolonisation. Under the visionary captaincy of Modi, Bharat, which was called "sone ki chidiya" i.e. the golden bird, in ancient times, is re-emerging as an economic power, recovering from hundreds of years of 'slavery' post-colonisation. Besides, it has also forged a new identity on the global stage with its scientific, strategic and 'soft' power. However, the anti-India international forces are not able to digest Bharat's new rise and are trying to hinder its advancement. The international media coverage, particularly news reports, articles, and editorials concerning Modi and the 2024 Lok Sabha elections, serves as one of the most reliable indicators of this negative approach towards Bharat. In



keeping with the idea that Bharat was called the golden bird once upon a time, the British economist Angus Maddison in his book The World Economy: A Millennial Perspective has shown that India was the richest country and the largest economy in the world till the 10th century, its GDP was more than one-third of the world's economy, which remained very high till the 16th-17th century. But on account of the loot by external forces and inappropriate domestic policies post-independence, the GDP gradually slumped to 2.6 per cent in 2014. It is only with the efficient implementation framework created by the Narendra Modi government that India jumped from the 10th largest economy of the world in 2014 to the fifth largest economy today. By 2027, hopefully, we are going to be the third-largest economy. Along with this, India's influ-

ence has also increased on global platforms, strategically and scientifically. With the launch successful of Chandrayaan-3 to the Moon, the nation has registered its presence strongly in the field of science and technology. It has also emerged as a major exporter in space industry and defence equipment. Also, providing Covid vaccines to the entire world during the pandemic and showcasing its prowess in the G20 meeting and other international platforms has added to India's prestige manifold in world today. the Unfortunately, India's rise has not gone well with certain vested interests, inimical to Bharat, in Pakistan, China, the Arab world as well as Western countries. These forces feel envious of India's remarkable progress under the leadership of Modi, marching towards Viksit Bharat @2047. That is why it can be seen that these anti-

India forces are trying to a paradox can be seen in all influence the Lok Sabha elections in an effort to stop Modi's visionary drive towards progress that he has envisaged for the country. There seems to be a sinister conspiracy to influence the Indian voters by running a 'well-planned campaign' at the global level. Naseem Javed, a corporate political philosopher and currently the president of the Canadian think tank Expothon Worldwide, in his book titled Alpha Dreamers: The Five Billion Connected Alpha Dreamers Who Will Change the World in 2019 writes, the people in the world, today, are interconnected. Global public opinion is now an authentic voice. This global public opinion can be used by various forces to influence any country. It would be pertinent to note in this context the international media's attitude vis-a-vis current elections in India. Whether it's The New York Times of the US, England's The Guardian, Qatar's (Arabia's) Al Jazeera, Pakistan's The Dawn or China's The People's Daily Online, there is a common thread seen in all – the portrayal of Narendra Modi and the BJP as the villain, whereas no negative sentiment could be found against Rahul Gandhi and his Congress or other Opposition parties. However,

Precision herbicides use essential for cotton protection – Godrej Agrovet

Bhatinda/ Mansa/ Fazilka: Cotton, a cornerstone of India's agricultural landscape, plays a pivotal role in the nation's economy. Contributing significantly to agriculture and industrial development, it also aids in employment generation. However, it faces a significant threat from weeds, causing substantial yield losses ranging from 40% to 85% thereby impacting the quality and increasing production costs. "To effectively manage weeds in cotton, it is imperative use both pre and early post and emergence herbicides smartly, especially during the crucial period when the crop and weeds compete. Hence using right herbicide at the right time and in right quantity aid control the weeds effectively. and at the right time knowing when weeds can be problematic is the foundation for sustainable and resilient farming," said Rajavelu NK, CEO- Crop Protection Business, Godrej Agrovet Limited. Highlighting the techniques that can aid reduce weed competition he said that manual weeding and frequent inter-cultivation, like hand hoeing have shown effective results. Farmers practicing hand weeding twice during critical growth stages observe a significant increase in cotton yield. Mechanical methods such as power weeding offer cost-effective weed control and improved soil aeration. However, challenges arise from labor shortages and excess soil moisture, especially during frequent irrigation or heavy rains in the kharif season, hindering timely cultural practices. To overcome these, adopting herbicides during critical periods becomes essential for effective weed control, ensuring higher yields. "Identifying the critical period of weed competition is crucial for effective weed management in cotton. As a long-duration crop, cotton faces a critical weed competition period of up to 45 Days After Sowing (DAS), during which maintaining a weed-free condition is imperative for optimal results. This makes the need to protect cotton crop during early post-emergent phase viz. 5-15 DAS extremely crucial," added Rajavelu. Due to the varied weather patterns the weed emergence and type of weeds are changing.

With effective weed management becoming a critical issue due to this, it is advisable that farmers select the right herbicide. Be it solo or scientific in-can mixture herbicides, it is important for farmers to go as per the label

recommendation and avoid own tank mix combinations which may not be advisable given the uncertainties of weather and weed emergence that can happen at the farmer field.

Delhi high court orders parents to pay for school AC

Delhi: The Delhi High Court recently ruled that parents must pay for school air conditioning, just like laboratory costs. While dismissing a public interest litigation, the division bench of acting chief judge Manmohan and justice Manmeet Pritam Singh Arora made the comment. The petition asked the Delhi government's DoE to restrict a private school from charging for classroom air conditioning. Air conditioning is a school facility, thus parents must pay for it like lab and smart class fees. When choosing a school, parents must consider the facilities and expenses for their children. The bench ruled on May 2 that school management cannot bear the cost of such facilities. Manish Goel filed the PIL because his child's Delhi private school charged Rs 2,000 per month for AC.

The petitioner said the school management should give AC to kids with its own funds. The bench heard from the DoE that it was investigating and asking for an action-taken report after



UP leads 2024 JEE (Advanced) aspirants at 11%

Delhi: Uttar Pradesh will have 11% of JEE-Advanced 2024 candidates, the entryway to 23 IITs. According to JEE (Main) qualification data, over 54% of the 2.5 lakh IIT entry candidates are from six states and approximately 73% from 10. Although over 75% of enrolled applicants took both the January and April sessions of the JEE (Main), an entrance test for centrally financed technical institutes and others, just 28% improved their scores in the second sitting. Canada will limit international students' job dreams to 24 hours per week.

Delhi: The Minister of Immigration, Refugees, and Citizenship of Canada has announced that international students can only work 24 hours per week. Marc Miller announced on social media X. "We removed the 20-hour/week work requirement for international students to aid post-pandemic rehabilitation. I stated today that this provision would be lifted and that offcampus student employment hours will be limited to 24 hours/week starting this autumn "on his official X account. International students might work more than 20 hours per week off campus under the old rule. The rule expired April 30, 2024. Miller added that kids on academic break can work unlimited hours. According to Miller, this adjustment will let students focus on their studies instead of working lengthy hours. International students come to Canada to study first. Students can work while focusing on class with this improvement. He claimed the program will remain strong while protecting youngsters. According to the Canadian government, recent US and Canadian studies have shown that students working more than 28 hours per week perform worse academically and are more likely to drop out. Most nations that accept international students have limited their working hours while studying. Australia now allows students to work 48 hours within two weeks.

US students must also meet additional standards before working off campus.

Canada is reducing the number of start-up visas it will accept, this year

Delhi: Although Canada attempted to improve the attractiveness of its start-up visa program in July of last year, an announcement tonight will terminate the aspirations of prospective immigrant entrepreneurs. In reality, a number of them who received early investment or assistance from business incubators can wind up in a limbo. Beginning on April 30, Canada will only accept petitions for permanent residency linked to ten or fewer startups per approved organization for processing each year. The Immigration, Refugees Citizenship and Canada (IRCC) released a statement stating that this action was taken to expedite application processing and minimize backlogs. To put it simply, there are currently about 82 of these



approved organizations, which include company incubators, angel investors, and venture capital funds (VCFs). It follows that, if the number of these organizations stays the same, no more than 820 applications will be approved. Furthermore, as per the release, entrepreneurs whose start-up is backed by Canadian funding or a business incubator that is affiliated with Canada's Tech Network will be eligible for priority processing. In order to be eligible for permanent residence, entremust preneurs demonstrate that they

have sufficient means to support themselves and their family upon arrival in Canada. The Startup Visa (SUV) program does not require applicants to invest any of their funds or have a mini-

mum net worth. It's essential to have support from one or more of the approved partners, such as venture capital funds (VCF), angel investor groups (who must invest a minimum of CAD 200,00 and 75,000, respectively), or be accepted into a program offered by a business incubator. 

The deadline for those who haven't linked their PAN and Aadhaar has been extended

Delhi: To alleviate burdens for taxpayers whose PAN and Aadhaar have not been linked, the ncome tax department has extended the deadline for levying penalties. PANs for individuals who failed to link the two forms of identification by the June 30, 2023 deadwere rendered lline invalid, and any party that withheld more money while deducting tax at source (TDS) or processing transactions that needed tax at source collection had to do so. For example, the TDS on house rent allowance jumped to 20% for people whose PAN stopped

working. Many of the tax collectors and deductors continued to collect or deduct taxes at the lower level without realizing the PAN was inactive, which resulted in penalties from the tax department. Many of them filed a petition with the government, which eventu-

RBI bans Kotak Mahindra from online and mobile customer acquisition

Delhi: The Reserve Bank of India has barred Kotak Mahindra Bank from onboarding customers new through its online and mobile banking channels and issuing new credit cards due to its failure to build IT systems and controls that grew with its growth and caused serious regulatory violations. As per RBI's announcement, . RBI's press notice stated that the bank is "materially deficient in building necessary operational resilience on account of its failure to build IT systems and controls commensurate with its growth". Kotak Mahindra Bank's IT inventory managepatch ment, and change management, user access management, vendor risk management, data security and leak prevention strategy, business continuity and disaster recovery rigour and drill had serious defi-



ciencies and non-compliances. Interestingly, the press notice noted that the bank's IT Risk and Information Security Governance fell short of regulatory criteria for two years. Delhi: The main topic of discussion in India's planned legislation governing big digital companies is how tech compaquent assessments, nies use internet users' data to bombard them with adverts. Public comments on the Ministry of Corporate Affairs' proposed Digital Competition Bill are currently being accepted. It prohibits "inter-mixing or inadequate, cross-using" data from various services provided by companies in the digital economy without the authorization of the users involved.

IndiGo orders 30 long-haul planes for \$9.5 billion



Delhi: In 2027, IndiGo will fly nonstop between India and remote locations using its own widebody aircraft. The Rahul Bhatia-founded mega budget carrier "has agreed" to order 30 twin-aisle Airbus A350-900s worth over \$9.5 billion at list price and an option for 70 more. Indian travelers will have two domestic airlines, Air India and IndiGo, running medium to ultra long-haul routes on dual aisles (Vistara merges into AI this year), as well as many foreign carriers. IndiGo "agreed to order" 60 Trent XWB engines for 30 A350s. IndiGo evaluated the B787 Dreamliner, but Boeing's ongoing issues persuaded it to stick with Airbus, which has over 1,000 A320 family single aisles on order and is the world's largest A320 operator. Airbus controls India's single aisle market, but troubled Boeing is no longer the only wide body with Indian carriers. Since last year, Airbus has been receiving orders for big birds, starting with AI. IndiGo leased two B777s from Turkish Airlines to run a daily Delhi/Mumbai-Istanbul trip.

After that experience, it ordered wide bodies for delivery in 2027, IndiGo's 21st year. Airlines can acquire 70 more A350-900 "at its discretion, for possible future needs under certain conditions," they say. IndiGo had over 10 crore passengers in 2023 on 350 planes.
