I'll be back soon': Wife reads out Kejriwal's first message from jail

"Together, we have to make India a great country, the strongest and number one country in the world"

NEW DELHI: CM Arvind Kejriwal's wife, Sunita, is not often seen making public speeches. But on Saturday, with her husband in Enforcement Directorate's custody, she read out a message from the CM. In it, the AAP national convener claimed he couldn't be kept behind bars for long and would return to fulfil his promises to Delhi's people.

In a digital address streamed live on AAP's social media channels from the CM's residence in Civil Lines, Sunita auoted her husband as saying that he was born to fight wars and was destined for still bigger challenges.

"Whether in jail or outside, every moment of



the country's service. Every drop of my blood is dedicated to the country," she read.A former IRS officer, Sunita, has so far kept away from active politics. She was recorded reading the letter in the same office in the CM's residence from which the CM regularly addressed the media digitally, with photographs of Bhim Rao Ambedkar and Bhagat Singh and the Indian flag forming the backdrop. He also asked people not to hate BJP for his arrest. "They are our brothers and sisters," he said in his message. "Aisi salakhein nahin jo aapke my life is dedicated to bhai bete ko zyada din

andar rakh sakein (no jail can keep your brother, your son inside for long). I will come out and fulfil my promises," he said. His wife quoted him in the address as saying that there were many forces in India trying to pull the country down. "Together, we have to make India a great country, the strongest and number one country in the world. We need to be cautious and identify these forces within and outside India weakening the working and defeat them," Kejriwal said, adding that there were numerous "patriots" who needed to unite and strengthen India's

Assam CM Himanta Biswa Sarma lays down 'indigenous' rules for Bangladeshorigin Muslims

GUWAHATI: Assam chief minister Himanta Biswa Sarma on Saturday laid down certain conditions for the migrant Bangladesh-origin Bengali-speaking Muslims, called "miya", if they want to be recognised as indigenous people of the state: "They should stop having more than two children and practising polygamy as it is not the culture of Assamese people. If they want to become indigenous, they cannot marry off their minor daughters."He wondered how could Bengali-speaking Muslims claim to be indigenous if they (Vaishnavite monasteries) land. "Instead of sending your children to madrassas, educate them to become doctors and engineers if you want to be called indigenous,' Sarma said, adding, they should also start sending their daughters to schools and give them the right over their fathers' properties. "These are the differences

between them and the indigenous people of the state. If they can give up these practices and imbibe the culture of Assamese people, at some point of time they too can become indigenous," Sarma said. Assam has the second largest population of Muslims after J&K. The 2011 census states that Muslims account for over 34% of Assam's total population. But this Muslim population in the state is of two distinct ethnicities - Bengalispeaking and Bangladesh-origin migrant Muslims and Assamesespeaking indigenous Muslims.

In 2022, the Assam cabinet recognised around 40 lakh Assamesespeaking Muslims of the state, who do not have any history of migration from Bangladesh, as "indigenous Assamese Muslims" and a sub-group of the greater native Assamese community, making a clear distinction between the two groups of Muslims.

NEW DELHI: Chief minister Arvind Kejriwal moved high court on Saturday, challenging his "illegal" arrest and subsequent remand by Enforcement Directorate in a money laundering case linked to the alleged Delhi excise policy scam. While the plea sought urgent hearing, possibly on Sunday, sources in high court indicated that the matter will be listed in due course, on or after Wednesday (March 27) when HC reopens after Holi vacation. On Friday, a trial court had remanded him in ED's custody till March 28 "for his detailed and sustained

interrogation". In his plea, Kejriwal, who was apprehended in a swift move by ED on Friday night, contended that his arrest and remand were illegal and that he was entitled to be released from custody immedi-ED

had arrested Kejriwal hours after the high court refused to grant him protection from coercive action by the central agency. This is the third time in a week that the chief minister has knocked on the doors of the high court.

Earlier, he had moved court for quashing and setting aside all proceedings, including the ED summonses issued against him. In that petition, Kejriwal said he is a "vocal critic" of the ruling party, an opposition leader and a partner in the INDIA bloc, and ED, being under Centre's control, had "weaponised". After

Ask Centre to release drought relief funds, Karnataka tells Supreme Court

BENGALURU: Karnataka govt on

Saturday moved the Supreme Court seeking a direction to the Centre to release drought relief funds to the state Natural Disaster Management Act (NDMA). The writ petition filed under Article 32 of the Constitution is scheduled for a hearing next week. New Delhi: A court here has sentenced a 34-yearold man to five years of rigorous imprisonment for sexually harassing and criminally intimidating a minor on a social networking site.

The court said it is the responsibility of society to protect children from exploitation by cyberstalkers or cyberbullies, observing that the psychological scars of childhood sexual abuse deeply impact the lives of innocent children. Additional Sessions Judge Susheel Bala Dagar was hearing a case against convict Akhilesh Kumar who was booked under provisions of the Indian Penal Code (IPC) and Prevention of Children from Sexual Offences (POCSO) Act. Noting the submissions of public prosecutor Yogita Kaushik Dahiya, the court said it was proved that Kumar chatted with the minor after creating a fake identity, made sexually coloured remarks, and contacted or followed her online despite the girl's clear disinterest.

Man lures astrologer with property deal, rapes her in Delhi; non-bailable warrant issued

NEW DELHI: A 36-year-old astrologer has alleged that she was sexually assaulted by a man on the pretext of a property

deal in south Delhi. A non-bailable warrant has been issued against the suspect and raids are on at different places to arrest him. The woman, in her complaint filed last month, stated that her family is known to



the accused's family. "In Jan, she contacted the 40-year-old suspect regarding the sale of a property of someone she knew. He then visited the woman's house and assured her that he could help in selling the property," a police officer said. The suspect claimed to be a property dealer, which is being investigated. The suspect learned that the woman was an astrologer. He then gained her trust by calling her under the pretence of wanting to learn more about astrology. One day, he contacted the woman and took her to his friend's house in Neb Sarai, apparently to finalise the property deal. "The woman claimed that he mixed something in her drink and then sexually assaulted her," the officer said. A case under sections of 328 (causing hurt by means of poison, etc., with intent to commit an offence), 376 (sexual assault) and 506 (criminal intimidation) of IPC was registered. "We are conducting raids to nab the accused," he added. (The victim's identity has not been revealed to protect her privacy as per Supreme Court directives on cases related to sexual assault)

The Supreme Court pulled up the State Bank of India for not disclosing all the details related to electoral bonds, calling its attitude "unacceptable". The 5-judge bench led by CJI D Y Chandrachud directed the directed SBI chairman to file an affidavit by Thursday 5pm, confirming that all details of the Electoral Bonds including the unique alphanumeric and serial numbers of redeemed bonds have been disclosed.

Indian students flouting cautionary advisorie

To prevent violent attacks against Indian students and other Indians, the current Biden administration has provided security, both on and off campus, and in the community at large. But do some Indian students put themselves in harm's way by flouting cautionary advisories on dangerous areas? Four Indian students have been killed in two weeks according to a news report datelined 2 February 2024. They were 19-year-old Shreyas Reddy Benigher from the Linder School of Business, Ohio, Neil Acharya of Purdue University, Vivek Saini from Panchkula in Haryana. The latest is Sameer Kamath, an Indian-American pursuing his doctorate in mechanical engineering at Purdue University again. In addition, Akul Dhawan was found dead of hypothermia outside the University of Illinois UIUC in Champaign. G Dinesh of Telangana and Nikesh of Andhra Pradesh were found gassed to death in their flat in Connecticut. Kuchipudi and Bharat Natyam dancer Amarnath Ghosh, age 34, was shot to death in St Louis Missouri. Paruchuri Abhijit of Boston University was found dead in his car, making up the ninth death so far in 2024. There is at least one death of an Indian every day across the US, says an American community leader Mohan Nannapaneni, founder of volunteer-based non-profit organisation TEAM Aid. These are mostly students and H-1B employees who have recently come to America. Are some Indian students lonely and feeling alienated far from home? Do some of them, unable to fit in socially or cope academically, persist in their studies there due to societal and parental pressures emanating from back in India? Though more often than not, Indian students who go to American universities are exceptionally bright and are there on earned scholarships. But are they mature and experienced enough in the Western cultural mores and milieu to avoid bullying and ridicule? Sometimes, there are underlying mental health issues even amongst gifted students which are activated by the pressures of academics and fitting in. Some die of physical illness and natural causes. Perhaps the lack of seeking timely medical attention in an alien medical system is to blame. Again, this is a phenomenon that affects foreign students even here in India, because many tend to neglect themselves in the absence of relatives to keep an eye on them. In January 2024, a young girl graduate student Jaahnvi Kandula was run over by a speeding policeman Officer Kevin Dave in a police car at a street intersection crosswalk in Seattle. To compound matters, the manslaughter caused by the police car being driven at 119 kmph was laughed off by another Seattle Police Officer Daniel Auderer, who said Kandula's life had 'limited value'. He dismissed the proposition that officer Dave was at fault and that a criminal investigation was necessary.

The Ministry of External Affairs in India has said a total of 403 Indian students have died abroad from various causes since 2018. The largest number of deaths occurred in Canada followed

Britain. Several voices in India are being raised

against the necessity of sending Indian students to study abroad. Perhaps the answer lies in sending them to better regulated and safer places such as Singapore where the spectre of racism is largely absent. It seems that most of the White world, including Australia and New Zealand, has a racist problem that their governments are struggling to quell. The lure of obtaining lucrative jobs in Europe and America by studying and graduating from their universities.

The demystification of MS

There are two kinds of people. One who likes salted caramel, the other, sugary sweet tarts; one who loves to hike, the other to lounge at a beach; one who loves cats, the other dogs. There are two kinds of people the world over, and then there is MS Dhoni. He studies the dialogues of an advert that he has to deliver, just as closely as he reads and decodes his opponents; he thrives under the spotlight of leading his side, just as much as he loves his almost reclusive solitude; he is reticent at most times in the public eye, as much as he taunts playfully and holds a room when surrounded by his people; he lets the whole world watch his every move on a cricket field, as much as he guards his innermost thoughts; who is cool and calm under the pressure of a last-ball finish, as much as he is enraged enough to storm onto the field when he had no business being there, to confront an umpire; who is extremely rigid about the seemingly banal things in life like the way he likes his dosa, or the juice he drinks, and yet is so carefree when it comes to the seemingly big things - like renouncing his captaincy.

I remember covering the series when Sourav Ganguly famously finished a press conference to say the words "Just one last thing, lads..." and dropped his retirement bomb. That sent a shock wave back then, but you expected the theatrics with dadi, as he is fondly called otherwise. That was the era of drama and oneupmanship. It was the need of



that hour, that time. And then of course, someone like MS came along. There were too many stark differences between the dadi era and the Dhoni era that followed, but we won't go into any of that. That is not at the heart of this narration. But there's a reason I bring up the dadi announcement, made at a time when social media was not the monster it is today. So I get the intent behind that and the manner in which it was made. Living in a time now when every movement of a public figure is somehow caught on camera and splashed across social media platforms, MS Dhoni's abstinence from the same, is remarkable. To understand this you somehow have to understand the man. And the only way you can truly get him, is if you interact with him face to face. There is no WhatsApp culture with MS (surprise, surprise). I worked

with the Chennai Super Kings franchise for close to five years. That is a long time when you look at career goals and what you want to do, because there has to be constant evaluation and recalibration. This obviously doesn't apply to the man who held on to the same position at CSK for 17 long years. I think I was lucky to be a part of a set up back then with all the senior hands in the system at their peak. Age was not on their side, but the vigour was sky-high because the franchise had just come out of a 2-year suspension. I guess to this day, if you ask anyone who walks down the corridors of Chepauk or the India Cements building, the 2018 season would be remembered as one of the best years for this group. A miracle season that only MS could have manifested. I'll circle back to this in just a bit. Chennai Super Kings, I realise

now, is the equivalent of Gryffindor of Harry Potter world - the House that every young wizard entering the Hogwarts School of Witchcraft and Wizardry, desires to be a part of. It's the right of passage. And it sounds about correct doesn't it? CSK has witnessed a lot of wizardry over the years too. So I only have gratitude. Not because of getting an opportunity to work with CSK alone, though I am certain that is on everyone's bucket list. But because I got to spend time and get glimpses into what made MS, well MS. I just want to share what I believe makes MS think the way he does. I want to connect the dots so you get a picture - maybe not the complete one - but a semblance of it, to fathom just why the hero you grew up idolising, or who inspired you to take up the sport, or who made you the leader you are today, does what he does and in the way he does it in.

We talk of MS making things happen on the field. We see him controlling and taking charge of the moments that somehow define the game and the end result. I think a lot of that comes from the way he thinks off the field too. Staying in control of the little things that eventually lead him to the big one. He resides in the small moments yes, but his sight is always on the bigger picture. Even the night after that 4th IPL title win, MS was already in the future. The squad had executed a fantastic turnaround from the horror season that 2020 was. That win in 2021 was a superb one, given the situation and MS approaching his big 40. And even when the whole group was celebrating the season that was, MS was already thinking of title number 5. That's the kind of person he is. He is able to compartmentalise his life to fit into boxes that make it part of a massive assembly line in the machinery of his brain. He believes that one needs to focus on moving from point A to B and henceforth to get to the ultimate goal - if that is infact Z. That's what you see on the field too. He talks about the process so much. It's a phrase that I am sure many of us in the sporting and broadcast industry would have casually scoffed at, at some point. But there is so much truth to that phrase or mantra because that is what he has constantly lived by. It has worked for him, and so he continues to believe that it will. Every franchise has its traditions, routines, certain things that they do. There are a few traditions in CSK too. And one of those is the inaugural team dinner. It is held just before the start of every season. The entire group from players, support staff, management, owners and families are invited to reflect on the past seasons and look to the future. There are a few moments that are highlighted, MS usually makes a speech, sometimes he refrains. It is a very private affair and is off camera, not for the media or even to post on their own platforms. 

Air India was fined Rs 1.10 crore by the DGCA for safety infractions

The aviation regulator DGCA fined Air India Rs 1.10 crore for operating Boeing 777 aircraft that were leased to the United States in breach of safety regulations. This is Air India's second penalty in a week from the regulator. A former Air India pilot filed a complaint with the regulator, claiming that the airline was operating Boeing 777 aircraft to the US without the necessary emergency oxygen supply system place. Directorate General of Civil Aviation (DGCA) conducted a thorough inquiry into the situation and served the airline with a showcause notice. "Since the said operations of the leased aircraft were not in line with OEM regulatory/ (Original Equipment Manufacturer) performance limits, DGCA has initiated enforcement action imposed a penalty of Rs 1.10 crore on Air India," according to a notification from DGCA. Air India did immediately



respond to inquiries regarding the punishment. The announcement said that following receipt of a voluntary safety report by an airline employee accusing Air India aircraft on specific longrange terrain-critical routes of safety violations, the regulator conducted a thorough investigation. A showcause notice was sent to Air India, according to the DGCA, since the investigation's first findings suggested the airline was not in compliance.

The press release omitted certain details. Before pursuenforcement action, the DGCA examined the airline's answer to the show

cause notice in light of the performance limitations outlined in the documents provided by the OEM and the requirements outlined under applicable statutory provisions, according to announcement. The pilot, who had been a B777 commander, lodged a complaint with the airline on October 29, 2023, over its policy of not having the necessary emergency oxygen supply equipment on board. According to reports at the time, the issue was that Air India was using leased B777 aircraft on flights that had a chemically manufactured oxygen system that lasted for around 12 minutes.

BJP eyes options in Badaun against SP veteran Shivpal

LUCKNOW: Who would be up against SP heavyweight and party chief Akhilesh Yadav's uncle Shivpal Singh Yadav in Badaun in the upcoming Lok Sabha elections? The question has started doing the rounds amid broad indications that the BJP may deny the ticket to sitting party MP and daughter of former SP leader Swami Prasad Maurya, Sanghmitra Maurya, this time. Highly placed sources in the BJP said that Union minister and sitting Rajya Sabha MP BL Verma and the party's Brai region president Durvijay Singh Shakya are emerging as the top contenders for the ticket from the constituency which has a sizable presence of the OBC, essentially Kushwahas, Shakyas, Lodhs and Yadavs.

Sixty-two years old Verma is often considered a 'close aide' of former CM Kalyan Singh. Currently, Union MoS for cooperative and north-east development Verma has also been the party's state vice-president. He was nominated to the Rajya Sabha in 2020 and a year later, in July 2021, was inducted in the Modi cabinet. Verma's tenure in RS is till November 2026.Shakya, too, wields considerable influence within the organisational command given his closeness to the RSS. He started his political career



while working with the Akhil Bharatiya Vidyarthi Parishad. He later became the Braj region general secretary and vice-president.

The saffron brass is also considering the name of SP MLA from Bisauli in Badaun, Ashutosh Maurya, who voted from the BJP candidates in the recently conducted Rajya Sabha poll. Maurya, a three-term MLA from the district, happens to be a Dalit. In 2019 Lok Sabha elections, Sanghmitra was the foremost choice of the BJP against SP's Dharmendra Yadav, who has been representing the seat since 2004. The move paid off as Sanghmitra defeated Dharmendra by a margin of

Rat-hole miner Hassan declines another house offered in Delhi's **Dilshad Garden**

NEW DELHI: Rat-hole miner Wakeel Hassan, who had lost his house in a demolition drive, has declined another offer of a house in Dilshad Garden here by the authorities. "On Friday night, four government officers, including an SDM, came and offered me a house in Dilshad Garden but I refused to accept it as they wanted me to shift on a temporary basis," Hassan said. "It was also not in writing. That house belongs to an NGO," he said. After the demolition, DDA officials proposed Hassan to relocate to an EWS (economically weaker sections) flat in Narela, which is far from Khajoori Khas in northeast Delhi. Hassan rejected the offer, stating that it was "far and unsafe." On being asked why he declined the second offer, considering that Dilshad Garden is closer to Khajoori Khas compared to the distant Narela, Hassan said that the cost of his demolished house was more than Rs 1 crore and if the government wants to compensate, then the cost of the house should be matched.



the National Stock Exchange of India crossed 9 crore (90 million) on February 29th, 2024. The total number of client codes registered with the Exchange stands at 16.9 crores (169 million) (Includes all client registrations done till date; clients can register with more than one trading member). Unique investor registrations at NSE have seen an accelerating trend over the last few years. While the increase from 6 to 7 crore (60 to 70 million) unique investors took about nine months, the next crore (10 million) investors came in eight months, and the jump from 8 to 9 crores (80 to 90 million) took only five months. During this period, daily new unique registrations



averaged between nearly 47,000 in October 2023 to 78,000 in January this year. The investor base has seen more than 3x jump in the last five years, facilitated by rapid growth in digitization, rising investor awareness, financial inclusion, and strong market performance.
