## Modi elected NDA leader, to be sworn in as PM on June 8



**NEW DELHI:** Amid Murmu on Friday speculation of jockeying for portfolios by its constituents, NDA on Wednesday moved swiftly for early formation of a BJP-led govt, setting the stage for Narendra Modi to be sworn in as PM on Saturday.Sources said Modi, who was unanimously elected leader the National Democratic Alliance on Wednesday, will be elected leader of the parliamentary party on Friday to fulfil JD(U) president and

The impetus for early swearing-in came from NDA partners at the meeting of the alliance. "Modi played a major role in our historic Andhra victory, should take over the reins of the govt without delay. He has the full support of all of us," a source quoted TDP chief N Chandrababu Naidu as saying in the meeting. the requirement to Bihar CM Nitish Kumar articulated the same sentiment and wondered why the matter President Droupadi was being delayed.

The drill for Modi's programme record-equalling third swearing-in got underway on Wednesday with the Union cabinet recommending the dissolution of Lok Sabha.

Chief election commissioner Rajeev Kumar, along with election commissioners Gyanesh Kumar and S S Sandhu, will call on the President with the list of newlyelected MPs. Rashtrapati Bhavan is clo sed for the public until Sunday, in what is being seen as part of preparations for the swearing-in ceremony. The NDA meeting was held amid growing buzz about Naidu staking claim to important infrastructure-related ministries besides demanding the position of Speaker as a pre-condition for pledging the support of his 16 MPs to Modi. Some political circles also maintained that Naidu had asked for a common minimum appointment of an NDA convener for better coordination among partners. Sources, however, denied any muscle flexing.

## Will take steps at right time: Mallikarjun Kharge after INDIA meeting

**NEW DELHI: O**n the day BJP and allies sealed the deal to form the next govt, the opposition said it will take "appro-priate steps" in the future to "realise the people's desire not to be ruled by the BJP govt", in a clear bid to uncertainty create about the coming NDA regime in which the BJP will depend on the allies to make the numbers. The opposition dubbed the Modi rule as "fascist".

Stalwarts of the INDIA bloc met Wednesday for over two hours to discuss the election results, with sources saying that most of the parties expressed the wish to form the govt but conceded that it was difficult to stop the BJP now that it has stitched the alliances.

Congress president Mallikarjun Kharge told reporters that "people's mandate has given a befitting reply to BJP and its politics of hate, corruption and deprivation". He said the mandate is "in defence of the Constitution of India and against price unemployment

PATNA: Bihar dealt a hard blow to dons-turned-politicians' proxies, aka their wives. Four such candidates were in the fray but three of them bit dust, while one scraped through. Kumari Anita, whose marriage to Nawada jailbreak convict Ashok Mahto was in itself a poll gimmick, contested from Munger on an RJD ticket against JD(U)'s Rajiv Ranjan Singh, alias Lalan Singh, who won by 80,870

Anita tied the knot with Mahto in March after being advised by RJD president Lalu Prasad to field his wife from the seat, as being a convict of more than two years' sentence, he himself couldn't contest. Since Mahto was not married at the time, he instantly went on a bride hunt and got married. Moments after wedding during an "inauspicious period", Mahto, accompanied by his newly-wed wife, went to Prasad's residence and the latter blessed her with an RJD ticket.

Among other losers are Bima Bharti - wife of Awadhesh Mandal facing murder, kidnapping and extortion cases- from Purnia, and Hena Shahab, widow of convict Mohammad Shahabuddin, from Siwan. Bharti too contested on a RJD ticket and got 27,017 votes equivalent to NOTA's 23,819 as she finished a distant third.

Shahab contested as Independent from Siwan - considered the "pocket borough" of Shahabuddin who was convicted in a kidnapcum-murder case in 2007.

## 5 trekkers feared dead, 4 missing in Uttarakhand

**UTTARKASHI:** Five individuals have been confirmed killed, and four others are feared dead after a group of "highly experienced" trekkers, aged between 34 and 71, returning from Sahastra Tal, a highaltitude lake 4,232 metres above sea level in Uttarkashi, struck were by adverse weather conditions and strayed off course in the mountains.

A collaborative effort involving the State Disaster Response Force (SDRF), Army, Air Force, Indo-Tibetan Border Police (ITBP), and forest and revenue departments managed to rescue 13 of them and recover the bodies of the five

**NEW DELHI**: Enough is enough, says the 12lakh strong Army, grappling with the repeated unauthorised use of its uniform and medals across the country. The force is now cracking the whip with the message that those "disrespecting the sanctity" of military attire and decorations.

#### 'Worn out' laws on missing soldiers' pension need to be abolished: HC

**INDORE:** Pradesh high court has observed that Indian Army's behaviour towards missing soldiers is "somewhat rude" and said that out" laws "worn regarding release of pension and retirement benefits to families of missing soldiers need to be abolished. Justice Anil Verma made the observation while issuing final directives in a second appeal filed by parents of signalman Surendra Singh Solanki — who has been missing since July 25, 2010 regarding modification of his date of death. "The history of our Army is full of unique tales courage, sacrifice and martyrdom. The brave soldiers live for the country and die for country. But

Madhya unfortunately, when a soldier suddenly goes missing, the Army's behaviour towards him becomes somewhat rude," HC said in its May 27 order.

Instead of helping the soldier's family, Army expects them to get the date of his death declared through civil court, and are denied pension and other retirement allowances, Justice Verma said, adding, "It is a hardship for the grieving family of a missing soldier."

Solanki, a Mandsaur resident, joined the Army in 2002. After he went missing, his parents lodged a missing person's report and started receiving ordinary family but in 2020, received a communication from the dept that "due to nonavailability of death certificate.

#### Prayag, Phaphamau railway stations to have double entry, exit gates

Prayagraj: In preparation for the upcoming Mahakumbh-2025 mega religious fair, the Northern Railway has started building second entry/exit gates at Prayag and Phaphamau railway stations, similar to the setup at Prayagraj junction. The development aims to streamline passenger movement and enhance overall accessibility at these bustling stations, informed officials. The construction of the new gates has already started, and the work is planned to be completed well before the formal start of the Mahakumbh. Comprehensive infrastructure enhancements, including the installation of new ticket counters, are also underway alongside the new gates at both railway stations, officials added. At Prayag station, the construction of a new platform and gates towards Ram Priya road has started. However, due to space constraints, there will be no parking facilities at this end.

In contrast, Phaphamau railway station is witnessing the erection of an entirely new structure, including a platform and an entrance/exit gate towards Rangpura village. A food plaza is also proposed at this location. The new gate will enhance connectivity to Varanasi Road and Phaphamau Kachaar. Divisional railway manager (DRM)- Lucknow Sachindra Mohan Sharma has been overseeing these developments, visiting Prayagraj twice within the last month. On May 19, Sharma briefed Kumbh mela officer Vijay Kiran Anand on the ongoing development works at the stations. Further inspections were conducted on May 31 to ensure the projects were well on track in keeping with the deadlines. Plans are also in place for construction of a second gate on the side of Lowther Road of Prayagraj Rambagh station. However, limited space on this side has led to some uncertainty regarding its implementation.

#### France offers a welcome breather for India

Prime Minister Narendra Modi with chief guest French President Emmanuel Macron during the 75th Republic Day parade, at the Kartavya Path, in New Delhi, on 26 January, 2024. PTI Between them, US President Joe Biden and rival Republican Party's Nikki Haley seem bent on pushing India closer to France for a balanced relationship in the western world that has all the ingredients of strategic stability, both in the bilateral and multilateral contexts. That is if one were to leave out India's Russia relations, which many believed were rocky but became sort of rock steady all over again owing to the Ukraine War, where the long American arm was seen all over the place.

Yes, Nikki Haley, 51, is not even Biden's likely rival in the US presidential polls in November. She did not mean to question, challenge or rebuke India, either. Instead, by claiming that India was moving closer to Russia than the US, implying that the Biden presidency did not inspire confidence not only in New Delhi, but also in Tokyo and Seoul, Canberra and Wellington, Halley was only targeting the incumbent back home. But her choice of India, and not any of America's NATO allies, for example and her choice of words, gave the impression that she was trying to convince a certain section of Republican voters that she was all American, and not Indian.It has to be front-runner and former president Donald Trump. Halley is trailing the Republican primaries and polled lower than their kind of NOTA in Nevada, but that does not make sure that Trump's name will be on the ballot. Indications are that at some point, either the Republican Party bosses or American courts could make it embarrassing for Trump's name to be on the ballot. Halley seems hoping for that day and is persisting in the primaries precisely for this reason. Maybe, like a typical Indian-origin woman that she is, Halley is hoping for 'sympathy votes' or 'survivor's votes', first in the primaries and later in the presidential poll. Of course, there is a long way to go this time than any time in the


#### **Disappointment for India**

Biden kept India waiting and eventually turned down the invitation to be the chief guest at the annual Republic Day celebrations. Information about India's invitation having spread after a time (generally it is kept secret until accepted – which again used to be a formality), Biden's avoidablydelayed rejection was a disappointment for India. It is not known how the Indian-American supporters of Biden and the Democratic Party feel about it. Not-so-official news sources claimed that Biden's decision owed to the election year commitments on campaigns and other essentials. In his place, another Democratic president, Barack Obama, took a short break from his socalled pressing engagements back home to be present in Mumbai first and Delhi next, where he was the chief guest at the 2015 Republic Day. Of course, in true American form and style, it was not a visit confined to honouring contemporary India's tryst with destiny. Obama did hard-selling business in an election year and took back orders for Boeing, which he said would ensure 20,000 Americans did not lose their jobs. Biden was constrained by domestic perceptions, both inside the Democratic Party and outside. Maybe, Team Modi too thought that having Biden would be a high-profile commencement to the ruling BJP-NDA's campaign for the Lok Sabha polls in the summer. To an extent, it compares with the 'Namaste Trump' show that India put out for the US President of the time, in February 2020 amid the farmers' rally in New Delhi. The Ahmedabad rally in particular was only a mirror-image of the Trump show for the Indian

## Narasimha Rao was a Batman of Indian politics, Bharat urgently needed to acknowledge

Former Prime Minister PV Narasimha Rao, in a true sense of the word, was a Batman of Indian politics. He became Prime Minister at a time when India's chips were badly down. In 1991, the country had to pledge its gold to pull the economy from the brink. He reoriented India's pro-Soviet Union foreign policy to bring it closer to the Western order. He reached out to Israel without leaving the Palestinian cause — an axis on which the Indian foreign policy still revolves around. And all this he delivered with a minority government. Still, Narasimha Rao remains largely forgotten and uncredited — Batman-like. Sanjaya Baru, in his book 1991: How PV Narasimha Rao Made History, emphasised at this phenomenon, with a tinge of sadness, when he recalled how "at an interaction with students at a university near Delhi, in the winter of 2015", he asked the audience "what the year 1991 meant to them". One student readily stood up to say he was born that year — and the entire audience burst into laughter. When Baru insisted on thinking more, there was silence.

PV Narasimha Rao, Charan Singh, MS Swaminathan: Why they deserve Bharat Ratna Later, the same year, Baru addressed "a meeting of the Hyderabad Management Association" and he repeated



the same question. Many were quick to reply this time: The government that year had "introduced new economic policies that opened up the Indian economy", Baru was told. And who was responsible for this? "Manmohan Singh," pat came the reply! Some even credited P Chidambaram and Kamal Nath! Later, in an interaction with this author, Baru expressed his surprise at the height of Indian ignorance: "No one mentioned PV Narasimha Rao. Ironically, this incident took place in Hyderabad, which was Rao's own city."

When I asked Baru why Rao had been forgotten, he cited two reasons. "One, he faced several corruption cases, especially towards the fag end of his rule. But most importantly, the Congress decided to erase the memory of Narasimha Rao, to make the point that no person from outside the family can ever be a successful PM. After all, what did Rao prove? He

proved that someone doesn't need to be related to the Nehru-Gandhi family to be a successful prime minister. By becoming the first PM outside the family to run the country for a full term, he effectively challenged this notion."

It's ironic to see the Congress disowning one of its own prime ministers, especially the one "whose impact on the nation's fortune went way beyond the economy", as Baru wrote in 1991. But then it was an obvious outcome for a non-Gandhi leader in the Congress. It had happened in the past with Sardar Vallabhbhai Patel and it took place after Narasimha Rao, as was the case with Pranab Mukherjee. Anyone seen to be eclipsing the halo of the Gandhi-Nehru family was systematically targeted to be pushed to the footnotes of the party's — and by extension, the nation's — history. This explains Sonia Gandhi's hostility for Rao, to the extent that the former Prime Minister was denied a well-

deserved memorial in Delhi, even when lesser worthies could find space in the national capital. Author Vinay Sitapati, in Half Lion: How PV Narasimha Rao Transformed India, gives a graphic detail on how the late Prime Minister was denied a rightful place and space in Delhi after his death. "The home minister, Shivraj Patil, suggested to Rao's youngest Prabhakara, that 'the body should be cremated in Hyderabad'. But the family preferred Delhi. After all, Rao had last been chief minister of Andhra Pradesh more than thirty years ago, and had since worked as Congress general secretary, Union minister, and finally prime minister — all in Delhi. On hearing this, the usually decorous Shivraj Patil snapped, 'No one will come'," Sitapati writes. Thereafter, Ghulam Nabi Azad and YS Rajasekhara Reddy reached out to Rao's family — Reddy, being the chief minister of Andhra Pradesh, promised a grand memorial for Rao in Hyderabad! Later in the day, prime minister Manmohan Singh entered the room and asked Prabhakara: "What do you want to do with the body?" To this, Rao's son replied, "These people say it should be in Hyderabad... This (Delhi) is his karmabhoomi. You should convince your colleagues." Cabinet Manmohan nodded. Sonia Gandhi was standing near, but

mostly kept quiet. When Sanjaya Baru arrived, Ahmed Patel sought his intervention. Baru's bureaucrat father knew Rao from the 1960s — and he was close to the family. "Sonia's political secretary tapped him on the shoulder. 'You know the family,' Patel said. 'The body should be taken to Hyderabad. Can you convince them?" Sitapati quotes Prabhakara as saying, "We sensed even then that Sonia-ji did not want Father's funeral in Delhi. She did not want a memorial (in Delhi)... She did not want him (to be seen) as an all-India leader." The next morning, when Rao's body, draped in the national flag, was being taken to the airport, it was planned to stop at 24 Akbar Road, the Congress headquarters. "As the body approached 24 Akbar Road, located adjacent to Sonia Gandhi's residence, the funeral procession slowed. The entrance gate to the compound looked firmly shut. There were several senior Congressmen present, but hardly any cadres had been rustled up. No slogans filled the air, just deathly silence. The carriage stopped on the pavement outside, as Sonia Gandhi and others came out to pay their respects." "It was customary for the bodies of past Congress presidents to be taken inside the party headquarters so that ordinary workers could pay their

## Why India's \$100 bn proposed trade deal with Europe is different

Byju's said that with Raveendran and board members deciding to skip the EGM, it will not have the required quorum and cannot proceed to discuss or vote on the agenda. "As custodians of Byju's, it is the responsibility of the founders to respect the established procedures of law and protect the company's integrity," the company added. The EGM is supposed to take place on Friday morning, according to the EGM notice reviewed by. We cannot be a nation where one community is progressing with the support of the Constitution while the other community is stuck in a time warp due to appeasement. We will do everything in our capacity to make UCC a reality in India," the PM said, while also



renewing his vow to move forward on his 'one nation-one poll' plan. Modi expressed confidence of getting a third straight term, and said he was striving for a 400-plus tally to foil the "evil designs of opposition parties to take away reservations and rights of SCs/STs and OBCs and give it to their vote bank".

#### Delhi plans to plant 2.3 lakh trees and 3.8 lakh bushes in parks

**Delhi:** To reduce dust pollution and increase green cover, the Municipal Corporation of Delhi plans to plant 2.3 lakh trees and 3.8 lakh bushes in parks, schools, open spaces, and roadsides this year. In 2023-24, the city planted two lakh trees and 3.25 lakh plants. The horticulture department requested zonal office requirements to complete the assignment. "We will plant when the details are acquired. An officer stated schools, hospitals, parks, and below flyovers are used for this. He stated that the government will continue roadside tree planting in some colonies at homeowners' request.

MCD plans to carpet or repair 50 km of interior roadways by Oct. to reduce dust. Between April 2023 and February 2024, 139 km of roads were resurfaced or repaired. A civic council wants to resurface 180km of roads by Oct. Road maintenance and resurfacing are ongoing. After winter, we started dense carpet work on damaged areas. Work is being done with MLA or Mukhyamantri Sadak Punarnirman Yojna nonplan head funding "said the official. Our 52 mechanical road sweepers are for PWD roads. #### **One-year DDA flat** maintenance with RWAs

Delhi: Delhi Development Authority would give residents' welfare societies maintenance work within a year of creation to ensure flat maintenance. This will also apply Diwali Housing Special Scheme 2023 units. This conclusion followed Real Estate Regulatory Authority criteria. A maintenance fee is normally collected by DDA during allotment. It has maintained flats for 10–20 years, depending on the scheme. A DDA official stated that applicants must join the registered agency or RWA to maintain common services. Per pocket, one RWA will be registered. All new DDA plans require upfront monthly costs for one year, depending on flat type. "DDA shall do daily maintenance from maintenance charges for one year or until RWA is formed, whichever comes first. An RWA will get the balance

one year. If a RWA is not created within a year, it will be done on actuals "said the official. "For subsequent years, the necessary arrangement will be communicated to the residents,' he said. Residents expect standard changes to speed up DDA flat maintenance, which had been delayed for a long period. #### Tata Steel to invest \$ 2 billion to fund rejig of UK operations

Mumbai: Tata Steel will infuse \$2.1 billion (Rs 17,408 crore) in its Singapore arm, to repay debt of its offshore entities and to "support the restructuring costs" of its loss-making UK operations. Further, it will convert debt instruments worth \$565 million (Rs 4,661 crore) it holds in the Singapore arm into equity shares. The fund infusion as well as the conversion of debt into equity will be done in this fiscal, said Tata Steel.

Tata Steel's profit slides 65% to Rs 555 crore

The Indian company owns 100% of Singapore arm called T Steel Holdings, which in turn owns the overseas steel assets including the UK plant. T Steel Holdings posted a loss of Rs 4,367 crore in FY23. Tata Steel will also be raising Rs 3,000 crore in the form of non-convertible debentures (NCDs). The company has been raising money through NCDs now and then. Tata Steel is investing £1.25 billion (\$1.6 billion) to build a new electric arc furnace (EAF) at its Port Talbot plant in UK, while deciding to shut down two blast furnaces at facility by Sept. The move will lead to axing of 2,800 jobs at the plant."We will proceed with proposal to shut down heavy end assets this year, and set up EAF by 2027. This is a difficult period of change for our people... With respect to EAF, we will place equipment orders by Sept 2024 and have signed the agreement with UK National Grid securing high voltage connection, which will be available on schedule. We have as part of discussions with the unions, offered the best ever package of support for affected employees in Tata Steel UK. We have agreed to final terms of proposed grant package.

MUMBAI: The bourses on Wednesday warned investors to not fall for social media posts offering high returns through specialised apps that use names of established brokers and other intermediaries. While NSE said in its warning that there have been cases where people impersonated representatives Choice Broking and R K Global Shares & Securities, BSE didn't name any broker or market intermediary.

"It has been brought to the notice of (NSE) that trading accounts by persons named "Makhan Prajapati"

and "Rakesh Sharma" claiming to be associated with entity named "Choice Broking" operating through mobile number "9977690997" and person named "Kuldeep Valiya" claiming to be associated with entity named "R K Global Shares & Securities" and operating through mobile number "9112569388" are providing securities market tips for trading and assured returns on investment in the stock market.He is also offering to handle investors' asking them to share their login ID/pass-

words," NSE said. "Investors are requested to take note that Choice Equity Broking and R K Global Shares & Securities, registered trading members of (NSE), have informed that the above-mentioned person is not associated with them in any manner," it added. "Generally, impersonators carry out their activities via social media platforms and messaging apps such as Facebook pages and groups. WhatsApp They make enticing promises of guaranteed high returns," BSE said. When investors start to

believe they are dealing with legitimate registered intermediaries, they download the app and invest through it. "Reality is that their investments never actually occur on the stock exchanges. Instead, these transactions remain as paper trades within the app. When investors try to withdraw substantial amounts, the app suddenly becomes nonfunctional."BSE, in its letter, said Sebi had been receiving complaints from investors/intermediaries about fraudulent

trading activities.
