"Their callousness on Katchatheevu has harmed interests of our poor fishermen and fisherwomen"

NEW DELHI: Raising the issue of Katchatheevu for the second straight day, PM Modi Monday targeted DMK over revelations that the party had consented to renunciation of the island in 1974.

Taking to X, Modi mentioned official documents cited by TOI to say that notwithstand-DMK's public protestations, party stalwart and then CM of Tamil Nadu M Karunanidhi had agreed to the Indira Gandhi govt's decision to hand over the island to Sri Lanka. The PM alleged that the then governing party of TN did nothing to safeguard the state's interests and stood unmasked following

disclosure of what had

transpired between it and the Centre. New details emerging on Katchatheevu unmasked DMK's double standards totally," PM posted on X, along

with the TOI report. He targeted Congress for the second day running over the controversial decision. "Congress and DMK are family units. They only care that their own sons and daughters' rise. They don't care for anyone else. Their cal-

lousness Katchatheevu harmed interests of our poor fishermen and fisherwomen in particular," he said.



On Sunday, he had said, "Weakening India's unity, integrity and interests has been Congress' way of working for 75 years and counting."PM's remarks come in the wake of growing scrutiny of the agreement between India and Sri Lanka, signed during the tenure of Indira Gandhi

Annamalai reiterated that Congress and DMK colluded to give away Katchatheevu to Sri Lanka. "This is part two of expose of betrayal of DMK in ceding of Katchatheevu," Annamalai said at a

conference, press adding, "Ex-CM Karunanidhi was consulted twice before ceding Katchatheevu to Sri Lanka and he said for obvious political reasons that he will not take an open public stand in accepting Centre's decision."

He said, "But he

assured the foreign secretary that he will keep the reaction low-key and not allow it to be played up. M K Stalin (Tamil Nadu CM) has to own up to this betrayal of his party and apologise unconditionally to our fishermen for putting their lives and livelihoods at risk for past 50 years." BJP is hopeful that the issue will help it in Lok Sabha polls since it involves neighbouring Sri Lanka whose treatment of its own Tamil citizens and Tamil Nadu fishermen has long been a charged political issue

Court orders judicial custody till **April 15, CM Kejriwal sent to Tihar**

NEW DELHI: A Delhi court on Monday sent chief minister Arvind Kejriwal to Tihar Jail till April 15 in the liquor polcase Enforcement

Directorate said he was being "non-cooperative" and should be sent to judicial custody.

Producing Kejriwal after the end of his remand, ED did not seek further custody but alleged that he had tried to mislead the officials who were questioning him.

The agency claimed Kejriwal had told them that co-accused Vijay Nair didn't report to him but to Atishi and Saurabh Bharadwai, now AAP ministers.

"We are asking for judicial custody, subject to the right of asking for further custody, as per SC judgment in the Senthil Balaji case," submitted additional solicitor general S V Raju, who appeared for ED. Raju also claimed that the CM had not provided passwords to his digital devices. In its application, ED said Kejriwal



was highly influential and there was every likelihood that he would influence witnesses and tamper with evidence if released. This could hamper the ongoing investigation, it said. Atishi, Bharadwaj, Gopal Rai and Kejriwal's wife,

that Nair was not a small-time volunteer of AAP but its head of media and communications. Addressing a press conference, AAP leader Jasmine Shah said: "Nair had given this statement (that he didn't report to the CM but to Atishi and Saurabh Bharadwai) to ED when he was arrested. Why did ED bring up this statement after a year-and-a-half? BJP has understood that putting Kejriwal in jail will not crush the party and it is preparing 2-3 more leaders (to send to jail)."

NEW DELHI: Union minister Kiren Rijiju on Monday night criticised China for reportedly renaming multiple locations in Arunachal Pradesh, emphasising that such actions do not alter the ground reality. Minister of Earth Sciences, Rijiju, wrote on X, previously known as Twitter, "I strongly condemn China's illegally 'standardised' geographical names given to 30 places inside Arunachal Pradesh. China has been making all baseless claims but that's not going to change the ground reality and the 'historical facts'. Arunachal Pradesh is inalienable part of India. & people of Arunachal Pradesh are supremely patriotic Indians by all standards & definitions." Rijiju's response came after Congress president Mallikarjun Kharge slammed the Centre over a media report detailing China's renaming of locations in Arunachal Pradesh and criticising Narendra Modi-led government for diverting attention from it by raising the Katchatheevu issue. The longstanding territorial and fishing rights dispute concerning Katchatheevu Island gained prominence ahead of the Lok Sabha polls in Tamil Nadu as PM Modi accused Congress of negligently ceding the island and criticised TN ruling party for failing to protect the state's interests. Kharge also denounced China's

move, labeling Beijing's actions as 'ludicrous' and urging the Indian government to take a stand against the neighbour's provocations.

I-T dept tells Supreme Court no action till Lok Sabha polls

notices to Congress raising demand of around Rs 3,500 crore, income tax department Monday assured Supreme Court it would not take any coercive steps to recover the amount as it did not want to cause any problem for the party during elections.At the outset of the hearing on Congress's appeal against a Delhi high court order, solicitor general Tushar Mehta told a bench of Justices B V Nagarathna Augustine George Masih that he wanted to make a statement on behalf of I-T department.

He said no further action would be



taken against the opposition party during the ongoing general elections. He said the case could be posted for hearing after June 4 when the results of Lok Sabha polls would be declared. He said he would oppose Congress's claim then. "Since elections are going on, we do not want to create any problem for the party.

We will not take action for recovery of the amount and the case could be heard in the second week of June," he told the bench. The bench was hearing an appeal filed by Congress in 2018 against a 2016 judgment of Delhi HC. In the appeal, the party had moved an inter-

application seeking stay of the demand notices issued by I-T department March. Initially, Mehta said

notices had been issued for recovery of Rs 1,700 crore but senior advocate Abhishek Singhvi said the total amount was around Rs 3,500 crore which was accepted by the SG. Singhvi appreciated the I-T department for its gracious approach.



HC restraint on razing unit built to provide jobs at defunct mill



Mumbai: The Bombay high court has placed a restraint on the demolition of recently built multistorey structure for 10,000 spindle units the defunct Mill in Mafatlal Byculla (Mazgaon division) next to Veer Jijamata zoo. The high court slammed a builder for putting profit over the livelihood of erstwhile mill workers and quashed as "illegal" the 2019 decision of the state to do away with a two-decade-old town planning condition.

The 2004 stipulation

was intended at social

re-engineering, said the high court as it required construction of the spinning unit while allowing sale of the mill land.

The high allowed a petition by Mafatlal Industries that challenged the state decision. The high court restrained the state, BMC and Glider Buildcon Realtors from razing the spindle unit building and from using any of its FSI. "This is a case of... relentless pursuit of profits by a developer; and the fates and livelihoods of the textile mill's erstwhile workmen

and their families, said the division bench of Justice Gautam Patel and Justice Kamal Khata. "Or, to badly para-

phrase Lewis Carroll, the time has come to speak of many things: of mills and zoos and city plans, of workers and developer kings," said the judges in an order uploaded on Monday. Mafatlal Industries, which owned the land, had in 2020 approached the high court against the Sept 2019 letter of the state to dispense with a condition incorporated in 2004 to DCR 58.

T witnesses 10% growth in GST figures for 2023-24

Hyderabad: Telangana crore GST collected in 15,342 crore in 2022clocked an overall Goods and Services Tax (GST) collection growth of 10% in the 2023-24 financial year as compared to the previous financial year. Overall GST figures available for financial year 2023-24 show that GST collection was 40,650 crore, up from 37,026 crore in 2022-23.

Thanks to tight checking of tax leakages and curbs on the indiscriminate release of GST claims, the state also registered a significant 19% growth in State Goods and Services Tax (SGST) figures.

Of the total 40,650

2023-24, the SGST component was 20,012 crore, which represented an increase of 19 % from the SGST figure of 2022-23 at 16,876

Integrated Goods and Services Tax (IGST) figure stood at 20,638 crore this year, registering a 2% growth from last fiscal's 20,150 crore.

Officials said that these figures assume more significance as there was no growth in VAT, especially from petrol sales. Despite stagnant VAT figures, Telangana collected 15,415 crore in 2023-24 compared to

Telangana also received a GST compensation settlement from the Centre on the last day of the 2023-24 financial vear. "With a lot of pursuance from the state authorities, Centre released the pending amount. In all, we have received 791 crore in compensation, significantly lower than the previous year's 5,033 crore. Additionally, we trimmed the refund claims by 264 crore which helped us witness good growth and check the leakages in the system," said an official.

Bengaluru: Following complaints of rude behaviour and use of unparliamentary language, the commissioner of health and family welfare services suspended Dr Leela Sampath, gynaecologist attached to KR Puram General Hospital, and ordered an inquiry against her.

They observed Dr Leela's alleged unruly behaviour and dereliction of duty by allowing nursing staff to maintain the records of patients admitted to the labour ward.

NEW DELHI: Vistara's woes ahead of its merger with Air India (AI) have mounted, with "significant cancellations and delays in the past few days" forcing the Tata-owned carrier to "temporarily" truncate schedules. The airline was forced to cancel close to 50 flights on Monday. Sources said the number of cancellations could go up to 60 on Tuesday. Vistara — a full service carrier that operates over 300 domestic and international flights.

Bengaluru: A minor collision between a car and a scooter escalated into an ugly confrontation involving lewd gestures and a chase in Koramangala Sunday night.

Saunak Ghose, a resident of Kudlu Gate, uploaded a video clip on her X account showing three youths on a scooter chasing her car for some distance from Madiwala underpass to Koramangala water tank.After seeing the video, police contacted Saunak, took a complaint from her, and nabbed two of the youngsters.

The arrested Jagannath, 26, a call centre employee, and Tejas, 23, a final-year BCom student, both residents

Seshadripuram. In her complaint to Madiwala police, Saunak stated that she, her husband Dr Subir Ghose, and their daughter were on their way to a restau-

tank. Saunak alleged that the youths also threatened her.

rant in Koramangala for dinner at the time of the incident. Subir was through Madiwala underpass around 9.10pm when the trio riding a scooter demanded that he stop the car. They allegedly hit the car's window, tried to open the door, and obstructed the family's way up to Koramangala water

In a panic, Saunak recorded the trio on her mobile phone and simultaneously called the police helpline. Her uploaded video shows that she had the windows closed while the youths were chasing

the car, and made the 112 call and explained the incidents live. However, before police

could reach the couple, the youths had stopped following them and had gone home. But cops, with the help of the scooter's registration number, detained the duo. During interrogation, the youths told police they were taking a right turn with indicator on when the person driving the car took a left turn without using indicator; the car is said have brushed against the scooter. When they shouted at the man to drive properly, he allegedly showed them the middle finger. Annoyed by the gesture, the youths followed the car.

They claimed they were initially unaware of Saunak and her daughter's presence in the car. After noticing them, they decided not to bother the family and left.

LG seeks time-bound revamp of heritage

New Delhi:

Lieutenant governor Vinai Kumar Saxena on Monday visited Van and Sanjay Mehrauli Archaeological Park to review the progress of the ongoing restoration and beautification work undertaken by Delhi Development Authority (DDA).

Raj Niwas officials said this was the LG's seventh visit since Feb last year to the two sites. In his last visit on March 4, the LG had directed DDA to start filling Anang Tal and Lalkot Baoli Qila Rai Pithora in Sanjay Van with water and to conserve and restore Balban's Tomb, Jamali Kamali Mosque and Rajon ki Baoli in Mehrauli Archaeological Park under the supervision Archaeological Survey of India (ASI). "These monuments

will be developed as

new public assets for

the capital and will



help Delhi emerge as a heritage city. Most of the works at both sites have been completed and are already drawing a huge footfall since Oct last year when the LG had inaugurated the renovated Mehrauli Archaeological Park," said a Raj Niwas offi-

The two sites were handed over to DDA by ASI, which is assisting in the protection of the monuments and their restoration. The Union culture ministry, too, had recently agreed that DDA will -use its resources to execute conservation works while ASI, with all its expertise, will supervise it.

Spread across around

200 acres, Mehrauli Archaeological Park is known to have more than 100 historical monuments ruins. The nearby Sanjay Van also houses several monuments, including Qila Rai Pithora, once the capital of Prithviraj Chauhan of the Tomar dynasty. At Sanjay Van, the LG visited the baolis (stepwells) and

directed the officials to ensure that the entire area must be protected and the drains and wells are restored. Spots were also identified where cultural programmes and events can be held.

While appreciating progress at Mehrauli Archaeological Park, the LG sought a timebound plan for restoration, preservation and encroachment removal.

The LG also directed the two agencies to preserve carved stones and relics that are scattered all over for a potential museum display. The LG had in Oct last year unveiled the restored Quli Khan's Tomb and Metcalfe's boathouse, a guest house, and a circular house, which is now running as a successful café alongside a rejuvenated water body.

Supreme Court blames Kerala for financial trouble

hardship is the creation of its own monetary mismanagement, Supreme Court Monday refused to grant interim relief to allow the state to borrow more money and referred its petition against Centre's decision to limit borrowing capacity of states to Constitution bench for adjudication. A bench of Justices Surya Kant and K V Viswanathan held that Kerala has failed to establish the three judicial prongs - proving a prima facie case, balance of convenience, and irreparable injury and the state was not entitled to the interim

injunction on borrowing cap. "If the state has essentially created hardship financial because of its own financial mismanagement, such hardship cannot be held to be an irreparable injury that would necessitate an interim relief against the Union. There is an arguable point that if we were to issue an interim mandatory injunction in such cases, it might set a

bad precedent in law that would enable the states to flout fiscal policies and still successfully claim additional borrowings," the bench said. The apex court also noted in its order that the state had already got substantial relief as the Centre agreed to release Rs 13,608 crore after the petition was filed. SC said several questions of significant importance impacting the Federal Structure of Governance arise for consideration and it should be adjudicated by a five-judge Constitution bench and framed four questions to be decided by the larger bench.

Bengaluru: The Rail Infrastructure Development Company (Karnataka) Ltd, or K-Ride, has advocated extending Bengaluru's four planned suburban rail corridors by around 120km to integrate them with the proposed 287km circular rail network — Nidavanda, Doddaballapur, Devanahalli, Malur, Heelalige, Hejjala, Solur, and back to Nidavanda of South Western Railway (SWR) on the city's outskirts.At present, K-Ride has a mandate for building 148km of rail corridor, and if the extension happens, it will add another 120km to the network. According to K-Ride officials, extending the railway network will benefit daily commuters from suburban areas and neighbouring districts. For instance, Corridor-3 from Whitefield could be stretched to Malur, while the same corridor could be lengthened from Kengeri to Hejjala on the western side.Corridor-2, an ongoing project between Byappanahalli and Chikkabanavara that is 20% complete, could link Nidavanda and Marikuppe. Corridor-4 from Heelalige to Rajanukunte could connect to Doddaballapur. "Bengaluru has operational rail tracks in six directions, and the suburban project will run parallel. Extending it to satellite towns will aid future commuters," said a Bengaluru Suburban Rail Project (BSRP) official. K-Ride argues the suburban rail is more cost-effective than the Namma Metro expansion proposed to nearby cities. "Last year, the railways turned down K-Ride's request for permission to conduct a feasibility study to extend BSRP to cities such as Mysuru, Tumakuru, and Chikkaballapur. Now, K-Ride has approached the railways to revisit its earlier decision and highlighted the need to link BSRP.

Ukraine: Try To Gaining International Support

These foreign visits were, on one level, part of various multilateral summits, but all these visits had one key goal: gaining international support for Ukraine in its war with Russia. Whether it was the visuals coming from inside the Canadian parliament or from Zelensky's visit to Washington, each of them contained a Ukrainian appeal for aid and material support besides their call to the global community to be on the 'bright side of history'. While Ukraine's top leader was shoring support for his cause across the world, India got nothing but a volley of attacks being launched by Ukrainian leaders, including their foreign minister, Kuleba, who is in India currently for a two-day visit. While responding to India, a developing country that was buying discounted oil to meet its energy needs, Kuleba said in August 2022, "When India purchases Russian crude oil (at a discount), they have to understand that the discount has to be paid by Ukrainian blood." Then again, after the G20 summit held in New Delhi, while reacting to India's hard work in securing a declaration at the end of the summit, Ukraine responded with a cold remark, saying "it is 'nothing to be proud of". In 2023, Ukraine crossed all limits when its presidential adviser, Mykhailo Podolyak, said India doesn't have an understanding of the modern world and is actually a country with 'weak intellectual potential'. Not just this, a senior Ukrainian lawmaker and head of the Ukrainian parliament's Foreign Affairs Committee, Oleksandr Merezhko, even called for sanctions against India for buying Ukrainian oil. Fast forward to March 2024, and Ukraine has suddenly changed its tune with regards to India. The visiting foreign minister, Dmytro Kuleba, has not only praised India as a global power that rightfully deserves a seat at the United Nations Security Council but also as an important 'global voice'. What can be the reason for this sudden change of heart if not Ukraine's own self-interest? Firstly, Kuleba is visiting India with a broader goal to mend bridges, deepen bilateral ties, and also place a request for humanitarian aid, but the most important agenda item is to secure India's presence at a high-level peace conference being organised by Switzerland based on Zelensky's peace formula in the next few months. Ironically, the same Ukraine, which failed to understand India's energy security needs as a developing country in procuring discounted oil from Russia at a time of volatile energy prices, is now requesting India to use its credentials in the 'global south' to support Ukraine at the peace table in Switzerland. In Kuleba's own words, "India can play a very important role in bringing together more nations from the Global South." He feels India's presence will attract more countries to join the Ukrainian cause. However, there is a catch.

First of all, India's stand on the Ukraine-Russia war has been consistent from the very beginning. India firmly believes that it is not an 'era of war' and the solution to the conflict will not come on the battlefield. New Delhi has also shown interest in mediating peace between the warring parties, with Foreign Minister S Jaishankar reiterating the same in an interview with the German economic daily Handelsblatt in February last month. However, despite its clear preference for an end to violence, India is highly unlikely to respond to any invitation, which may jeopardise India's strategic ties with Russia. Neither Russia itself is likely to join the peace conference in Switzerland, nor

is Ukraine genuinely interested in Russia's presence. This is because for Ukraine, this peace conference is more like

a show of strength. , and this is why it wants India.

Western countries have dominated the rest of the world for centuries

The West still dominates global institutions established after World War II. The Western countries are the richest, the most advanced in technology, the strongest militarily, and they control the international media. This gives them the tools to exert power over the non-Western world, intervene militarily to oust governments or even change the maps of countries, employ the tools of sanctions to coerce others to fall in line with their policies, intervene in the internal affairs of other countries on grounds of promotion of human rights, democracy and protection of minorities. The dominant Western powers have lost the capacity to introspect about the deficiencies in their own polities and societies, the glaring double standards that animate their external policies and the willingness to discard their "values based" foreign policies if they clash with their parochial national interests. Lately, of course, the challenge to the power of the West has grown. The biggest challenge has come from China, a country that Western capital built up on the assumption it could be co-opted in the West-dominated international system. China's huge store of cheap labour and its massive market drove the West's investment in China, trade with it and use of the country as an



export base. Its authoritarian government provided the assurance that they could do business and invest without having to worry about trade unions, rights of workers, strikes, questioning by local interests, and the like. It was a win-win formula which the Chinese now repeat on every occasion to promote cooperation with the West in the face of moves by Western governments to reduce over dependence on China. China's mercantilist policies, its unfair trade practices, forced technology transfers, the systematic control over critical raw materials and technologies that China has acquired through state controlled industrial policies has created a backlash. More than that, it is China's open challenge to the dominating power of the US in the international system that has led to the West seeking to "reshore" manufacturing, pursue "de-risking strategies", questioning globalisation so on, has not been limited and imposing restrictions on to what it calls "authoritari-

technology transfer to China, and so on. Relations between the West and Russia have collapsed over Ukraine although it was clear for some time that treating Russia as a security threat, seeking democratisation of Russia before it could be considered a worthy partner of the West, accusing it of human rights violations, promoting colour revolutions in Russia's periphery to instigate a similar revolution in Russia, portended a breakdown of the West's ties with Moscow. Unlike in the case of China, the West, led by the US has intervened in Russia's internal affairs, promoting select opposition leaders, as in the case of Navalny, to put pressure on President Putin internally. The West's international agenda of promoting democracy, protecting minorities, highlighting human rights violations, and markets, and

an" regimes. It is extended to even friendly democracies like India. Ever since Prime Minister Modi has come to power, even as the West has engaged India and built productive ties, it has not been able to shed its ingrained patronising habits of lecturing India, accusing it of violating human rights, democratic backsliding, persecution of minorities, and so on. This is largely done by the mainstream press, the think tanks and their associated journals, academics, NGOs, etc. At the official level, the US State Department in its annual report on human rights at the global level highlights violations of human rights in India. Other than this, quite often the State Department comments on sporadic incidents in India of communal tensions, rioting, and legislation seen as anti-minority such as the CAA, etc. The latest provocation comes from Germany which gratuitously commented on the arrest of Kejriwal by the ED, patronisingly asking for the standards relating to independence of judiciary and basic democratic principles to be applied to his case, and for him to get a fair and impartial trial and make use of all available legal avenues without restriction as well. This implies that all this may not be available in the normal course. This is a presumptuous statement that calls into question India's political and legal system. The Ministry of External Affairs (MEA) summoned the German Deputy Chief of Mission to lodge a strong protest which was made public. The US State Department then jumped into the fray by also patronisingly "encouraging" a fair and transparent trial of Kejriwal by India. This was in response to an emailed question, which suggested that the US was keen to quickly back its ally Germany, ignoring that India had already made public its strong displeasure to Germany for interfering in our judicial process etc.

The State Department showed scant regard for India's legitimate annoyance at Germany's unwarranted interference in our internal affairs.

If India had ignored the offensive remark by the US, it would have meant that we had one standard for Germany and another for the US, which is why for the same provocation a senior US diplomat was called in by the MEA for a protest. Surprisingly, the US State Department instead of backing off as Germany has done, doubled down on its earlier intrusive comment by not only calling for a fair and transparent trial of Kejriwal but also added the issue of hampering electioneering by the Congress party by the closure of its bank accounts.

Will China's fourth aircraft carrier challenge US naval dominance

NEW DELHI: China's ambitious expansion, marked by the construction of its fourth aircraft carrier, the Type 004, is poised to reshape the maritime balance of power in Asia and potentially challenge the US navy's dominance. According to Yuan, a key figure in the carrier's development, there have been no delays in its construction, with illustrations suggesting the vessel is being built at Shanghai's Jiangnan shipyard, a South China Morning Post report said.

Experts like Abdul Rahman Yaacob from the Lowy Institute speculate that if powered by nuclear energy, the Type 004 could wield advanced. power-intensive weaponry and operate at sea for extended periods without the need for replenishment.

This capability would enable the Chinese navy to project a formidable more presence in international waters, despite



China's limited regional military bases compared to the US's extensive network and alliances with countries such as Australia, South

Korea, and Japan. The potential nuclear propulsion of the Type 004 raises its strategic profile, making it comparable to the US's Nimitz-class carriers in terms of size and capability. Malcolm Davis of the Australian Strategic Policy Institute notes that while this development recalibrates regional power dynamics, the operafocus tional of Chinese carriers remains primarily on supporting joint landing operations target-

Chennai: Police protection cannot be ordered for people with criminal backgrounds, as it would affect the faith of common citizens in the existing system, Madras high court has said.

"Wherever the person seeking police protection has a criminal background, and such a threat perception is as a result of their own activities, this court should be very hesitant to grant police protection," Justice N Anand Venkatesh said.

The court passed the order while rejecting the application moved by K Venkatesh, OBC state secretary of Tamil Nadu BJP, seeking police pro-

During the course of the hearing, it came to light that Venkatesan is facing three criminal cases in Tamil Nadu and 49 cases in Andhra Pradesh in connection with red sanders smuggling.

He claimed that he and his family started receiving life threatening messages after the murder of his close relatives on August 17, 2023.

Refusing to entertain the plea, the court said: "There is yet another perspective, from which, these cases can be looked into. The order passed in this writ petition at least acts as a precedent in the State of Tamil Nadu."

Therefore, in the instant case, assuming that this court grants police protection to the petitioner, the order will be shown as a precedent in another case where a similar threat perception is encountered by another person with criminal background, the judge added.

Require more than one reserved seat, say TN tribal voices

Election fervour may be gripping the nation, but not for the tribal communities in the state, who continue to be politically marginalised alongside underrepresentation in education, basic rights, infrastructure, economic development, and healthcare. Tribal welfare groups and activists came together recently to address the persistent neglect of tribal concerns in political agendas.

"There are more than govt-recognised tribal communities in Tamil Nadu such as Aranadan, Adiyan, Eravallan, Irular, Kadar, and Kammara while many others are fighting for scheduled tribe status.

But we still don't have reservation for seats in the parliamentary general elections and have only one reserved seat legislative the election," assembly R Rajangam,

founder Empowerment Centre of Nomads and Tribes (TENT), Madurai.

"This seat is often passed to the Malaiyali tribe (hill tribes) because they are generally educated and seen as more wealthy." Activists say the reason other tribes do not get the opportunity to acquire the reserved seat is because education is a distant dream for many. "In all fairness, the Malaiyali tribes are educated, and we need an educated person from our community to voice concerns. However, our issues are never addressed because no one listen to the concerns of so many tribes," says R Maheshwari,

founder of TENT. The constituency allocations were reduced from 3% to 2%, citing that the population of tribals in TN is decreasing. But tribal rights

activists say the population is well over 10 lakh. "A census needs to be conducted to ensure equal opportunity in the coming elections," she says. What also appears to be a matter of concern on the bureaucratic side is that though there are people from scheduled caste communities who secure the posts of IAS officers through reservation, there is no representation from tribal communities. govt looks at issues facing the ST community from a broader lens and tries to provide us with jobs and housing. That is never enough, as each tribal community has different needs," says Shibu T, an advocate and social activist based in Kanyakumari. "In order to present the needs of each community, there should be representation from within the communities.

Will it be happy homecoming for Mumbai **Indians and Hardik Pandya?**

MUMBAI: Almost 22 years ago, a chilling act shocked the sporting world. When Luis Figo showed up in bitter rivals Real Madrid jersey to take a corner kick in an El Clasico clash at Barcelona's famed Camp Nou, a butchered head of a pig was hurled at him.

The severed skull laid near Figo's feet demonstrated the extreme hatred that Catalan team's fans had developed for the former Portuguese captain, who had, two years lback, chosen to be a 'Galactico' at a handsome paycheck of 44 million pounds.

While things are unlikely to go that level at the Wankhede here on Monday night, there could be resentment in the hearts of passionate Mumbai Indians fans when Hardik Pandya having replaced Rohit Sharma leads them out against Rajasthan Royals in one of most highlyanticipated IPL matches. Having been booed and heckled in the ground and trolled on social media ever since he replaced Rohit, who



led MI to a record five titles, Pandya is set to play the toughest match of his career. And what makes it worse for the India allrounder is the fact that despite Pandya taking over, Mumbai Indians have made their trademark slow start, losing both their away games so far, by six runs to the Gujarat Titans, followed by a 32-run loss to Sunrisers Hyderabad in Hyderabad. A few of Pandya's decisions, like opening the bowling himself and holding back Jasprit Bumrah in Powerplay, coming to bat as late as No 7 when the chase was getting tighter against GT, giving an

IPL debut to South Africa's 17-old left-arm pacer Kwena Maphaka, who went for 0-66 in four overs as SRH's marauding batsmen tore into him, have come underfire. Despite the barrage of negativity around him for the last month or so, Pandya, as Steve Smith recommended to him has "shut out external noise" and is unflustered. "What's appearing on social media doesn't bother him since he has avoided it completely of late. He wants his team too to be focused on cricket, rather than worry about him being booed in stadiums," a source told.

A match-winning performance with either bat or ball, or both, will help Pandya win back the love of his fans.

It remains to be seen if MI persist with Maphaka or English left-arm pacer Luke Wood comes back in. Will they hand an IPL debut to Sri Lankan import Nuwan Thushara? Additionally, will Mumbai left arm spinner Shams Mulani, finally getting match-time for Mumbai Indians, come to the party at his home ground?

For MI to get back to winning ways, it's vital that Rohit and Ishan Kishan find their mojo again. Like he has done in the last few IPL seasons, Rohit, who scored a 29-ball 43 vs GT and 12-ball 26 vs SRH, is showing a tendency to lose his wicket after an initial burst.

For someone who can be susceptible to left-arm pace early on,

Rohit needs to be guarded while playing RR's left-arm speed merchants Trent Boult and new recruit Nandre Burger, who has been impressive.
