Vatika Times DELHI: NEW Enforcement

Directorate produced Arvind Kejriwal before trial court for remand on Friday. This came after Kejriwal withdrew his petition filed against the arrest from the Supreme Court as it was clashing with the remand, advocate Abhishek Manu Singhvi appearing for Kejriwal said. During the ongoing hearing, ED told court that the Delhi CM demanded Rs 100 crore from some accused from 'South group' for Punjab elections.

ED is seeking ten day custody of Kejriwal in the case.

Referring to the previous arrests made by the ED in this case, it The Aam Aadmi Party



said to the court that Delhi chief minister Arvind Keiriwal was liable for role of his ministers. ED's arrest came hours after Delhi high court turned down Kejriwal's plea seeking protection from any coercive action by the agency, which had issued nine summonses to him to face questions arising from their investigation into the excise policy case.

AAP won't celebrate Holi, to gherao PM's residence in protest


(AAP) declared that they would abstain from celebrating Holi this year and instead organize a protest outside Prime Minister Narendra Modi's residence on March 26. Gopal Rai, the party's Delhi convenor, announced that AAP members would gather to protest against Arvind Kejriwal's arrest by the Enforcement Directorate (ED). Sunita Kejriwal, wife of chief minister Arvind Keiriwal, condemned his arrest on Friday, accusing Prime Minister Narendra Modi of acting out of arrogance of power. She labeled the arrest as a betrayal to the people of emphasizing Kejriwal's dedication to serving them, both in office and as a citizen. Referring to him as "Janardan," a protector of the people, she reiterated his commitment to the country and expressed solidarity with her husband's val-

'Violates secularism': High Court nixes Uttar Pradesh madrassa Act

LUCKNOW: Allahabad high court on Friday struck down as "unconstitutional" the Uttar Pradesh Board of Madrassa Education Act, 2004, on the ground that it violated the principles of secularism with its "scheme and purpose" of "only promoting and providing education of Islam", and allows degrees to be awarded in contravention of the UGC Act.

Justices Vivek Chaudhary and Subhash Vidyarthi's order upholding petitioner Anshuman Singh Rathore's contention that the legislation was "ultra vires" — Latin for beyond the powers — directly impacts 15.75 lakh students enrolled in 13,329 recognised madrassas in UP.The division bench directed the BJP-led state govt, which has been trying to integrate science and maths into madrassa education, to accommodate students of all such institutes in regular schools affiliated with the primary, high school and intermediate education boards."The state govt, for the said purpose, shall ensure that per requirement, sufficient number of additional seats are created and further, if required, sufficient number of new schools are established. The state govt shall also ensure that children between the ages of 6 to 14 years are not left without admission in duly recognised institutions," the order states. Board chairperson Iftikhar Ahmed Javed said it wasn't easy to accept that an Act governing madrassa education for 20 years had been suddenly declared unconstitutional. "Obviously, there has been some mistake somewhere. Our lawyers could not present their case properly before the court," he said.

'Preventive detention can't be misused for law & order issue'

NEW DELHI: Terming preventive detention a draconian provision, Supreme Court has held that govt's inability to tackle the law and order situation should not be an excuse to invoke it and any capricious or routine exercise of it must be nipped in the bud. A bench of Chief Justice Chandrachud Justices J B Pardiwala and Manoj Misra said preventive detention can be ordered only in case of public disorder and not for law and order problems. Differentiating between these two, the court said that distinction between them is one

of degree and extent

of the reach of the

act in question on

society. "It is the

potentiality of the act



to disturb the even tempo of life of the community which makes it prejudicial to the maintenance of the public order. If a contravention in its effect is confined only to a few individuals directly involved as distinct from a wide spectrum of public, it could raise the problem of law and order only," the bench said.

The court further said that habituality committing offence should not be the sole reason for invoking preventive detention.

"This court has time and again reiterated that in order to bring the activities of a perwithin expression of 'acting in any manner prejudicial to the maintenance of public order', the activities must be of such a nature that the ordinary laws cannot deal with them or prevent subversive activities affecting society. Inability on the part of the state's police machinery to tackle the law and order sit-

uation should not be

an excuse to invoke

the jurisdiction of preventive detention," it said, while coming down hard on Telangana govt for taking recourse to preventive detentions without the necessary justification. The court pulled up

Telangana govt for unnecessarily invoking preventive detention and warned the state not to do anything to force the court to observe further against it.

It said that the Advisory Board, set up under the Act and which is to approve preventive detention, should not act as a mere rubber-stamping authority and it must play an active role in ascertaining whether the detention is justified under the law or not.

30 little-known companies add Rs 300 crore to TMC kitty

KOLKATA: Over 30 little-known companies from Kolkata and two from outside West Bengal con-

tributed over Rs 300 crore to Trinamool Congress's kitty through electoral bonds, according to details submitted by SBI to the Election Commission of India. Some of these also funded other parties through electoral



bonds worth over Rs 90 crore. The list includes Transways Exim, Chennai Green Woods, Avees Trading and Finance, Prarambh Securities, Westwell Gases, Mishrilall Mines, SKP Merchants, OM Metals, Sengupta & Sengupta, Himalayan Endeavour, Ramesh Agarwal CS Bottling Plant, Sandeep Auto, Ashis Finance and Tivoli Park Apartments, among others. Some of these are operating companies, while the rest are investment firms. The largest among them is Chennai Green Woods, a Ramky Group company engaged in infrastructure development. It donated Rs 40 crore to TMC and Rs 15 crore to Congress. Transways Exim, headquartered in Kolkata and involved in the liquor business, paid Rs 19 crore to TMC and bought bonds for Congress too. Avees Trading and Finance, another Kolkata firm, donated a total of Rs 110 crore, of which Rs 46 crore went to TMC and Rs 53 crore to Congress. Ahmedabad-based Prarambh Securities paid Rs 38 crore to TMC and Rs 33 crore to BJP.



Islamic state claims responsibility for Moscow concert hall shooting that killed 40

NEW DELHI: The Islamic State group on Saturday claimed responsibility for the attack on Crocus City Hall, in Moscow. The attack resulted in the deaths of 40 individuals and left 145 injured.

According to AFP, the group in a statement on the Telegram messaging app said that IS fighters "attacked a large gathering... on the outskirts of the Russian capital Moscow."

According to Russian news sources, the gunmen hurled explosives, igniting a large fire at the hall capable of housing 6,000 people. Footage from outside captured the building engulfed in flames, while a sizable plume of smoke billowed into the night sky. The street was illuminated by the flashing blue lights of numerous fire

engines, ambulances,



and other emergency vehicles.

Emergency services reported that approximately 100 individuals were evacuated from the basement of a Moscow concert hall following a shooting and fire outbreak on Friday. Efforts are underway to assist others seeking refuge on the roof.

The spokesperson for President Russian Vladimir Putin stated that he is continuously being briefed on the assault at a concert hall near Moscow, which resulted in numerous casualties

Dmitry Peskov said, President is constantly being informed by all relevant about what is happening and the measures being taken."

International condemnation

White House spokesman John Kirby said, "The images are just horrible and just hard to watch and our thoughts obviously are going to be with the victims of this terrible, terrible shooting attack."

The German foreign ministry issued a state-

ment stating, "The images of the horrific attack on innocent people at Crocus City Hall near Moscow are horrific. The background must be clarified quickly. Our deepest condolences go out to the families of the victims." Mykhailo Podolyak, Ukranian presidential adviser denied Ukraine's involvement in the attack stating, "Let's be straight about this: Ukraine had absolutely nothing to do with these events.We have a full-scale, all-out war with the Russian regular army.

Cong questions timing of arrest, claims level playing field denied

New Delhi: Questioning the timing of chief minister Arvind Kejriwal's arrest in the excise policy-linked money laundering case, Delhi Congress chief Arvinder Singh Lovely on Friday said it was evident that the BJP did not want a level playing field in the upcoming Lok Sabha elections and was selectively targeting opposition parties. Talking to, Lovely said the Congress was standing "solidly" with Aam Aadmi Party at a time when it was facing a crisis and reaffirmed that the opposition INDIA alliance was "intact". "In which democratic country is the chief minister of a state arrested or accounts of a national party are frozen after elections already have announced? We used to hear such things happening in Pakistan but never dreamt that it would happen in India too," Lovely said. He, however, added that he was not going into the merits of the excise policy and if there was evidence, the courts should act.

Central Delhi under siege, AAP ministers among 80 detained

Delhi Friday Police on detained 80 protesters. including Delhi govt ministers Atishi Saurabh Bharadwaj, in central Delhi for protesting against the arrest of chief minister Arvind Kejriwal.

According to officers, they were taken to various police stations, including Alipur, Bawana, Jafarpur Kalan and Dwarka. "All of them were released later," police said.

More than 500 personnel from Delhi Police paramilatary forces were deployed across central Delhi. A senior officer said ITO, being a bustling intersection, experienced a significant influx of traffic regularly and precautionary security measures were implemented to prevent any congestion. DDU Marg, which has AAP's headquarters, was shut down and CrPC Section 144 was enforced, making it a no-protest zone. At least 150 people were removed from AAP's protest sites in central Delhi. "We also heightened



security along the court route to avoid any disruption," the officer said.

By 11.10am, a protest erupted at the ITO intersection and several AAP functionaries, including the Punjab education minister, were detained. A senior officer claimed that no force was used dur-

ing the action. At 12.10pm, AAP protesters moved to Bahadur Shah Zafar Marg, disrupting vehicular traffic. People were seen de-boarding buses and autos, and walking to their destination. However, the roads at ITO were cleared by the cops by 12.40pm. They also stationed buses at ITO to detain demonstrators if there was any protest on the road. Since Friday morning, police had erected barricades near the AAP headquarters along adjacent roads, ensuring strict control over entry and exit points to central Delhi. Security measures around the BJP headquarters were also heightened, heavy deployment of personnel and multiple layers of barricades surrounding the adjacent roads. Similar steps were taken near Enforcement Directorate's office. Police also used drones to monitor the situation. Around 1.45pm, Kejriwal, AAP's national convener, was taken Rouse Avenue Court. New Delhi: While CM Arvind Kejriwal will be subjected to restrictions while in the cus-Enforcement Directorate, working as CM could ease for him if he is sent to Tihar Jail in judicial remand provided the court allows him certain privileges.

While the rulebook doesn't say anything specific about a CM discharging duty from jail, sources in different establishments said it was entirely up to the court and the lieutenant governor to make this possible.

Prison officials recalled the case of Subroto Roy, chief of Sahara group, who was allowed by the Supreme Court to run a full-fledged office from jail via a "special facility", including an internet connection, video conferencing and visitors between 10am and 4pm under police supervision. These allowed Roy to negoti-



ate sales and raise Rs 10,000 crore, but they cost him Rs 31 lakh for two months. Kejriwal might not need an elaborate setup as he does not hold a ministerial portfolio, opined an official. However, without a court order, things will not be so easy. As former law officer in pointed out, "The jail manual states that you can meet your family, friends or associates only twice a week. It will not be easy for Kejriwal to govern under such restrictions." Officials, however, said there wasn't much clarity on the matter because of lack

AAP worried about CM Arvind **Kejriwal's security in ED** custody: Delhi minister Atishi

NEW DELHI: Delhi's cabinet minister Atishi expressed concern on Friday about the safety of Chief Minister Arvind Kejriwal as he remains in ED custody under Z+ security.

Kejriwal was arrested by the Enforcement Directorate (ED) on Thursday in relation to a money laundering case linked to the excise policy.

Atishi said that this is the first instance in India's democratic history where a national party leader has been detained before the Lok Sabha elections.

ED has not been able to produce a single evidence. This shows how fearful the BJP is of Arvind Kejriwal," she charged.

"They know that only one leader can chal-



lenge them which is is why they are making every attempt to trample Arvind Kejriwal and AAP," the minister added.

She stressed that "Arvind Kejriwal is an ideology, an inspiration".

"He left his Income Tax job to take to the streets to save democracy. You have arrested him to stop him from campaigning in the Lok Sabha polls. Many Kejriwals will emerge

to save the democracy," she said.

She raised concerns about Kejriwal's safety in ED custody, questioning the responsibility for his security and criticizing the alleged political conspiracy by the BJP against opposition leaders.

"Being the Chief Minister of Delhi, Kejriwal is given Z+ security. Now he is in ED custody. Who will be responsible for

Kejriwal's safety? Who is entering his lock-up in the ED office? The Centre has to answer about his security arrangements there, she said.

She accused the BJP of hatching a "political conspiracy" against Kejriwal and the opposition leaders.

"If leaders facing corruption allegations join BJP, their cases are not investigated. Hemant Soren is arrested and Congress accounts are frozen. This is an attempt to affect elections," the minister said.

"Whatever conspiracy you are hatching against opposition and AAP, the people of Delhi, Punjab and this country will give you a befitting reply," she added.

Why young Indian students are being targeted in America

Why are so many young Indian students in their early twenties dying in the US? The tally is nine so far in the three months of 2024 alone. Is it an outbreak of racism extended to the brown Indian student? Are they guite thoroughly unwelcome in America? If so, why do their Indian parents send them there in droves and at enormous expense? The expatriate Indian student community is the largest in the US and bigger than that of the Chinese. Generally, it is the American, Caribbean and African people who are subjected to murderous racist attacks. The Black Lives Matter movement is a testament to the fact that rampant racism involving some institutions and police departments persists in America. To prevent violent attacks against Indian students and other Indians, the current Biden administration has provided security, both on and off campus, and in the community at large. But do some Indian students put themselves in harm's way by flouting cautionary advisories on dangerous areas? Four Indian students have been killed in two weeks according to a news report datelined 2 February 2024. They were 19-year-old Shreyas Reddy Benigher from the Linder School of Business, Ohio, Neil Acharya of Purdue University, Vivek Saini from Panchkula in Haryana. The latest is Sameer Kamath, an Indian-American pursuing his doctorate in mechanical engineering at Purdue University again. In addition, Akul Dhawan was found dead of hypothermia outside the University of Illinois UIUC in Champaign. G Dinesh of Telangana and Nikesh of Andhra Pradesh were found gassed to death in their flat in Connecticut. Kuchipudi and Bharat Natyam dancer Amarnath Ghosh, age 34, was shot to death in St Louis Missouri. Paruchuri Abhijit of Boston University was found dead in his car, making up the ninth death so far in 2024. There is at least one death of an Indian every day across the US, says an American community leader Mohan Nannapaneni, founder of volunteer-based non-profit organisation TEAM Aid. These are mostly students and H-1B employees who have recently come to America. Are some Indian students lonely and feeling alienated far from home? Do some of them, unable to fit in socially or cope academically, persist in their studies there due to societal and parental pressures emanating from back in India? Though more often than not, Indian students who go to American universities are exceptionally bright and are there on earned scholarships. But are they mature and experienced enough in the Western cultural mores and milieu to avoid bullving and ridicule? Sometimes, there are underlying mental health issues even amongst gifted students which are activated by the pressures of academics and fitting in. Some die of physical illness and natural causes. Perhaps the lack of seeking timely medical attention in an alien medical system is to blame. Again, this is a phenomenon that affects foreign students even here in India, because many tend to neglect themselves in the absence of relatives to keep an eye on them. In January 2024, a young girl graduate student Jaahnvi Kandula was run over by a speeding policeman Officer Kevin Dave in a police car at a street intersection crosswalk in Seattle. To compound matters, the manslaughter caused by the police car being driven at 119 kmph was laughed off by another Seattle Police Officer Daniel Auderer, who said Kandula's life had 'limited value'. He dismissed the proposition that officer Dave was at fault and that a criminal investigation

Pushpak Viman: affordable space exploration

ISRO's Pushpak Viman is India's first Reusable Launch Vehicle. Image courtesy ISRO India's Re-usable Launch Vehicle (RLV) Pushpak Viman made another experimental flight (RLV LEX 02) this morning from Chalakere Runway. The car-sized winged rocket sometimes dubbed the "swadeshi space shuttle" is India's bold attempt to enter the reusable rocket segment. The current flight test is the third of its autonomous landing ability in more complicatcircumstances. Pushpak launch vehicle is India's bold attempt to make access to space most affordable," said S Somanath, chairman of the Indian Space Research Organisation (ISRO). **Pushpak Viman RLV**

The "Pushpak Viman" is India's legendary spaceship named in the Ramayana, known to be the vehicle of the Lord of Wealth, God Kuber. Therefore, it is decided to name India's most audacious spacecraft 21st-century Pushpak. The 6.5-metre aeroplane-like spacecraft weighs 1.75 tonnes. The most expensive part, the upper stage, houses all the important electronics and is made reusable by bringing it back safely back to Earth. For the flight test, the craft was hoisted aboard an Indian Air Force (IAF) helicopter. During the descent or glide phase, small thrusters help the vehicle navigate to the exact spot where it is sup-



posed to land. India thought of building its

version of the space shuttle nearly 15 years ago. Ten years ago, a dedicated team of engineers and scientists plunged into making RLV a reality. The RLV flew first time from Sriharikota in 2016 and successfully landed on a virtual runway in the Bay of Bengal. The RLV then sank into the sea as per plan and was not recovered. A second test was in April 2023, at the Chitradurga Aeronautical Test Range (ATR). Called the RLV-LEX-01, the winged rocket was taken up under-slung to an altitude by an IAF Chinook helicopter and then released. It thereafter glided and landed autonomously. The test was fully successful. ISRO's objective is to fly a

vehicle that is more costeffective and provides very low-cost access to space. The long-term operational goals

would include positioning satellites in space and supporting their repair and refuelling in orbit. It would be used to retrieve satellites from orbit for refurbishment. It would also be used to reduce space debris. It is expected that in times to come, it could be a money spinner for India when it becomes a commercially available launcher.

India's Aeronautical Test

The Aeronautical Test Range (ATR), is an outdoor testing and evaluation facility set up by DRDO exclusively for unmanned and manned aircraft. The ATR is managed by Aeronautical Development Establishment (ADE). It is located at Varavoo Kaval in Challakere Taluk of Chitradurga district on a 4,290-acre plot. The rocket boosters were jettisoned before the vehicle reached orbit, while the main engines continued to operate, and the external tank was jettisoned after the main engine cutoff and just before orbit insertion. Thereafter, the orbiter's two Orbital Maneuvering System (OMS) engines were used. At the end of the mission, the OMS supported deorbit and reentry into the atmosphere. During the reentry, the orbiter was protected by its thermal protection tiles. It then glided as a spaceplane to a runway landing, usually to the Shuttle landing facility at KSC, Florida, or to Rogers Dry Lake in Edwards Air Force

Curious case of the 'missing' East-West Metro passengers in Kolkata

Kolkata: A curious case of passenger mismatch has emerged underground with Metro Railway officials noticing a significant disparity in the number of people buying tickets to ride in the East-West Metro and the actual riders on lits trains. That is because thousands entering through Howrah Maidan for joyrides are buying single journey tickets but taking multiple rides without disembarking from the train.

Officials said even if the registered ridership on Day One was 70,204, the actual number of rides could have been well past a lakh. Saturday, an ideal weekend for joyrides on Metro, the actual passenger count must have been around 80,000 and not 67,240," mused an official. A train on the Esplanade-Howrah Maidan line takes the same tunnel (either the Sector V-bound or the Howrah-bound) returning from Esplanade to Howrah Maidan because there is no crossover for switching tracks at Esplanade. "The passengers from Howrah Maidan or Howrah Metro station continue to sit in the train after it reaches Esplanade and halts for a few minutes. Then they return to Howrah

Noting the submissions of public prosecutor Yogita Kaushik Dahiya, the court said it was proved that Kumar chatted with the minor after creating a fake identity, made sexually coloured remarks, and contacted or followed her online despite the girl's clear disinterest.

Delhi govt decides to extend excise policy again by one more year

NEW DELHI: Delhi govt has decided to extend the current excise policy for one more year. The excise dutybased policy regime, which transferred the retail liquor business from private entities to govt-run corporations, was implemented in Sep 2022 and was extended twice after that, in Apr 2023 and again in Oct 2023. A senior Delhi govt official said there

was no immediate need to make any changes in the excise policy at this stage when several provisions of the Delhi Excise Policy 2021-22 were under the scanner of investigating agencies. Implemented in Nov 2022, the Excise Policy of 2021-22 was touted as a progressive one but it had to be scrapped after Central Bureau of Investigation (CBI) registered a case against alleged irregularities in its formulation and imple-



mentation. The excise department on Saturday issued an order saying that the competent authority had granted its approvalto extend the policy for the year 2024-25 for granting the wholesale licences. Sources said asimilar order for the retail licences will be issued soon. Under the current policy regime, there are 684 liquor vends in the capital run by Delhi Tourism and Transportation **Development Corporation (DTTDC)**

JNU teachers condemn 'disruption' of lectures

NEW Jawaharlal Nehru University Teachers' (JNUTA) Association on Monday strongly condemned the alleged disruption caused during the lectures of Nivedita Menon at Gangadhar Meher University and Sambalpur University in Odisha. "The disruption and intimidation of Menon by anti-academic elements is a grave

assault on academic freedom," JNUTA stated, adding that "it is extremely worrying that attendees were forced to leave, depriving them of the opportunity for dialogue and exchange of ideas." The teachers' association further demanded police action against the perpetrators and urged the two universities to issue strong statements over the incidents.

Job fraud haunts OPT students in the US

sultancies are cheating Indian students — those on F1 visa in the United States — of their hardearned money, in the name of jobs. According to some, students who are on Optional Practical Training (OPT) or Curricular Practical Training (CPT) are being made to cough up \$500 to \$700, or even more, under the pretext of getting a job. However, there's no trace of any employment once the fee is paid. Gaming Students on F1 visa have two options - CPT and OPT, to gain practical training. Social networking platforms are flooded with such posts, warning students against this scam. "I lost USD 600 to one such company. They promised to provide training and refund the money once I get placed," said an MS student adding that the company did not do anything except forwarding his profile to a few consultancies. "When I asked for a refund, they stopped responding to my messages and calls," added the student. Another computer science student, who is on OPT, said: "I paid \$600 as I was assured of training and placement within two months. But nei-

placed. I lost my money."Some, however, got lucky - thanks to these online posts. "I had recently submitted my profile and recently I got an email to deposit \$700. But, I chose not to pay the money," the student said, adding how it was because he'd seen posts about it. "As an international student, we are often filled with fear, anxiety, and a sense of urgency leading us to take steps that could cost big bucks. NEW DELHI: A 36-year-old astrologer has alleged that she was sexually assaulted by a man on the

pretext of a property deal in south Delhi. A non-bailable warrant has been issued against the suspect and raids are on at different places to arrest him. The woman, in her complaint filed last month, stated that her family is known to



the accused's family. "In Jan, she contacted the 40-year-old suspect regarding the sale of a property of someone she knew. He then visited the woman's house and assured her that he could help in selling the property," a police officer said. The suspect claimed to be a property dealer, which is being investigated. The suspect learned that the woman was an astrologer. He then gained her trust by calling her under the pretence of wanting to learn more about astrology. One day, he contacted the woman and took her to his friend's house in Neb Sarai, apparently to finalise the property deal. "The woman claimed that he mixed something in her drink and then sexually assaulted her," the officer said. A case under sections of 328 (causing hurt by means of poison, etc., with intent to commit an offence), 376 (sexual assault) and 506 (criminal intimidation) of IPC was registered. New textbooks for all classes in 2024-25 are "highly unlikely". Based on the new national curriculum framework, the council is creating new school textbooks. Officials acquainted with the subject say new textbooks for numerous classes, including 10 and 12, are unlikely before the new school year."Textbook drafting is



meticulous and cannot be rushed. All mistakes must be avoided. This year, the NCERT may publish textbooks for various primary classes including class 9. A senior NCERT official stated, asking anonymity, that textbooks with rationalized curriculum will continue in other courses in 2024-25. The council told the CBSE in its previous curriculum committee meeting that the new 9-12 textbooks will not be released this year. "The board must release class 10 and 12 sample papers before a new session. In its last curriculum

committee meeting, the board decided to continue with the NCERT syllabus with a condition that it may be reviewed if the NCERT delivers books of classes 9 to 12 before April 2024, a senior CBSE official said. on insisting on production via videoconferencing," a senior cop said.Prohibitory orders under Section 144 of CrPC may be imposed in different areas of the city on Friday.

Apart from police personnel from north Delhi, reserved forces and the Rapid Action Force were deployed at the Flagstaff Road residence of Kejriwal soon after ED sleuths landed there with a search Barricades warrant. were also put up on the lane leading to the chief minister's official residence in north Delhi.

As soon as the news of the arrest came out, workers started protesting on the road. Cops swung into action and started removing and detaining them. They were sent to different police stations in north Delhi.

The Special Branch is learnt to be keeping a close tab on the chatter pertaining to demonstrations, etc, officials said.
