Hathras stampede key accused Madhukar surrenders

NEW DELHI: The key accused of the Hathras stampede, Devprakash Madhukar, surrendered on Friday and has been taken into custody by the Uttar Pradesh Police. Madhukar was the main organiser of the 'satsang' (religious prayer meet) where a stampede claimed the lives of 121 people.

Madhukar's lawyer, AP Singh claimed that Madhukar surrendered to the Delhi Police in Naiafgarh and following his surrender, the Delhi Police handed him over to the UP Police.

Earlier, Uttar Pradesh police had announced a Rs 1 lakh bounty on Madhukar. The state government agencies had launched intensive searches across the state and in neighbouring Rajasthan and Haryana to trace the Hathras stampede key

Imran Khan to go on hunger strike over lack of confidence in chief justice

ISLAMABAD: Pakistan's jailed former prime minister Imran Khan has threatened to go on hunger strike over his lack of confidence in the Chief Justice of Pakistan, Justice Qazi Faez Isa, and if the ill-treatment meted out to him in prison continues, said Pakistan Tehreek-i-Insaf (PTI) politicians who met him in Rawalpindi's Adiala jail on Friday. Speaking to media after meeting Khan, the PTI politicians warned that if the injustice continues the party's founder will go on hunger strike. "If the party's founder goes on a hunger strike in jail, it will trigger a nationwide hunger strike," said Shamim Naqvi, a PTI politician from Karachi.

Imran cited ongoing concerns over Justice Isa's involvement in benches handling PTI cases and his personal cases. He emphasised the concerns expressed by his legal team about the CJ's infrequent attendance, reflecting a growing sentiment in his camp that justice might not be administered fairly in these circumstances.

Imran also expressed disappointment over a cancelled meeting with his legal and political teams. The superintendent, allegedly at the request of a jailed colonel, denied Khan's team access, citing operational reasons."They (Pakistan's powerful military authorities) are mistaken; they think my party will weaken. They don't realize that the party with the strongest voter base remains strong," Imran said while asserting his party's resilience. 

Trump dares Biden for a no holds barred debate to prove


Biden prepares to put up a brave front and convince his supporters in a TV interview with ABC on Friday evening (local time), former President Donald Trump has issued a new debate challenge, unlike the previous format, which the ex-president claimed would test Biden's competence. Trump, who got the better of Biden in their first debate, proposed a debate with no rules and no moderators. In a post on Truth Social on Thursday, Trump, 78, called for a "no holds barred" debate to let Biden, 81, prove his "competence or lack thereof." He suggested a direct, unmoderated dis-



cussion, claiming it would "blow everything away" and attract higher ratings than their previous debate, which drew 47.9 million viewers.

Buffalo follows its owner home, resolves ownership dispute!

Prayagraj: To resolve the dispute over ownership of a buffalo, the Pratapgarh cops used an age-old method of leaving the decision to the bovine itself after several hours of panchayat failed to decide the issue. Police handed over the buffalo to its owner after it followed him on being left on the road unattended. The other claimant was reprimanded by both police and villagers.

The case involved Nandlal Saroj, a resident of Rai Askaranpur village under Maheshganj police station of Pratapgarh district. His buffalo went missing some days back and strayed to Purey Harikesh village where one Hanuman Saroj allegedly caught hold of it. Hanuman refused to hand over the buffalo to Nandlal who finally traced the animal after a frantic search for three days. Nandlal then approached the cops at Maheshganj police station and lodged a complaint against Hanuman Saroj. Cops called both the claimants to police station on Thursday. However, despite a panchayat over the issue held for several hours, both of them kept claiming the buffalo to be theirs.

SHO of Maheshganj police station Shravan Kumar Singh then devised a way out to resolve the dispute. Singh announced before the panchayat that the decision should be left on the buffalo itself. The buffalo will be left on the road alone, and the person whom it will follow will be declared its owner. The villagers also agreed to the decision and both Nandlal and Hanuman were asked to stand in opposite directions on the route to

Cops then released the buffalo from the police station, and it took the route straightaway to Rai Askaranpur village following Nandlal. As per the decision, the buffalo was handed over to Nandlal. Hanuman Saroj who was still objecting to the decision was admonished by both cops and villagers. SHO Shravan Kumar Singh said acting on the complaint, an investigation was carried out. The buffalo itself returned to its owner, he added.

Arrest of ex-principal demanded in paper leak case

Prayagraj: The paper of RO/ARO examination conducted by the Public Service Commission was distributed by the same accused Arpit Vineet Jaswant, who was arrested from Bishop Johnson Girls School, Mission Road. At his behest, the post of Principal was assigned to Parul Solomon for his personal gain without any management approval and without any advertisement, with the aim of ensuring ARO/RO papers could be leaked. Making the above allegations, Michael Daniel, national president of the Masihi Jagriti Manch who held a meeting in Rajpur, has demanded an investigation from the Chief Minister of the state. In the meeting, he demanded the arrest of former school principal Parul Solomon, the alleged real mastermind of the ARO/RO paper leak episode.

Anger among traders over non-disclosure of robbery incident

Bishop Dan hands over memo to Police Commissioner, levels serious allegations against evicted principal

UP Board's compartment/ improvement exams on July 20

Prayagraj: The officials Uttar Pradesh Madhyamik Shiksha Parishad, commonly known as UP Board, will conduct compartment/improvement examinations of students who had appeared in High School and Intermediate Examinations-2024, on July 20. The High School improvement or compartment exam would be held from 8am to 11.15am and in the second shift, the exams for intermediate students would be held from 2pm to 5.15pm,

said UP Board officials. Secretary, UP Board, Bhagwati Singh said the exams for both the classes will be held at all the district headquarters at the examination centres determined by the District Inspectors of Schools (DIoSs) concerned. The DIoSs will ensure all the requisite arrangements at the examination centres, he added. It is

worth mentioning that a total of 44,357 students are registered to appear in the compartment/improvement examinations, including 20,729 students of high school and 23,628 students of intermediate compartment exam. Applications for the compartment/improvement examinations were accepted by the board till May 31.

UP Board secretary Shukla further said that the centre administrators will ensure that unnecessary crowd of examinees do not collect at the entrance gates of the examination centres. Likewise, similar arrangements should be made after the completion of the examination.

Candidates are strictly prohibited from carrying any electronic device inside the examination hall. Officials will also ensure that CCTV cameras equipped with voice recorder and routers etc are fully installed in the classrooms during the examination period, UP Board officials shared. The overall arrangements, from storing of the question papers to taking them to the examination centres, will be carried out strictly as per the prescribed steps like the one followed during the main examination. The strong room will be under CCTV surveillance with 24X7 working voice recorders, they said.

The candidates concerned must reach the examination centre at least 45 minutes before the commencement of the examination on the prescribed date by getting their admit cards downloaded www.upmsp.edu.in or by contacting the registered school and getting their admit cards countersigned by the principal of their school, officials explained.

A younger lot: On the **French Open**

For nearly two decades, a champion other than Rafael Nadal at Roland-Garros has been as elusive as a shadow at high noon on solar equinox. Ever since he made his debut in 2005, the legendary Spaniard has won the event a record 14 times. losing just three of his 115 matches. The occasional uprisings against his ironclad rule, mainly from Novak Djokovic, were crushed with characteristic menace; Nadal leads the Serb 8-2 on Parisian clay. French Open 2023, however, is set to herald a shift, for Nadal will miss the event for the first time since 2004 because of the hip injury that has kept him out since January. There are signs that a change of guard is in the offing in men's tennis in general. With Roger Federer retired and Djokovic out of form, the once vice-like hold of the 'Big Three' is at its weakest. Djokovic is a two-time champion and will be motivated to break the tie with Nadal on 22 Majors. But Carlos Alcaraz, the reigning World No.1 and winner of the French Open tune-up events in Barcelona and Madrid, seems primed to occupy centre stage. The 20-year-old has already established his Slam-winning credentials (2022 US Open), and a follow-up act will only embellish his status as the game's chosen one. Challenging him will be the Scandinavian duo of No.4 Casper Ruud, who lost the 2022 summit clash to Nadal, and No.6 Holger Rune, finalist at both Monte Carlo and Rome recently. Daniil Medvedev has developed a newfound love for the red dirt following his success in Rome last week, but the Russian No.2 is at best a wild card, alongside Stefanos Tsitsipas, Andrey Rubley, Jannik Sinner, and Alexander Zverey. In contrast — and in a departure from the past — it is the women's field that wears a settled look, with Iga Swiatek, Aryna Sabalenka, and Elena Rybakina forming a dominant troika. They have swept the last four Majors and the Roland-Garros preparatory tournaments Stuttgart, Madrid and Rome. If anything, Swiatek is just the first among equals, by virtue of being the World No.1.

Studios claim ownership of rights

It was since foreign companies entered the Indian film market that filmmakers in the country, espe-

cially in the Hindi film industry, took huge strides. Films with budgets in lakhs suddenly started costing crores. With projects being underwritten by bigtime backers, the films with stars



started costing over Rs 100 crore. Actors wanted to be paid in crores and so did the director. Soon, the stars started asking for Rs 100 crore or more and the ones with just a single success wanted Rs 10-15 crore. Female artistes started demanding in crores, even though their films, at best, collected Rs 5 crore or less in lifetime business. Somewhere along the line, the filmmaking happened with no sense of the economics. The prices the stars demanded were artificial, much against their draw or potential to recoup. This continued for a long time because the companies which backed these films opened their purse strings generously. The producer had nothing to lose and stood only to gain. Nobody cared for what a star charged or a director did. Ridiculous budgets were presented and sanctioned by the new corporate entrants who were under the impression that they were producing films when, in fact, they were actually outsourcing the film production activities.

Everyone benefits from the Lok Sabha election

Everyone benefits from the 2024 Lok Sabha election.



Though unhappy by its drop from 303 seats in 2019 to 240 this time, the ruling Bharatiya Janata Party (BJP) is relieved to have won three consecutive terms for the first time in over 60 years. Congress-led Opposition's 2024 numbers may be lower than the BJP's, but it seems to have found a weakness in Prime Minister Narendra Modi. After three general elections in a succession of two-digit votes, the Congress under Rahul Gandhi had its third-worst Lok Sabha performance, but its supporters are celebrating keeping the BJP below 272. Same with their supporters: Hindu BJP voters are thrilled that their party is back in power, but Muslim voters believe

they have returned their

'veto power' in Indian poli-The Congress-led Opposition may be celebrating, but the BJP should be relieved. After all, it realized the party is in trouble without losing power in Raisina Hill. The party has five years to clean up. A vote where everyone has something to be thrilled about makes it easier to misread the outcome, which is the BJP's problem. First, the BJP should view the Lok Sabha results with cautious optimism, as three consecutive terms are exceptional. The Modi government has defeated antiincumbency and the postpandemic tendency of Covid-19 being a graveyard for ruling dispensations globally. Most incumbents have failed to recover from the enormous coronavirus outbreak. Taking the wrong medication is more dangerous for the BJP than not taking any cor-

Unfortunately, politicians' egoistic tendency to blame voters rather than party leadership for recent political defeats makes the latter more likely. One can understand how Uttar Pradesh voters, especially Ayodhya, were villainized after the poll. Dubious political commentators have already given their verdict, exposing Hindutva's declining returns in Indian politics! Such feel-good, partdubious analysis should not be accepted by the BJP. The party may also view the results as localized and onetime. Localized because while losing approximately 50% of seats in Uttar Pradesh, the party swept Madhya Pradesh. Uttar Pradesh, unlike Madhya Pradesh, has a viable opposition with a strong M-Y votebank for anyone who can defeat the BJP. The

Opposition troubled the BJP wherever it had a party infrastructure, albeit a basic one, and vote-banks, whether in Uttar Pradesh Maharashtra. Naturally, the Opposition distributed tickets smartly, notably in Uttar Pradesh, where Akhilesh Yadav generously offered SP tickets to Dalits and OBCs and less than 10 seats to M-Y candidates! In contrast, the BJP had ticket distribution troubles. Misfits, incompetent, and corrupt candidates were common, as were imports from other parties. This sparked party discontent and heartburn. The Ayodhya BJP candidate was unpopular before the election, and he was on sticky ground. Of course, his loose statements on reserves and the Constitution made matters worse for himself and the party. Ideological fluidity in the BJP compounded its

problems. A party that earns 18-20% of votes for being a Hindutva vehicle is bound to boomerang when its national president publicly distances itself from "bhagwa" during the election campaign. In an interview with a Delhi daily, JP Nadda said the "BJP and bhagwa (saffron) are not synonymous" and that the BJP might win the 2024 elections.8 without the RSS! He overlooked that when a Hindu doesn't see himself as a Hindu, he's tempted to adopt caste identities. The BJP must realize that any ideological compromise has led to political hara-kiri. In 1984, the BJP, fresh from the Jana Sangh, burned its fingers by openly supporting Gandhian socialism and won only two Lok Sabha seats. When the Jinnah-fied BJP downplayed its Hindutva identity in 2004 and 2009, the party suffered

Mob and justice: On the Alwar lynching case verdict

The thin line between culpable homicide and murder under Indian penal law is a subject of endless analysis, but it is not easy to accept this nuanced distinction in a case of mob lynching. A Sessions Court in Alwar district of Rajasthan has sentenced four men to a prison term of seven years for the lynching of a Muslim dairy farmer in July 2018. However, it acquitted Naval Kishore, a Vishwa Hindu Parishad functionary, for want of sufficient evidence. If one recalls the acquittal of all those tried for the 2017 murder of Pehlu Khan,

who was also a victim of successfully prosecuting cow vigilantism, there is a semblance of justice for Rakbar Khan, 31, who was attacked by a mob while transporting two cows along with a friend near Lalawandi village in Alwar. The police had found Rakbar Khan with serious injuries, to which he succumbed later, presumably due to the delay in taking him for medical treatment. If one takes into account the number of attacks, some of them fatal, involving so-called cow protection gangs in various States in recent years, the record of the criminal justice system in

those involved in such incidents is quite dismal. In this backdrop, the fact that the police in Alwar managed to obtain a conviction is noteworthy. However, that the assailants were found guilty only of culpable homicide not amounting to murder and wrongful restraint does raise some concern. A conviction for murder would at least life entailed imprisonment.

Rakbar Khan's family is justly aggrieved both over the acquittal of one suspect, who they believe was the main year prison term. The police relied on some teleconversations between the acquitted VHP leader and the assailants to rope him in as a key suspect. However, the

court did not consider this adequate proof. While deciding that the fatal attack did not amount to murder, the trial court has concluded assailants neither intended to cause death nor knew that their assault may cause death. The prosecution is likely to take up both the "inadequate" sentence awarded

accused, and the seven- to the four and the acquittal of one on appeal. Organised cow vigilantism poses a major threat to the safety and security of minorities, as well as to the maintenance of the rule of law.

> Despite the Supreme Court deprecating the bigotry and hate propaganda that underlie such activities, incidents of sectarian violence and vigilantism seem to go on. Both preventive and punitive measures are needed to arrest the trend, and one cannot emphasise enough the need for efficient investigation and prosecu-



Non-recovery of cash not prima facie proof no graft took place: HC on Sisodia

NEW DELHI: Non-recovery of ill-gotten money can't be prima facie proof that no corruption has taken place because a person now uses new technologies to commit offences without leaving behind any trace, Delhi high court has observed, while denying bail to AAP's Manish Sisodia in the city excise policy case. In its order pronounced Tuesday and uploaded Wednesday, HC said "recovery of cash from a person may not necessarily be a mandatory requirement in a money laundering case where allegations are part of a conspiracy comprising multiple accused." 

Although there may be more rain, some forecasts expect powerful bursts with dry spells in between. The IMD expects the monsoon to reach Kerala by May 31, with a four-day delay.
