Key recommendations of Kovind panel on 'one nation, one election'

NEW DELHI: A highlevel committee headed by former President Ram Nath Kovind on Thursday submitted the 'One Nation One Election' report to President Droupadi Murmu recommending simultaneous elections for Lok Sabha and state assemblies as the first step.The panel in its report, spanning over 18,000 pages, said that simultaneous polls will spur development and social cohesion, deepen "foundations of democratic rubric" and help realise the aspirations of "India, that is Bharat".

Following this, all general elections for the Lok Sabha and state legislative assemblies would be held simultaneously. An Implementation Group is proposed to oversee the execution of the committee's recommendations.

SBI submits all electoral bonds details to Election Commission of India

NEW DELHI: The State Bank of India (SBI) on Tuesday submitted all data related to electoral bonds to the Election Commission of India (ECI) in compliance with the strict Supreme Court regarding the matter.

"In compliance of Supreme Court's directions to the SBI, contained in its order dated Feb 15 & March 11, 2024 (in the matter of WPC NO.880 of 2017), data on electoral bonds has been supplied by State Bank of India to Election Commission of India, today, March 12, 2024," the spokesperson for the poll panel said on X.

The top court had ordered the central bank to furnish all details to the ECI by 5pm on Tuesday.

Election Commission of India is expected to upload the data on its website by March 15 for public view in accordance with the SC's order.

Dismissing the SBI's application seeking time till June 30 to reveal electoral bond details to EC, the fivejudge SC bench - headed by CJI Chandrachud

The apex court was hearing the application filed by SBI seeking extension till June 30 to disclose details of each electoral bond encashed by political parties before the scheme was scrapped last month.

During the hearing, the bench took note of the submissions of senior advocate Harish Salve, appearing for the SBI, that more time was needed for collating the details and matching them as the information was kept in two different silos with its branches. He said if the matching exercise was to be done away with, the SBI could complete the exercise within three weeks.

The bench said it had not directed the bank to match the details of donors and donee with other information.

Mamata Banerjee suffers injuries after fall at home, gets 4 stitches, discharged



KOLKATA: Mamata Banerjee suffered a deep gash on her forehead, a cut on the nose and concussion after a fall at her Kalighat home on Thursday evening that state-run SSKM Hospital's director attributed to "some push from behind". The Bengal CM was taken around 7.30pm to the hospital's British-era Woodburn Ward, where doctors first stopped the bleeding and then closed the forehead wound with three stitches.

The cut on the nose required one stitch. She underwent a CT scan and an MRI, among other procedures, on the advice of a multidisciplinary medical board before being taken home at 9.45pm.

"We wanted to find out whether the fall was an accident or she suffered any fluctuation in blood pressure," a health department official said. The theory about Mamata tripping on something while entering her bedroom and falling on her face changed around 11pm when SSKM director Manimoy Bandyopadhyay suggested a mysterious "push" was the culprit. He spoke of her injuries but didn't elaborate on the cause. "Investigations like ECG and CT scan were done. She was advised admission for observation, but she preferred to go home. She will continue to be under close watch. She will be assessed Friday," on Bandyopadhyay said. Mamata's sister-in-law Kajari Banerjee, a Trinamool councillor, added to the conspiracy theory, saying she heard that "Didi fell after a dhakka". The Bengali word can be interpreted variously, including "impact after colliding.

Several biz groups bought bonds via multiple entities

Several groups have purchased electoral bonds through multiple corporate entities, according to SBI data uploaded by Election Commission Thursday. The biggest such donors include Megha Engineering and Western UP Power Transmission both part of the Hyderabadbased group — which together account for Rs 1,186 Similarly, Haldia Energy and Dhariwal Infrastructure, both from the RP Sanjiv Goenka group, together contributed Rs 492 crore. The Aditya Birla group also has several companies on the list such as Utkal Alumina, Birla Carbon India, UltraTech Cement and Essel Mining, which gave a combined Rs 510 crore. Among the other big donors are Madanlal Ltd, MKJ Enterprises Keventer Food Park Ltd, all from same Kolkata-based group, which donated a total of Rs 573 crore. MKJ

of securities and real estate as well as in food processing". Qwiksupply, a littleknown Maharashtrabased firm, is in the business of warehousing, storage and transportation, according to company details on the net. Friday deadline for publication of electoral bond details fast approaching, Election Commission has realised it would not be in position to fully comply with Supreme Court's March 11 direction, which included publishing on its website by March 15 the EB data it had supplied in two tranches to SC during pendency of petitions questioning validity of the bonds. In its application, EC on Thursday said it would comply with the directions to publish SBIfurnished details about EB purchasers and recipient political parties, but would not be able to publish the data it had furnished in sealed cover

Uzbek woman found dead in Bengaluru hotel, hunt on for 3 suspects

BENGALURU: A 27-year-old Uzbekistan national was found dead in her hotel room in Bengaluru on Wednesday night, with police suspecting she was smothered after being beaten up, reports. There were injury marks on her face and she was found bleeding from the nose.

Cops have launched a search for the suspects, including two hotel employees who have disappeared since the incident and a person who had booked the room for her. The victim, Zarina Utkirovna, had arrived in Delhi on a tourist visa, before flying into the city on March 5. She had checked into Jagadish Hotel in Kumara Park West. CCTV footage revealed three men had entered her room since Wednesday evening.

DELHI: Assam Thursday informed SC that Union-controlled oil and gas firms in the past 12 years have earned a cumulative net profit of over Rs 3.3 lakh crore but are unwilling to part with even 0.6% of that amount towards their tax dues to the state, chargeable on 6,639 sq km of land used by them, which is more than the size

India's challenge to Assam Taxation (on Lands) (Amendment) Act, 2004 for including coal, crude oil, natural gas and limestone bearing lands within the state tax regime, Assam govt through Rakesh Dwivedi told SC that Rs 1,894 crore, including interest on principal tax, is due from Oil India and ONGC from 2005 till 2022. Despite defecting to TMC in 2022, Singh has officially remained a BJP MP all this time. Objections were raised by some leaders at the meeting, but those who sought Singh's return prevailed. State leader of opposition Suvendu Adhikari was among those who wanted him back in BJP.

Road ministry starts pilot project on cashless treatment of victims in Chandigarh

transport ministry on Thursday announced launching a pilot programme to provide "cashless" treatment to all road crashes in Chandigarh, which will entitle such victims to get treatment of up to Rs 1.5 lakh and for a maximum of seven days. Based on the outcome of the pilot programme, expansion of the cashless treatment facility to the entire country will be considered, it said. The ministry said the pilot programme is aimed at establishing an ecosystem for providing timely medical care to the road crash victims, including during the golden hour (first hour from accident). TOI had on Jan 31 first reported about the govt proposal to cap the amount for cashless treatment. The National Health Authority (NHA) will implement the pilot programme, in coordination with police, hos-

pitals and State Health

Agency (SHA). Several

studies have found that around half of road deaths can be prevented by providing quick medical care in the first one hour of a crash. In 2022. India recorded the maximum ever 1.68 lakh road deaths. Sources said an assessment by the ministry has found that average medical expenses in around 97% of road crash cases is approximately Rs 60,000. Only a small number of victims need long hospitalisation and intensive care.The cashless medical treatment will cover crashes caused by motor vehicles on all types of roads. The Ayushman Bharat (PM-JAY) packages for trauma and poly-trauma cases are also being coopted in this scheme. "Claims raised by hos-

pitals for providing treatment to be reimbursed from the Motor Vehicle Accident Fund. The programme will be implemented through an IT platform combining the functionalities of e-DAR application of transport ministry and Transaction Management System (TMS) of NHA," govt said. The road transport ministry has carried out inter-ministerial consultation for the scheme, which was introduced in the Central Motor Vehicle Act in 2019. The scheme will have no burden on the public exchequer as insurance companies will bear the expenses. "It will be a fraction of the third party insurance premium they collect from vehicle owners. Reducing fatalities by providing faster medical care will ultimately benefit the insurance firms as their compensation outgo will reduce significantly," said a government offi-

NEW DELHI: Politics in Odisha is set for a churn. If the reports are to be believed, the ruling Biju Janata Dal of Naveen Patnaik is all set to join hands with BJP, which is the main opposition party in the state, ahead of upcoming elections. The recent visit of Prime Minister Narendra Modi to the state added fuel to the fire when he chose not to attack the Odisha government, chief minister Naveen Patnaik or the BJD. NEW DELHI: Assam chief minister Himanta Biswa Sarma on Thursday claimed that Citizenship Amendment Act (CAA) is completely significant in the state as there will be "least number of applicants". "CAA is completely insignificant in Assam; the state will have the least number of applications on the portal," CM Himanta Sarma said in a press conference. Himanta has also said that he will be the first to step down if even one person, who has not applied for the National Register of Citizens (NRC) in the state, gets citizenship under the Citizenship (Amendment) Act, 2019 (CAA). The Assam chief minister said the Act is very clear that the cut-off date for application of citizenship is December 31, 2014, and in Assam,

Agni V with MIRV gets India into global deterrence league

The successfully test-fired Agni-V ballistic missile equipped with Multiple Independently Targetable Re-entry Vehicle (MIRV) technology vastly extends India's strategic envelop. The Agni-V boasts an intercontinental ballistic missile (ICBM) range, exceeding 5,000 kilometres. This extended reach significantly alters India's strategic landscape. Traditionally, India's missile arsenal primarily focused on deterring threats from its immediate neighbours. However, the Agni-V's extended range allows India to potentially engage targets across vast distances, encompassing a broader spectrum of potential adversaries. This expanded reach compels any potential aggressor to consider the wider ramifications of a conflict with India. The psychological impact of this extended deterrence capability is undeniable. The stakes have just gone up.

The integration of multiple independently targeted re-entry vehicle technology turbocharges India's capability to launch a survivable multiple nuclear attack from a single source. MIRV allows a single missile to carry multiple independently targeted warheads. During the final stages of flight, these warheads separate and manoeuvre towards pre-designated targets. This capability significantly complicates an enemy's missile defence system. Previously, an enemy could potentially expend a single interceptor missile to neutralise an incoming threat. However, with MIRV technology, the enemy's defence system would need to engage and destroy each independently targeted warhead, exponentially increasing the defensive burden. This complexity significantly enhances the effectiveness of the Agni-V as a deterrent. It's important to acknowledge the regional context. China, India's hostile neighbour, possesses a robust and growing missile arsenal. China's Dongfeng-41 (DF-41) ICBM, with an estimated range exceeding 12,000 kilometres, dwarfs the Agni-V in terms of sheer reach. However, the Agni-V's successful test firing demonstrates India's commitment to closing the strategic gap. Furthermore, India's indigenous development programme allows for greater flexibility and faster production. It makes a greater range and more powerful warhead-integrated missile system just a matter of time and investment. **Nuclear deterrence: Maintaining stability**

The Agni-V, with its extended range and MIRV technology, serves as a potent deterrent against potential nuclear threats. The concept of deterrence relies on the credible threat of massive retaliation to dissuade an enemy from launching a nuclear attack. India has no first use of nuclear weapons posture, though there has been ambiguity on India's commitment to that posture lately. The Agni-V's capabilities complicate strategic choice for an adversary especially with regards to a nuclear first strike against India, knowing the potential for devastating retaliation across multiple targets. This strengthens regional stability and discourages

the use of nuclear weapons. Road ahead

While the successful test of the Agni-V marks a momentous milestone for India's strategic defence, the journey doesn't end here. Continued development and modernisation of India's missile programme are crucial to maintaining a credible deterrent in the face of an ever-evolving global security landscape. India must prioritise research and development in areas like hypersonic missiles and advanced defence penetration capabilities to stay ahead of potential threats. CAA is not against Indian Muslims, but its opposition clearly smacks of anti-Dalit prejudice

The Citizenship Amendment Act (CAA) is back in the news. The Modi government, after keeping the momentous legislation in a limbo for three years after it had sparked massive protests then, has decided to implement the law, which gives citizenship to religious minorities from Pakistan, Bangladesh and Afghanistan. The Act states Hindus, Sikhs, Buddhists, Jains, Parsis and Christians from Afghanistan, Bangladesh and Pakistan will not be treated as illegal migrants, and therefore, be eligible for naturalisation. These communities are given this leeway because they have been facing religious persecution in their respective countries and are often forced to cross the border to save their lives and dignity. While the government says

the new law gives sanctuary to people fleeing religious persecution, its critics find it to be anti-Muslim. While the government is categorical in saying that the legislation has nothing to do with Muslims staying within the country, those in opposition refuse to be convinced. One senior journalist called it a testament of sagging moral values in the country, while another bemoaned at not including Muslims in the list of 'beneficiaries'. What the opponents of CAA don't understand, deliberately or otherwise, is that Muslims from Pakistan, Afghanistan



and Bangladesh can still seek India's citizenship under the old Citizenship Act — just the same way former Pakistani singer Adnan Sami did. Other countries, including the United States, too have similar citizenship laws. Also, what most critics don't understand, as highlighted by senior journalist Abhijit Majumder in his Firstpost article, dated 12 March, 2024, that the US has a CAAlike "narrow-window legislation called the Lautenberg-Specter Amendments which give preferential shelter to persecuted minorities from Russia and Iran".

In fact, by delaying it in providing succour to minorities for so long, especially in Pakistan and Bangladesh, the Indian leadership has committed a moral transgression. The famous Liaquat-Nehru pact signed between India and Pakistan in 1950 promised to provide safety to minorities in the divided subcontinent. While India kept its side of promise by not just providing minorities equal rights and opportunities but also — as then prime minister Manmohan Singh insisted publicly in 2009 — giving them the first right to the nation's resources, the same cannot be said about the state of minorities in the neighbourhood. There were over two lakh Sikhs in Afghanistan in the 1980s. By the beginning of 2021, the number dwindled to 400 Sikhs, and after the Taliban's takeover of that country, the number barely touches a

three-figure Similarly, Hindu population in Pakistan today finds itself below the 2 per cent mark, while in Bangladesh, it has dwindled from being almost a third of the total population in 1950 to about 20 per cent in 1971 to less than 8 per cent today. Worse, if a leading Bangladeshi intellectual, Prof Abdul Barkat of Dhaka University, is to be believed, there won't be a Hindu in that country after 30 years. There is no doubt that minorities, especially Hindus, are facing existential crises in the neighbourhood. The same cannot be said about Muslims, though a few Islamic sects like Shias and Ahmediyyas do feel the occasional brunt of Islamic fundamentalism. Without denying

grant a CAA-like relief to the descendants of those who had actively participated in its Partition. The fact of the matter is that Shias and Adhediyyas, among others, were at the forefront of the Pakistan project. In fact, the main architect of the Pakistan movement, Mohammed Ali Jinnah, too was a Shia Muslim, today facing the brunt of Islamic fundamentalism. So, can the Indian state open its arms for the very people who once took an active part in its dismemberment? What's the guarantee that the descendants of the same sects won't participate in a similar Partition-like movement in future? Can the Indian State take this chance? But why special treatment for Hindus, critics could still ask. The answer lies beyond the Liaquat-Nehru pact of 1950. One can also for a moment ignore the civilisational aspect of the crisis where Hindus have no country but India to secure their safety and security. What makes the Indian state obligated to look after the Hindus of the neighbourhood is the fact that these people stayed back at the time of Partition after Mahatma Gandhi and Jawaharlal Nehru proactively discouraged them from leaving the territories that would

later become Pakistan.

Many centuries ago when the world at large didn't have much clue about statecraft and strategy, Kautilya had advised Chandragupta Maurya, his disciple, that the country with which his kingdom would share an immediate border will always be its enemy. 



Pakistan inflation slows to 23.1% yr/yr in Feb

KARACHI: Pakistan's consumer price index for February was up 23.1% from the same month last year, marking the slowest rate of annual inflation since June 2022, data from the Pakistan Bureau of Statistics showed on Friday.

The country has been struggling with soaring inflation, which last May hit an all-time high of 38% on an annual basis, partly driven by new taxation measures the government imposed to comply with International Monetary Fund demands. Islamabad's funding agreement with the IMF expires on April 11. On a month-on-month basis the February CPI was unchanged, having risen every month since the fiscal year began last July.Pakistan's finance ministry projected in a monthly report on Thursday that inflation would hover around 24.5%-25.5% in February, with expectations of further easing to 23.5%-24.5% in March as the crop situation and the supply of commodities improves. The annual CPI for January had clocked in at 28.3%. February's improvement on that was partly due to base effects. In January, Pakistan's central bank held its benchmark interest rate at 22% for the fifth policy-setting meeting in a row and raised its full-year inflation projections.

Once a global ideal, Germany's economy struggles with an energy shock that's exposing longtime

ESSEN: For most of this century, Germany racked up one economic success after another, dominating global markets for high-end products like luxury cars and industrial machinery, selling so much to the rest of the world that half the economy ran on exports. Jobs were plentiful, the government's financial coffers grew as other European countries drowned in debt, and books were written about what other countries could learn from Germany. No longer. Now, Germany is the world's worst-performing major developed economy, with both the International Monetary Fund and European Union expecting it to shrink this year.

It follows Russia's invasion of Ukraine and the loss of Moscow's cheap natural gas - an unprecedented shock to Germany's energyintensive industries, long the manufacturing powerhouse of Europe. The sudden underperformance by Europe's largest economy has set

off a wave of criticism.

World Bank maps out plans to further boost lending by \$100 bln-plus over a decade

WASHINGTON: The World Bank on Thursday proposed steps that would boost its lending to developing countries by an additional \$100 billion over a decade as part of an ongoing reform process aimed at helping the bank expand its mission to include climate change.

In a 24-page report to the joint ministerial committee that oversees the bank and the International Monetary Fund, the bank's management said it would ask shareholders to approve a hybrid capital measure and a new portfolio guarantee platform that together could boost lending by over \$100 billion.

That amount would come on top of measures already being implemented that will boost the bank's lending to developing countries by up to \$50 billion.





New Delhi: BJP on Thursday came down heavily on AAP and chief minister Arvind Kejriwal over his statements on CAA, alleging that he was spreading rumours to garner votes for the Lok Sabha elections. Ramvir Singh Bidhuri, a

BJP senior leader, said Kejriwal's statement shows he is anti-Hindu anti-humanity. "There have been huge atrocities against Hindus, Sikhs and minorities in Pakistan, Afghanistan and Bangladesh. In these countries their proper-



ty has either been taken away or destroyed," he said. "Hindu girls are not safe in these countries. Such news is continuously coming that they are kidnapped, converted or murdered. To save themselves from these atrocities and

torture, Hindu, Sikh, Jain, Christian and Parsi families have come to India," Bidhuri said.

"By giving shelter to such families and giving them Indian citizenship, Modi govt has fulfilled its moral promise," he said.

Bhowanipore trader killed by biz partner, body dumped in Nimta house

KOLKATA: The body of a 44-year-old medicine wholesaler from Bhowanipore, who went missing from Ballygunge Circular Road on Monday, was found inside a water reservoir on the terrace of his business partner's house in Nimta, north Dum Dum, on Wednesday morning. Police suspect a dispute over Rs 50 lakh that the accused Anirban Gupta (40) had taken from victim Bhavya Lakhani led to the murder. Gupta had allegedly taken the money on the pretext of giving it to the pharma company he used to work for.

Gupta has been arrested along with aide Suman Das (38) of Jorabagan, allegedly helped murder Lakhani and then dump his body in the tank. Gupta reportedly paid him Rs 2,000 and



asked him to take Lakhani's phone to Kolkata and dispose it of. Accordingly, the latter dumped the phone inside a public toilet in the Burtolla area.

The accused have been remanded in police custody till March 27. Prima facie it appears that the trader was battered to death with a cricket bat and stump. There were injury marks on his head, forehead, righ eyebrow and right arm. The assailants also tightly wrapped an adhesive

tape around his neck eight times. After he died, the body was stuffed in a gunny bag and dumped in the tank. A concrete wall was also erected overnight to conceal the body. Police had to dismantle the wall to recover the body.

Police said Gupta had opened a fake email ID in the name of a pharma company and from it, he sent a mail to Lakhani, stating that the company had returned the entire amount to Lakhani. Sources said he had

lured Lakhani to his house in Nimta's Probodh Mitra Lane with the assurance of settling the dues. Gupta, who claimed to be the chief medical representative of the firm, had allegedly borrowed the sum from Gupta for supplying medicines. But he didn't supply any medicine, nor did he return the money, said joint (crime) Syed Waquar Raza. The homicide wing of detective department has taken over the case.

Paytm employees brace for layoffs

Mumbai: **P**aytm Payments Bank, which has come under regulatory scrutiny, is likely to lay off employees, sources said. employee working with the PPBL said that about 20% of the operations team will be laid off by March-end. "We have also been hearing of a major rejig across Paytm by June," the employee told TOI on a condition of anonymity. An email sent to PPBL did not elicit any response.

Paytm is also expected to slash jobs across departments as part of its annual performance exercise. "We continue to transform our operations with Al-powered automation to drive efficiency...," a Paytm spokesperson said.
