3 new criminal laws kick in today, data ousts 'danda' as policing tool

NEW DELHI:

The criminal justice system is set for a major overhaul with the three new criminal laws -Bharatiya Nyaya Sanhita Bharatiya (BNS), Nagarik Suraksha Sanhita (BNSS) and Bharatiya Sakshya Adhinivam (BSA) - coming into force on Monday, replacing the British-era Indian Penal Criminal Code, Procedure Code and the

Indian Evidence Act. Starting Monday, all FIRs will be registered under the provisions of BNS.However, all cases registered before July 1 will continue to be tried under IPC, CrPC and Indian Evidence Act until final disposal BNS has 358 sections, down from 511 in IPC. As many as 21 new crimes have been added in BNS compared to IPC, duration of imprisonment extended in 41 crimes, fines increased in 82 crimes, minimum punishment introduced in 25 crimes, community service introduced as penalty in six crimes



and 19 sections removed. BNSS has 531 sections as against 484 in CrPC, with changes in 177 sections, addition of nine sections and 39 sub-sections and deletion of 14 sections. The Indian Evidence Act, with 166 sections, is being replaced with BSA having 170 sections, with change in 24 sections, addition of two new sub-sections and deletion of six sections. BNS, BNSS and BSA are being implemented six months after they were enacted based on protracted and detailed consultations with all stakeholders including SC and HC

police officers, collectorates and Members of Parliament and legislative assemblies. Around 3,200 suggestions were received and examined over several rounds of talks. with home minister Amit Shah having taken 158 such meetings, leading to the drafting of a whole new set of criminal laws that seek to leverage technology to make India's criminal justice system one of the most modern in the world. The BNS, BNSS and BSA bills were referred to a parliamentary standing committee and most of its recommendations accepted by the govt before bringing the bills

to

approval.

The underlying spirit of the new criminal laws, as PM Modi had stated at the All-India DGPs conference in Jan, is "citizen first, dignity first and justice first", with emphasis on the 'danda' (baton) being replaced by 'data' as a policing tool.While replying to the debate in Parliament on BNS, BNSS and BSA bills, Shah had underlined that the focus of the new laws was on justice delivery, while safeguarding the rights of victims as well as accused, rather than on punishment. Also, the colonial mindset apparent behind ordering of IPC sections - with those dealing with 'rajdroh' (treason) preceding ones related to serious offences like 'murder' and 'rape' - was being done away with. Under the new criminal

justice system, a person may report crime online, without having to visit a police station (online FIR) and also file a zero-FIR at any police station.

JAMMU: NIA conducted Sunday searches at multiple locations across Rajouri district of J&K in connection with the June 9 terrorist ambush on a pilgrim bus in Reasi that claimed nine lives and left 41 wounded.

"NIA took over the investigation on June 15 on orders from the ministry of home affairs. It searched five locations linked to hybrid terrorists and overground workers (those who provide logistical support)," said an NIA spokesperson.

Hybrid terrorists are radicalised people who execute acts of terrorism and then seamlessly blend back into their regular routines without leaving any discernible trace.

These sites were identified by Hakam Khan, a local suspect arrested for allegedly providing shelter and food to the terrorists, and aiding them in hiding and navigating the area undetected. In addition to NIA, security teams from Army, paramilitary forces, and J&K police are scouring the hilly, forested terrain of Jammu division following four attacks over three days (June 9, 11 and 12) in Reasi, Kathua and Doda districts. Security forces have killed five terrorists so far, all suspected to be Pakistanis. American M4 carbines, AKseries assault rifles, grenades, IEDs, and assorted ammunition were found on the slain terrorists."NIA has also started examining the seized material to unravel the conspiracy.

The capital this year suffered its most torrid peak summer months of May and June in at least 74 years. Both the month of June and the May-June period this year were the hottest in terms of maximum temperatures in records at Safdarjung station since 1951, which were analysed by

TOI. The average maximum temperature in June was nearly 42°C (41.95), surpassing the previous highest of 41.9°C recorded in 2012. This was only the eighth time since 1951 that the mean maximum temperature in June had stayed above 41°C. This May-June was Del's hottest in at least 74 yrs.

CBI arrests Godhra edu trust chief for NEET malpractices

Bloody stalemate, no signs of breakthrough

In the book 'The Fathomless Caves', Kate Forsyth, the author, describes war as, "An unpredictable beast. Once unleashed, it runs like a rabid dog, ravening friends and foes alike. It can drag on for years, a slow attrition of nerve and fortitude, or be over in one brilliant flash, an extravagant configuration of flame and blood and sweat." The Russian-Ukraine War fits well into the above description.

When President Putin launched 'special military operations' to 'demilitarise and denazify' Ukraine on February 24, 2022, it was universally given that the war would be over in a few days, with Russia inflicting a crushing defeat on Ukraine.Ironically, two years later, the conflict rages on, degenerating into a state of stalemate with little change in the ground situation. Although a classic limited war, its politico-economic impact has been felt far and wide, with serious geo-strategic ramifications. Militarily, it has gone on to redefine the very nature of warfare. The Russian offensive commenced as a typical military campaign, preceded by missiles and airstrikes, followed by a large-scale ground invasion along multiple fronts. The northern thrust was launched from Belarus towards Kyiv, the southern one was from Crimea, and the south-eastern push was from Luhansk-Donetsk towards Kharkiv.

. In the wake of heavy losses and stiff Ukrainian resistance on the outskirts of Kyiv, the Russian Northern thrust stalled within a month. towards the end of March. By April, the Russian Army had retreated to consolidate gains around the Luhansk and Donetsk areas. However, the Russians did succeed in capturing Mariupol in May after a prolonged siege. Having stabilised the situation, in August, the Ukrainian forces launched a limited counterattack in the south and a month later in the north-east, succeeding in recapturing Kharkiv and Kherson by November, thus forcing the Russians to withdraw east of the Dnieper River. With winters setting in, the pace of operations had slowed down. The Ukrainians resorted to launching a number of drone strikes against the Russian bases. A period of lull was used by the belligerents to consolidate their positions and gear up for the next phase. By the end of 2022, around 8 million refugees had fled Ukraine. Both sides had suffered heavy casualties; more than half a million Russian and Ukrainian soldiers were killed or wounded. besides over 10,000 civilian fatalities. Towards early 2023, Ukraine launched a major counteroffensive on a wide front. However, it soon went awry. The frontal assaults by the Ukrainian mechanised forces against the Russian multi-layered field fortifications complemented with minefields made no headway, and the offensive soon petered out. On the other hand, the Russian Army achieved a major success in May 2023 with the capture of the strategically important city of Bakhmut after months of fighting, with Prigozhin's Wegner militia making a major contribution. In 2024, Russia is prepared for a grand offensive to gain an upper hand, sensing exhaustion amongst the Ukrainian ranks and Kyiv's depleting manpower, equipment, and resources. Russia has revived its defence industry and also revamped its warfighting potential with military supplies, particularly ammunition, missiles, and drones from North Korea and Iran. The recent seizure of Avdiivka, an important town 20 kilometres east of Donetsk, will definitely offer a significant operational advantage to the Russians in the region.

Stubble burning will get relief and this type of plants will be set up in UP

Pollution becomes a major problem in the National Capital Region of New Delhi and its surrounding areas as winter sets in. This has become a big problem for the last several years not only in Delhi but for the residents of the surrounding areas. In view of this problem, the Yogi government of Uttar Pradesh has tried to provide relief to the citizens and to provide a source of income to the farmers instead of loss from the stubble generated from the paddy crop other than rice. It is noteworthy that in some areas of Uttar Pradesh. Puniab Haryana, and Rajasthan, administrative action is being taken continuously against farmers due to stubble burning. In which, apart from imposing fine on paddy farmers by the local administration, action is being taken to send them to jail. Due to which farmers are troubled. Seeing this problem of farmers, the Yogi government of Uttar Pradesh is trying to get rid of the pollution caused by stubble burning. For which the government is working on the technology of producing compressed gas (CNG) from stubble in the state, which will provide income as well as employment to a large number of people of the state. Along with this, pure organic fertilizer (green energy) will also be produced, the con-



sumption of the produce will ensure better health.

In fact, in view of this problem in the state, CM Yogi had already released the Bio Energy Policy 2022 to encourage bio energy. Under this policy a target of large scale investment was set. In which many big investors of the country had signed an MOU (Memorandum of Understanding) with the state government in the Global Investors Summit, which is now going to come to fruition. The Yogi government had set a target of biogas plant in every tehsil, some of which are ready to start soon.

Among the plants which are ready to start is Buland Biogas of Bulandshahr district, which is being established in village Lauhgala tehsil. Buland Biogas had signed an MoU worth Rs 18 crore 75 lakh with the state government, the price of which has now increased to around Rs 21 crore. According

to government representatives, this plant will start its production in December. This plant will produce 3 tonnes of CNG per day, which will reduce the dependence on petrol and diesel in the state. 80 to 100 people will also get employment. In these, both skilled and unskilled people will get employment. While talking to Dainik Bhaskar, owner of Buland Bio Gas, Athar Ahmed said that the plant produces not only stubble but also compressed biogas from degradable waste like straw, cow dung, chaff, sugarcane dung, municipal waste or a mixture of all the gases.

Is made. With the help of this technology, CNG is purified. License for this plant has been obtained from PSU Indian Oil of the Ministry of Petroleum, Government of India. However, the government and the people running the institute believe that the

best thing about this project is Government is also providing that it will produce organic fertilizer in large quantities. The waste generated in the production of compressed gas will be 100 percent organic. This waste will be solid as well as liquid. The liquid organic fertilizer produced by the plant will be given to the farmers free of cost for 3 years. These farmers will be identified by the DM or CDO of the districts. This will benefit those farmers who are not able to buy fertilizer, DAP, urea. The advantage of organic fertilizers and liquid fertilizers is that a thick layer of fertilizers has been spread in the fertile lands. It takes time to reach the roots of trees and plants. At the same time, if organic fertilizer is added to it, it will reach the roots in 2 to 3 hours.

This will not only benefit the farmers but also the common people will be able to get pure organic food. People's health will be benefited by pure eating habits. It is believed that considering the need of the hour, the Yogi government of the state has taken this project forward very rapidly and brought Bio Energy Policy-2022 for it. The government provided all the facilities in this.

The first facility is that those who have received a LOI license can apply for it. Apart from this, along with the Central Government, the State a maximum subsidy ranging from Rs 75 lakh to Rs 20 crore. Not only this, the surcharge on electricity has been exempted for 10 years. Stamp duty has also been exempted for 10 years and land development charges have also been made free for 10 years. Facing political persecution with resilience

After Maharani Jind Kaur, Maryam Nawaz Sharif will rule the Takht-e-Lahore. Jind Kaur, popular as Rani Jindan, took over as queen regent in 1843, ruling on behalf of her fiveyear-old son Duleep Singh, who ascended the throne after the death of his father Maharaja Ranjit Singh. She remained queen until the end of the First Anglo-Sikh War in 1846. Nearly 180 years later, Pakistan Punjab is finally getting its first female chief minister. No mean achievement in a political male-dominated setup where women are often relegated to the sidelines. And certainly not a small feat in a family where every third per-

son has been or wants to be the chief minister of Punjab province. Maryam's first prominent appearance was in a BBC interview, where she detailed her father's incarceration by General Pervez Musharraf in the October 1999 coup. While Nawaz and other male members of the family were imprisoned, his fearless wife Kulsoom and daughter Maryam rallied for public support. "I can smell the danger, but who is on the wrong side? Ultimately Gen Musharraf is going to be in trouble," Maryam had said. First lesson learnt - dictators die politically, but civilian leaders live through generations. Facing political

persecution with resilience and defiance made Maryam Nawaz a political force long before she began her parliamentary career. The 'How to Become a Successful Politician in Pakistan' guide will have one chapter, really — let thyself be persecuted at the hands of the real rulers of this land. In the case of Maryam, this persecution began years before she fought her first provincial and national election in 2024. If Nawaz was targeted by the Pakistan Army, Maryam was hounded with trumped-up political court cases that only served to enhance her popularity. Let's rewind to July 2018, when hundreds of paramilitary

soldiers apprehended the father and daughter at Lahore airport, taking them into custody just days before the general election that year. The imagery of a defiant daughter, standing next to her father and willingly accepting arrest, is what catapulted Maryam. to where she is today. Going to jail before getting a political launch is the best start to the career for any Pakistani politician. In the next four years of Imran Khan's Army-backed hybrid government, Maryam continued to be hounded with arrests, court cases, harassment and even death threats.

Even before Himachal Pradesh Chief Minister Sukhvinder Singh Sukhu's wife Kamlesh Thakur could reach Dehra in Kangra district on Thursday to launch her campaign for the July 10 Assembly bypoll, problems had flared up for her in this high-stakes battlefield. 



Bill Gates on nuclear energy, 'investing billions', huge costs

Delhi: Bill Gates, billionaire and Microsoft founder, spoke to CNN about his TerraPower nuclear energy plant in Wyoming, its challenges, and the future of nuclear power. He sought to allay concerns about radioactive waste and expenses. He vowed to invest "billions more" in newgeneration nuclear power and that global collaboration and scale will lower costs. Gates claimed they've "gone back to the basics" to cut costs: "We're willing to cool the plant with metal instead of water, as folks have long said. That solves the high pressure and extra heat when shutting down. The complexity has made nuclear power more expensive and complicated. We completely

A Japanese company is creating battery material with an energy density that is 100 times higher

Delhi: TDK, a multinational electronics business based in Japan, has revealed that it has created a material for solid-state batteries that has an energy density that is roughly 100 times higher than that of traditional ones. The Tokyo-based company claims that a variety of wearable gadgets, including smartwatches, wireless earbuds, hearing aids, and environmental sensors, may make use of their technology. Although the new material is intended to replace current coin cell batteries, it makes use of lithium alloy anodes and an oxide-based solid electrolyte. "Batteries are quite safe since they employ solid electrolyte based on oxides. It stated in a statement that "it is intended for use in wearable devices and other devices that come into direct contact with the human body." "The battery can be applied for replacing coin cell primary batteries in compliance with EU battery regulations, which require them to be replaced by rechargeable batteries, which is expected to contribute to the reduction of environmental impact," it stated. According to the company, the new technology also makes it possible for batteries to be smaller and have a longer operating life.

Voda to sell 10% Indus share for \$1.1bn

Delhi: Vodafone Group will sell 10% of India's Indus Towers for up to \$1.1 billion to service debt, according to a term sheet obtained by Reuters. Avoid promoting 'Ulips' as investments: Irdai

Delhi: The insurance regulator prohibits promoting Ulips and index-linked plans as investment products. The Irdai mandated tight standards for fund performance ads in a circular. They should show compounded yearly returns for the past five years with a caveat that past success does not guarantee future results. If applicable, benchmark index performance must be stated with fund performance. The circular advised advertisers not to overestimate benefits, selectively offer benefits without constraints, or make derogatory comparisons to competitors or the industry. The laws compel insurers to form an advertisement committee and appoint distribution channel compliance officers to ensure compli-



ance. These businesses strictly oversee advertisement material and enforce restrictions. The regulator also requires companies to let policyholders pay premiums online or hire a new agent or direct sales staff if the policyholder's agent leaves. A any new policy from the allocated insurance agency or direct sales staff for the same policyholder if the assigned policy is not resurrected or abandoned.
