Advising against nonessential travel to Lebanon, the embassy said, "In view of the recent escalations in the region, Indian nationals are advised to avoid all non-essential travel to Lebanon." 'If he wins, I give him free ...': Elon accepts Venezuela President Maduro's challenge



President Nicolas Venezuelan Maduro and billionaire Elon Musk are at loggerheads with each other with both of them trading barbs viciously. With the war of words brewing, the Tesla CEO now has accepted to debate the Venezuelan president.

The billionaire who has been at odds with Maduro amid political turmoil in the Venezuelan capital took to X and said, he "accepts" to fight him on national television with a condition ----- "If I win, he resigns as dictator of Venezuela.

If he wins, I give him a free ride to Mars."

Elon Musk has taken to X multiple times over the past few months to criticise Maduro and at times even thrown weight behind the opposition candidate in Venezuela. In one particular post Musk referred to Maduro as a "big guy", while also taking a dig at Facebook founder Mark Zuckerberg by terming him a "little fella".

"Maduro is a big guy himself and probably knows how to fight, so this would be a real fight. Zuck is a little fella, so that would be a short fight lol," he said in his post.

For his part, the socialist leader has accused Musk of being behind "attacks against Venezuela" and possibly the mastermind of an alleged "computer hacking" at the National Electoral Council (CNE), which concluded Maduro as the winner of Sunday's vote.

Following a meeting with top political and military advisors on Tuesday, Maduro announced the creation of a special committee, aided by Russian and Chinese experts.

Ensuring Bridge Safety in UP

Mirzapur: The recent incidents of the bridge collapse in neighbouring Bihar have instilled fear among the people of Mirzapur, Uttar Pradesh. The Shastri Bridge, a crucial link connecting Mirzapur to Jaunpur, Varanasi, Bhadohi, Gopigani, Allahabad, Sonbhadra, and Banaras, has become alarmingly weak due to overloaded trucks and heavy vehicles. Potholes are cropping up in various places, hinting at the possibility of a major accident. The Shastri Bridge, constructed in 1976, has undergone three repairs so far, but its current condition remains precarious. Recently, a portion of the footpath collapsed, prompting the police to barricade it. However, for the convenience of residents, the bridge had to be reopened after repairs. Given the continuous bridge collapses in Bihar, the situation at Shastri Bridge and the heavy vehicular load raise concerns for commuters. Unfortunately, the administration lacks a mechanism to prevent overloaded vehicles from using this bridge. If the administration had been vigilant and installed higher barriers to restrict overloaded vehicles earlier, the bridge's lifespan would have extended.

The presence of potholes on the bridge poses a danger, especially during rainfall when they fill with water. Pedestrians and two-wheeler riders are particularly vulnerable. The administration must address the noise pollution caused by heavy vehicles and immediately implement a higher barrier system to prevent overloaded vehicles from crossing the bridge. Modifying NH-19 (formerly NH-2) to divert such traffic away from the bridge would reduce pressure. While some suspect foul play, the Shastri Bridge remains crucial for Mirzapur, and its safety is essential for the general public. If we all remain vigilant and avoid negligence, we can prevent a major disaster. Let's ensure that the fate of this bridge doesn't mirror Bihar's recent incidents. The administration must stay alert to safeguard lives and infrastructure.



Why Celebrities Are **Seeking Legal Protection For Their Personality Rights**

The court was also informed that third parties were unfairly benefiting commercially from the sale of merchandise featuring his pictures and voice for ringtones. Most alarming was the online circulation of fake pornographic images and videos of the actor with other actresses. Notably, in its order, the Delhi High Court stated that satirical writing and genuine criticism would be safeguarded and not construed as violations of personality rights. While the word 'Jhakaas' can be used by people, they cannot exploit it commercially in the manner Anil Kapoor does. Similarly, it can be used for satire, criticism or parody, but not for monetary gains. In the Jackie Shroff case as well, the court declined to order the removal of a video titled 'Jackie Shroff is Savage, Jackie Shroff Thug Life', posted on a YouTube channel named 'Thugesh'. The court deemed the video a form of artistic expression and said imposing restrictions would have significant consequences. In the Anil Kapoor case, the court established the protection of personality rights in the realm of AI and deepfakes. However, this hasn't deterred the illegal use of celebrities' personal attributes for financial gains. Regarding the existing laws, advocate Naik says: "I feel the current laws and the jurisprudence that we got from the Delhi High Court in matters of Mr. Bachchan or Mr. Kapoor are good references. I personally feel the time has come for us to protect personality rights.

Jackie Shroff's case marks the first instance of a court restraining an unlicensed Chatbot. In the online world, cybercriminals exploit AI for nefarious purposes to make money while jeopardising people's reputations. Celebrities are taking the lead, and the courts are establishing principles and precedents. Being vigilant to preempt damage

"A few celebrities may choose not to pursue legal action due to various reasons such as the perceived insignificance of unauthorised use, the costs involved in litigation, or a desire to avoid negative publicity," says Shoeb Masodi, Partner, M&P IP PROTECTORS. Personality rights, as the name implies, pertain to the rights associated with the personality of a well-known individual, primarily applicable to celebrities whose names, images or voices are prone to misuse for profit. The concept dictates that only the owner or creator of these attributes has the right to derive monetary benefits from them. Personality rights have gained importance alongside the right to privacy given the kind of fame celebrities enjoy today. In 1995, the Supreme Court recognised a person's right to control the commercial use of one's identity in the R Rajagopal vs. State of Tamil Nadu case, commonly known as the Auto Shankar case. In 2015, the Madras High Court intervened to protect actor Rajinikanth's personality rights, halting the release of the movie Main Hoon Rajinikanth. The filmmakers had utilised the actor's name and style without his express permission, with the title itself serving as a clear indication of its connection to Rajinikanth. In yet another case involving actor Amitabh Bachchan. , the Delhi High Court 🛮 in 🛭 November 2022 restrained the use of the actor's name, image, voice.

Hezbollah vs Israel: What happened the last time they went to war in 2006?

The killing of a top Hezbollah commander in Beirut by the Israeli Defence Forces has sparked concerns about a possible war between Israel and the Lebanon-based terror group. The two previously fought a 34-day war in 2006 that ended in a stalemate. But what happened? Hezbollah vs Israel: What happened the last time they went to war in 2006?

Hezbollah on 12 July, 2006, killed three Israeli soldiers and captured two others in what it called operation 'Truthful Promise.' AP

Are Israel and Lebanon's Hezbollah going to war? This is what many are worried about in the aftermath of the Israel Defence Forces (IDF) killing a top Hezbollah commander in Beirut. Israel claimed that the commander Fouad Shukur was allegedly behind the weekend rocket attack that left 12 young people dead in the Israeli-controlled Heights – an assertion that Hezbollah has denied. The two sides have exchanged near-daily strikes for the past 10 months against the backdrop of the war in Gaza, but they have previously kept the conflict at a low level that was unlikely to escalate into full-on war. However, that could now change. "The Israeli enemy has committed a great stupid act in size, timing and circumstances by targeting an entirely civilian area,"



Hezbollah official Ali Ammar told Al-Manar TV.

"The Israeli enemy will pay a price for this sooner or

But what happened the last time Israel and Lebanon did battle?

Let's take a closer look:

The war between Israel and Hezbollah kicked off with Hezbollah fighters crossing the border into Israel on July 12, 2006. As per Human Rights Watch, the militants attacked an IDF convoy near the border. They killed three soldiers and kidnapping two others – whom they brought back to Lebanon. The aim of the operation was in keeping with Hassan Nasrallah's objective to capture Israeli soldiers and exchange them for prisoners. Hezbollah also sought the return of the Israeli-occupied Sheba Farms. The terror group then announced it would enter 'indirect negotiations' with Israel. However, then Lebanese prime minister

Fouad Siniora denied that he knew what Hezbollah was planning. In a letter dated July 13, 2006, to the Secretary-General and the President of the Security Council, the Government of Lebanon declared that "[T]he Lebanese Government was not aware

of the events that occurred and are occurring on the international Lebanese border" and that "[T]he Lebanese Government is not responsible for these events and does not endorse them."

'Act of war'

However, Israel was having none of it. minister Ehud Olmert announced that the Lebanon government had committed an 'act of war.' "Lebanon is responsible and Lebanon will bear the consequences of its actions," Olmert vowed. Meanwhile, Israel's chief of staff Dan Halutz said "if the soldiers are not returned, we will turn Lebanon's clock back 20

Adam, the head of Israel's Northern Command, added, "This affair is between Israel and the State of Lebanon. Where to attack? Once it is inside Lebanon, everything is legitimate – not just southern Lebanon, not just the line of Hezbollah posts." The IDF on July 13, 2006, began bombing bridges, roads, and important other Hezbollah positions including Beirut's Rafic Hariri International Airport. Israel also imposed a 'complete blockade' on Lebanon, as per Human Rights Watch. According to CSIS, Hezbollah

was taken by complete surprise.

Hezbollah leader Hassan Nasrallah later admitted he would not have started the war had he known its outcome. Reuters

Indeed Nasrallah would later announce that he would not have conducted the operation if he had known about the outcome. But that would come later. Hezbollah's immediate reaction was to fire a hail of rockets at Israel. The terror group is estimated to have fired 4,000 rockets – around 34 on average

As per CSIS, Hezbollah militants hid themselves along trees, patches of vegetation, caves, surface irregularities, and buildings along the slopes of the hills. From here, they launched missiles and rockets at Israeli posialso used civilian infrastructure to hide command centers, ambush Israeli fighters and allow its own militants to manouvre. space Hezbollah also used antitank guided (ATGMs) to great effect. During the war, ATGMs accounted for the majority of Israeli infantry casualties including 24 tank crewmen. ATGMs also took out 20 tanks. The performance of Hezbollah's militants won praise from Western analysts, as per CSIS. According to ICRC, the government in Lebanon repeatedly asked the United Nations Security Council to call for an 'immediate and unconditional ceasefire' between Israel and Hezbollah.

The ceasefire

The war finally ended with the United Nations Security Council passing Resolution 1701 on August 11, 2006.

The resolution called for a "full cessation of hostilities based upon, in particular, the immediate cessation by Hezbollah of all attacks and the immediate cessation by Israel of all offensive military operations, and emphasising the need to address urgently the causes that have given rise to the current crisis, including by the unconditional release of the abducted Israeli soldiers. The resolution also called for a demilitarised zone on Lebanon's side of the border.

Ten paediatric hospitals in five states have joined hands with the National Allergy Centre of Excellence (NACE) to roll out the peanut oral immunotherapy (OIT) programme, reported (Australian Broadcasting Corporation). With this, the hope is to increase the tolerance threshold and decrease the risk posed by peanuts to allergic babies. "In some cases, [the threshold] might be so high that they can eat peanut in their diet freely, for others it might raise it to a level where accidental exposures wouldn't result in an allergic reaction," Brettig was quoted as saying by BBC. After the end of two years, a food allergy test will be done to ascertain if treatment led to remission, reported AFP. Doctors have warned families against trying oral immunotherapy at home without supervision. "This programme follows a carefully planned dosing schedule and children are under the strict medical supervision .





Scientists, Gaganyaan astronaut bat for Ladakh as Moon & Mars analogue research site

BENGALURU:

Scientists from Indian Institute of Science (IISc) and Birbal Sahni Institute Palaeosciences (BSIP) have identified Ladakh as an ideal location for India's first Mars and analogue Moon research station. Their proposal leverages past research as well as their own field work experience.

The research work, carried out by Binita Phartiyal from BSIP along with IISc's Aloke Kumar and Shubhanshu Shukla one of India's four Gaganyaan astronauts comes as India accelerates its ambispace proincluding gramme, plans for a space station by 2035 and a Moon landing by

2040. An analogue research explained: "is a place where activities meant for Moon and Mars can be planned and practised. For example, if you're planning

an astronaut habitat, vou can build a habitat there as there are some similarities (geological, for example) with extra-terrestrial conditions. You can also use it to see how microbes and other organisms respond to such extreme environments." Phartiyal and Kumar, lead authors of the proposal, highlight Ladakh's unique geographical features that closely resemble both Martian and Lunar environments. The region's cold, arid desert landscape, rocky terrain, and geomorphological similarities to early Mars and the Moon make it an exceptional candidate for simulating extraterrestrial conditions. "Ladakh offers a natural laboratory for testing equipment, train-

ing personnel, and

Moon,"

Phartiyal, who has been visiting Ladakh for research work nearly every year since 2000, has studied the landscape closely. "...Being there often makes me feel that you are on a different planet altogether," Phartiyal, who also participated in Nasa's Spaceward Bound India programme (2016), which cited Ladakh's high altitude mountainous ecosystem possessing Marsanalogous topological features, said.

She failed physics and chemistry papers in board exams conducted in March.

She then took Gujarat board's supplementary exams in June, which give those who failed up to three papers a second shot. She has now failed Class 12, being unable to pass physics. She scored just 22 in physics in the supple-



mentary exam, compared to 21 on her first attempt.

"We, therefore, issue notice to A Kowsigan, commissioner land revenue, and TR Jayapal, additional secretary, government of Kerala, and direct them to remain present

in this court on August 21, 2024, and show cause as to why an action for committing contempt of the court may not be initiated against them by this court," the bench said.

Rahul Gandhi lying, says **Ashok Chavan reacting to** 'weeping' claim

MUMBAI: A day after Congress politician Rahul Gandhi's critical remarks, former chief minister Ashok Chavan, now a Rajya Sabha member from BJP. described the comments as baseless and illogical. "Rahul Gandhi did not mention my name. If he is referring to me, then I will describe his remarks as baseless and illogical. Let me make it clear, before joining BJP I did not meet Congress leader Sonia Gandhi in New Delhi. In fact, till the last moment, I was working in the Congress office, working on the seat-sharing formula. What Rahul Gandhi said is a lie. Rahul Gandhi's remarks are factually incorrect. It is just a political stunt in view of the forthcoming Lok Sabha election and to embarrass me," Chavan said. Chavan said that before joining BJP, he resigned from the assembly and, a few hours later, quit the primary membership of the party. Addressing a public meeting at Shivaji Park, Rahul Gandhi said a senior leader from Maharashtra, whom he did not want to name, left Congress and wept in front of his mother, Sonia Gandhi.

Fire safety steps missing, JLN Stadium told not to host events

NEW DELHI: Delhi fire department has written to the administrator of Jawaharlal Nehru Stadium (JLN) to stop using the premises for sporting events and functions due to a lack of fire safety measures. The fire safety certificate of Samrat Hotel in Chanakyapuri has also been cancelled over non-compliance with fire safety regulations. The hotel management, however, said it hasn't received any notice.
