Vinesh Phogat becomes first Indian woman wrestler to reach Olympic final

NEW DELHI: Vinesh Phogat on Tuesday created history, becoming the first Indian woman wrestler to reach the final of the Olympic Games.

She secured her place in the final with a convincing 5-0 victory over Yusneylis Cuba's Guzman Lopez in 50kg category in Paris, guaranteeing herself at least a silver medal.

SC bristles, mulls action as Punjab & Haryana HC judge slams apex court

NEW DELHI: Taking serious note of "judicial indiscipline" of Punjab and Haryana high court judge Rajbir Sherawat by showing defiance towards a Supreme Court order, CJI D Y Chandrachud and four most senior judges decided to form a bench on Wednesday to decide the future course of action in regard to the HC judge's July 17 order.

Justice Sherawat had remarked in his order: "A tendency to presume the Supreme Court to be more 'Supreme' than it actually is and to presume a high court to be less 'High' than it constitutionally is." The bench of CJI Chandrachud, and

Justices Sanjiv Khanna, B R Gavai, Surya Kant and Hrishikesh Roy will tackle Justice Sherawat's order, who had reluctantly adjourned a contempt proceeding.

Agri insurance claims worth 1.6 lakh crore cleared so far, says Shivraj



Agriculture Minister Shivraj Singh Chouhan stated that under the Pradhan Mantri Fasal Bima Yojana, farmers have received Rs 1.6 lakh crore in insurance claims against Rs 32,440 crore in premiums since 2016-17. He emphasized the scheme's farmer-friendly and affordable nature, noting the introduction of a 12% penalty for delayed claim disbursal from the Kharif 2024 season.

Agriculture minister Shivraj Singh Chouhan on Tuesday said insurance claims of Rs 1.6 lakh crore have been paid to farmers against Rs 32,440 crore premium paid by them under Pradhan Mantri Fasal Bima Yojana (PMFBY) since inception of the scheme in 2016-17.

Replying to a question on the scheme during Question Hour in Lok Sabha, he said Modi govt has made it "farmer friendly and affordable" and made provisions for "timely & transparent" processing of all claims.

"As per provisions of the scheme, 12% penalty is required to be paid by insurance companies to farmers for late disbursal of claims, for which a penalty module has also been developed to calculate the penalty automatically w.e.f. Kharif 2024 season," said Chouhan.

MAHAKUMBH 2025 Railways to tap expertise from officials posted during 2013, 2019 fairs

Prayagraj: To ensure the safe conduct of the forthcoming mega religious fair of Mahakumbh-2025, the railways will be seeking suggestions from officials who have served in Prayagraj during 2013 and 2019 editions of the fair. The officials will be asked to provide tips to their colleagues serving in Prayagraj. Moreover, the railways will also be soliciting suggestions from officials of other departments who have served here during earlier Kumbh fairs. The railways will study the circumstances which resulted in the mishap at Prayagraj Junction and will invite suggestions from officials who were posted there at that time. While identifying the mistakes during earlier fairs, the railways will form new strategies and chalk out a concrete plan which will be implemented this Mahakumbh-2025 for its successful and grand conclusion.

The railways will also take suggestions on the routes of Mela Special trains. The series of meetings with officials having experience of Kumbh will be held from August to September under the chairmanship of DRM. A list of suggestions and advices will be prepared which will be presented during the meeting for Mahakumbh later as proposals and suggestions.

Besides railway officials, the staff and officials of other departments along with other people and media persons who have experience of Kumbh will be invited to give their suggestions. Railway officials said that some officials in the department who have served here earlier and now posted elsewhere may also be deployed here for some months between December to March during the Mahakumbh. A list of such officials who have served here during Kumbh 2013 and 2019 is being prepared. Such officials will be intimidated and will be asked if they were willing to work at Mahakumbh. A proposal for their deployment is being prepared and following the approval of the board, the officials may be called to Prayagraj for serving at Mahakumbh.

Shastri Bridge: A **Critical Situation**

Mirzapur: The Shastri Bridge, which connects Mirzapur and its surrounding areas, is currently deteriorating. Despite its precarious condition, the administration seems indifferent to the potential hazards it poses. During a meeting of senior officials, permission was granted for heavy vehicles to use the bridge, disregarding public concerns.

Recently, a truck narrowly avoided falling into the river after damaging the footpath while attempting to cross the bridge. Daily commuters now face anxiety and traffic congestion, fearing accidents and the bridge's instability. Instead of restricting heavy vehicles, the administration allowed 6, 10, 12, and 14-wheeler trucks to use the Shastri Bridge freely.

Despite the historical significance and its vital role for people from Mirzapur and neighbouring districts, the administration has turned a blind eye to these issues. The Shastri Bridge has been a lifeline for countless individuals, especially students, labourers, and small traders. However, as the bridge's condition worsens, and citizens raise concerns, the administration's decision to permit heavy vehicles exacerbates safety risks.

With rising monsoon water levels and swift currents, the bridge experiences severe traffic jams and large potholes. Rather than issuing permits for heavy vehicles to continue using the deteriorating Shastri Bridge, the administration should prioritise public safety by redirecting them to alternative routes.

Surveillance teams have been asked to ensure cleanliness, awareness and fogging in dengue-affected sensitive areas. Instructions have also been given to make children also aware of the ways to protect themselves from mosquitoes in schools, he added. Last year, 31 dengue patients were found in Naini, 24 in Jhunsi, 22 in Mundera, 19 in Bamrauli, 14 each in Sulem Sarai and Civil Lines, 12 in Dhumanganj, 8 each in Jhalwa and Kalindipuram areas of Prayagraj.



Prayagraj: The management dispute of Bishop Johnson Girls School and College located on Mission Road is not getting resolved. New complications are being seen in this case every day. On July 2, Parul Solomon, Principal of Bishop Johnson Girls School and College, was working in her school. Thereafter, Bishop Morris Edgar Dan alias Tiger of the Diocese of Lucknow Church of North India, along with his son Alan Dan, alias Sunny and a group of associates including alleged rapist public relations officer Archie Timothy, Rockwell Amar Moses

Mohit, forcibly entered the school and broke the lock of the principal's room. After entering the room, she was abused and physically assaulted and forcibly removed from her chair. Woman Principal of Bishop Johnson, Parul Solomon, accused Bishop Dan of issuing life threat to her including family members. However, she is willing to die but will not withdraw the case. It is alleged that they molested the Principal and snatched her mobile phone so that she could not shoot the video of the incident. She was expelled from school on erroneous charges. Protect personality rights

I personally feel the time has come for us to protect personality rights. like the one provided by the Copyright Act." However, the challenge lies in taking tangible action to identify infringers, notify them, and ensure compliance. In the online world, cybercriminals exploit AI for nefarious purposes to make money while jeopardising people's reputations. The Delhi High Court recently issued an order safeguarding the personality and publicity rights of film actor Jackie Shroff, restraining several social media accounts, AI Chatbots, and e-commerce websites from exploiting the actor's name, voice, or image for commercial purposes without his consent. Shroff petitioned the court against the unauthorised use of his name and persona, seeking protection against various individuals and entities utilising and misusing his identity without permission. The proliferation of Al-generated deepfake videos has exacerbated concerns for celebrities. Jackie Shroff's isn't the first instance of a film star resorting to legal action to protect their personality rights. Over the past two years, the Delhi High Court has issued interim orders to prevent the unauthorised use of Amitabh Bachchan and Anil Kapoor's name, image, and voice. The question arises: why are some celebrities turning to courts for the protection of their personality rights, while others refrain? "Where there is demonstrable misuse, people are approaching. Personality right is a facet of publicity right," says advocate Ameet Naik, who has represented Bachchan, Kapoor and now Shroff.

, images or voices are prone to misuse for profit. The concept dictates that only the owner or creator of these attributes has the right to derive monetary benefits from them. Personality rights have gained importance alongside the right to privacy given the kind of fame celebrities enjoy today. In 1995, the Supreme Court recognised a person's right to control the commercial use of one's identity in the R Rajagopal vs. State of Tamil Nadu case, commonly known as the Auto Shankar case. In 2015, the Madras High Court intervened to protect actor Rajinikanth's personality rights, halting the release of the movie Main Hoon Rajinikanth. The filmmakers had utilised the actor's name and style without his express permission, with the title itself serving as a clear indication of its connection to Rajinikanth. In yet another case involving actor Amitabh Bachchan.


Great length the advisability

Maj Gen Himmatsinghji, deputy minister of defense (chairman), it included Lt Gen Kulwant Singh, K Zakaria, head of the Ministry of External Affairs' historical division, SN Haksar, joint secretary also from MEA, Group Captain MS Chaturvedi from the Indian Air Force, and Waryam Singh, deputy director of the Intelligence Bureau. After discussing at great length the advisability of pushing forward a post to Tawang, it was decided to go ahead. It was also decided to send troops to Nelang (then written Nilang) and Jadung (then Jadhang), two tiny villages south of the Tsangchokla, the pass marking the watershed in the area, in the Chamoli district.

One man was central in the setting up of Maj Khathing's expedition to Tawang; it was Jairamdas Daulatram, the governor of Assam. It is sad that his role has been more or less forgotten today. On December 10, 1950, he managed to get the concurrence of the Ministry of External Affairs headed by Nehru; a Joint Secretary concurred with the Committee, "We cannot agree to a unilateral occupation of Tawang by the communists." The ball then started rolling, and preparations for the expedition began. Maj Khathing received detailed instructions from Nari Rustomji, the advisor to the governor, on behalf of Daulatram himself.

Precise tasks were given to the young and bold officer.

The first task was to occupy Tawang. Khathing was asked



to explain to the local population and Tibetan officials that he was "doing no more than is being done by the administration in other parts of Indian territory;" in 1914, Tibet had agreed to the McMahon Line, north of Tawang being the boundary. The major was ordered to "treat any Tibetan or other officials you may meet with courtesy, but nevertheless let them understand that jurisdiction in the area vests in you and not in them." He was directed to submit detailed reports about the Tibetan 'influence' in the area and the nature of taxes collected. He was further told to abolish all existing taxes and substitute them with lighter taxes to be paid to the Political Officer, representing the Indian government: "There will be no forced labour and everything needed will be duly paid for." An important task was to communicate to the local people that "none of their religious practices The sixth point was that in case Khathing met with armed opposition, he was to cable Shillong (the governor's office) immediately, "indicating the strength and position opposing

Fortunately, due to Khathing's intelligence and diplomatic skills, this would not be necessary, and

74 years later, he was still considered by the Monpas as their liberator. Khathing was also asked to keep daily wireless telegraphic contact with Daulatram after crossing the Se-La pass. It is what Khathing did, and his dispatches and cables still make fascinating reading. Finally, Daulatram asked Khathing to "conduct [the] operation with tact, firmness, and discretion".

The logistics of the expedition were not easy; for example, the question of porters and loads was difficult to coordinate. One can imagine having as many as 200 troops and 600 porters to feed.

Another issue was 'political presents' for the local authorities.

On February 9, 1951, the Tsona Dzongpons met Khathing again, and the latter reported to the governor: "As regards the lay officials, like Tsona Dzongpons Drekhangs, the salt monopolists and grain collectors, I have not allowed them to exercise any of their powers and influence." Undoubtedly, the merit of having taken over Tawang's administration goes to Daulatram as well as to the most reliable major.

Nehru's Reaction

On March 18, 1951, the prime minister noted: "I hear constantly about the activities of the North and North-Border Defense Committee. These activities have resulted in action being taken on the Tibetan border and in Nepal. At no stage have these matters been brought up before me for consultation, although apparently consultations have taken place with the Governor of Assam and other people far away. ... I am greatly concerned about this matter because ...the manner of our going to Tawang and taking possession of it and thus creating some international complications, has not been a happy one. Indian Army, along with the Tawang administration and the local Monpa population, commemorated the 74th anniversary of the arrival of Maj Bob Khathing in the area In 1951, the Manipuri Naga officer took over the administration of the border town of Tawang, south of the McMahon Line; a communiqué of the Defense PRO in Guwahati thus explained, "After the valiant Major undertook a treacherous march from the plains of Assam to Tawang, negotiating Sela and Bomdila passes during peak winters, leading a contingent of 200 Assam Rifles troops and 600 porters for a difficult maiden mission. , thus materialised the formal establishment of Indian civil administration at Tawang." The above two events are linked as the takeover of both places' administration is the result of a decision of the Himmasinghji Border Defence Committee created by the Army Headquarters on November 12, 1950.

Let us remember the facts

One can imagine what would have happened if the prime minister had been in the loop. On October 7, 1950, the communist troops advanced in eastern Tibet, and after smashing the ill-trained and ill-equipped Tibetan army, Chamdo, the capital of Kham Province, fell to the invaders. On November 7, Sardar Patel, the deputy prime minister, despite his poor health, sent a long letter to the prime minister about the implications of the Chinese invasion.

Delhi: India, which forbids liquor advertising, will soon outlaw surrogate ads and event sponsorship, forcing Carlsberg, Pernod Ricard, and Diageo to rethink their marketing strategies. Such "surrogate ads" often circumvent the ban by showcasing less desirable things like water, music CDs, or glassware with logos and colors related to their main product, often pushed by Bollywood stars. "You can't take a circuitous

way to promote products. "If we find ads to be surrogate and misleading, then even those who are endorsing (products), including celebrities, will be held responsible." In India, Carlsberg advertises their Tuborg drinking water with film stars at a rooftop dance party and the phrase "Tilt Your World", echoing its beer commercials elsewhere, "Drink which say Responsibly". India is the world's eighth-largest alcohol market by volume, with Euromonitor estimating \$45 billion in annual revenues. The reforms imperil liquor companies. accounts for a tenth of Pernod's global revenues, while Diageo and Pernod hold a fifth of the whisky market.

The proposal states that "prohibition against engaging in surrogate advertisement" applies to sponsorships and commercials for extensions" that resemble alcohol brands.



Record 7.3 crore I-T returns filed till July 31: Tax department

Income tax returns (ITRs) touched a new record of nearly 7.3 crore, 7.5% higher compared to 6.8 crore in previous fiscal, by the July 31 deadline, the income tax department said on Friday.Out of the total ITRs of 7.3 crore filed for AY2024-25, 5.3 crore have been filed in the new tax regime compared to over 2 crore ITRs filed in the old tax regime," it said. Thus, about 72% of taxpayers have opted for the new tax regime, while 28% continue to be in the old tax regime.

Apple does not currently have "no immediate plans" to manufacture MacBook laptops and iPad tablets in India, according to insiders. While trial production would start a bit sooner, the insiders also mentioned that when the newest iPhone 16 models hit stores worldwide around September this year, the first iPhone Pro handsets will be produced in India.

Just like with the non-Pro series, Apple will export the iPhone Pro models to different worldwide markets after production stabilises in India. A year has passed since the plan's inception, during which time the supply chain for new gadgets has been under constant scrutiny. The company will continue to assemble the Pro models, as it has been successful thus far, according to one source. The results have been positive.
