Eye on 370 seats, BJP to focus on 161 it lost in 2019 polls

NEW DELHI: With a target of 370 seats in Lok Sabha polls, BJP has decided to focus on 161 seats it lost in 2019, with the party leadership telling that the cadre that it can achieve the goal set by PM Narendra Modi by winning 67 of those seats.

"We have to cross 370 seats and NDA has to cross 400," Nadda said inaugural in his address at the party's National Council meet on Saturday.

Speaking of the importance of winning the seats BJP lost last time, he said development of the constituencies concerned under the watch of 'pravas mantris' will help, even as it drew out the outreach plan for the party workers over the next 100 days, right from the booth level, to take the message of 'Viksit Bharat' and 'GYAN' -Garib (poor), Yuva (youth), Annadata and Nari (farmers) (women).



underscored the party's meteoric rise since PM Modi took office and lauded his leadership in the past decade. The Modi government will score a hat-trick and retain power for a third straight term, he told the nearly 11,500 party delegates. He listed the 16 victories in 26 elections post-2019 and said: "It's all because of the trust of the people on Modi and his guarantees. They have endorsed Modi's work.

Modiji has fulfilled the commitment he has made."

Significantly, Nadda also asserted that BJP would win the next state polls in Bengal, a state where it is expected to do well along with Telangana, Uttar Pradesh and Andhra Pradesh where it is on the verge of finalising a tie-up with

of the Citizenship Amendment (CAA). Enacted to provide citizenship to non-Muslim communities facing religious persecution Pakistan, Bangladesh and Afghanistan, CAA is of special significance for West Bengal, home to lakhs of Hindus who escaped from Bangladesh.


KOLKATA/NEW DELHI: The ED on Thursday summoned two Trinamool leaders actor-MP Dev and former MP Mahua Moitra - to its Delhi offices next week. The former has been called on Feb 21 in connection with the agency's ongoing probe into the cattlesmuggling racket; the latter on Feb 19 over some foreign currency transactions.

The summons to the actor-politician, who represents the Ghatal Lok Sabha constituency in West Midnapore, barely three days after he announced that he was not quitting politics, has prompted cries from the TMC of this being another example of Centre's "vendetta politics".

Sources said Moitra has sent a lawyer's letter to the agency, questioning whether it could probe the charges against her.

Delhi Police on high alert, security beefed up

on high alert and security has been tightened in the national capital in view of the 'Bharat Bandh' call given by the Samyukta Kisan Morcha (SKM), officials said on Friday. Traffic may be affected in the national capital with barricades put up in several areas, according to police. The SKM has called for the 'Bharat Bandh' to press the BJP-led central government to accept farmers' demands, including a legal guarantee of minimum support price (MSP) for crops. LG to govt: Give equal perks to welfare officers on contract

New Delhi: Lieutenant governor VK Saxena has directed Delhi govt to implement the judicial orders to provide the same amount of house rent and travel allowance to contractual welfare officers in the social welfare department as paid to the regular employ-

In a note to the state govt, the

expressed displeasure that there had been recurrence of delays in handling such administrative matters by the department. He

directed the department to identify and fix responsibility of the officials responsible for causing undue delay in the above matter within 15 days. He further asked the department to avoid any such delays in future and process all administrative matters with "due care and alacrity".

Taking note that Central Administrative Tribunal, Delhi High Court as well as the Supreme Court passed orders in favour of the contractual officers for extension of equal benefits, the LG said that the department exhibited a "lackadaisical and dilly-dallying attitude" in critical administrative

Citing the SC's March 2023 order, Saxena said it was "unreasonable and unjustified" that the social welfare department took another eight months to process the matter. AAP govt, however, said services related matters were being handled by the LG since 2015.

HC raps child rights body, says it acted irresponsibly

New Delhi: Delhi High Court on Friday rapped the Delhi Commission for Protection of Child Rights (DCPCR) for acting irresponsibly with regard to a petition it filed against the alleged stoppage of funding by LG VK Saxena on the basis of a "nonexistent press release".

Justice Subramonium Prasad said the petitioner's response to the lieutenant governor's specific stand that there was no order to withhold funding was "wishy washy" and the body should have been more responsible when making allegations against a constitutional authority.



New Delhi: During a conversation with son Harsh on Thursday, Anil Thakur talked about picking up groceries on his way home from work at the factory. Little did they know it would be their last exchange. As the sole breadwinner in his family of four, Thakur's absence is an impossible void to fill. Like many others caught in the blaze at the paint factory in northwest Delhi's Alipur, Thakur had journeyed to the city from another state, Muzaffarnagar in Uttar Pradesh in his case, for a simple reason: to provide a brighter future for his children.At the mortuary of Babu Jagjivan Ram Hospital in Jahangirpuri on Friday, grieving families gathered to identify their loved ones. Shaken awake by the horrors of the preceding night,

None of these places has a noobjection certificate from the fire department but that has not proved to be deterrent for them as they collude with other authorities and function without any hinderance. How UPA government helped China grow at India's expense

"In my third term, I promise that India will become the third largest economy in the world," the Prime Minister said in his recent speech to the Lok Sabha. This is "Modi ki guarantee," he added. In the last 10 years, India has iumped six places, from 11th largest in 2014 to fifth in 2024. The Prime Minister has now set a target of 2029 to make India the world's third largest economy. Latest calculations by the IMF suggest it could happen even earlier, likely by 2027. That would leave the Indian economy behind only China and the United States. Compare this to the target of 2043 set by the previous UPA government while presenting its final budget in 2014. But senior Congress leader P Chidambaram, who had presented that budget in 2014, was not impressed. "China's GDP is five and a half times more than our GDP," he reminded us. Now, Chidambaram's numbers are a bit off the mark. China's GDP is a little under five times our GDP, not five and a half times. But that is not the point. There is a huge gap between India and China. We must deal with this difficult fact. But how did it get this way? To begin with, here are two surprising facts. In 2004, India's economy was about 37 percent the size of China. By 2014, it was only 19 percent. In other words, during the UPA years, India's economic size relative to China was cut in half. Second, when you are shopping, whether online or otherwise, does it ever bother you that so much of our stuff seems to be made in China? But it was not always this way. Would you believe that in 2004, India actually used to run a trade surplus with China? It was a surplus of \$1.75 billion in 2004. By 2014, it had turned into a deficit of \$38 billion! So how did we become so dependent on China? Here is that story. In a surprise result, the Congress party came to power after the 2004 elections. At the time, the world was just entering a period of high growth. For decades, India had been an economic underperformer. But now, everyone was talking about the BRIC (Brazil, Russia, India and China). These four emerging powers were supposed to lead the world. Everything was going upwards: markets, business confidence, economic growth numbers. India on the way to becoming an economic superpower? The UPA government could hardly believe its luck. But the Chinese were only too happy to take advantage of the UPA's giddy feeling. In April 2005, Chinese premier Wen Jiabao visited India. By the 2004-05 financial year, India was already running a small trade deficit with China, about \$1.48 hillion. The Chinese premier must have felt extra welcome in India, because the UPA needed the support of the Communist parties to stay in power. That is when the UPA agreed on its first "trade target" with China. At the time, India's trade with China was worth about a billion dollars a month, or roughly \$12 billion a year. The two countries agreed to raise this to at least \$20 billion over the next three years. But this "target" was achieved quickly. Too quickly, in fact. Chinese President Hu Jintao traveled to New Delhi in November of 2006. India promptly agreed to double the "trade target" to \$40 billion a year. There wasn't much of anything 'bilateral' about this trade. Indian markets were being flooded with Chinese goods. Almost unbelievably, the UPA government did not seem to notice at all. Prime Minister Dr. Manmohan Singh even boasted about it during his visit to China. "Our trade target of \$20 billion by 2008 was reached two years ahead of schedule.

West's glaring double standards on terrorism

The latest example of nations adopting double standards emerged post a drone strike launched by the Islamic Resistance, a pro-Iran group based in Iraq, on a US base in Jordan, killing three US service personnel and wounding 40 more. In retaliation, US air force struck multiple targets in Iraq killing at least 16 civilians and wounding dozens more. The Iraqi government spokesperson responded by accusing the US of 'violating international law and lying about the circumstances surrounding its retaliatory strikes'. Subsequently another US drone strike killed the commander of the Iraqi militia group Kataib Hezbollah, who was an Iranian, on Iraqi soil. Similar strikes also took place in Syria. Both Iraq and Syria objected to the US unilaterally conducting air strikes on their soil. In the UN Security Council, Russia and China accused the US of violating the territorial integrity of these nations. They also accused the US of escalating the ongoing conflicts. But the US was least concerned. This is not the first time that the US has conducted strikes in

Iraq is not an enemy of the US but an ally whose armed forces are being trained by them. Since when is unilaterally launching air strikes and killing scores of civilians as a counter to three soldier deaths by a militant group



legally justified, especially when the nation involved is an ally. The US ignored the criticism of Iraq and did not even bother to respond or address its concerns, treating it as a non-entity, solely because Baghdad lacks military power. At the same time, it continues to demand that India investigate who is behind the attempted assassination of a known anti-India terrorist, Gurpatwant Singh Pannun. Why double standards?

In the West, even joking about hijacking an aircraft or being a member of the Taliban is considered a crime. People are arrested and face jail terms. However, Pannun, who threatened to hijack Indian airlines flights is permitted to do so without even a whimper from the US and Canadian governments. If this is not adopting double standards, wonder what would be. Canada accused India of interfering in their elections. A declassified Canadian government docu-

ment stated, 'India engages in foreign interference activities.' On the accusation the Indian spokesperson mentioned, 'We strongly reject such baseless allegations of Indian interference in Canadian elections, it is not govt of India's policy to interfere in the democratic process of other countries, in fact, quite on the reverse it is Canada, which has been interfering in our internal affairs.' Earlier Justin Trudeau had claimed that India was behind the killing of Hardeep Singh Nijjar, a declared terrorist by India. India refuted the accusation and sought evidence, which New Delhi claims is yet to be received. On the subject of interference, during the height of the farmers' agitation in 2020-21, Trudeau had mentioned, "The situation (farmers protest) is concerning and we're all very worried. Let me remind you, Canada will always be there to defend the rights of peaceful protest." When Amritpal

Singh, the radical Sikh preacher, was arrested in March last year, Canada's foreign minister, Melanie Joly stated, "We are aware of the evolving situation in Punjab, and we are following it very closely. We look forward to a return to a more stable situation." Justin Trudeau stated, "We are looking forward to a swift return to a more stable situation." On Canada's truckers' agitation over which Ottawa applied illegal laws, India's only comments were, 'We have noted that the government of Canada has actually invoked the Emergency Act. Let us leave it at that on that issue.' When comments from leaders of both states are compared, it is evidently Ottawa which is commenting on India's internal affairs, rather than New Delhi, though it accuses India of interference in its internal affairs. Globally, India was criticised over its handling of the farmers' strike, which remained largely peaceful, while Ottawa was backed and supported when it applied emergency laws to forcibly quell the truckers' agitation. Why double standards? Post Tucker Carlson's recent interview of Vladimir Putin, the European Union began considering imposing sanctions on him.

A member of the European Parliament mentioned, "As Putin is a war criminal and the EU sanctions all who assist him in that effort, it seems logical that the External Action Service examine his case as well." The sanction would prevent Carlson from entering the European Union. Simultaneously, European nations have adversely commented on freedom of press in India. Post the detention of Mohammed Zubair in August 2022, the German foreign ministry mentioned, "Free reporting is beneficial to any

society and restrictions are a

cause for concern." After raids on the BBC offices for tax evasion, India came in for western criticism on grounds of curbing press freedom. Not a word was mentioned when the BBC acknowledged in June last year that it has been paving lower taxes in India. Another example of double standards. Globally, India is ranked 161 in the press freedom index while European nations, seeking to impose sanctions on Tucker Carlson just for an interview are considered far more liberal. Simultaneously, those who interview Zelenskyy are praised. What a paradox. When a Surat court sentenced Rahul Gandhi to two years in a defamation case in July last year, leading to his suspension from the Lok Sabha, there were negative comments from the west. Union education minister to head TISS Society, Tata Trusts to have 1 member

MUMBAI: The Union education minister will soon be the chairman of the new Tata Institute of Social Sciences (TISS) Society. The executive council of the premier institute, which will replace the governing board, will be chaired by the vice chancellor and will have four nominees of the education minister and academic representatives from TISS. Tata Trusts, which had two senior members on the governing board, will now have only one member in the society. TISS Society will facilitate the

functioning of TISS, while the executive council will have the power of management and administration. The norms are in line with those of regulatory bodies in central universities.Last year, Centre had decided to bring all institutions that receive over 50% govt funds under its jurisdiction. TISS, a centrally funded deemed-to-be university, has, therefore, been brought under govt's ambit. The drafting of a new memorandum of agreement (MoA) had been pending for some time. The executive coun-

cil, as per the proposed MoA, will replace the governing board of the institute. The agreement said the institute will be fully funded by govt. Earlier, the institute was managed by Tata Trusts and the governing board had a nominee of the trust as its chairperson. But, for some time, Tata Trusts has been funding only a few projects, under which there are ad hoc teaching and non-teaching positions in the institute. As per TISS's 2022-23 annual report, 181 teaching positions are sanctioned.



Fire flowed like lava, it was like a movie scene' in Delhi's Alipur

NEW DELHI: It almost seemed like lava was flowing in the drains when the paint factory went up in flames in northwest Delhi's Alipur on Thursday evening, recalled evewitnesses. A massive blast rocked the area, leaving residents with the sensation of an earthquake. Drums filled with chemicals were flung into the air and then fell on roads, houses and drains, flowing and quickly spreading the fire. "Everything was like we have only seen in movies. Had I not seen it with my own eyes, I would have never believed it," said Rajesh Chaudhary, a shop owner in the Mandir Wali Galli, where the broke out. Eyewitnesses told that the chemicals acted as a catalyst and the blaze spread furiously. Though at least 20 fami-

lies were able to evacu-

ate to safety, eight hous-

es were burnt down.



Sumit Bharadwaj, 40, said that after fuelled by the chemicals, the fire flowed in the drain water and onto the road, affecting many houses. "The flames stood as high as the first floor of the building," Bharadwaj said. "People were screaming and running everywhere. The situation was horrif-

The chemicals on the road caused the fire to erupt, said area resident Deepak. Locals said that labourers were trapped inside the paint factory and were beating at the locked door, screaming for help. A paint drum thudded down in front of the gate and caught

fire due to which rescue became difficult. heard the labourers screaming," said Usha, "and I asked people to break open the door. They tried, but the fire spread in seconds and engulfed the factory." Anil, who runs an alcorehabilitation holics centre adjacent to the factory, said that the impact of the blast broke all his building's windows and slammed chemical drums into the wall. The event was then attended by opposition MLAs, including Gayatri Prajapati's wife and Amethi MLA Maharaji Prajapati. "Irani has fulfilled the promise (of making a house in Amethi and settling as a local resident) she made to the people of Amethi in the 2014 LS elections," said BJP's Amethi spokesperson Govind Chauhan.

asked to respond to the notice within seven days."DGCA has issued Car section 3, series 'M', part I on "carriage by Air - Persons with Disability (Divyangjan) and/or Persons with Reduced Mobility". As per the Para 4.1.7 of the CAR, airlines are mandatorily required to provide assistance to persons with disability or reduced mobility's particular needs and ensure their seamless travel from the departure terminal of the departing airport upto the aircraft and at the end of the journey from the aircraft to the

"Further, an advisory has also been issued to all airlines to ensure that an adequate number of wheelchairs are available for passengers who require assistance during embarking or disembarking from the aircraft during their journey," it added.

An 80-year old man who flew in with his wife, both of them booked as wheelchair passengers on an Air India flight from New York, collapsed at Mumbai airport immigration counter and passed onMonday.

The deceased was an Indian-origin, US-passport holder. They had pre-booked Air India's wheelchair facility. The Gujarati coupie was booked in economy of Mumbaibound Air India flight AI-116 that left New York on Sunday afternoon. The flight landed in Mumbai at 2.10pm on Monday.
