Atishi sworn in as Delhi's youngest chief minister, takes charge ahead of 2024 polls

NEW DELHI:

Atishi was sworn-in as the chief minister of Delhi on Saturday, making history as the youngest leader to hold the top position. She has become the third woman CM of Delhi, following in the footsteps of Sushma Swaraj and Sheila Dikshit. Five cabinet ministers including Saurabh Bhardwaj, Gopal Rai, Kailash Gehlot, Imran Hussain and Mukesh Ahlawat also took the oath of office during the ceremony which was held at Raj Niwas. This marks the fourth consecutive AAP government in the capital. Atishi's parents, Tripta Wahi and Vijay Singh, were present during the ceremony at Raj Niwas.

At 42, Atishi has become the 17th female chief minister in India. However, her tenure will be brief, as Delhi's assembly elections are slated for February next year. Despite the short time frame, her government faces the challenge of fast-tracking several key policies and welfare schemes, including the Mukhyamantri Mahila

Bengaluru horror: Woman's body found inside fridge, chopped into over 30 pieces; probe underway



NEW DELHI: In a gruesome discovery, the dismembered body of a 29year-old woman was found stuffed inside a refrigerator in Bengaluru. The body was chopped up into over 30 pieces, according to the police. Authorities have identified the victim as Mahalakshmi, though details surrounding the incident remain unclear. The shocking incident is believed to have taken place approximately a week ago.

Additional Commissioner of Police (West Zone) N Satheesh Kumar said, "A woman's body was found chopped into pieces and stored in a fridge at a house within the Vyalikaval police station limits.

It appeared to have been done 4-5 days ago."

Senior police officers have cordoned off the area surrounding the building where the body was discovered.


The victim, who was originally from another state but had settled in Karnataka, was living alone in the house at the time of the incident.

The dog squad and forensic experts have been called in to assist with the investigation.

It has been reported that the woman was living separately from her husband, who worked in a hermitage away from the city. Upon learning about the incident, he arrived at the scene. The brutal nature of the crime has drawn comparisons to the murder of Shraddha Walker by her live-in partner Aftab Poonawalla in Delhi last year in which the suspect killed her and cut

However, he did not start as an opening batsman. Sehwag began his Test career under Ganguly's captaincy in 2001, debuting against South Africa Bloemfontein, where he batted at the fourth position and scored a century. Bail rejected for accused of embezzling Rs 50 crore from investors by creating fake company

Prayagraj: Ravindra Kumar Verma, accused of embezzling about Rs 50 crore from investors by fraudulently using different names and registering the company in different names on the basis of fake documents, has not got relief from the Sessions Court. District Judge Santosh Rai, after listening to the defense counsel and DGC Gulab Chandra Agrahari, said that by registering the company in different names on the basis of fake documents, they were luring the investors by making fake schemes and brochures and by counterfeiting fake bonds, the investors were cheated. The active role/participation of accused Ravindra Kumar Verma is being shown in the crime of illegally embezzling crores of rupees through deceit and fraud. The above case falls under the category of economic offence. The 28 criminal history of the accused shows that all the cases are related to fraud and forgery. From which the conclusion seems to be drawn that if the accused is released on bail, he may get involved in a similar crime again. There is no sufficient basis for bail. According to the prosecution, the plaintiff Rajendra Kumar had lodged an FIR through Section 156 (3) application in Naini police station on March 7, 2019, alleging that he had met Nafees in 2018. He told that he is direct in Awesome Infra Projects Limited Company. The company invests people's money through FD/RD etc. After that he made people invest about Rs 3 crore in the company. After some time, when the company stopped paying the monthly interest and returns to the investors, when Nafees and other directors Ravindra Kumar Verma, Amarnath and Dharmendra Kumar Singh were contacted, they told that the payment had been stopped from the level of CMD Krishna Kumar Verma. It has happened. When they talked to Krishna Kumar Verma, he said that investors have lost their money due to demonetization and GST. Now that money will not be returned. When the plaintiff inquired, he came to know that there was an organized gang of Krishna Kumar Verma, Nafees, Dharmendra Kumar Singh, Amarnath and Ravindra Kumar Verma, who were fraudulently using each other's names by interchangeably and on the basis of fake documents. Crores of rupees have been embezzled from investors by committing fraud under different names.

Rs. 3.84 crore embezzlement case: CJM court quashes FR, orders re-investigation

Prayagraj: Chief Judicial Magistrate (CJM) setting aside the Final Report (FR), which was filed by Civil Lines police in Rs. 3.84 crore embezzlement case. After investigating the FIR, which was registered on the complaint of BHS Principal DA Luke against Bishop Morris Edgar Dan, ordered re-investigation prosecution in FIR - CRIME

NO. 315/2023 under section 419, 420, 467, 468, 471, 406, 506 IPC was registered on the complaint of BHS Principal DA Luke, in which complainant alleged that in the year 2002, the Income Tax Department conducted a raid in which, some important document including FDR and Rs. 3.84 crore cash was seized by officials of IT Dept. Later, school administration ap-

proached the High Court for justice. The court after hearing the petition filed by complainant, the Income Tax Department released the seizure, which they obtained from BHS. Taking action on the High Court order, Income Tax Department shot off a letter to the then, Bishop Morris Edgar Dan, who hatched a conspiracy along with his aide HR Mall and opened a

new account in the name of Allahabad High School Society in Axis Bank Civil Lines branch by claiming himself to be the chairman and HR Mall as secretary. The later got transferred Rs. 3.84 crore in Axis Bank account.

Rs. 3.84 crore was to be used in the new educational work of the school, but knowing all these things, Morris Edgar Dan, H.R. Mall and

Daniel Suman after withdrawing the entire amount from the account, the said account was closed by these people. These people defrauded Axis Bank, Allahabad and embezzled Rs 3 crore 84 lakh from the school, which was revealed by examining the detailed income tax refund statement number 91101005 of Axis Bank Civil Lines branch. Skilled construction workers of UP will get employment in Israel

Prayagraj: Construction workers of UP once again have an opportunity to get employment in Israel. Under the agreement between India and Israel, the registration facility on the Rojgar Sangam portal has started for the fame work/shuttering carpenters and ceramic tile workers of Uttar Pradesh. It is noteworthy that the selected construction workers will be sent to Israel for

two years at a pay scale of Rs 1,37,500. Workers working in Israel will have the opportunity to serve for at least 2 years. Apart from this, workers will also be provided insurance cover and experience certificates, which will improve their future employment prospects. Applicants have to follow the conditions to avail these employment opportunities. The age of the applicant should be

between 25 to 45 years. He must have a passport of at least 03 years validity. Also, at least 03 years of work experience in the relevant trade is also mandatory. Apart from this, not having worked in Israel before is also included in the qualification. Other related conditions and qualifications are given on the employment department's portal rojgaarsangam.up.gov.in. Israel's Population,

Immigration and Border Authority (PIBA) will lead the process of selecting workers. In the first phase, the English language knowledge of the workers will be assessed. This evaluation will be done by the Principal of the nodal ITI of the district and the District Employment Assistance Officer. This pre-screening process will be the first step in sending workers to Israel. Workers who are

successful in prescreening will be given training under RPL. After this, the vocational skills test will be conducted by the Israeli organization PIBA. The workers who are successful in this test will undergo police verification and medical examination. In the context of this initiative, Minister of State (Independent Charge) for Vocational Education, Skill Development and

Entrepreneurship, Kapil Dev Aggarwal said that this agreement will provide a golden opportunity to our skilled construction workers to prove their worth on the international platform. Working in Israel will give them better employment opportunities, which will also improve their standard of living. He also said that this scheme will further deepen ties between the two countries and give our con-

struction workers an opportunity to make their mark on the global stage. Following the signing of the G2G (Government-to-Government) agreement in November 2023, NSDC All states were contacted for the recruitment process. In the first phase of recruitment, workers from Uttar Pradesh, Haryana, and Telangana were selected. 9327 skilled workers were sent to Israel from Uttar Pradesh. A Framework Agreement for Temporary Employment of Indians was also signed between India and Israel in May 2023. Under this, all workers sent through G2G are given mandatory orientation training before departure. In this training, information is given about Israeli culture, the way of life there and the new home, so that the workers can quickly adjust to the environment there.

Putin did a surprise reshuffle

The President has chosen deputy prime minister and long-time economic advisor Andrei Belousov to replace Shoigu, who in turn has replaced Patrushev. The latter's new appointment remains unknown. The move is being seen as an effort to reduce the unsustainable and soaring costs of the war in Ukraine. It also challenges the narrative that the Russian economy is unaffected by the sanctions in the long-standing war. For 2024 alone, Putin has allocated \$117 billion for the special military operation against Ukraine. His war economy runs feverishly in an overheated mode. Most international estimates state that 7.5 per cent of Russia's GDP is directed to the militaryindustrial complex although Kremlin's official estimates claim it is 6.7 percent. It is a rare submission of a rising-cost problem from Putin, who had preferred to continue with his hunting-holidaying excursions pal Shoigu despite repeated allegations of systemic corruption and inefficiency against him for years. These allegations became the order of the day when mercenary group Wagner, led by Yevgeny Prigozhin, was brought to deliver victory in the infamous battle for Bakhmut in 2023. Putin's slighting of Prigozhin's outright allegations against Shoigu and Chief of General Staff Valery Gerasimov led to the incredible Wagner mutiny against the two generals, which ended up with Prigozhin's death in uncanny circumstances. It, however, unleashed an investigation into rampant corruption inside Russia's military leadership, of which Prigozhin had become the most notorious victim. Russia-watchers had an inkling of Shoigu's exit after Prigozhin and his aides were made to bid adieu into the flannel skies, and many corrupt links started to get exposed in the Ministry of Defence. The inkling became stronger as Shoigu's deputies, including Timur Ivanov, got arrested on corruption charges last month. Soon, two other deputy defence ministers allegedly backdated their resignations before 9 May, or the Soviet Victory Day. The Russian army was supposed to make an impressive win in Chasiv Yar on the eastern front but had to make do with American tanks captured at a small village called Berdychi when Ukranians retreated, running out of ammunition to fire. All has certainly not been going as planned. The latest reshuffling in key defence and security offices has been Putin's biggest shake-up in the past 15 years. There are two reasons for this. One is ensuring economic efficiency at a time when the stakes are very high for Russia and Putin. And two, Shoigu's leadership has not been able to yield the anticipated results in the Ukraine war. His current appointment is a step-down with little direct authority. Getting an economist like Belousov in the key position of a defence minister also shows that Putin is preparing for the longer haul. It is a solemn reiteration that the Ukraine war has indeed been reduced to a grinding war of attrition, with both sides lacking the capabilities to end it anytime soon. Europe's combined strategies to support Kyiv militarily won't come to fruition until mid-2025. American aid and the conditionalities attached are likely to help Ukraine stay afloat, but not gain a decisive edge.

That said, Russia, too, has been astonishingly lacklustre in exploiting the window of opportunity that had remained open for the last six months as Ukraine was outgunned and outnumbered with a lack of troops and ammunition. Despite the high intensity, war-economy

33-yr-old Rajasthan bureaucrat dies after botched surgery: What went wrong?

A Rajasthan bureaucrat passed away on Wednesday night following surgery at a Jodhpur hospital. She died at a hospital in Ahmedabad two weeks after she underwent surgery at a private hospital in Jodhpur on September 5. Her family has accused the doctors of negligence, claiming she was administered an "excessive dose of anaesthesia." Her demise has sparked anger in the community, and an inquiry has been ordered after the allegations.




Legal Procedure to Report Online Cheating and Fraud: Amit Manchanda

Delhi: With the rise of technology and internet use, cybercrime has become one of the most common crimes. WFH culture has caused a tremendous increase in these situations in our country. Therefore, this article discusses the laws and procedures for reporting this offense. The Ministry of Home Affairs/National Cyber Crime Reporting Portal defined cyber crime as "Any unlawful act where a computer or a communication device or a computer network is utilised to commit or facilitate the commission of crime". Different cyber crimes exist today. When investigating internet cheating and fraud, many offenders use viruses, trojans, and worms. Online auctions and job offers let crooks commit financial and money laundering crimes. Phishing involves stealing credit card and password information from victims via fake websites. The 2000 Information Technology (IT) Act, revised in 2008, governs most cyber crimes. The Indian Penal Code, 1860, also addresses the crime, which can be confusing. Hacking and data theft are covered by Sections 43 and 66 of the Information Technology Act and Sections 378 (Theft), 424 (Dishonest and fraudulent concealment), and 425 (Mischief) of the Indian Penal Code. Identity theft protection and online cheating are covered by Sections 66C and 66D of the Information Technology Act, 2008. The court also upheld interception under Section 69A and Section 79, which govern intermediary liability. This ruling reiterated that any law, virtual or real, must comply with the Indian Constitution. The 2002 Anti Money Laundering Act also addresses cybercrime in several Indian sectors. This Act aimed to seize money-laundering-related property. Since the Information Technology Act, banks must keep electronic records properly. Bank e-Records Maintenance Policies are a model.

Pul Prahladpur railway underpass eliminated from water logging areas

Delhi: PWD officials claimed the railway underpass at Pul Prahladpur in southeast Delhi, which was famed for flooding every monsoon until a year ago, had been removed from the waterlogging hotspot list. Over time, the wet underpass became notorious for drownings. Every monsoon, it would be closed to traffic, causing delays. A senior PWD official said waterlogging has afflicted the site for 20-25 years, but it worsened in the last years. 10-15 He blamed the worsening condition on a Delhi Jal Board sewage pumping plant in Khanpur. Drain sewage overflowed onto highways during monsoons, causing waterlogging. "The old pump house was a few meters from the main road, and by the time the water reached it through the

pipes, it would have



spiraled out of control," he said. The official said a 7.5-lakh-litre sump and a pipeline were built to empty storm water into a neighboring Municipal Corporation of Delhi drain. To drain the water and clean the underpass, a permanent pump building with six 100-horsepower motors was built. Future growth is possible, and two additional pumps can added, spokesman said. He

said the agency has

two pumps attached to a two-foot, 600mm-diameter conduit to flush water into an open drain. Other problems included plastic and other solid trash clogging pipes in the sewage. The official added these positive

Aundh-Baner residents grapple with inadequate garbage disposal problem and its consequences

Ill-equipped waste disposal systems, leading to garbage getting piled at various points, is a cause of worry for residents of Aundh, an area which is otherwise considered as one of Pune's most developed and progressive zones. Residents are concerned about the problems that could be caused by frequent dumping of trash at various spots in the Aundh-Baner areas, such as those between Jupiter Hospital and Nagras Road. "I know there are these agencies that dump garbage anywhere in Aundh; there are specific spots. There is no control at all," noted Subhabrata Sanyal, 51, a resident of Kumar Padmalay. He said the waste menace could also draw in more stray dogs, posing a threat to people going for morning and evening

"When you walk onto the streets, you can see food littered all over, that attracts stray dogs. In case we go near the garbage by mistake, these animals could even attack us," observed Deepa Adiga, 47, a resident of Sylvan Heights. Residents blamed lack of a proper collection system by the municipality for the mounting garbage piles. "Sometimes the municipal truck may be arriving at a particular time and the waste is generated later, particularly by restaurants where the waste is generated very late at night, post 11 pm or midnight, after the restaurant is closed," said Anil Gokarn, founder of ProEarth Co., a company that deals with effective waste management.



No request yet from Nikhil Gupta for consular access: MEA

New Delhi: Indian authorities haven't received any request for consular access from Nikhil Gupta, the Indian national extradited to the US from the Czech Republic following allegations of his involvement in a foiled plot to assassi-Khalistani extremist Pannun. Gupta, who was arrested in the Czech Republic in June last year, was extradited to the US on June 14. "He was extradited to the US on June 14. We have so far not received any request for consular access from Gupta but his family has got in with us," touch Affairs External Ministry spokesperson Randhir Jaiswal said. "We are in touch with the family mem-



bers and are looking at the matter as to what can be done on their request," he said during his weekly media briefing while replying to a question. Gupta, 53, pleaded not guilty when he was produced in a court in New York on June 17. While Gupta was in custody of Czech authorities, Indian officials were given consular access to him on a few occasions. Last November, US federal prosecutors charged Gupta with working with an Indian government

employee in the foiled plot to kill Pannun in New York. Pannun, wanted in India on terror charges, holds dual of the US and Canada. The issue of consular access to Gupta would be decided in line with provisions of the Vienna Convention Consular of 1963, people familiar with the matter said. Article 36 of the Convention states that a detained person will have to make a request for consular access to authorities of his or her country. "Nevertheless, consular officers shall refrain from taking action on behalf of a national who is in prison, custody or detention if he expressly opposes such action," the article states.

India's defense exports surpass 21,000 crore

Delhi: India's defense increased exports 32.5% this year, surpassing 21,000 crore for the first time, with the focus on enhancing domestic production and military exports, according defense ministry. Defence exports reached record

21,083 crore (US\$ 2.63 billion) in FY 2023-24, a 32.5% increase over the previous fiscal year's 15,920 crore.

The ministry stated that defense exports had surged 31 times in the previous decade compared to FY 2013-14. It claimed the private sector contributed

60% and DPSUs 40%. and export authorisations grew from 1,414 in FY 2022-23 to 1,507 in FY 2023-24.

India's defense exports hit Rs.21,083 Crore in 2023-24, a 32.5% increase over the previous fiscal, defence minister Rajnath Singh wrote on X.

Brokers increase margin trading fees because they anticipate increased volatility

Delhi: Some stock brokers have increased the cost of trading for their clients in anticipation of heightened volatility surrounding the Union Budget and the US Federal Reserve's policy meeting, two events that could influence the direction of the market in the near future. Customers of these brokers must pay up to 100% upfront margin for any new positions inside the margin trading facility (MTF) in the cash sector beginning in the first week of February in order to discourage traders from taking unnecessary risks in the event of severe swings.

Government considers 5% diesel ethanol blend

Delhi: The government is considering a 5% ethanol blend in diesel (ED-5) to reach its aim of 20% ethanol in fuel within two years. The Prime Minister's Office (PMO) met with all relevant departments last week to consider this new plan, according to media reports. June ethanolgasoline blends hit 15.9%, advancing the government's aim.

The report also said the administration is preparing for diesel ethanol mixing. Blending ethanol with diesel would enhance production of this green fuel, but also has environmental advantages and reduces crude oil imports, saving foreign cash, said an official. BS-III and BS-IV buses were tested for 500 hours to determine performance, emissions, and durability. Despite somewhat lower fuel usage than diesel, there were no severe breakdowns.
