NEW DELHI: Finance minister Nirmala Sitharaman Wednesday hit back at the opposition's "Trojan Horse" remark the in the backdrop of the Centre bearing Rs 12,000 crore towards Jammu & Kashmir police.

The opposition had expressed apprehension that the Centre financing the Jammu & Kashmir police might have been a part of a plan to "retain" the home affairs of Union territory with the central government -- calling the decision a "Trojan Horse" approach. Lashing out at the opposition during her reply to the Union Budget, Nirmala Sithraman said if at all there was a "Trojan Horse", it was Article 35 and Article 370 -- which kept J&K away from being integrated.

Gadkari asks FM Sitharaman to withdraw 18% GST on life, medical insurance

NEW DELHI: Union minister Nitin Gadkari urged finance minister Nirmala Sitharaman to withdraw the 18 per cent Goods and Services Tax (GST) levied on lite and medical insurance premiums, calling it a "tax on the uncertainties of

In the letter addressed to the FM, Gadkari said: "Main issue raised by the Union is related to withdrawal of GST on Life Medical Insurance Premium.

Both life insurance and medical insurance premiums attract a GST rate of 18 per cent. Levying GST on life insurance premium amounts to levying tax on the uncert "The Union feels that the person who covers the risk of life's uncertainties to give some protection to the family should not be levied tax on the premium to purchase cover against this risk. Similarly, the 18% GST on medical insurance premium is proving to be a deterrent for the growth of this segment of business which is socially necessary. Therefore, they have urged withdrawal of GST as mentioned above," he added. The minister noted that the Union has put forth several suggestions, including the provision of Differential Treatment to Savings through Life Insurance policies. Additionally, they have advocated for the reinstatement of Income Tax deductions for health insurance premiums individuals. paid by Furthermore, the Union has proposed the consolidation of public and sector general insurance companies, with the aim of streamlining operations and

LUCKNOW: The Uttar Pradesh assembly is on Tuesday scheduled to take up for consideration and passing a bill that seeks to amend Unlawful Conversion of Religion Act to increase the maximum punishment to life imprisonment and fine of Rs 5 lakh for violators.Under the amended provisions of the Uttar Pradesh Prohibition of Unlawful Conversion of Religion Bill, 2024, if a person threatens, attacks, marries or promises to marry or conspires for it, or traffics a woman, minor or anyone with the intention of conversion, then his crime will be placed in the most serious category. The amended bill provides for 20-year imprisonment or life imprisonment in such

For example, a plastic chemical called 6PPD is added to the rubber of vehicle tires to make them Tires and shoes contribute to 50% of micro-plastics in the environment stronger. Similar chemicals are also added to shoe soles. This chemical is extremely toxic.

A study conducted at Vienna University of Austria states that such tires and shoes contribute 50% of micro-plastics in the environment. The steps taken to save the earth from this terrible disaster are negligible, not only single use plastic is a danger, but every plastic is a curse on life on earth, the nature of plastic is that it loses its flexibility with time and becomes brittle and breaks down to micron and nano size, this process of plastic breakdown accelerates in sunlight and corrosive environment. Thus, plastic lying in the open environment has reached the air we breathe, water, our food chain. The awareness of the public is also insufficient to deal with disaster, because what

The Public **Examinations** (Prevention of Unfair Means) Bill, 2024 that has provision for up to five years' imprisonment and a fine of up to Rs. 1 crore for malpractices and organised cheating in government recruitment exams, was notified by the Union government to come into



Verge of a cascade of conflicts

The world today appears to be on the verge of a cascade of conflicts. Over two years since it started, the Russia-Ukraine war does not seem to be heading towards an imminent settlement. Likewise, despite calls for a ceasefire, the Israel-Hamas conflict appears unlikely to abate anytime soon. And now, events over the past month involving Israel and Iran have demonstrated the potential for a wider regional conflict. While the wars in Eurasia and the Middle East may seem disjointed and seeped in their own historical and political contexts, they are also interconnected in a broader sense of the emerging great power competition for the future of the world order. What we are witnessing today is an era of great power competition in an increasingly multipolar world. The US and China are the chief protagonists in this new order, although each is constrained by its domestic politics and capacities. This creates a certain power vacuum, but also space for autonomy of action, balancing and bandwagoning, and even adventurism by middle powers. In this environment, while there are no distinct blocs that have emerged. there are certain alignments that are becoming more prominent. For instance, NATO seems to have found a fresh purpose following Russia's assault on Ukraine, but there are deep concerns related to American policy continuity. Likewise, there is the emergence of a Russia-Iran-China axis based on common interests and grievances with the West. But there are limits to the nature of support that each lends to the other. After years of mutual antagonism, Israel and Iran now appear to be on the brink of a new conflict. The proximate cause for this can be traced back to Israel's frustration with what it argues is Iranian support for Hamas, and other groups such as the Hezbollah, the Houthis, the Syrian government and groups in Iraq. Over the course of the past month, the two countries have engaged in a cycle of attack and counter-attack. Neither seems to desire a major escalation. But the ladder of escalation often follows its own logic, which can put the best-laid plans to waste. Two strategic outcomes can be observed amid these recent events. First, the persistence of the war in Gaza and the emerging spillovers have exposed the limitations of American and Chinese power, particularly since the situation does not necessarily serve either's strategic interests. Second, there is a clear alignment, albeit with increasing friction, between the US and Israel. The US has been at the forefront, supporting Israel in its war against Hamas, and led its defence amid the recent Iranian strikes. It is interesting to note that this effort was supported by regional actors like Saudi Arabia, the UAE and Jordan. In addition, options to coerce Iran economically are being discussed in both the European Union (EU) and the US. On the other hand, China and Russia have been critical of Israeli actions since October 2023. Amid the Iran-Israel tensions, Beijing has backed Iran and sought to preserve its tenuous effort at reconciliation between Saudi Arabia and Tehran. Russia, meanwhile, has become Iran's largest military backer since 2022 and threw its diplomatic weight behind Iran's "retaliatory measures" on April 14 against Israel. On the other side of the world, the war in Ukraine is well into its third year. The conflict has fundamentally reshaped European geopolitics and geoeconomics. The war has re-energised transatlantic unity for the moment. However, the direction of American domestic politics has a significant bearing on this momentum. Beijing has sought to straddle the line in Europe by trying to appear neutral while backing the Russian call for a new regional security architecture. It has supported Russia's defence industrial complex with the supply of dual-use items, but has been cautious to avoid direct weapons support. Russia, meanwhile, has eco-

There's A Deeper Problem

According to the India Meteorological Department's (IMD) latest forecast, India is expected to receive above-normal rainfall during the upcoming June-September southwest monsoon season. This is great news after a gap of eignt years; 2016 was when India experienced decent rain. The country's dependence on monsoon can be gauged from the fact that it receives about 70-90% of its annual rainfall in the four months of June-September. Normal monsoon has a direct impact on the country's economy. Evenly-distributed rainfall is crucial for the 61% of Indian farmers who are dependent on monsoon for agriculture. A positive monsoon enhances agricultural production, which in turn boosts the country's economy and

enhances food security. Over the last few dwindling decades, resources have led to overuse of groundwater. According to the Central Groundwater Board of India, 18% of India's groundwater assessment units are overexploited or critical, meaning that the rate at which water is extracted is higher than the rate at which the aquifer can recharge. The overuse of groundwater for agriculture has increased since the 1960s, especially after the Green Revolution. To fulfil requirements, a largely ungoverned groundwater irrigation economy has mushroomed in rural areas. Increased availability of borewells and free or subsidised electricity have allowed farmers to withdraw groundwater at will, leading to the resource's overexraises concerns given

that about 75% of the annual groundwater recharge takes place during the southwest monsoon. With climate change altering monsoon patterns, these recharge cycles can get disrupted, consequently leading to high crop tailures. The **Election Commission of** India (ECI) has repeatedly defended EVMs as non-tamperable, citing technological measures and strict administrative and security measures taken by the poll body. Unfortunately, Rangarajan, the man who designed the EVM, is no longer here to defend the device that has drastically reduced the time taken to count votes. However, he was more popularly known as 'writer Sujatha' among the most prolific writers in Tamil - who wrote thrillers, science fiction, human drama, critiques on Tamil classics, and explained science and technology. Delhi Skills University "revokes" EWS, SC/ST fee concession; no clearance in place

Delhi: On July 9, a second-year Scheduled Caste student at Delhi Skills and Entrepreneurship University (DSEU) requested a fee waiver from the academics department. The student, enrolled in the Bachelor of Business Administration (Facilities and Hygiene Management) study at the main campus in Dwarka, was advised to pay the same course fee as 2022-23 students without a waiver. "SC students paid Rs 45,140. We must pay Rs 56,700 (the 2022-23 batch's standard fee)," the youngster said. This BBA course costs this year. Students, reeling from a significant cost spike across most programs, claimed DSEU has abolished the 10% fee concession for EWS students and 20% for



SC and ST students, which the institution disputed. Students' group Aawaz protested by posting posters on 22 campuses asking: "Why does DSEU revoke aid for SC, ST and EWS students... (sic)." According to DSEU Vice-Chancellor Prof Ashok Kumar Nagawat, "SC/ST and EWS students do not currently receive fee concessions. finance committee will decide on concessions, but until then, no action can be made because of audit objec-

The V-C declined to comment on how concessions from last year approved. "Waivers will be discussed in the meeting," Nagawat said. Professor Gagan Dhawan, Registrar, said.



Studies show polluted air increases Type 2 diabetes risk

Delhi: Air pollution may increase Type 2 diabetes risk. Air pollution, especially PM2.5, is known to cause chronic lung ailments, heart attack, stroke, and cancer, but the diabetes argument is gaining ground. Several research from the US, Europe, and China have shown the association, but a new two-city study from India found that even a 10 g/m3 increase in PM2.5 exposure raises blood sugar. Mumbai-based JAPI (Journal of Association of Physicians of India) published an editorial



Pollution: A New Cause of Type 2 Diabetes?' this month. Diabetes specialist Dr. V Mohan from Chennai wrote, "We now know that PM2.5 is an endocrine disruptor that affects insulin

The daily capacity of each facility will increase by 1,000 tonne. On July 7, the Delhi Electricity Regulatory Commission approved the Okhla plant's 40 MW increase from 23MW, a senior MCD official said. The Tehkhand plant proposal is also seeking environmental permission, the official said. The Okhla plant

processes 1,950 tonnes

of garbage daily, and with another boiler unit, we can feed 2,950 tonnes of new waste daily. The source said the Okhla facility received environmental permission last year and will raise its power output from 25MW to 40MW by increasing its capacity from 2,000 tonne to 3,000 tonne. Shahdara North generates 1,250 tonne of waste daily and South 1,200. Most of this goes to the Ghazipur landfill, but its WtE can only process 1,300 tons per day. According to a February 2023 report to the submitted National Green Tribunal (NGT), Delhi generates 11,332 tonne of waste daily, 8,066 of which are processed by segregation, recycling.

IT hiring is improving, but firms are wary



Delhi: LinkedIn and other leading job sites said that top IT services companies' active hiring rose to 82,000 in March from 50,000 in January, the first growth in 20 months. However, due to declining attrition, the top IT services businesses' collective gross hiring declined 4-6% QoQ in the quarter ending March, according to Xpheno's study for ET based on talent movement patterns in January-March. Wipro, Infosys, TCS, HCL, LTI Mindtree, Technology Services, Tech Mahindra, and Cognizant were exam-

ined. "While gross hiring (attrition refills and fresh hiring) has been low and declining for eight quarters, the current rise in active demand denotes a return of hiring for capacity in the ITS cohort," Anil Ethanur, co-founder of X Gross hiring volume for the quarter ending March 2024 may be the lowest in over two years due to the 4-6% reduc-

Despite the drop in gross hiring, fewer exits will result in a headcount degrowth than last quarter "and IT sector consultants said FY25
