## RBI lifts digital lending curbs on **Bajaj Finance after 6 months**

MUMBAI: RBI has lifted digital lending restrictions on Bajaj Finance nearly six months after it imposed them for violation of its guidelines. RBI had, on Nov 15, 2023, directed Bajaj Finance to halt loan issuance through its 'eCOM' and 'Insta EMI Card'.

RBI had imposed the restrictions due to a lack of transparency and disclosure of conditions like fees, charges, and recovery practices in a key fact statement, which is a crucial requirement for digital loans.

The EMI card allows customers to shop with a flexible repayment tenure for purchases of consumer goods and electronics without an additional cost. Similarly, the eCOM product enables online purchases on platforms such as Amazon and Flipkart through loans.

Bajaj Finance informed the stock exchanges that RBI, based on the remedial actions taken by the company, has

#### SIT to charge Prajwal with rape as 2nd woman alleges

**BENGALURU:** The alleged sexual harassment and sleaze videos case against former PM HD Deve Gowda's grandson, Hassan MP Prajwal Revanna, took a grave turn on Thursday with another woman alleging she also was sexually assaulted by him.

Based on her statement, the special investigation team (SIT) probing the case has been allowed to invoke rape charges against him under IPC Section 376.

Karnataka home minister G Parameshwara said Prajwal was "able to leave the country only because of the diplomatic passport issued to him by the Centre". said He Siddaramaiah has written to the Centre seeking the immediate revocation of Prajwal's diplomatic passport.

With this, the noose around Prajwal and his father HD Revanna will tighten as they were earlier charged with bailable offences under IPC Sections 354A (sexual harassment and punishment for sexual harassment), 354D (stalking), 506 (punishment for criminal intimidation) and 509 (word, gesture or act intended to insult the modesty of a woman). Sec 376 is a cognisable and non-bailable offence entailing over 10 years in jail.Congress politician Rahul Gandhi alleged on Thursday that suspended JD(S) functionary and Hassan MP Prajwal Revanna had "raped 400 women" and recorded videos of the assaults. Calling Prajwal a "mass rapist", he accused PM Modi of endorsing Prajwal by soliciting votes for him in Karnataka.The first woman who lodged the complaint against Prajwal and his father worked in their household as domestic help. The second woman, who allegedly figured in one of the sleaze videos.

## Commr, demanding proper investigation in fake case

#### Filed with intention of tarnishing political and social image of Anurag Sant

Prayagraj: BJP leader Poonam Sant on Wednesday came down heavily over fake cases being registered on frivolous complaints, sans proper probe by investigating authorities. It is worth mentioning that her son Anurag Sant has been recently implicated in a false case. The slow pace of investigation into allegations levelled against him, complicating their problems. He has been made an accused in the case filed in Dhumanganj police station, allegedly by Virendra Kumar, son of Panna Lal, resident of Gayasuddinpur.

If the assault took place, then where is the medical checkup report of the plaintiff? There is nothing clear in the entire case, this case has been fabricated and prepared fraudulently, my son Anurag Sant is a businessman and a grassroots leader associated with BJP, recently his name was also prominent in the claim for ticket from Kaushambi Lok Sabha, A fake case has been filed by some so-called people with the intention of tarnishing his political and social image by preparing a fabricated story," she opined. Poonam Sant has made this demand in the application given to the Police Commissioner. That the entire incident should be properly investigated and legal action should be taken against the culprit, so that in future no one can file a false case against anyone due to malicious intent. And such incidents should not recur in the future.

#### New criminal laws: An era of accountability, transparency and justice

The Central government has notified that the three new criminal laws, namely the Bhartiva Sakshya Sanhita (BSS), Bharatiya Nyaya Sanhita (BNS) and Bharatiya Nagarik Suraksha Sanhita (BNSS), which aim to replace the colonial era Indian Evidence Act 1872 (IEA), Indian Penal Code 1860 (IPC), and Code of Criminal Procedure 1973 (CrPC), will come into effect from 1 July 2024. One of the most appreciable measures in the enactment of the new criminal laws has been the insertion of the words "electronic and digital records" in the definition of "document" in section 2(1)(d) of the BSS. The scope of "documents" in the new BSS has been widened and made futuristic to include server logs, locational evidence, voice mail messages stored on digital devices...etc. In the IEA 1872. the definition of "document" did not specifically include electronic records. For the admissibility of electronic records in evidence, compliance with Section 65B of IEA 1872 was required. To ease the process further, two new forms have now been included in the schedule of the BSS, which will not only authenticate the collection process but also speed up the appreciation process of digital evidence. These reforms in the domain of "electronic evidence" will help in plugging the loopholes that were present in the IEA 1872. In CrPC 1973, there was no specific provision for Zero FIR. Zero FIR means an FIR registered by the police in case of a cognisable offence, irrespective of the jurisdiction. Earlier section 154 CrPC provided for the registration of FIR but not Zero FIR expressly. Now, section 173(1) of BNSS explicitly provides that every piece of information disclosing the commission of a cognizable offence\_, "irrespective of the area where the offence is committed"\_, may be given orally or through electronic means to the police. In many instances, the police refuse to register an FIR, citing a lack of jurisdiction, and the helpless victims or complainants have to run from pillar to post to get an FIR registered. The new BNSS, by clearly providing for Zero FIR, will ensure that no common man faces difficulty in getting an FIR regis-

Section 173 further mandates that when such information related to the commission of a cognizable offence is communicated electronically, it shall be "taken on record by him (police officer) on being signed within three days by the person giving it." It will ensure that FIR is registered in a stipulated time without any delay. Section 105 is a new provision added to the

Section 105 mandates that search and seizure made by the police, including preparing the list of seized items and signature of witnesses, shall be recorded through audio-video electronic means. It further obliges the police officer to forward such recording "without delay" to the District Magistrate, Sub-Divisional Magistrate, or First-Class Judicial Magistrate. Section 105 of BNSS will ensure more transparency and curb the misuse of police powers by eliminating any likelihood of the police planting fake evidence. A new sub-section (3) has also been added in section 176 of BNSS, which provides for the procedure for investigation by the police. Section 176 was section 157 in the old CrPC. The newly added sub-section (3) specifically provides that where an offence is punishable with imprisonment of seven years or more, a forensic expert shall visit the crime scene to collect the forensic evidence. It further provides that such process of evidence collection shall be video recorded. It is a noteworthy step towards greater transparency and accountability in evidence gathering by the investigating agencies.

## India and Mauritius: Gateways to Africa, investment and development

**Prime** Minister Narendra Modi and Prime Minister of Mauritius Pravind Jugnauth jointly inaugurated several infrastructure and connectivity projects in the strategic island nation on 29 February. Prime Minister Modi also recalled his promise given to the people of Agalega island, who have been disconnected from the mainland. He even reiterated the catchphrase 'Modi ki Guarantee' in the context of India's fulfilment of promises even in the context of foreign domains of development as India continues to support the developmental aspirations of friendly people in the Global South while becoming their voice at the global stage. Fighting for their cause in an unjust world has been a major marker of Indian foreign policy. India and Mauritius are crucial and critical in the Indian Ocean Region which is facing increasing traditional and non-traditional threats. As the maritime collaboration continues to expand within and beyond the confines of SAGAR(Security and Growth for All in the Region) doctrine and IORA(Indian Ocean Regional Association) the outreach of India's non-reciprocal "Neighbourhood First" and "Link Africa Faster" encompasses the fulfillment of developmental aspirations of the Mauritians – 70 per cent of whom are of Indian



origin, courtesy the French and British colonialism.

Mauritius since 2005 has been a gateway to foreign direct investment and often aced the charts for the highest investment being routed through Port Louis into India due to a unique Double Taxation Avoidance Treaty and Convention(DTAC). The FDI accounted for over 26 per cent of the total during 2000-2022 amounting to \$161 billion. No doubt since its renegotiation the FDI via this route has come down but Port Louis still retains that ease and charm for investors. Trade is also burgeoning to over half a billion dollars.

In the developmental domain too Mauritius takes the larger pie of the cake with highimpact socio-economic, infrastructural and developmental projects let alone a large number of scholarships and

capacity-building assistance provided under various Government of India programmes. These have been tailored under India's Africa policy so succinctly outlined by Prime Minister Modi during his address to the Ugandan parliament in 2018 underscoring that India believes and works for 'Africa for Africans' approach and their wishes must be respected. Projects included the metro to the community centre and developmental projects to social housing, the largest cultural centre, civil services college and the establishment of the World Hindi Secretariat. As Prime Minister Modi said India during the last decade has extended over \$1 billion in Lines of Credit and \$400 million as grants and assistance. For New Delhi, Mauritius is

ready to play a more signifi-

cant and dynamic role as a to have direct and reliable gateway to Africa as the continent moves towards greater integration charting its own course of growth and development including the African Continental Free Trade Agreement(AfCFTA). Since Africa figures prominently in India's foreign and security policy calculus and naturally and mutually sustaining partnerships, Prime Minister Modi invited Mauritius as a special guest at the G20 Summit last September and successfully engineered the African Union (AU) 's inclusion as a permanent member in the G20 making it effectively a G21. India has also been a first responder and a HADR partner in every contingency Mauritius faced from the extensive medical and vaccine assistance during the pandemic to the Wakashio oil spill accident in 2020. Even this time the Prime Minister of Mauritius has agreed to follow the Indian model in digital public infrastructure like RuPay card and UPI as well as the first country to set up an Aushadhi Centre on a similar pattern as in India's Jan Aushadhi Scheme (JAS). Prime Minister Modi and Prime Minister Jugnauth virtually inaugurated the St James jetty an airstrip and six other high-impact developmental projects to cater to

connectivity with the mainland thereby ensuring aerial, maritime and digital connectivity within Mauritius. This collaborative effort reflects the deep-rooted partnership between the two nations in addressing various challenges in the Indian Ocean region, both leaders underscored.

Mauritius is also important from the point of view of maritime strategic calculations. New Delhi has been rendering all possible assistance including joint monitoring and preventing and countering threats in the maritime domain including its extensive and Extended Economic Zone (EEZ). India has always respected the territorial integrity of Mauritius and has stood for it. The case of the Chagos Islands (Diego Garcia) and the Mauritian sovereignty against the British claims over them, is a case in point. In this context Prime Minister Jugnauth, speaking in Creole to his people, wanted to dispel the opposition spreading vicious rumours in his country regarding the Indian desire for a military base in Mauritius while highlighting Indian help and assistance in fulfilling their developmental objectives. Likewise, Prime Minister Modi reiterated that "Various traditional and nontraditional challenges are emerging in the Indian Ocean region.

## Fall of The House of Ming: Money, militia and Myanmar

Three years after the military Myanmar, Operation 1027 was launched against the military junta The Three Brotherhood Alliance members comprising the Myanmar National Democratic Alliance Army(MNDAA) from the Kokang Region of Shan State, the Ta'ang Liberation Army also from the Shan State and the Arakan Army (AA) based in the Rakhine State. On 27 October 2023, the Alliance simultaneously attacked military outposts, police stations and took control over key cities and highways in the northern part of Shan state. The rebellion quickly spread across Myanmar and by 7 November 2023 with the launch of Operation 1107 in support of Operation 1027 many other insurgent groups across the country joined hands. This was perhaps one of the rare occasions in the troubled history of Myanmar where Eastern Armed Organisations(EAO) from a variety of ethnic had come groups together in a meticucoordinated lously attack against the junta. AA operating in Rakhine state largely was a surprise entry in this alliance but MNDAA had been an old player in the region. Subsequently, Myanmar observers debated the pushback by the rebel groups as a victory for democracy, with some reports stating only 30-40 per cent of Myanmar was under the control of the junta.

However, in the debates that raged with every town that fell to the rebels what was forgotten was the importance of MNDAA in this offensive. In fact, it was the first blow by MNDAA to the military junta in Laukkaing that propelled the far-reaching consequences of Operation 1027. The fallout of this rebel victory in Shan state resulted in three brigadier generals of the military junta sentenced to death and three to life imprisonment. They were accused of surrendering with their soldiers to MNDAA in Laukkaing, the capital of the Kokang Self-Administered Zone in northern Shan state making it possibly the largest surrender in the history of the military junta in Myanmar resulting in not just a humiliating defeat for the military junta but the sentencing of the brigadier generals sending shock

## Is the situation changing in favour of Russia?

**The** war in Ukraine has sprung back to life over the last few days with activation of the Eastern battlefront in Donbas. Worldwide, the public's appetite for war, however, seems to have stemmed after the horrific events in both Ukraine and Gaza. The former was largely quiet after the Ukrainian counter offensive in June 2023 which made little headway. Thereafter, the war in Gaza took over ever since October 2023 and held centre stage, pushing Ukraine to the back pages. It was largely presumed that both Russia and Ukraine had suffered heavy casualties and major equipment and weapon losses ren-

launch counter offensives of a serious nature. The war was presumably petering out into a stalemate with potential revival being linked to the US elections and its results.

That belief now appears belied, especially in the context of Russia where it was believed that sanctions and embargoes have hamstrung the war effort. Yet, in late February 2024, in a sudden turnaround the Russian forces are reported to have broken the back of the Ukrainian defensive position at the town of Avdiivka, 15 kilometres North West of Donetsk which is one of the biggest cities in

### **Supreme Court restores Scheduled** Caste status to BJP leader Navneet

**NEW DELHI:** In a relief to BJP leader and MP Amravati reserved constituency Navneet Kaur Ravi Rana just ahead of general elections, Supreme Court on Thursday quashed Bombay high court order by which her Scheduled Caste certificate of 'Mochi' was cancelled.

A bench of Justices J K and Maheshwari Sanjay Karol held that 2017 order of District Caste Scrutiny Committee which validated Kaur's caste claim as 'Mochi' was right and the HC inadvertently undertook an erroneous exercise of appreciating evidence and swayed itself into a roving inquiry which was not expected as per settled legal position. "When the scrutiny committee which is principally tasked with the fact finding exercise for validation of the basis of the certifi-

claim, had applied its mind and reached a conclusion, then in such a situaenquiry by HC was required? It is well settled that high courts as well as Supreme Court should refrain themselves from deeper probe into factual issues like an appellate body unless the inferences made by the concerned authority suffers from perversity on the face of it or are impermissible in the eyes of law. In the instant case, the order passed by the committee reflects due appreciation of evidence and application of mind and in absence of any allegation of bias/malice or lack of jurisdiction, disturbing the findings of the committee cannot be sustained," the bench said. #### What ED said in SC while opposing Kejriwal's plea against arrest

NEW DELHI: The Enforcement Directorate (ED) has informed the Supreme Court that Delhi chief minister Arvind Kejriwal played a central role in the excise policy case, acting as the "kingpin and key conspirator."The probe agency asserted that arresting an individual based on evidence of an offense does not undermine the principles of free and fair elections. According to the ED, Kejriwal allegedly collaborated with his ministers and AAP leaders, and was involved in "demanding kickbacks" from liquor businessmen in return for favors granted through the policy. The agency filed an affidavit in the Supreme Court in response to Kejriwal's plea challenging his arrest, stating that he failed to cooperate with the ED despite being summoned multiple times in connection with the excise policy case. On April 15, the top court had sought a response from the ED by April 24 on Kejriwal's plea challenging his arrest in the case. "The Aam Aadmi Party (AAP) is the major beneficiary of the proceeds of crime generated in the Delhi liquor scam. Part of the proceeds of crime to the tune of cash of Rs 45 cr approx. has been utilised in the election campaign of AAP in Goa Assembly elections 2022," it

#### Centre advises CBSE on biannual board logistics

Delhi: Officials said the Union ministry of education has ordered the CBSE to create a plan for twice-yearly board exams and will confer with stakeholders next

month. The new national curriculum framework (NCF) unveiled last year suggested pupils take board twice a year. In



February, union education minister Dharmendra Pradhan stated the scheme would likely start in 2025-26. A senior education ministry source said CBSE has been urged to figure out how to organize the academic calendar to allow another round of board exams without affecting undergraduate admissions."The ministry and board will consult CBSE school principals and stakeholders on this. The person, who requested anonymity, indicated that other NEP 2020 implementation difficulties will be examined. A second official claimed scheduling is the board's biggest issue. Another exam will take three months, by which time most universities have resumed classes. ## JEE-Main: 56 applicants score 100 NTA, IIT cut-offs rise

Delhi: On Wednesday night, the National Testing Agency (NTA) reported that 56 applicants, including two women, scored 100 in JEE-Main. The qualifying percentile for JEE (Advanced), the entrance test for 23 Indian Institutes of Technology (IITs), reached a five-year high. In the JEE (Main) January session, 23 applicants obtained 100 NTA, whereas 33 in April did. The 56 winners include 40 generals, 10 OBC, and six gen-EWS. No SC or ST applicant scored 100 NTA this year. Officials say NTA score is not the same as mark %. "NTA scores are normalised across multi-session papers and based on the relative performance of all one-session exam takers. For each exam session, marks are translated into a 100to-o scale "said a sen-



ior NTA official. The official added that 39 students were blacklisted from JEE-Main for three years for cheating. According to protocol, candidates' ranks are based on the best of two NTA scores. Telangana leads state-wise for the third year with 15 scorers. Maharashtra Andhra Pradesh, with seven individuals each scoring 100 percentile, were distant second, followed by

undergraduate admissions test for engineering and architecture programs in centrally financed technical institutions to qualify for JEE (Advanced). Around 24,000 seats are available at NITs.

The exam was given in languages (Assamese, Bengali, English, Gujarati, Kannada, Hindi, Malayalam.

#### 1 in 4 Congress, 1 in 5 BJP from political families

Delhi: Given the political churn, not all political family candidates are running for the same party as their elders. Multigenerational politics is seen in the fact that one in four Congress candidates in the Lok Sabha elections are from political families, compared to one in five (of the 424 announced) Bharatiya Janata Party candidates. Thus far, 87 of the 424 BJP candidates are from political families, compared to 65 of 250 Congress candidates. For this analysis, A political family has a grandparent, parent, or elder sibling who is an elected or nominated member of Parliament or a state assembly or a key political party position. Analysts expect the BJP's list to include many political families for two reasons. First, the party has always prioritized winnability. Two, Prime Minister Narendra Modi stated in Parliament that candidates who follow their elders are fine. The BJP's Andhra Pradesh candidate is D Purandeshwari, daughter of Telugu Desam Party founder NT Rama Rao. She and BJP candidate Kiran Kumar Reddy (former CM) were Congress members. His Congressman father was connected to Indira Gandhi and PV Narasimha Rao. BJP candidates come from anti-Congress political families. Its Bihar candidate is the son of former Bettiah MP Madan Kumar Jaiswal. Newada candidate Vivek Thakur is the son of former Union minister CP Thakur. In Gujarat, the BJP nominated Poonamben Madam, daughter of six-term MLA and former mayor Hemantibhai Madam. Bharatsinhh Dabhi, son of two-term MLA Shankarji Okhaji Thakor, is another seasoned state candidate. BJP candidates from political families include Bansuri Swaraj, daughter of late Sushma Swaraj in New Delhi, BY Raghavendra, son of BS Yedyurappa (the sitting MP from Shimoga who was refielded), and former chief minister Basavaraj Bommai, son of SR Bommai.
